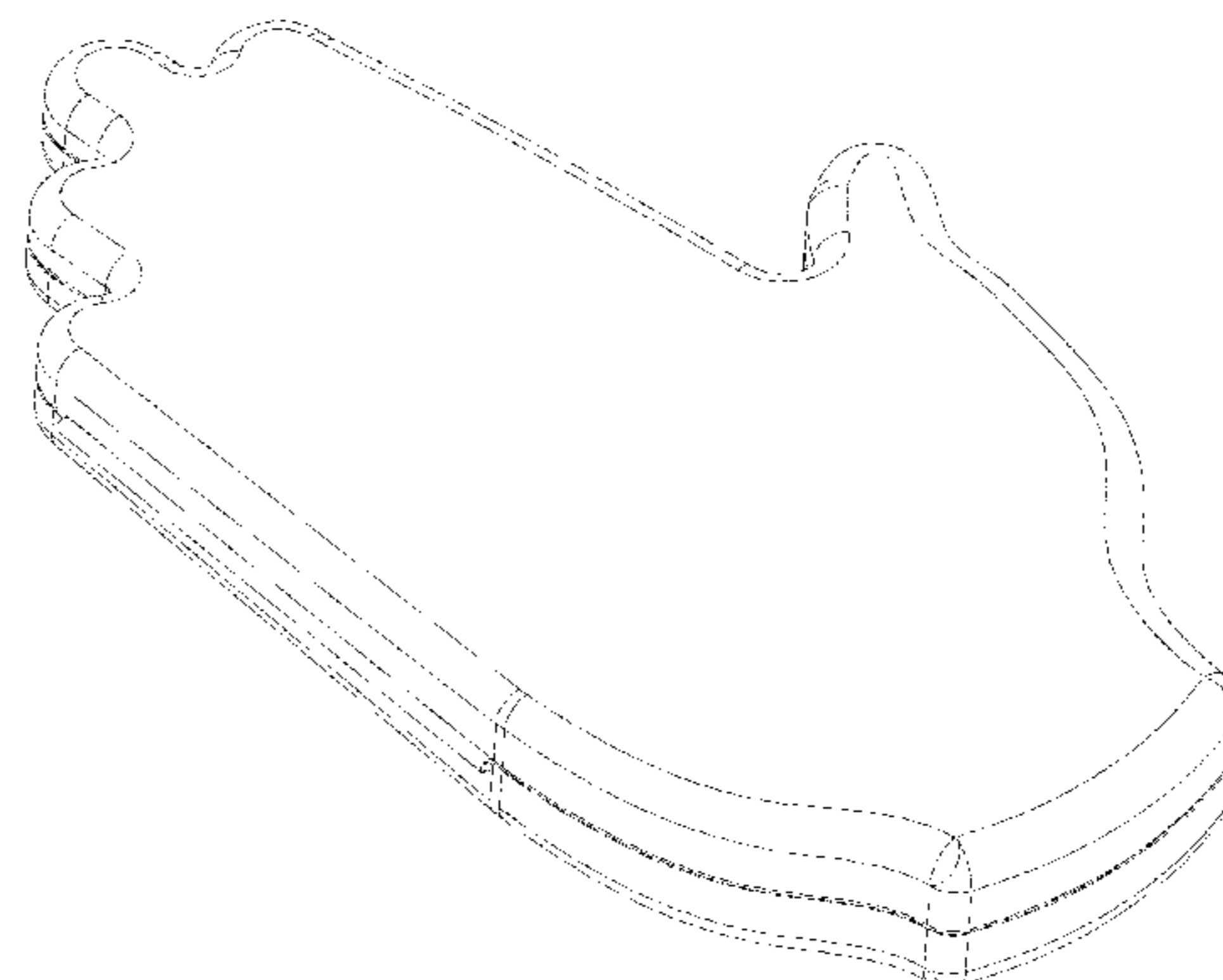
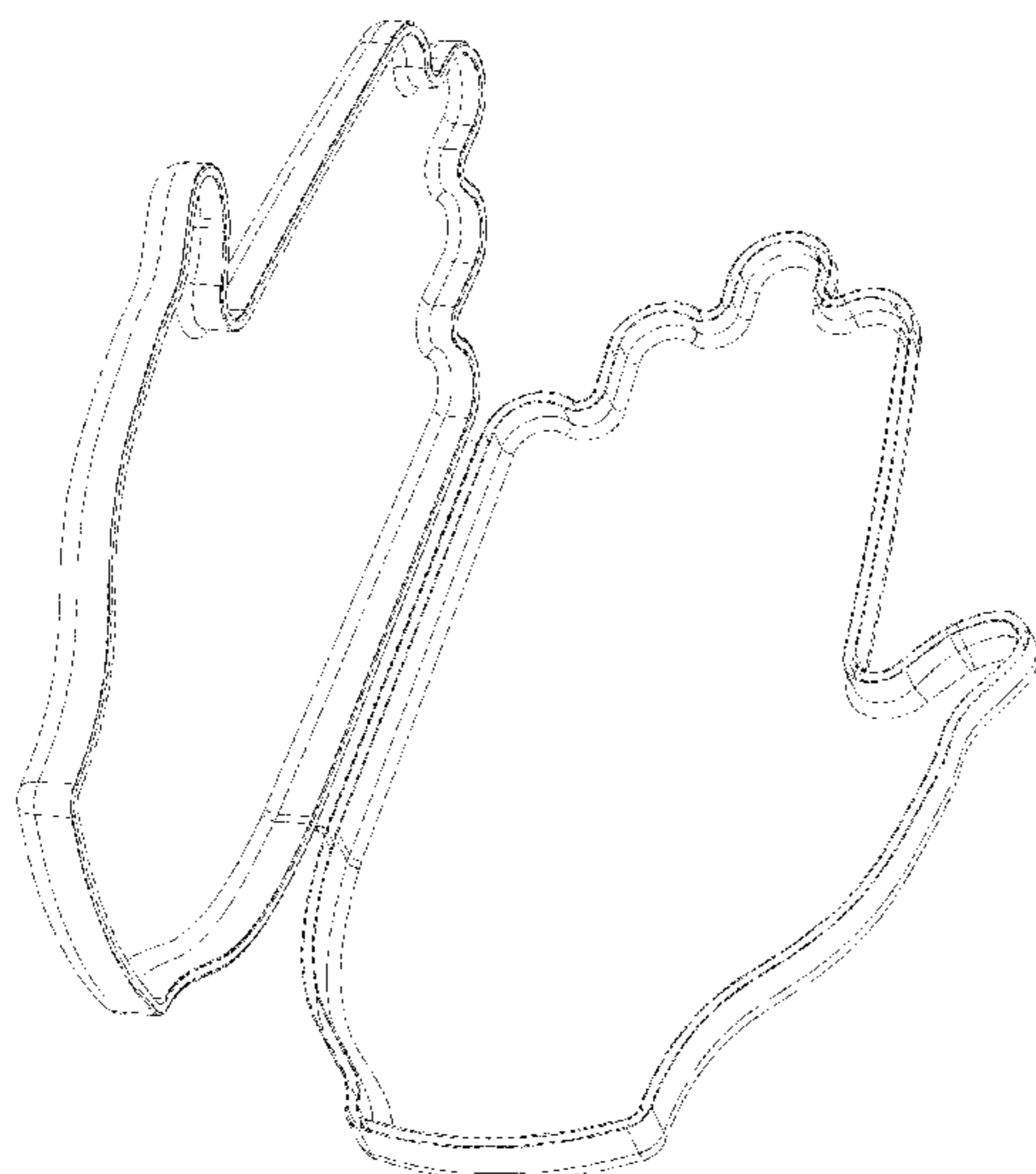
(57) **CLAIM**

The ornamental design for a glove case, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the glove case showing my new design in an open position;
 FIG. 2 is a front view thereof;
 FIG. 3 is a top view thereof;
 FIG. 4 is a cross-sectional view taken along line 4-4 of FIG. 2;
 FIG. 5 is an exploded view of FIG. 1, shown in a closed position with the outer lining, substrate, inner lining, and base shown for clarity of disclosure;
 FIG. 6 is a side view thereof;
 FIG. 7 is a top view thereof;
 FIG. 8 is a front view thereof;
 FIG. 9 is another perspective view thereof;
 FIG. 10 is another perspective view thereof;
 FIG. 11 is an enlarged view of the encircled portion as shown in FIG. 4; and,
 FIG. 12 is a cross-sectional view taken along line 12-12 of FIG. 8.
 In FIGS. 1 and 11, the broken lines encircle and indicate a portion of the claimed design shown on an enlarged scale in FIG. 11. All broken lines form no part of the claimed design.

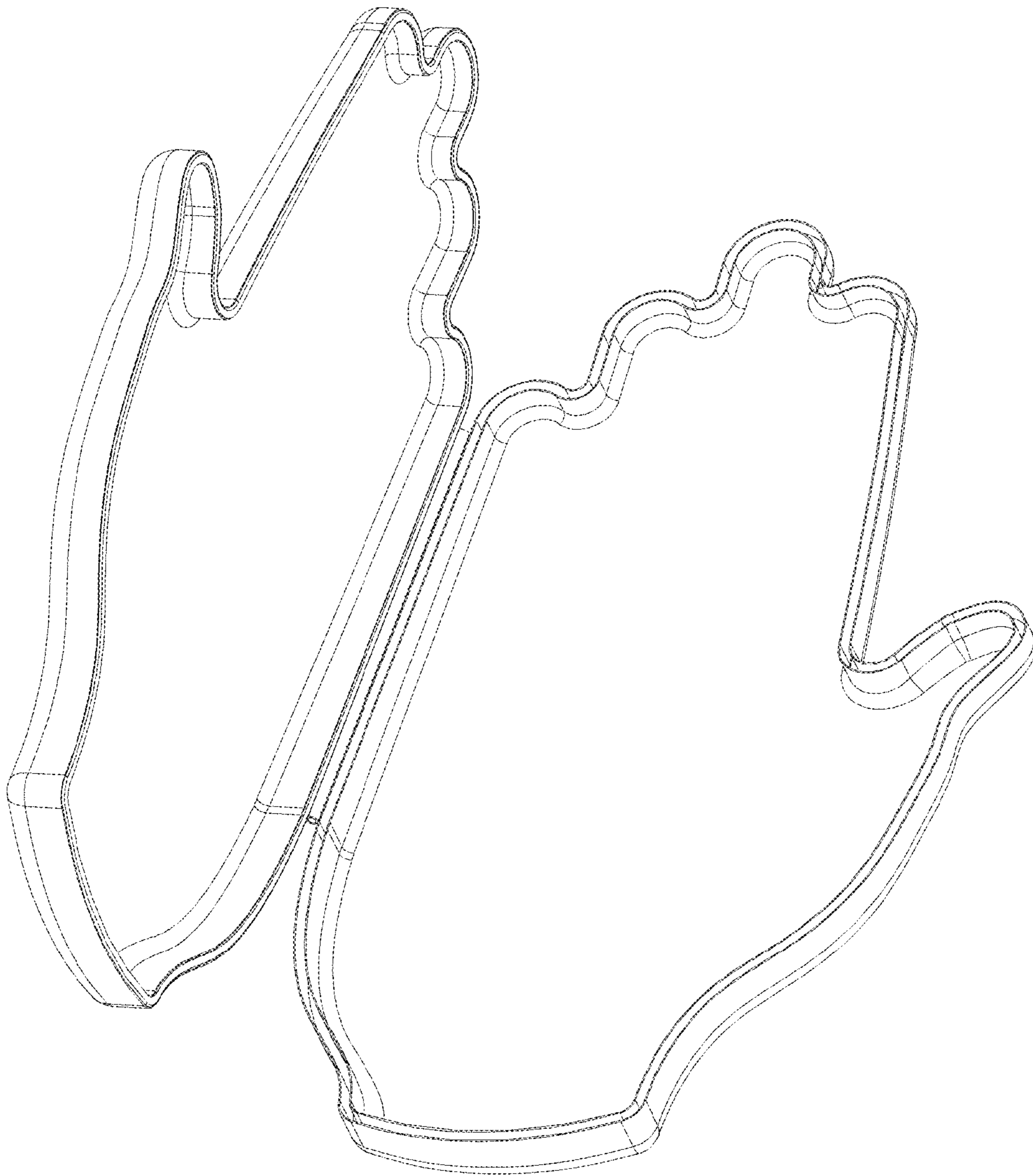

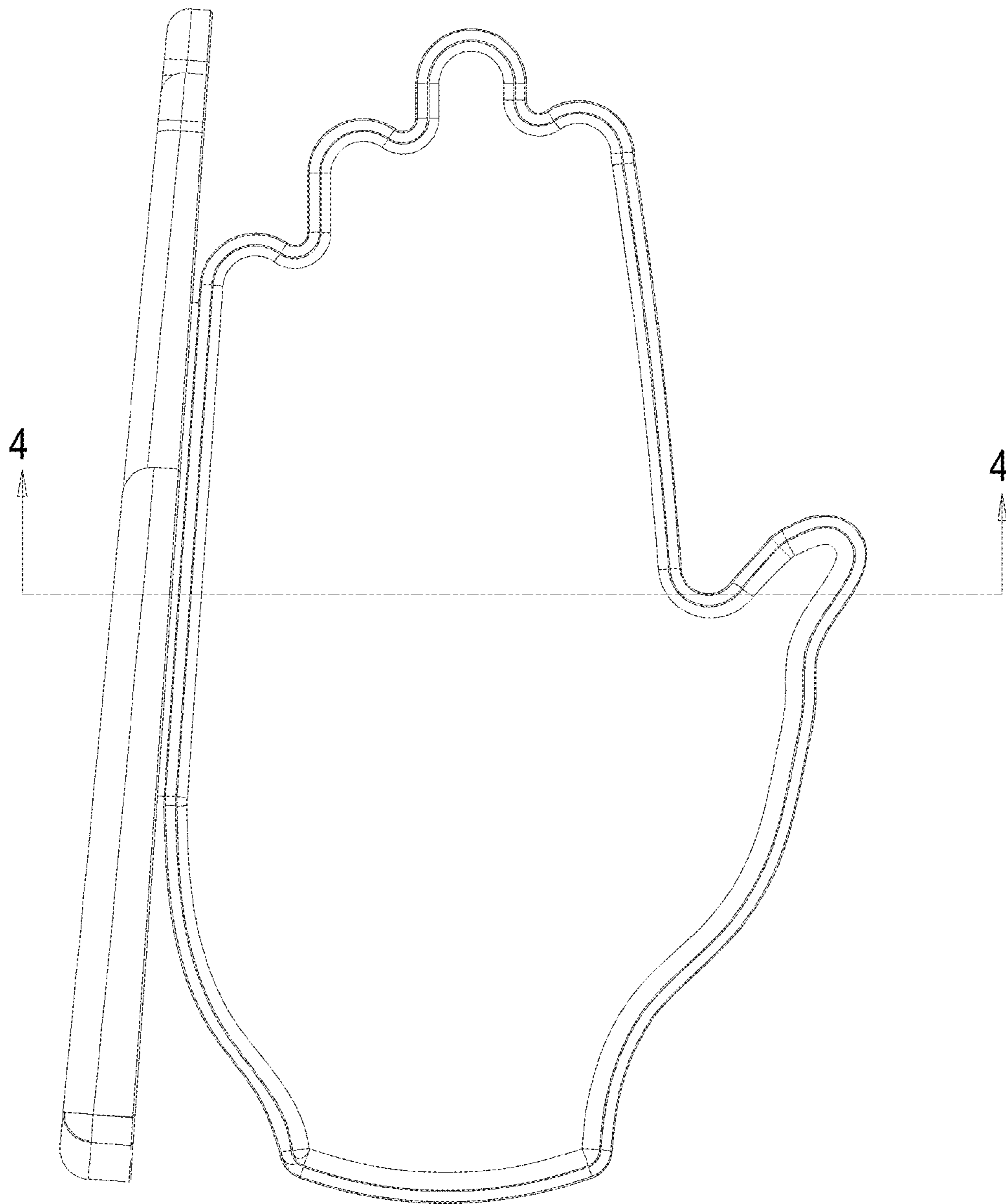

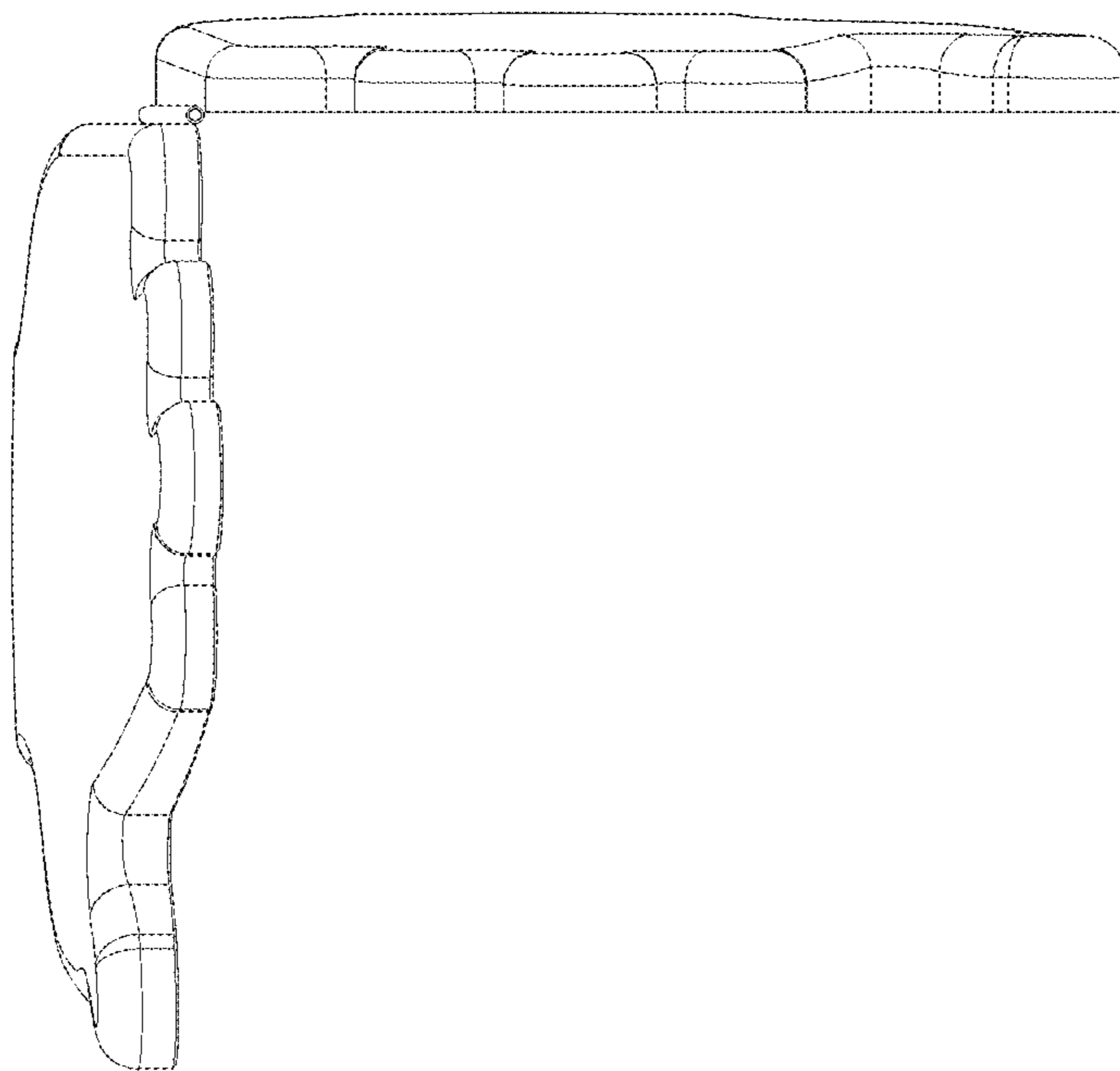

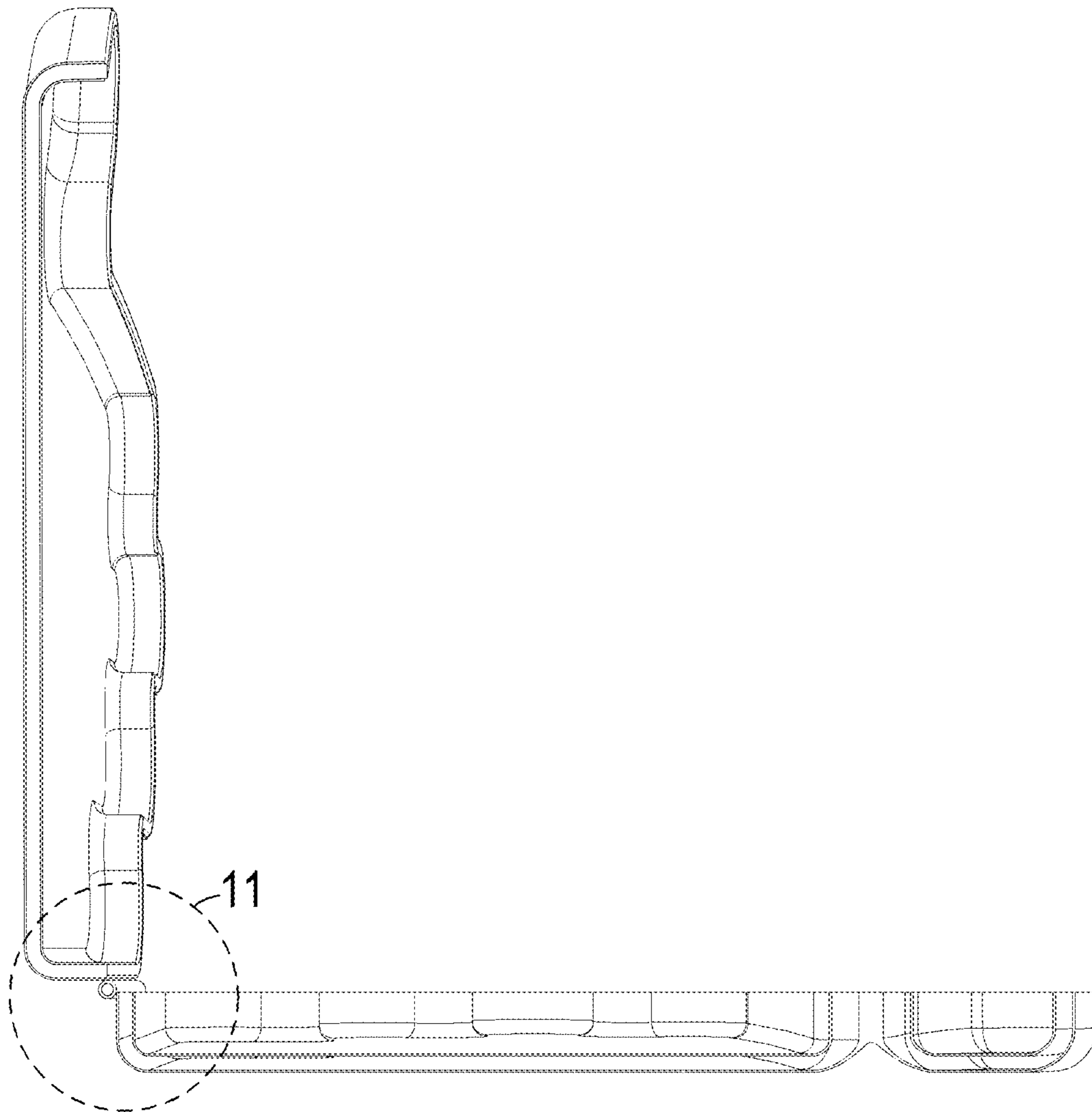

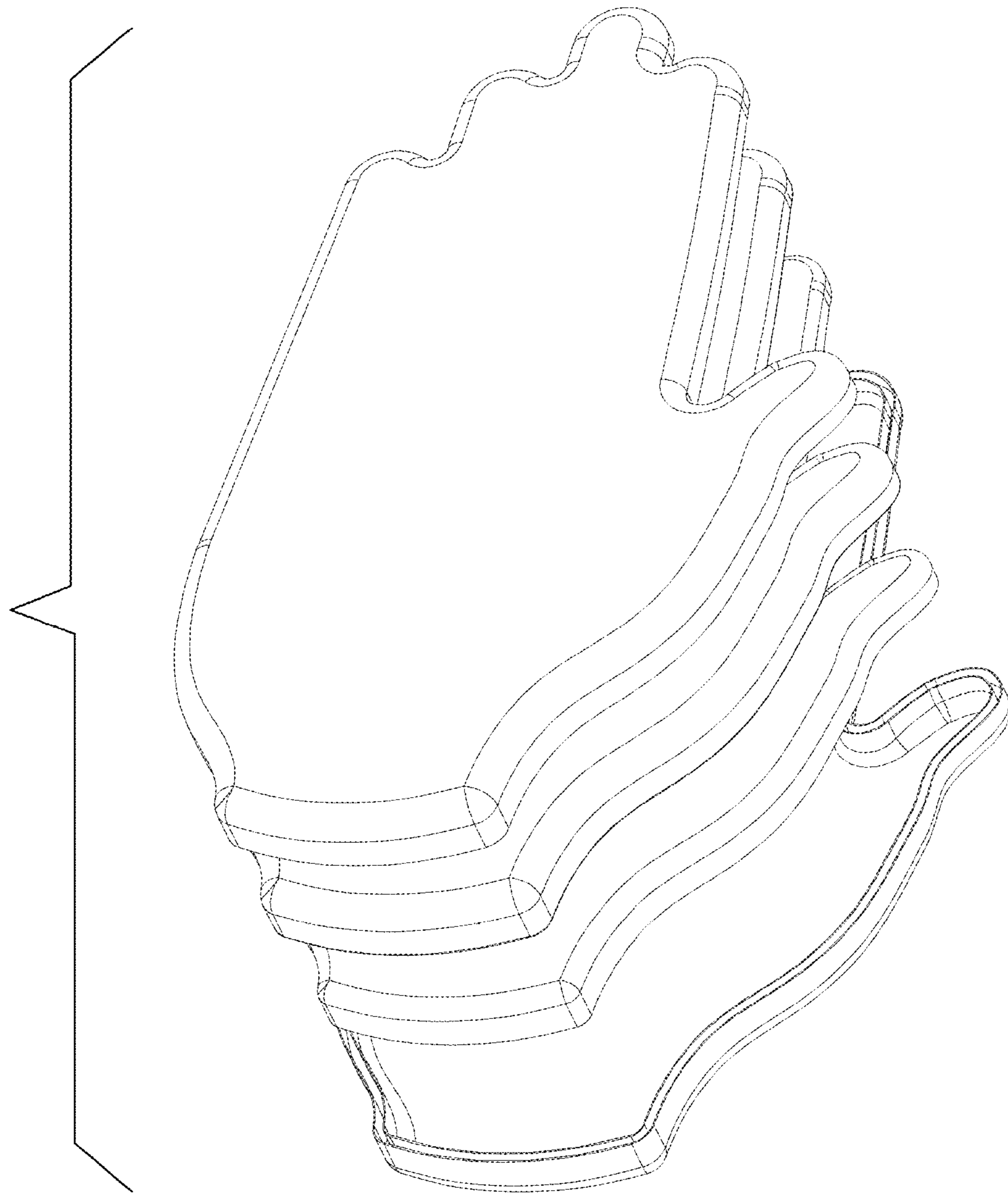

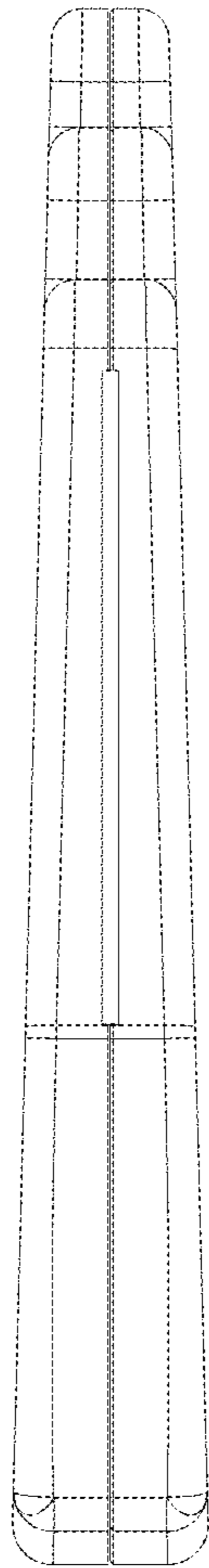

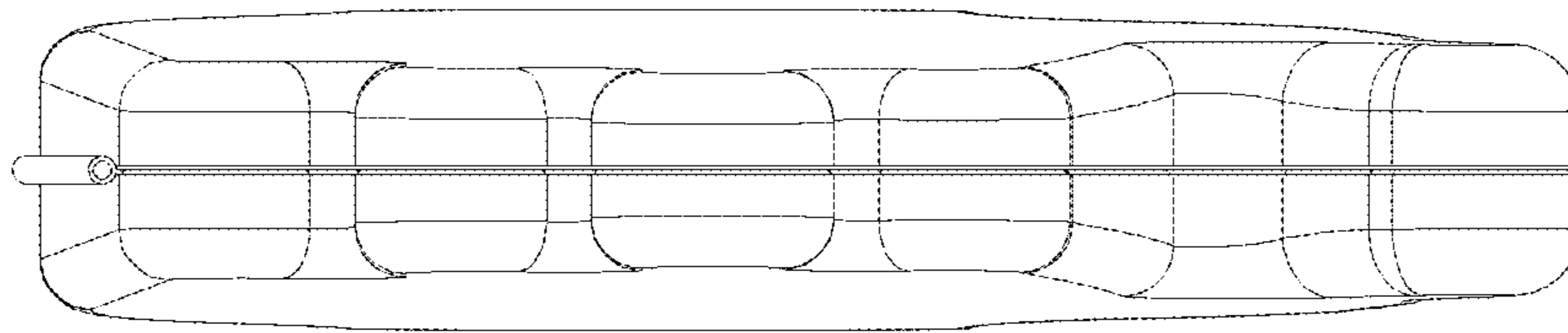

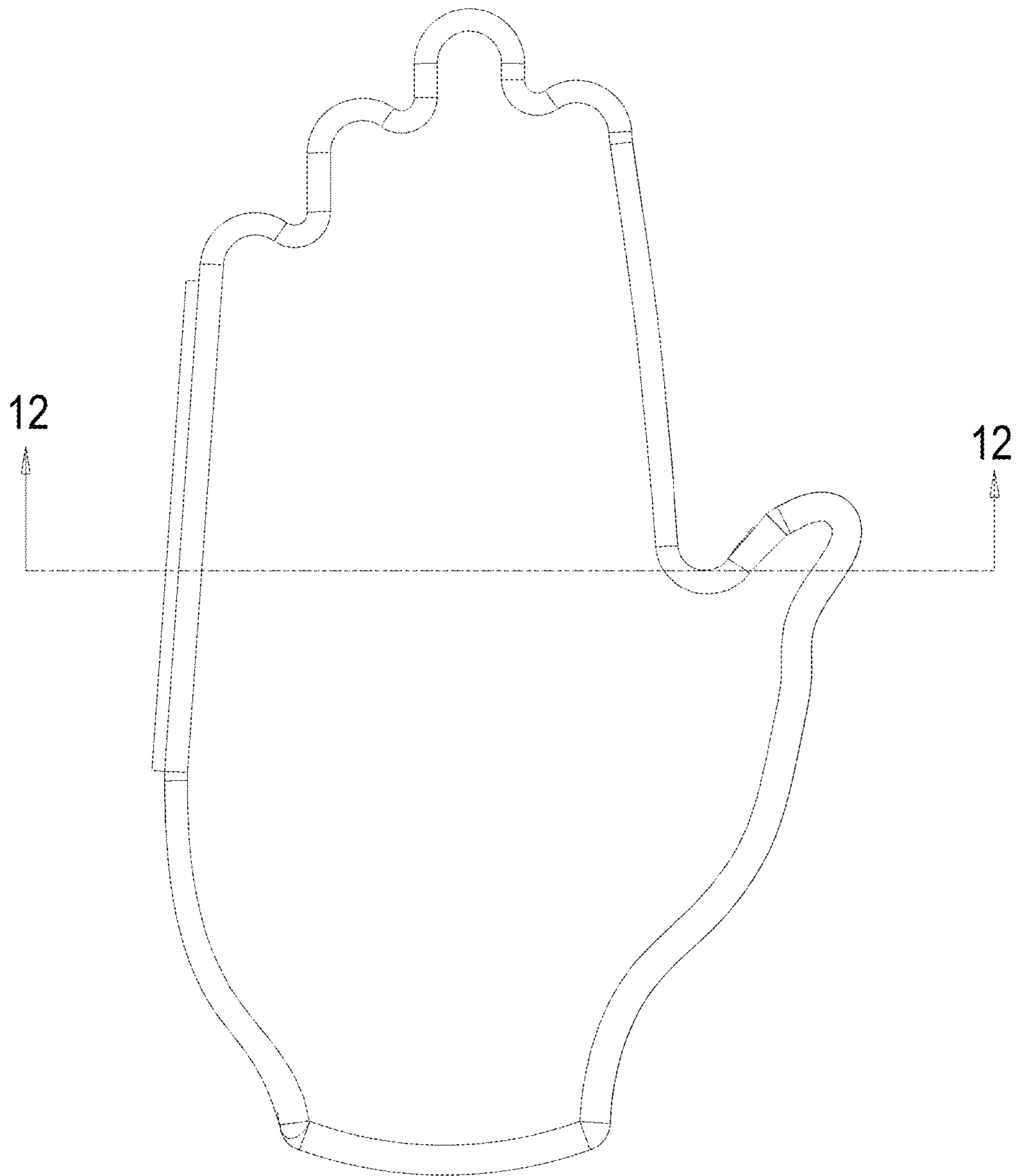

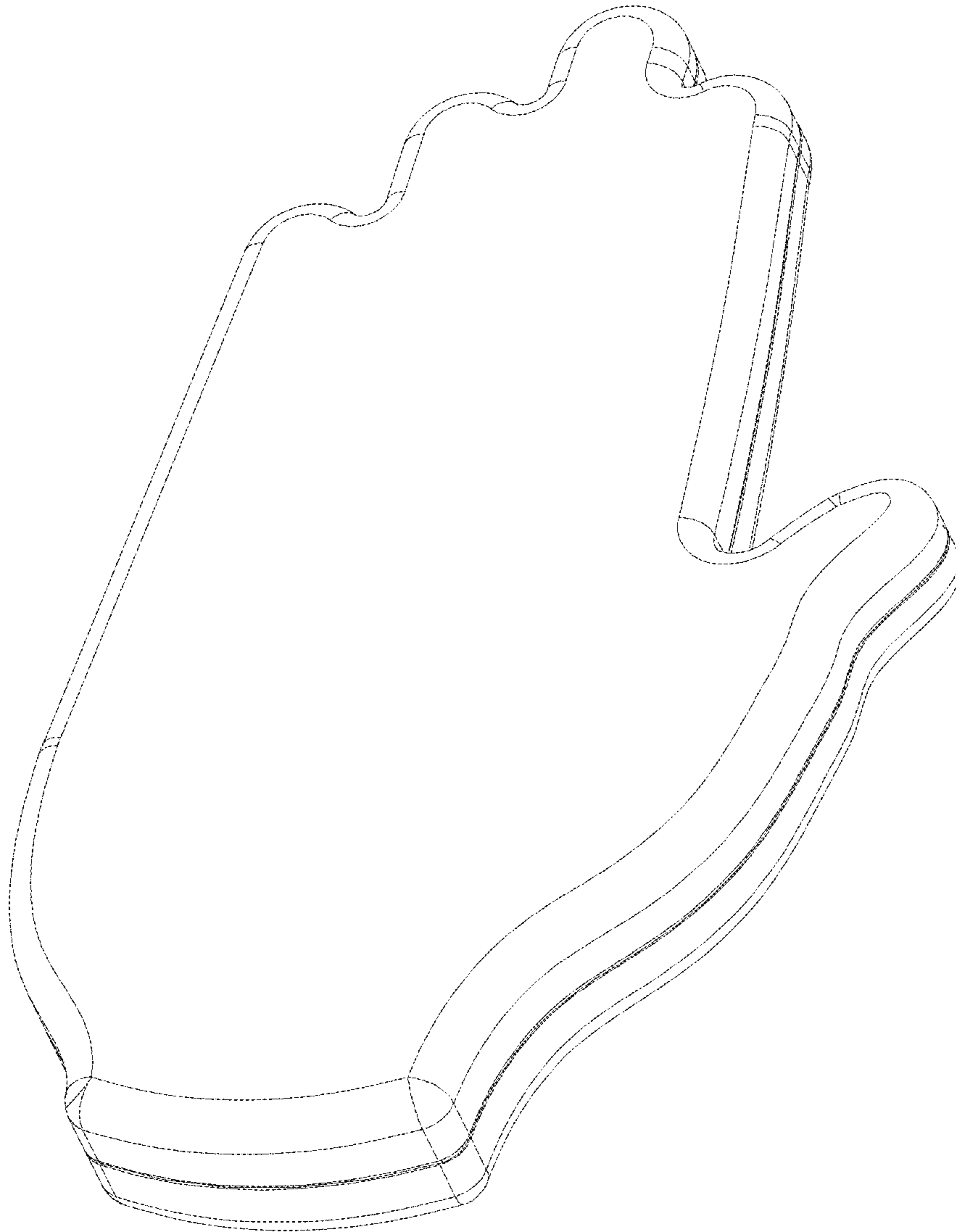

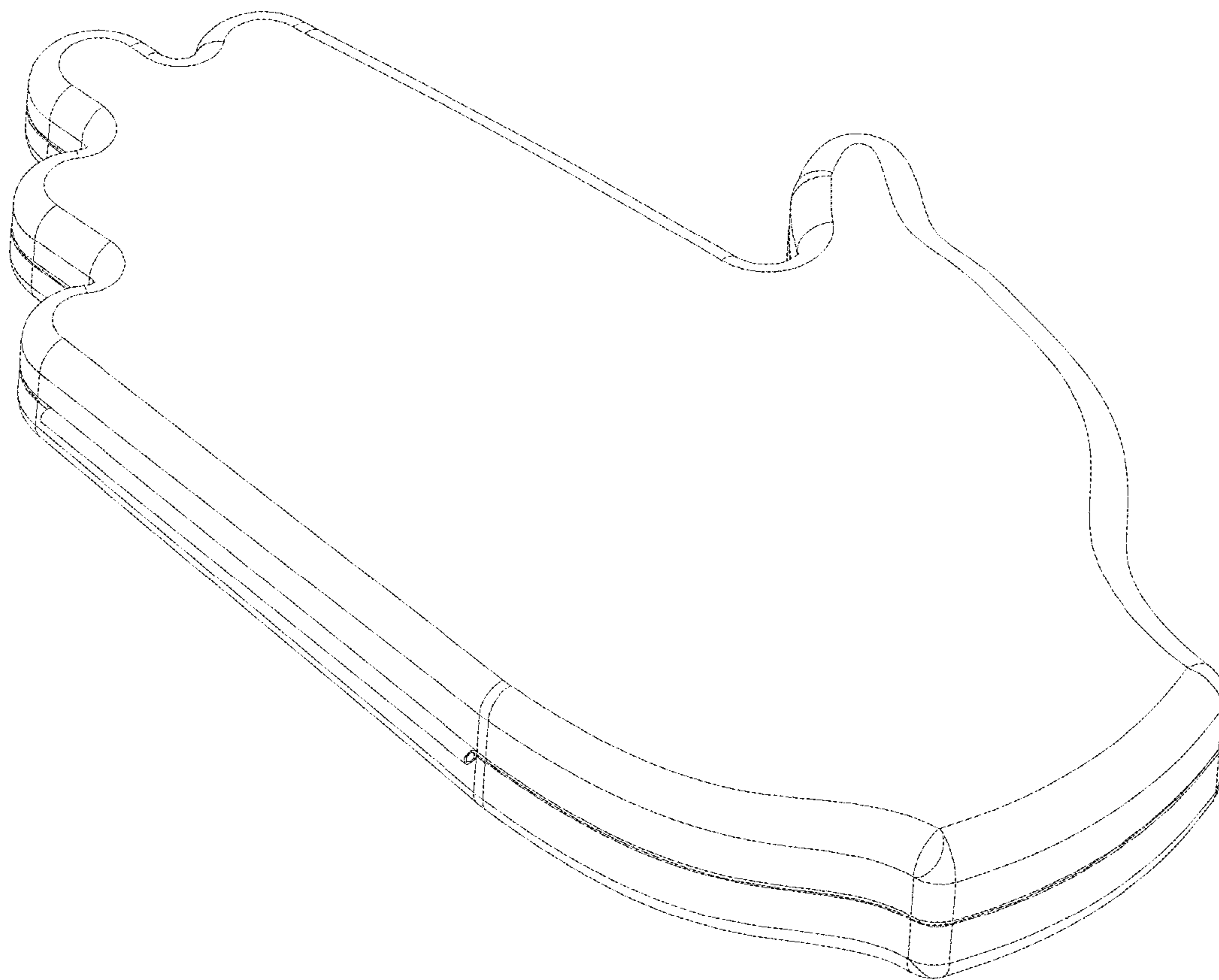

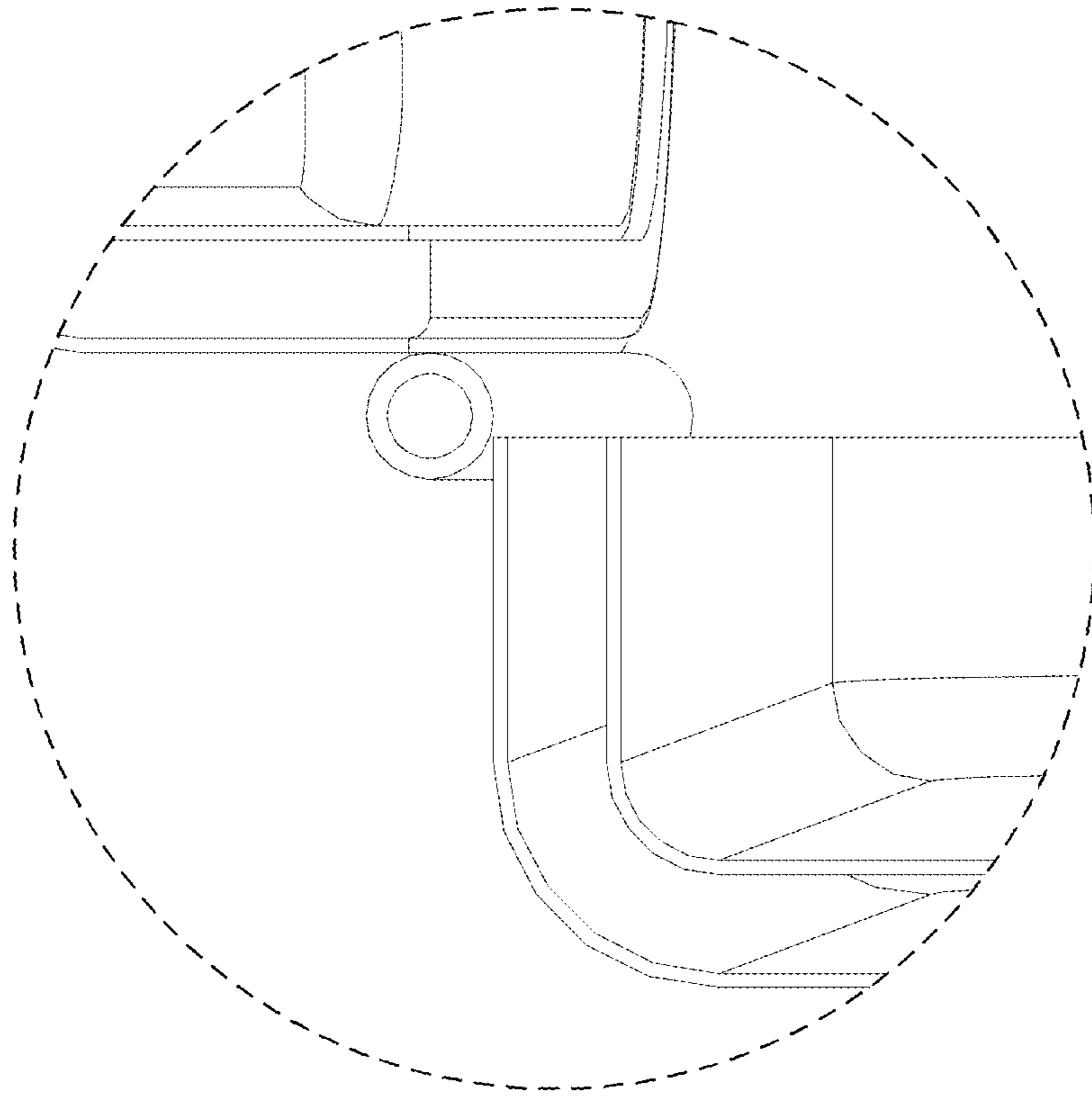

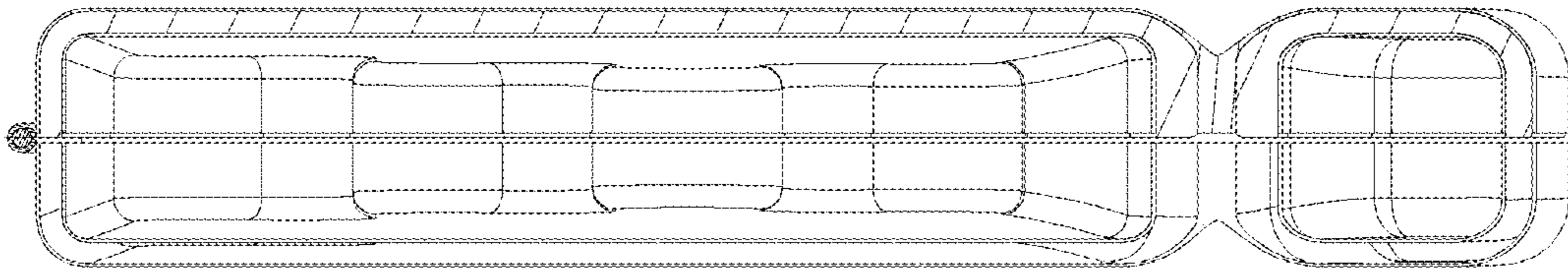
