(57) **CLAIM**

The ornamental design for a storage device for gift wrapping, as shown and described.

DESCRIPTION

This application is a continuation of U.S. patent application Ser. No. 13/373,203, filed Nov. 8, 2011.

FIG. 1 is a front view of the storage device for gift wrapping, in a folded or closed position, embodying my new design; FIG. 2 is a rear view of the storage device for gift wrapping, in the folded or closed position;

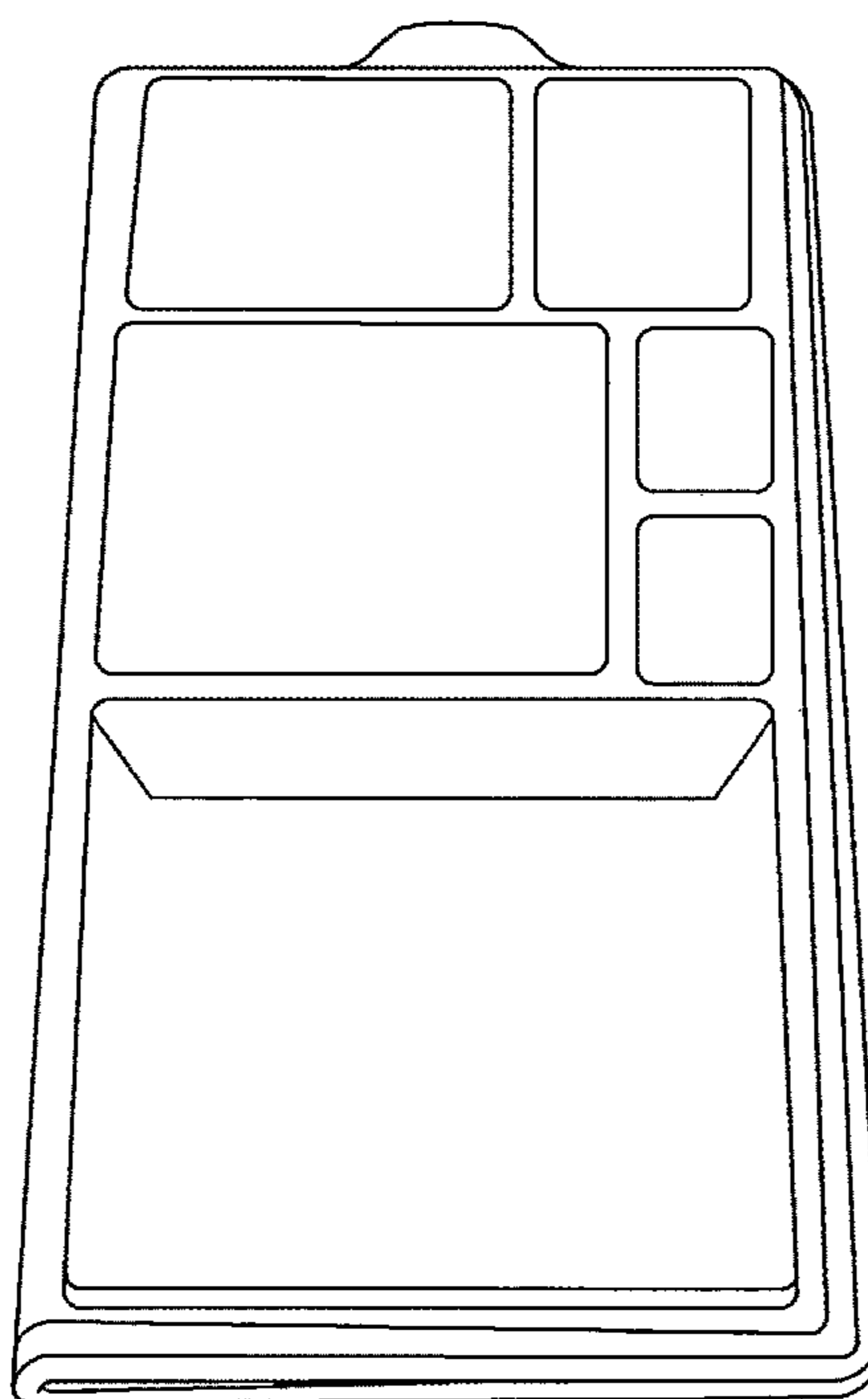
FIG. 3 is an inside view thereof, in an open or unfolded position;

FIG. 4 is a left side view of the storage device for gift wrapping, in the folded or closed position; and,

FIG. 5 is a top of the storage device for gift wrapping, in the folded or closed position.

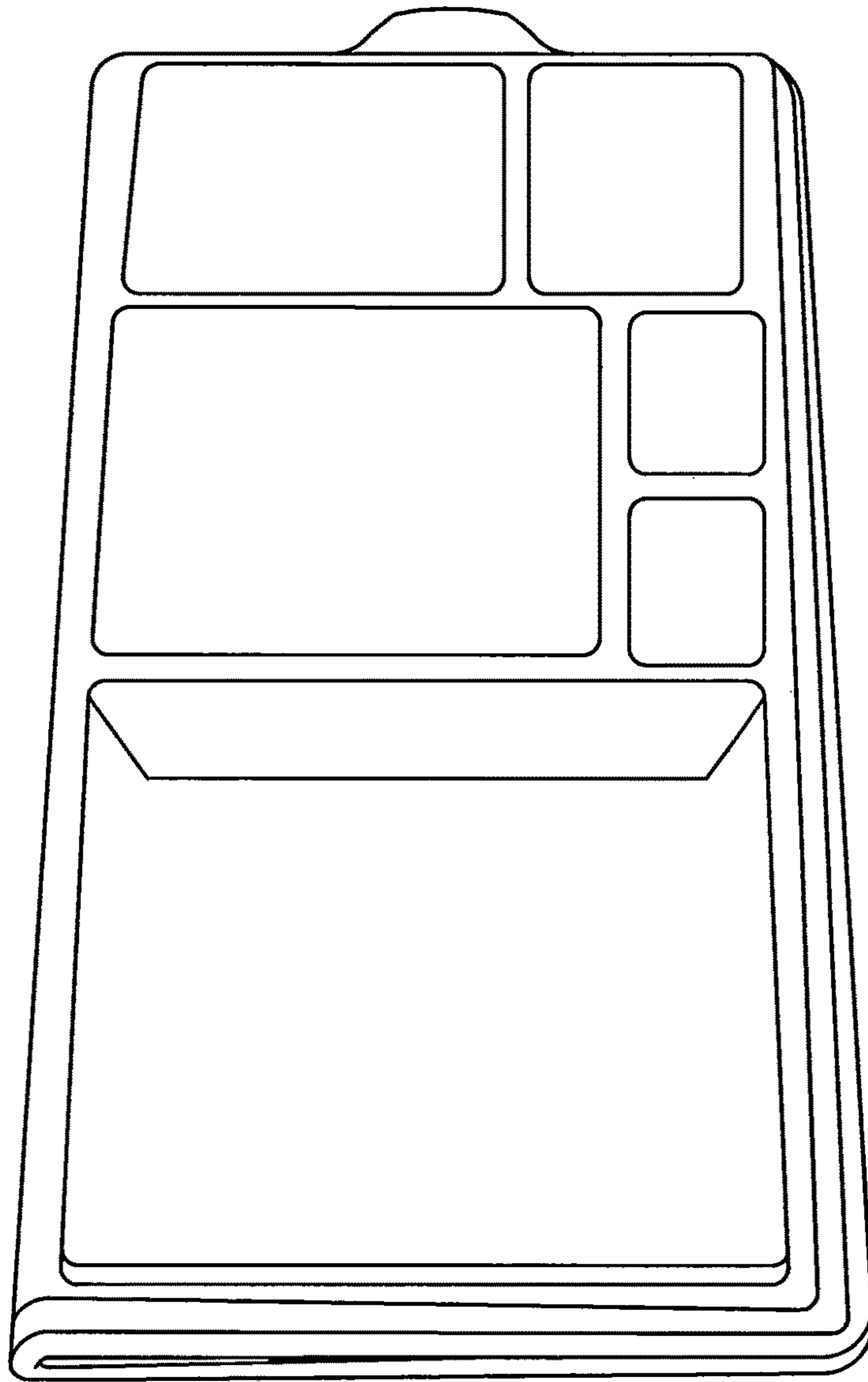

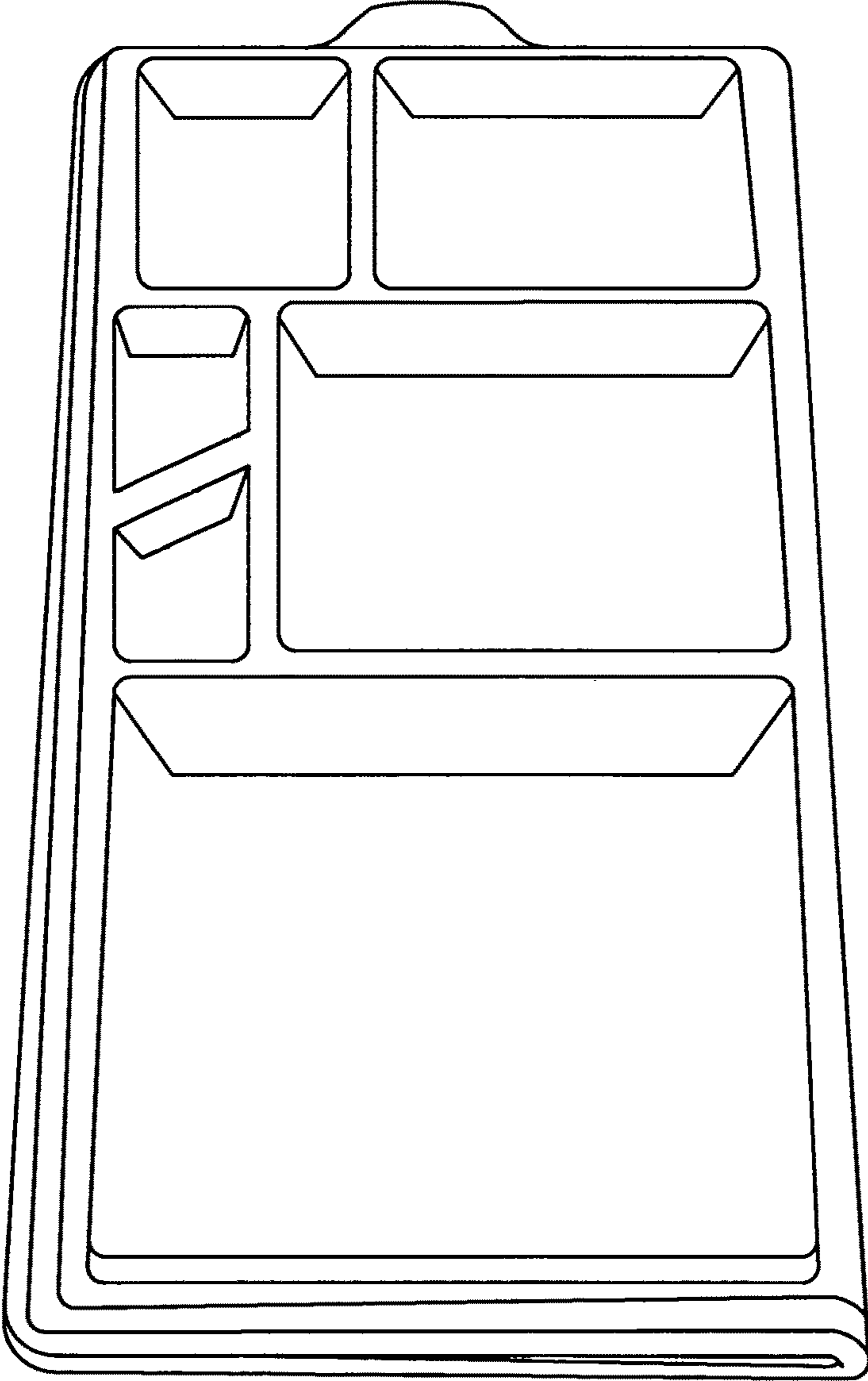

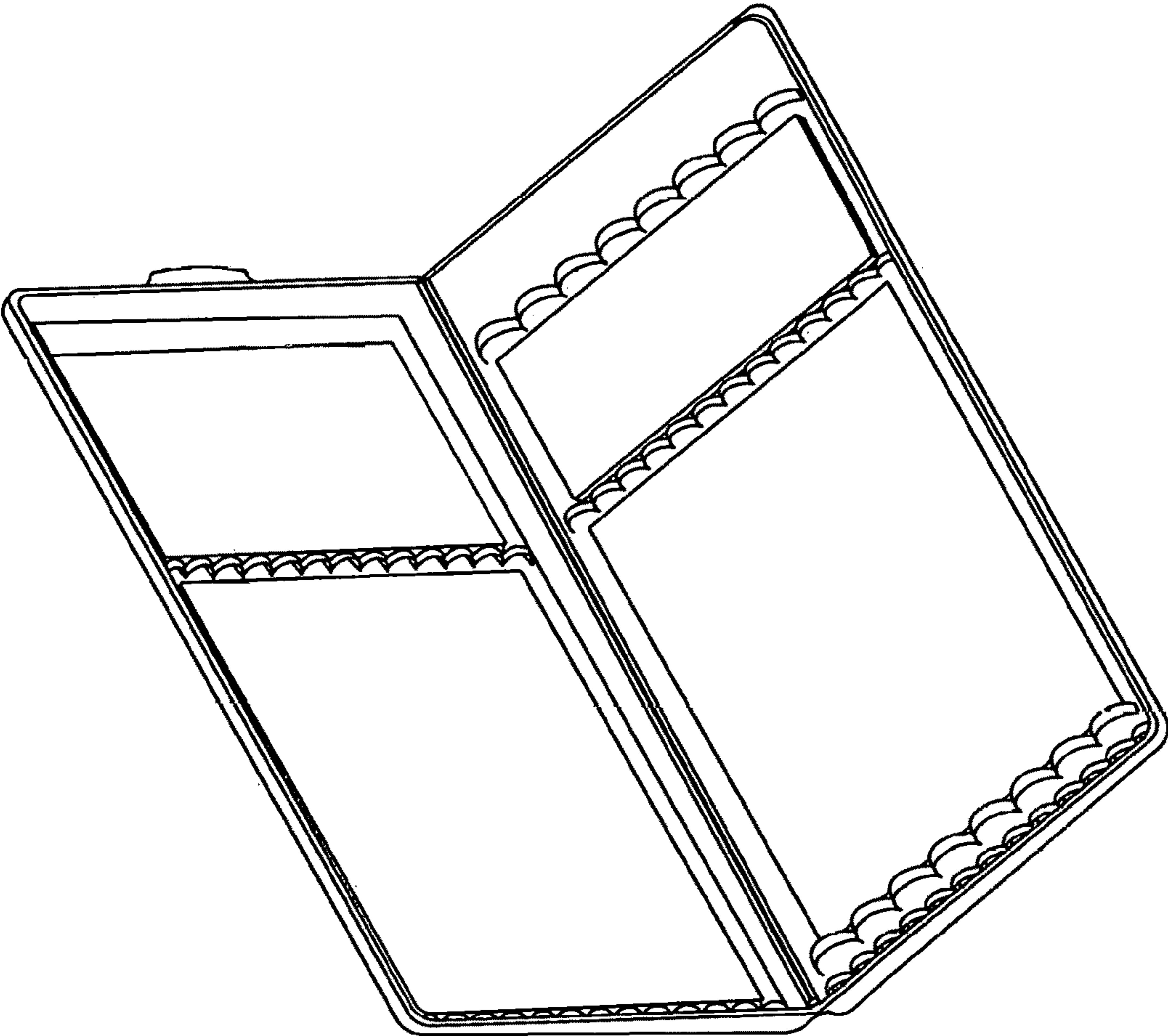

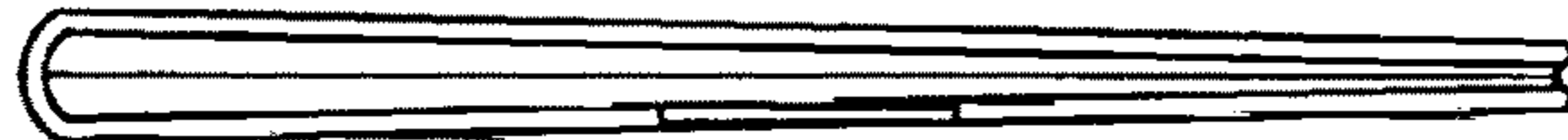
