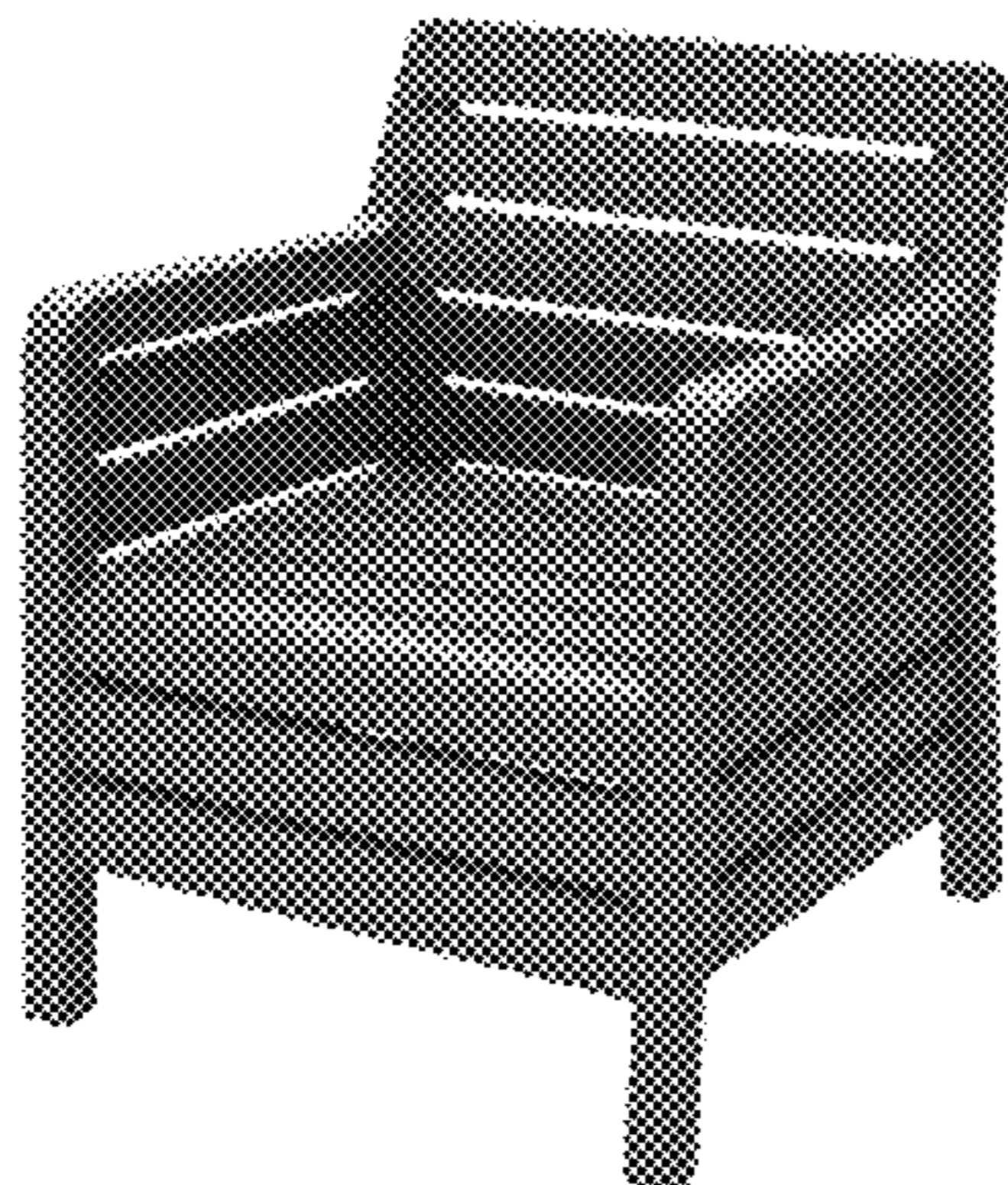

(57) **CLAIM**  
The ornamental design for a seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view for a seat of a first embodiment,  
 FIG. 2 is a bottom perspective view of the design as seen in FIG. 1;  
 FIG. 3 is a front elevational view of the design as seen in FIG. 1;  
 FIG. 4 is a rear elevational view of the design as seen in FIG. 1,  
 FIG. 5 is a side elevational view of the design as seen in FIG. 1, the other side being a mirror image,  
 FIG. 6 is a top plan view of the design as seen in FIG. 1; and  
 FIG. 7 is a bottom plan view of the design as seen in FIG. 1;  
 FIG. 8 is another top perspective view for a seat of a second embodiment,  
 FIG. 9 is a bottom perspective view of the design as seen in FIG. 8;  
 FIG. 10 is a front elevational view of the design as seen in FIG. 8;  
 FIG. 11 is a rear elevational view of the design as seen in FIG. 8,  
 FIG. 12 is a side elevational view of the design as seen in FIG. 8, the other side being a mirror image,

 FIG. 18 is a rear elevational view of the design as seen in FIG. 15,  
 FIG. 19 is a side elevational view of the design as seen in FIG. 15, the other side being a mirror image,  
 FIG. 20 is a top plan view of the design as seen in FIG. 15; and  
 FIG. 21 is a bottom plan view of the design as seen in FIG. 15.

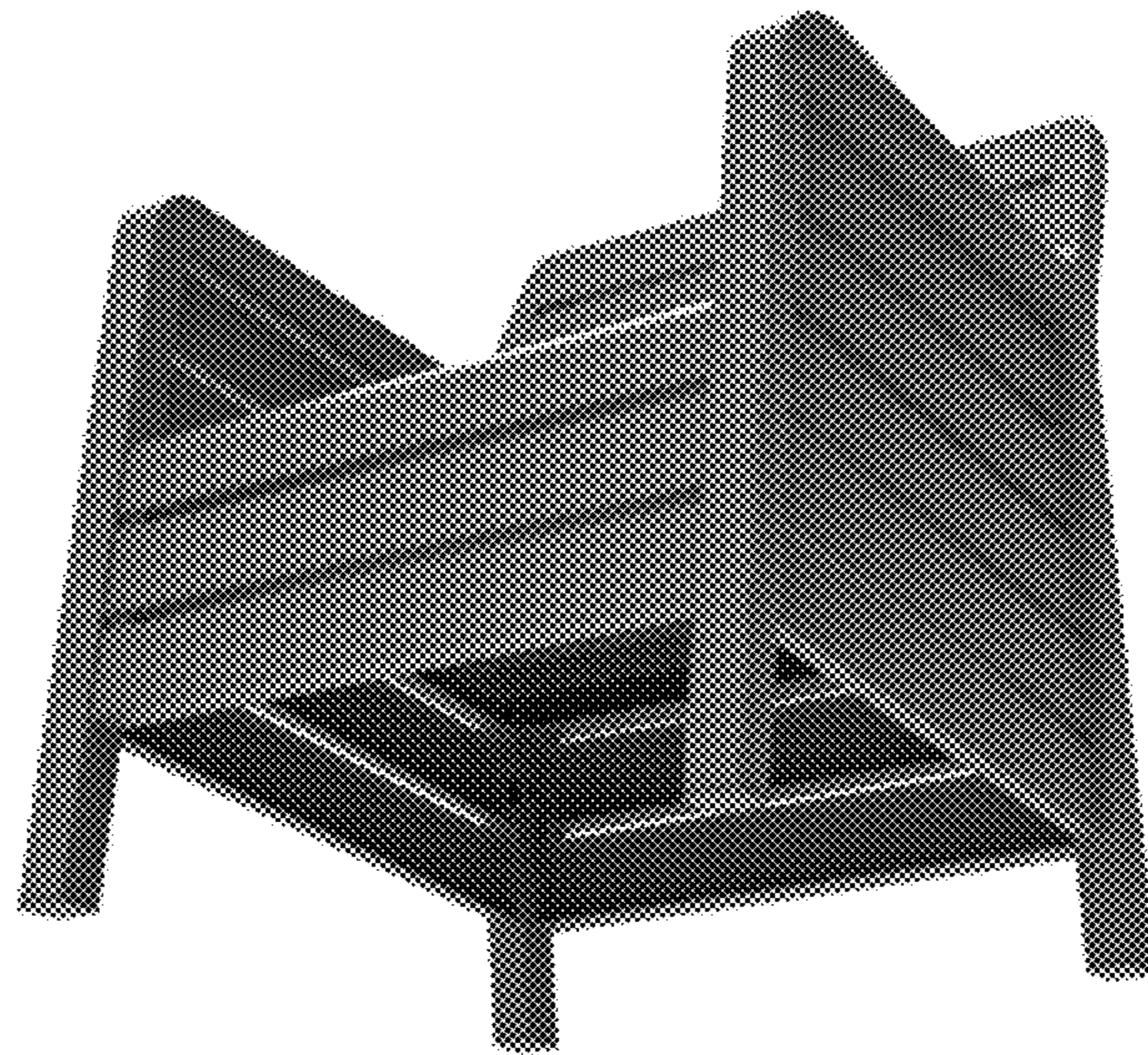

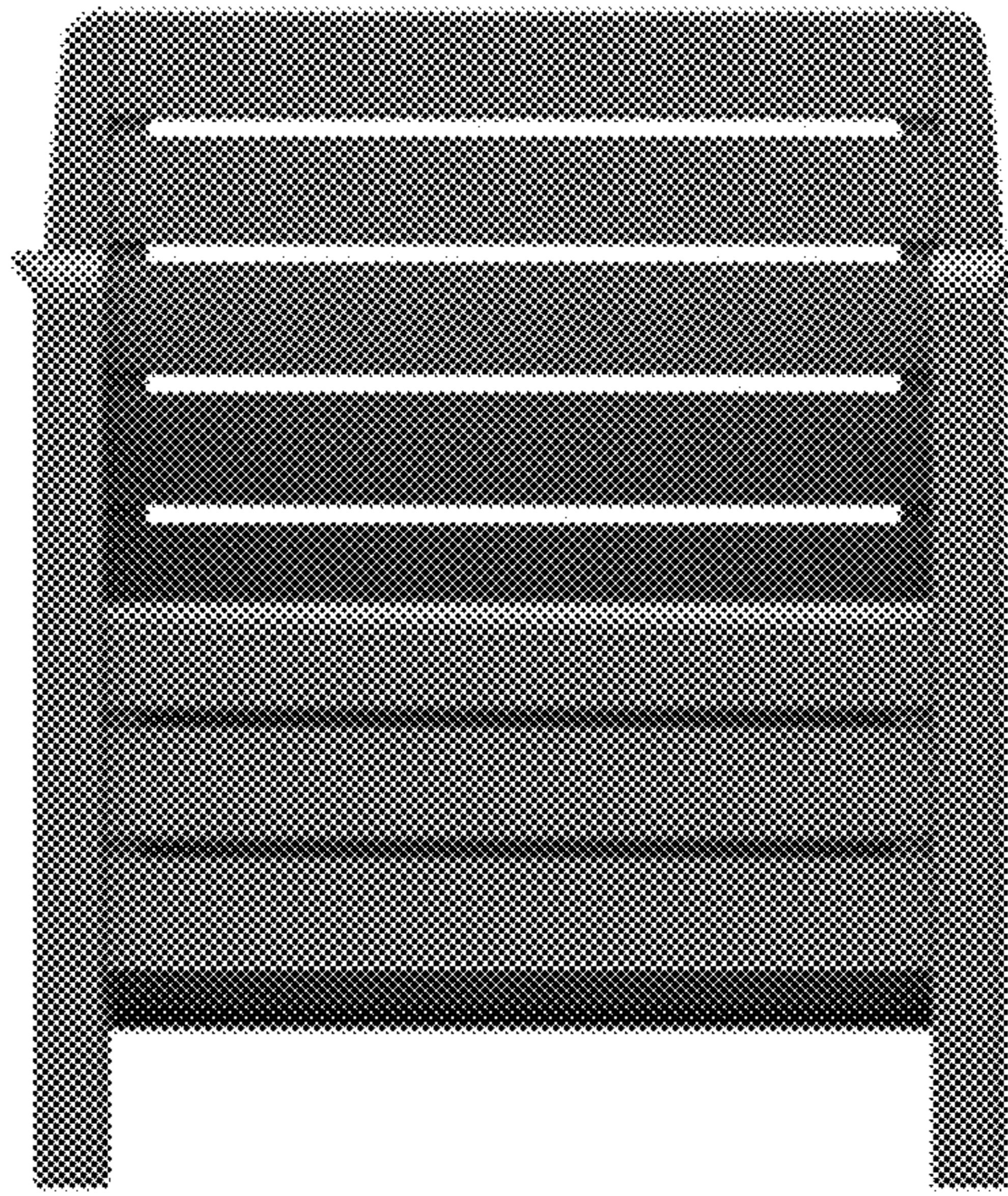

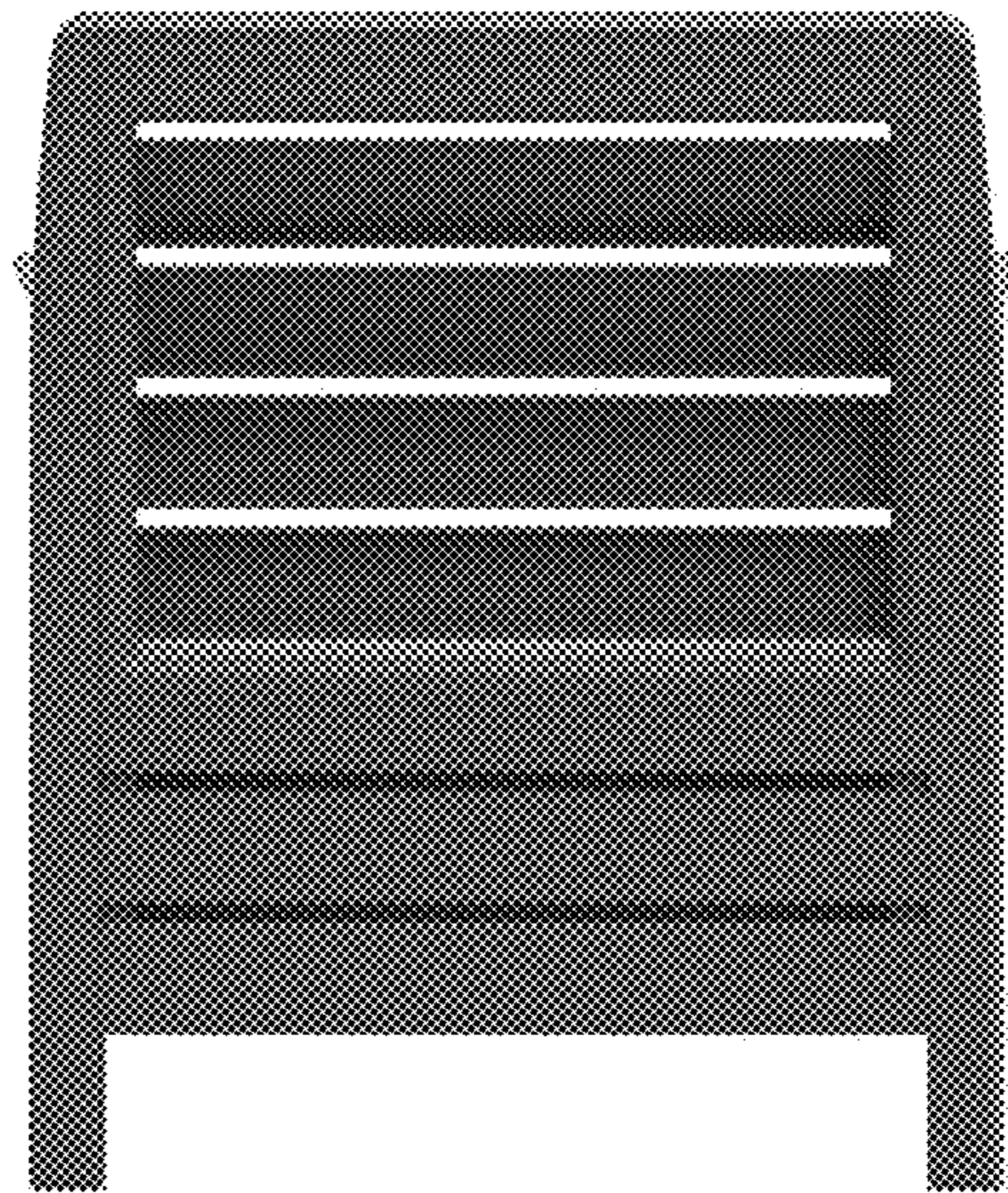

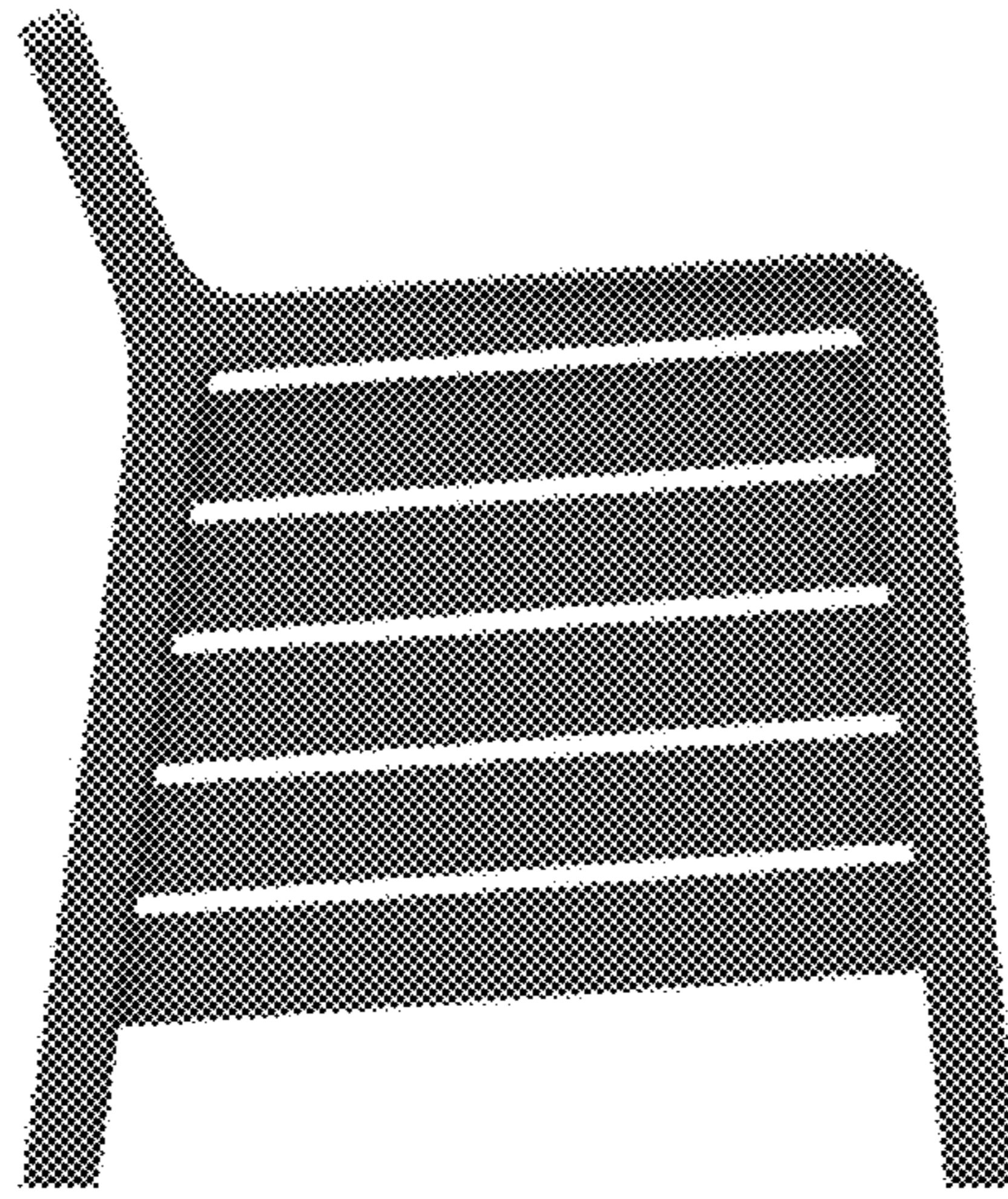

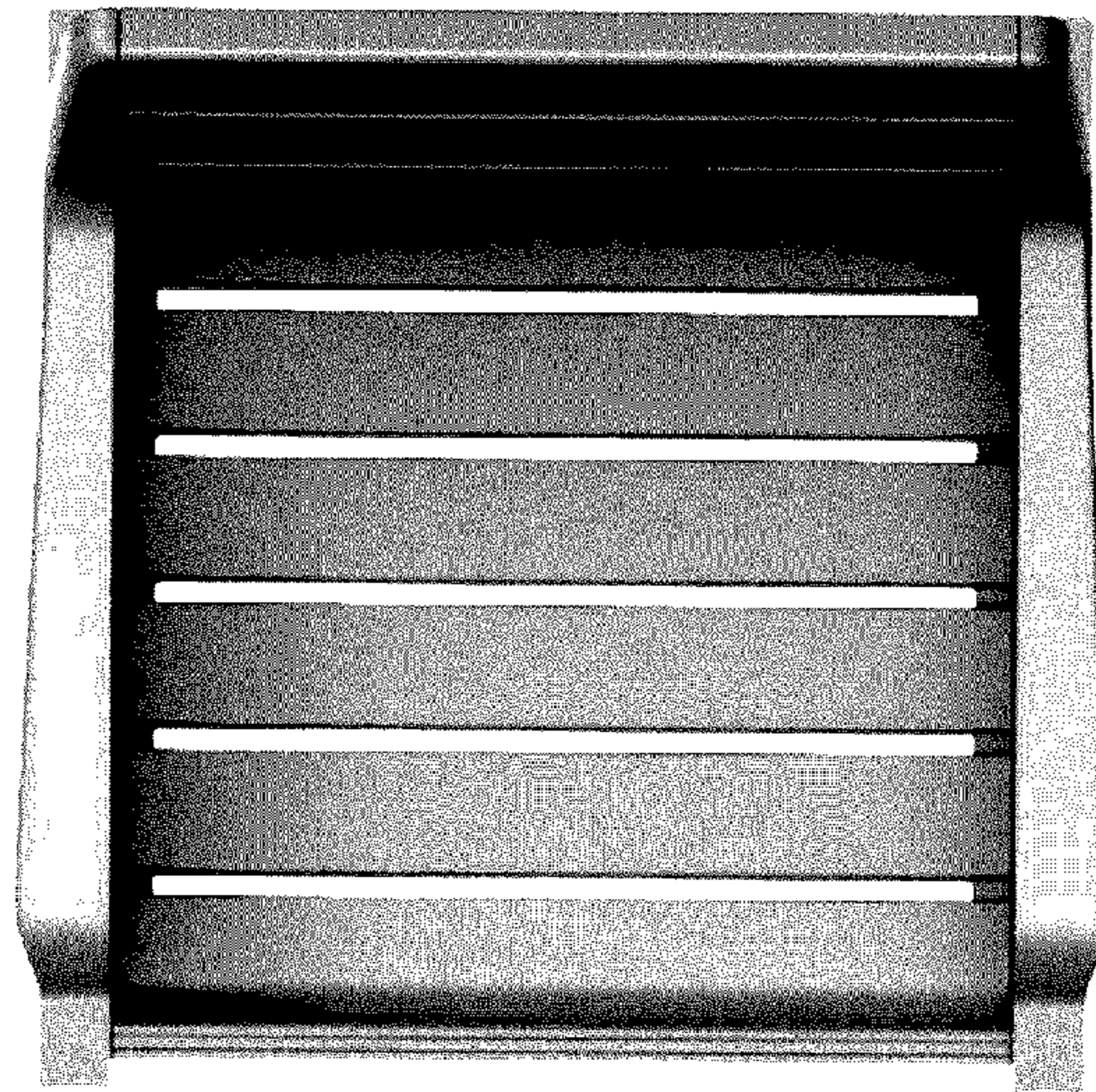

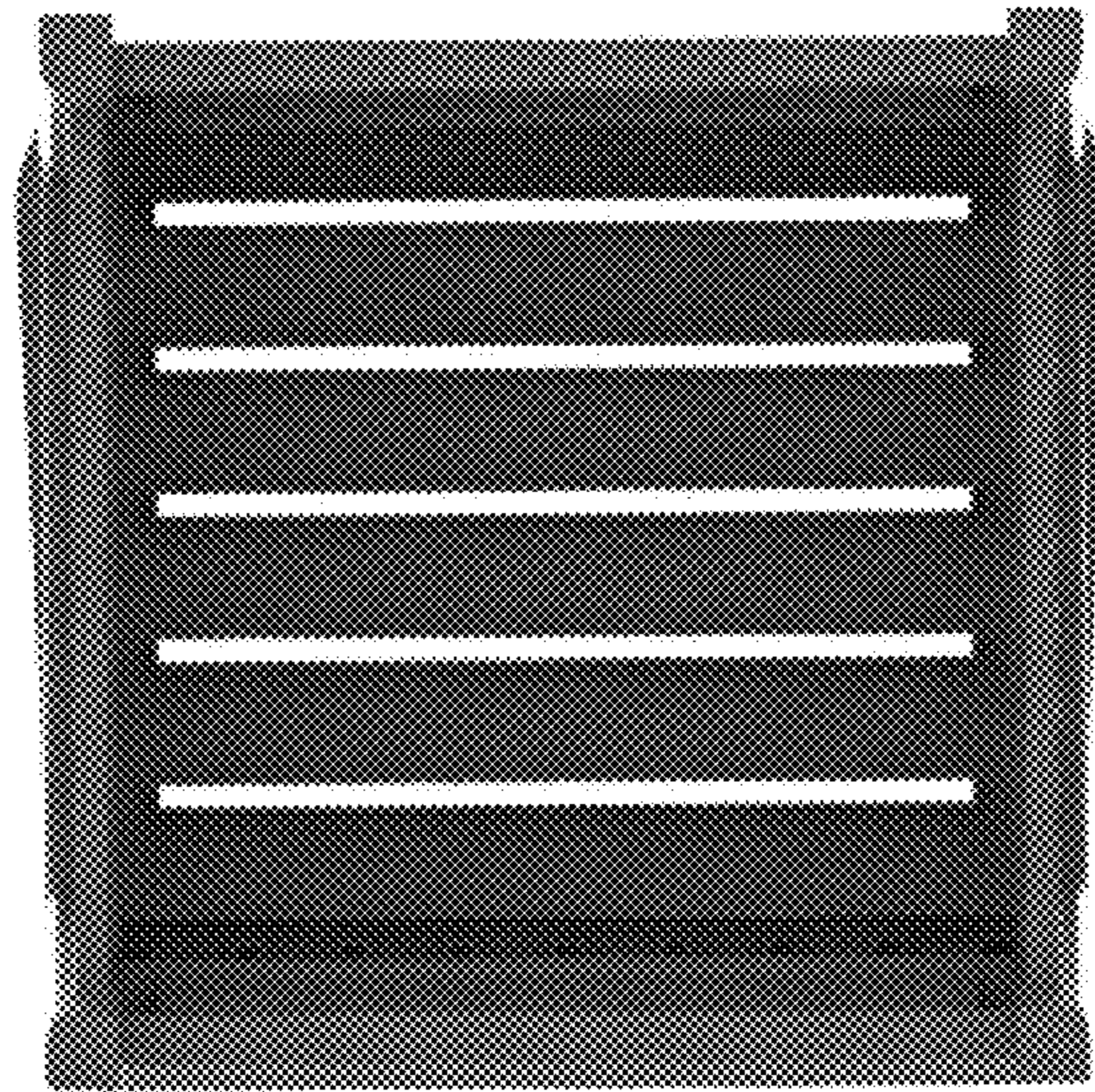

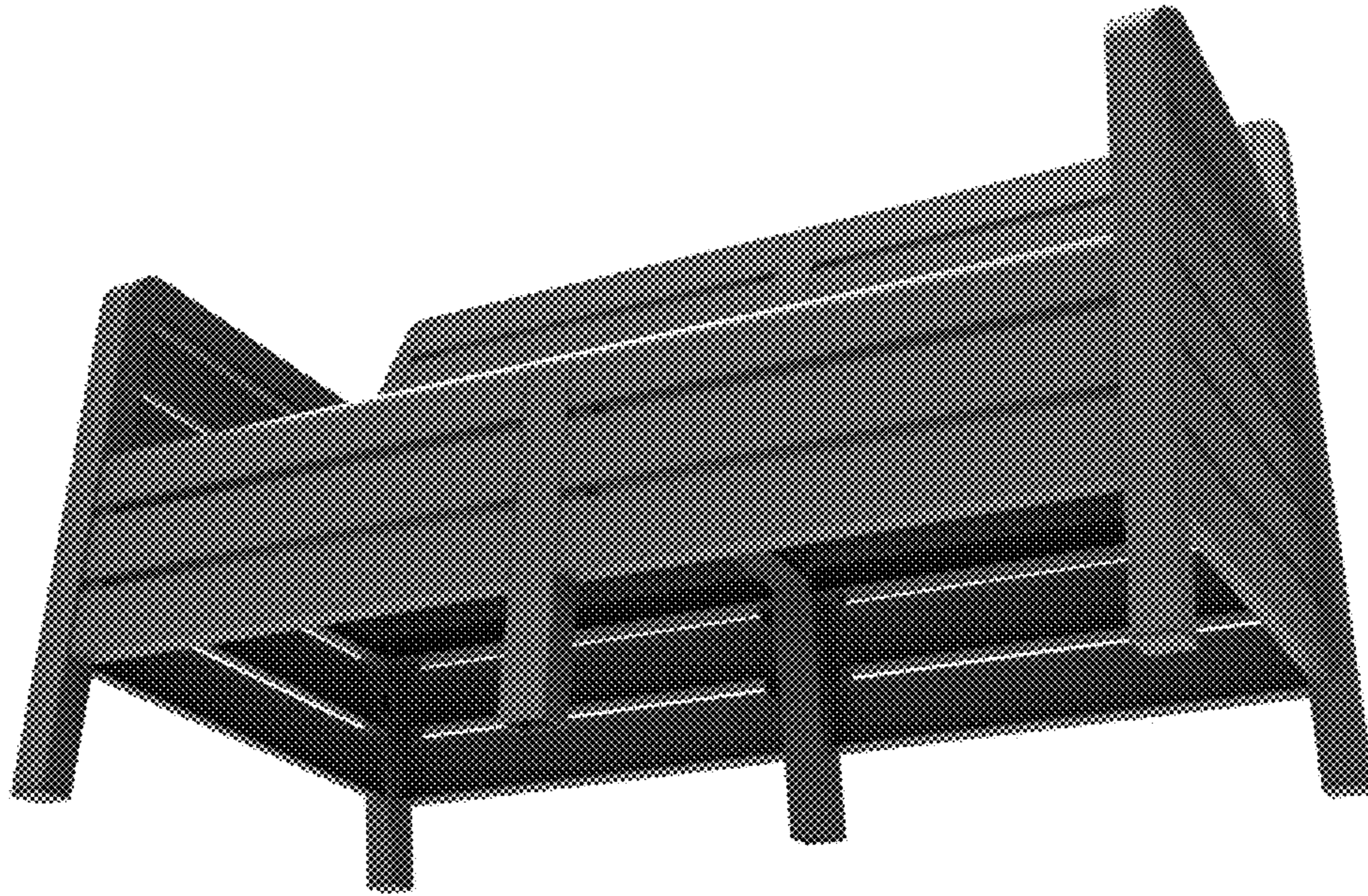

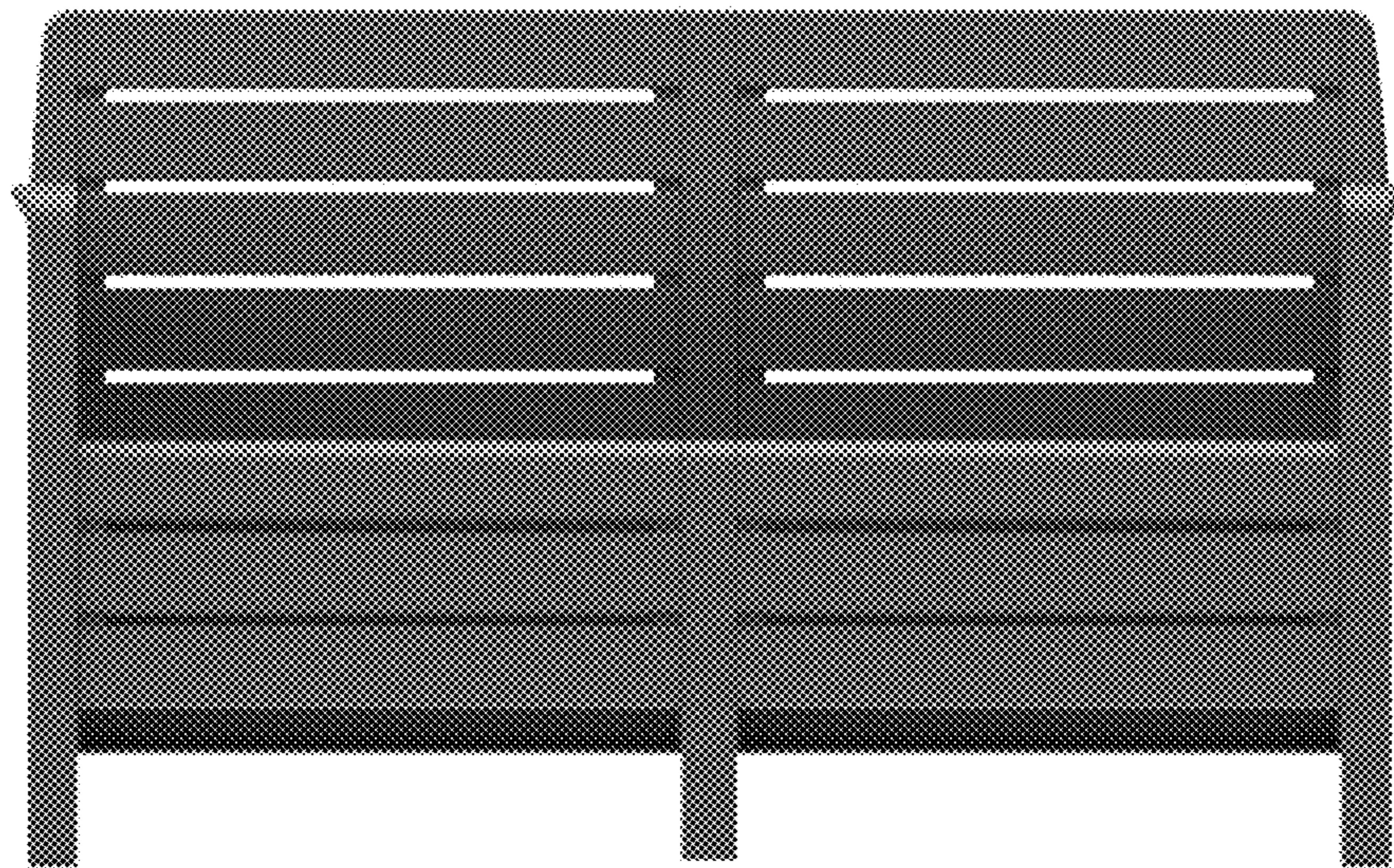

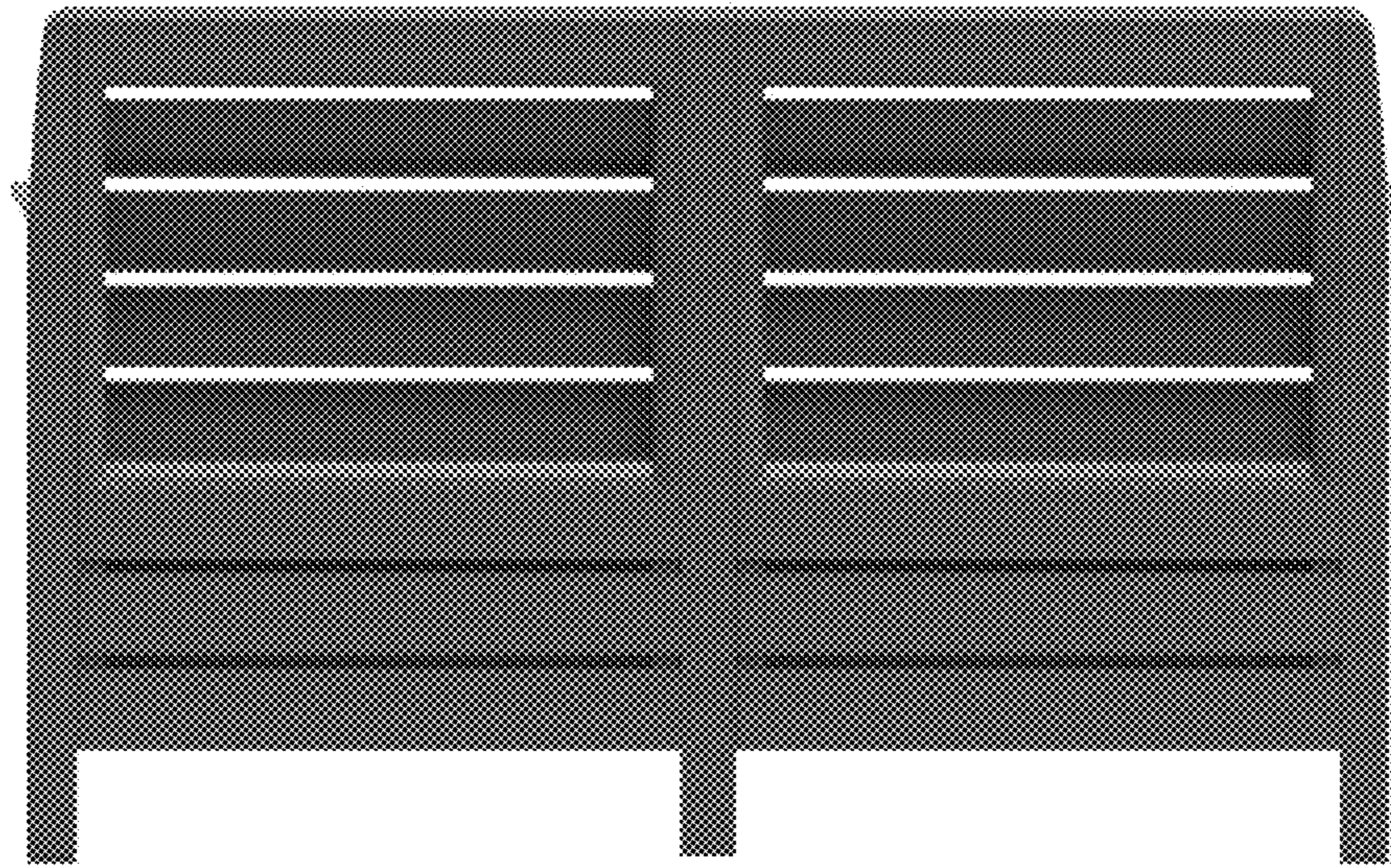

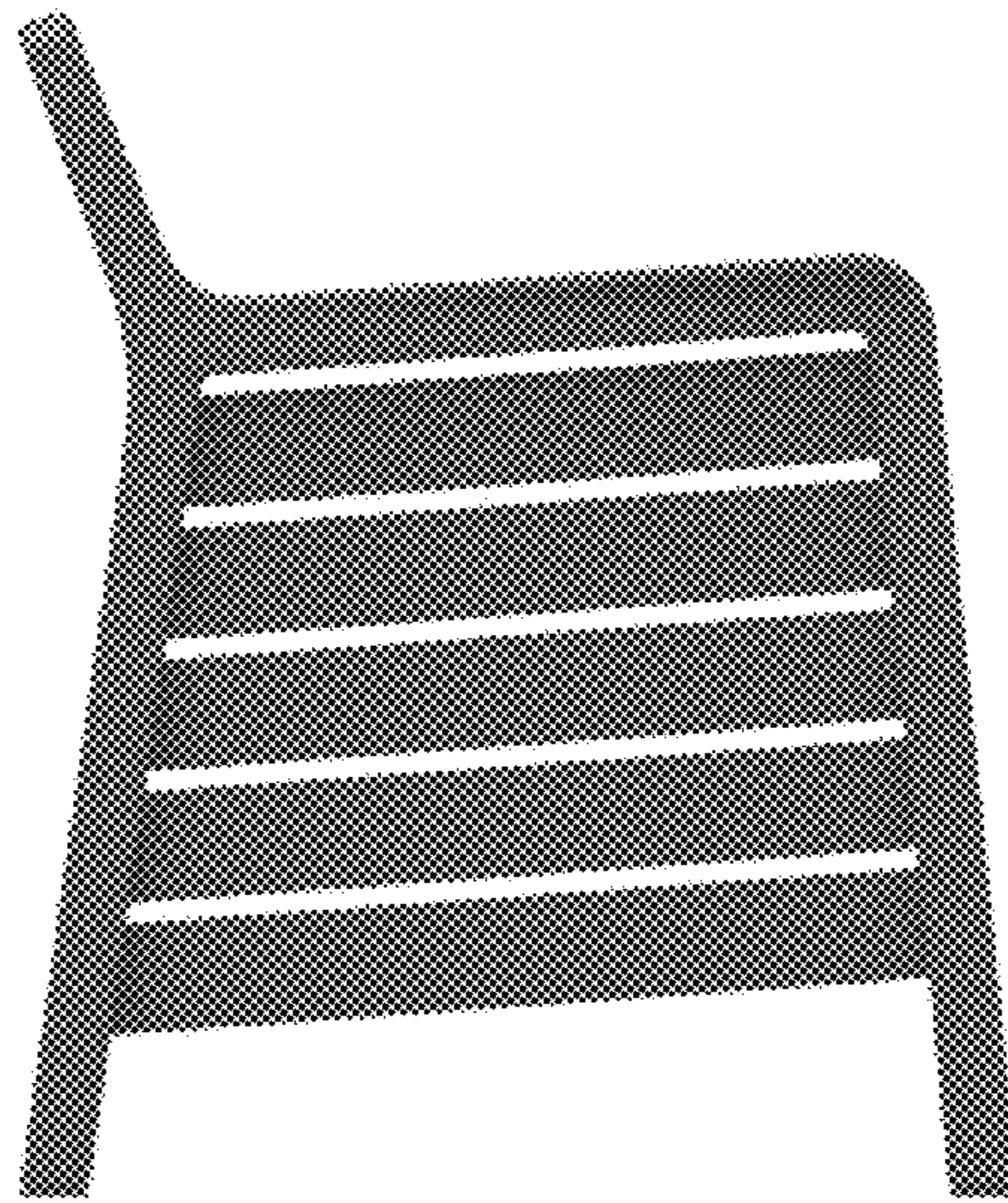

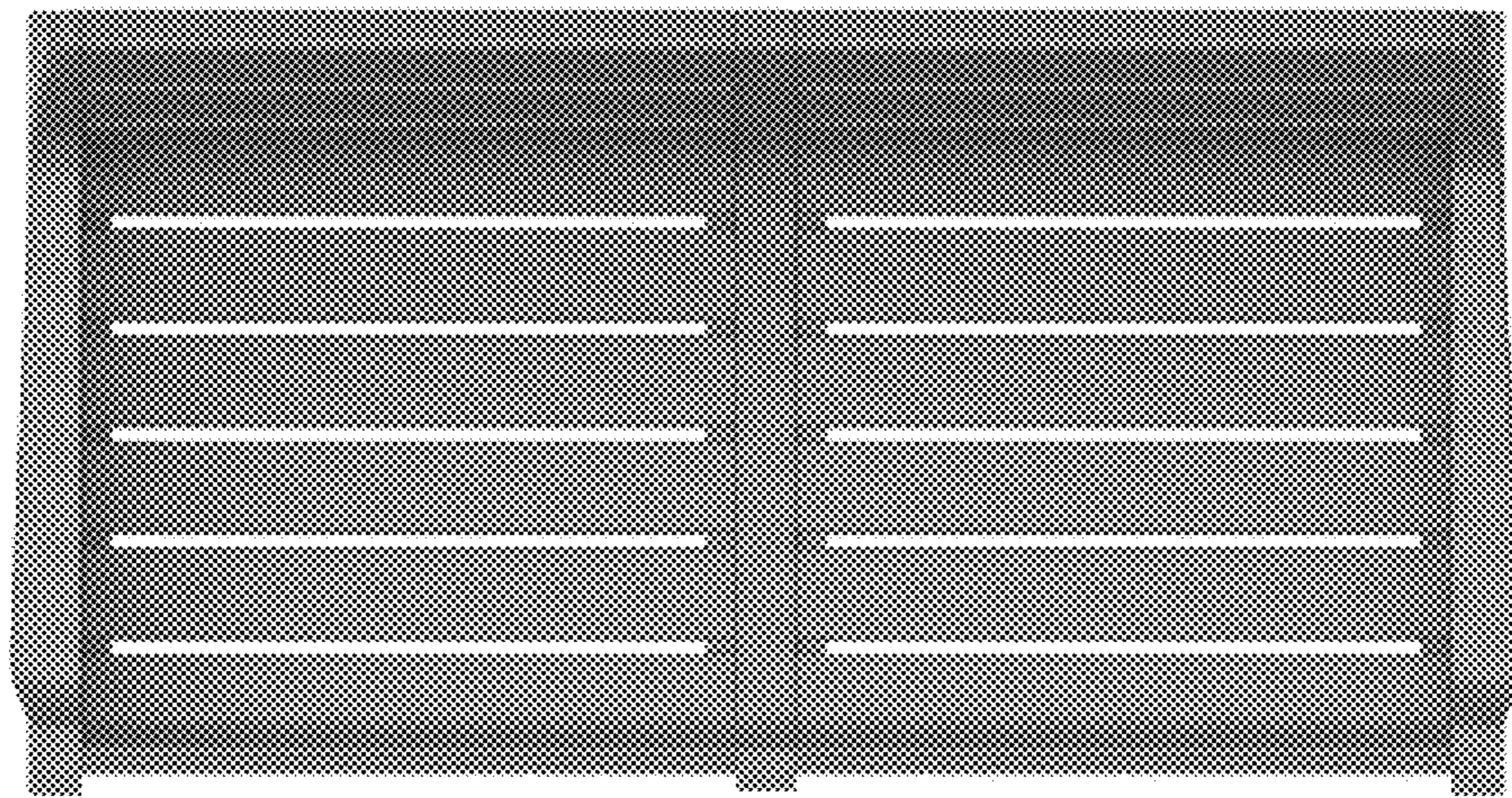

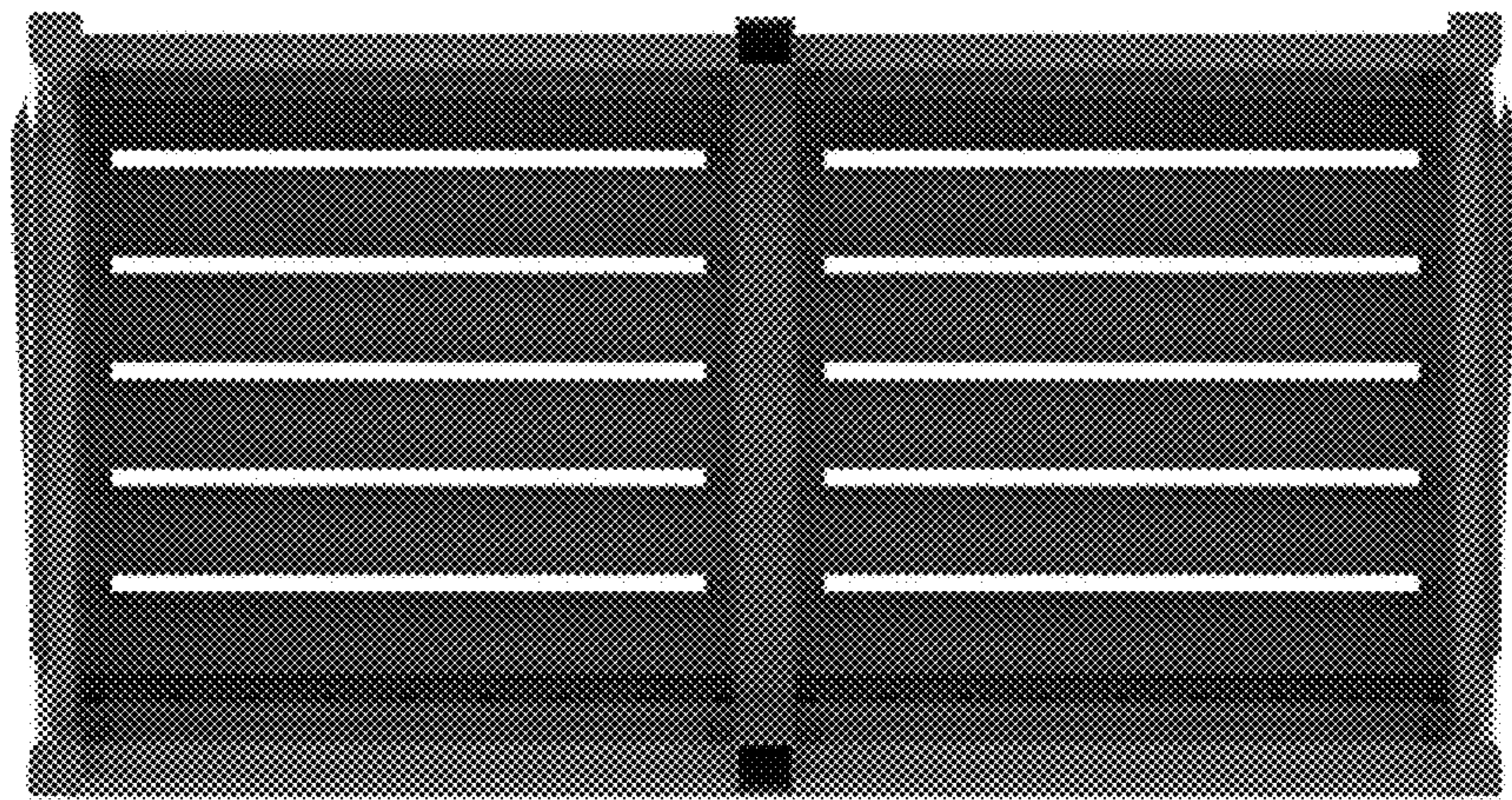

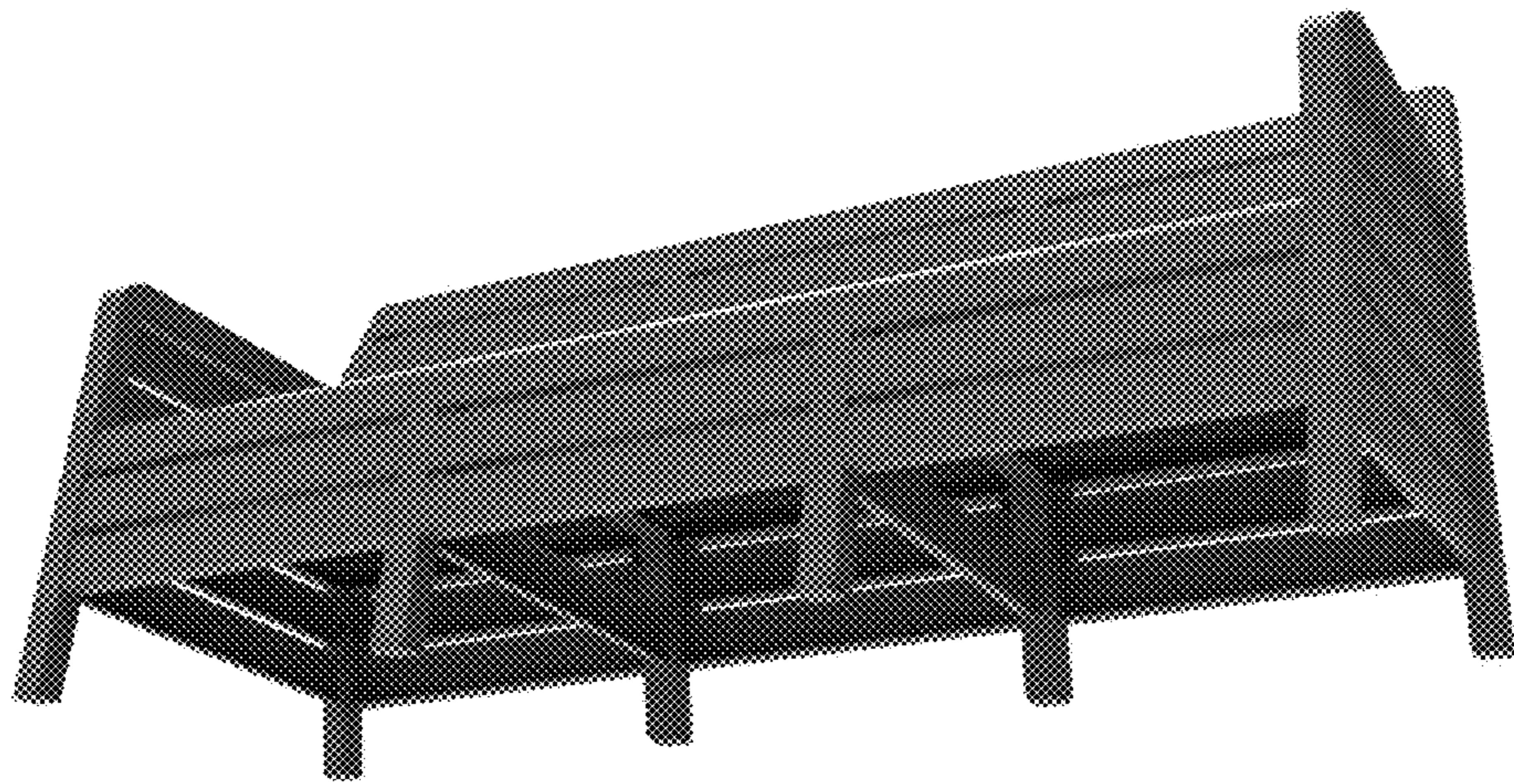

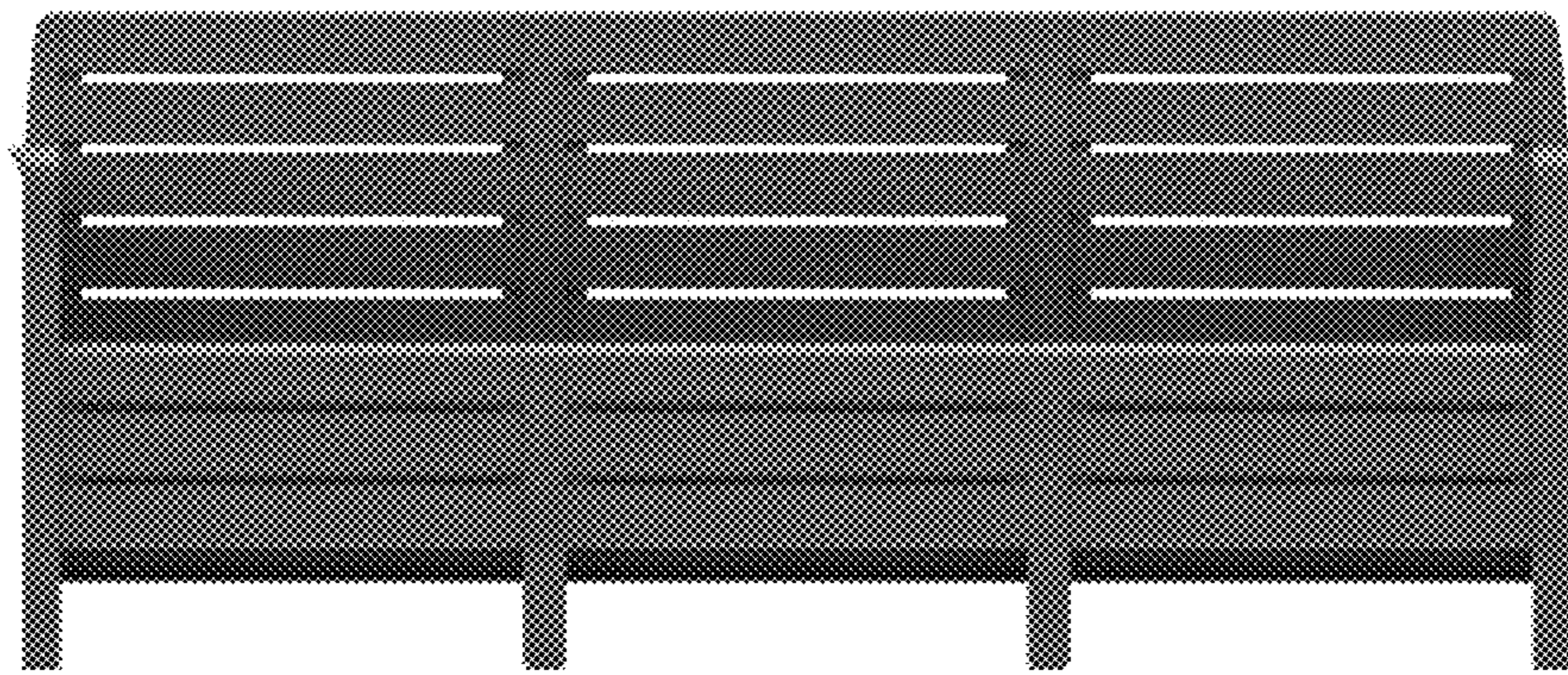

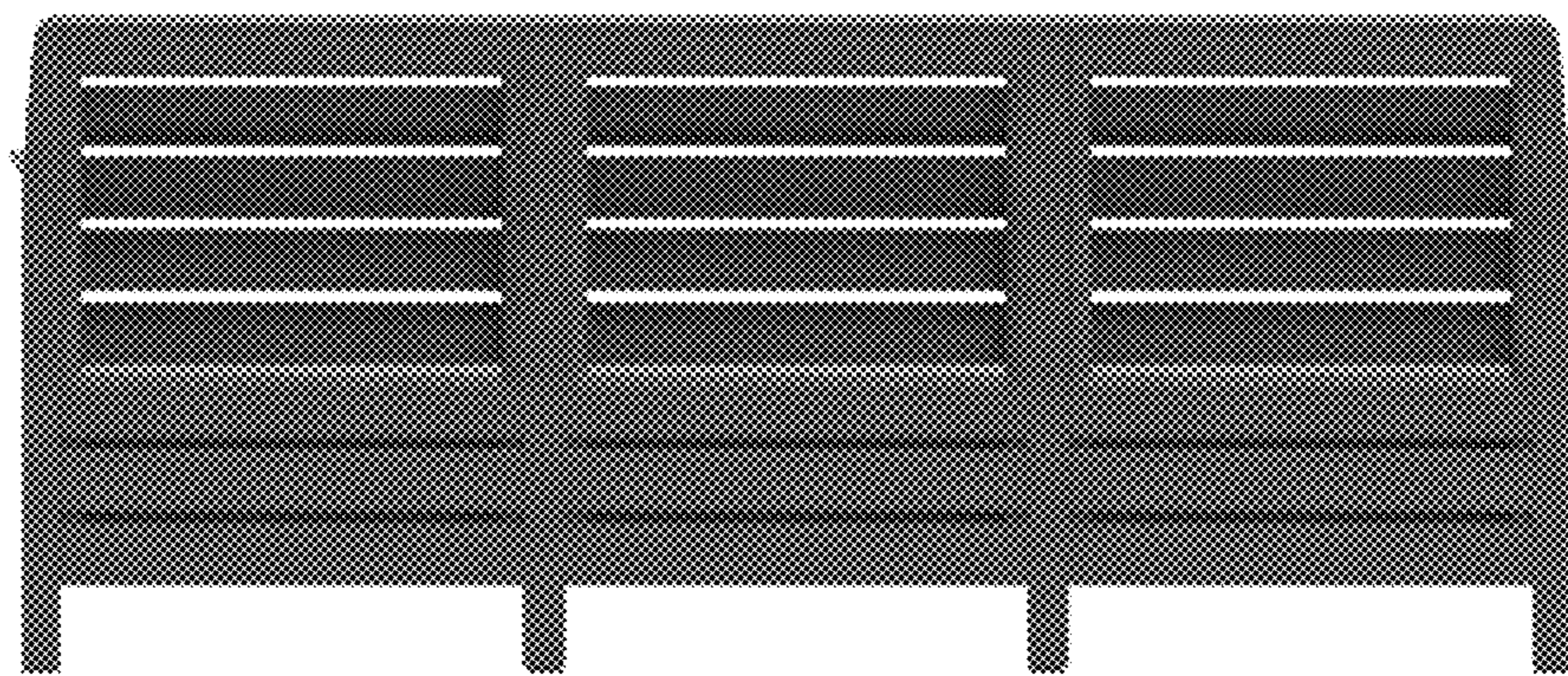

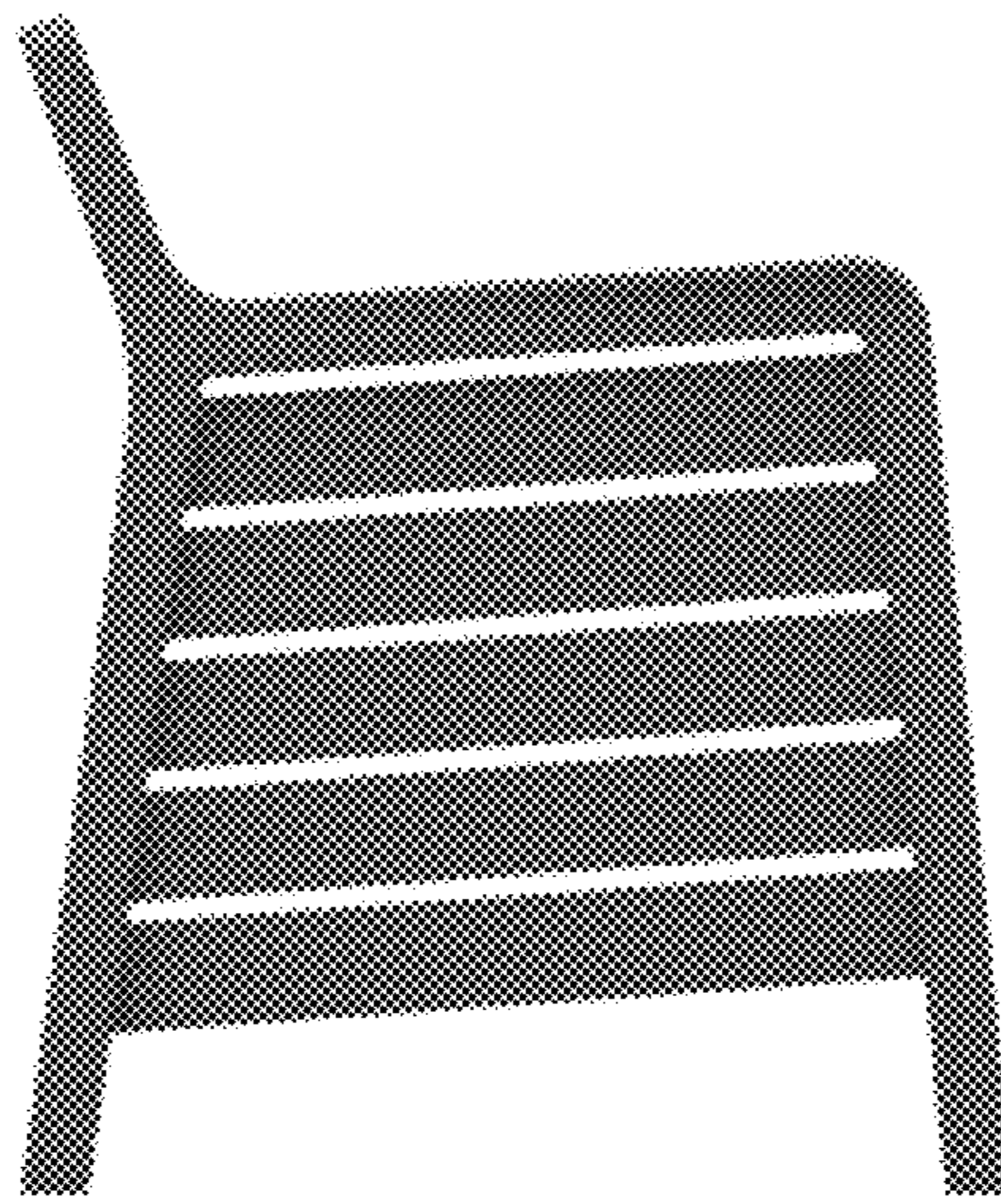

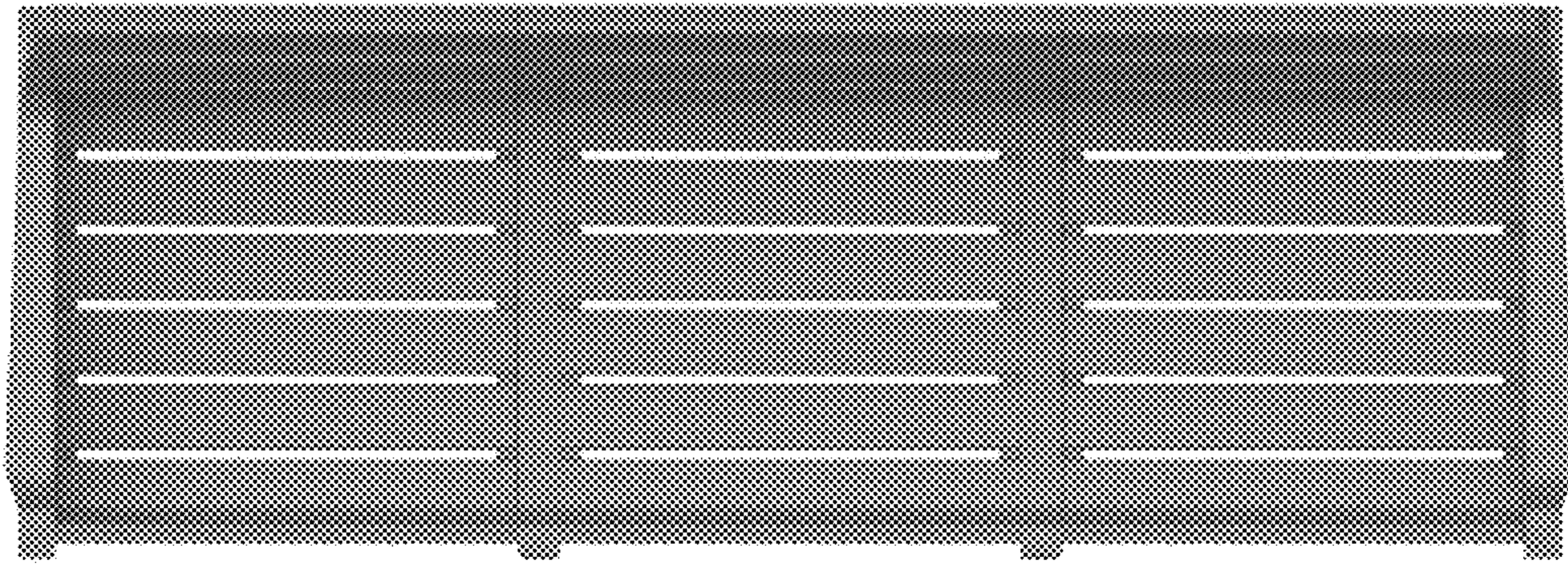

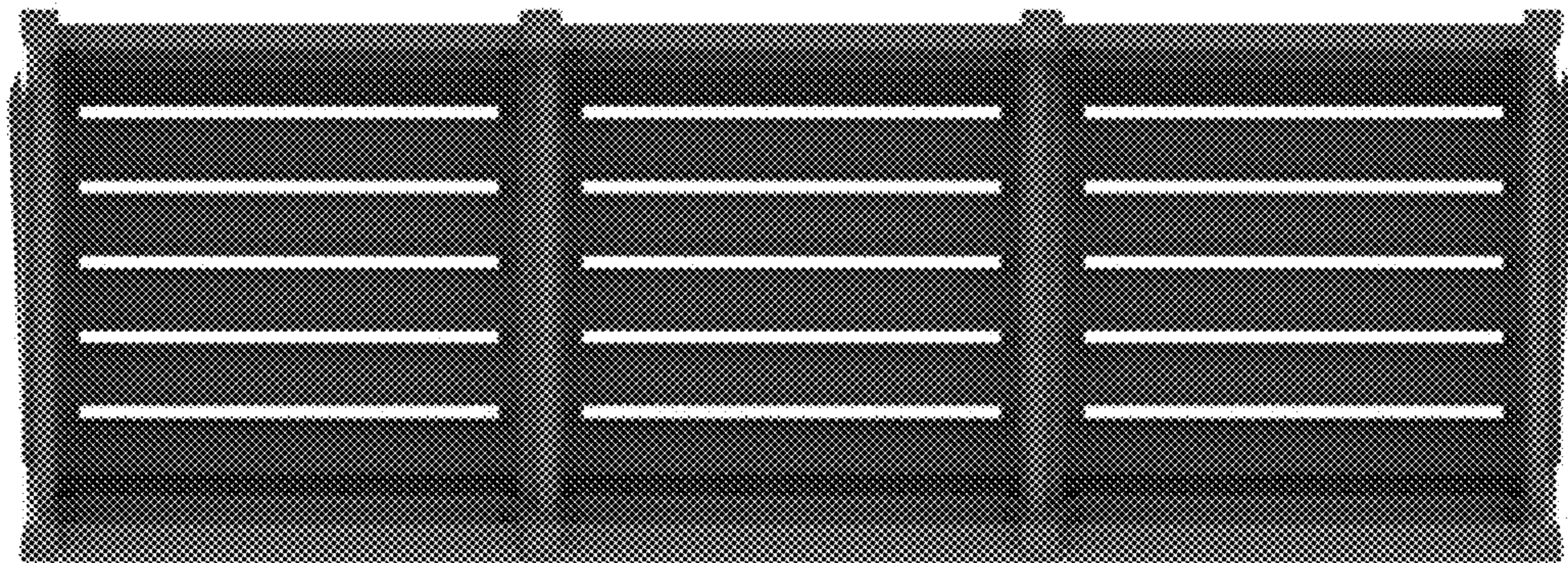
