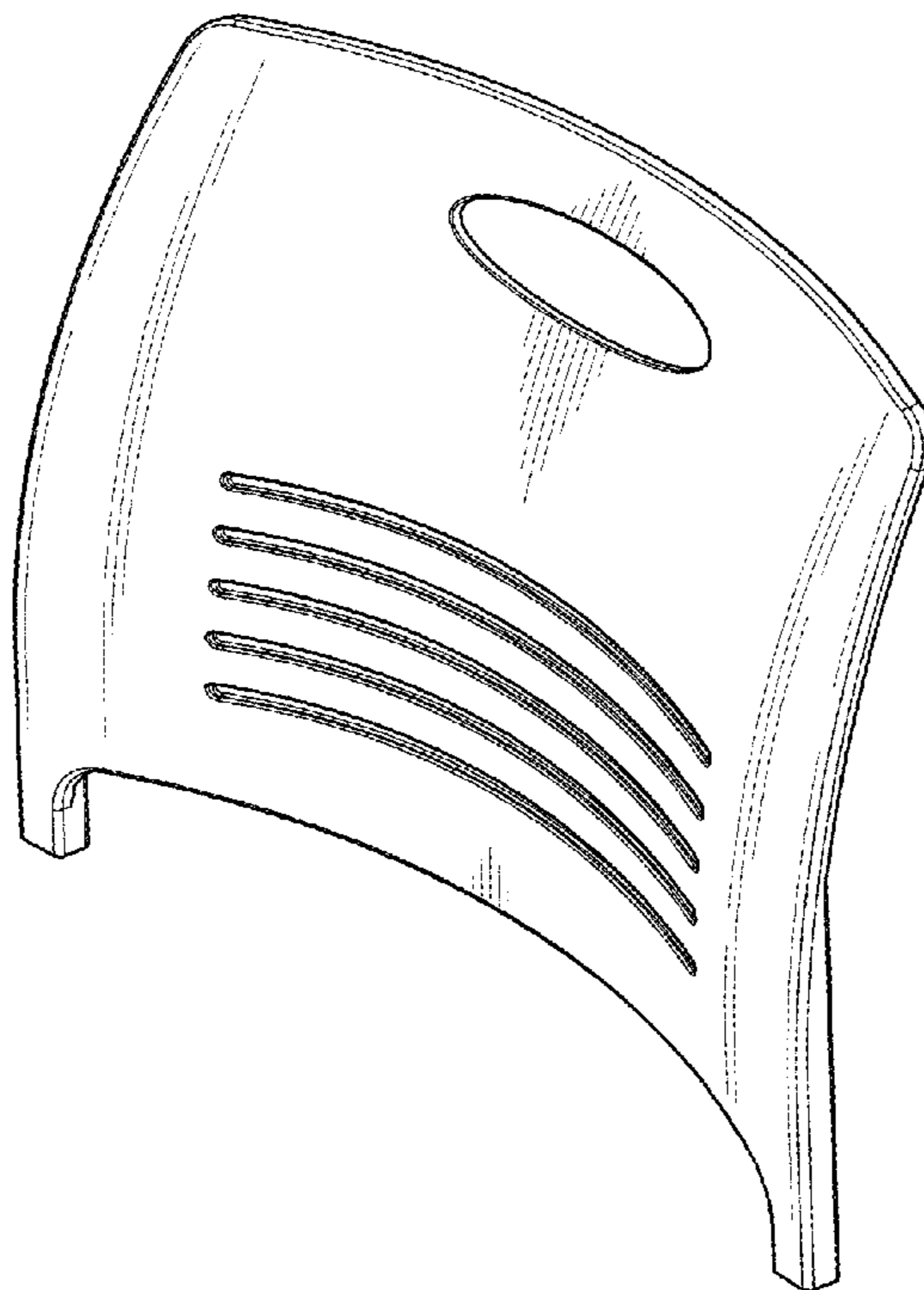
FIG. 9 is a rear perspective view thereof.

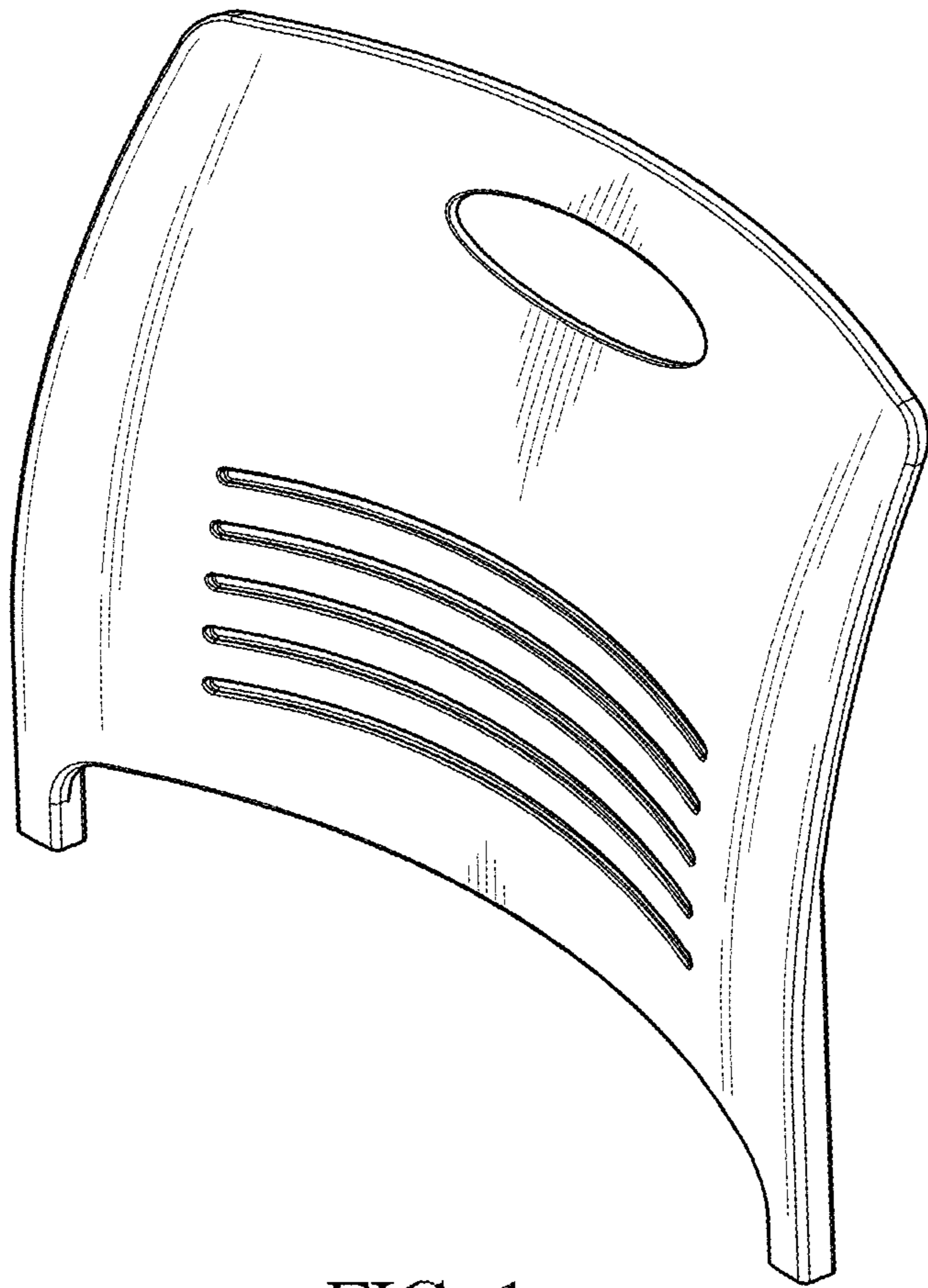

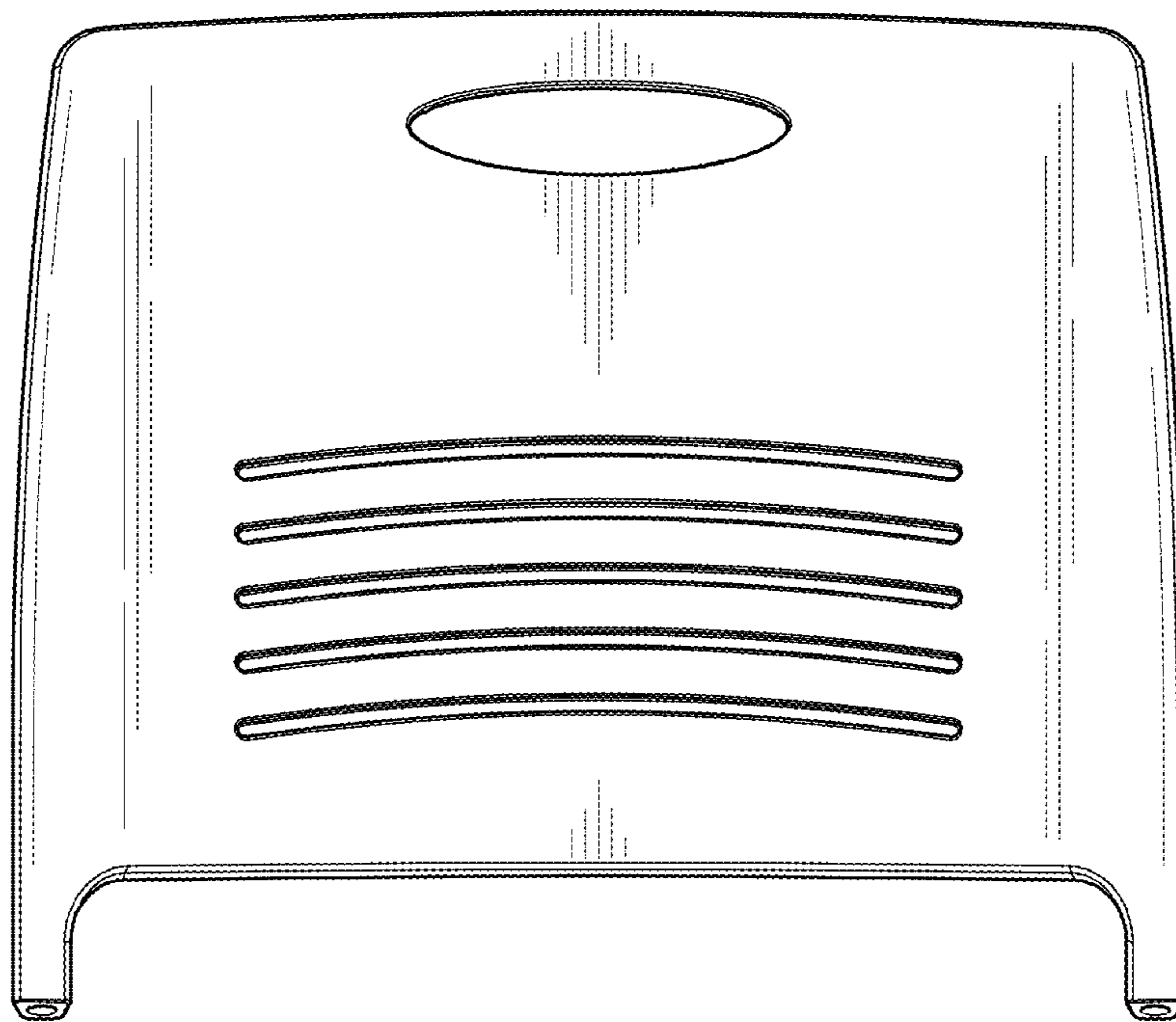

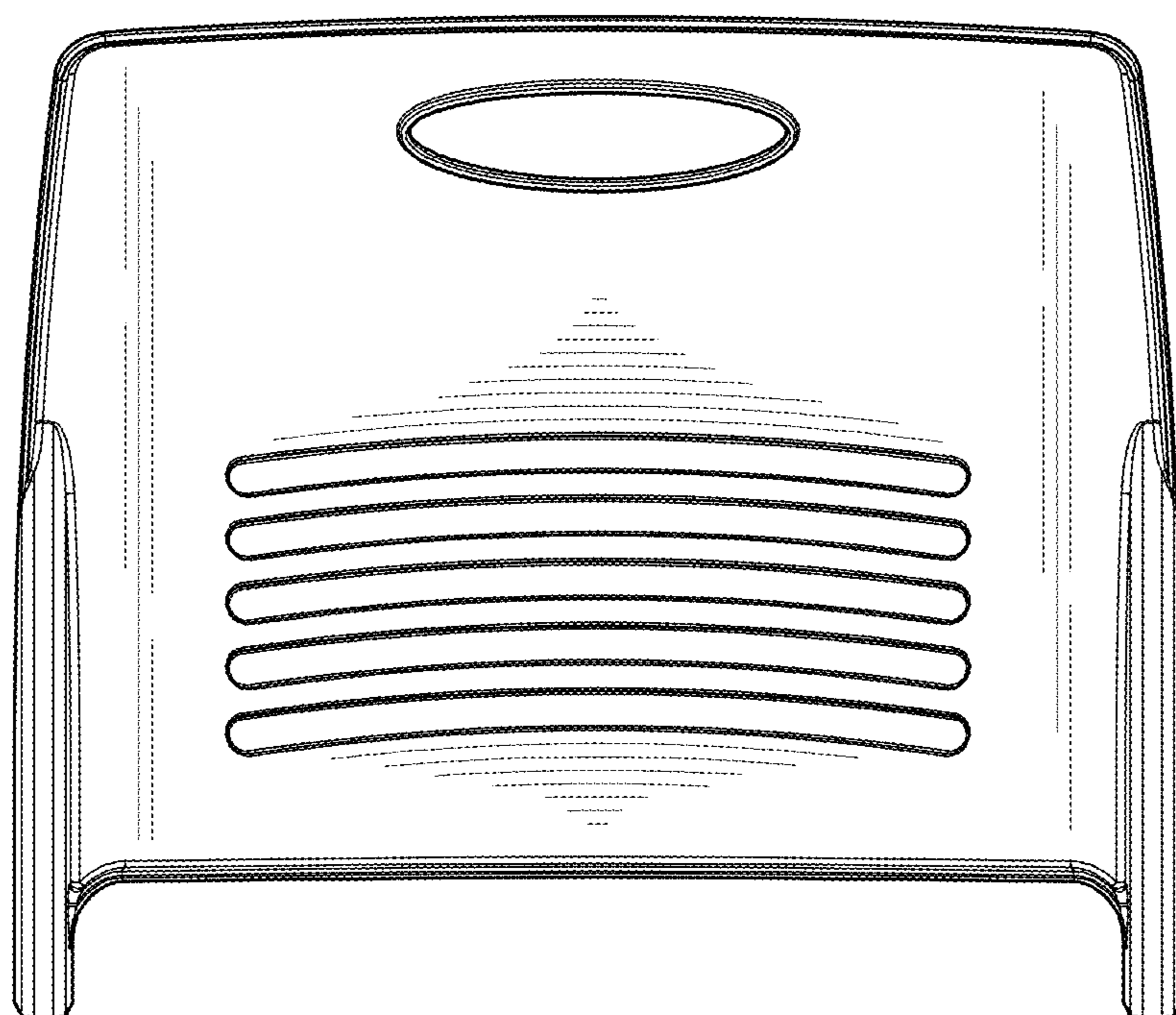

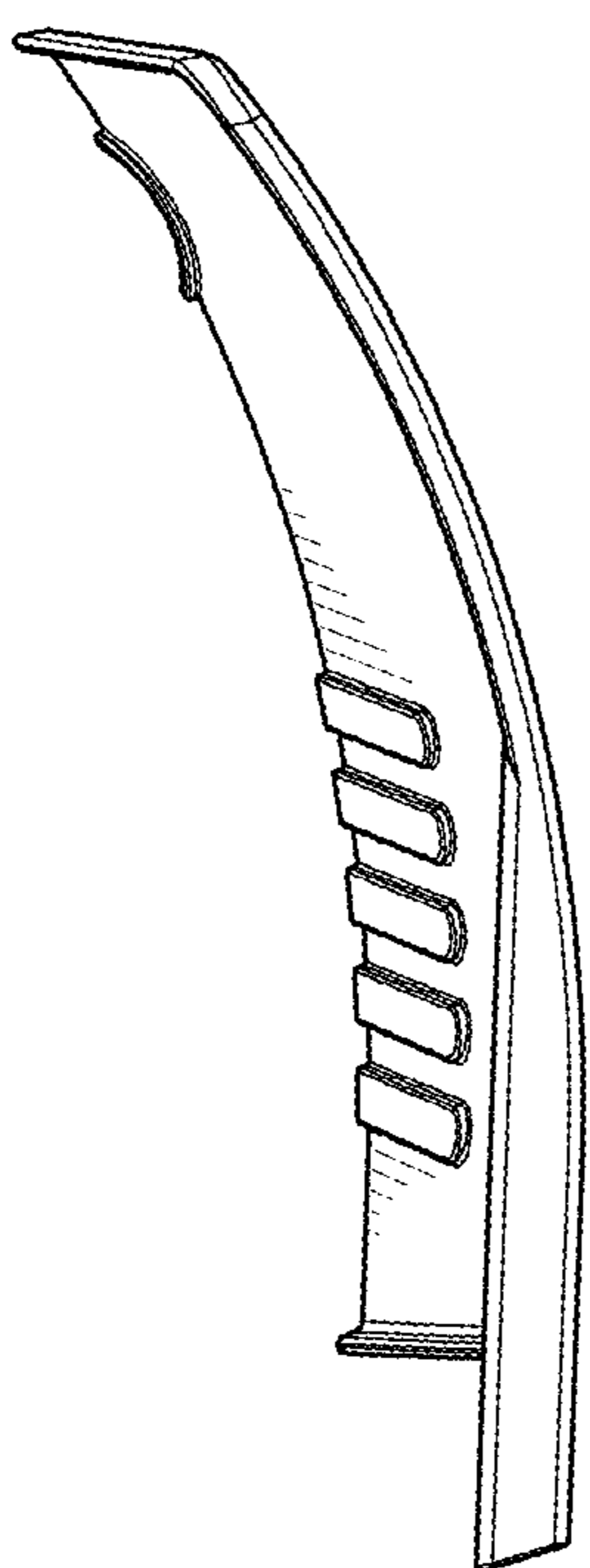

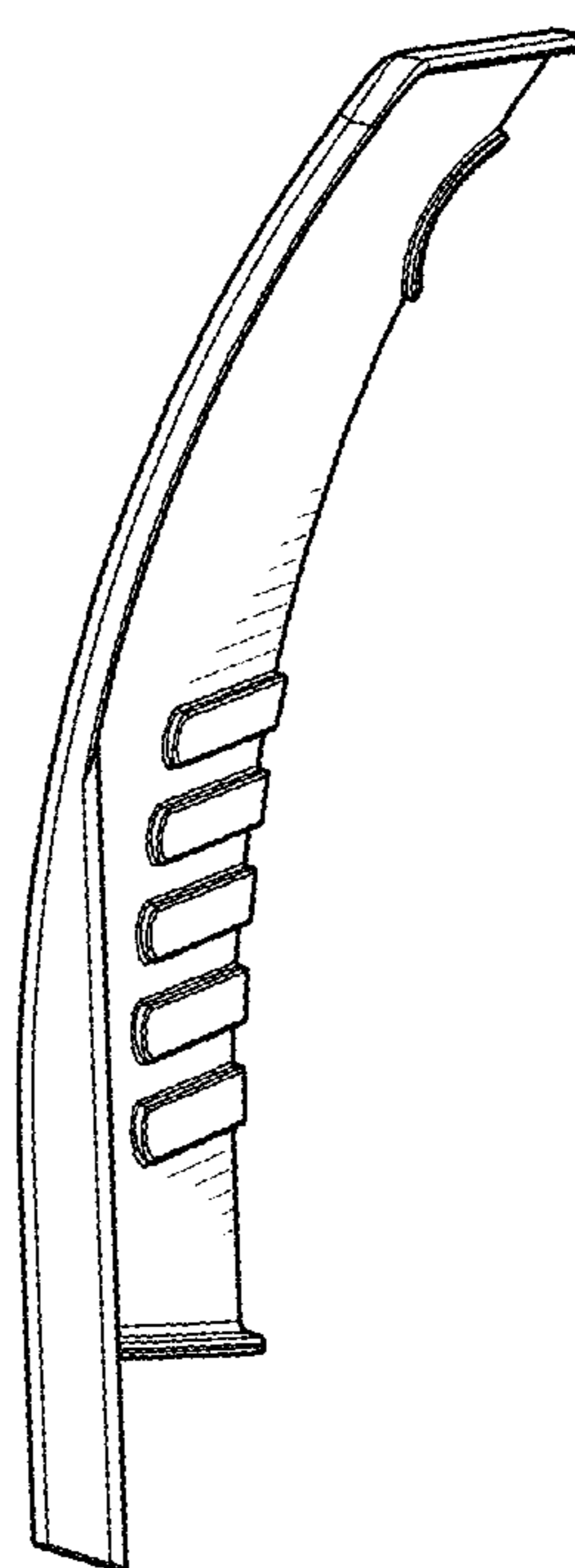

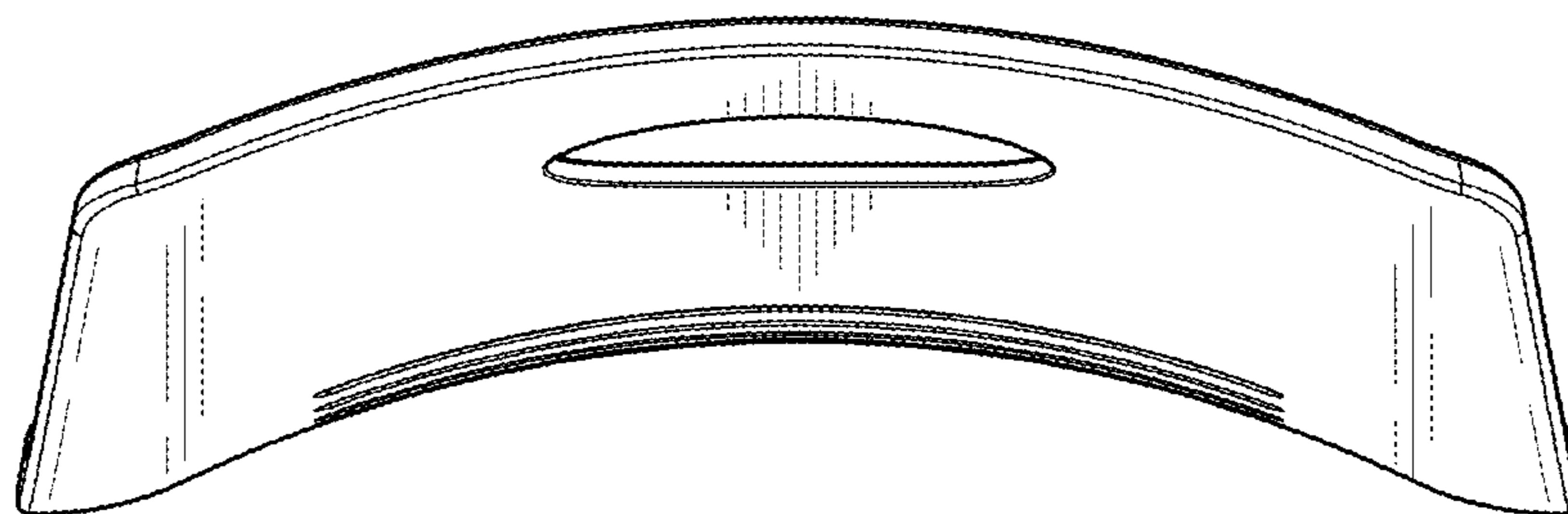

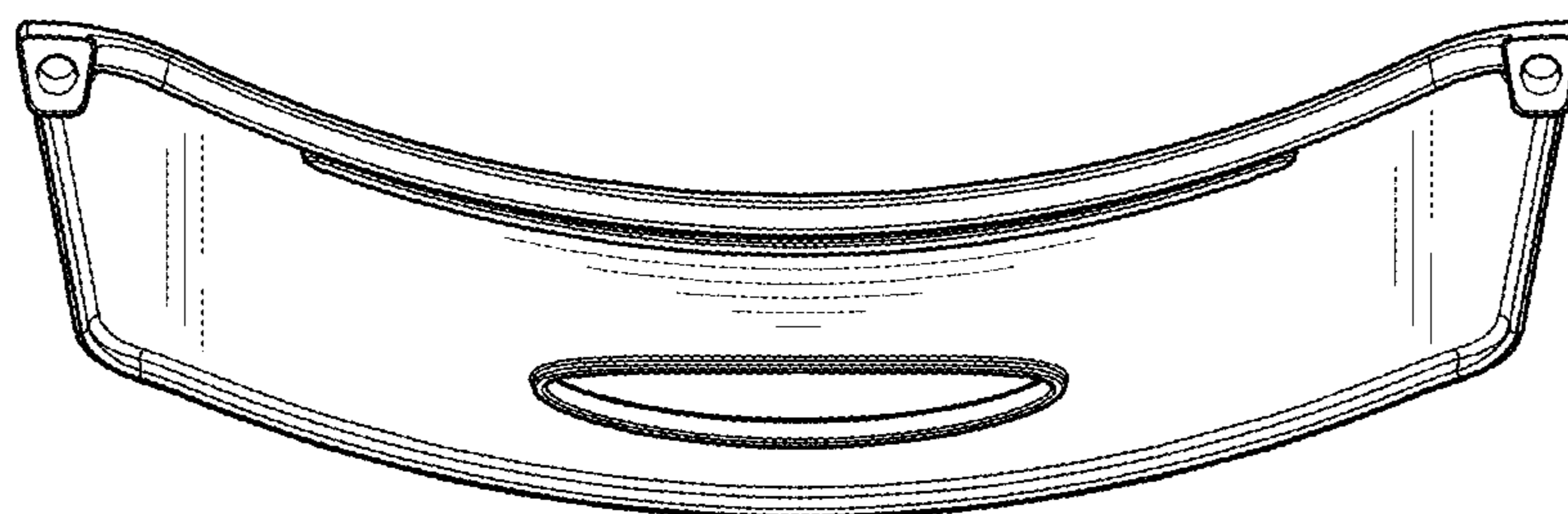

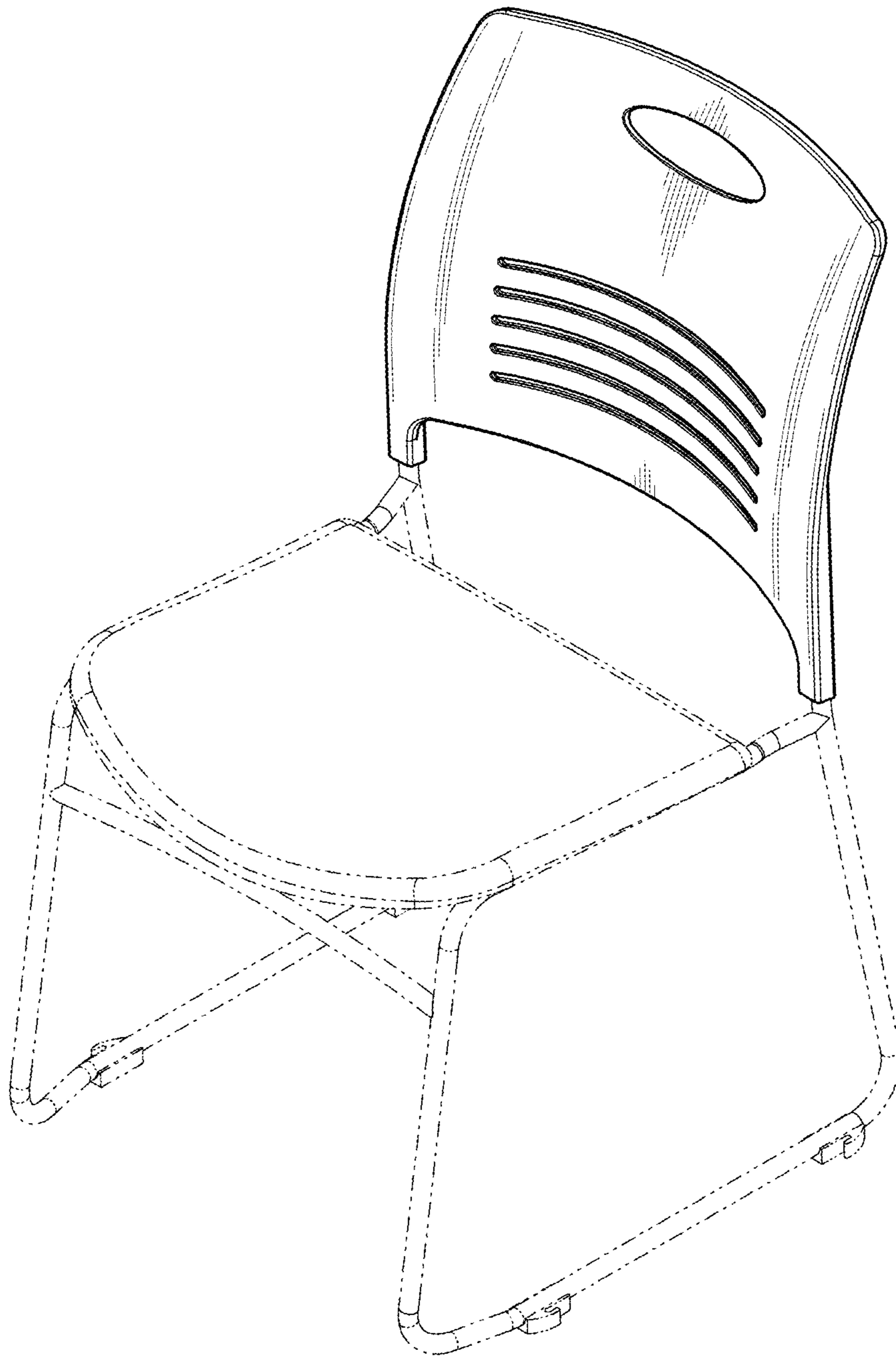

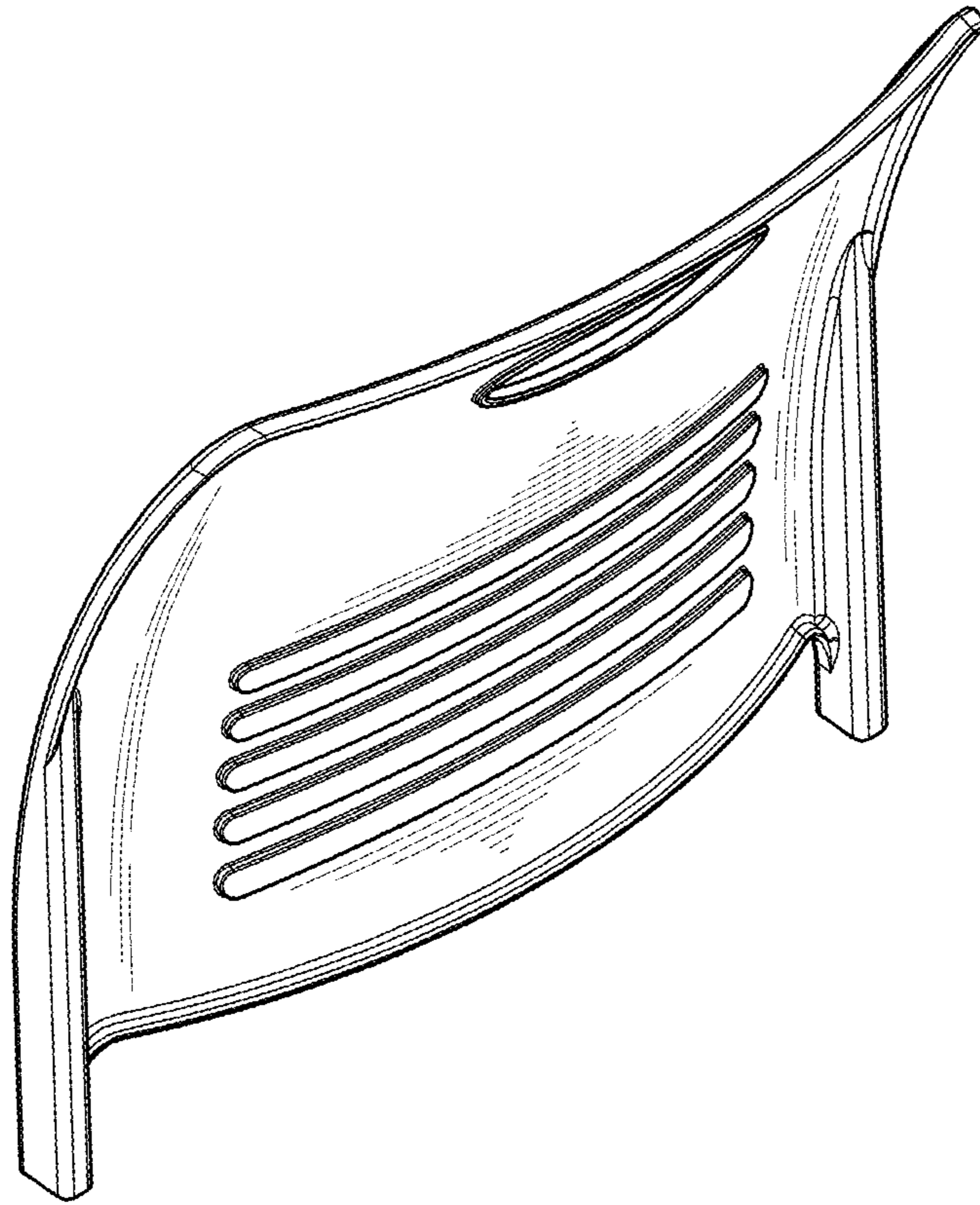
