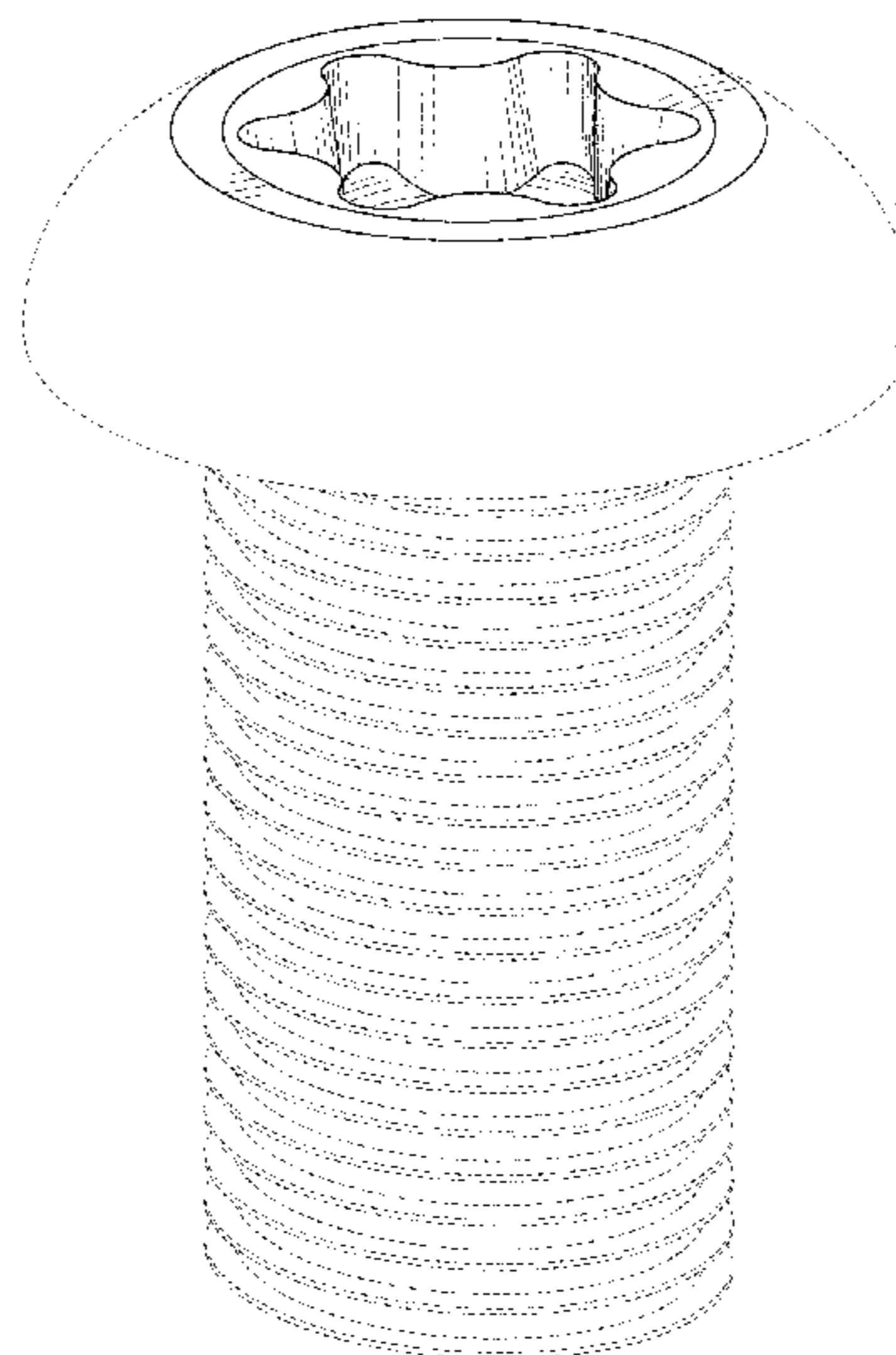
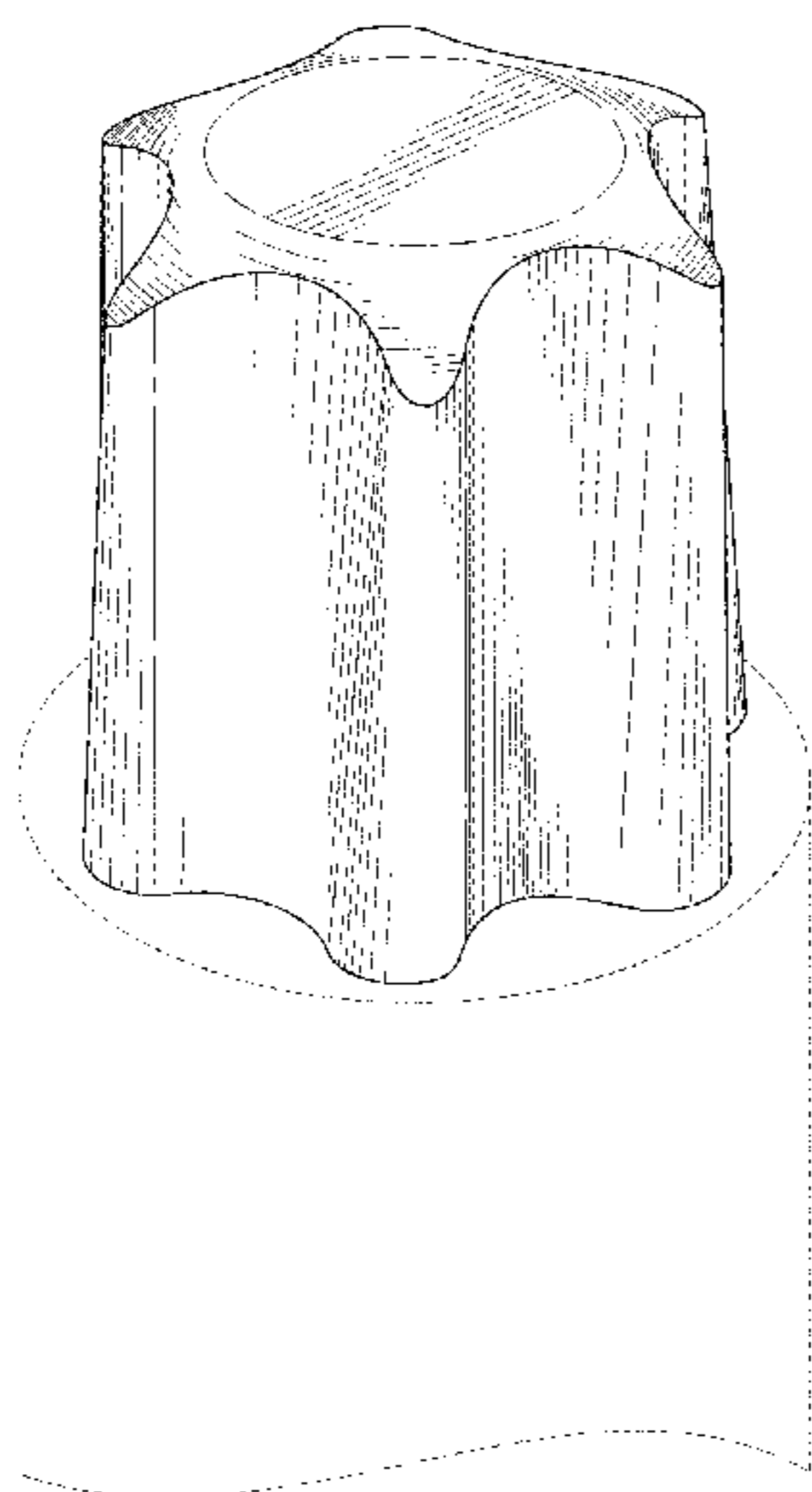
(57) **CLAIM**

The ornamental design for a combination fastener and mating driving tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a six fin driving tool; FIG. 2 is a left side view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top view thereof; FIG. 7 is a perspective view of a fastener having six recessed receiving areas; FIG. 8 is a side view of the fastener in FIG. 7, wherein the opposite side, front, and rear views are identical; and, FIG. 9 is a top view of the fastener shown in FIG. 7. The broken lines in the drawings illustrate portions of the combination fastener and mating driving tool that form no part of the claim.

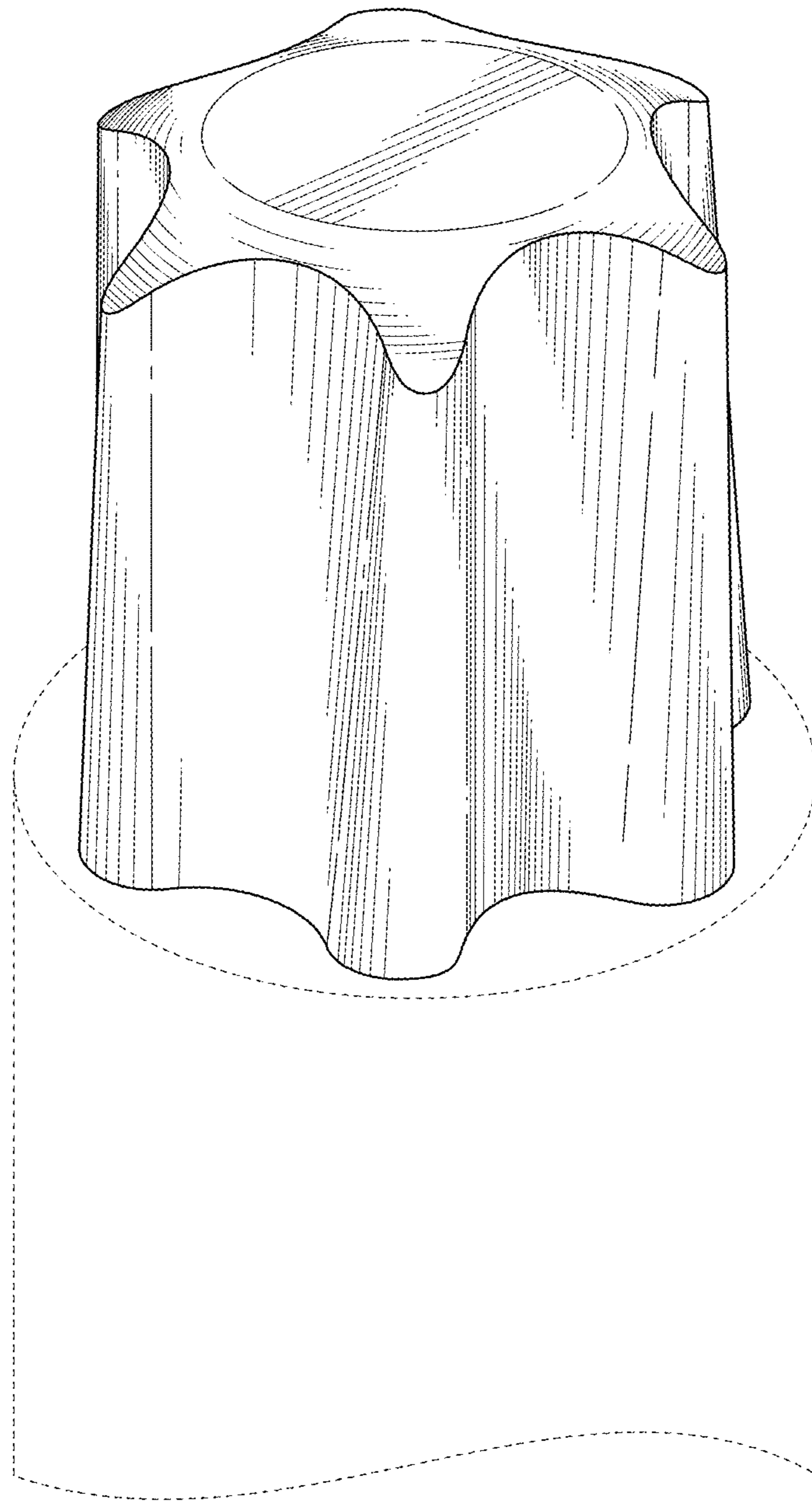

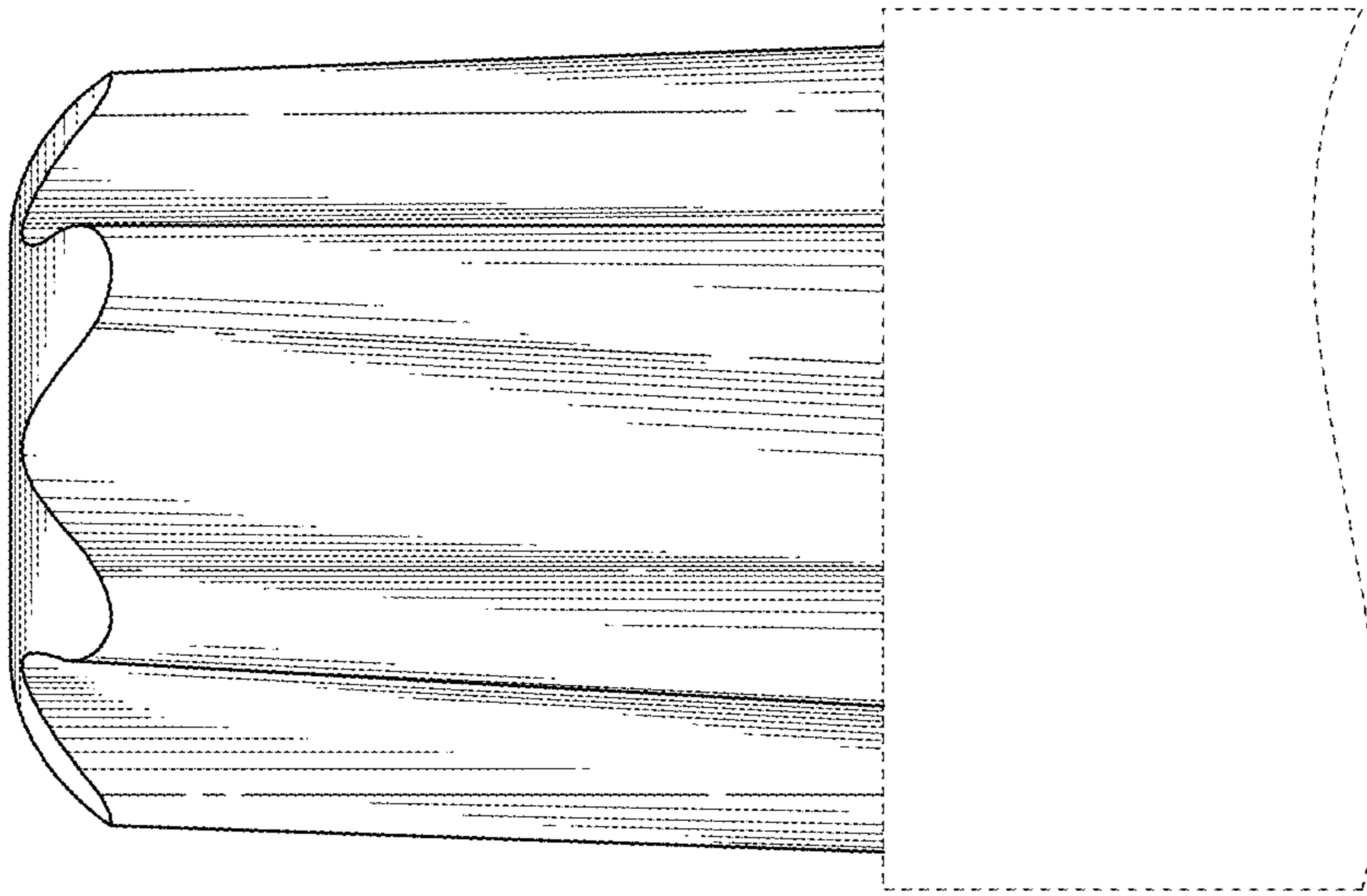

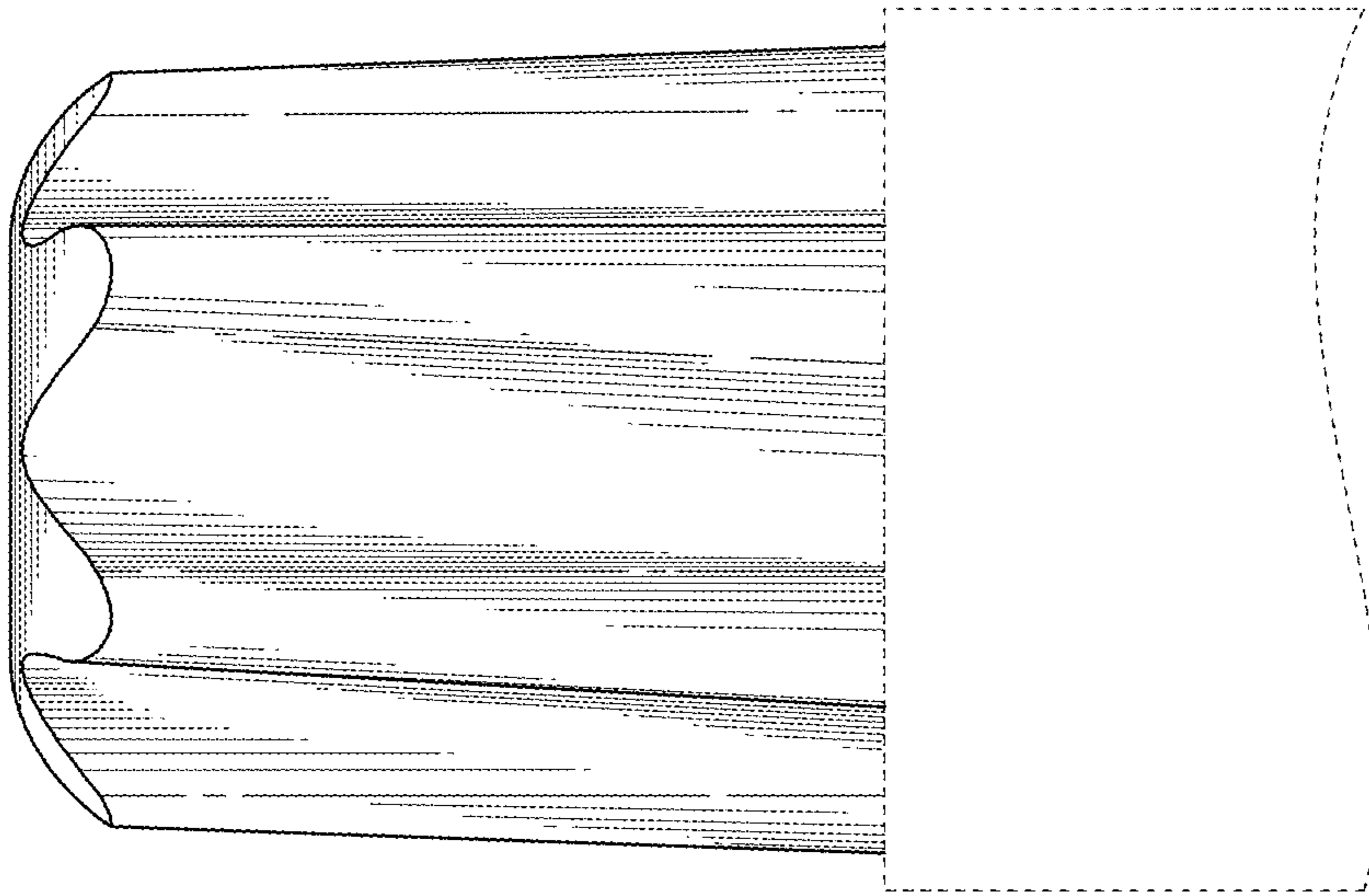

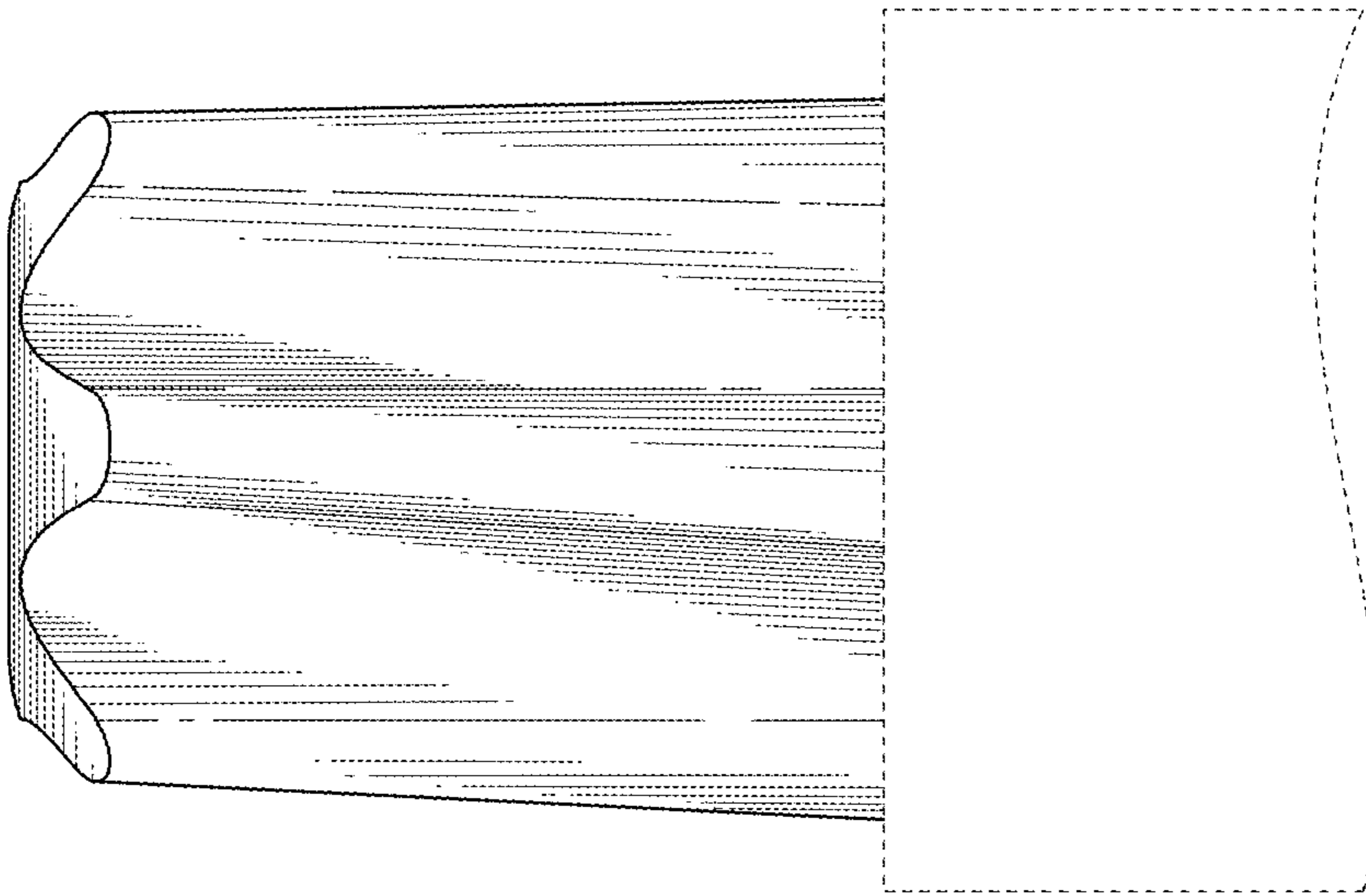

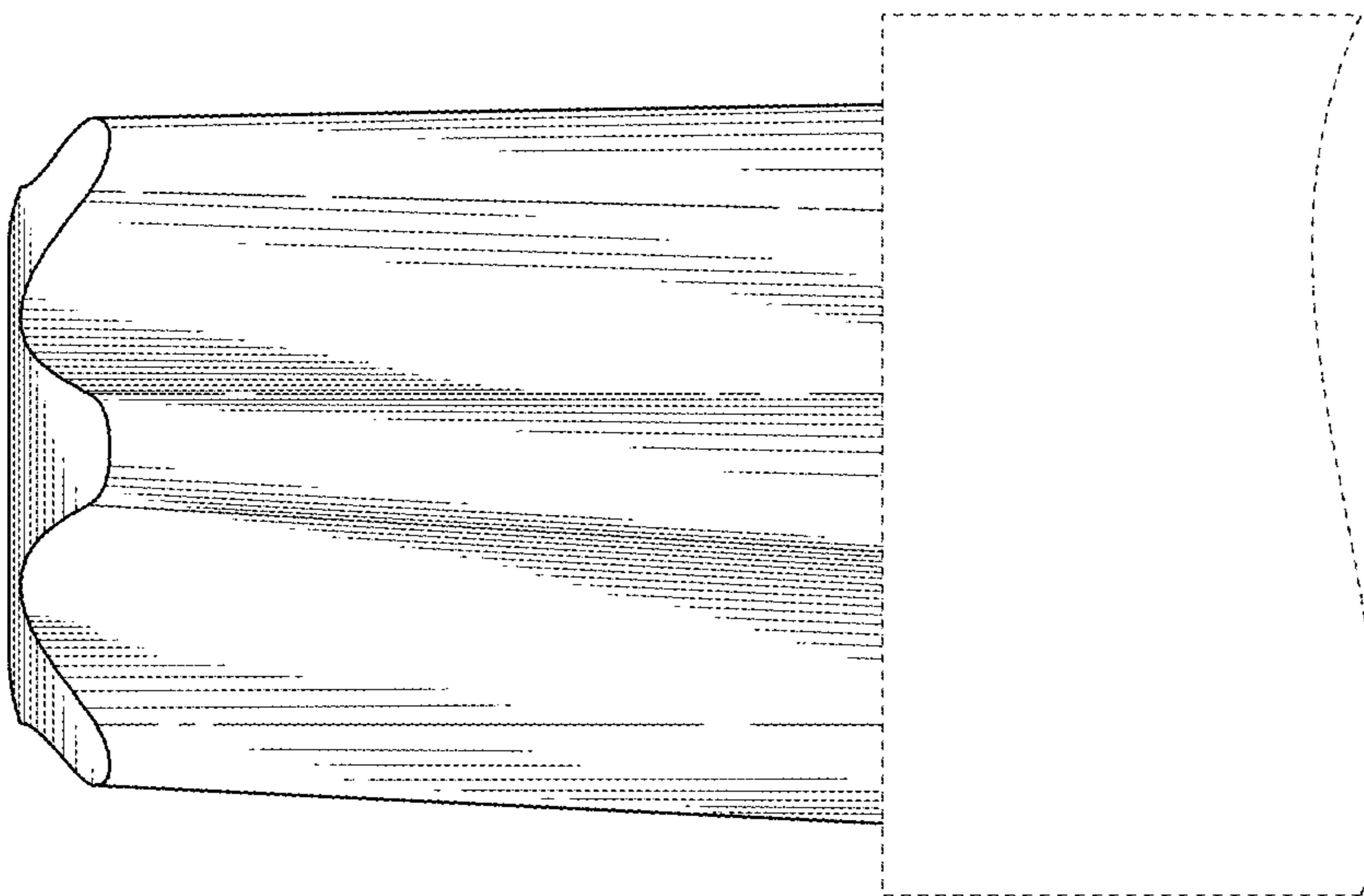

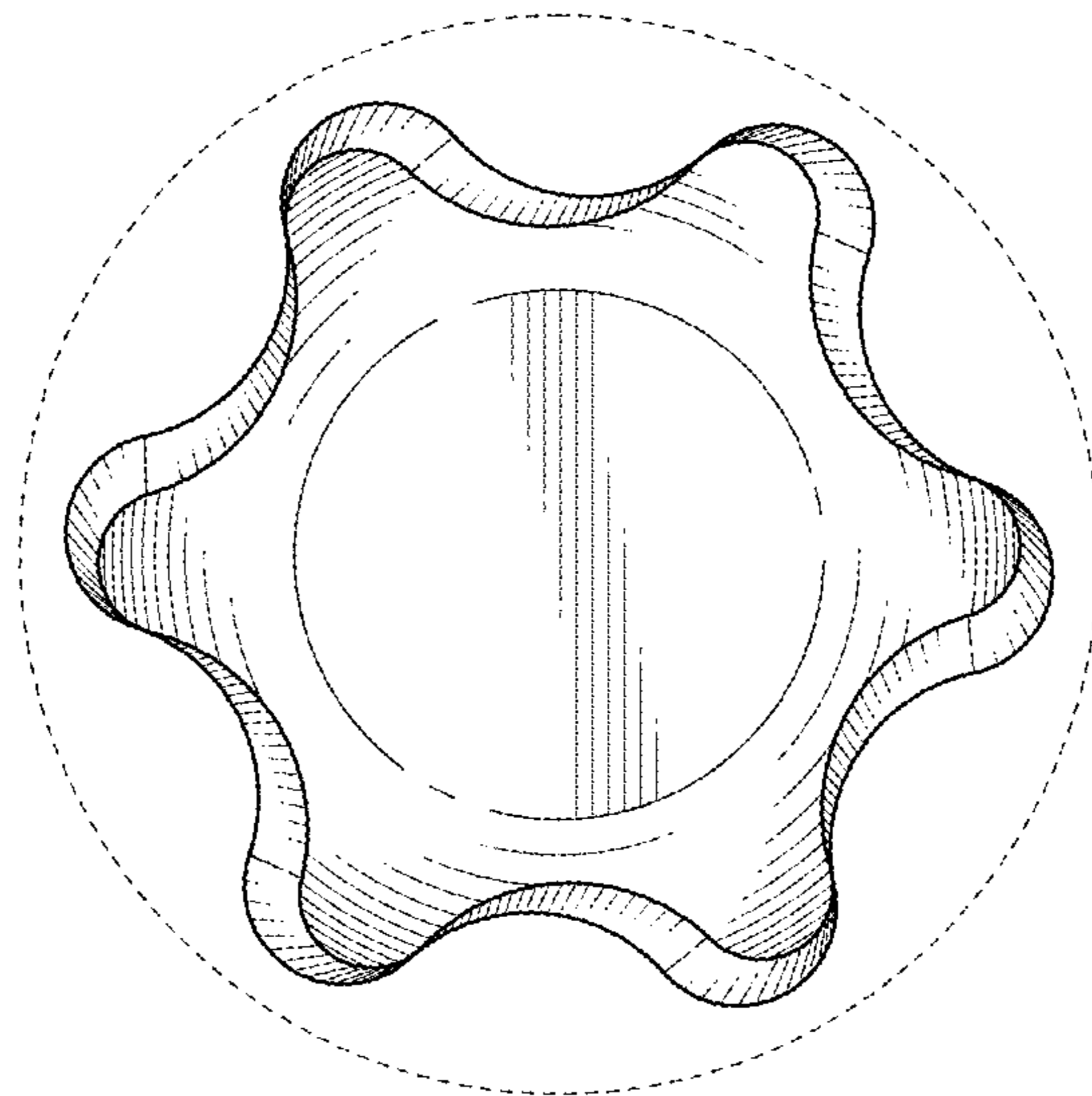

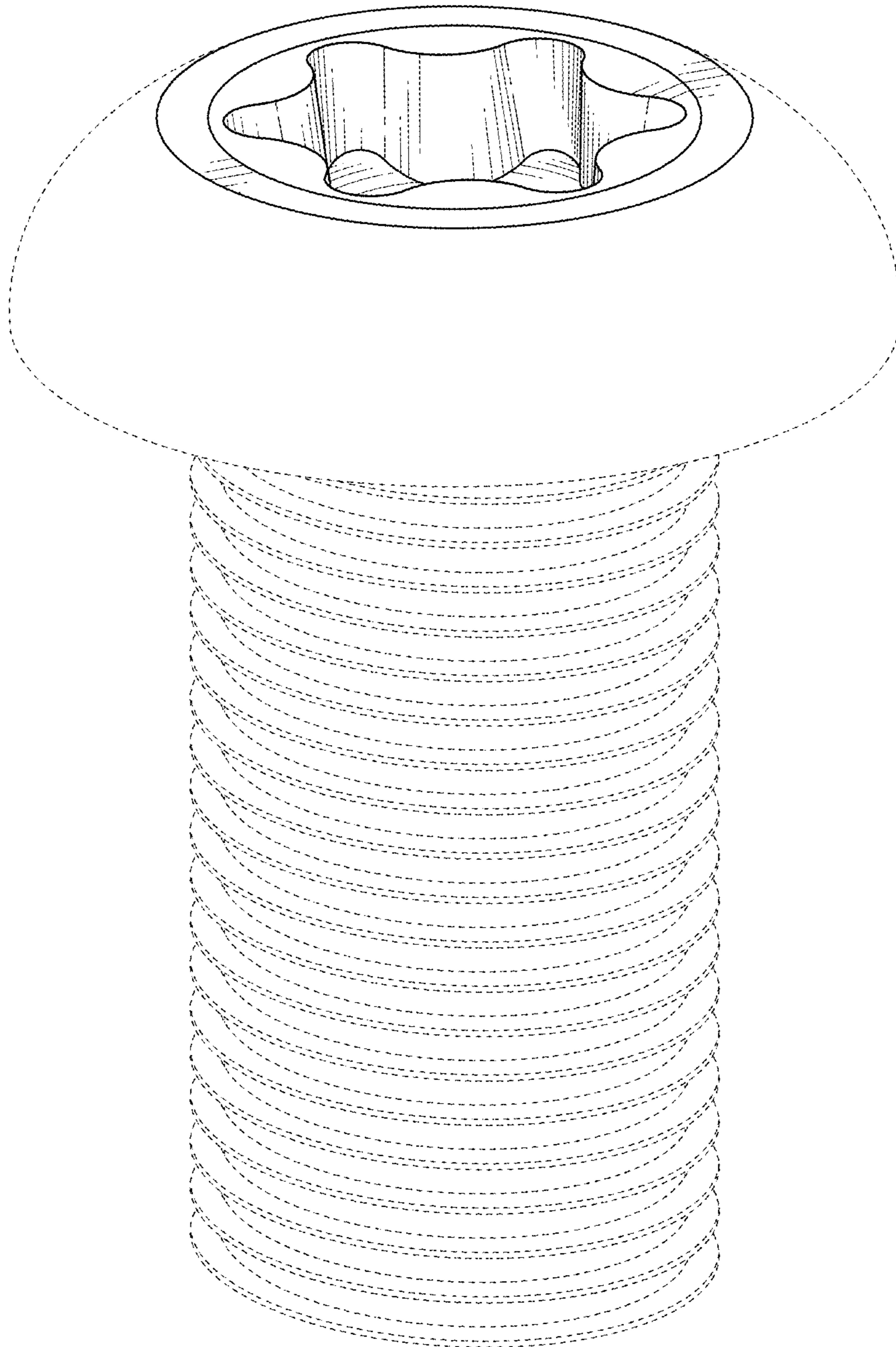

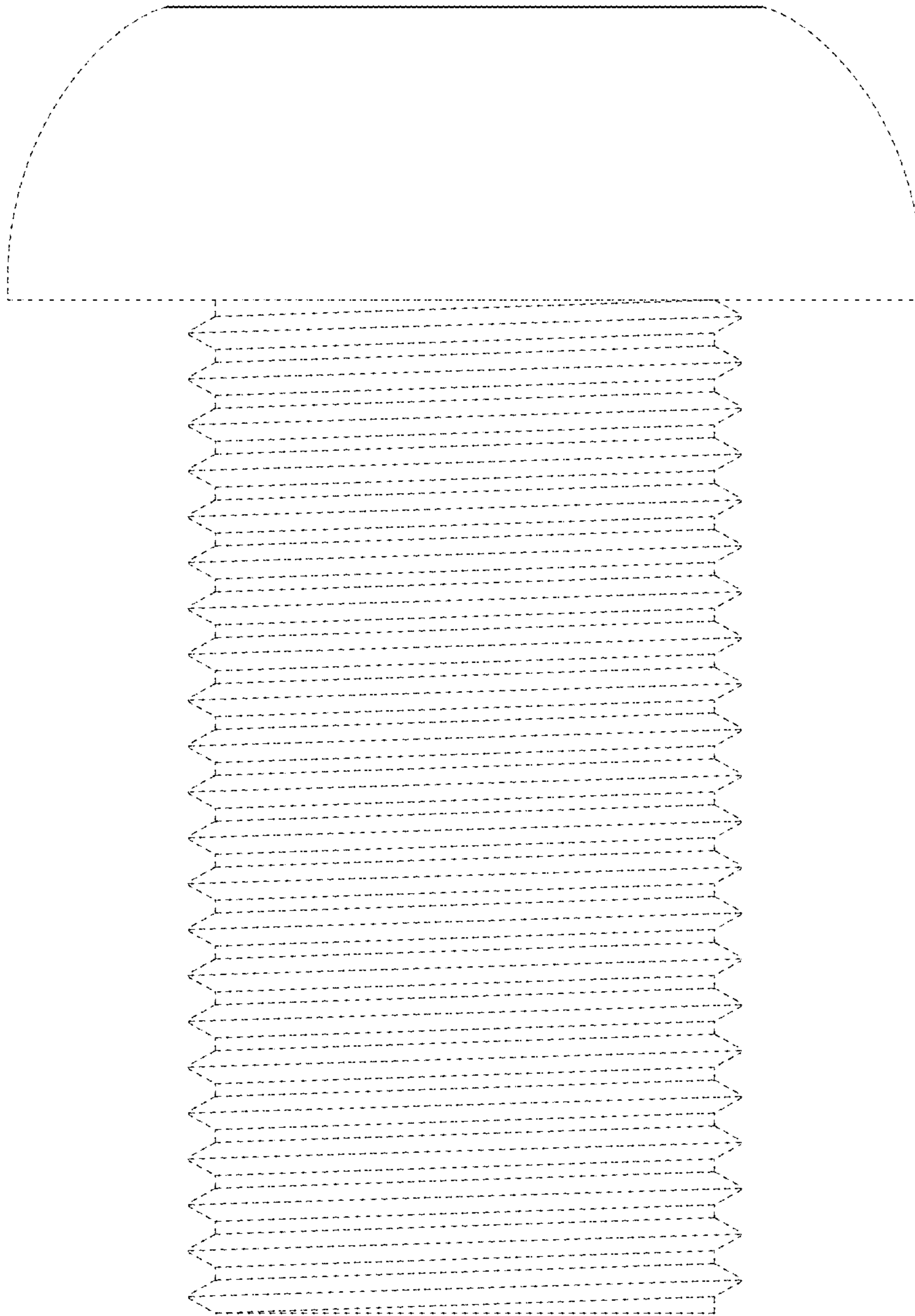

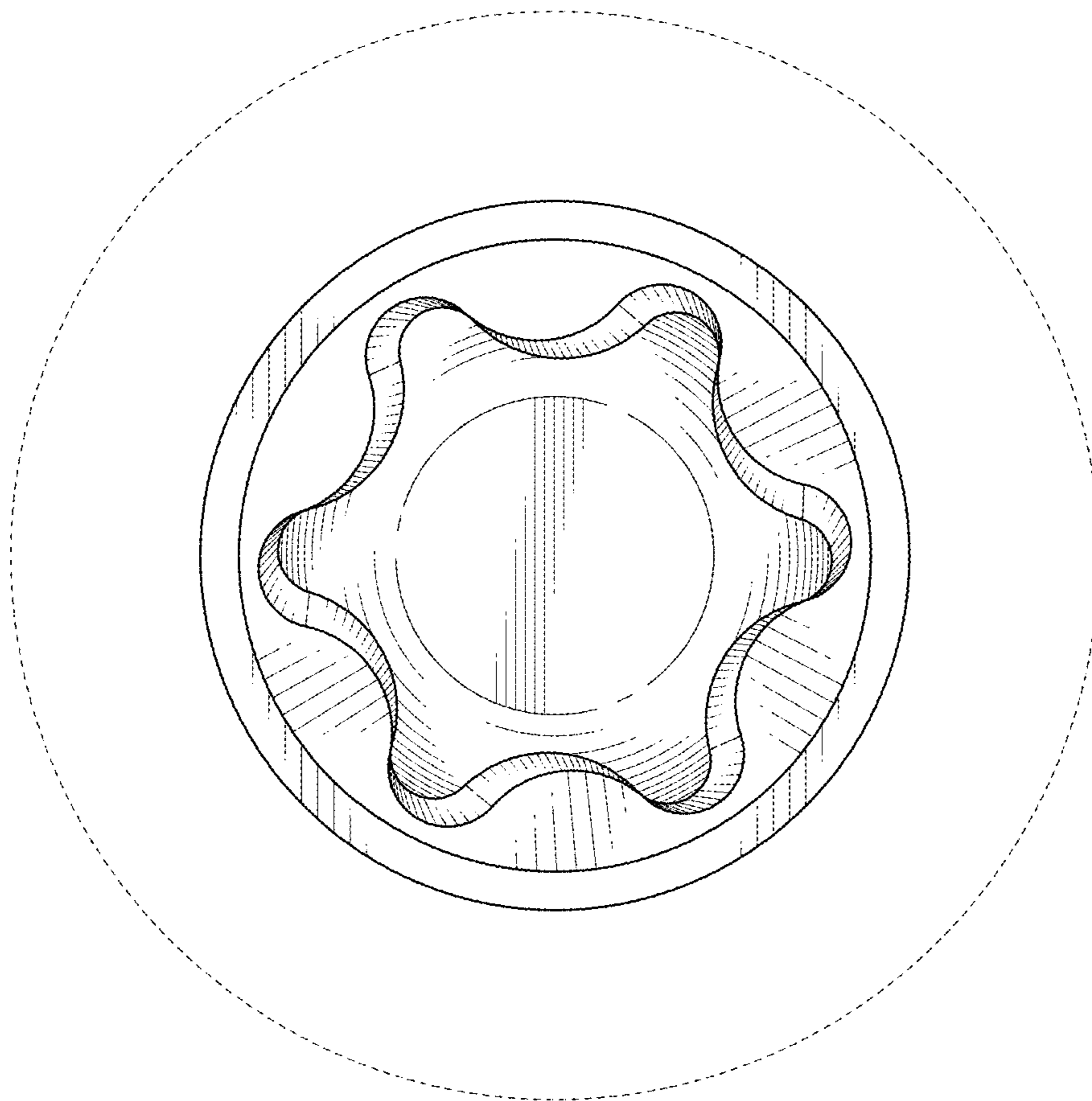
