DESCRIPTION

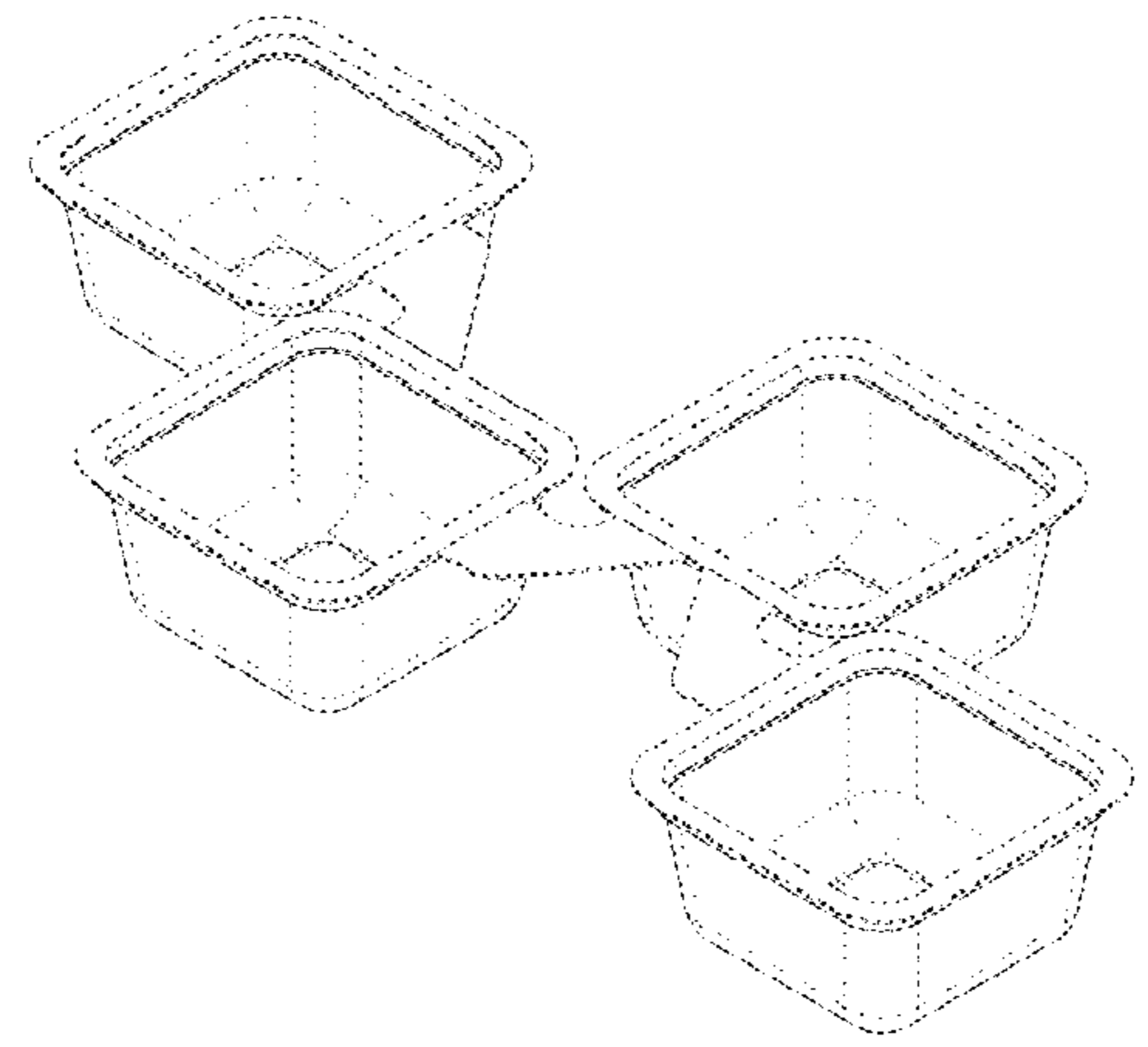
FIG. 1 is a perspective view of a packaging assembly showing our new design.

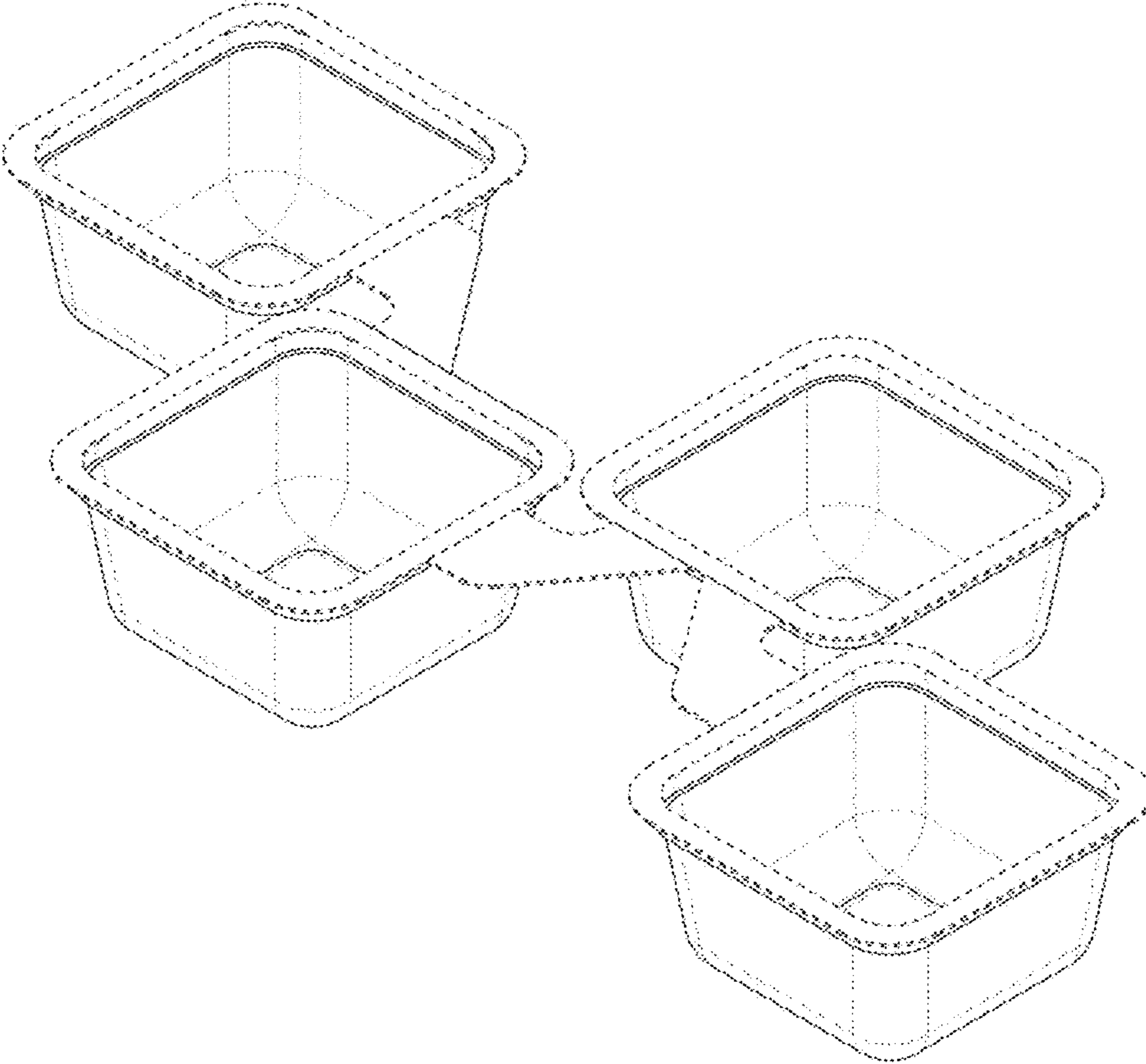

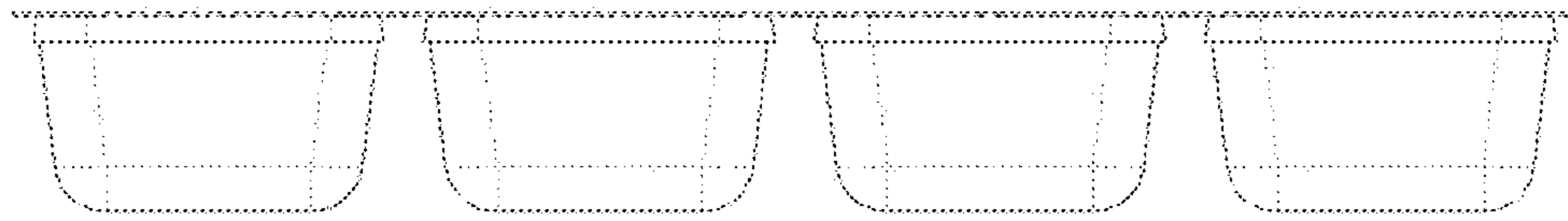

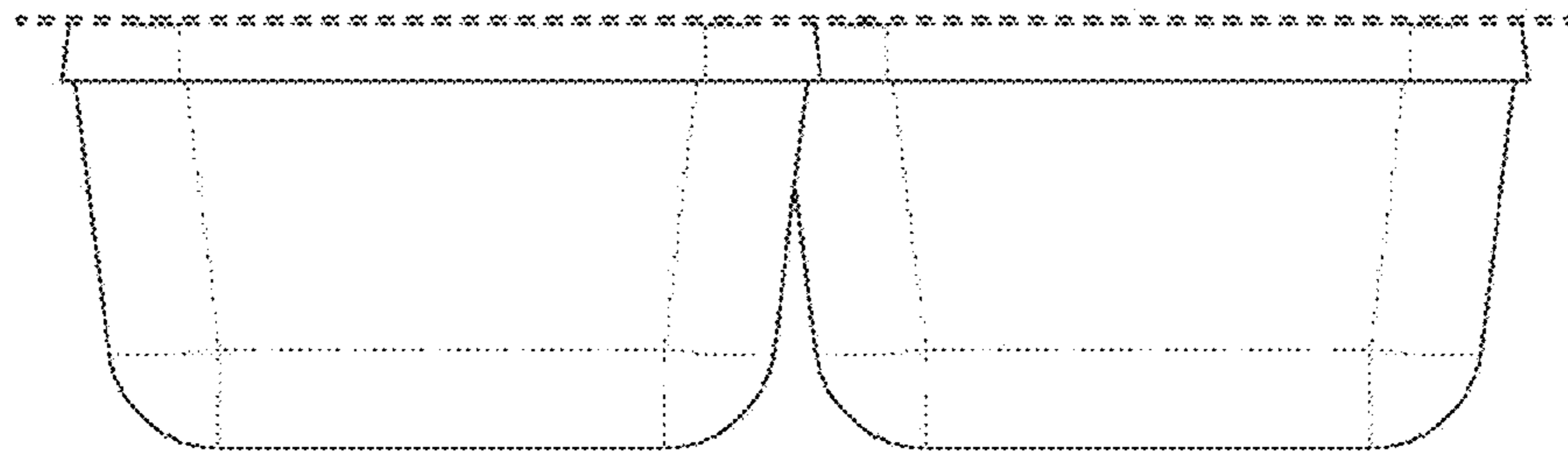

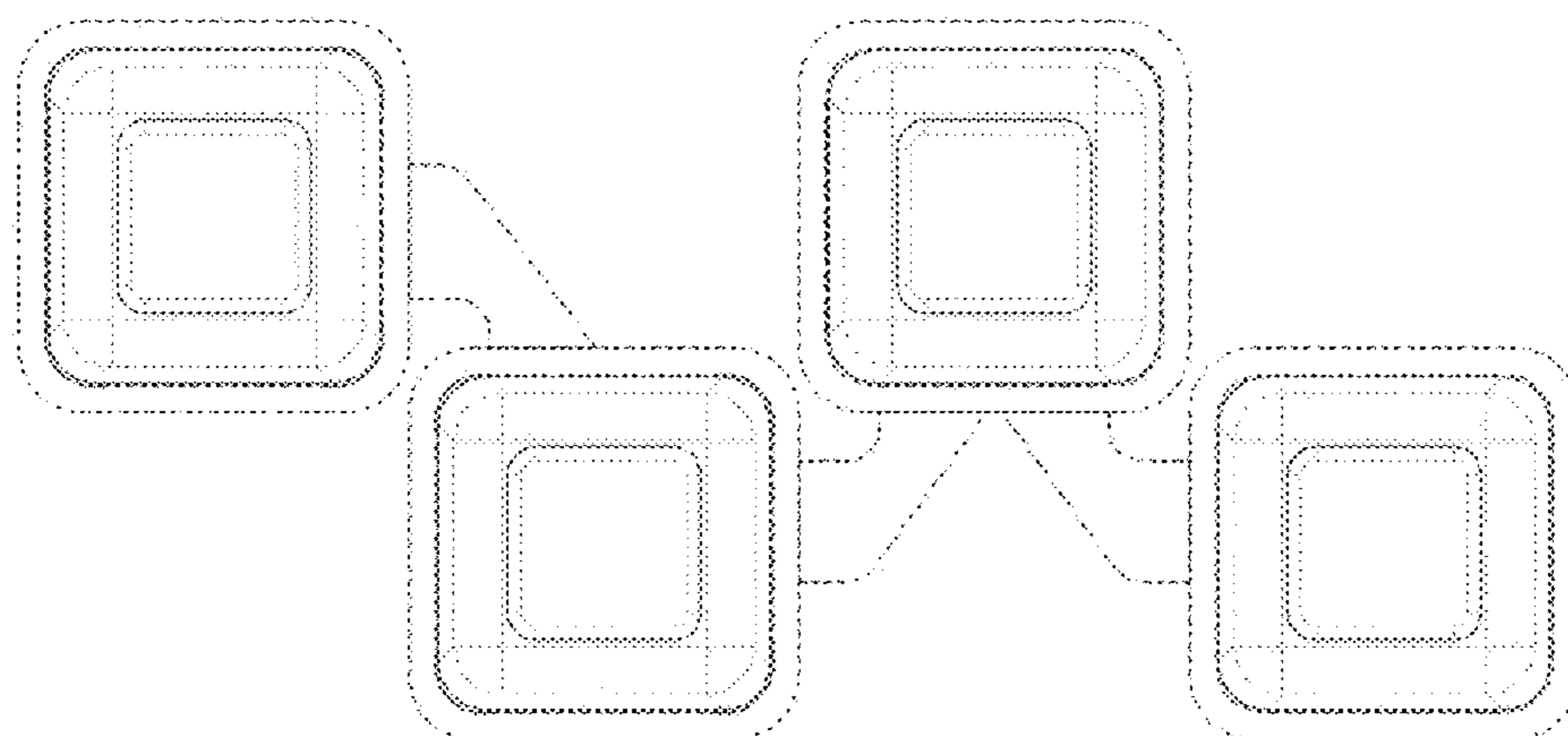

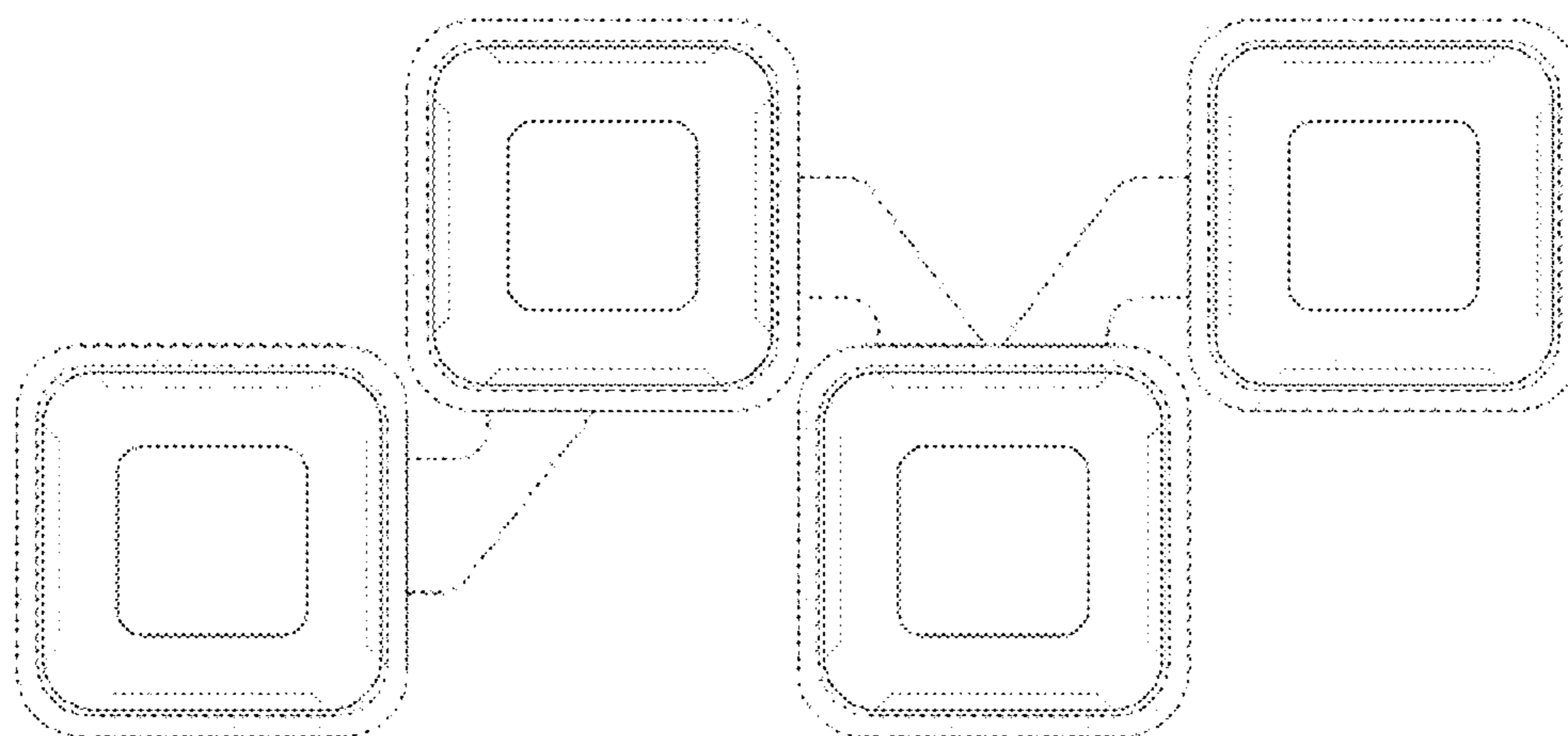
