FIG. 2 is a front view of the design of FIG. 1;

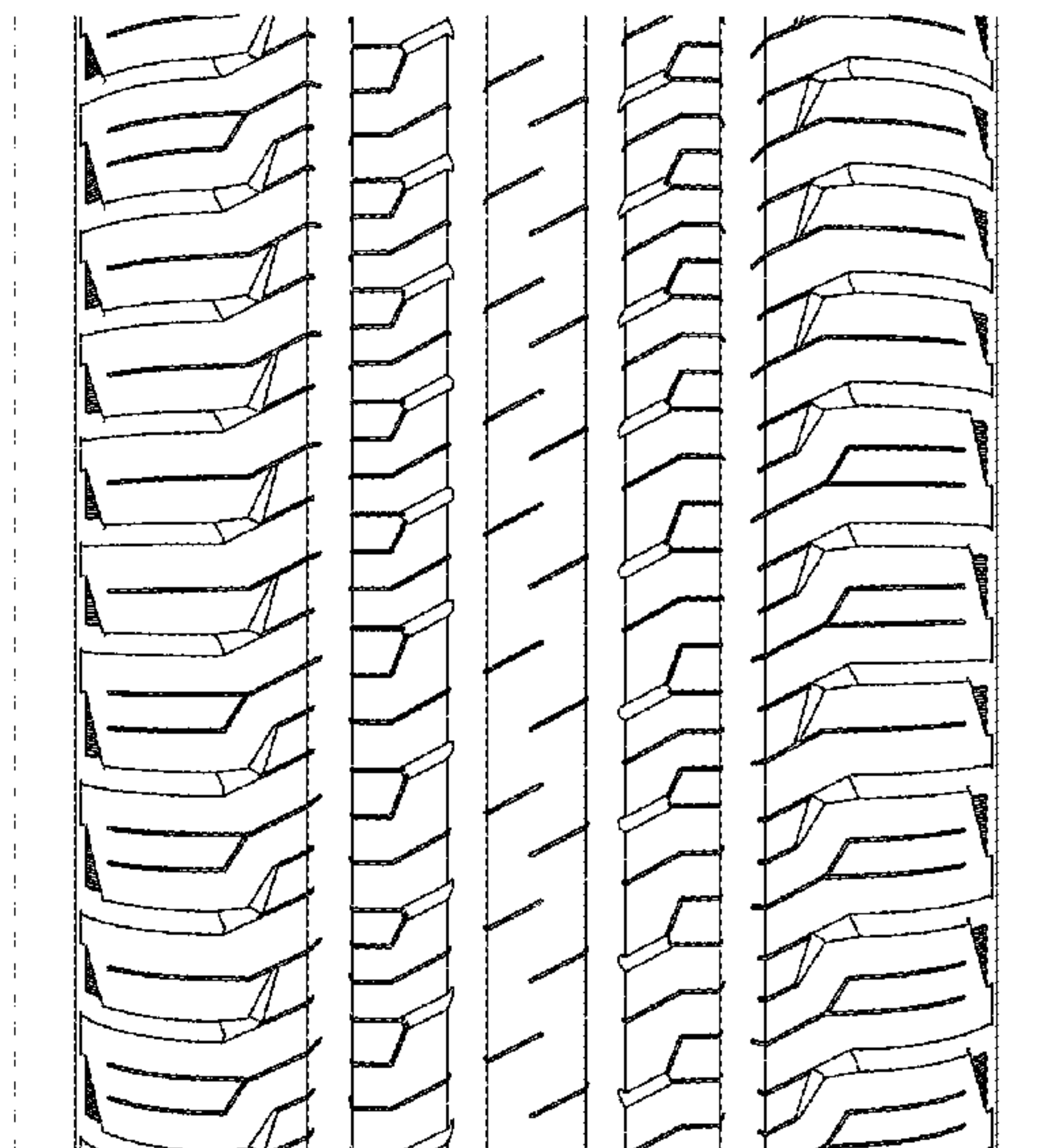
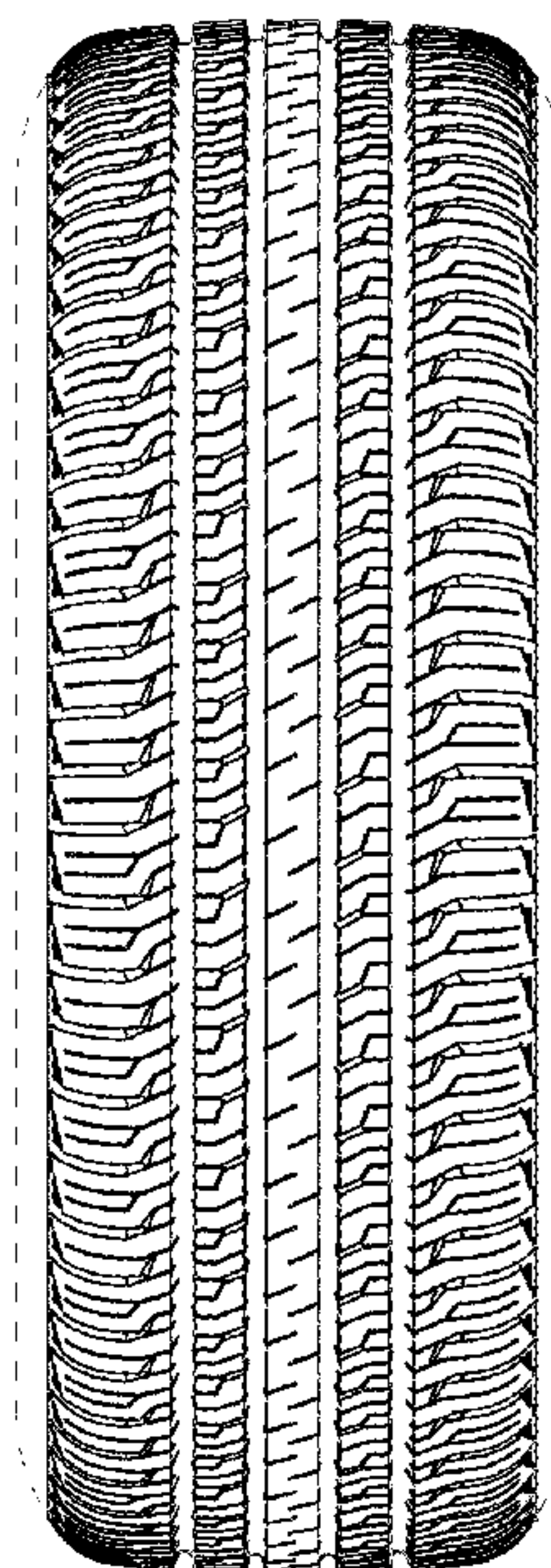
FIG. 3 is a side view of a first side of the design of FIG. 1;

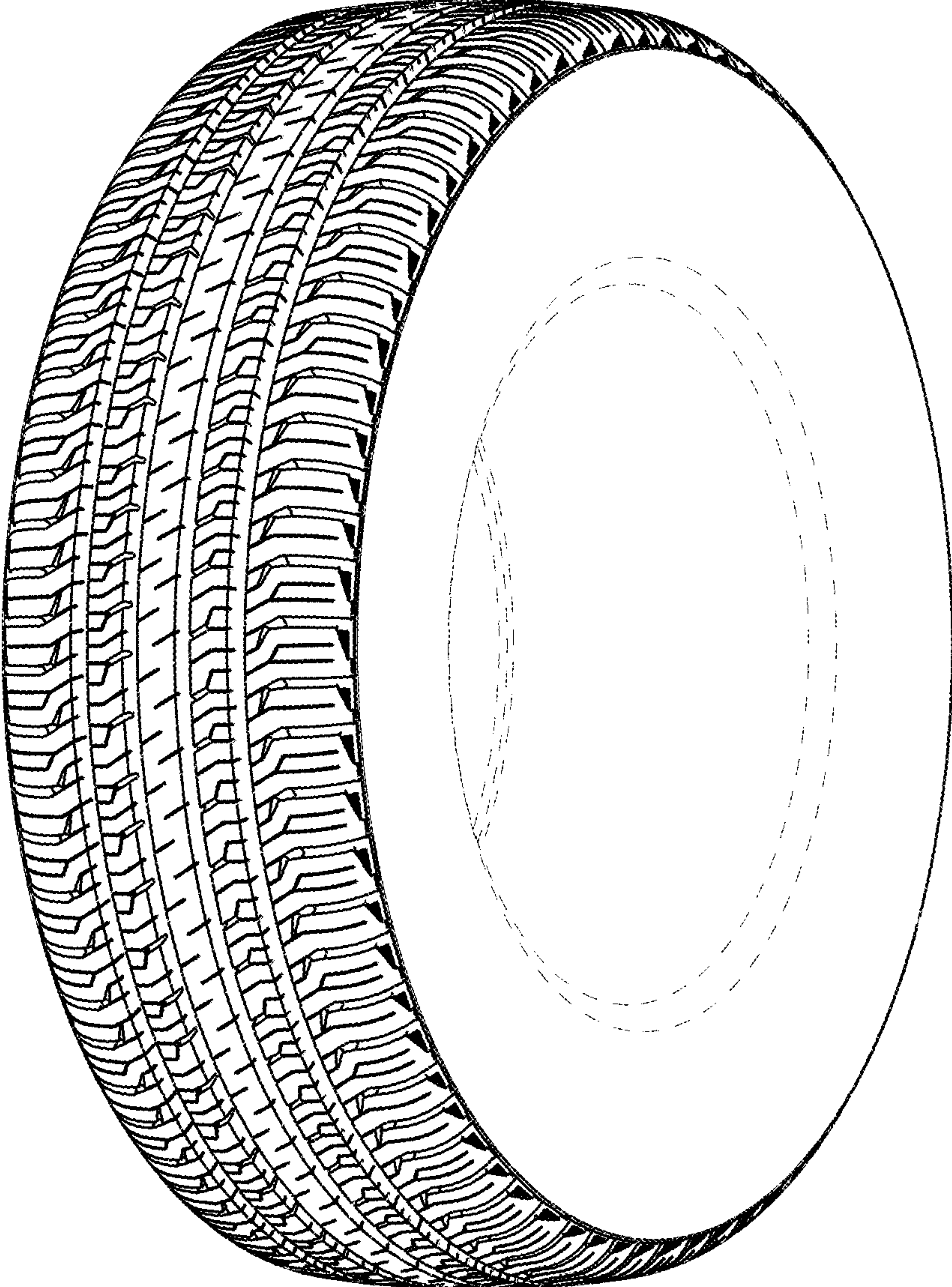

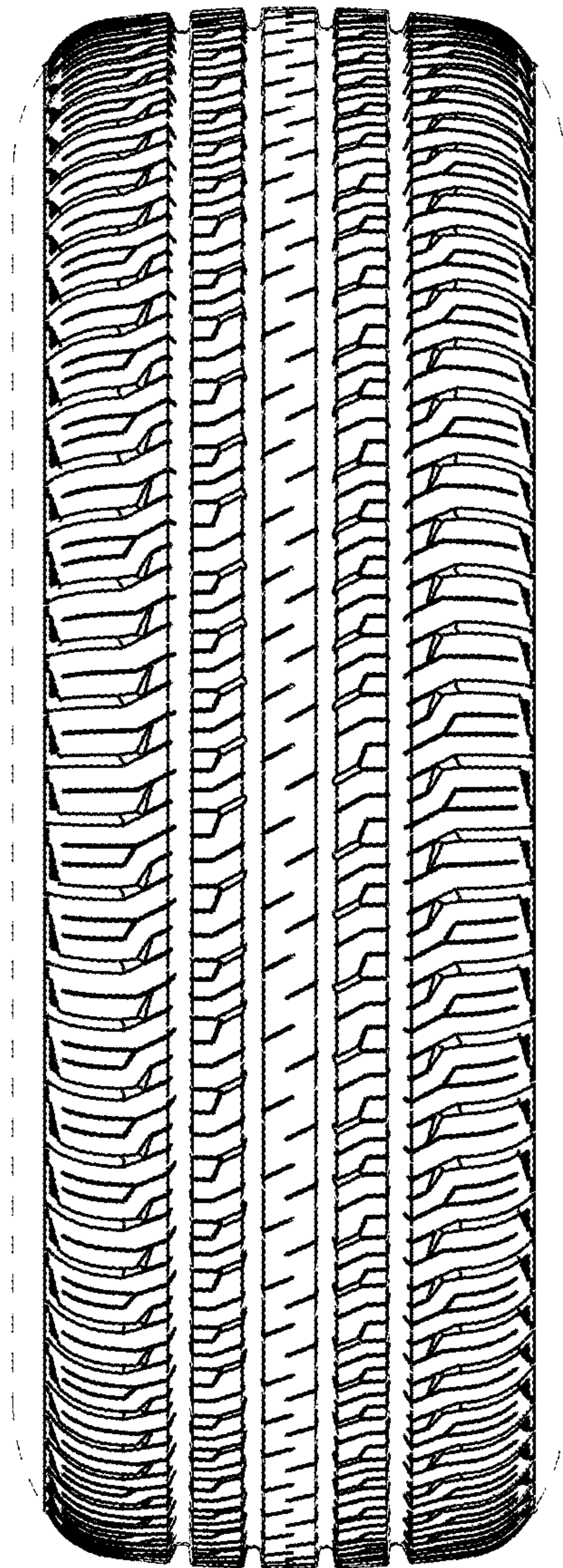

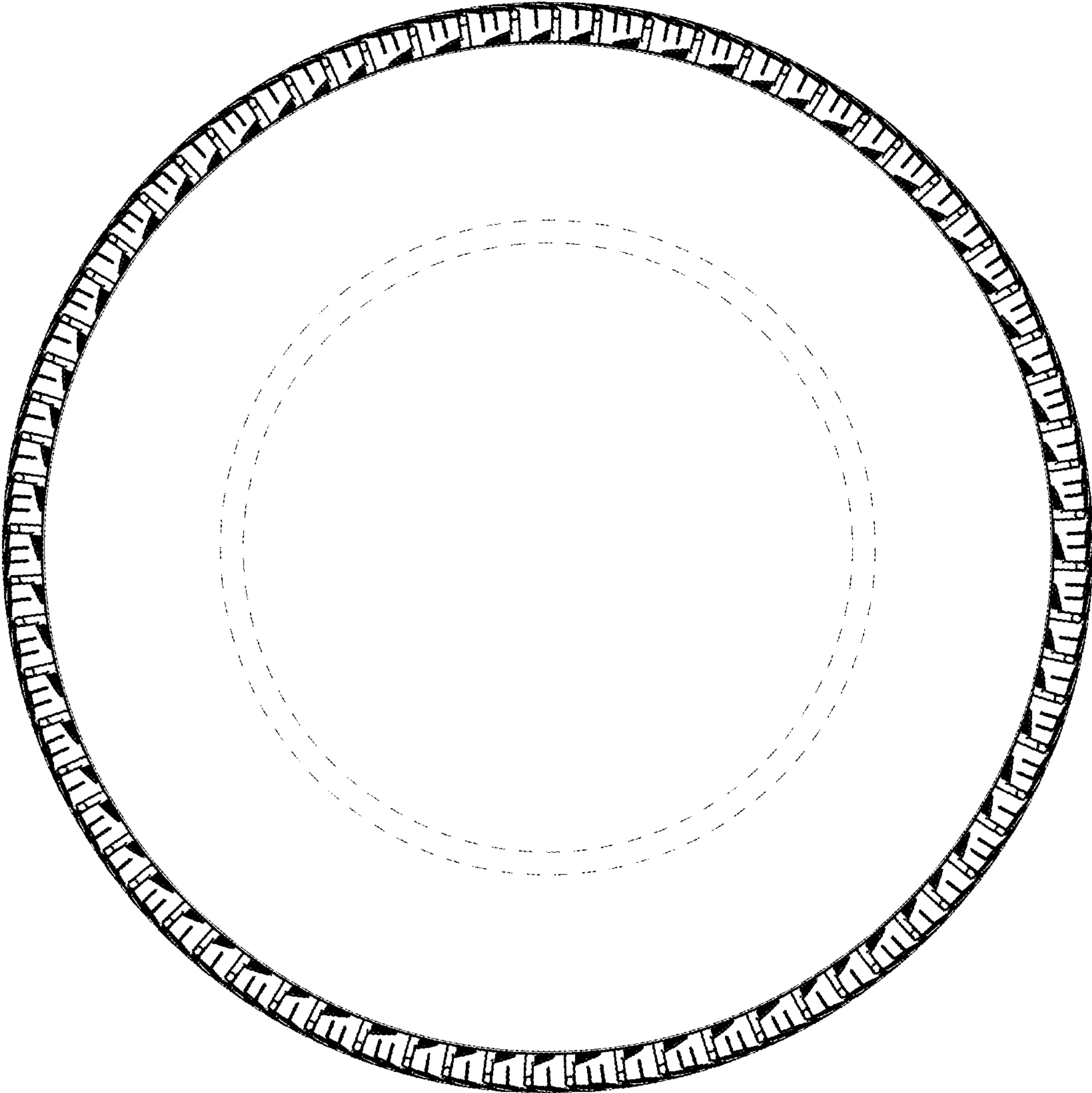

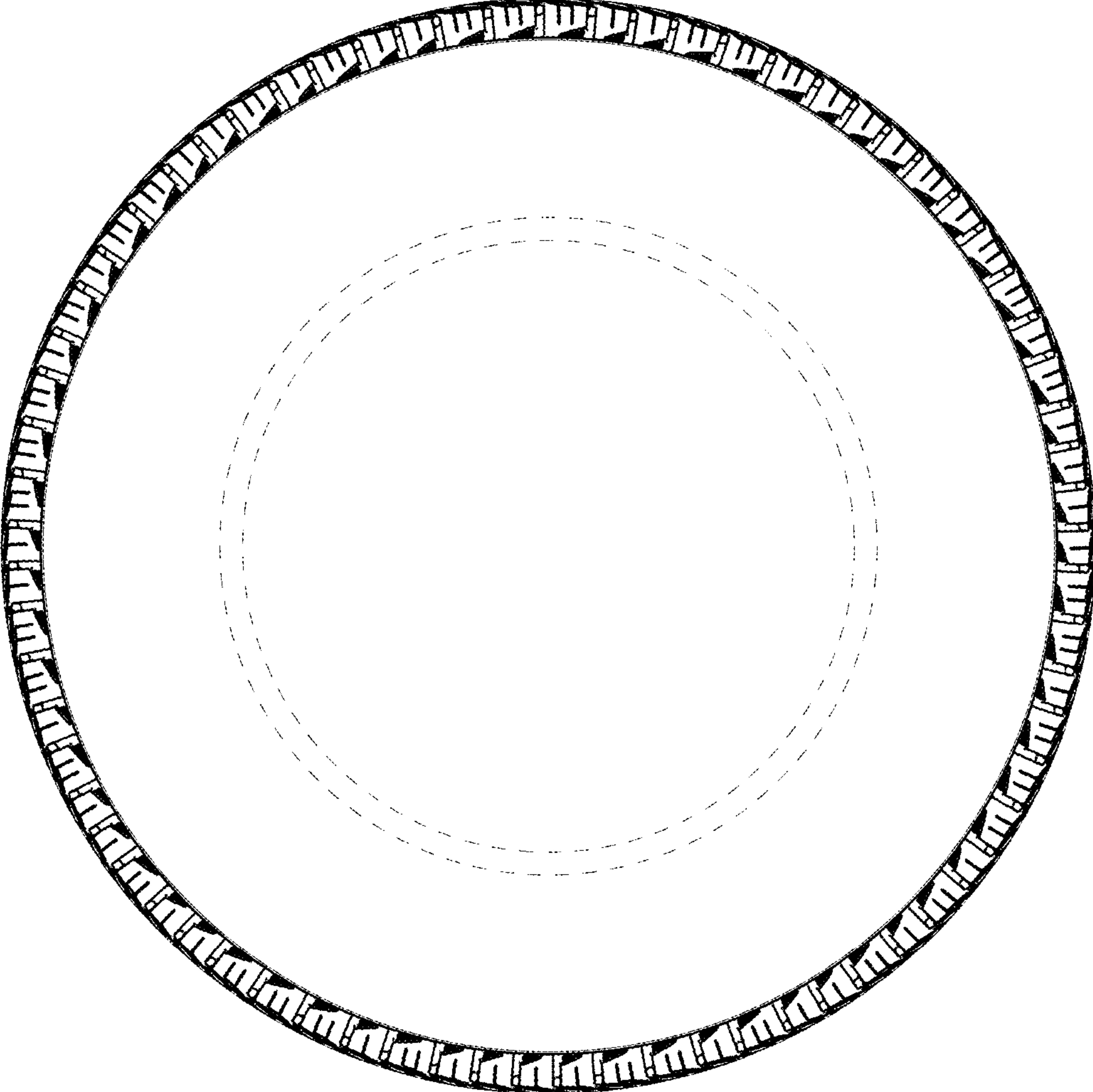

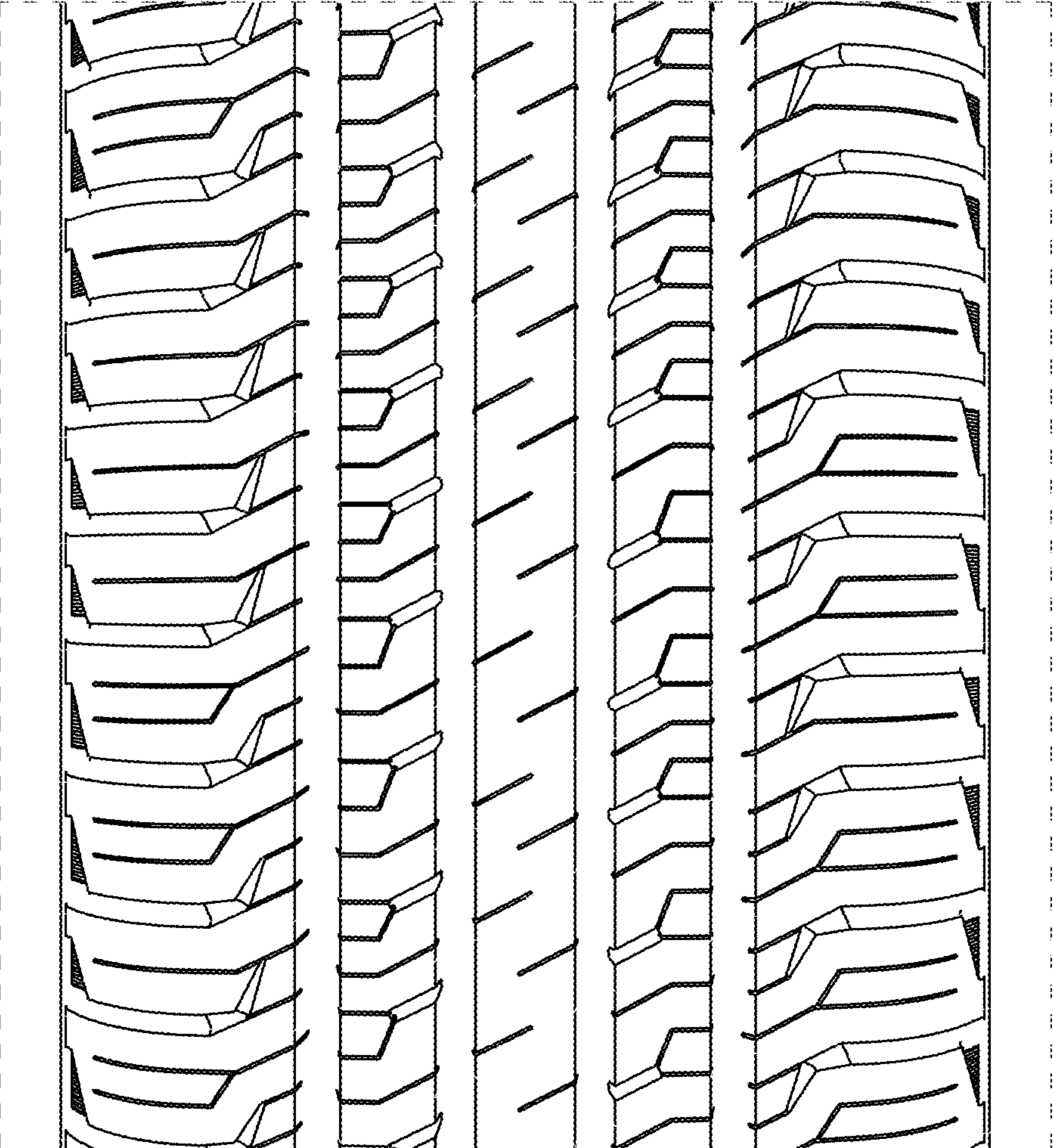
