**DESCRIPTION**

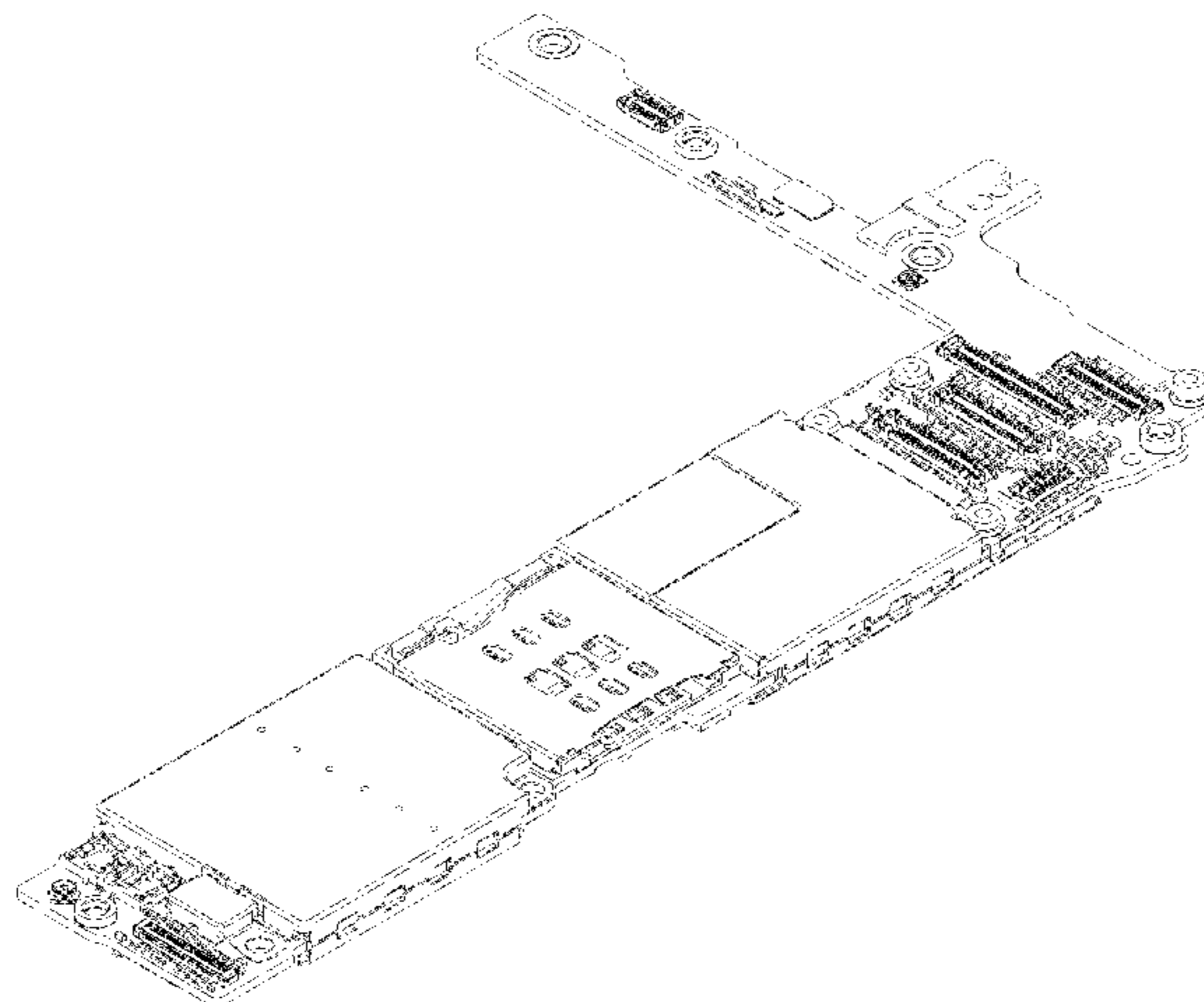
FIG. 1 is a front perspective view of a component for electronic device showing our new design;

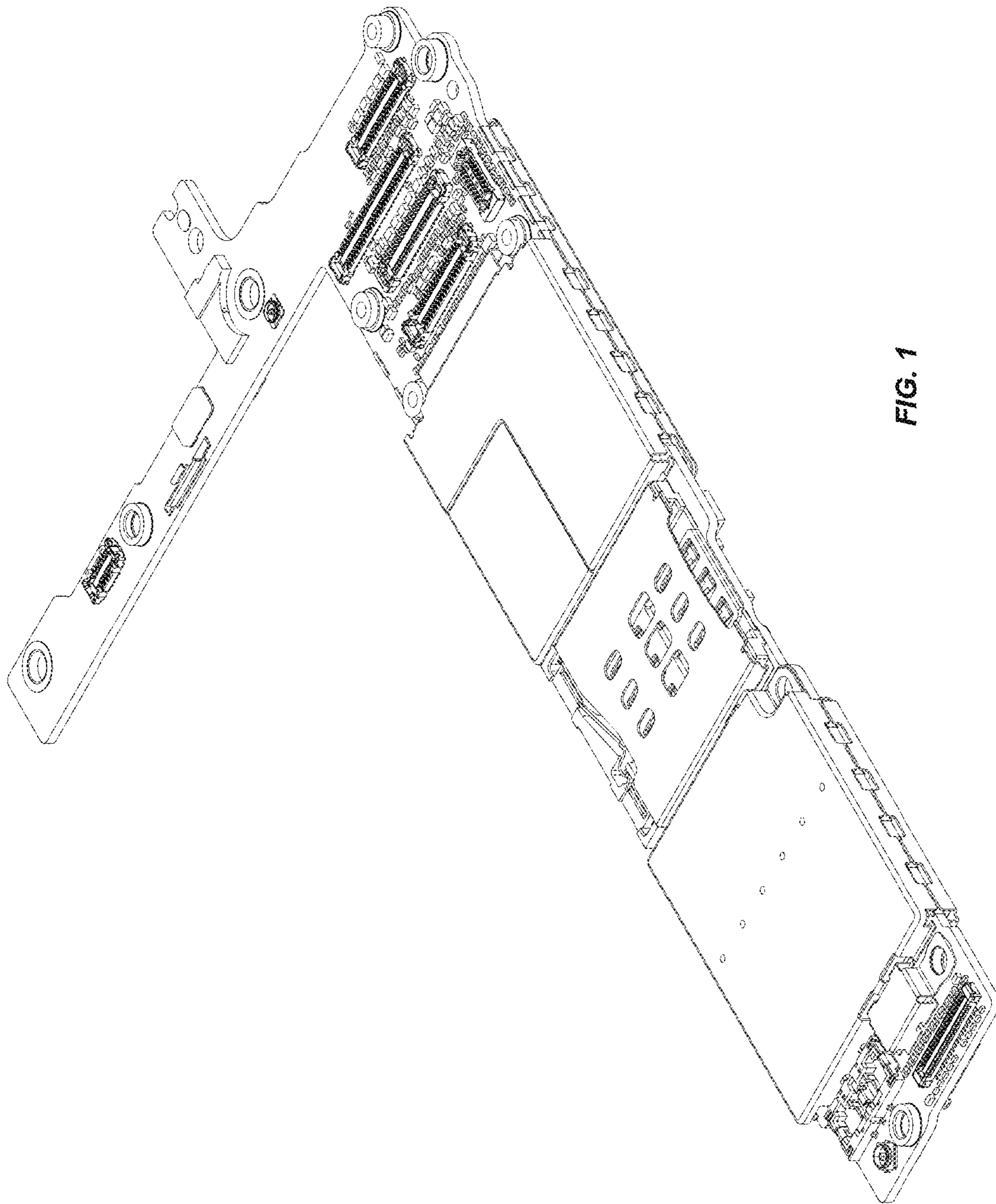

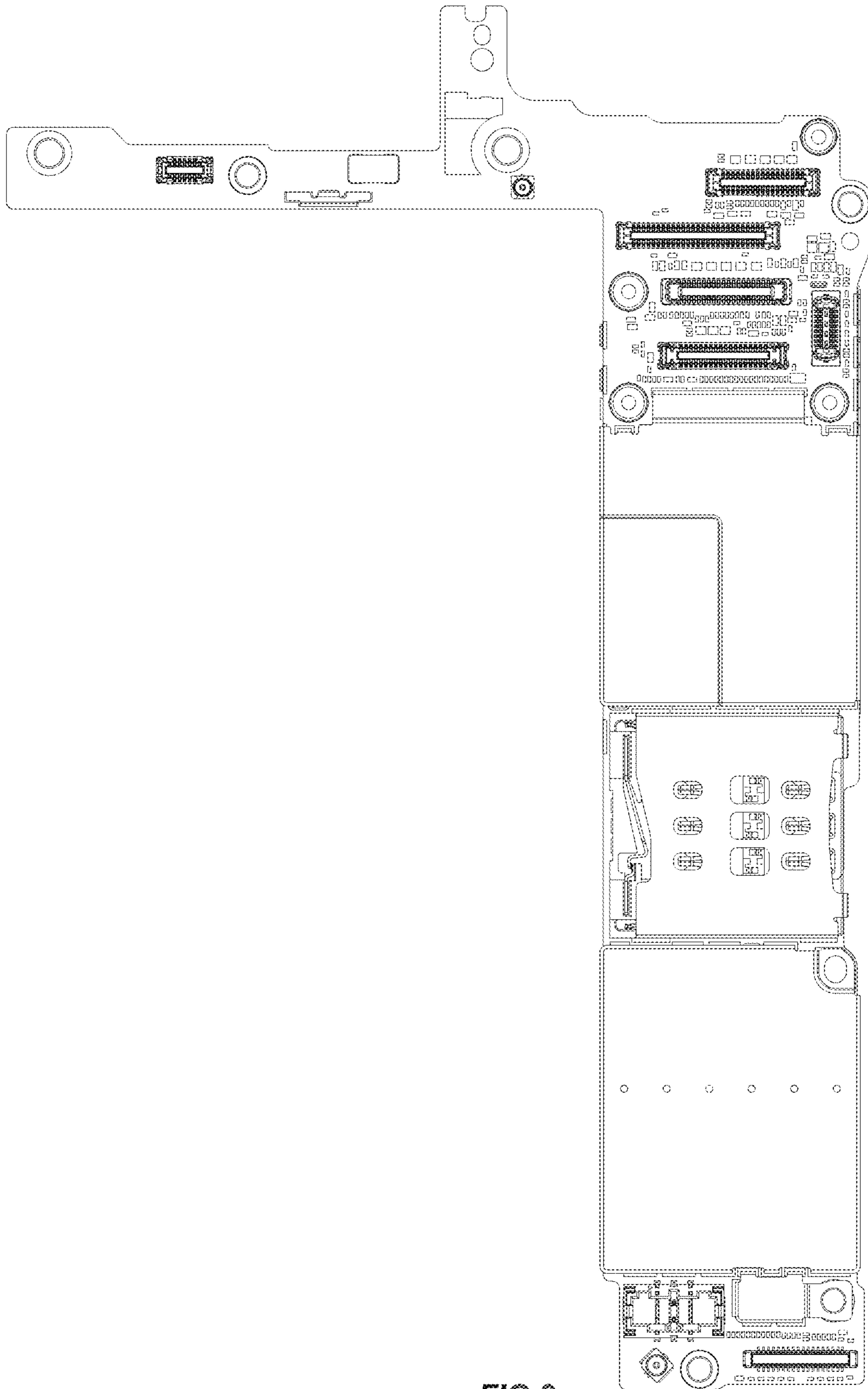

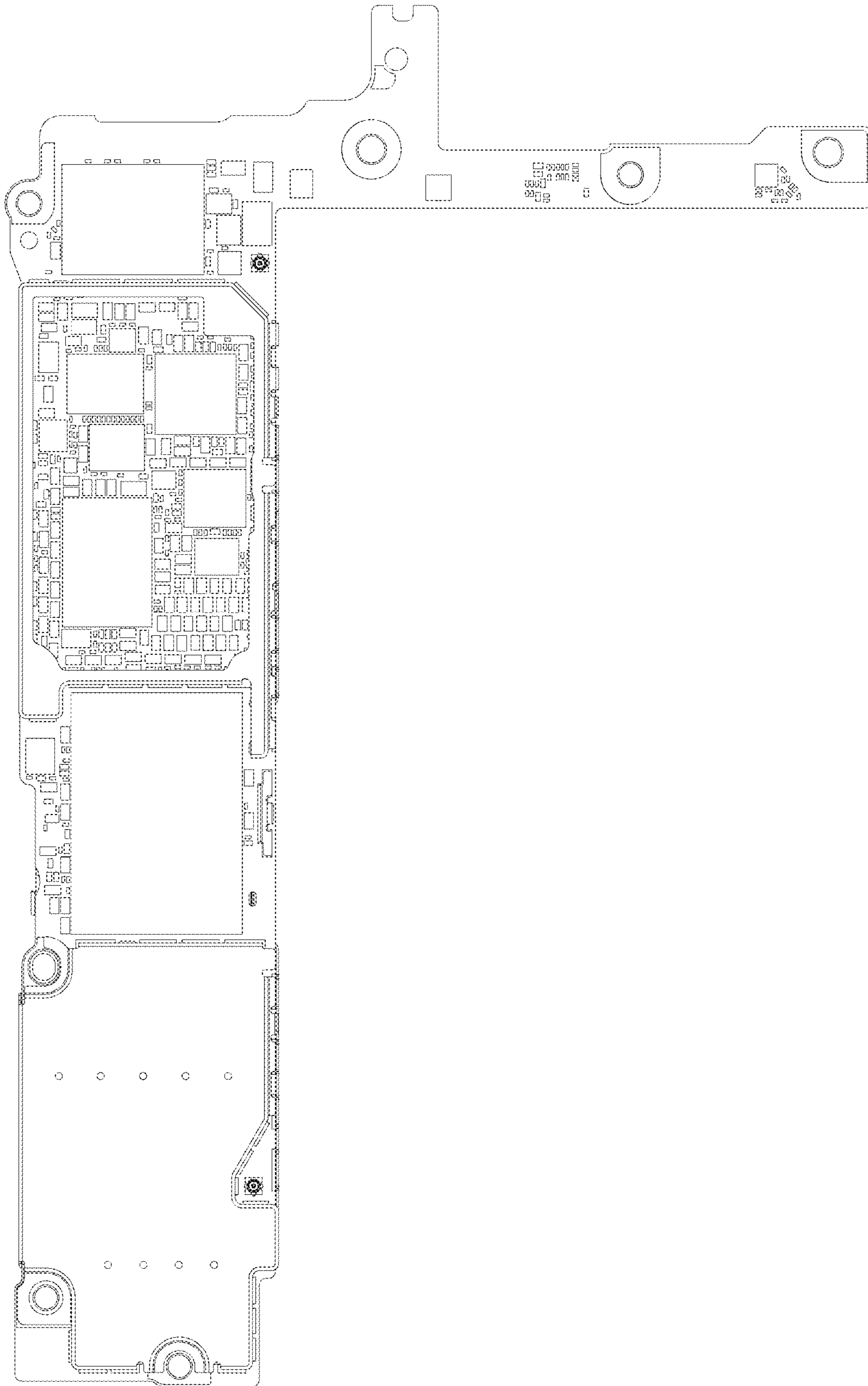
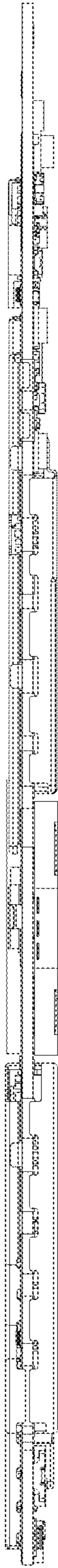
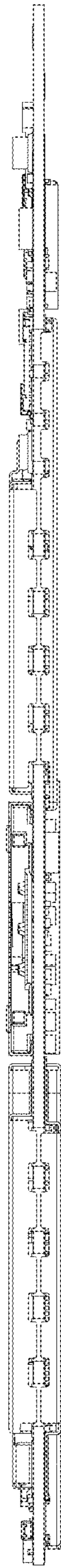


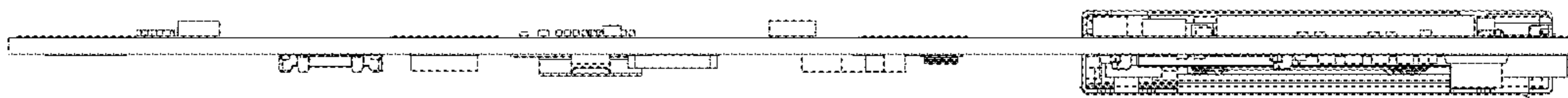

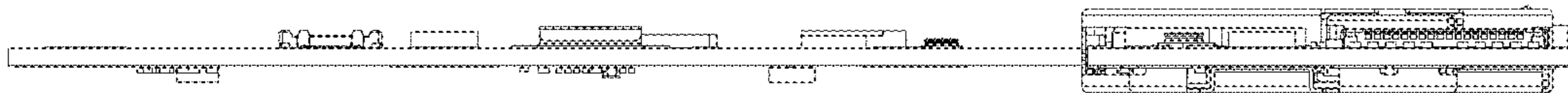
