DESCRIPTION

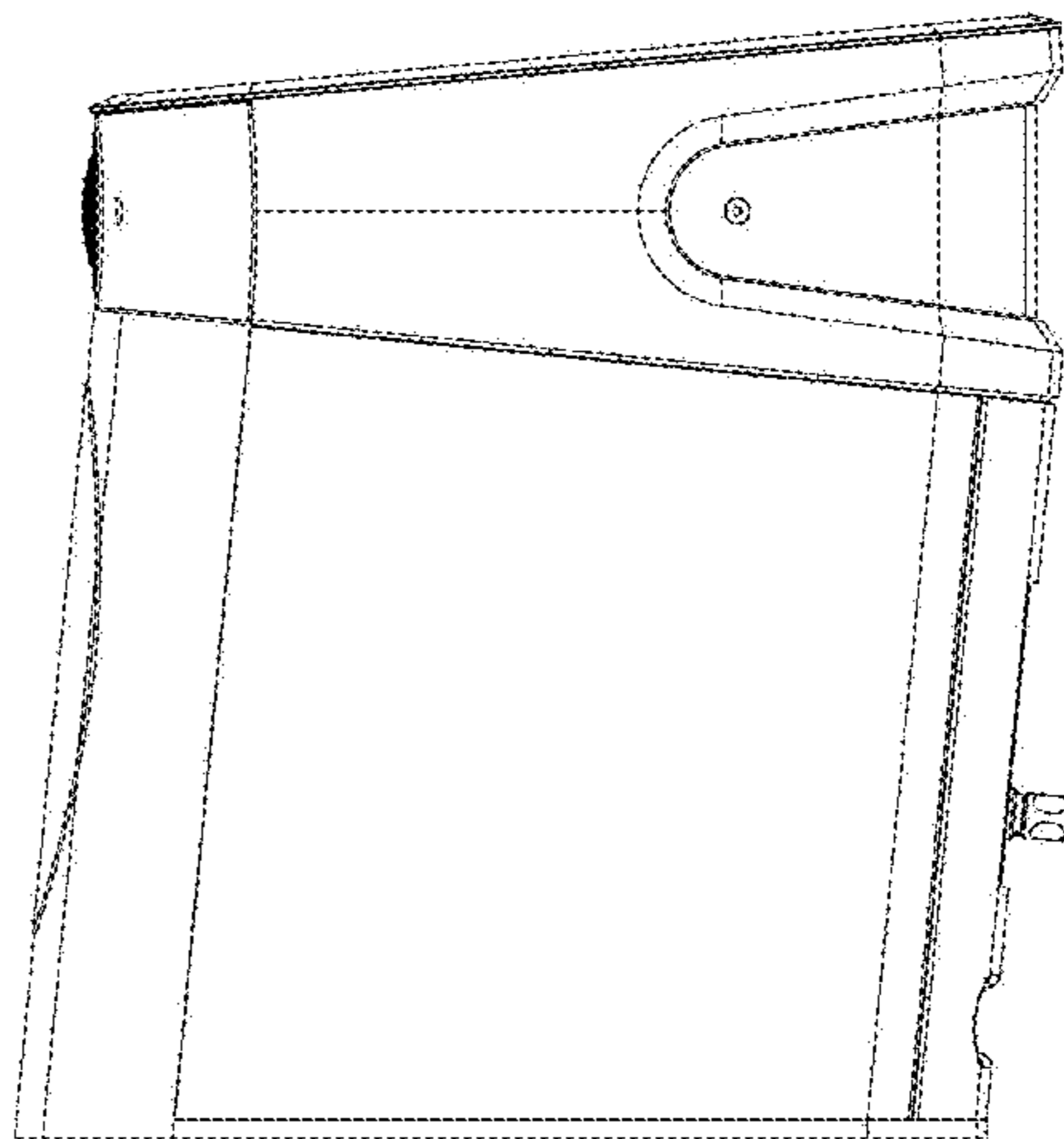
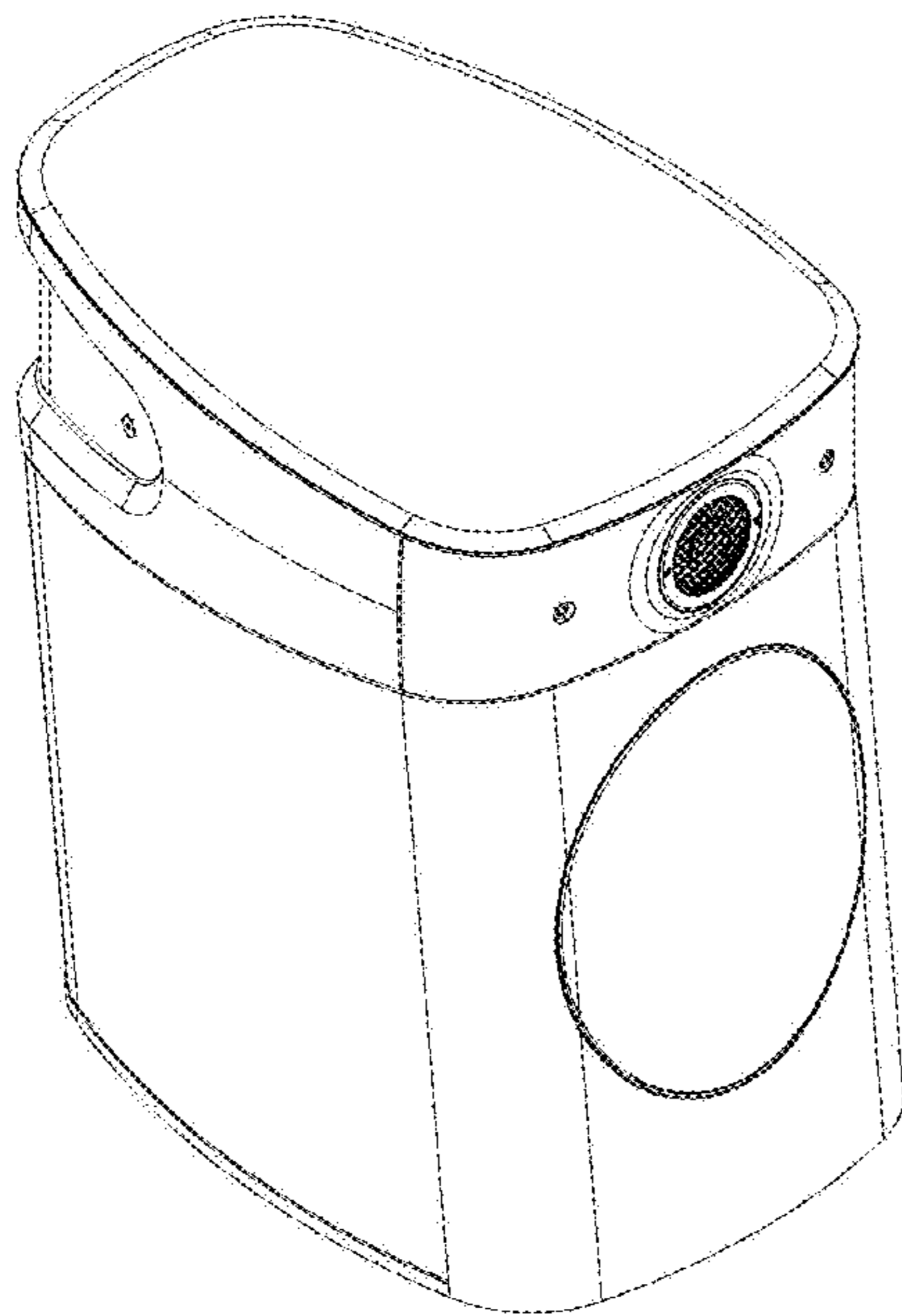

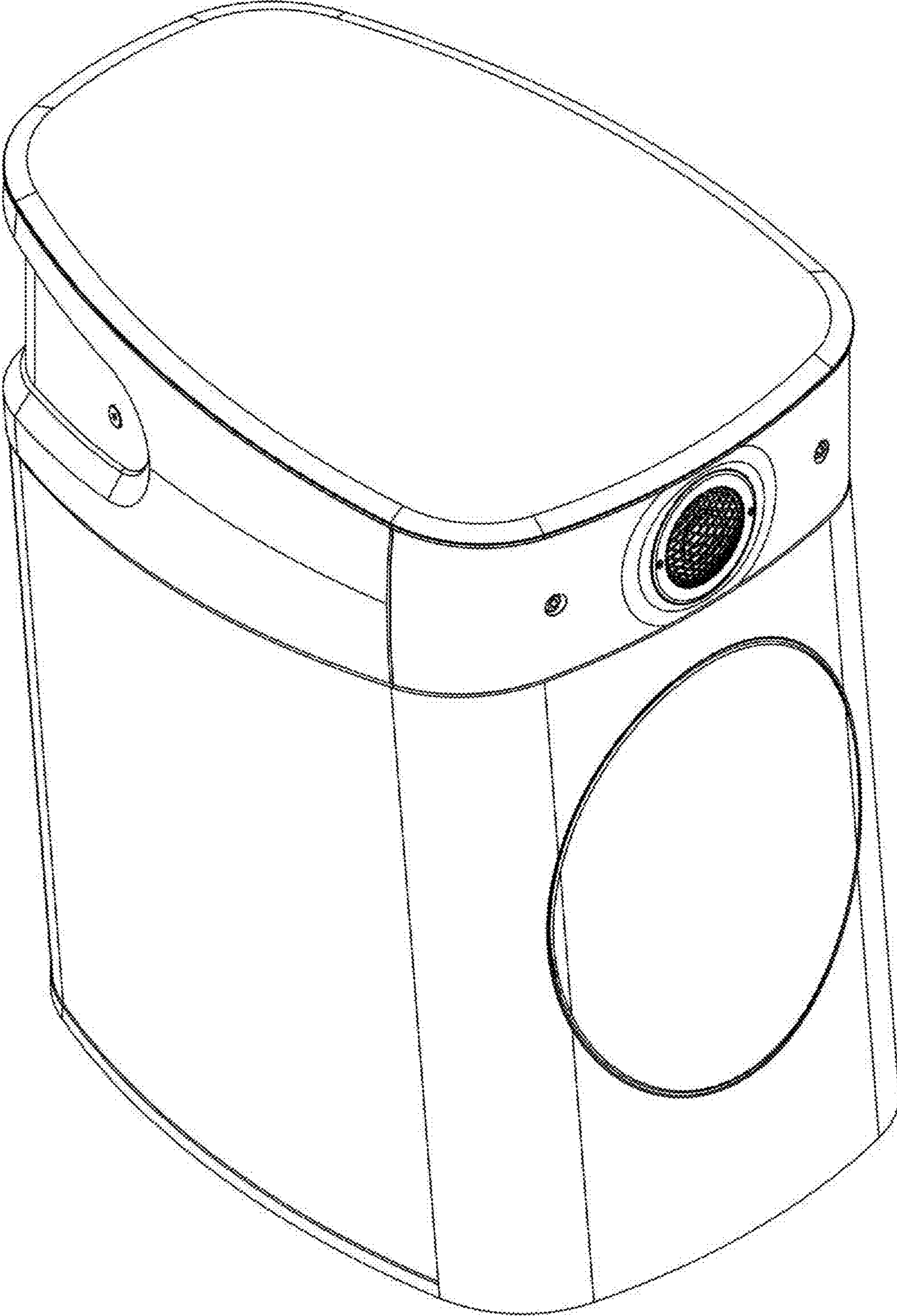

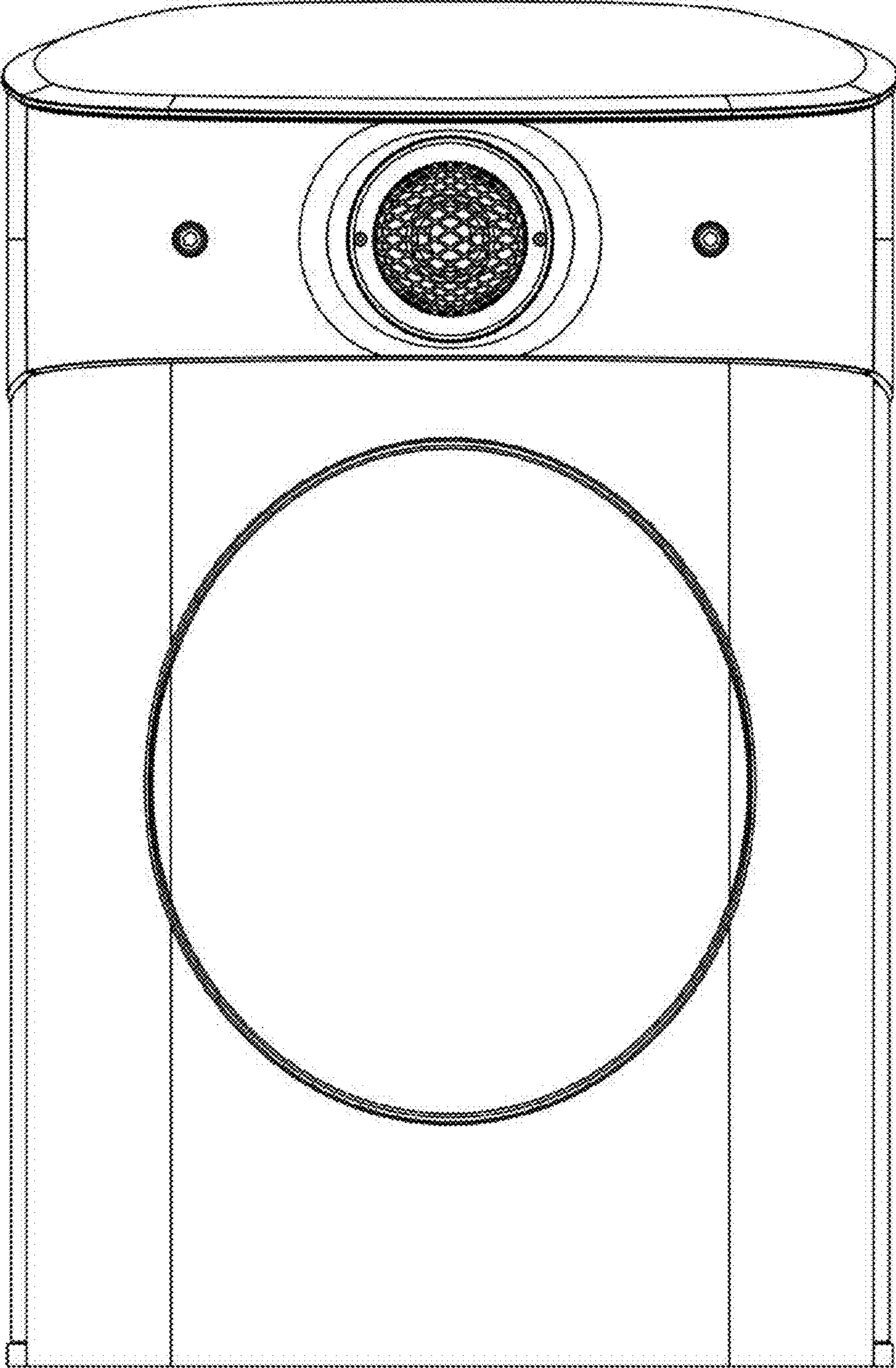

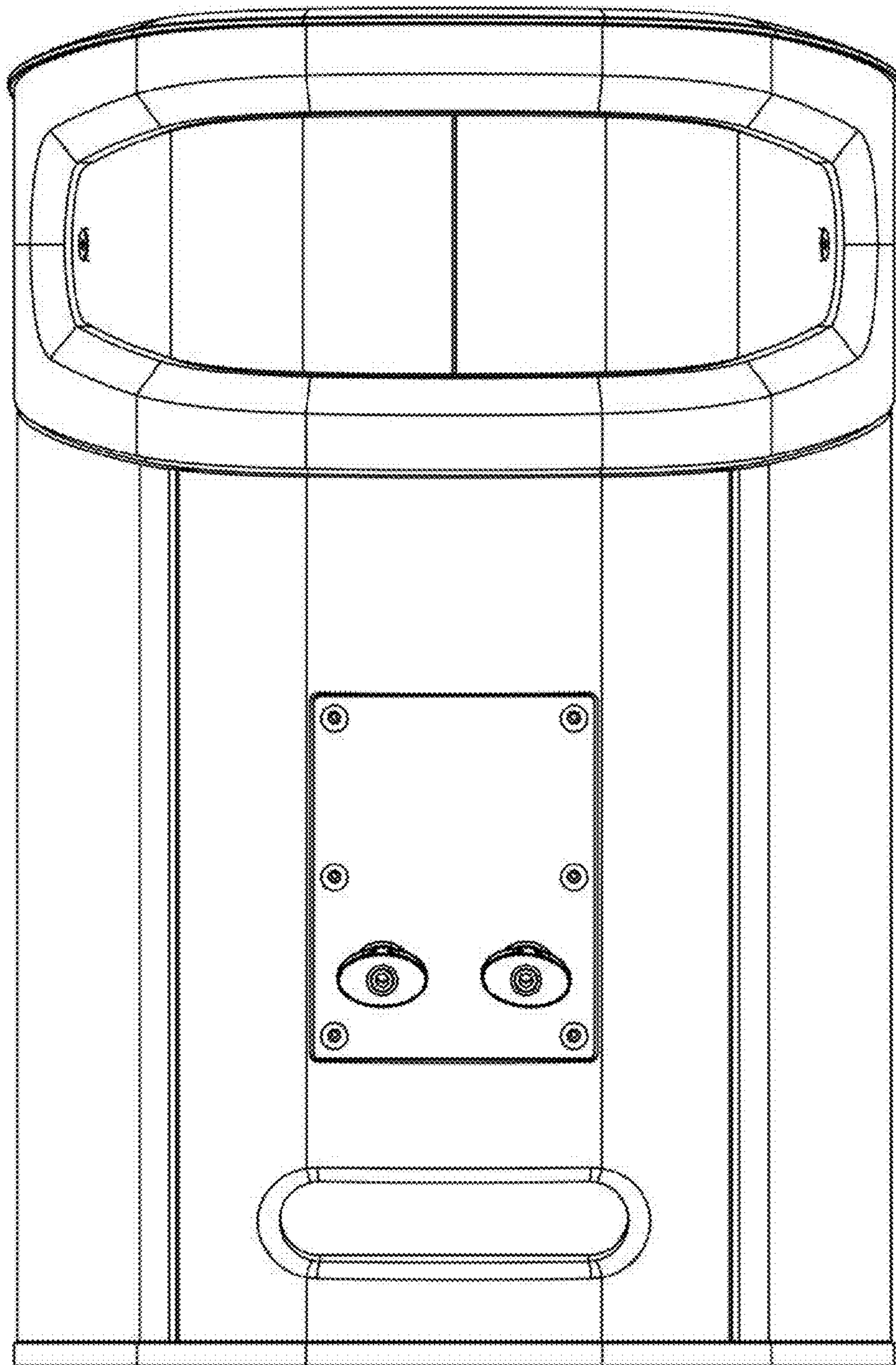

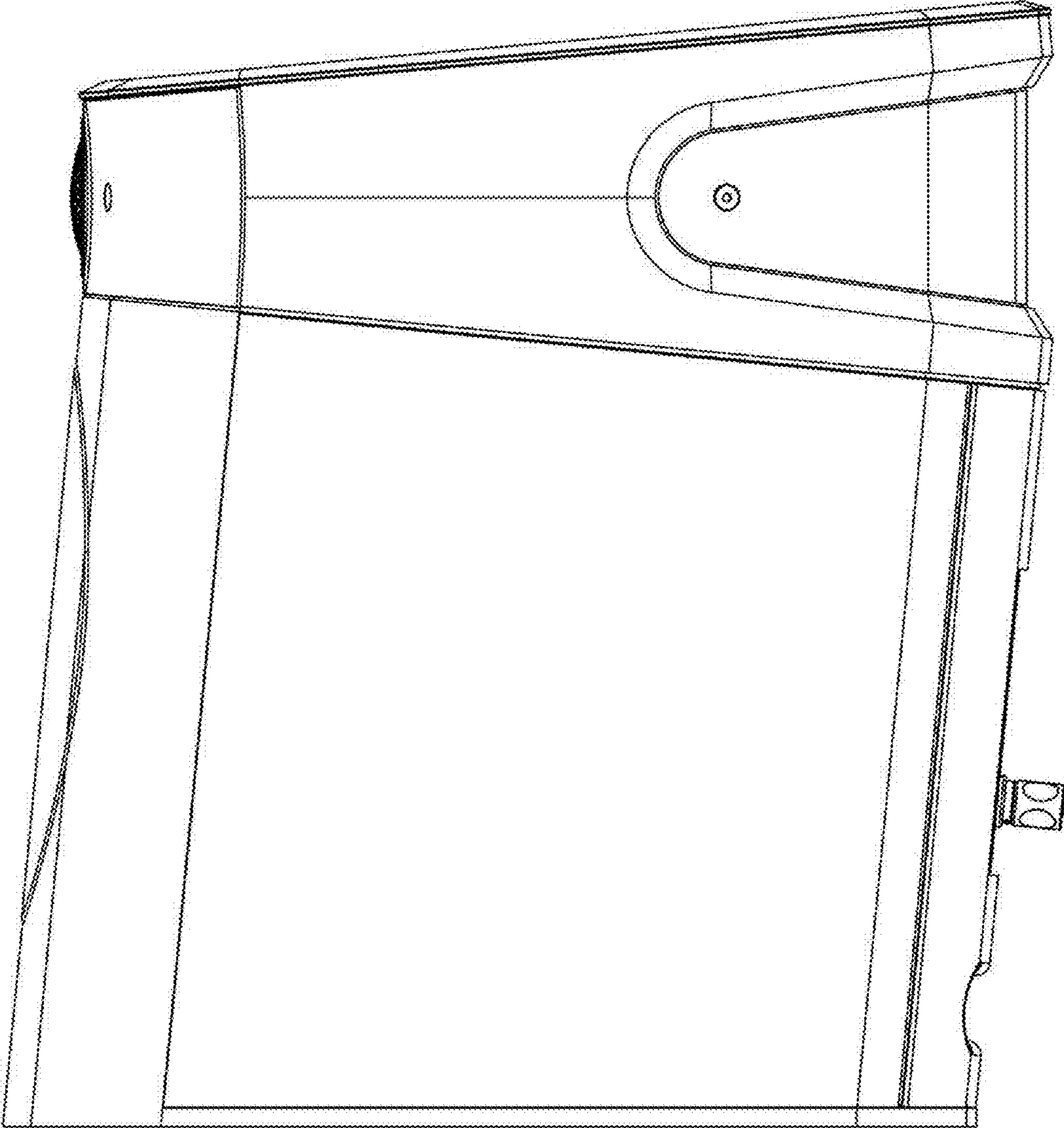

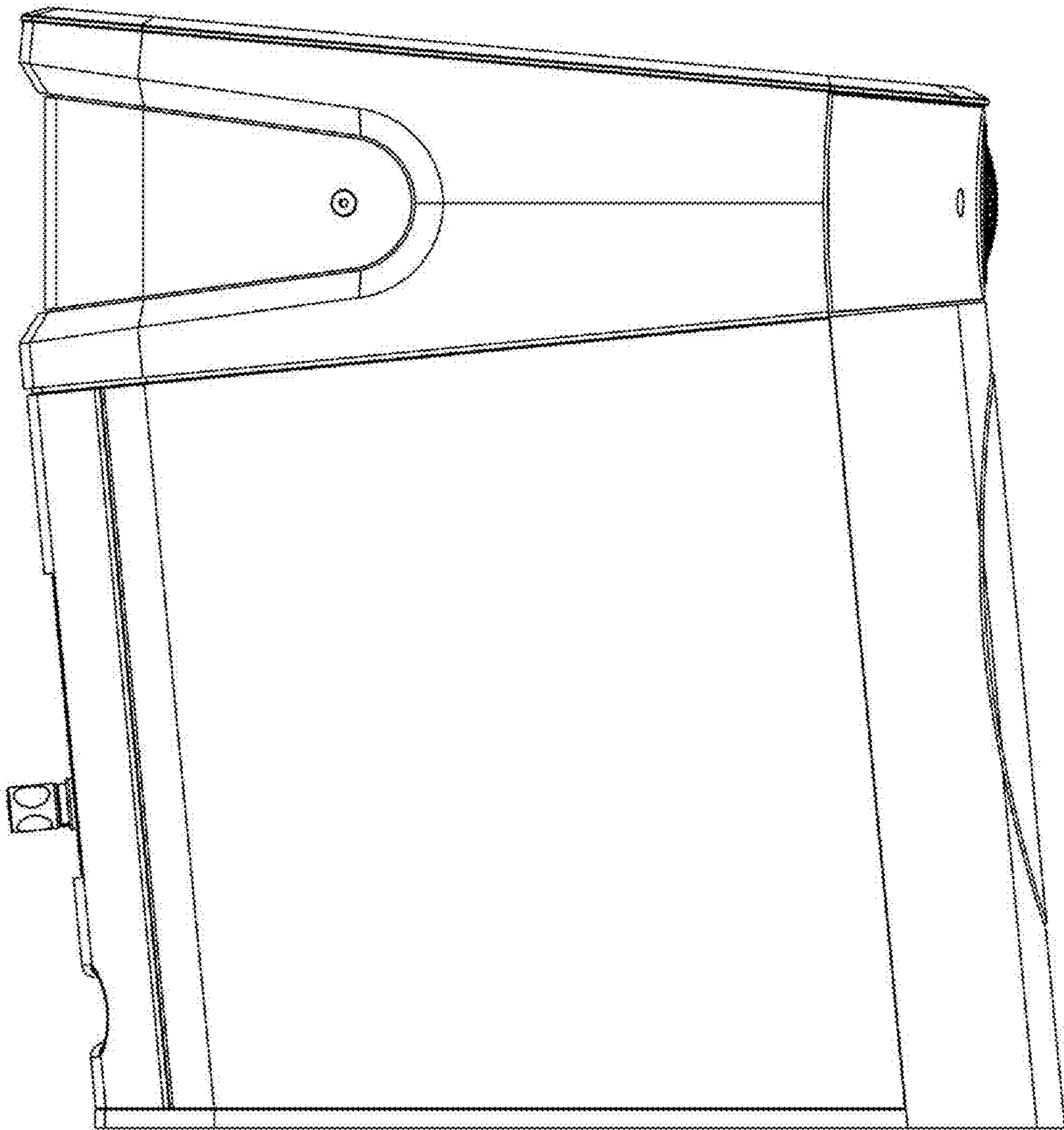

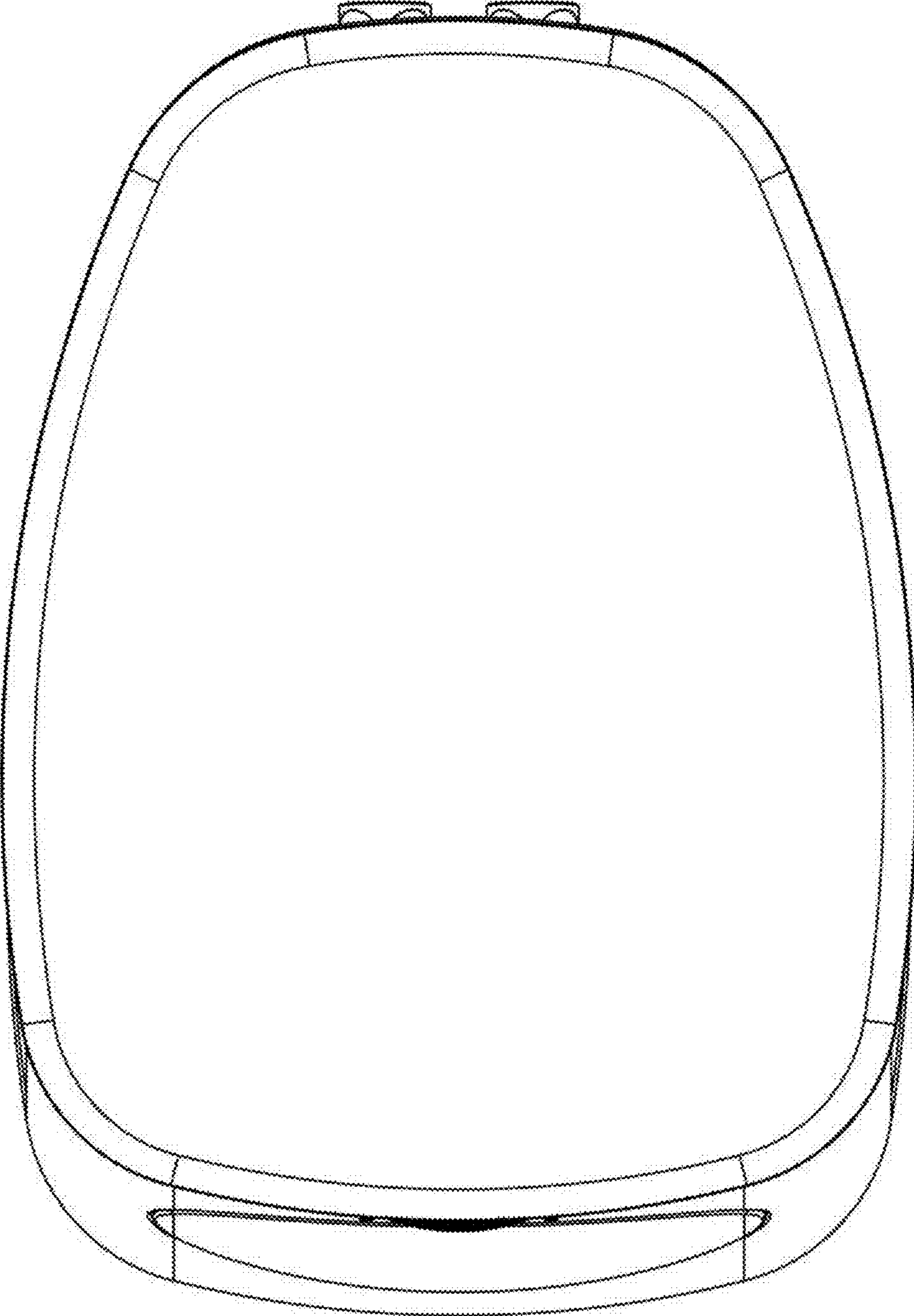
