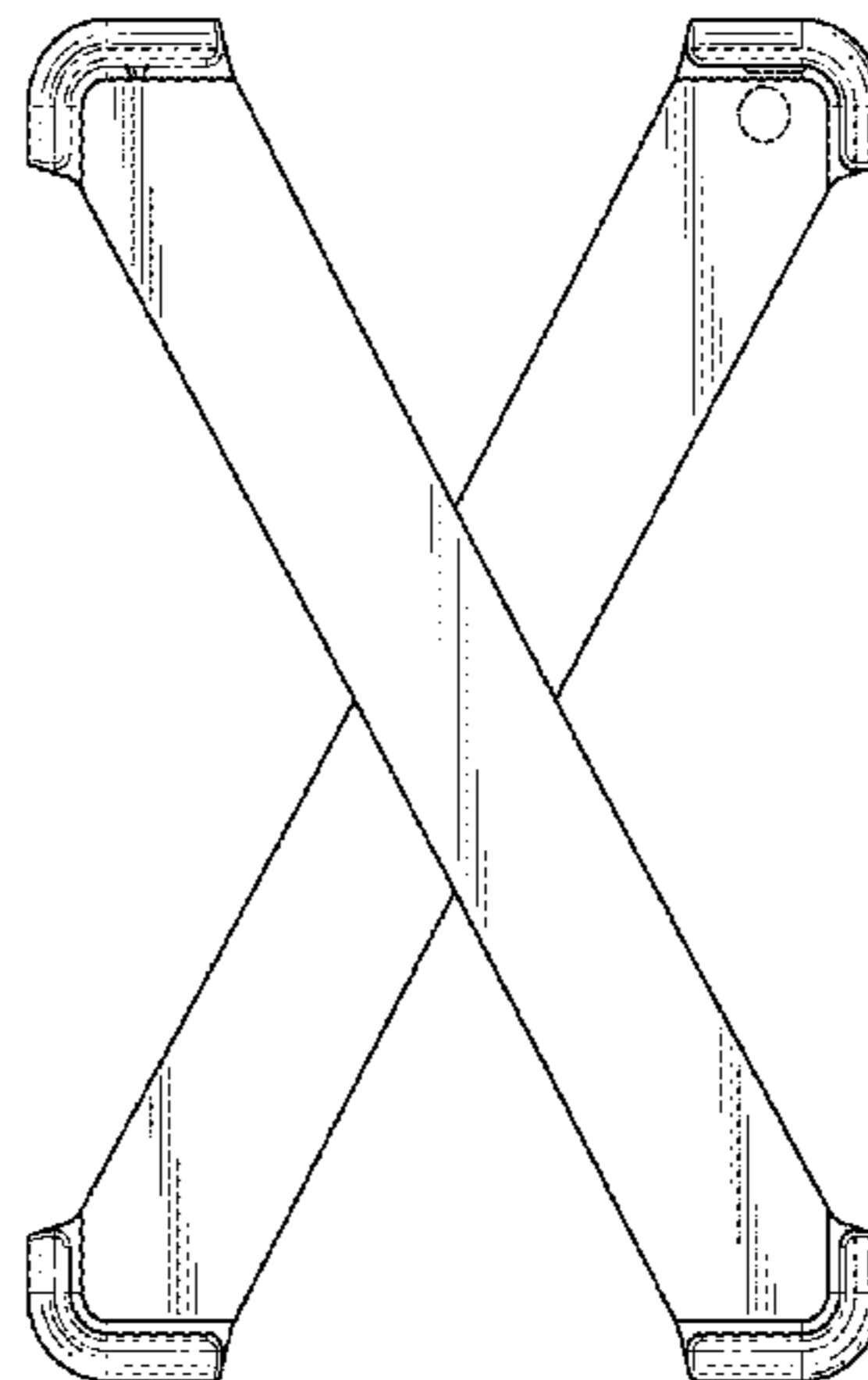
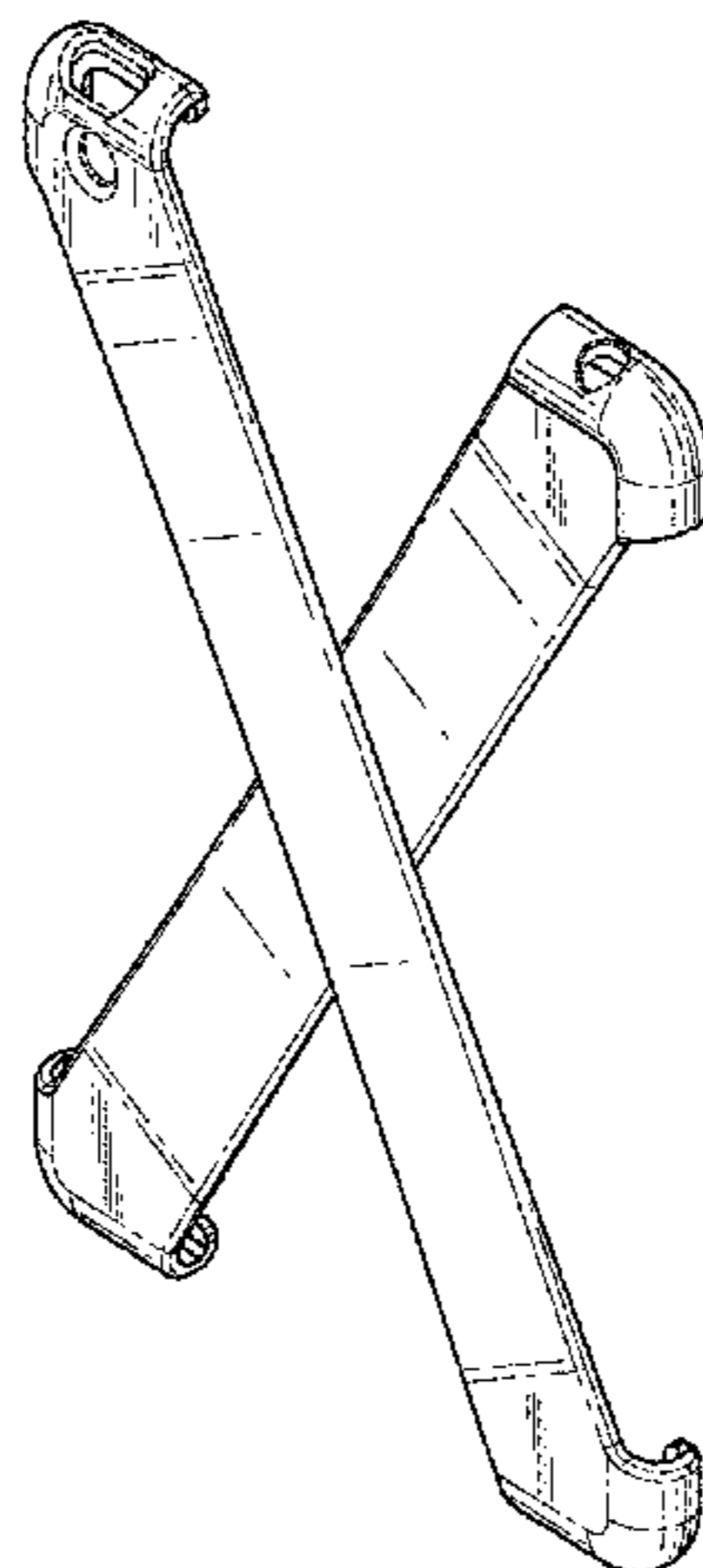
(57) **CLAIM**

The ornamental design for a mobile communications device case, as shown and described.

DESCRIPTION

FIG. 1 is a front/right perspective view of the mobile communications device case of the present invention; FIG. 2 is a rear/left perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right elevational view thereof; FIG. 6 is a left elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines depict portions of the mobile communications device case that form no part of the claimed design.

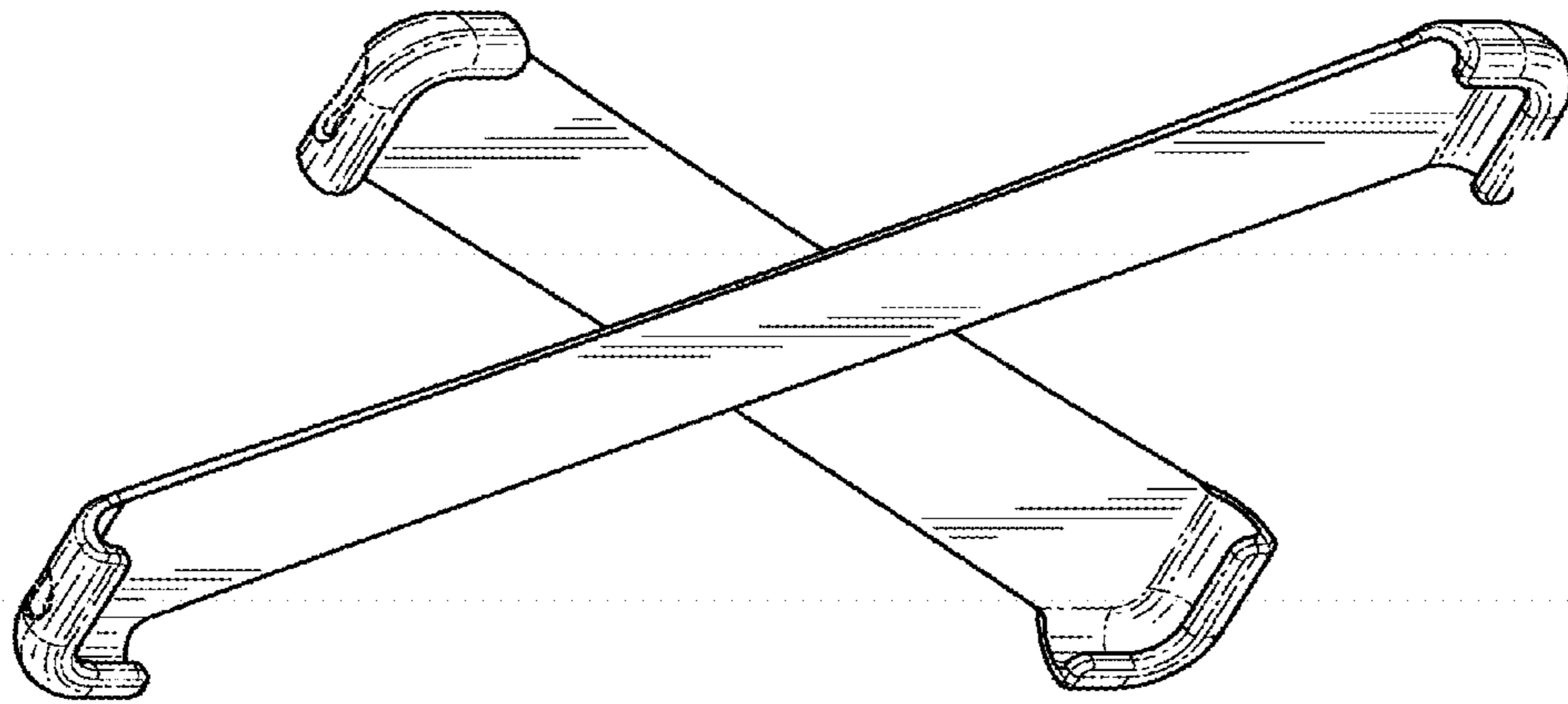

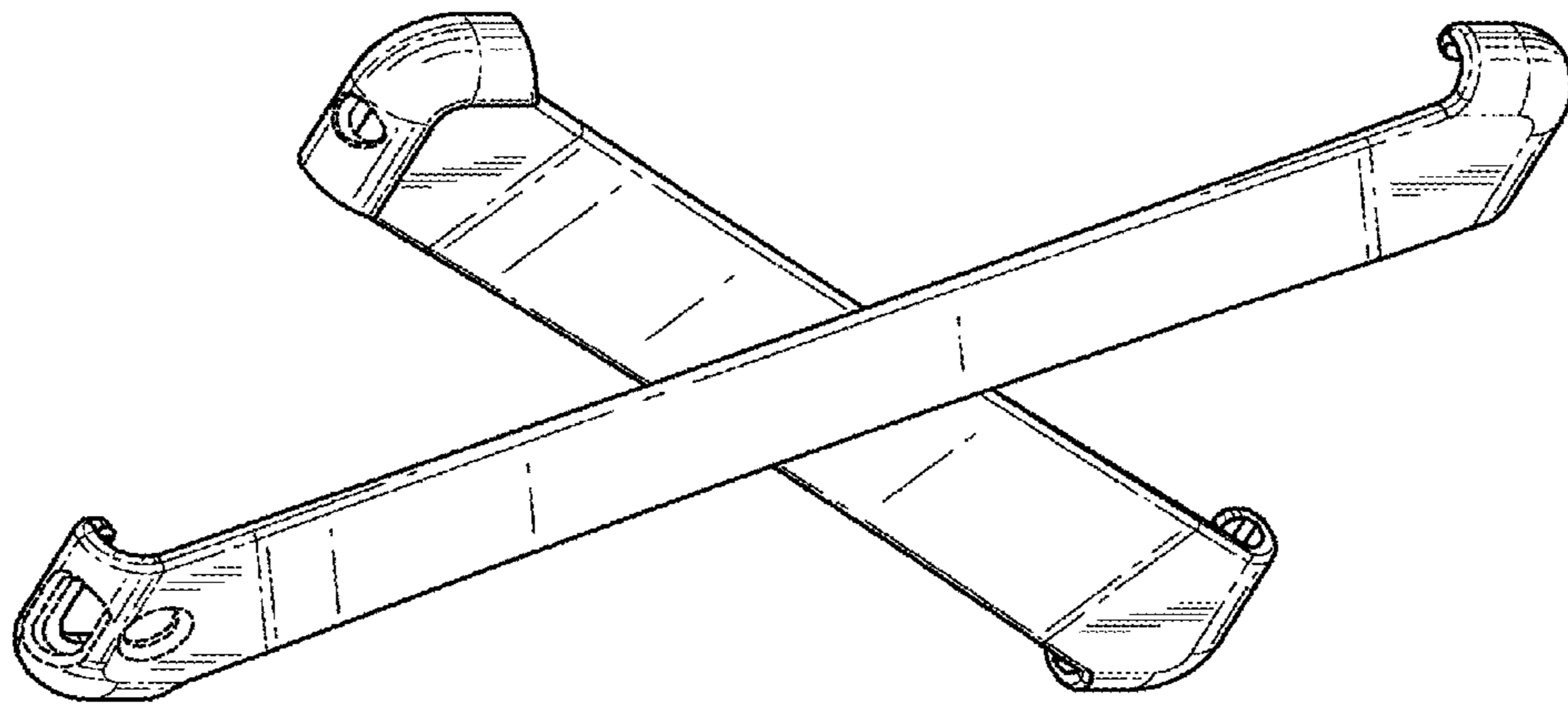

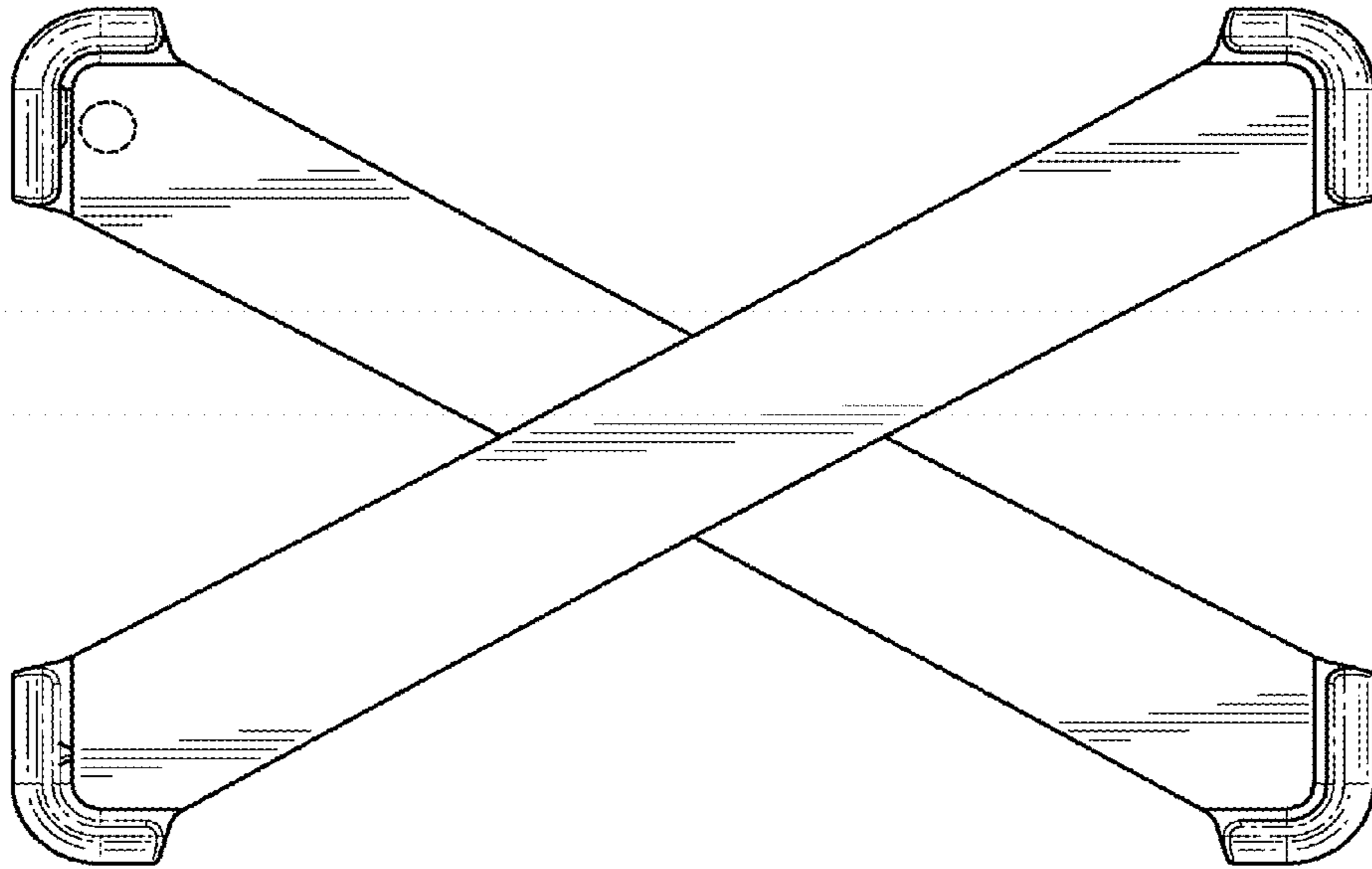

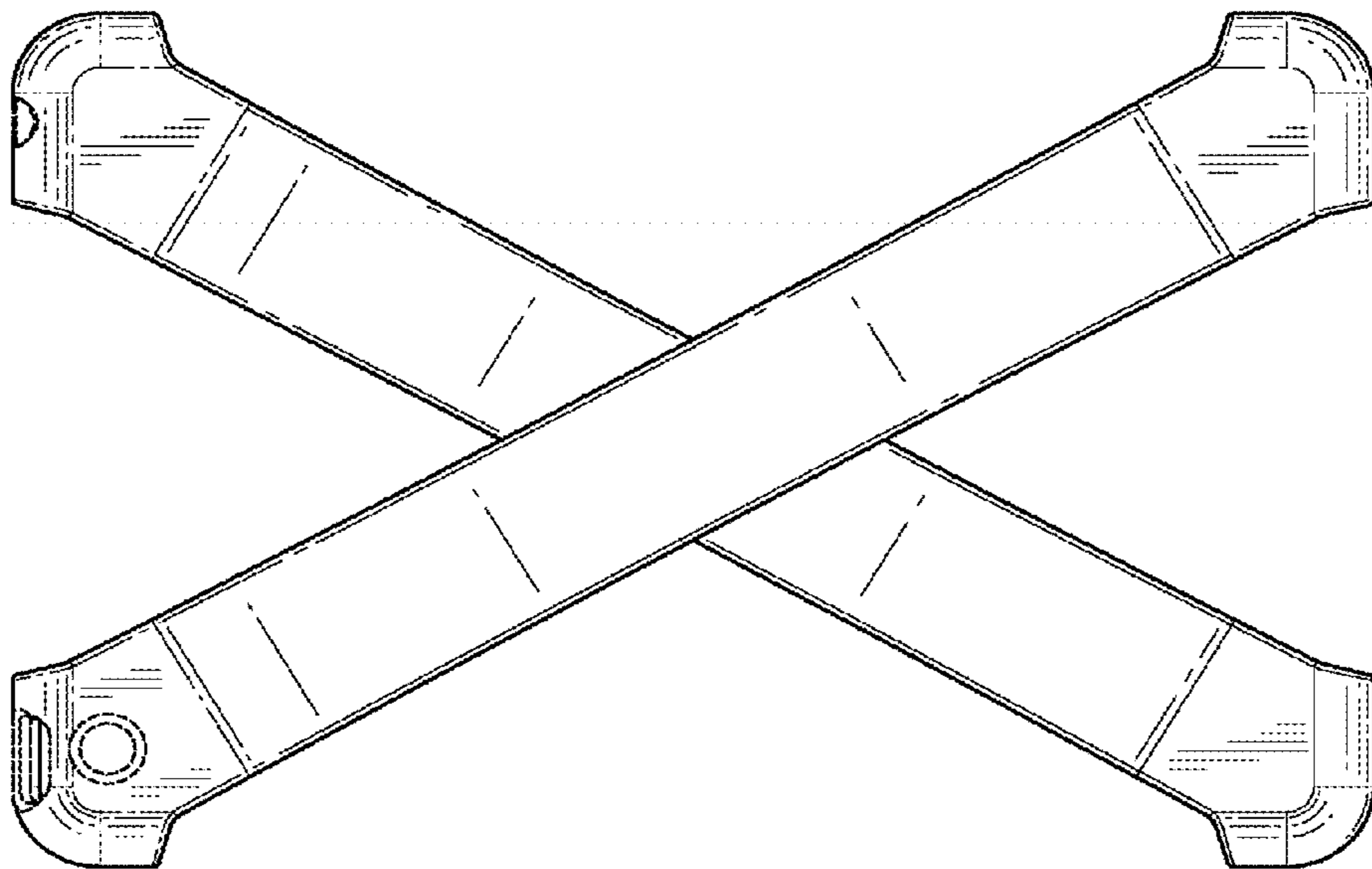

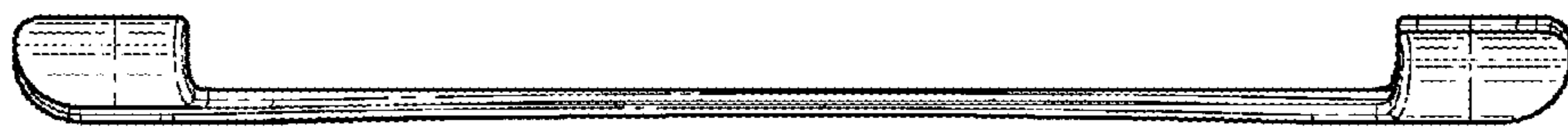

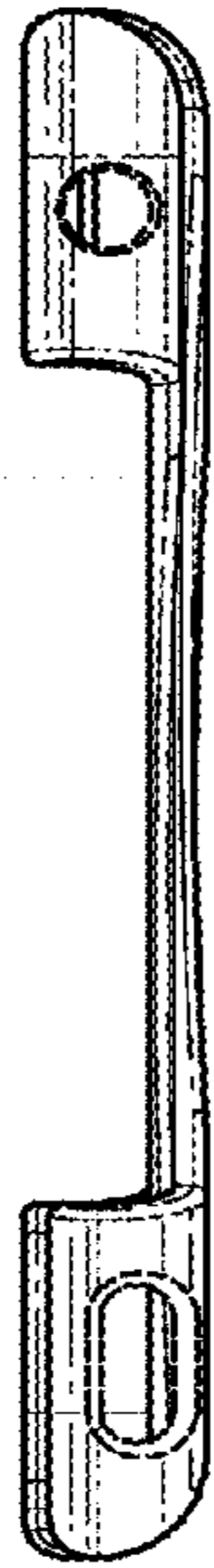

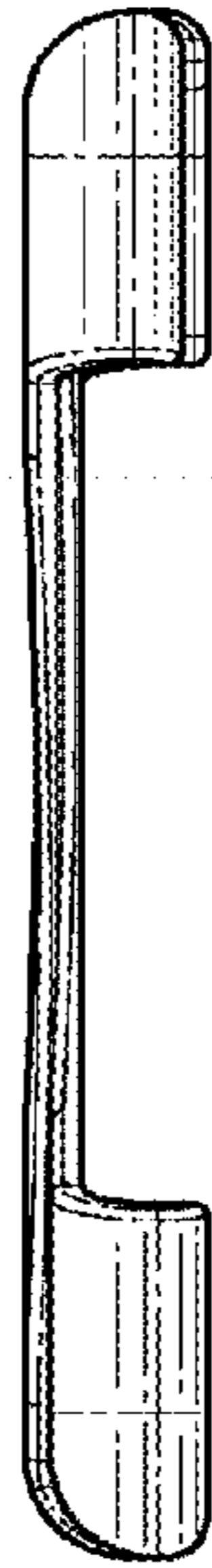

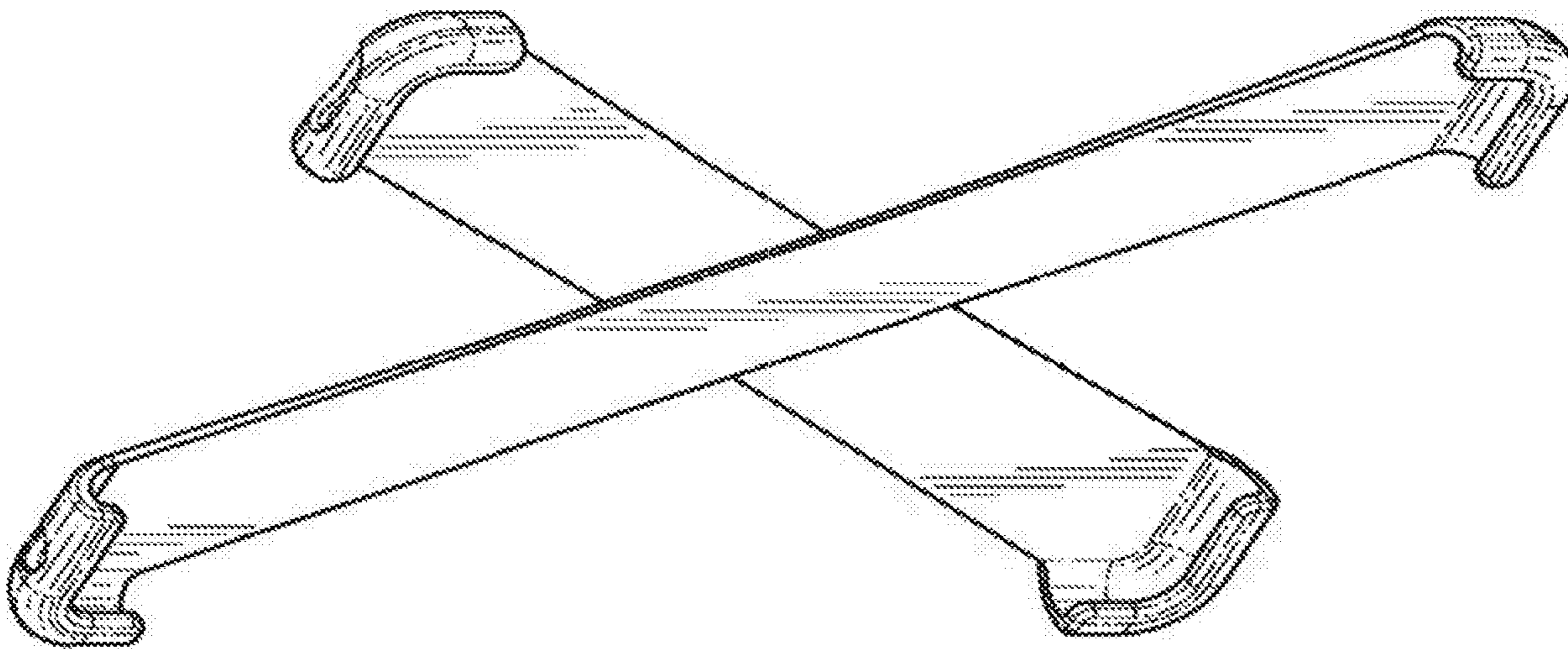
