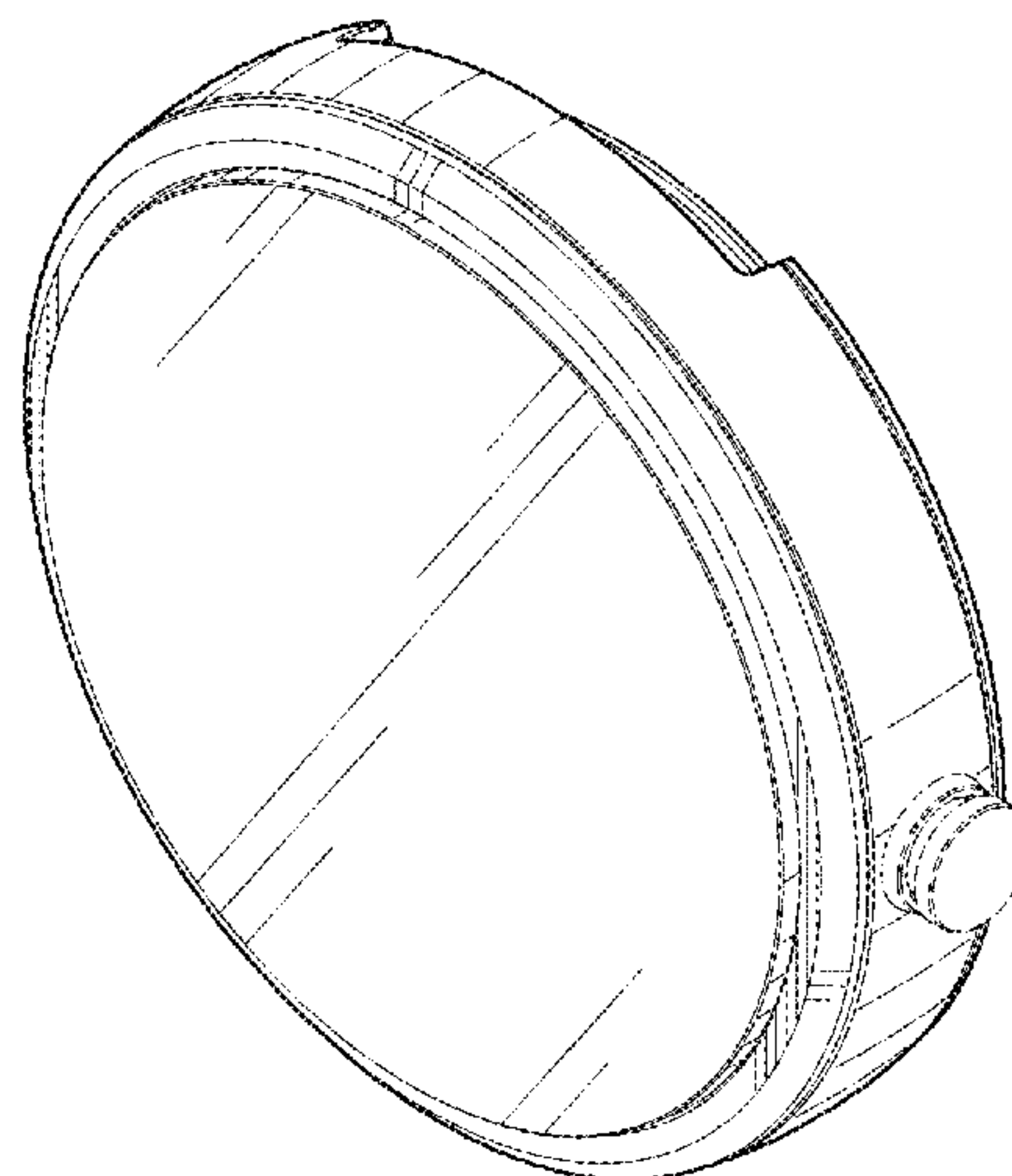
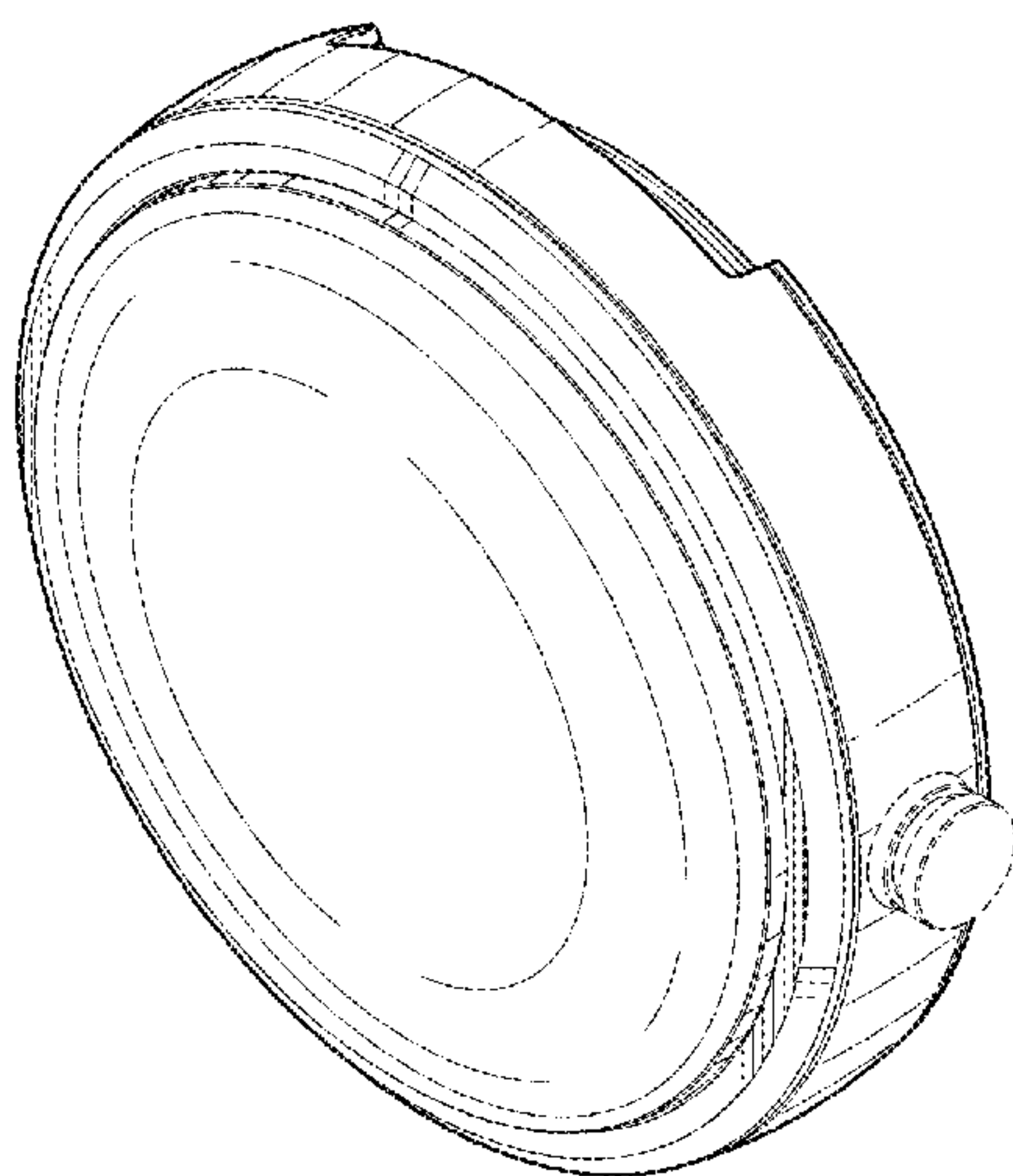
(57) **CLAIM**

The ornamental design for a wearable electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of an ornamental design for a wearable electronic device; FIG. 2 is a rear perspective view of the first embodiment thereof; FIG. 3 is a front view of the first embodiment thereof; FIG. 4 is a rear view of the first embodiment thereof; FIG. 5 is a first side view of the first embodiment thereof; FIG. 6 is a second side view of the first embodiment thereof; FIG. 7 is a top view of the first embodiment thereof; and FIG. 8 is a bottom view of the first embodiment thereof. 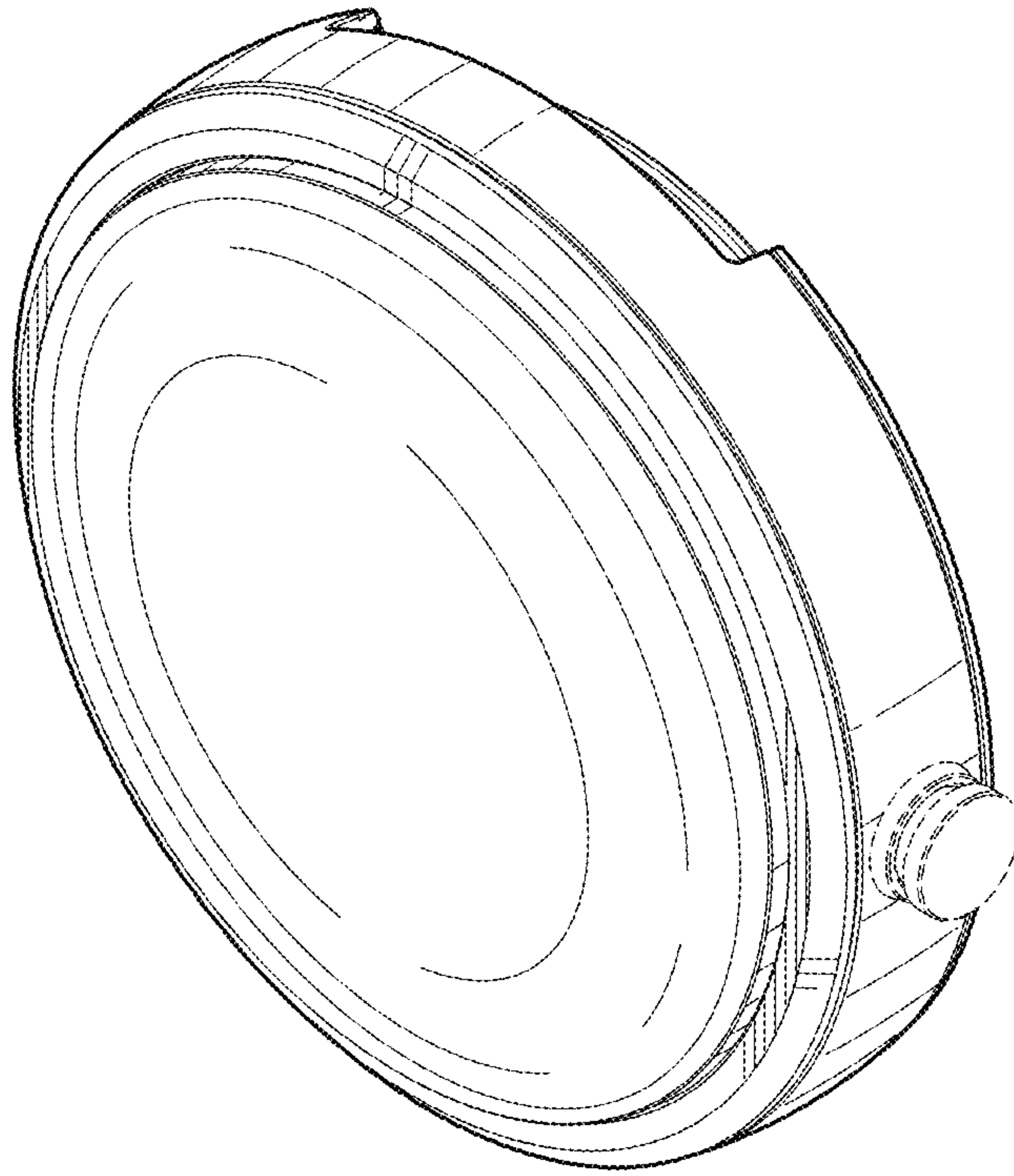

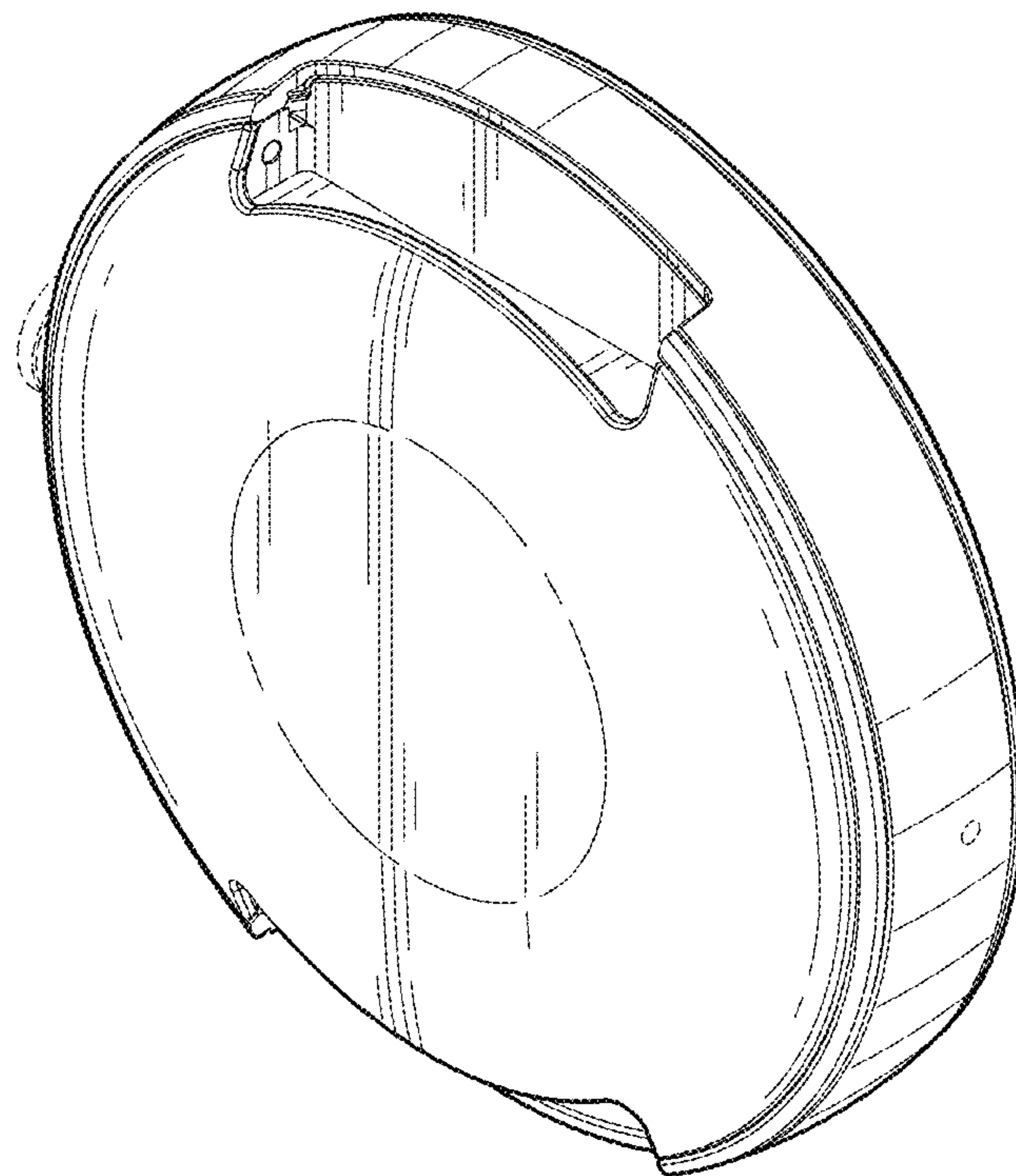

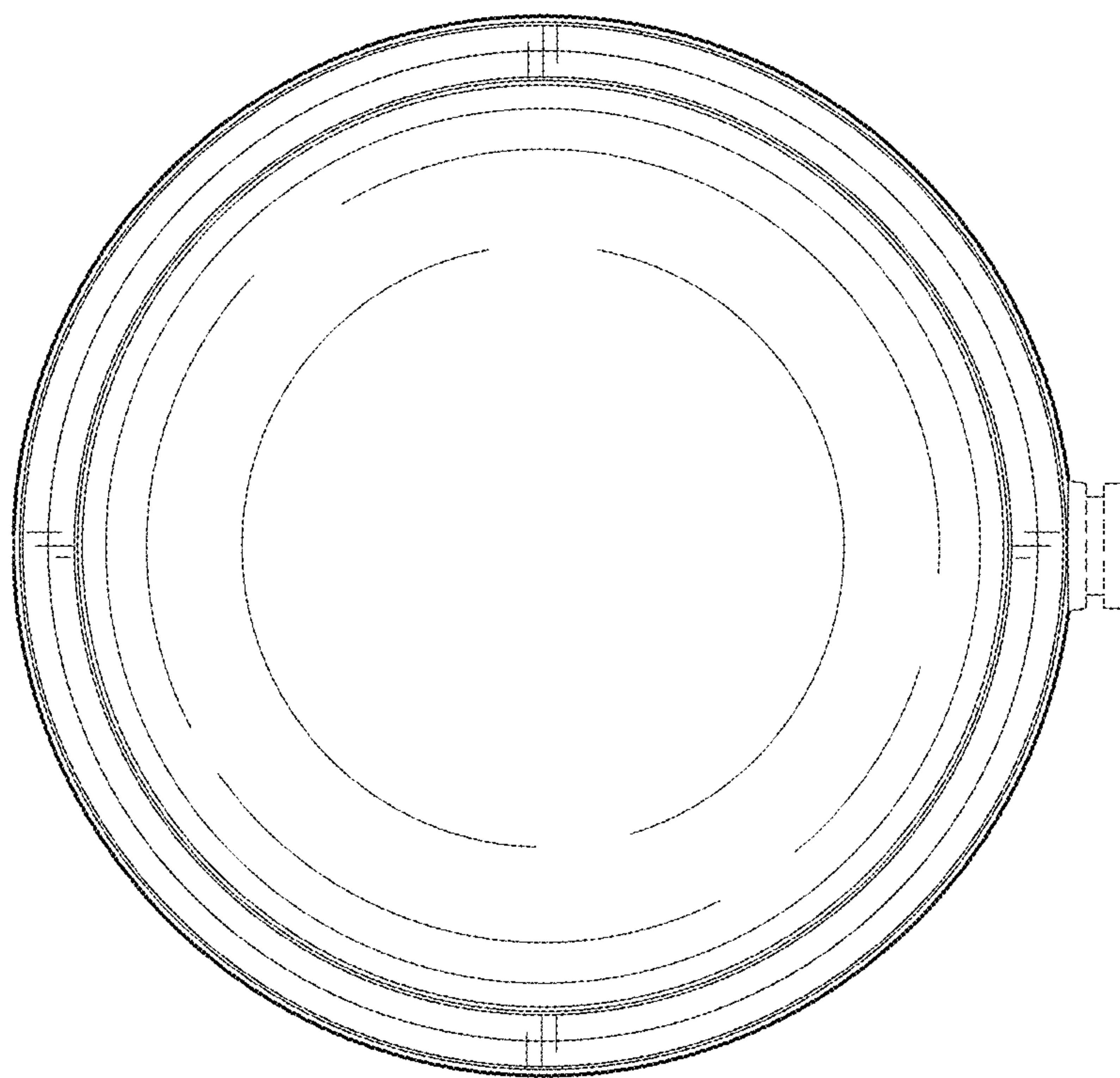

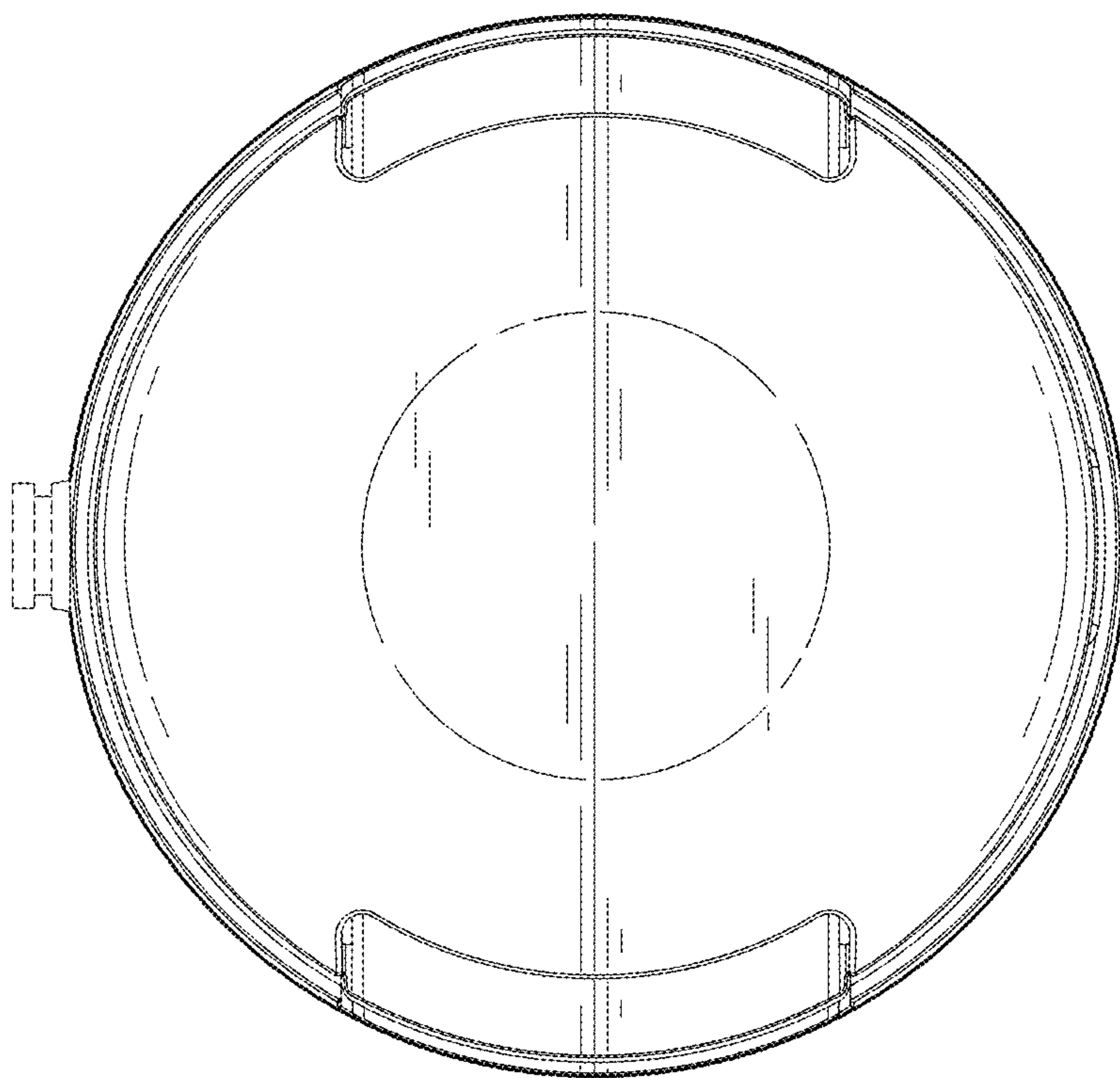

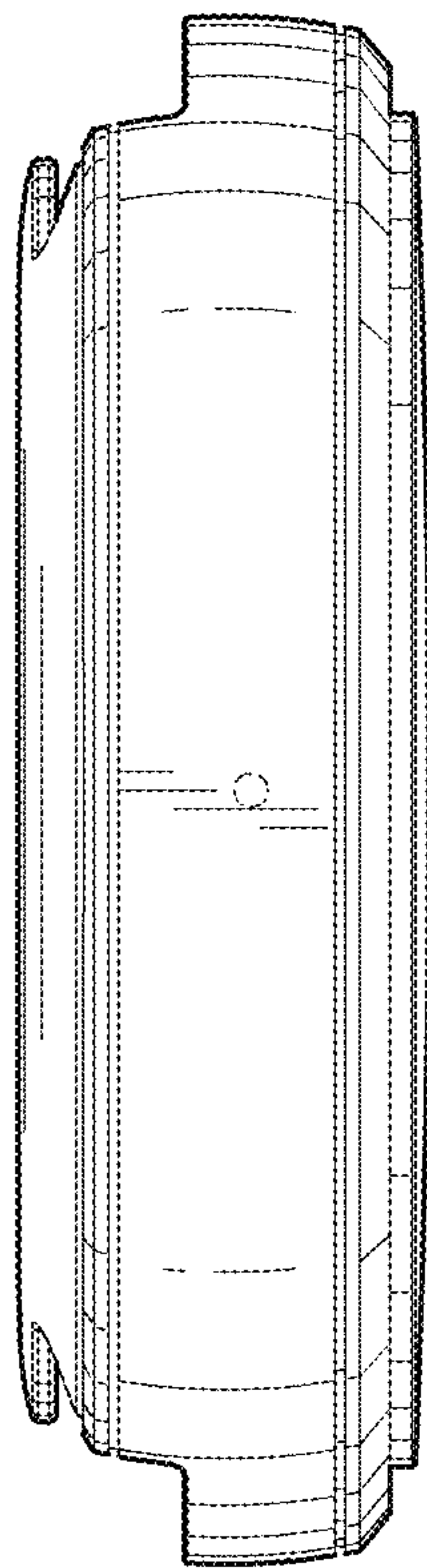

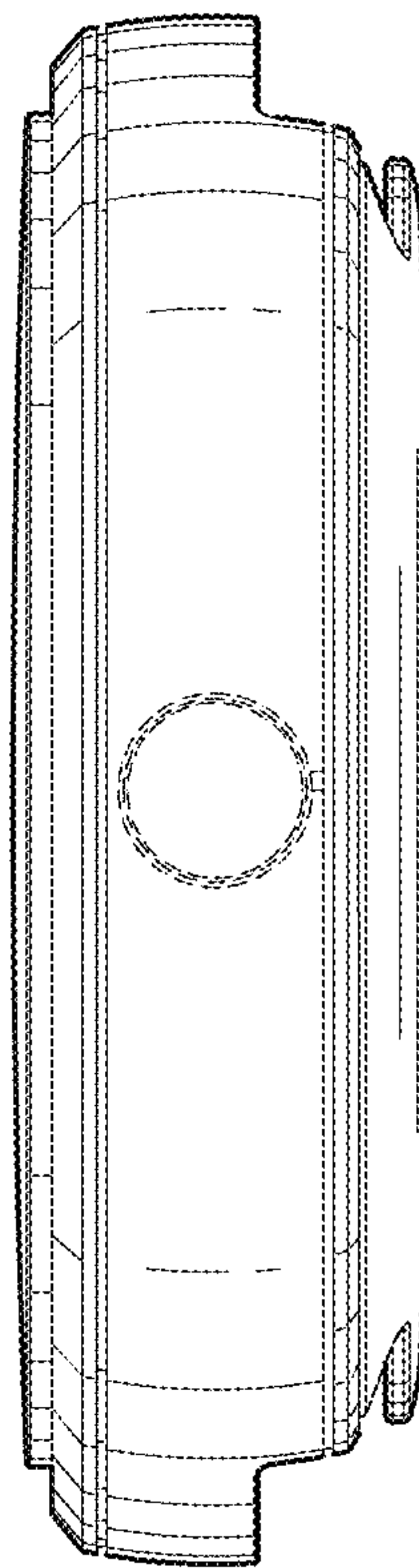

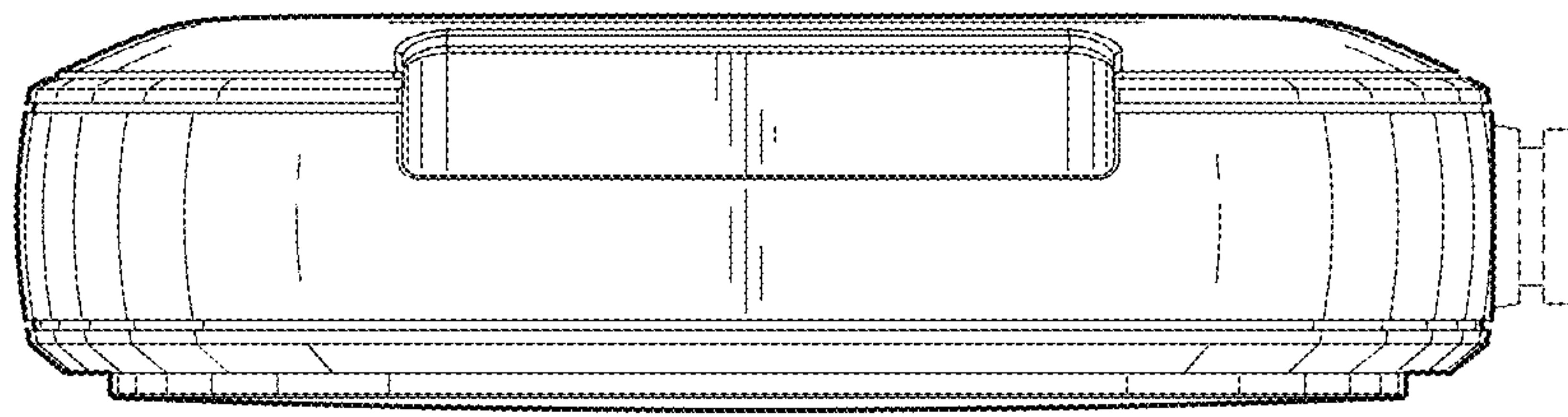

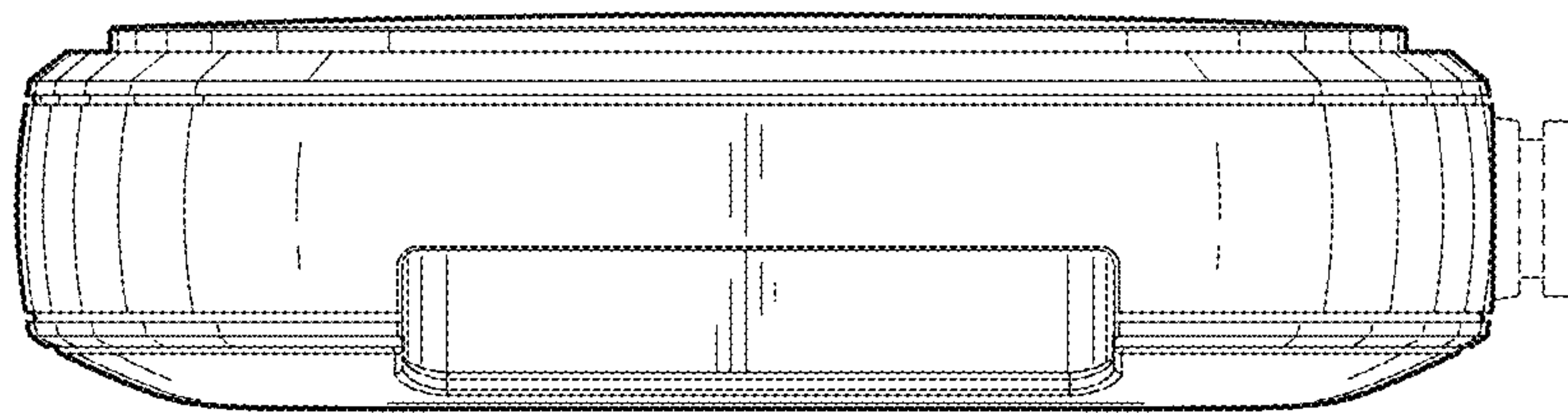

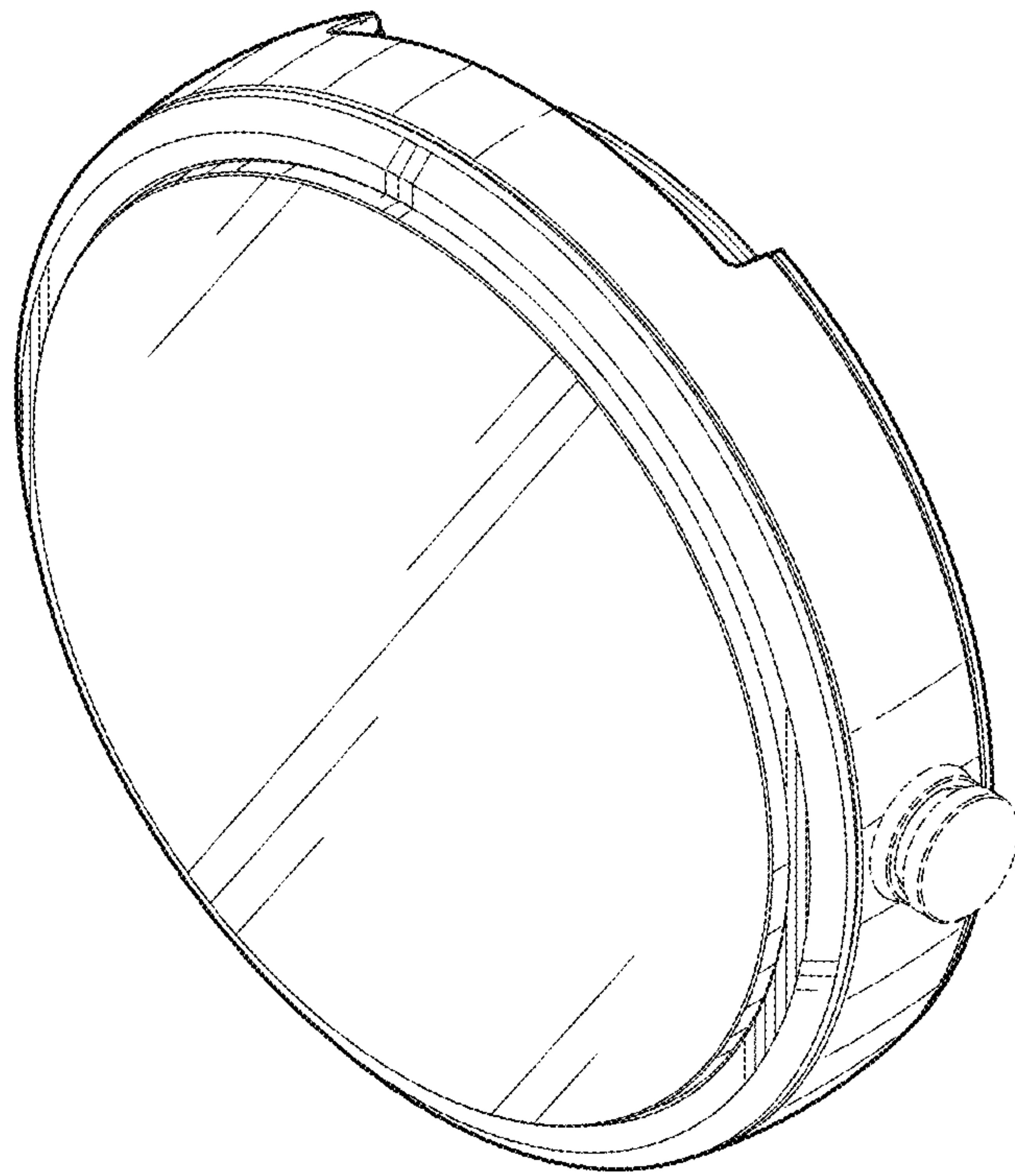

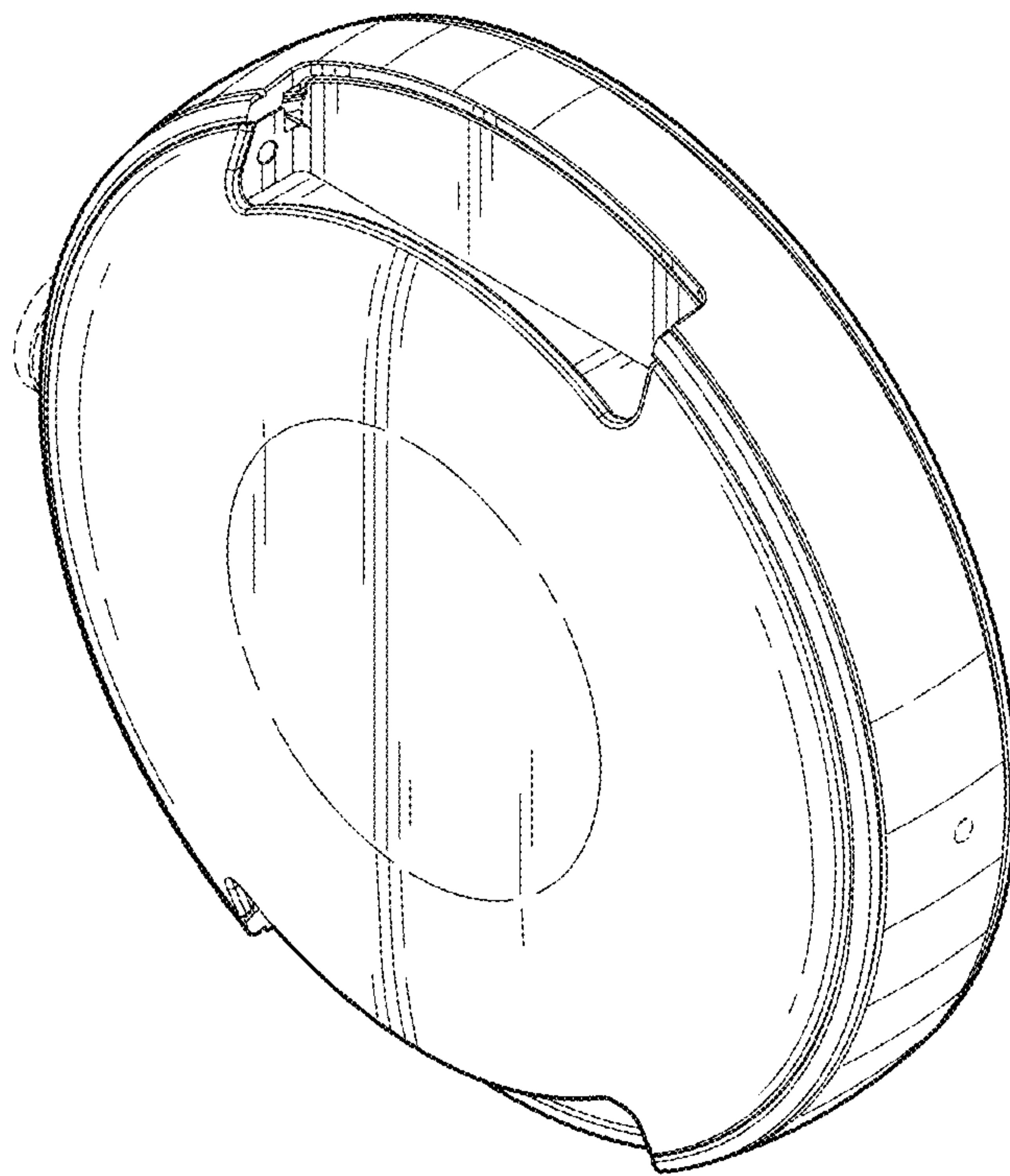

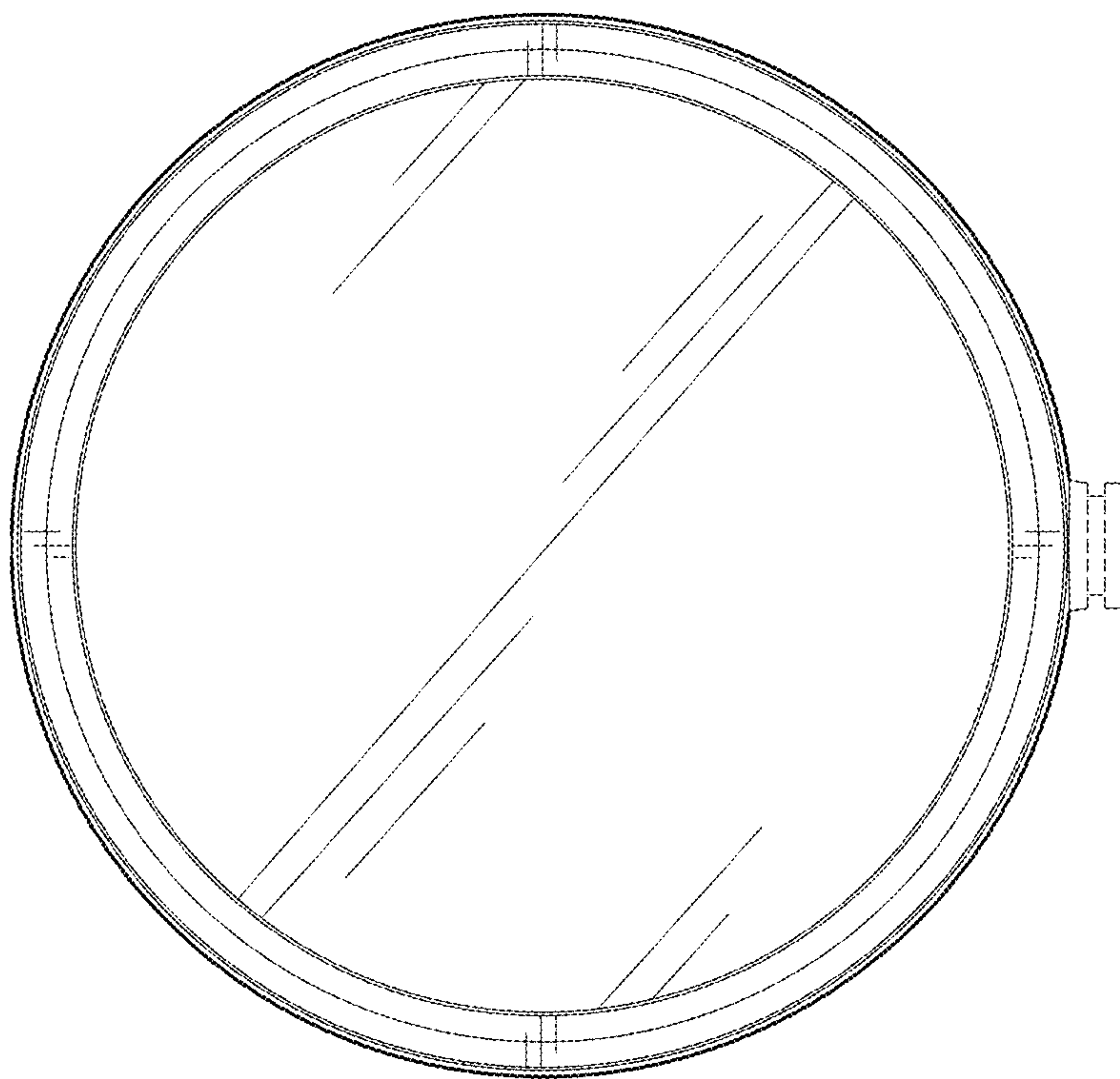

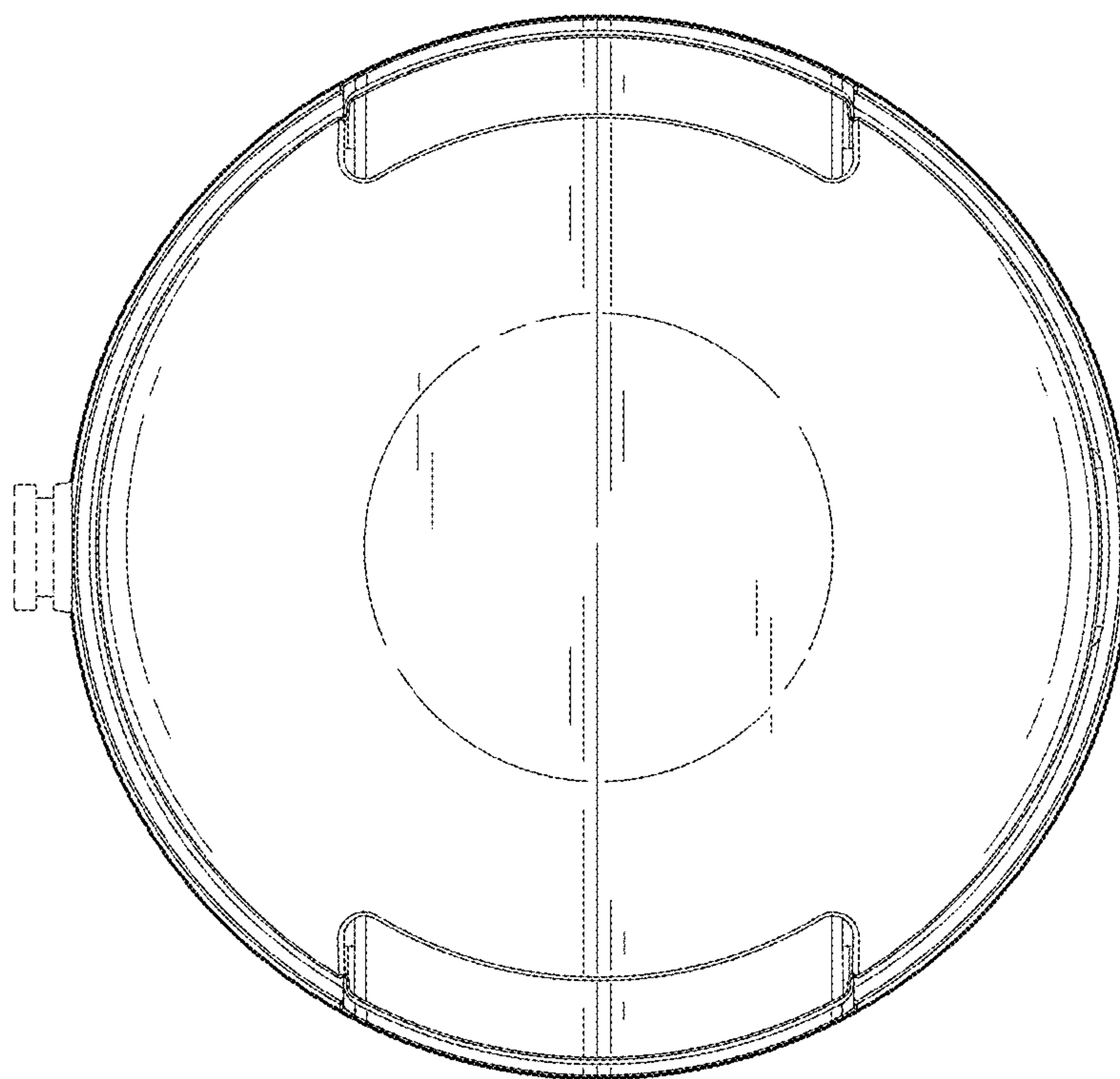

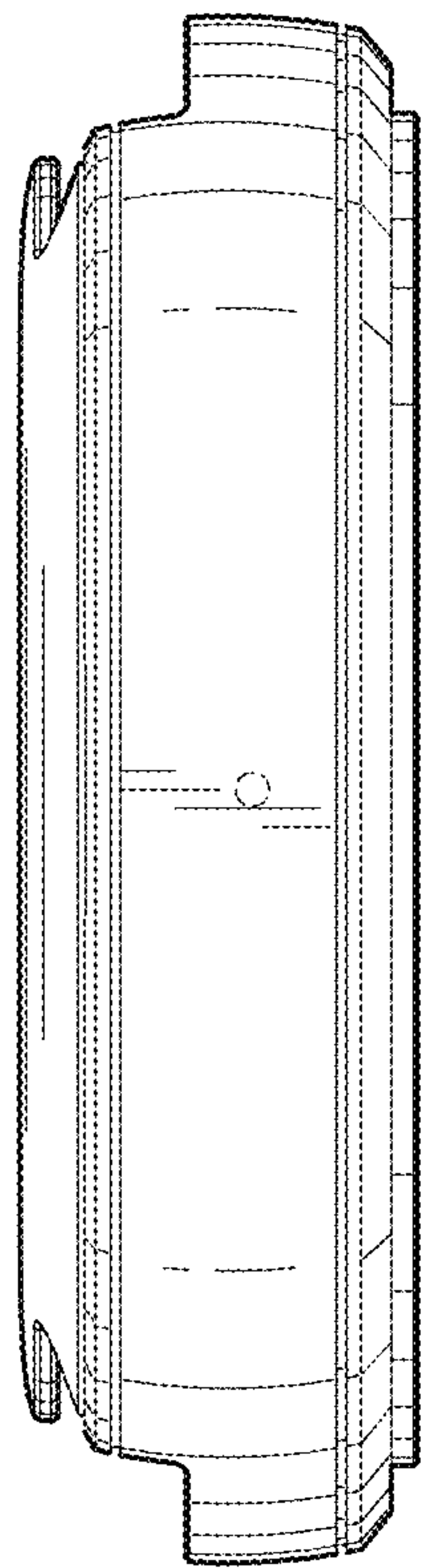

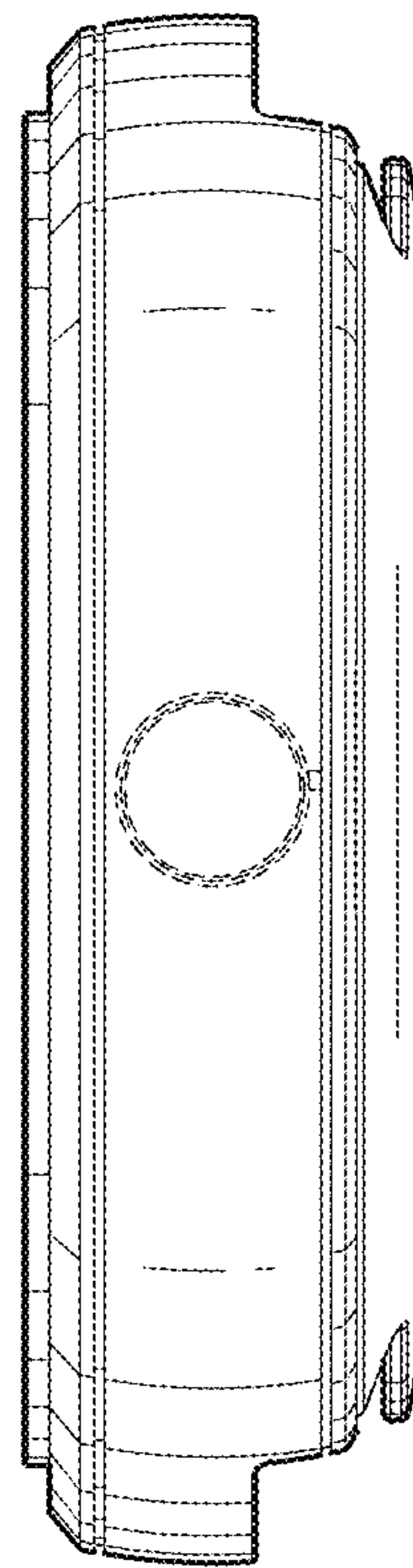

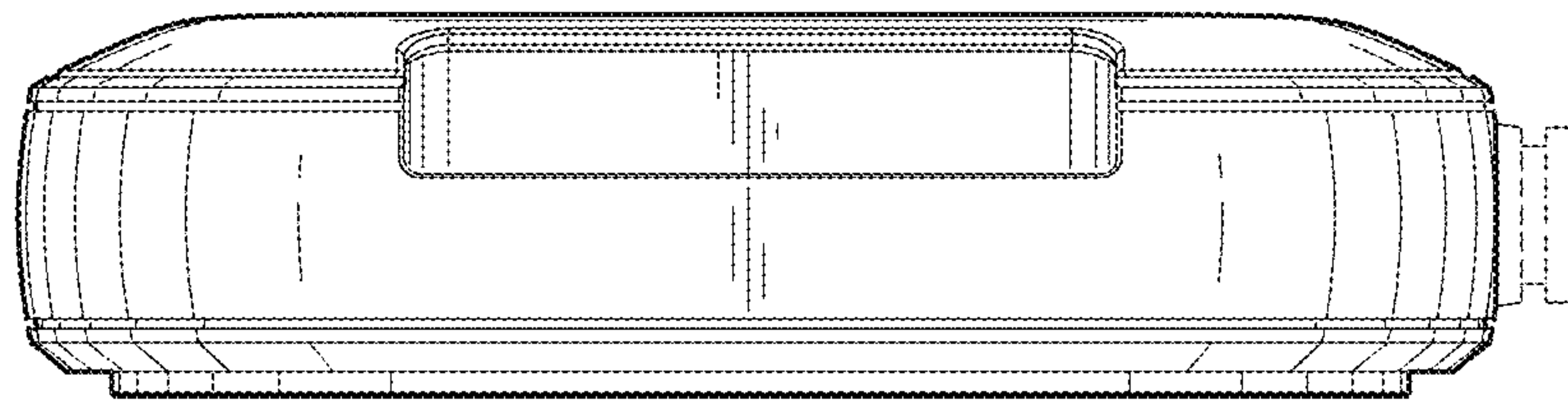

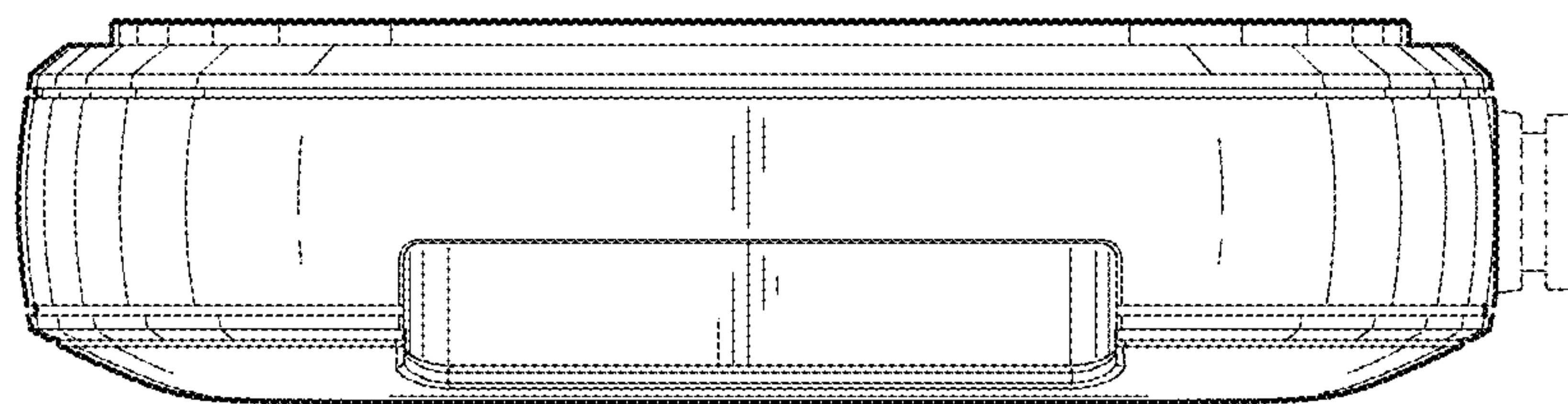
