**CLAIM**

The ornamental design of a modular media player, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan of a modular media player showing my new design;

FIG. 2 is a side elevational view thereof.

FIG. 3 is a top plan view of a music player module of a modular media player, shown separately for clarity of illustration;

FIG. 4 is a side elevational view of FIG. 3;

FIG. 5 is another side elevational view of FIG. 3;

FIG. 6 is a bottom plan view of FIG. 3, shown with car phone attachment;

FIG. 7 is a top plan view of a speaker module of a modular media player, shown separately for clarity of illustration;

FIG. 8 is a top plan view of a display module of a modular media player, shown separately for clarity of illustration;

FIG. 9 is a side elevational view of FIG. 7;

FIG. 10 is another side view of FIG. 7;

FIG. 11 is a top plan view of a combination of a music player and speaker module of a modular media player;

FIG. 12 is a top plan view of a combination of music player and display module of a modular media player; and,

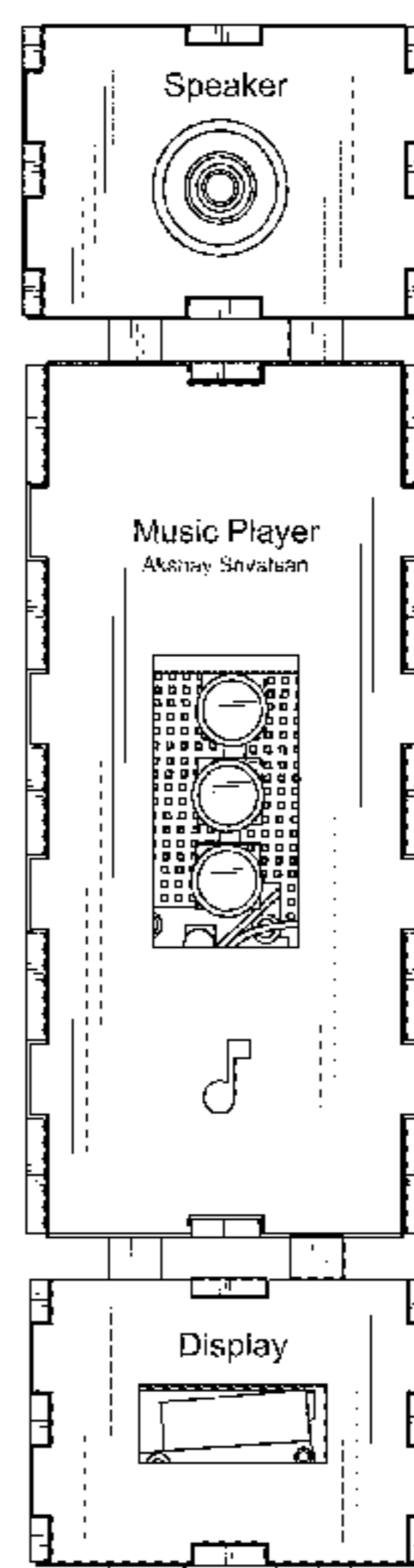
FIG. 13 is a top plan view of a modular media player shown in alternate arrangement of the music player, speaker, and display modules of a modular media player;

The broken lines indicate environment and form no part of the claimed design.

FIGS. 11 and 12 disclose the use of a modular media player with speaker and display modules respectively and FIG. 13 discloses alternate use of the modules of a modular media player.

The article of manufacture to which the ornamental design has been applied is a modular media player (e.g., MP3, Wav, AIFF etc.), a novelty item or toy.

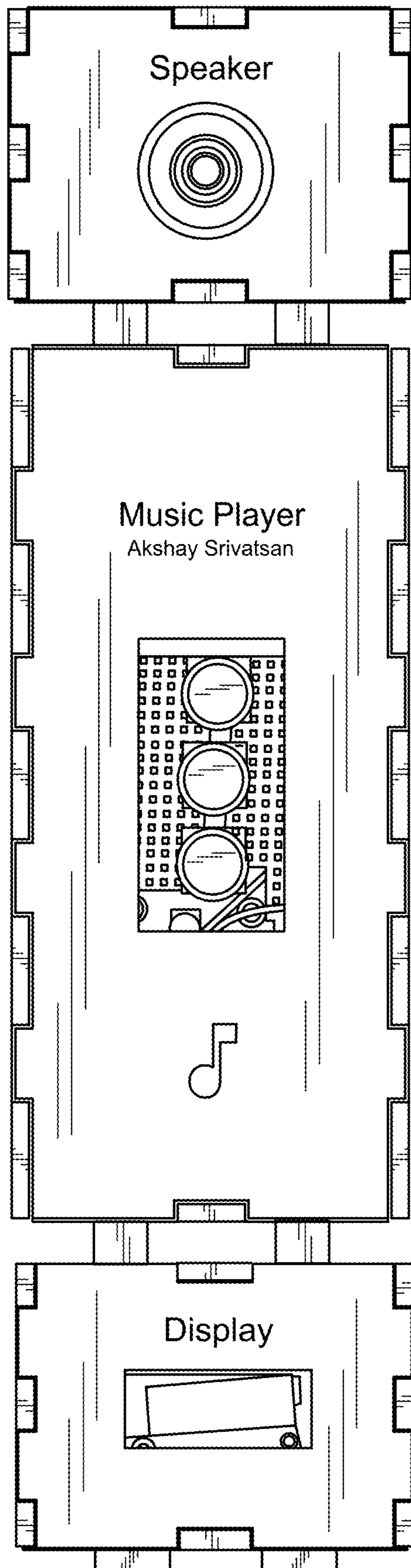

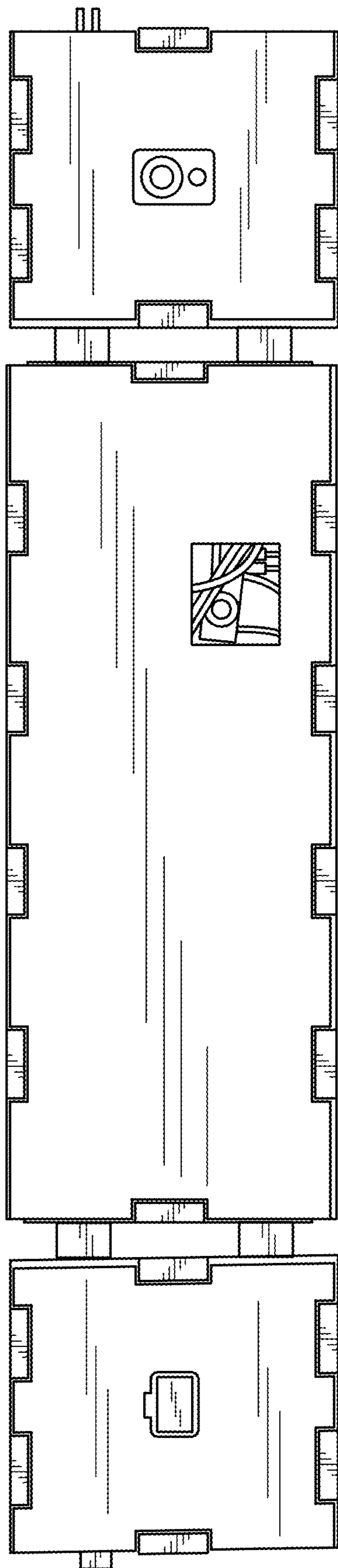

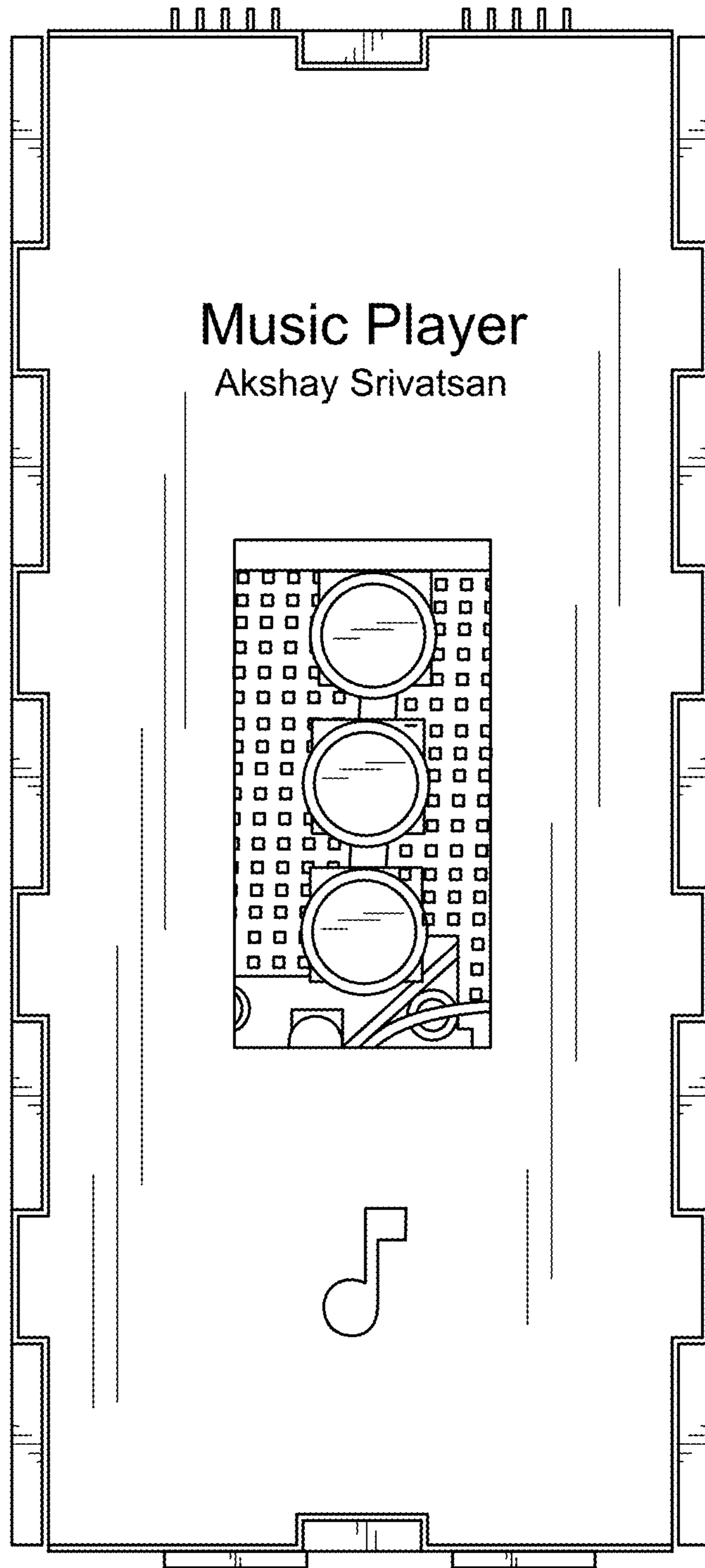

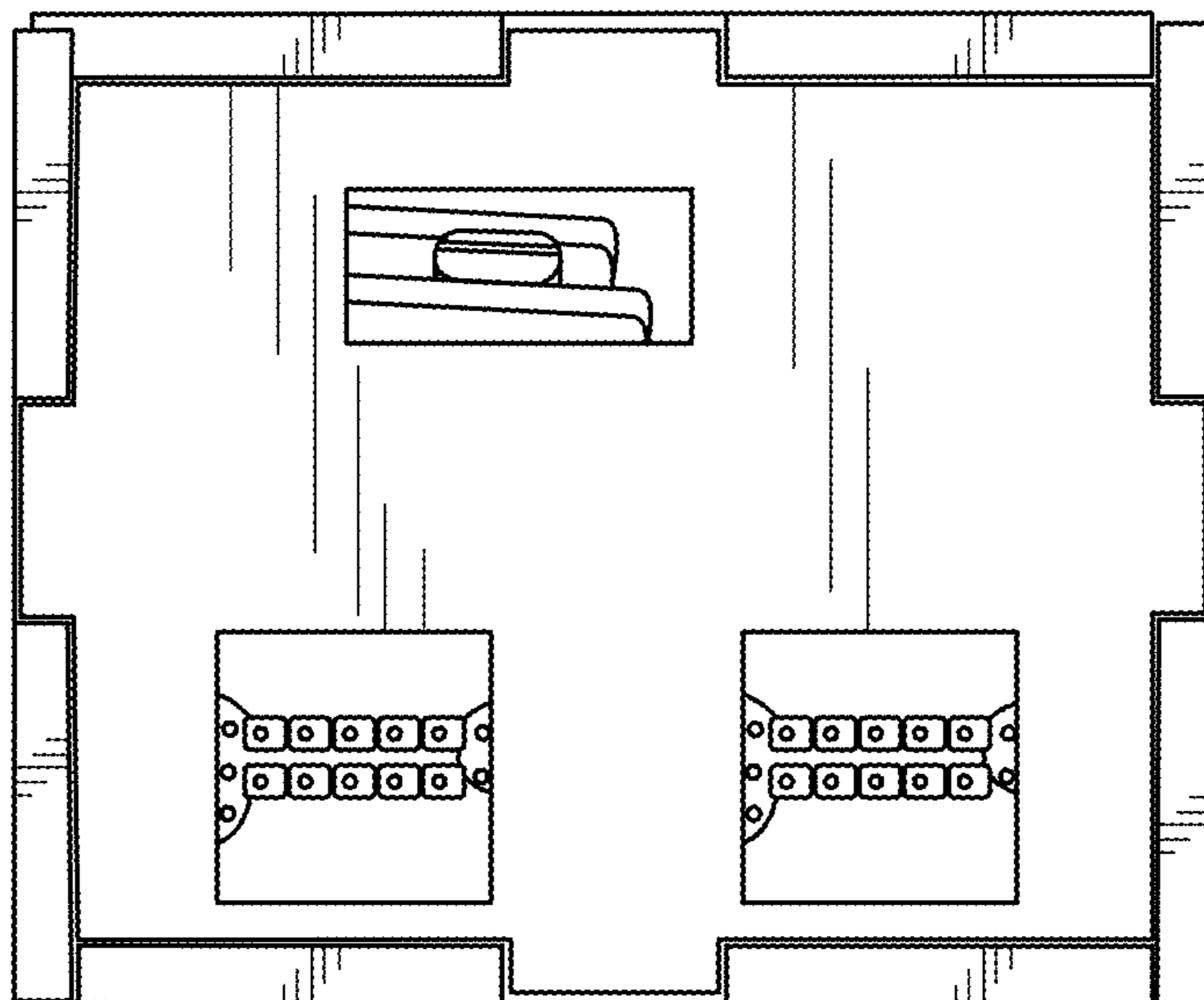

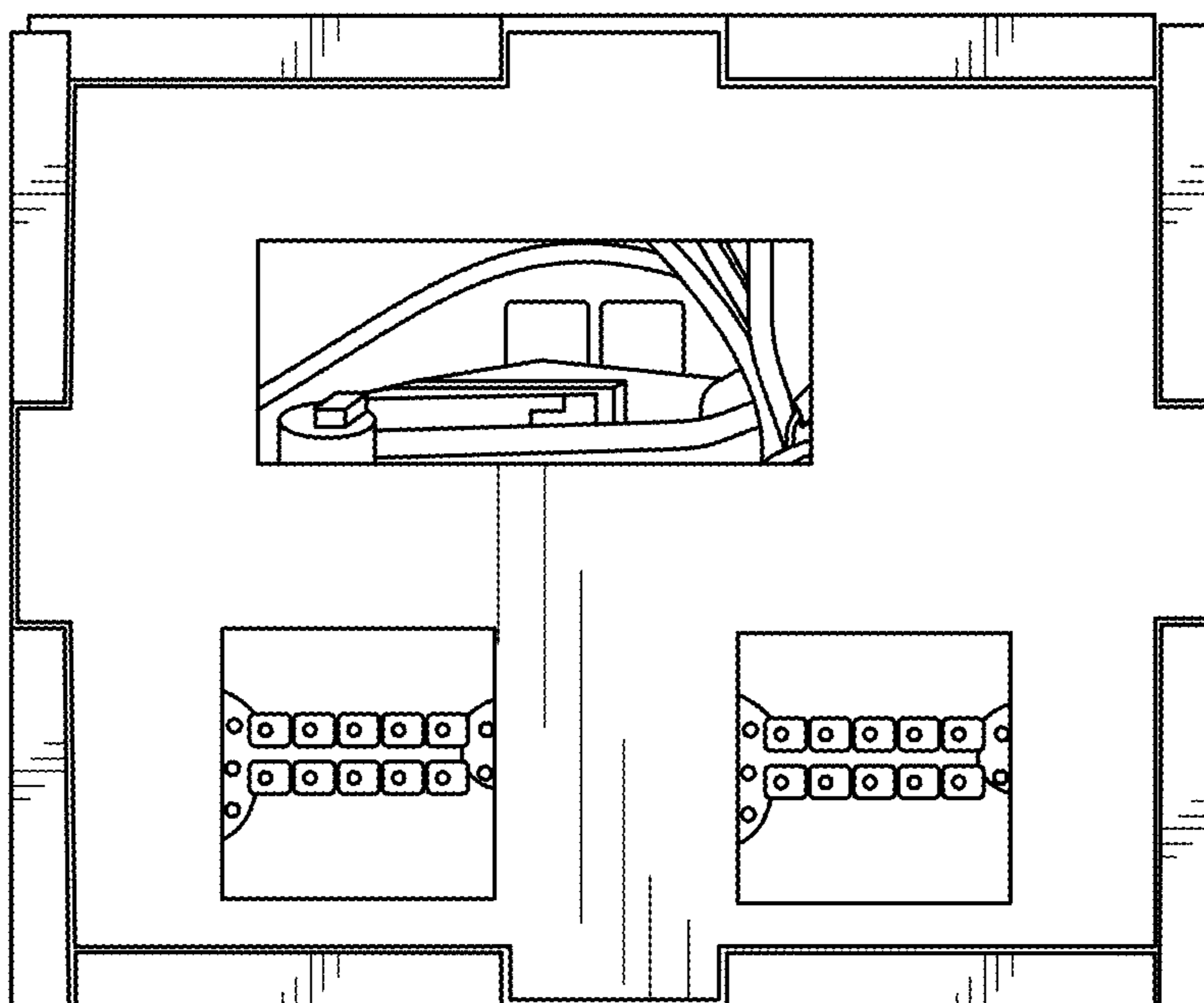

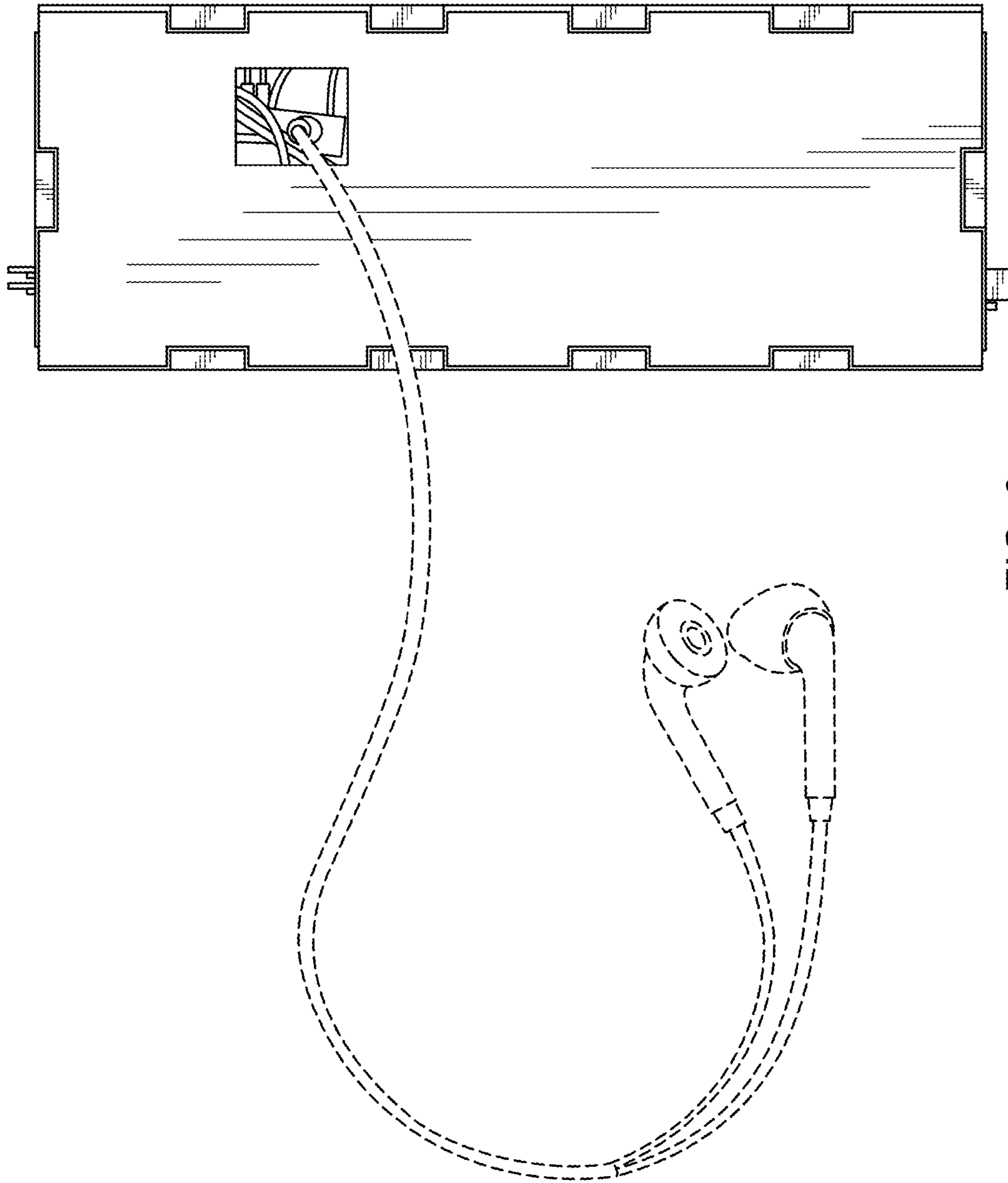

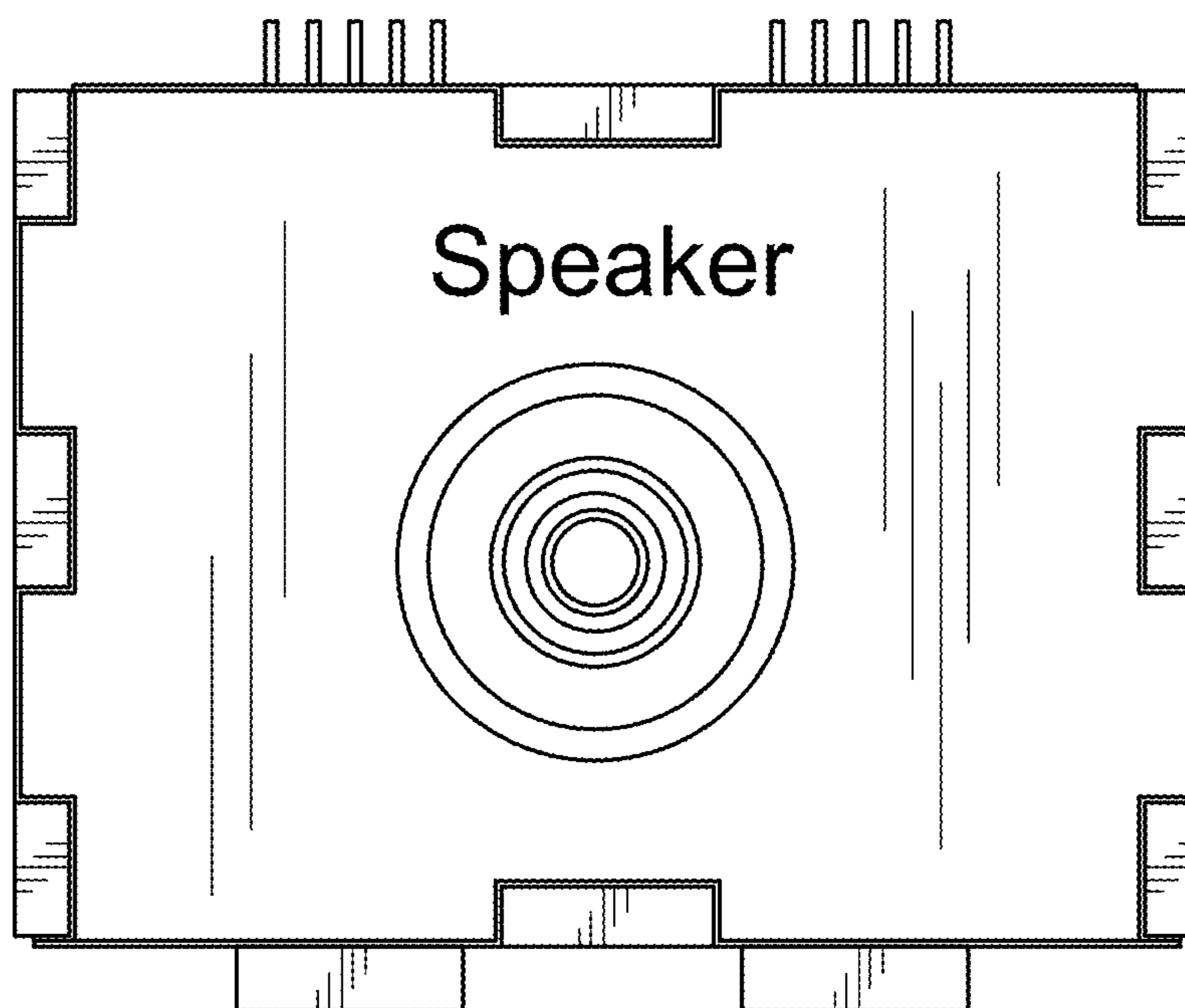

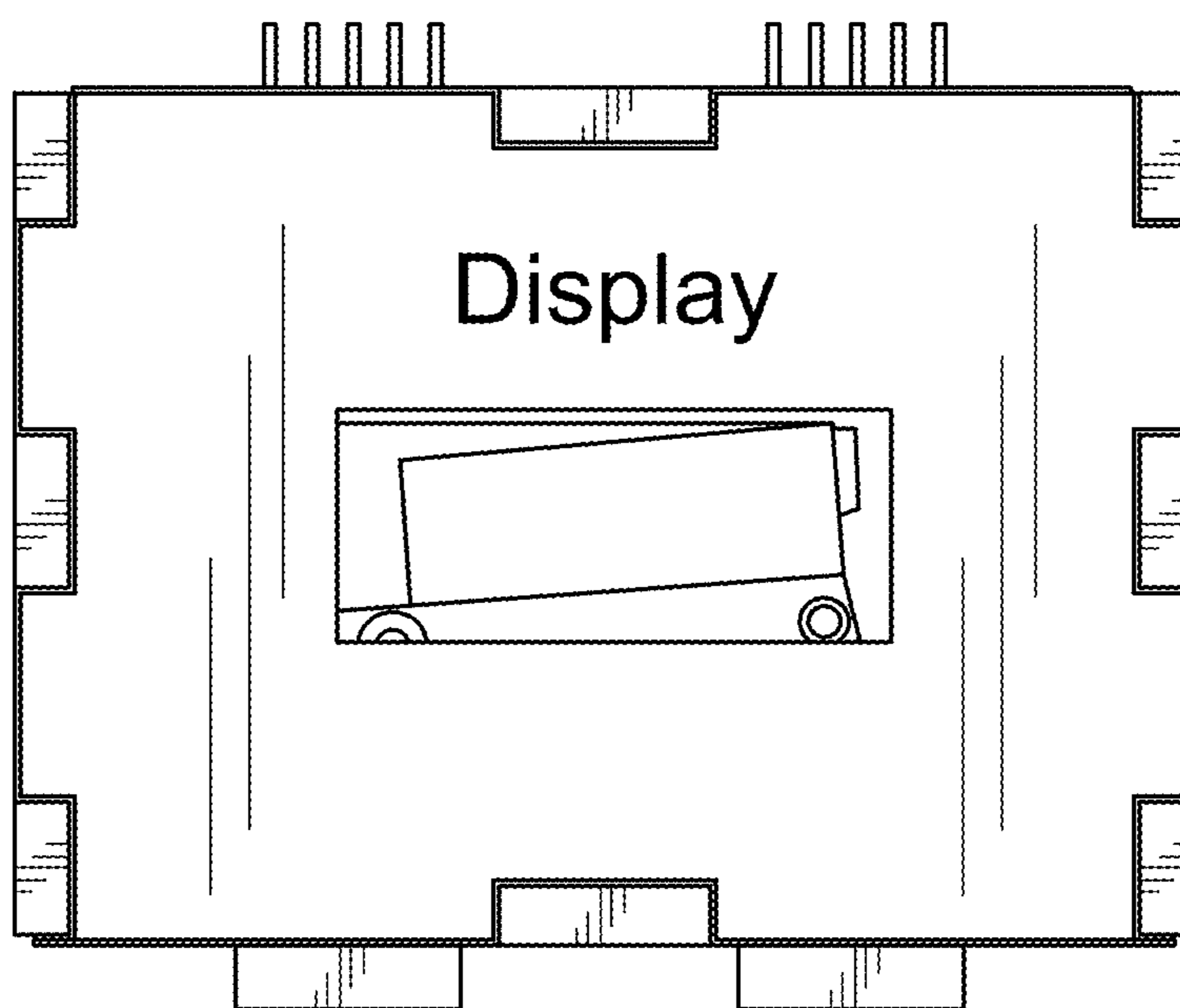

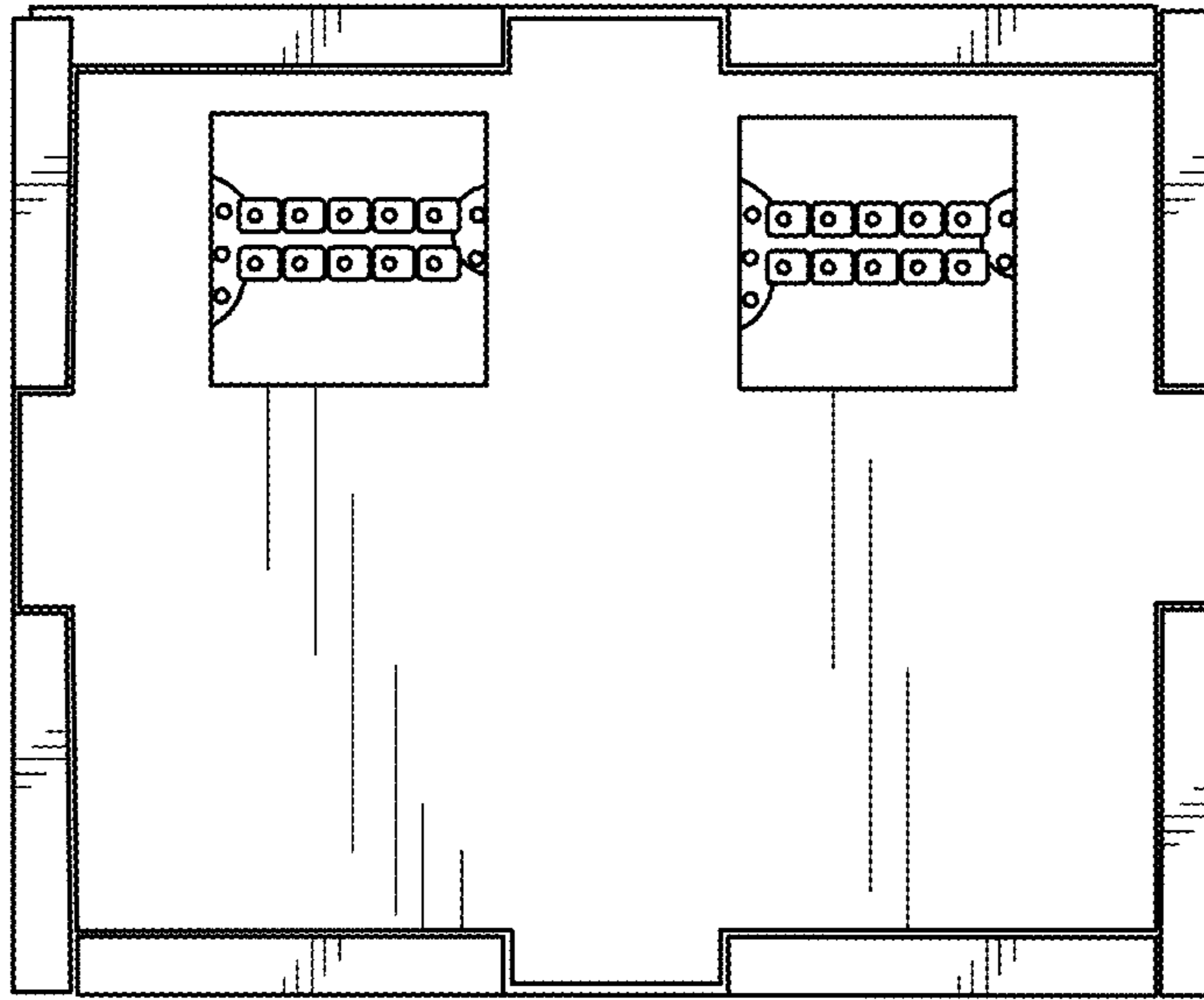

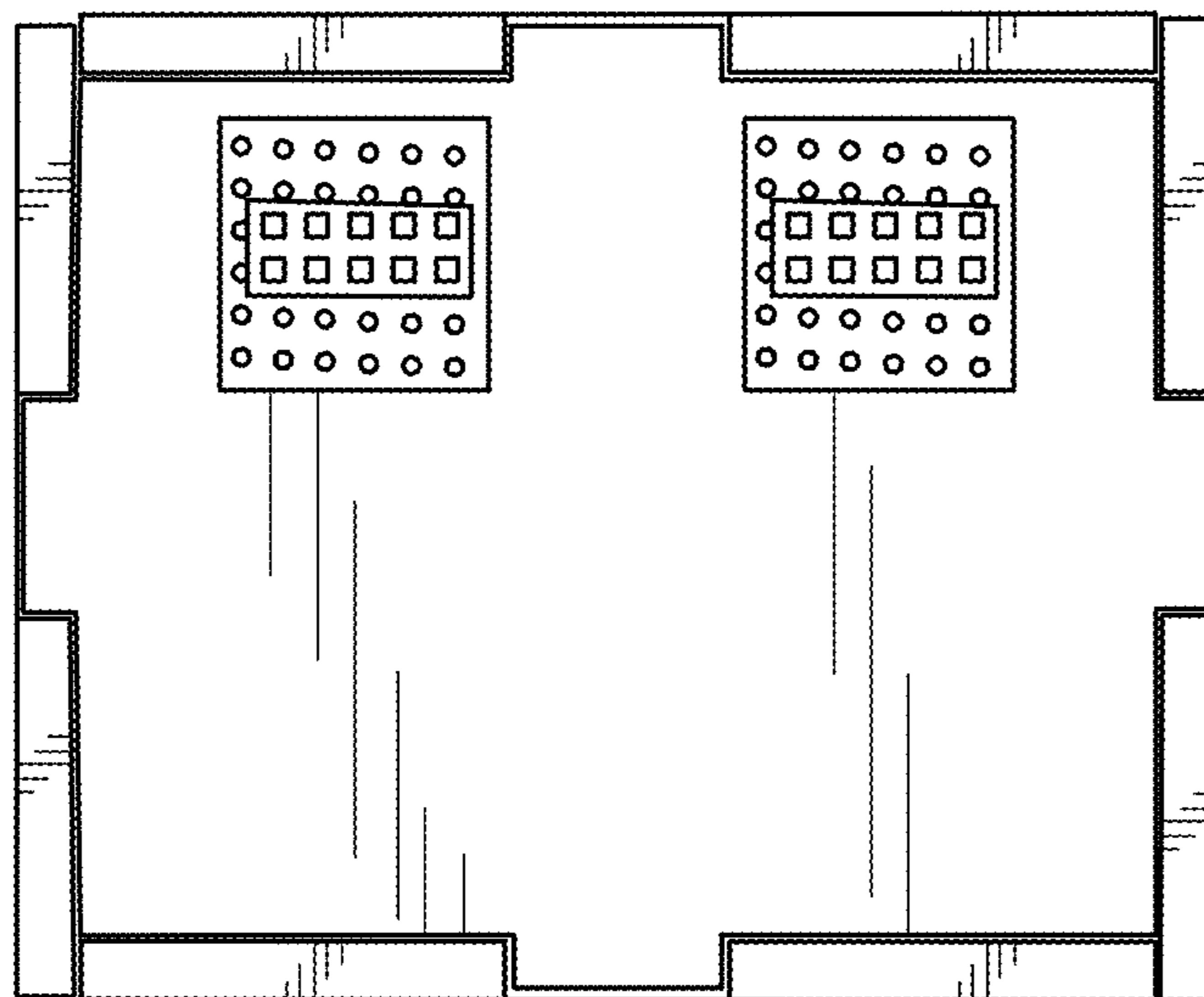

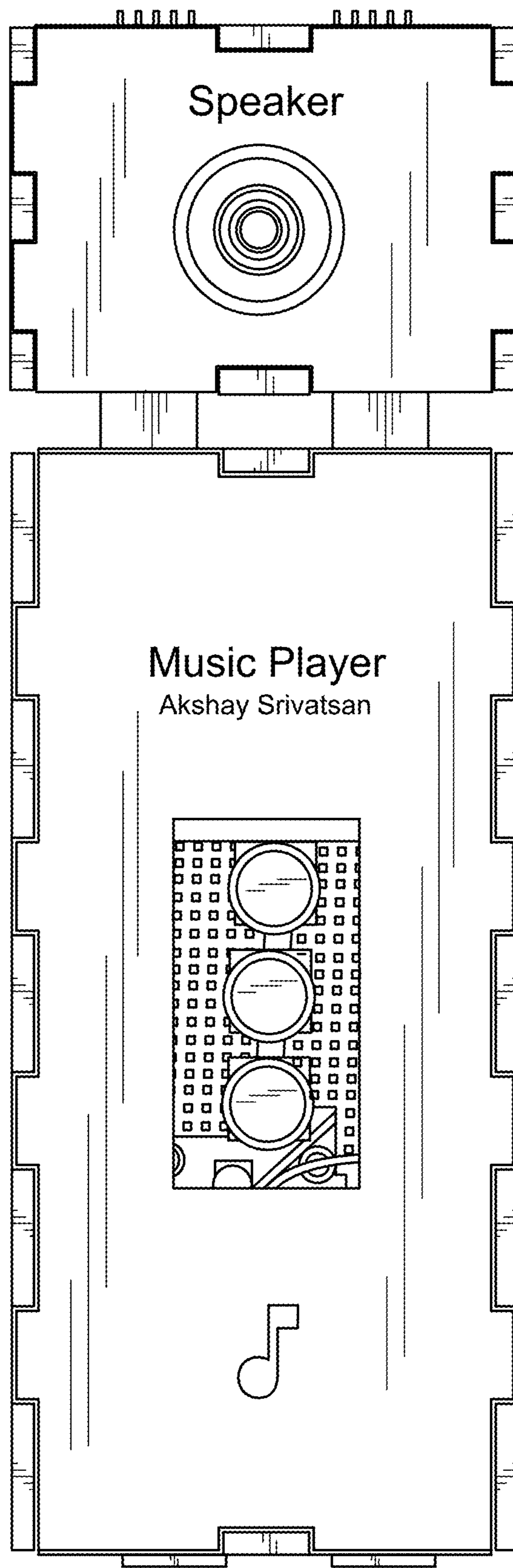

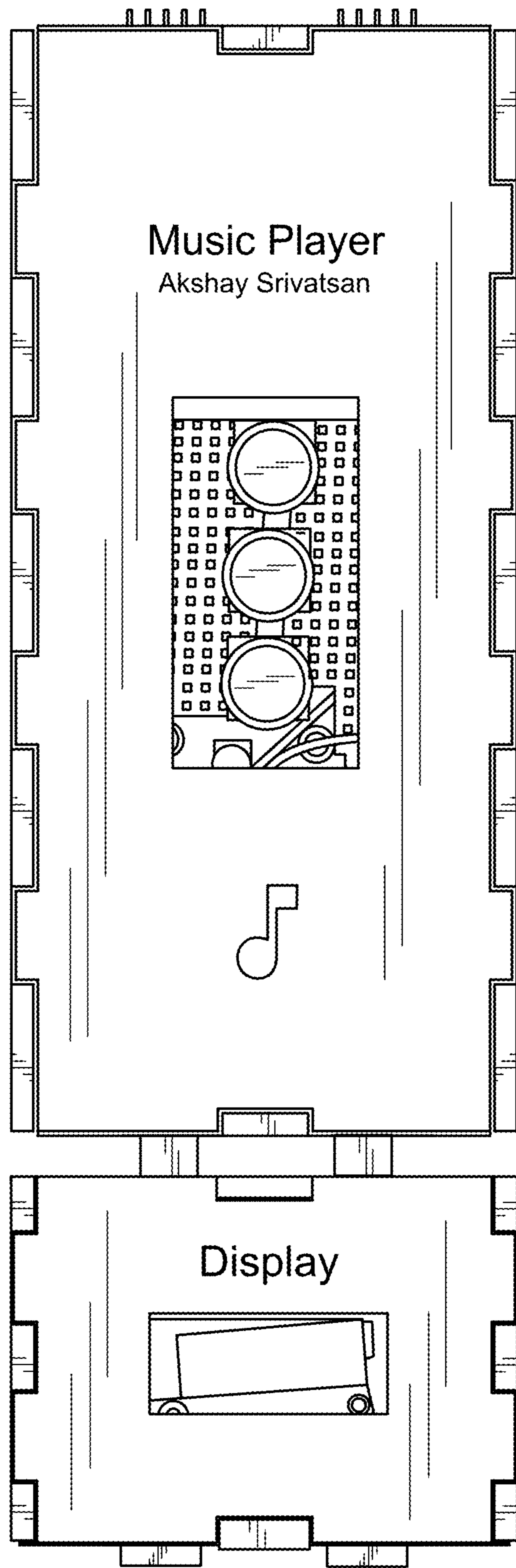

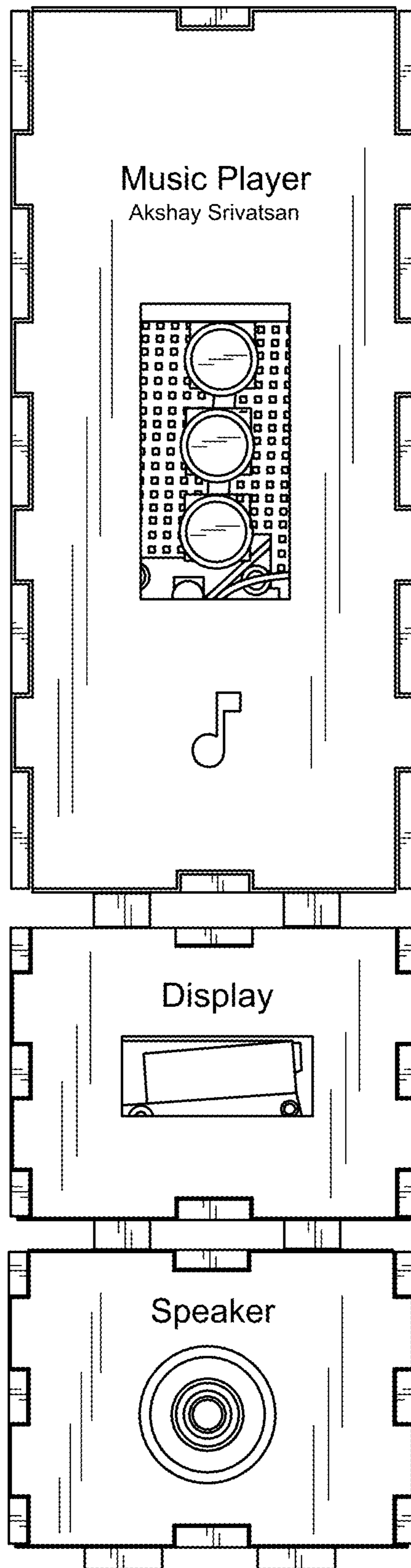
