(57) **CLAIM**

The ornamental design for a medication injection device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a medication injection device showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is bottom view thereof;

FIG. 5 is a side view thereof;

FIG. 6 is an opposite side view thereof; and,

FIG. 7 is a rear view thereof.

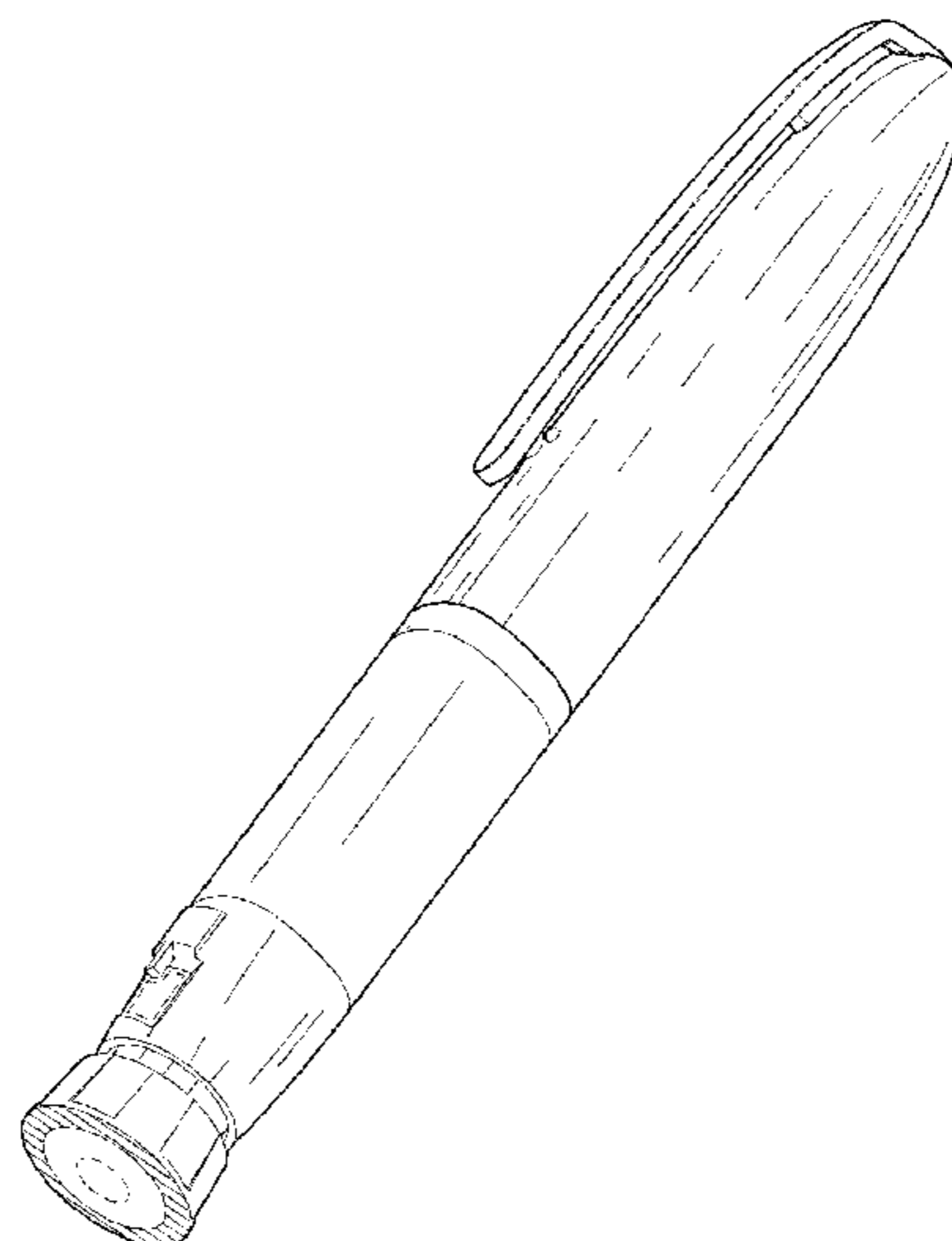
The cross-hatched annular region of the button in FIGS. 1 and 4 represents a contrasting color region visible on the button that forms part of the claimed design. The dash lines in FIGS. 1, 2 and 4 show a bottom portion and surround a front portion of the device which form no part of the claimed design.

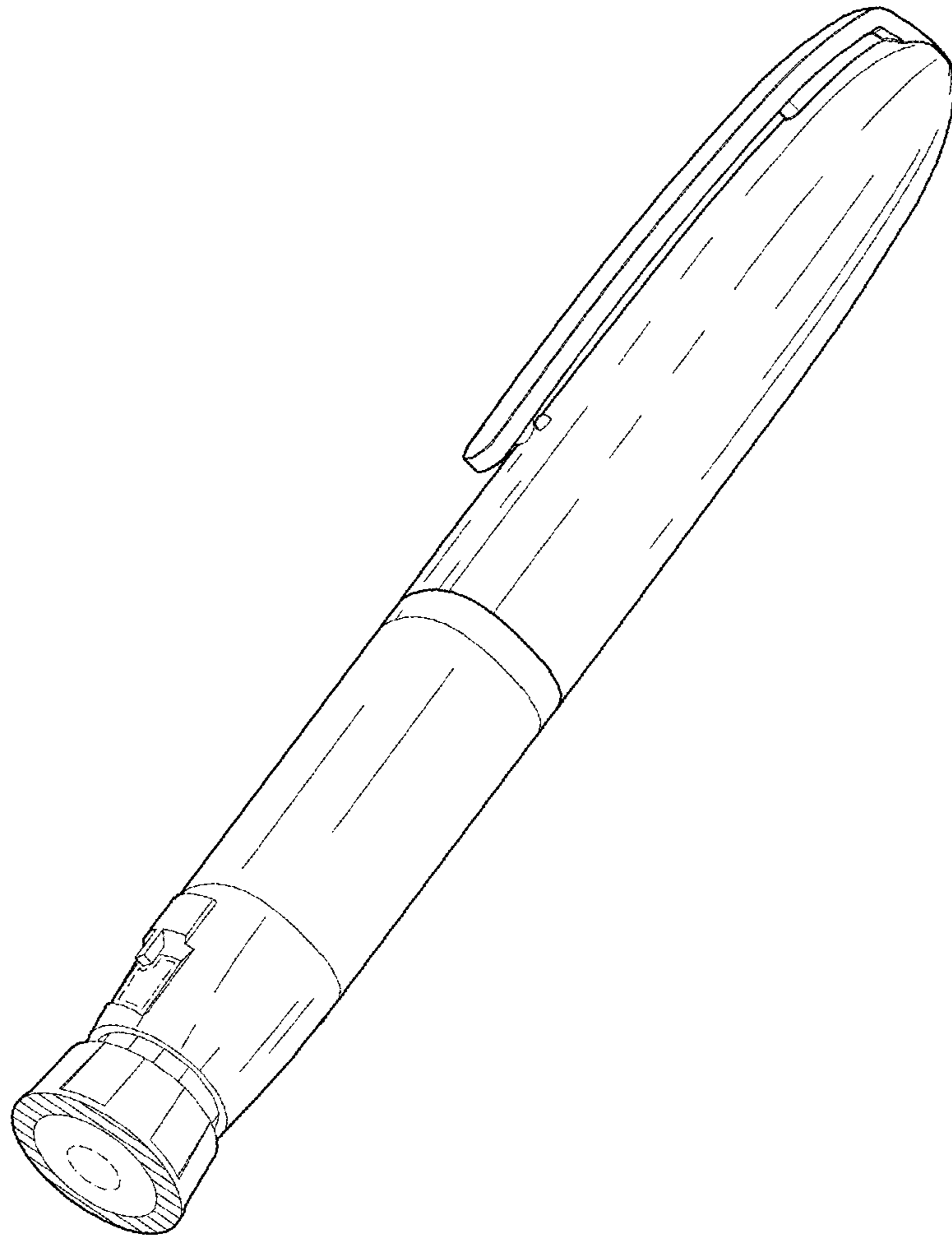

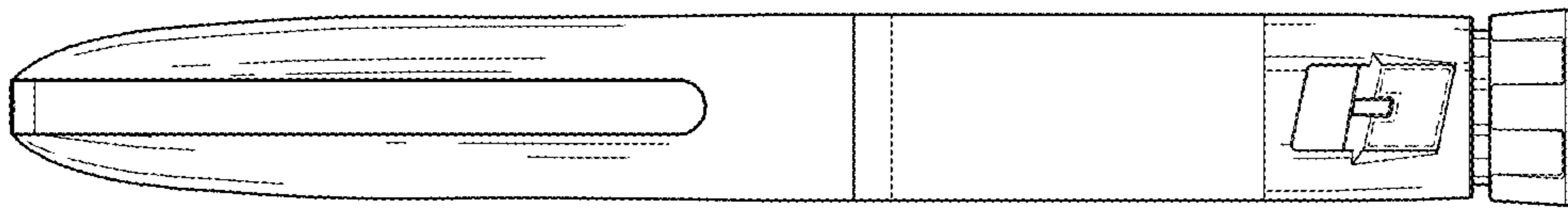

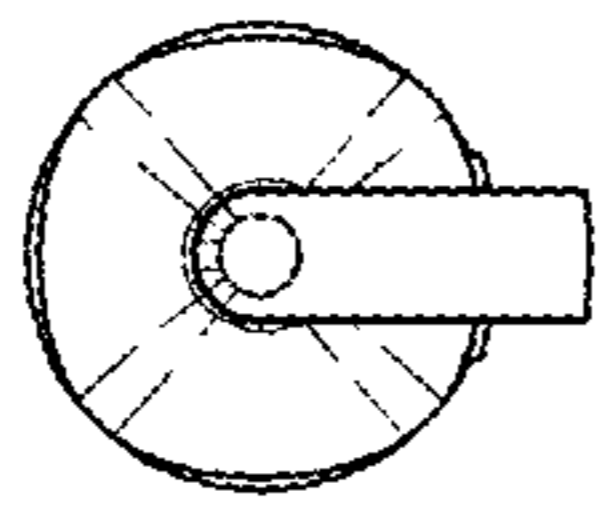

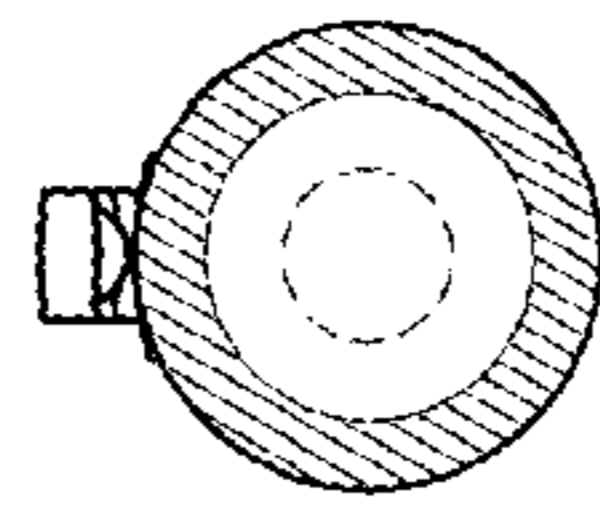

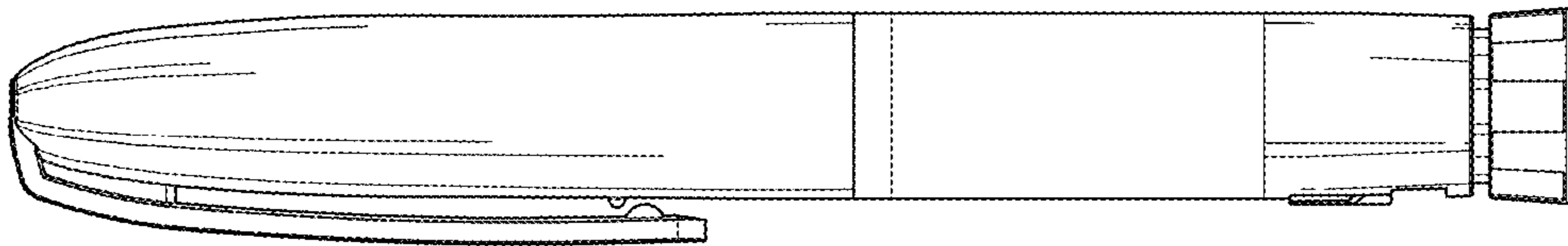

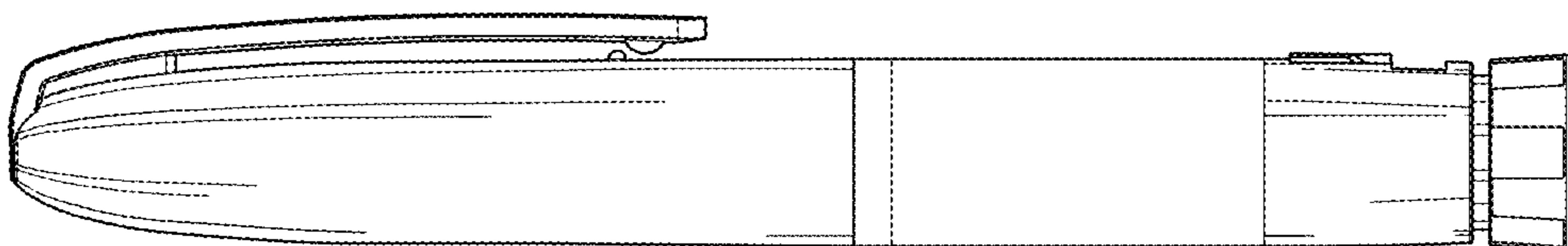

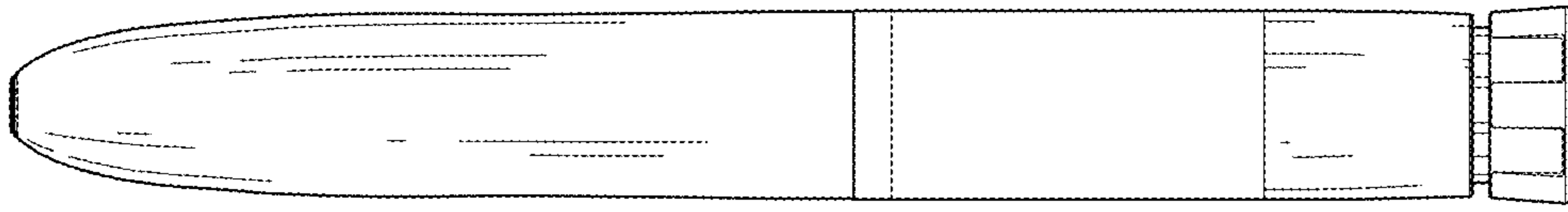
