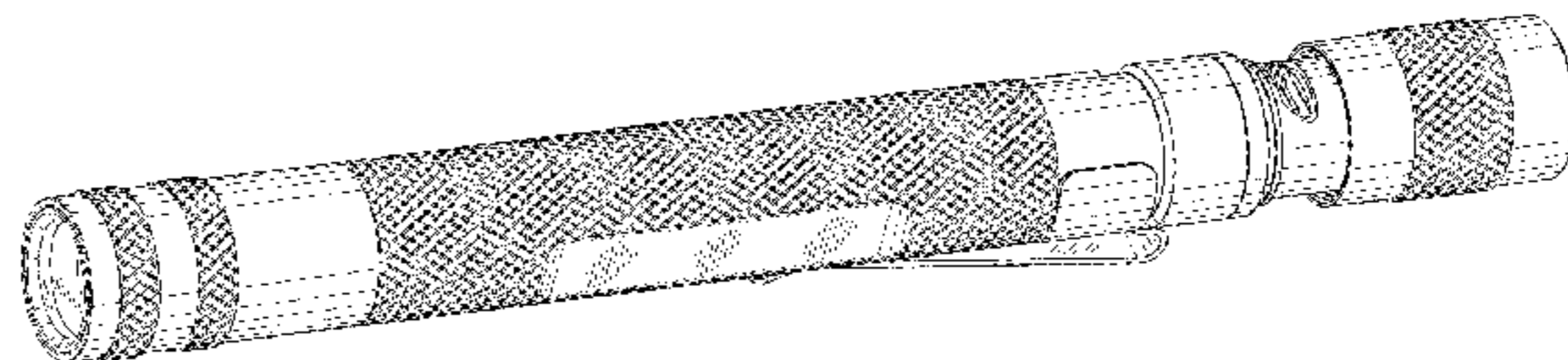
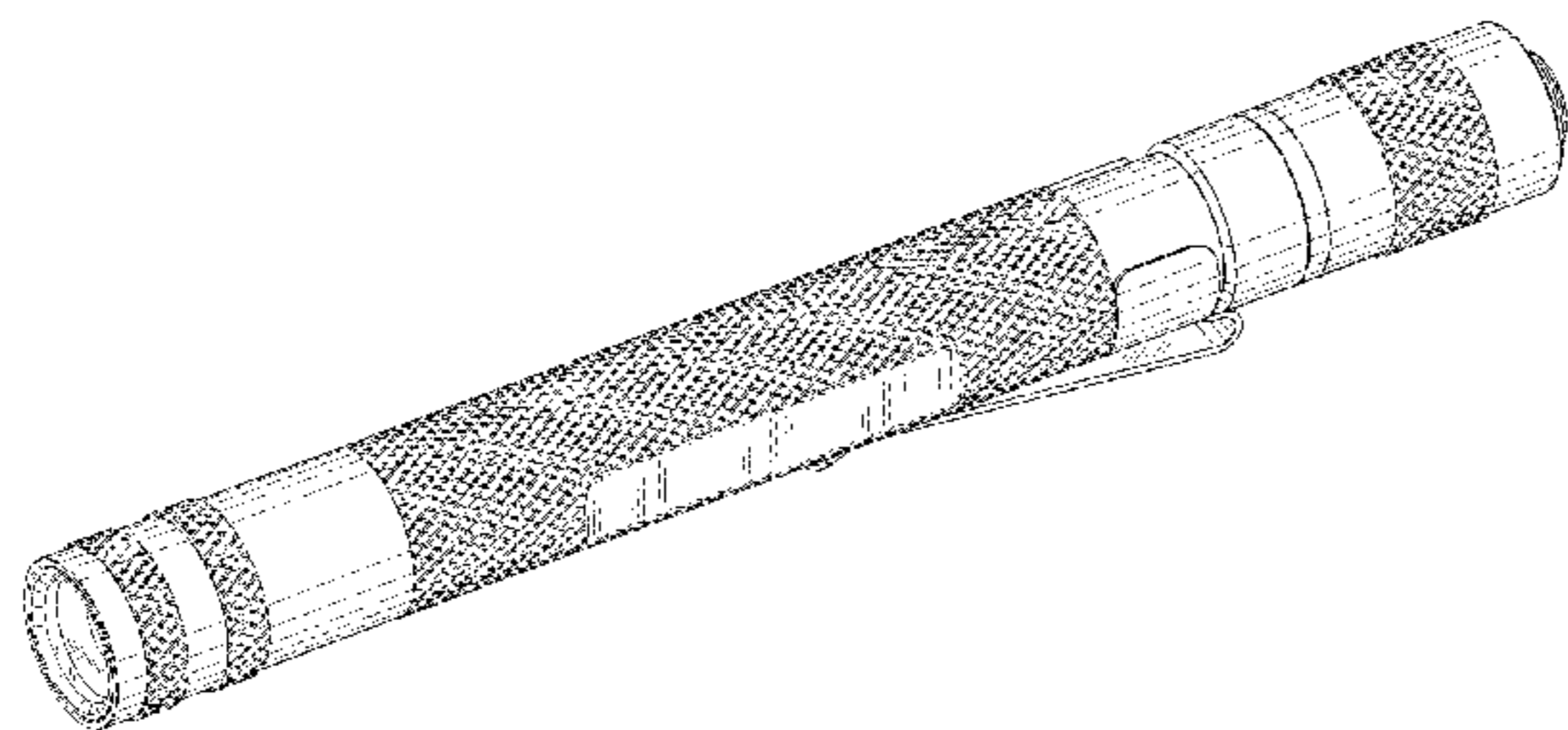
(57) **CLAIM**

We claim the ornamental design for a pen light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pen light;
FIG. 2 is a bottom end view of the pen light as illustrated in FIG. 1;
FIG. 3 is a top end view of the pen light as illustrated in FIG. 1;
FIG. 4 is a left side view of the pen light as illustrated in FIG. 1;
FIG. 5 is a front side view of the pen light as illustrated in FIG. 1;
FIG. 6 is a right side view of the pen light as illustrated in FIG. 1;
FIG. 7 is a back side view of the pen light as illustrated in FIG. 1;
FIG. 8 is a perspective view of the pen light with the top pulled out;
FIG. 9 is a bottom end view of the pen light as illustrated in FIG. 8;
FIG. 10 is a top end view of the pen light as illustrated in FIG. 8;
FIG. 11 is a left side view of the pen light as illustrated in FIG. 8;
FIG. 12 is a another left side view of the pen light as illustrated in FIG. 8, with the movable sleeve partially cut-away to show the top end of the pen light;
FIG. 13 is a front side view of the pen light as illustrated in FIG. 8;
FIG. 14 is a right side view of the pen light as illustrated in FIG. 8; and,
FIG. 15 is a back side view of the pen light as illustrated in FIG. 8.

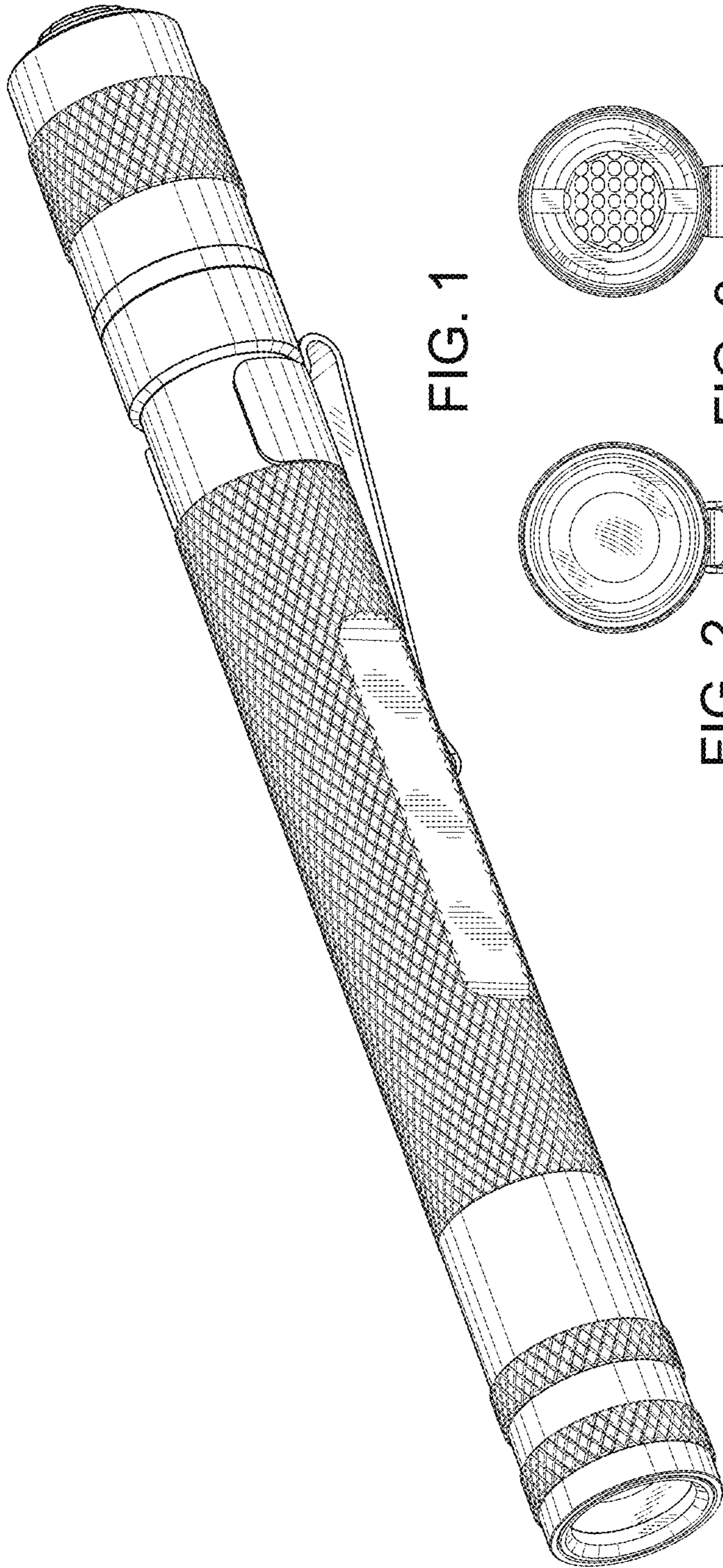

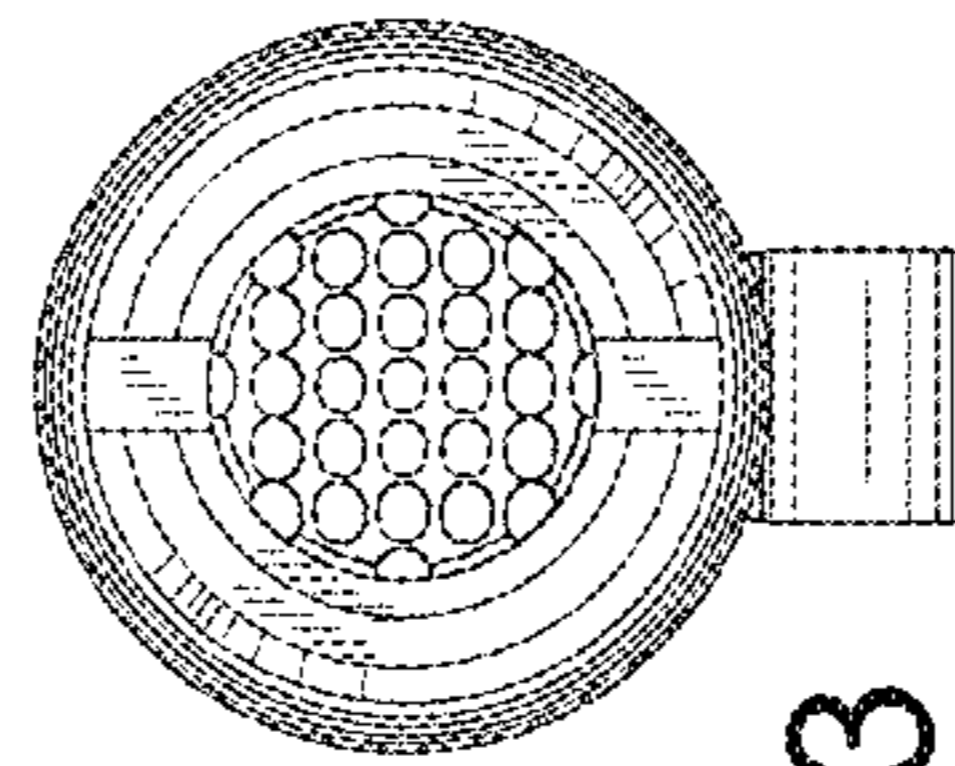

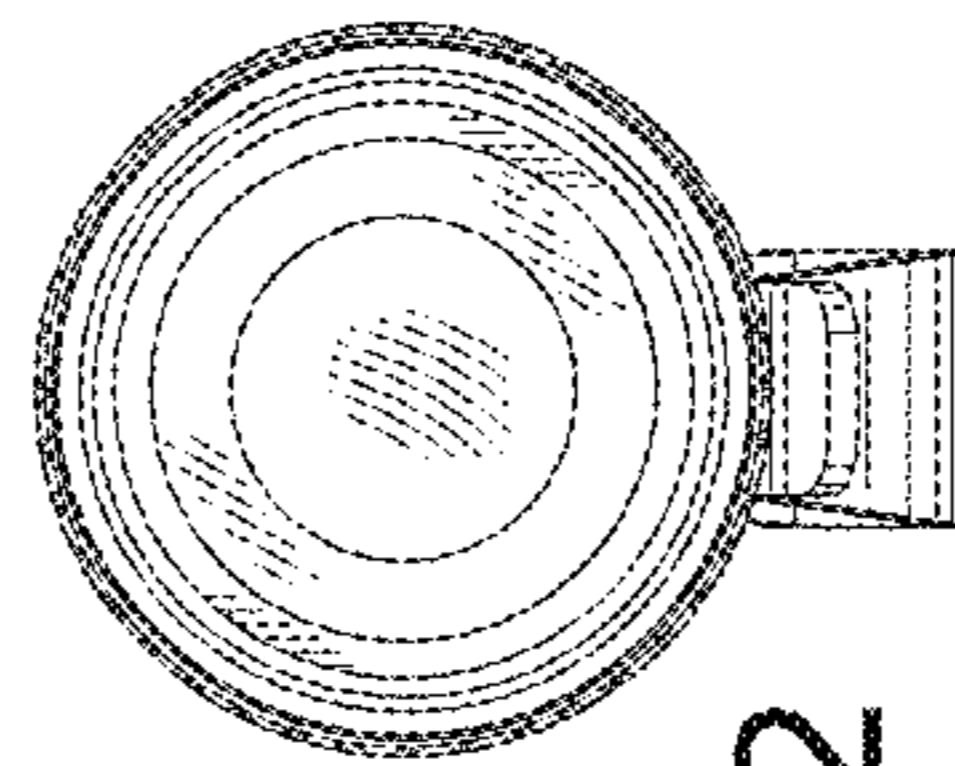

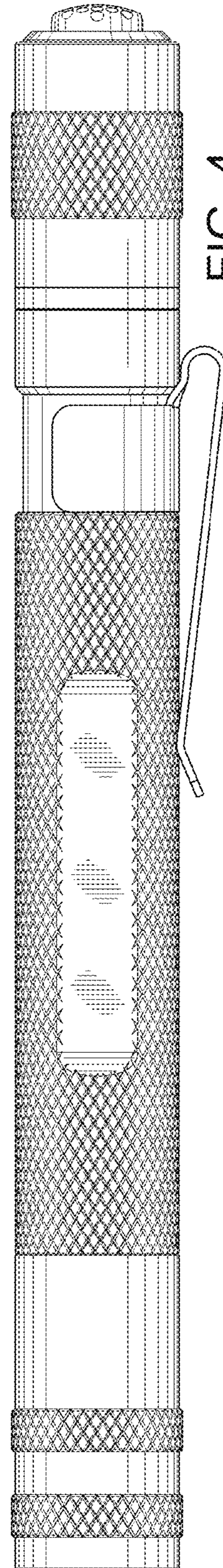

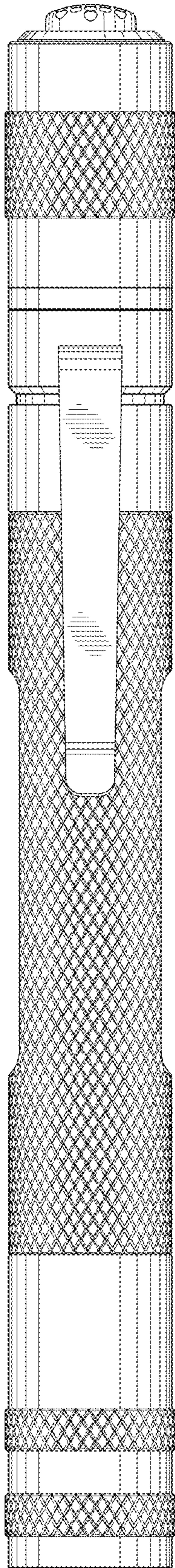

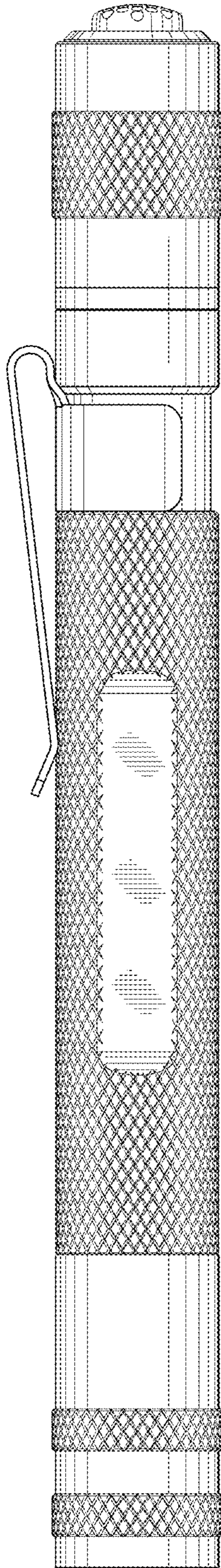

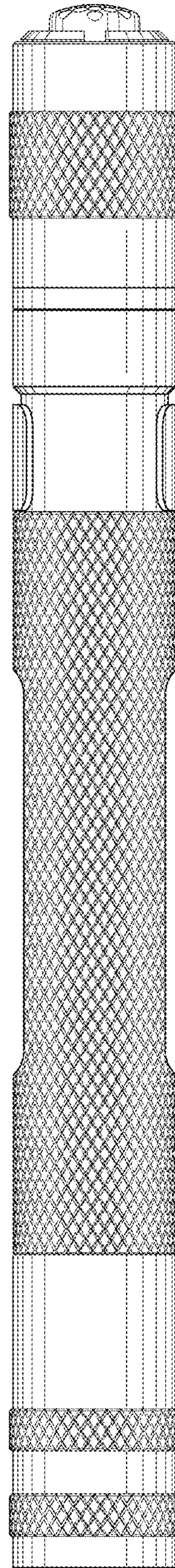

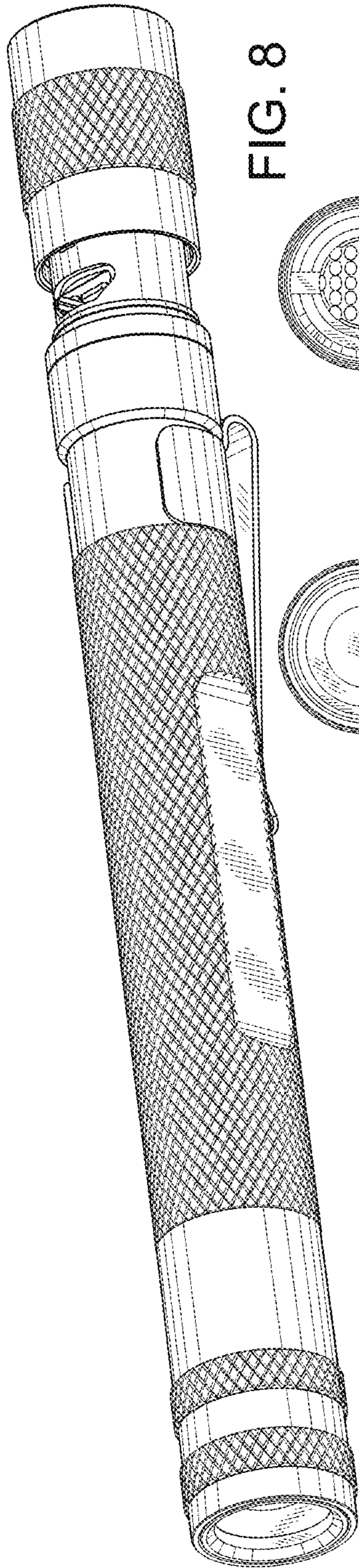

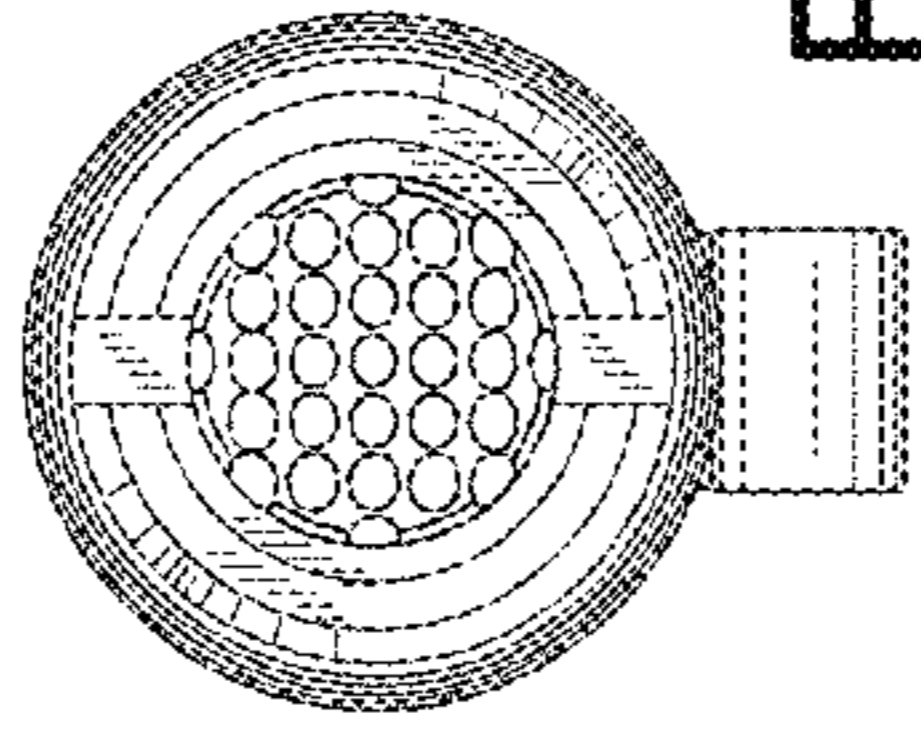

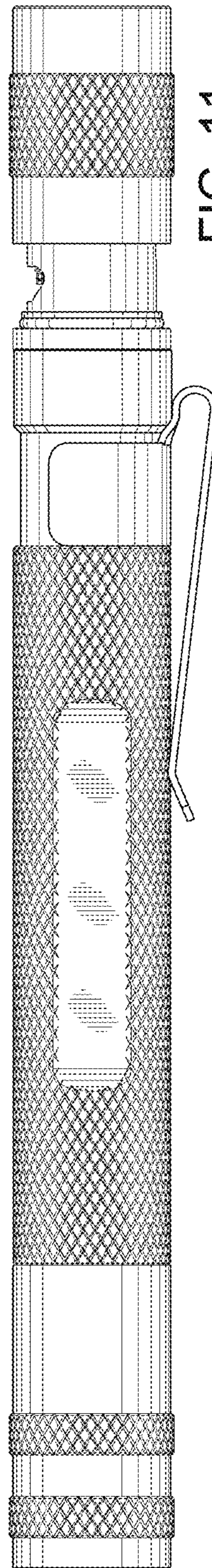

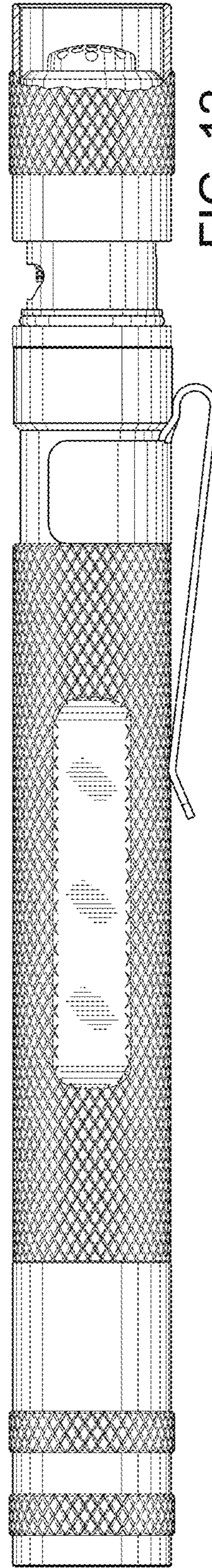

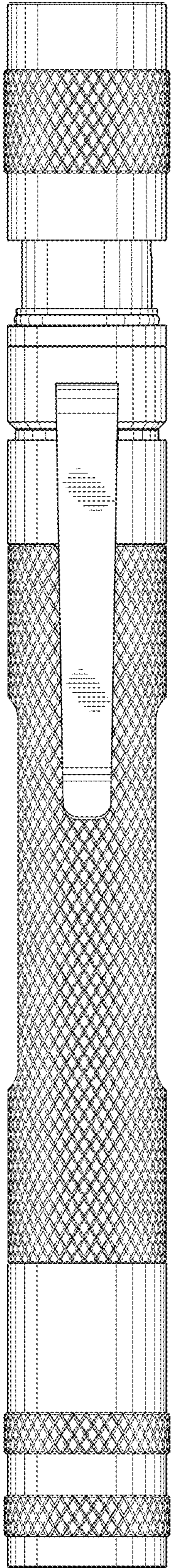

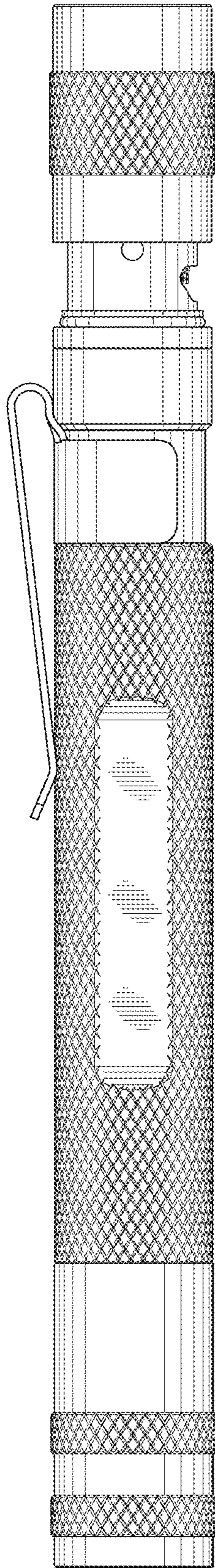

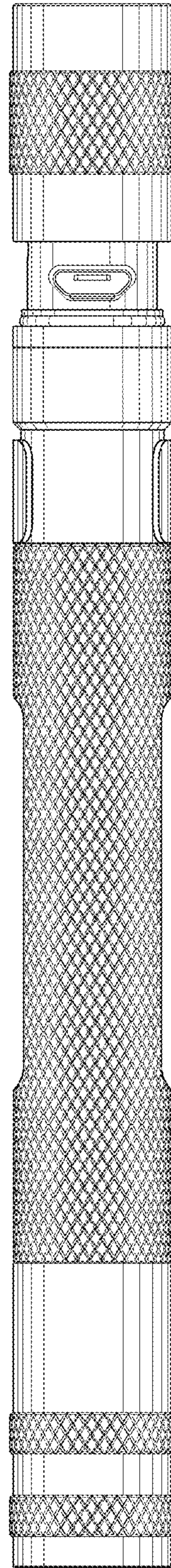
