We claim the ornamental design for a washing machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a washing machine showing our new design;

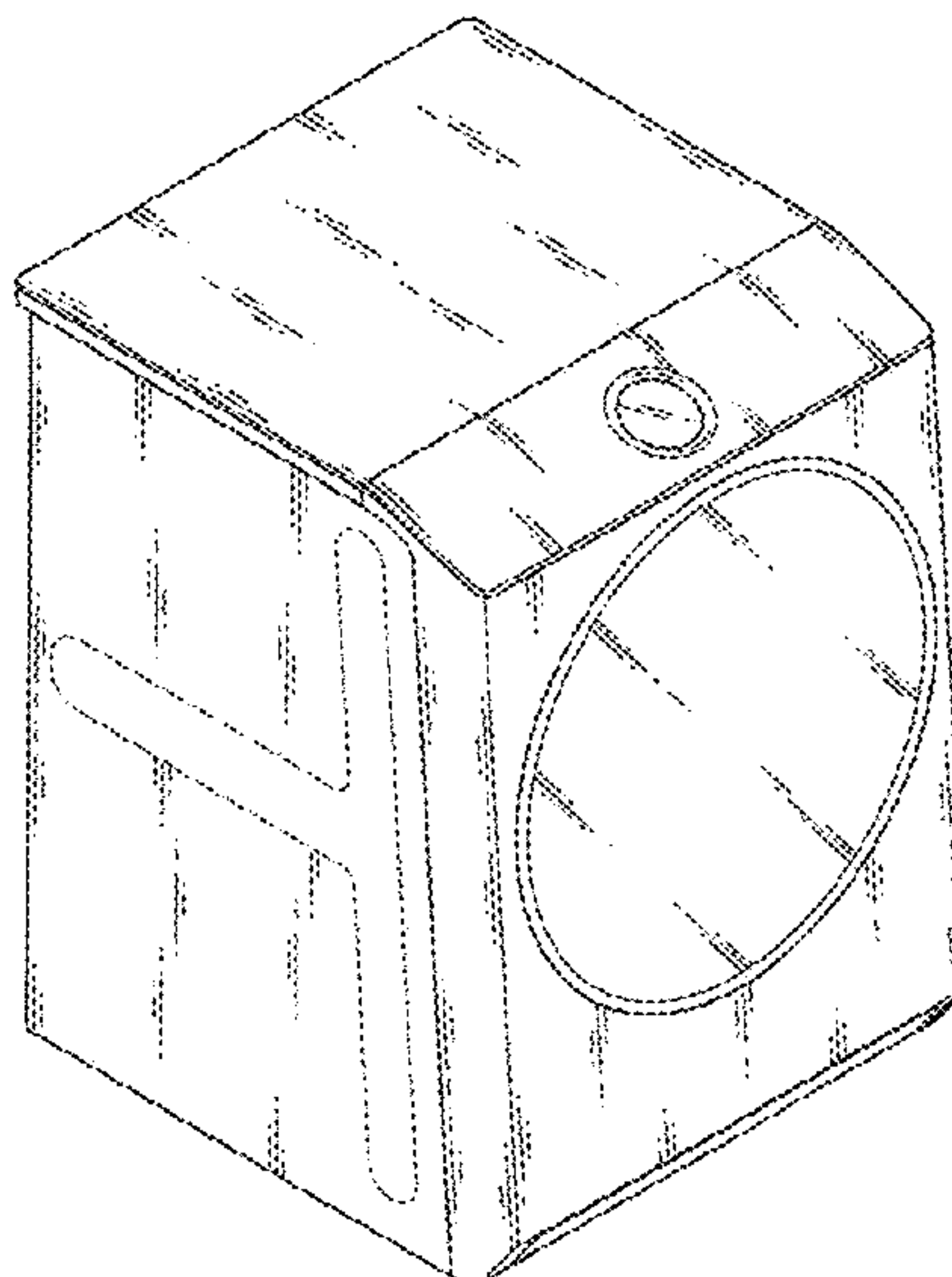

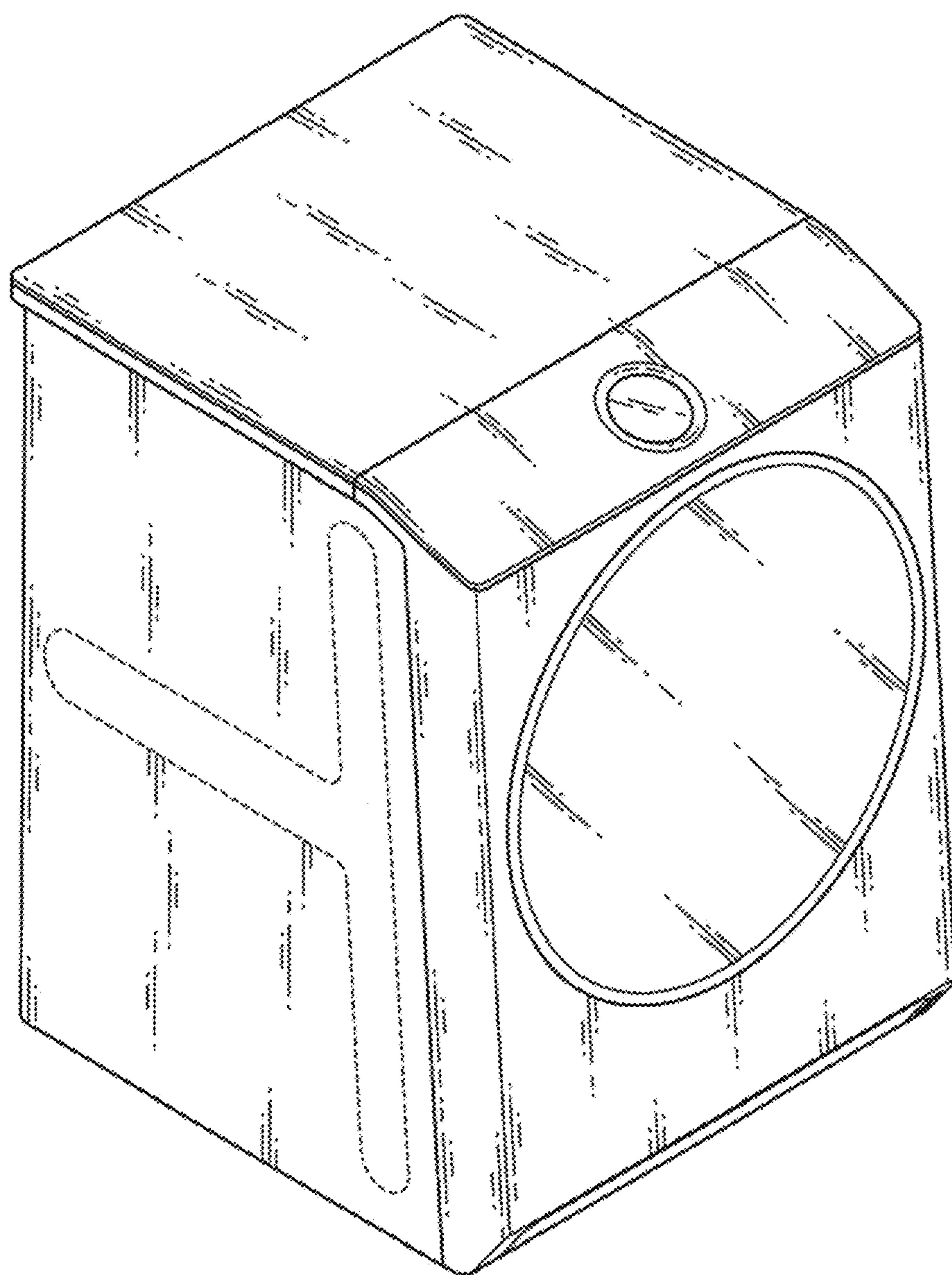

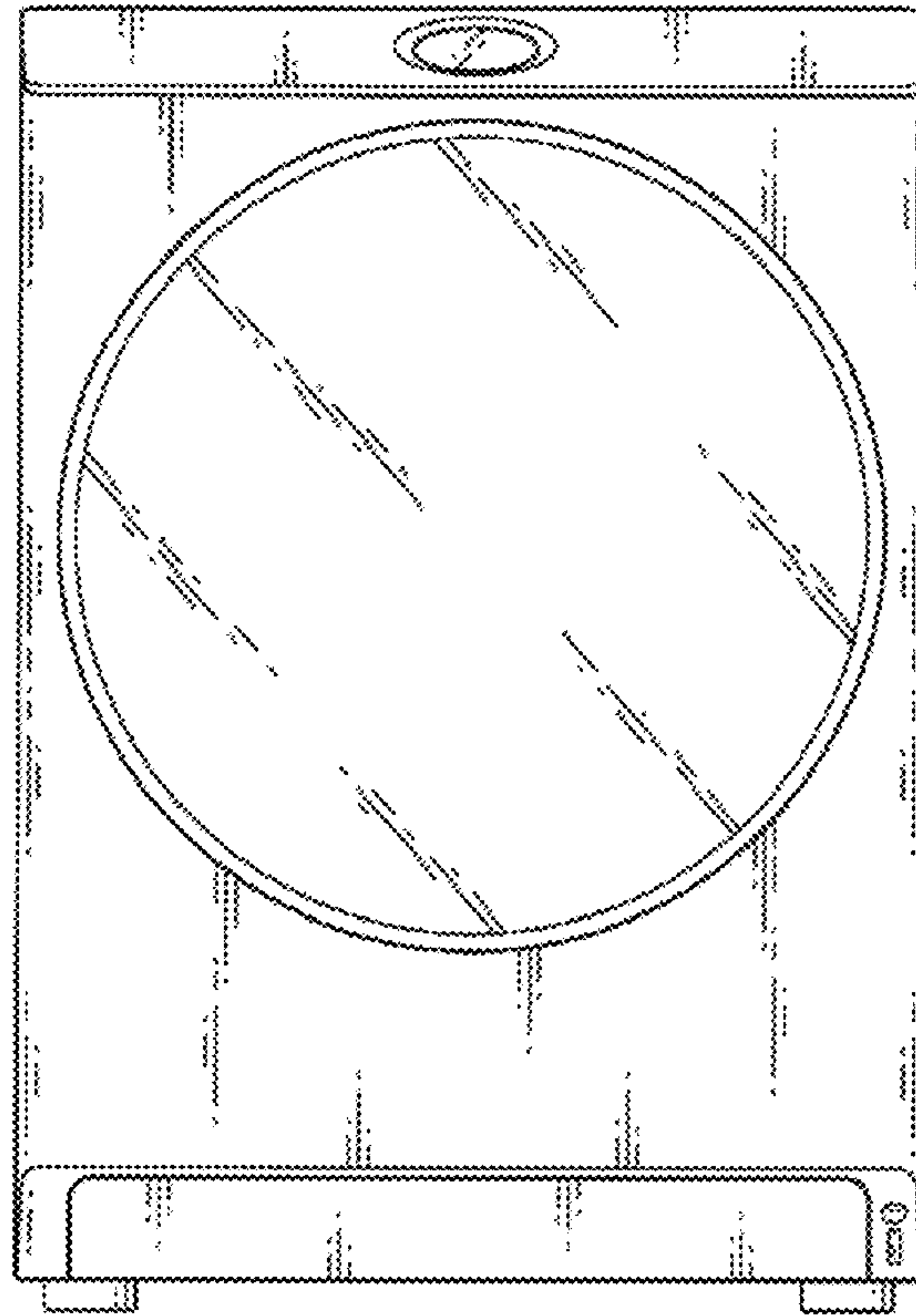

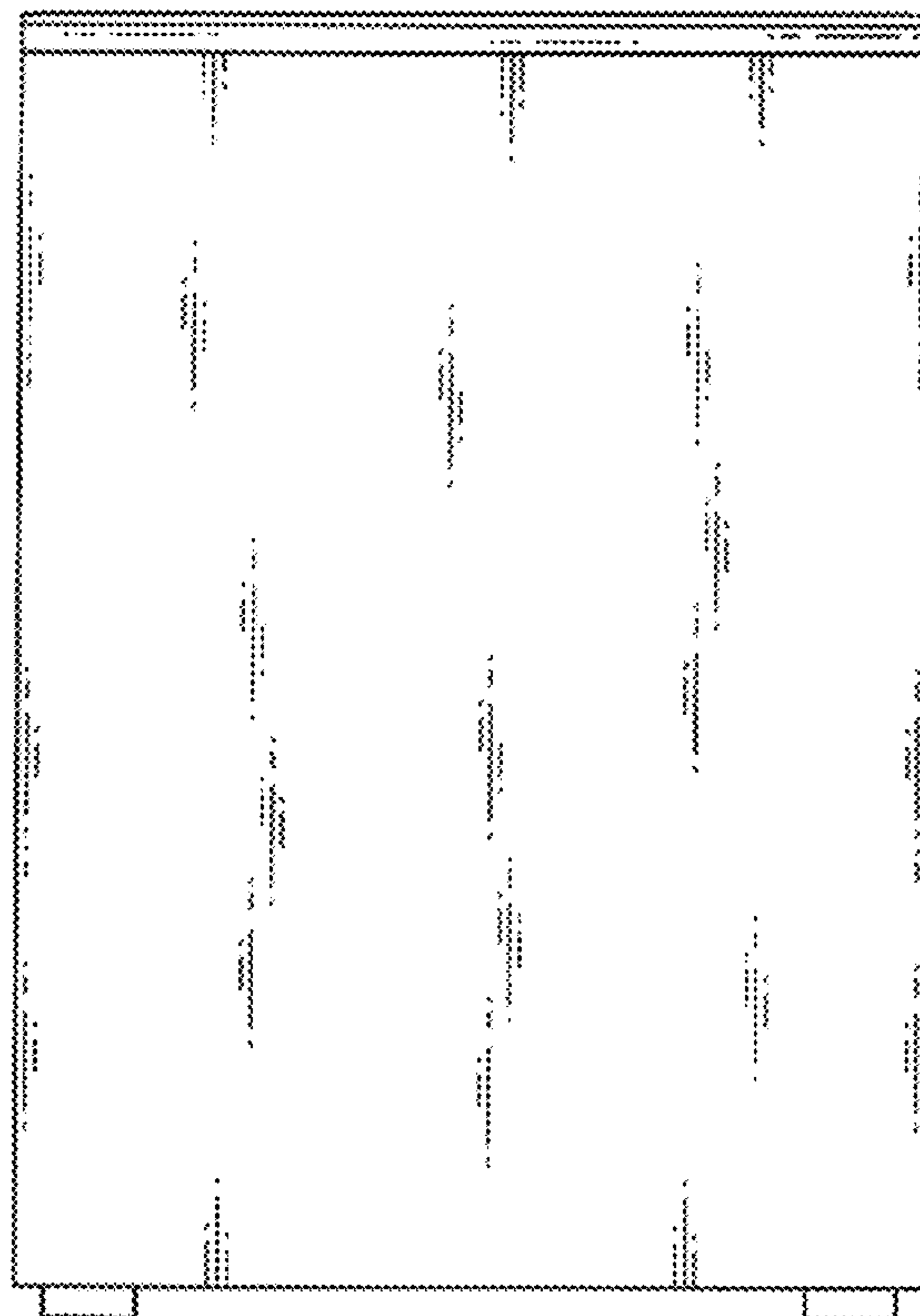

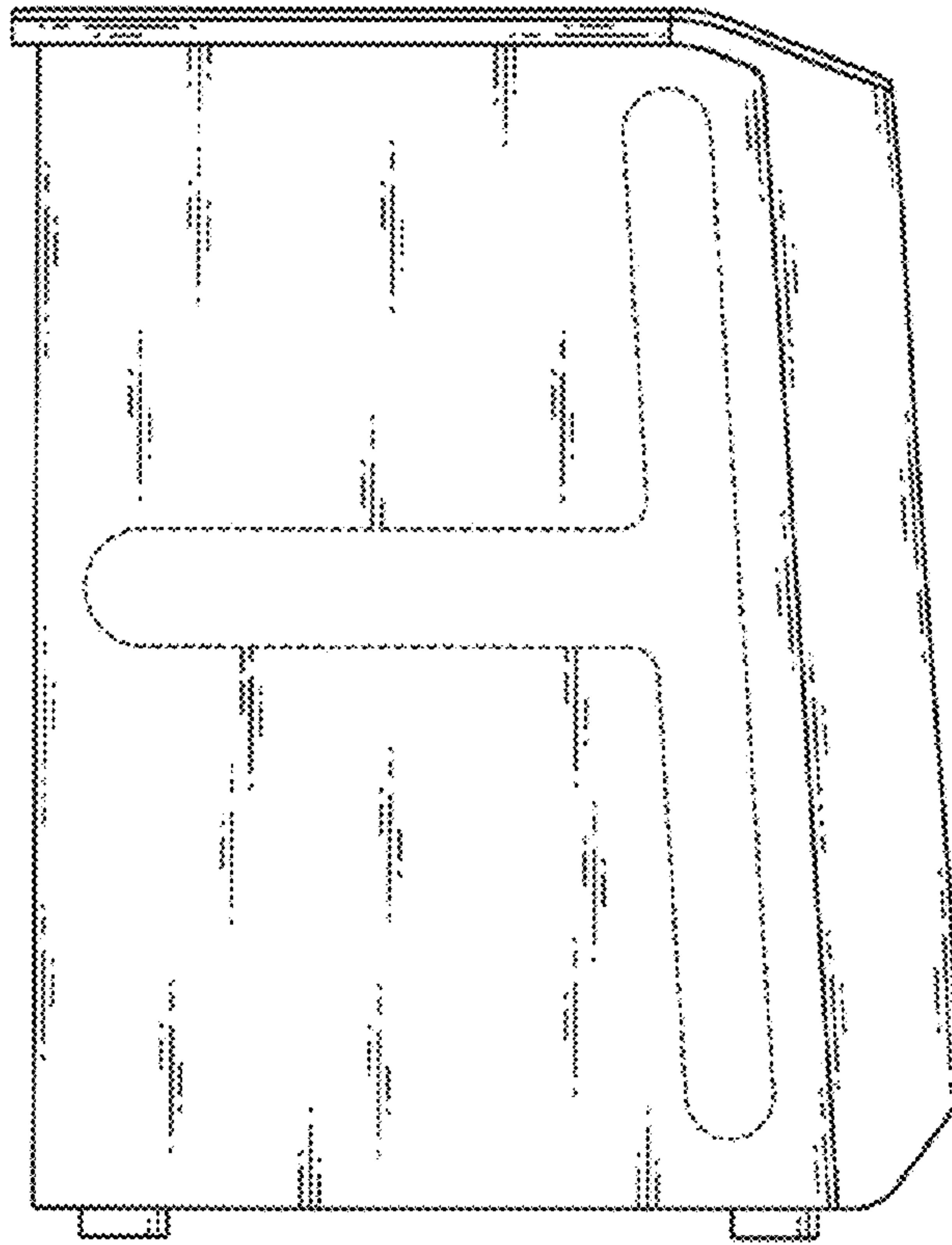

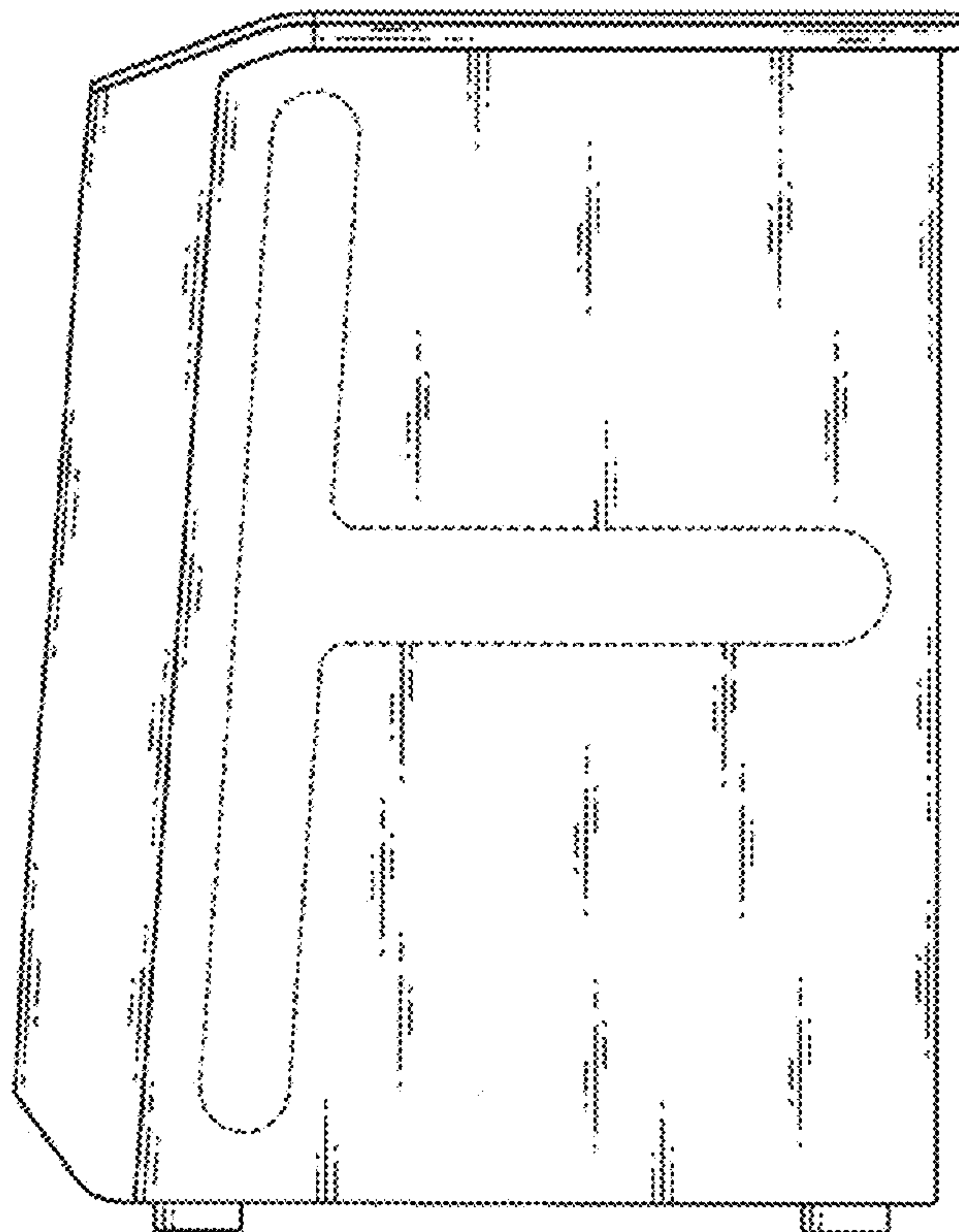

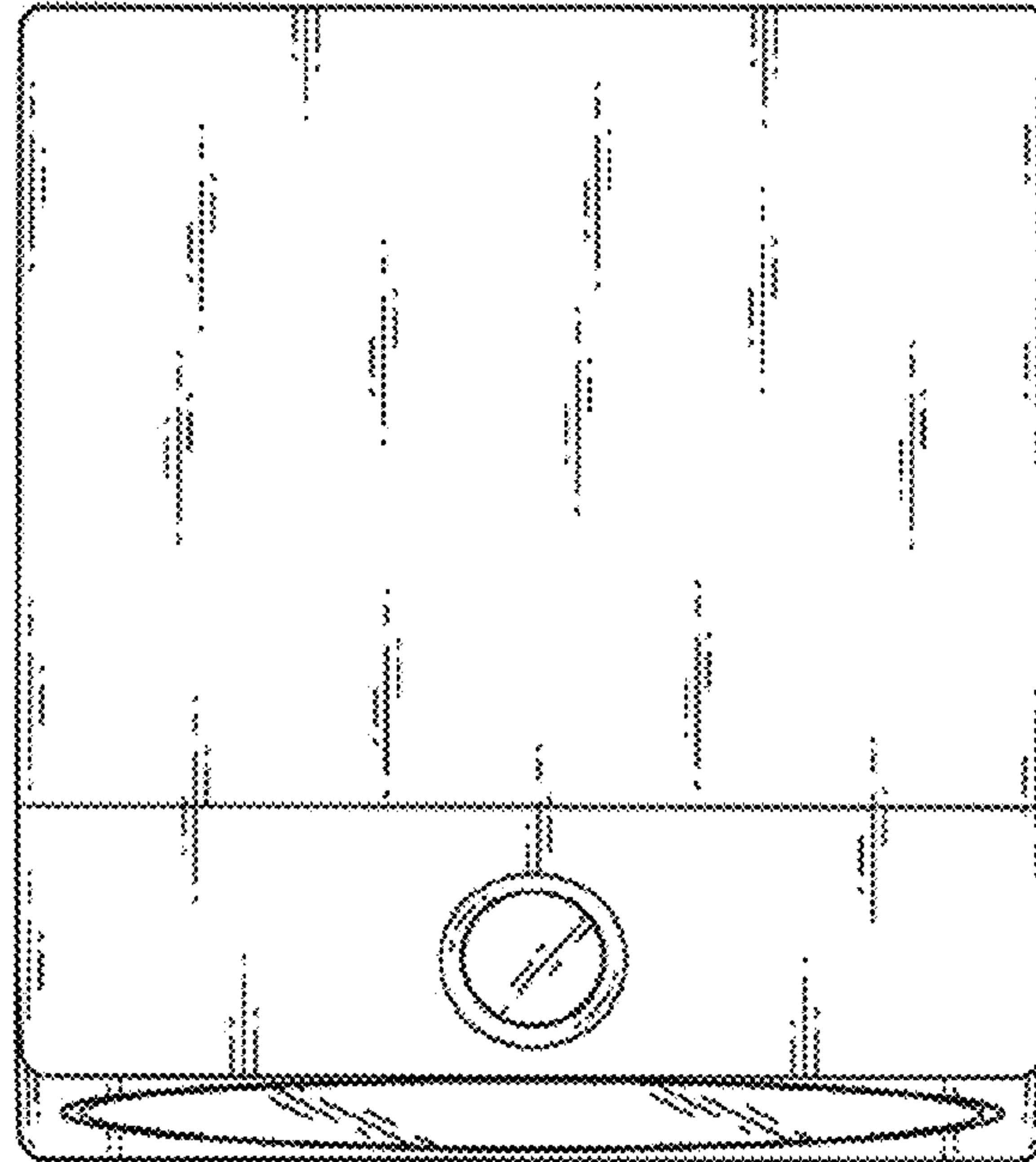
