**DESCRIPTION**

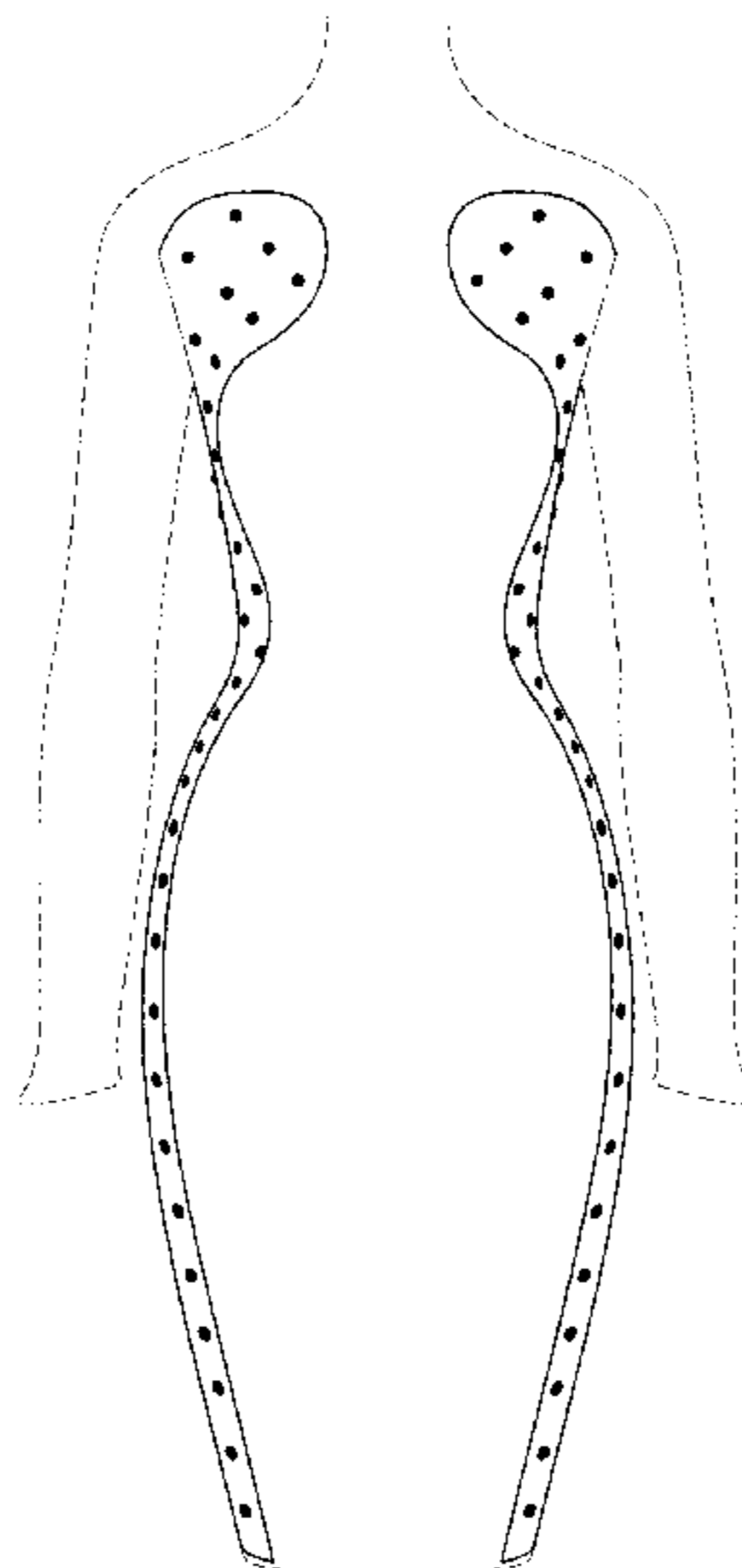
FIG. 1 is a front view of a dress showing my new design; and,

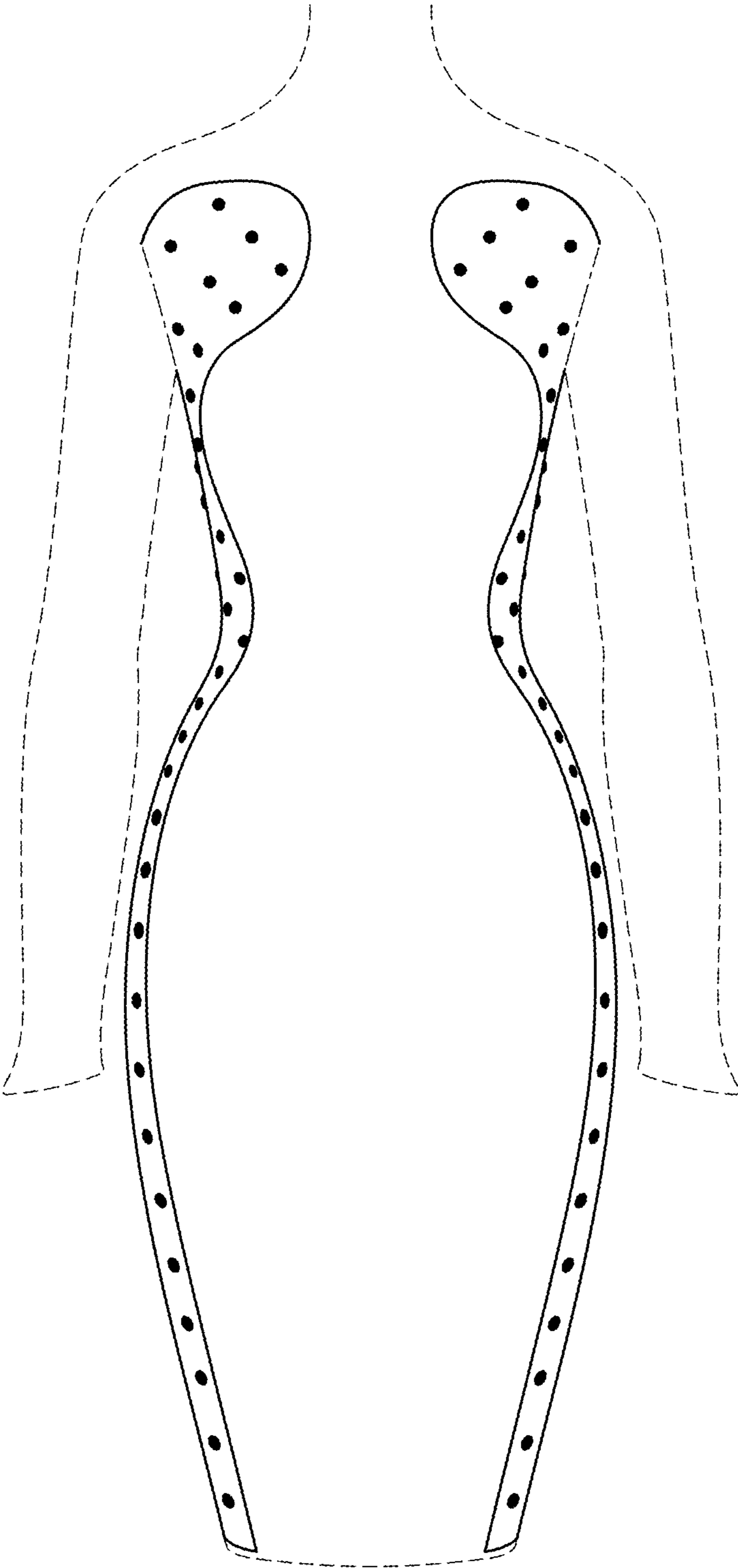

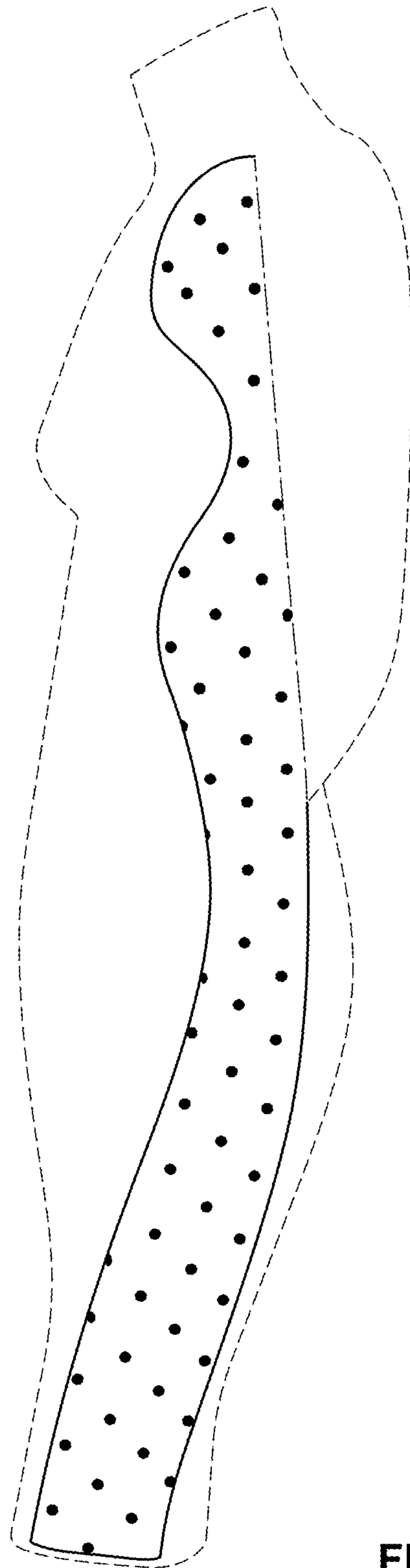
