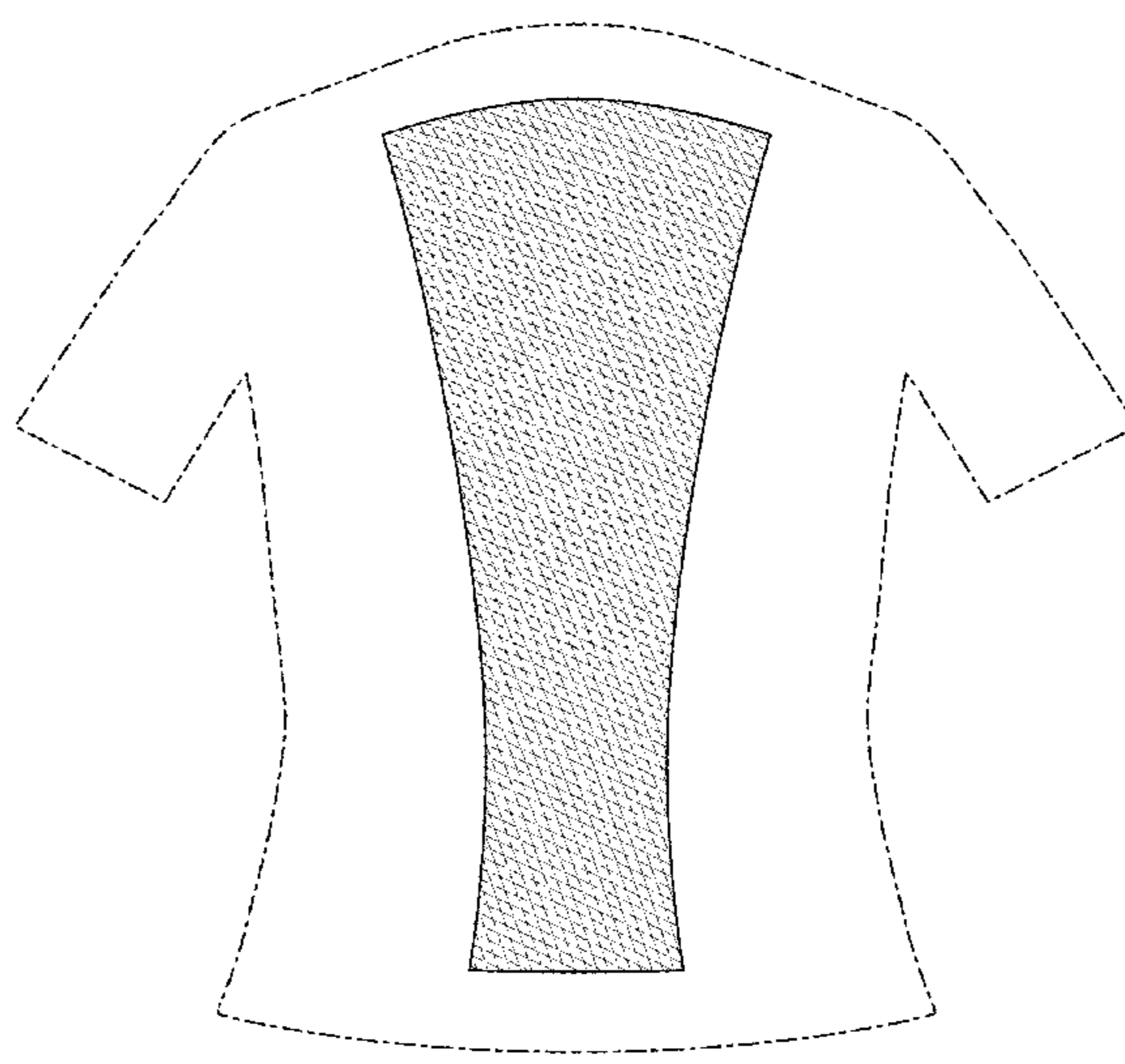
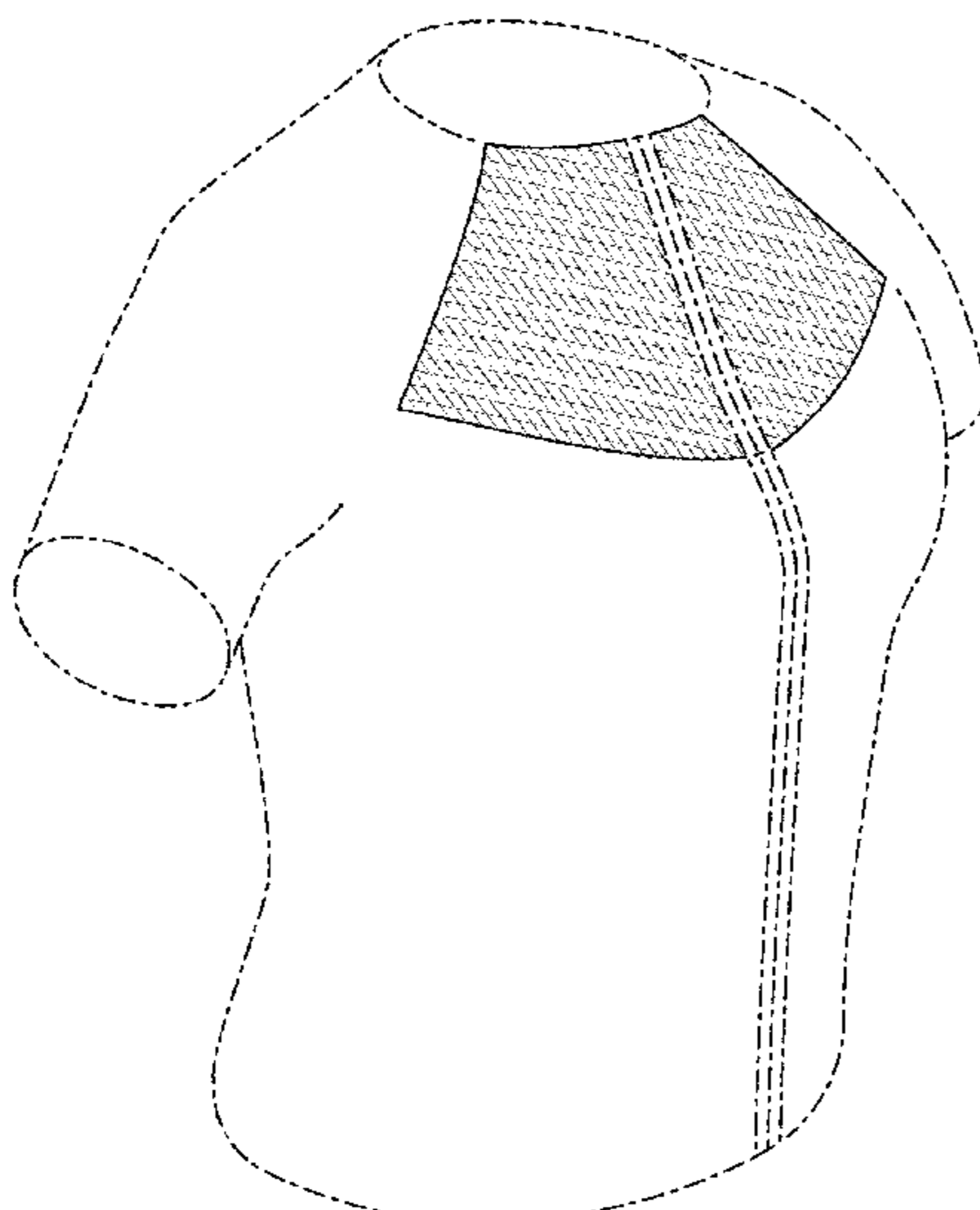
The ornamental design for an upper body garment, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of an upper body garment showing my new design in an in-use configuration; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

In the drawings, the hatched pattern represents the appearance of a diamond-shaped open mesh fabric. The unshaded regions, demarcated by broken lines, represent unclaimed portions of the garment and form no part of the claimed design.

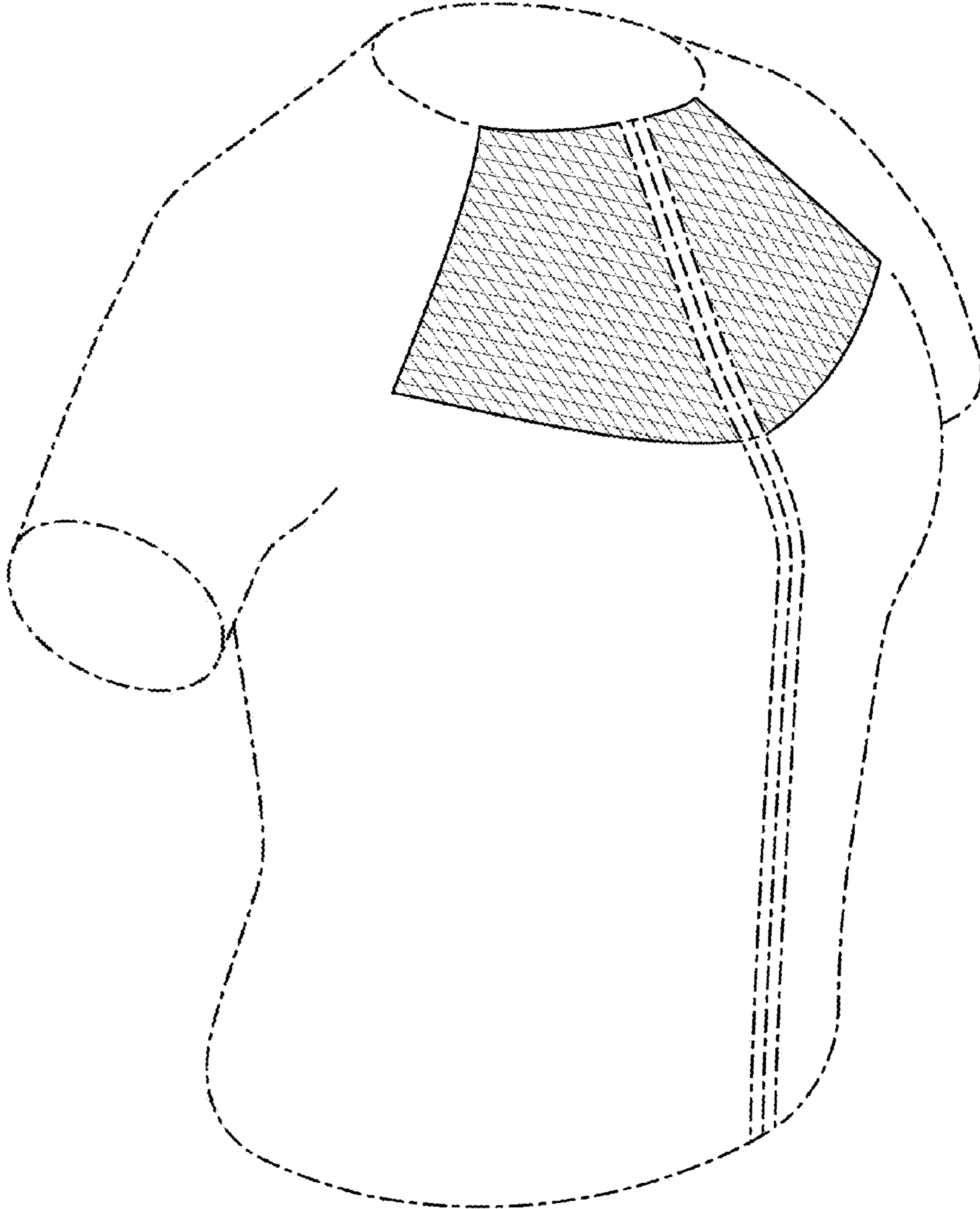

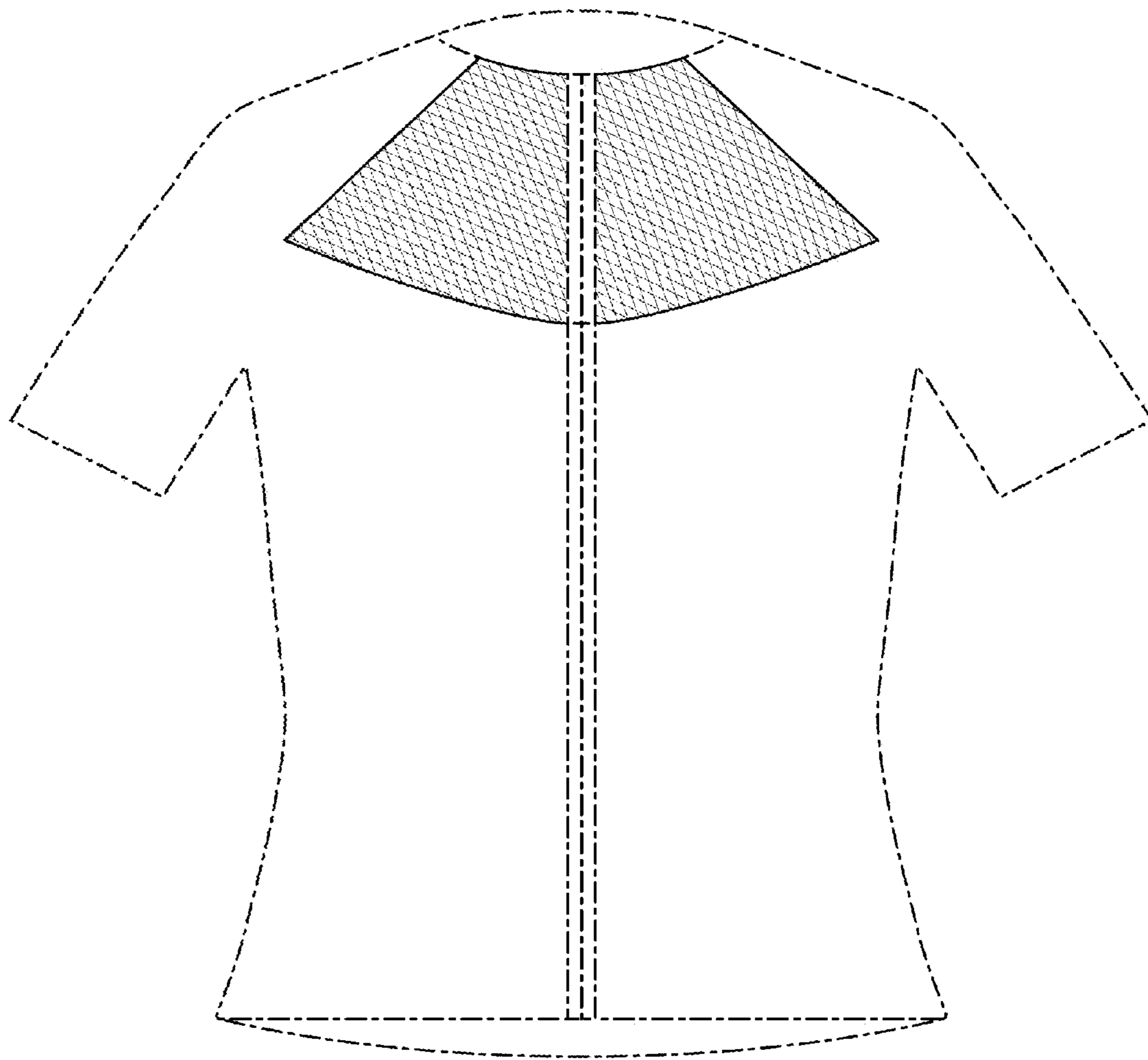

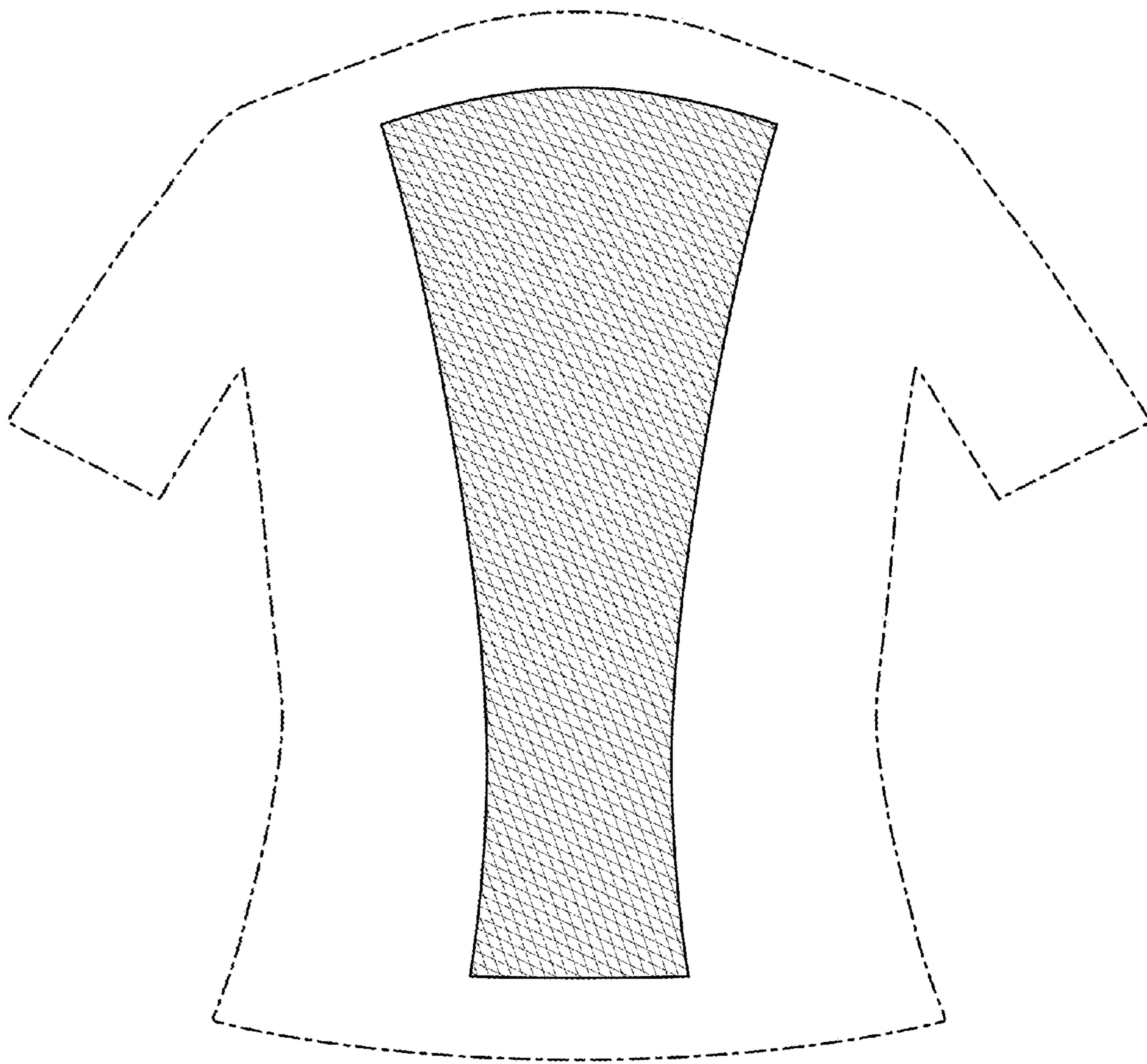

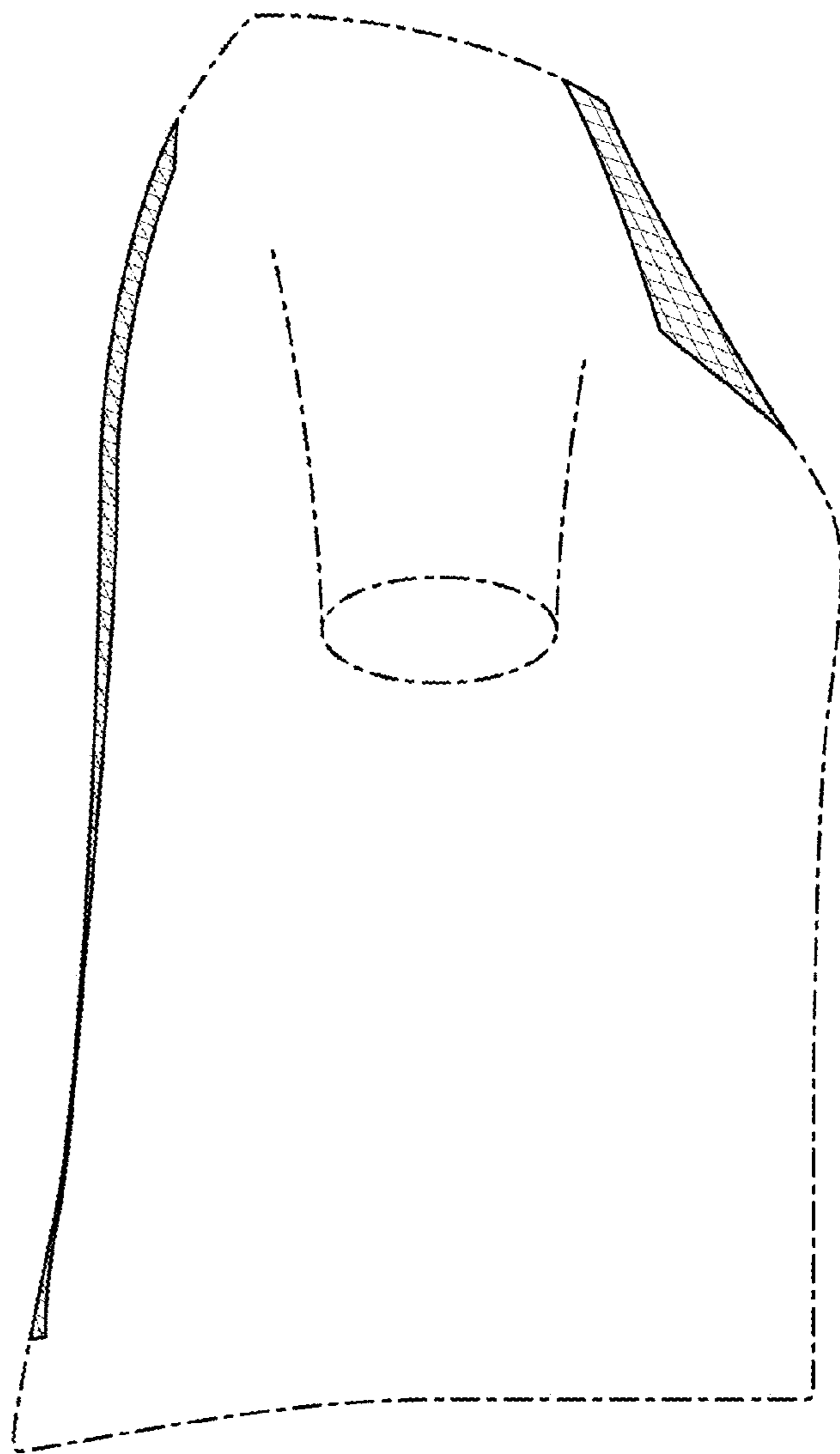

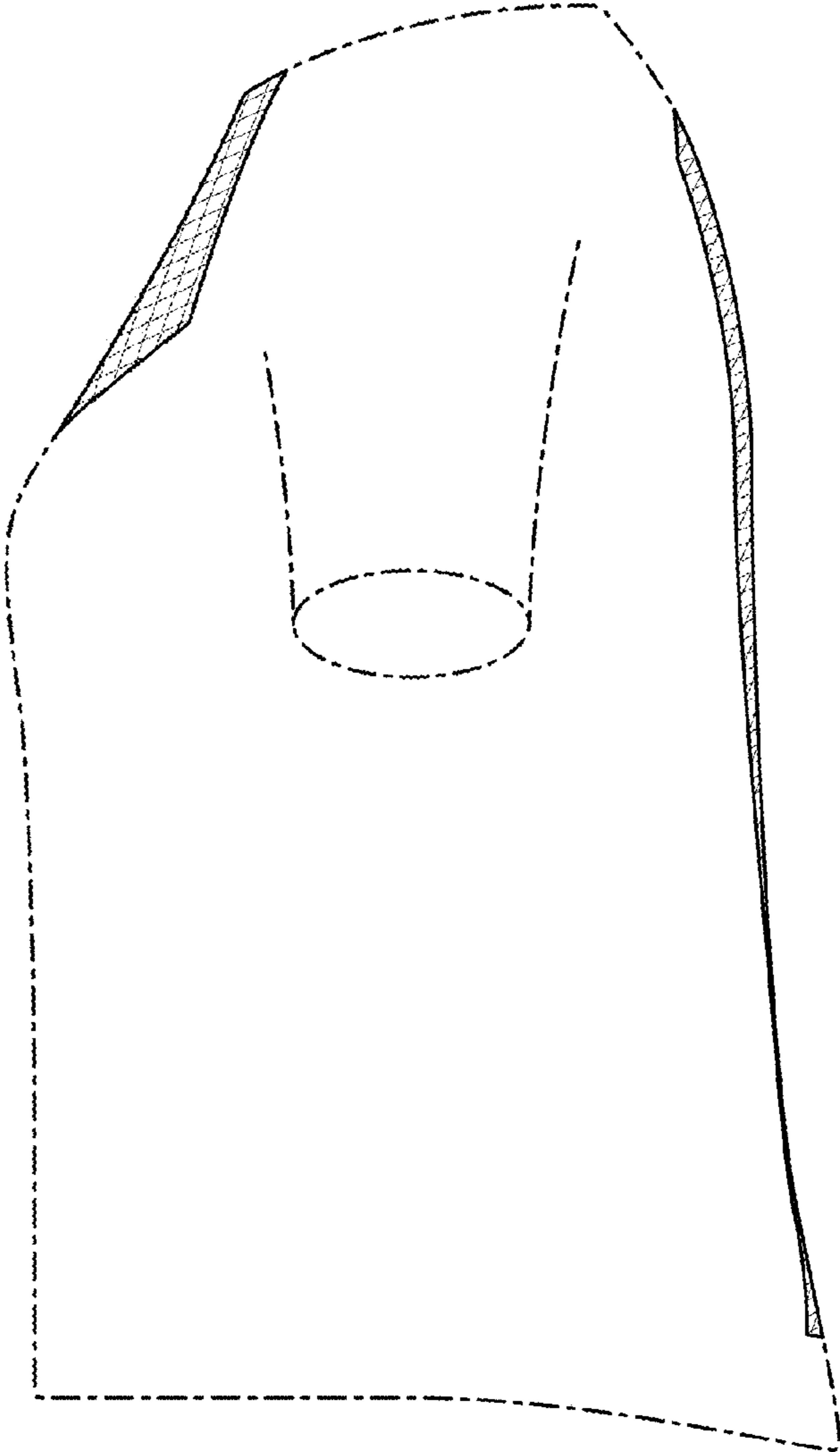

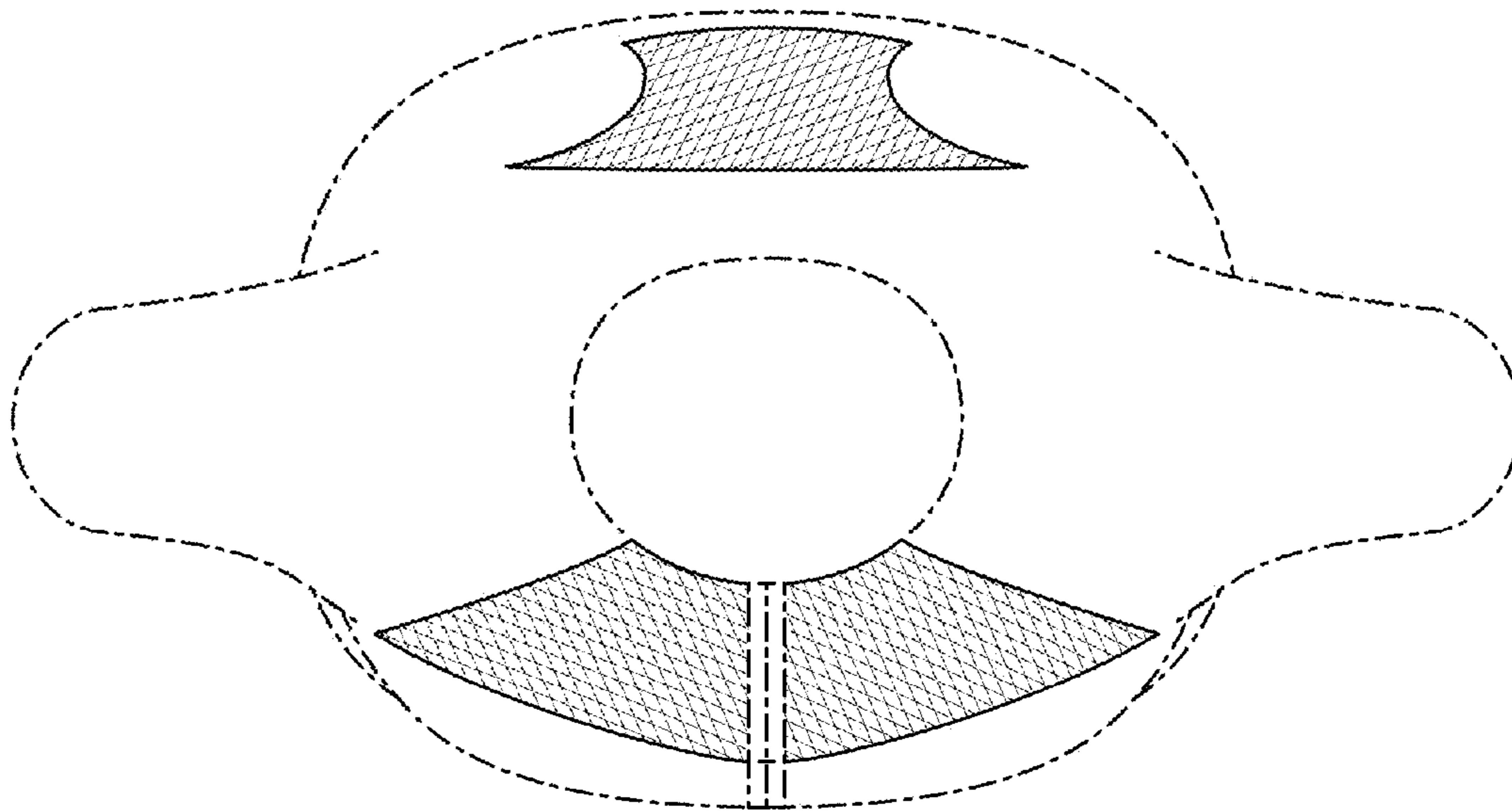

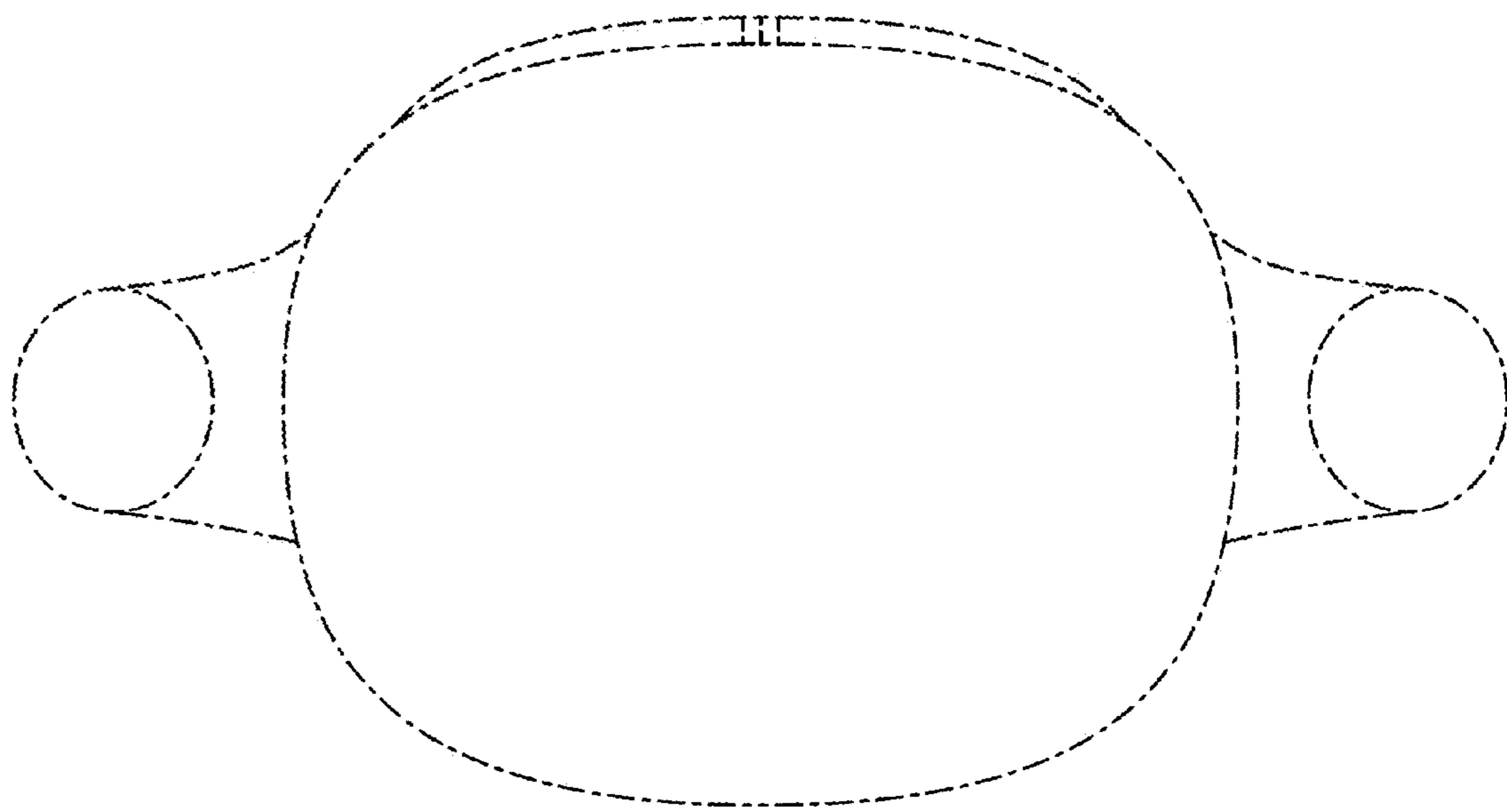
