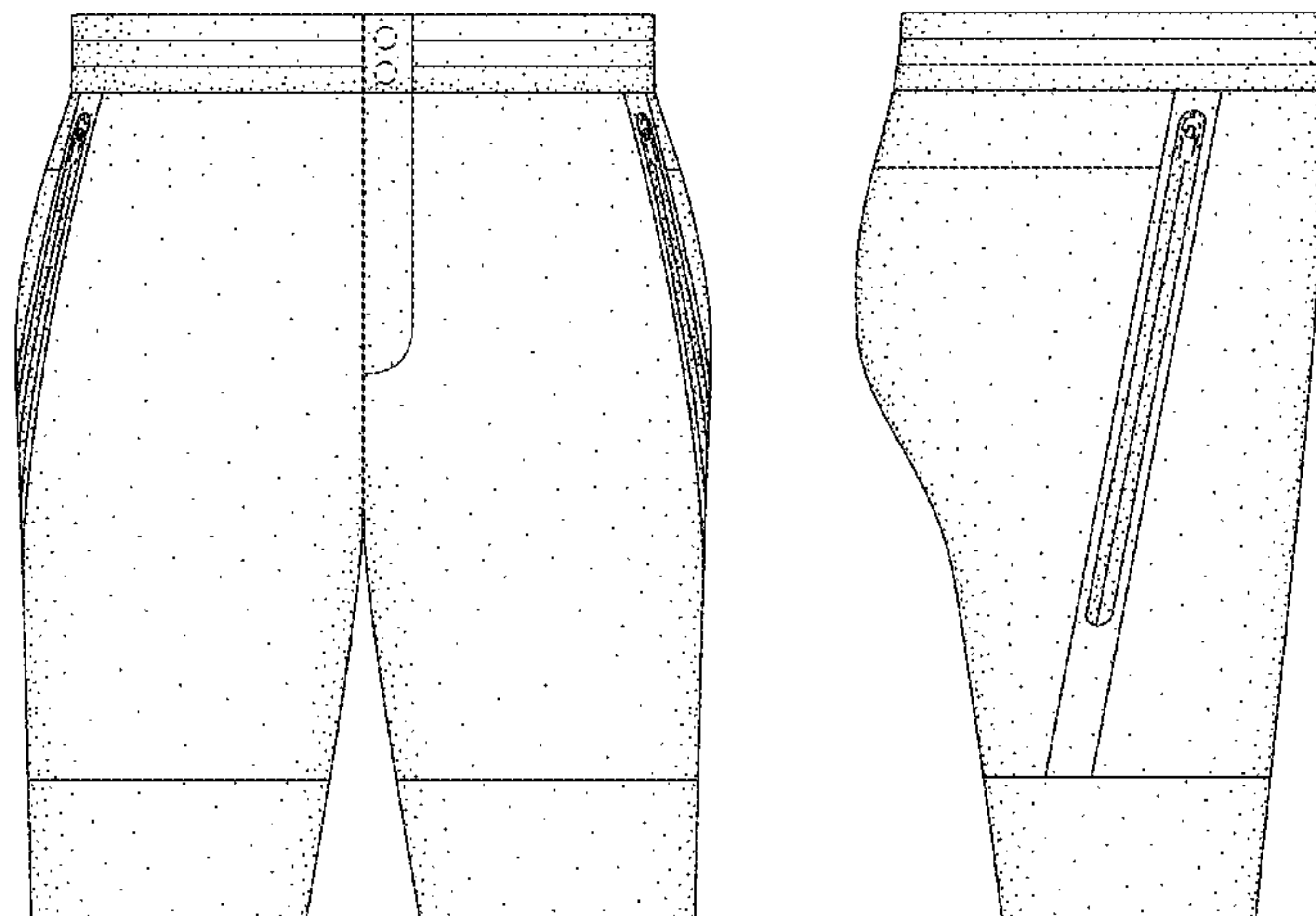

FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines represent unclaimed boundaries of the design. The unshaded regions, demarcated by broken lines, represent unclaimed portions of the pants.

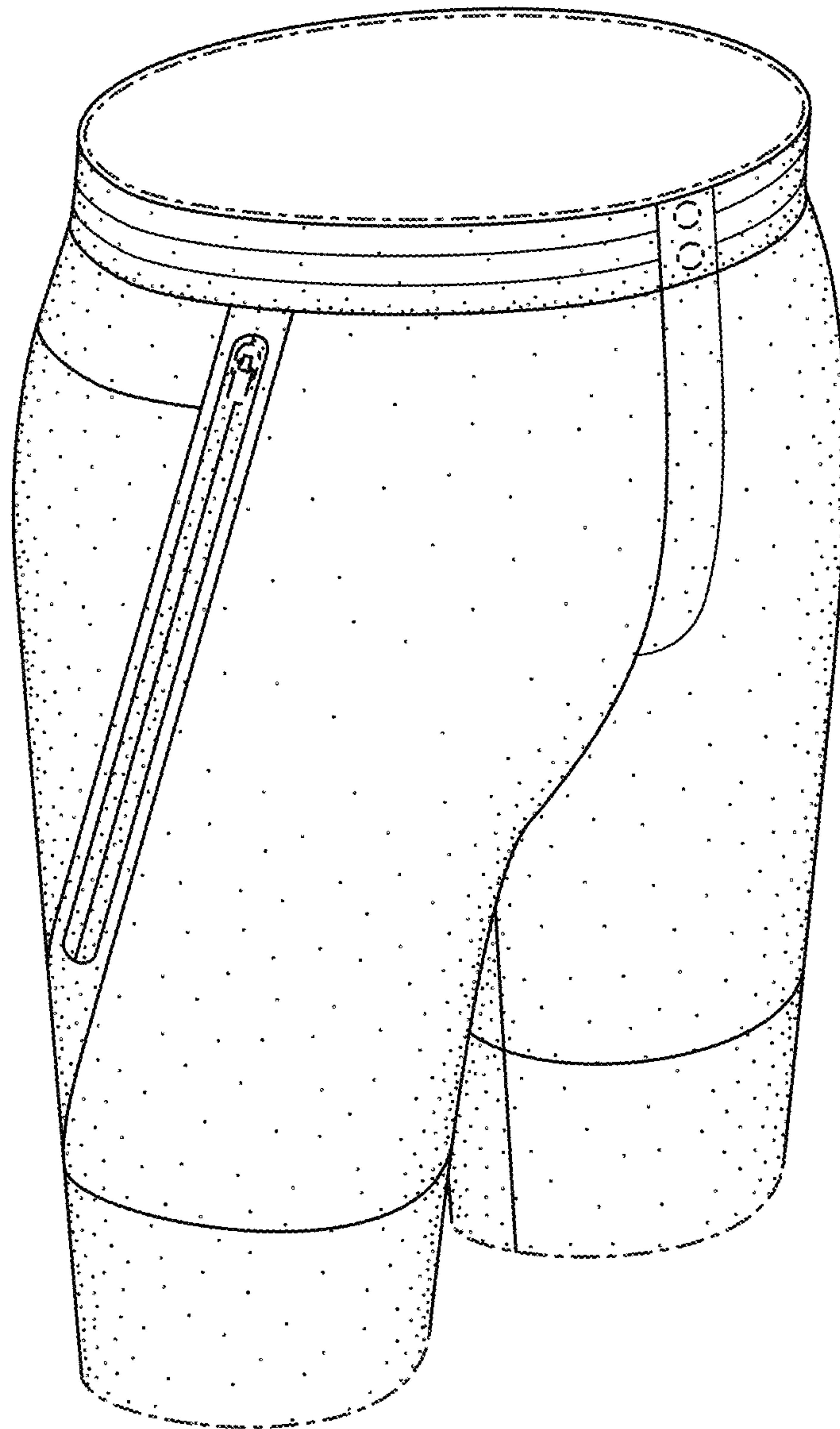

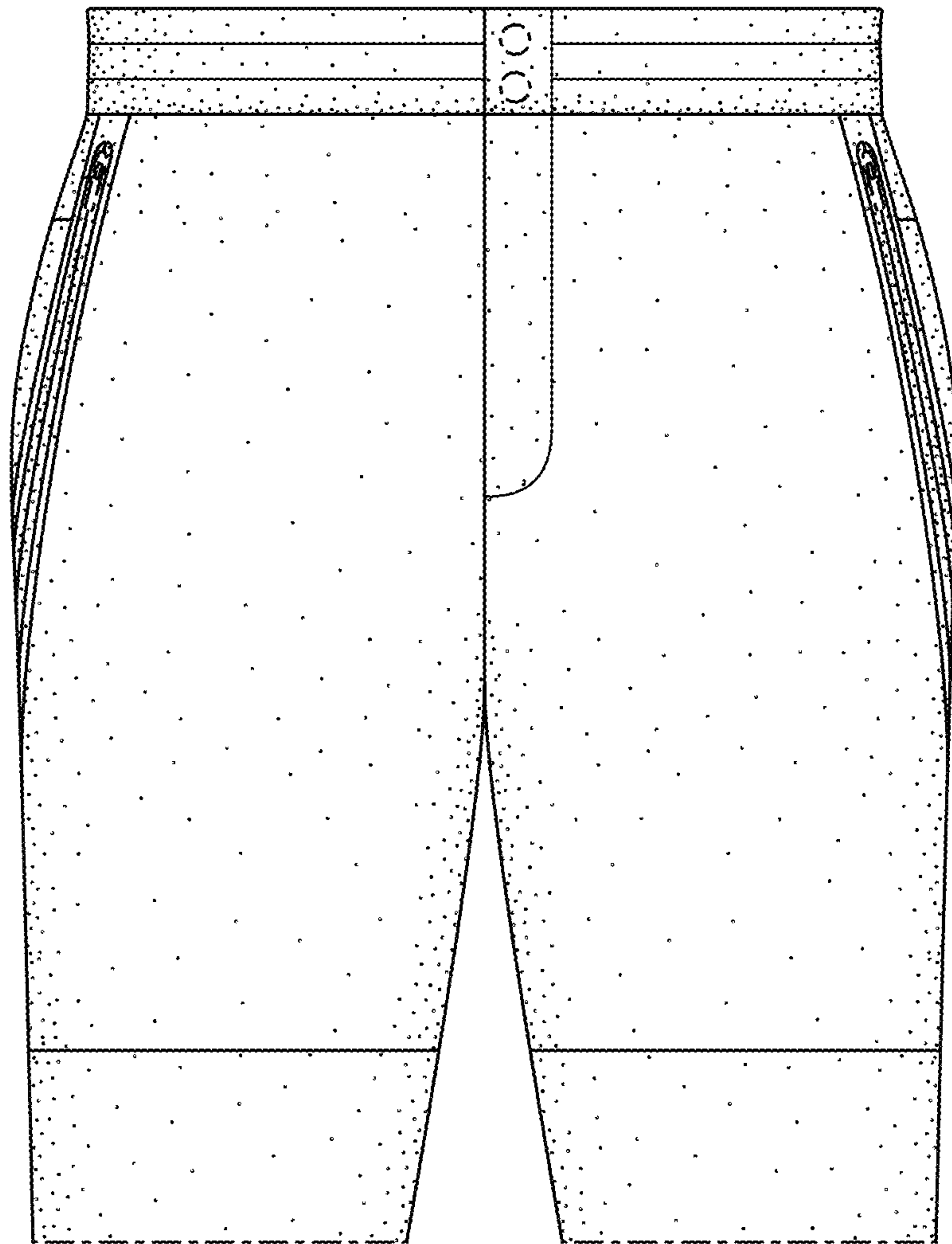

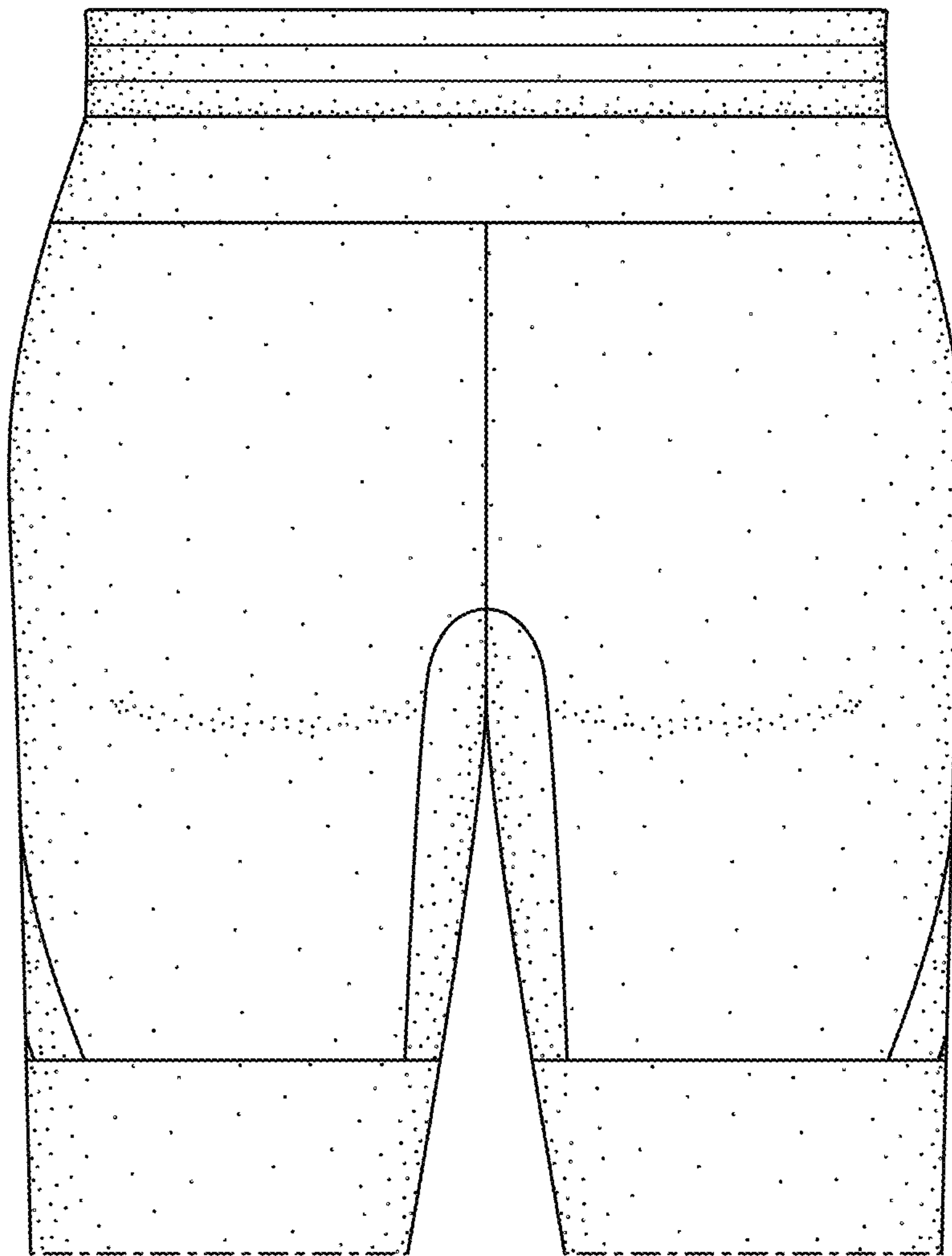

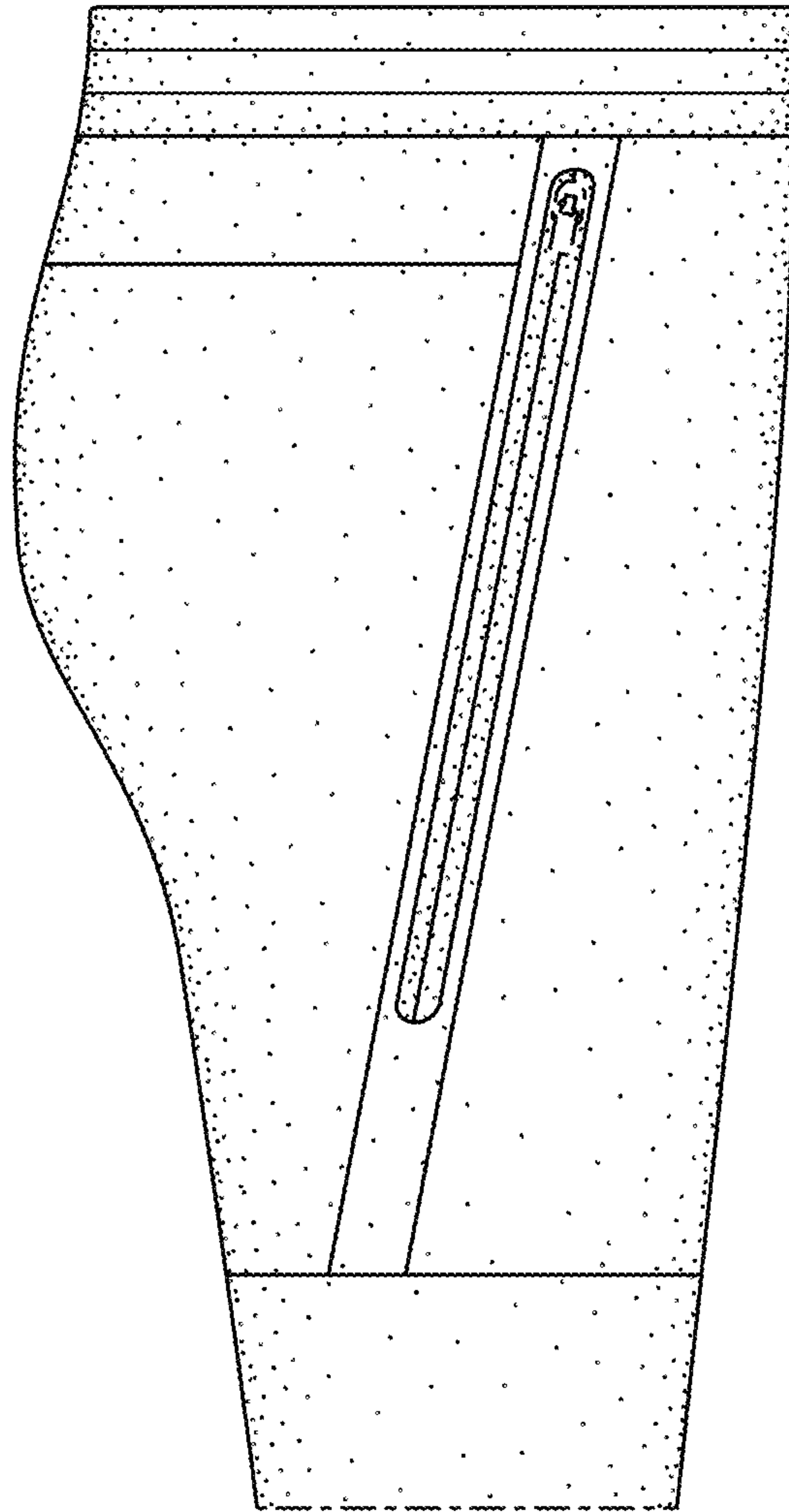

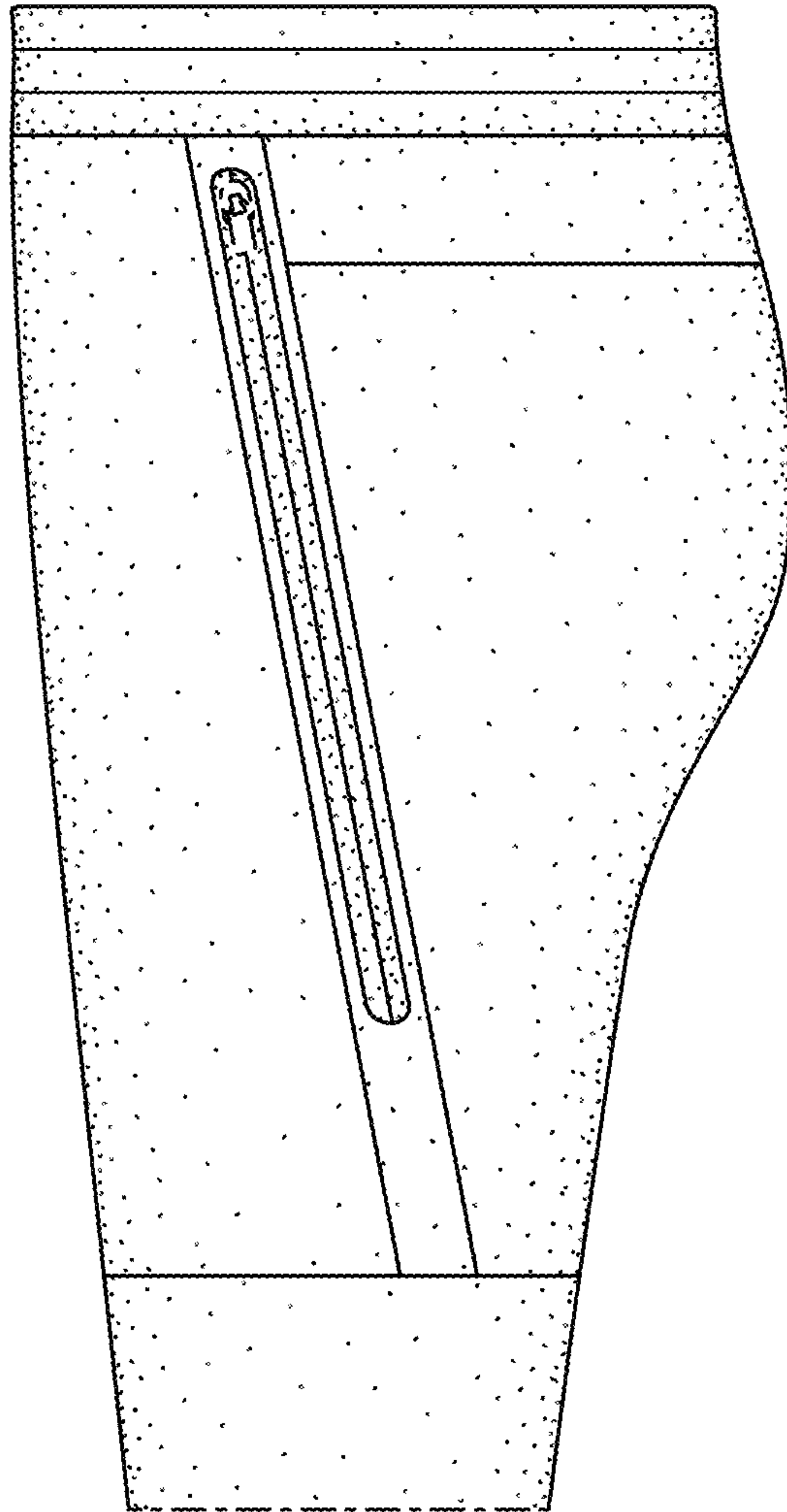

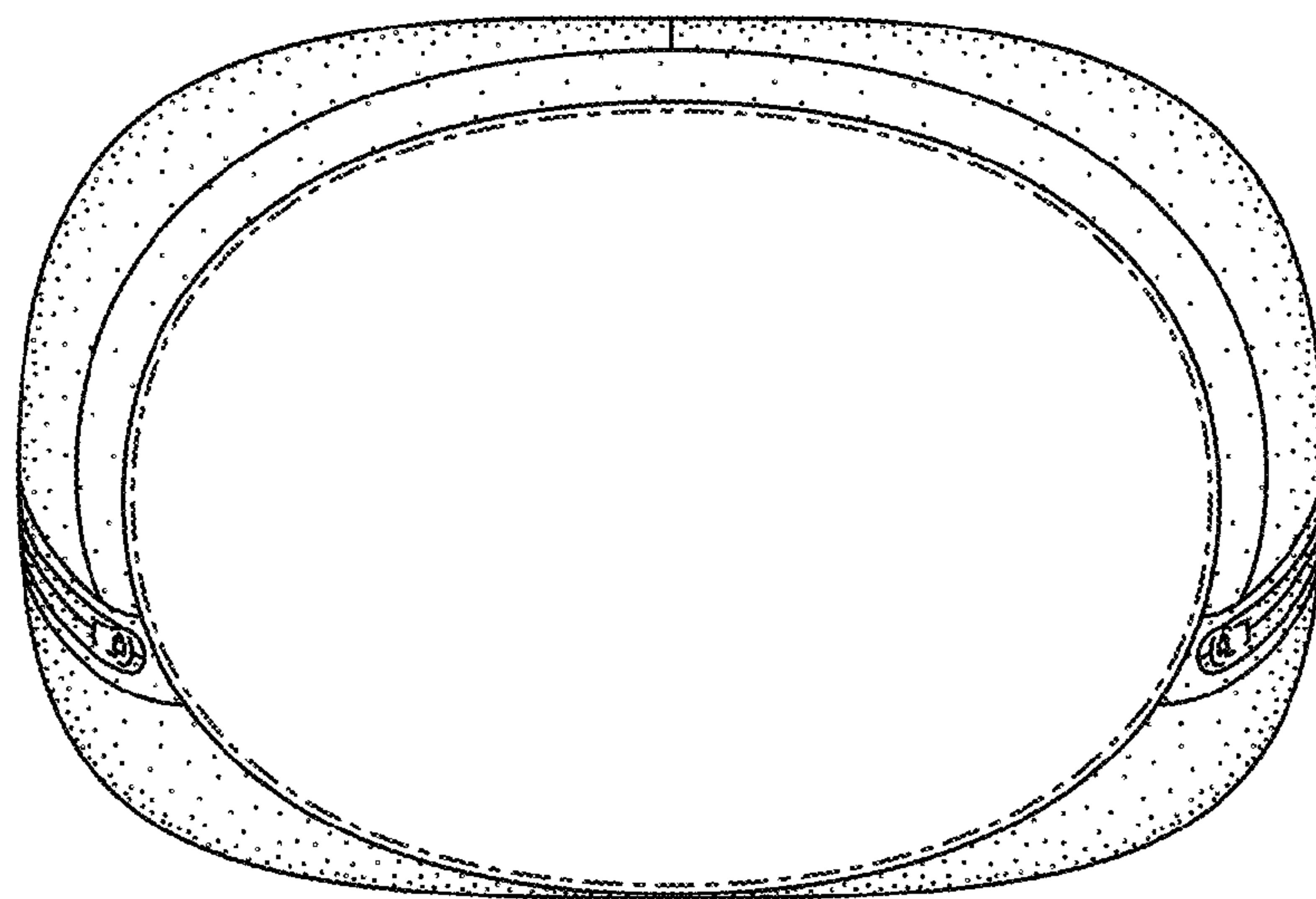

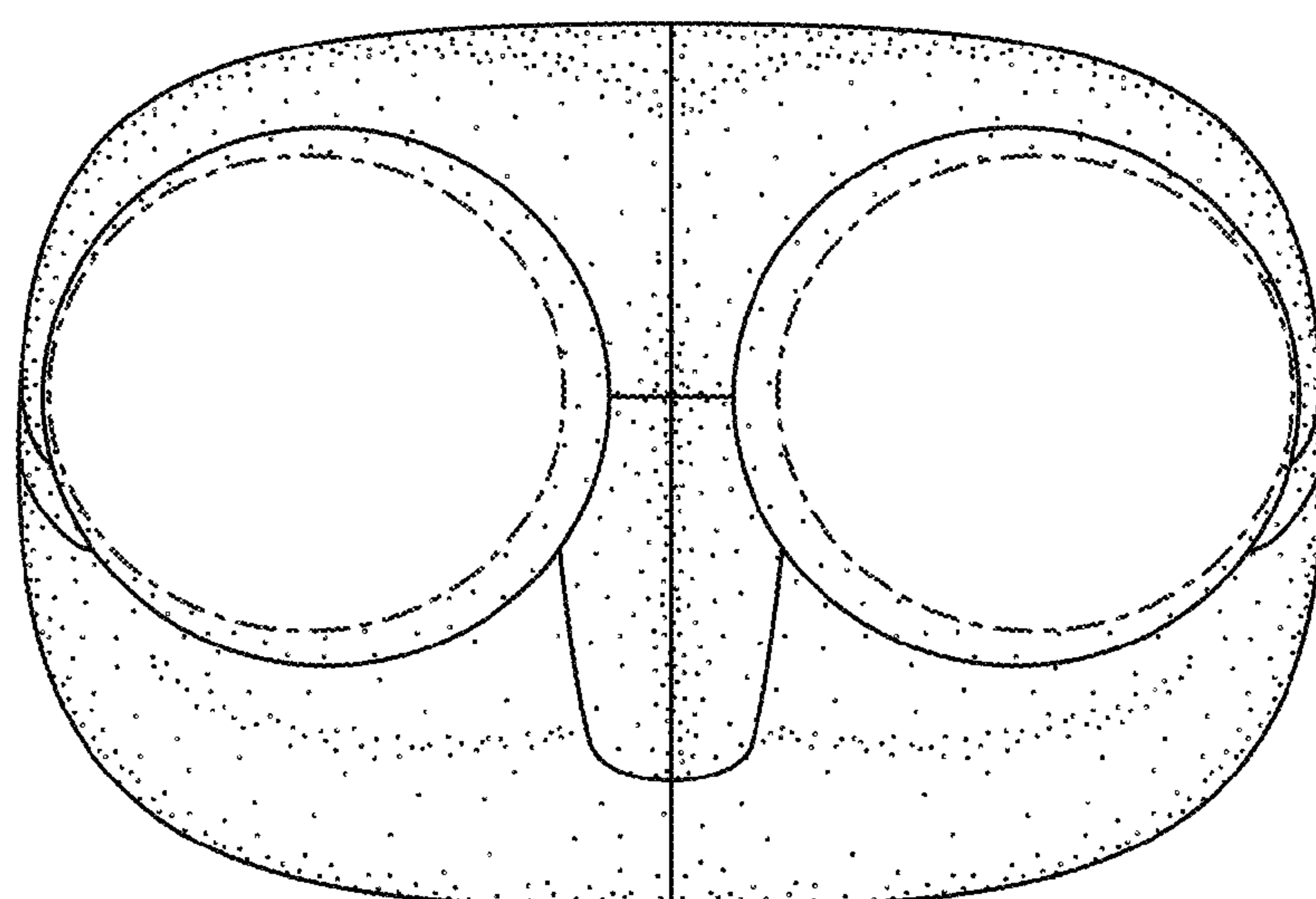
