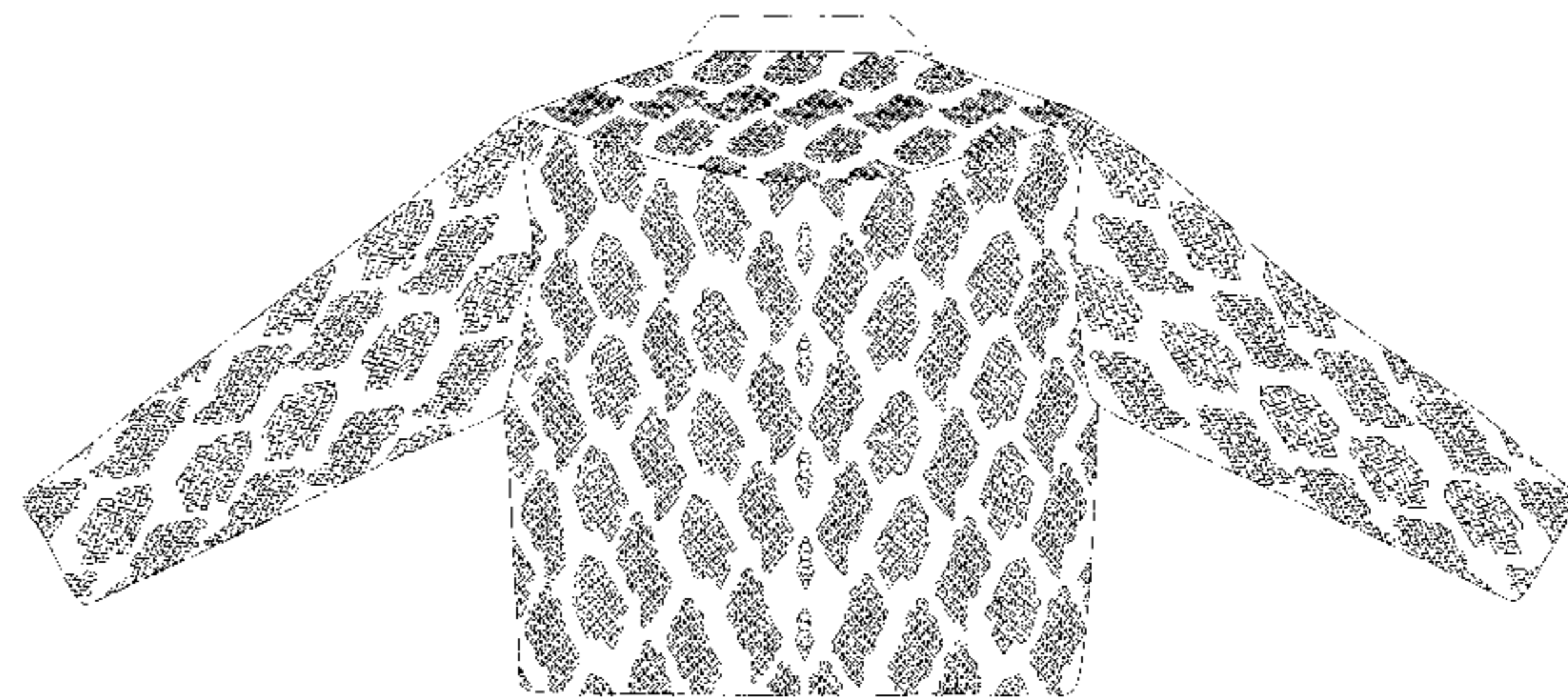
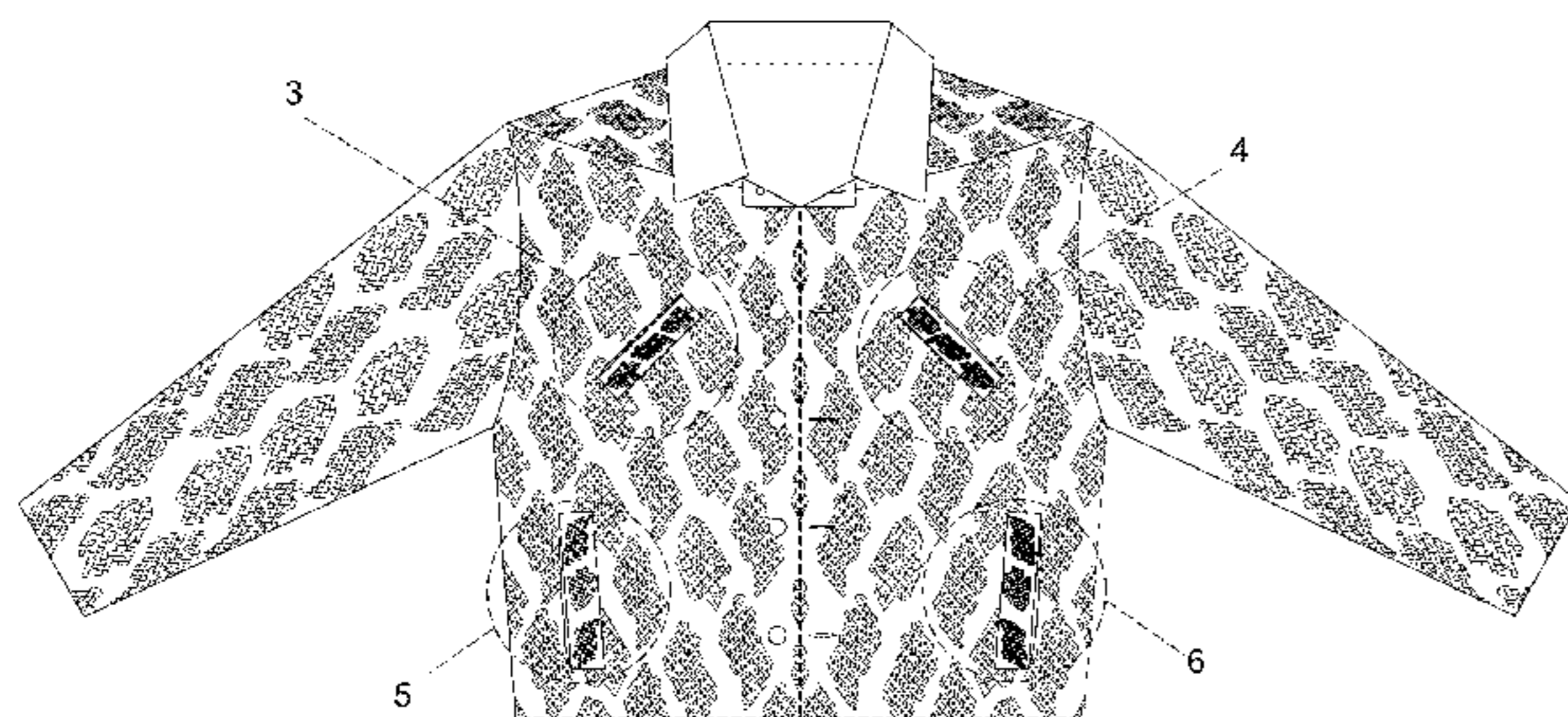
(57) **CLAIM**

The ornamental design for a jacket with snakeskin-like pattern, as shown and described.

DESCRIPTION

FIG. 1 illustrates a front view of a jacket with snakeskin-like pattern showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is an enlarged view of the right breast pocket trim, the remainder of the jacket removed for ease of illustration; FIG. 4 is an enlarged view of the left breast pocket trim, the remainder of the jacket removed for ease of illustration; FIG. 5 is an enlarged view of the right waist pocket trim, the remainder of the jacket removed for ease of illustration; and, FIG. 6 is an enlarged view of the left waist pocket trim, the remainder of the jacket removed for ease of illustration.

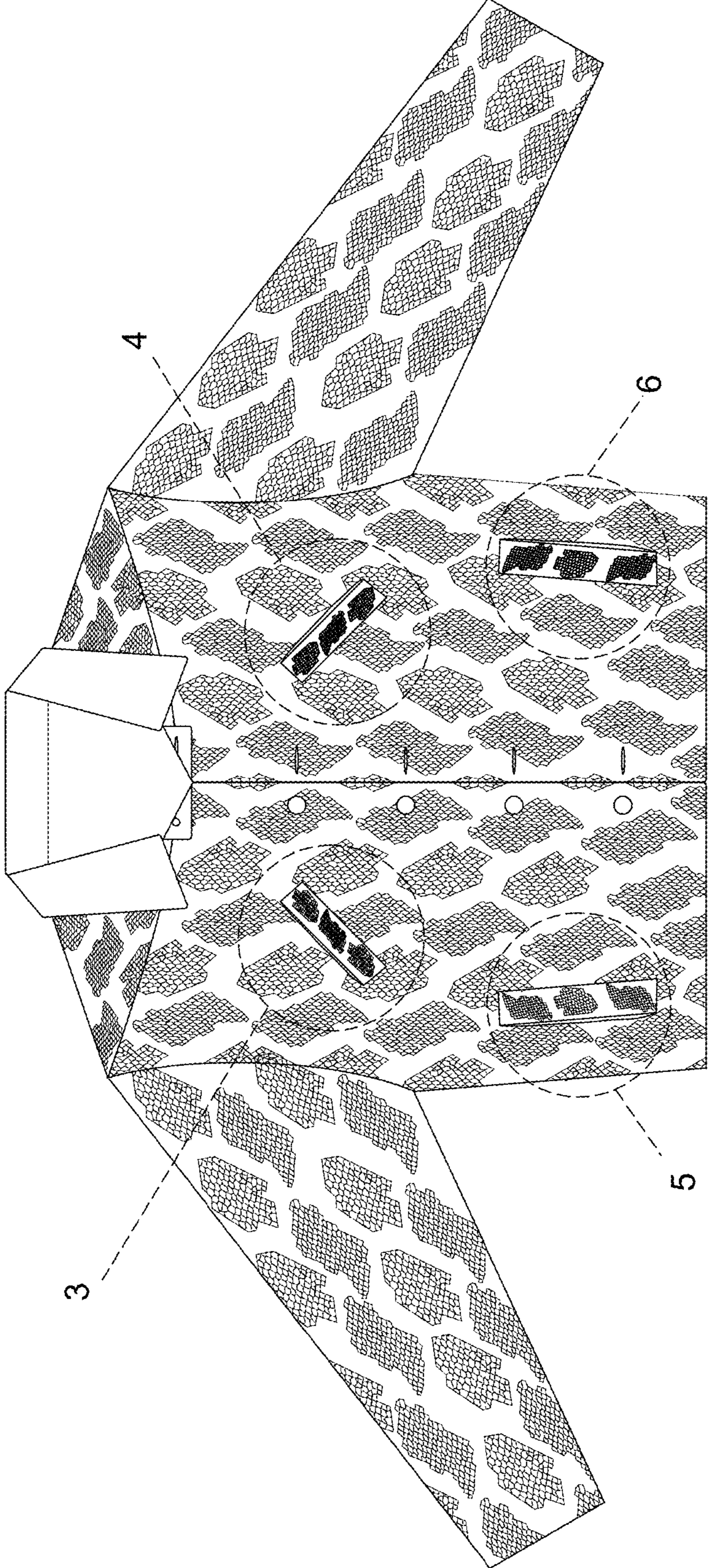

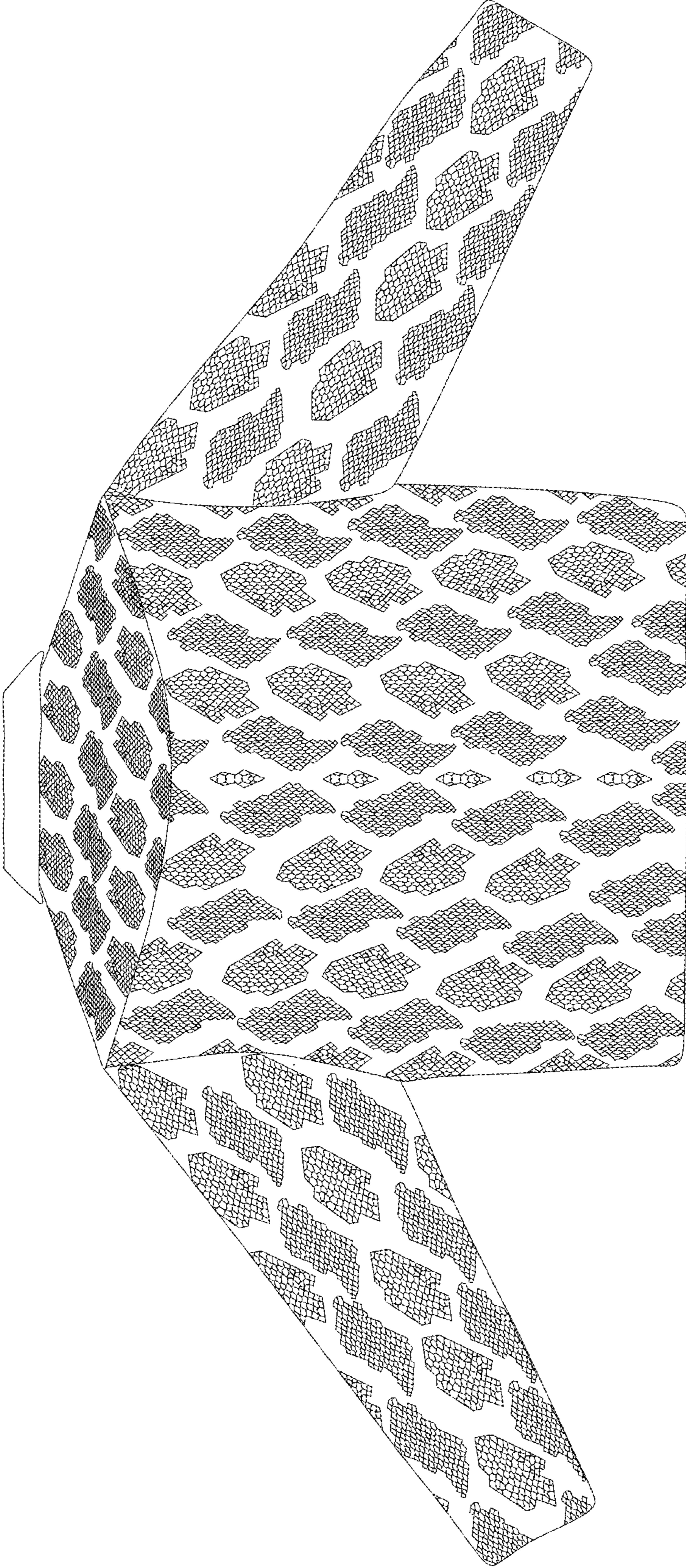

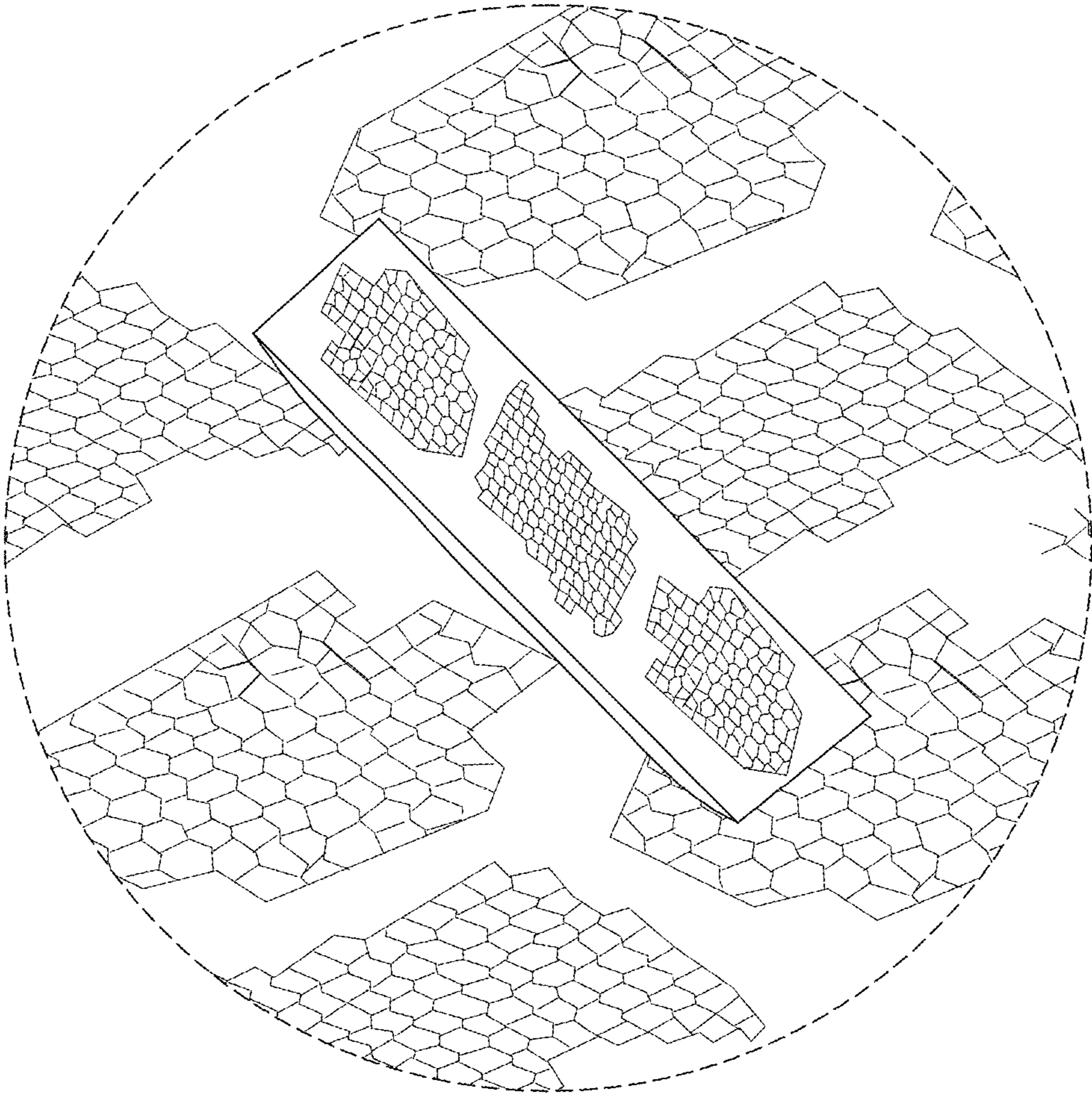

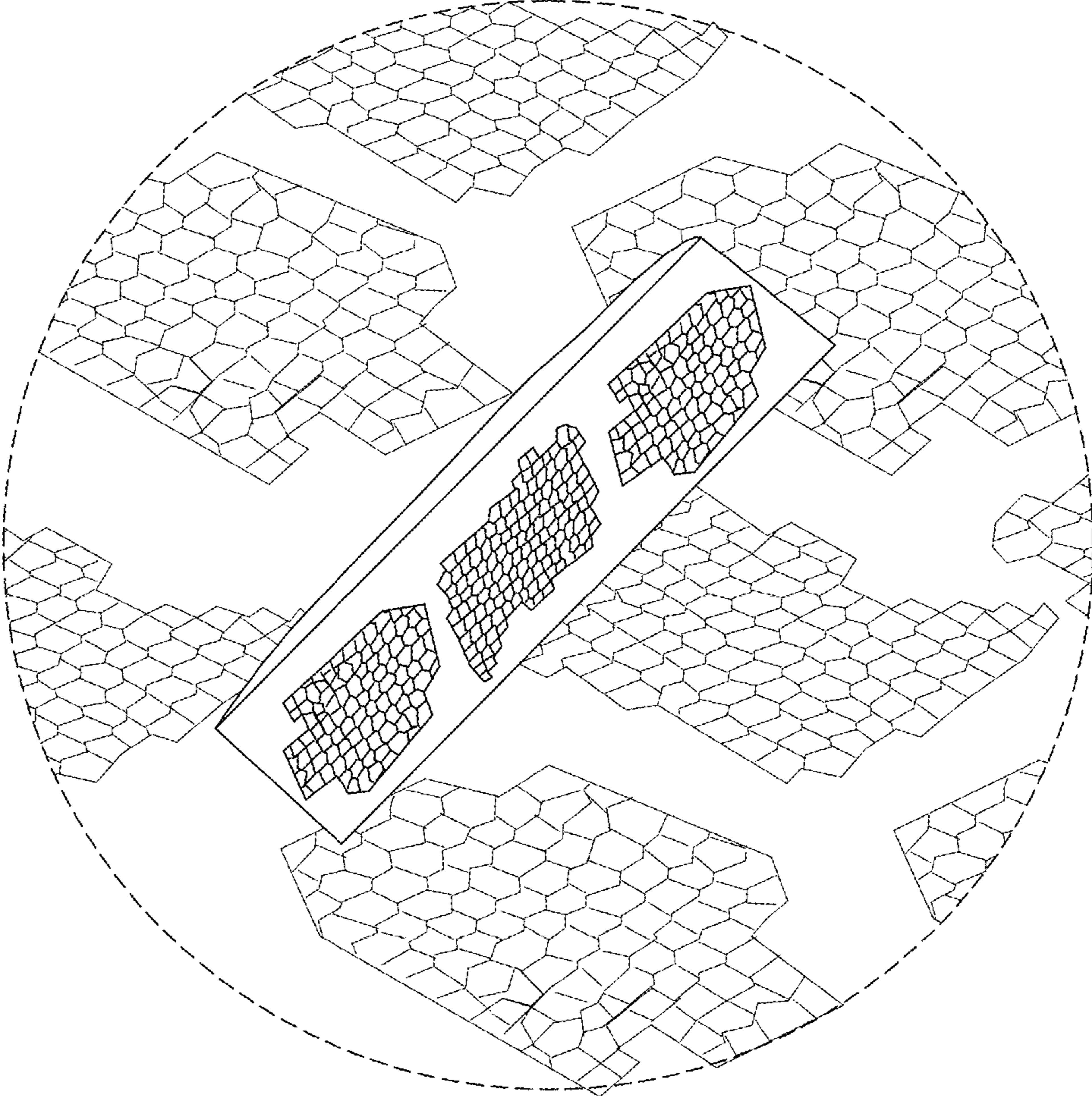

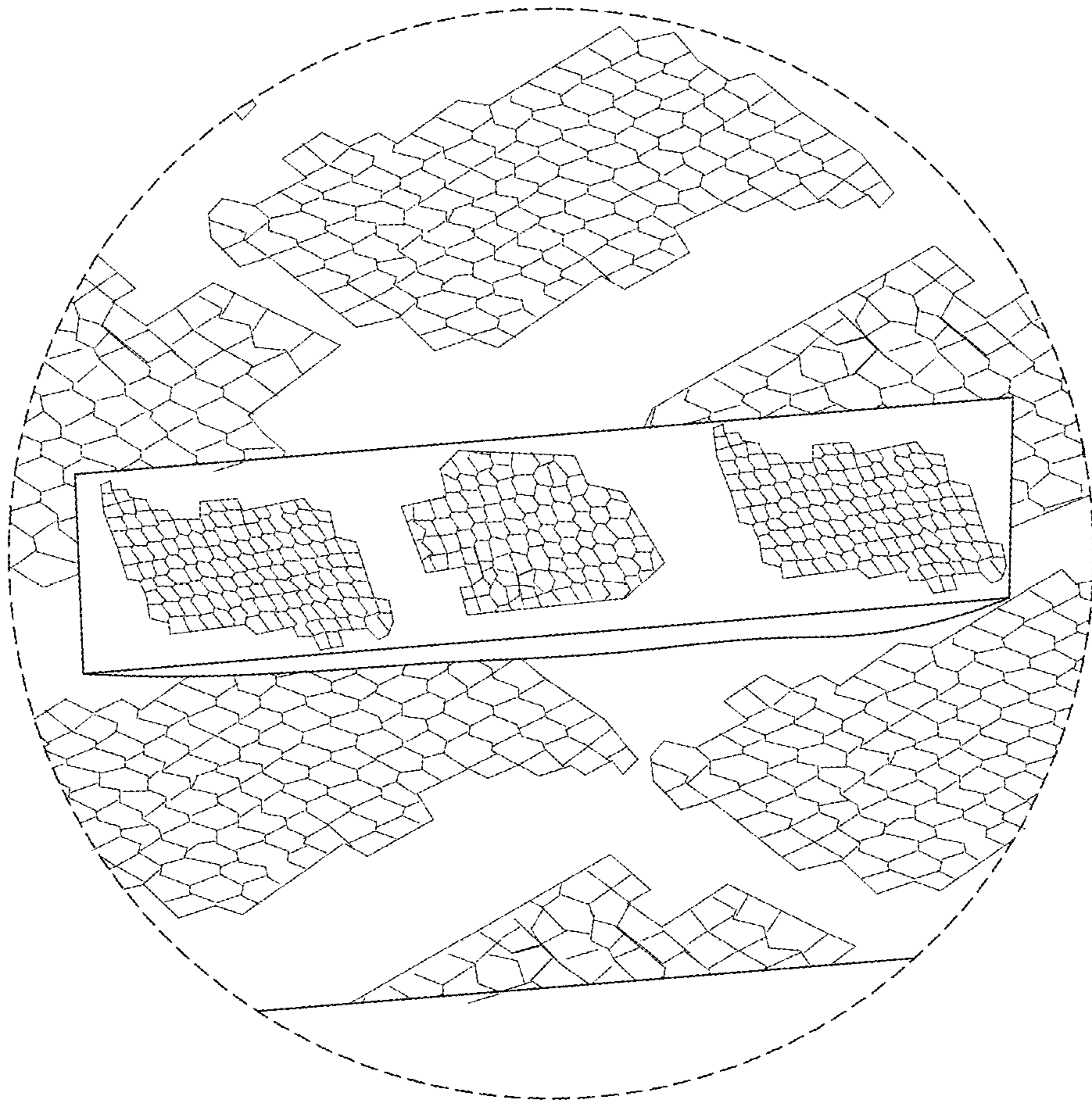
