(57) **CLAIM**

The ornamental design for a rugby jersey, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a rugby jersey showing my new design.

FIG. 2 is a left side elevational view thereof.

FIG. 3 is a right side elevational view thereof.

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a rear elevational view thereof.

The broken lines show environmental structure that forms no part of the claimed design.

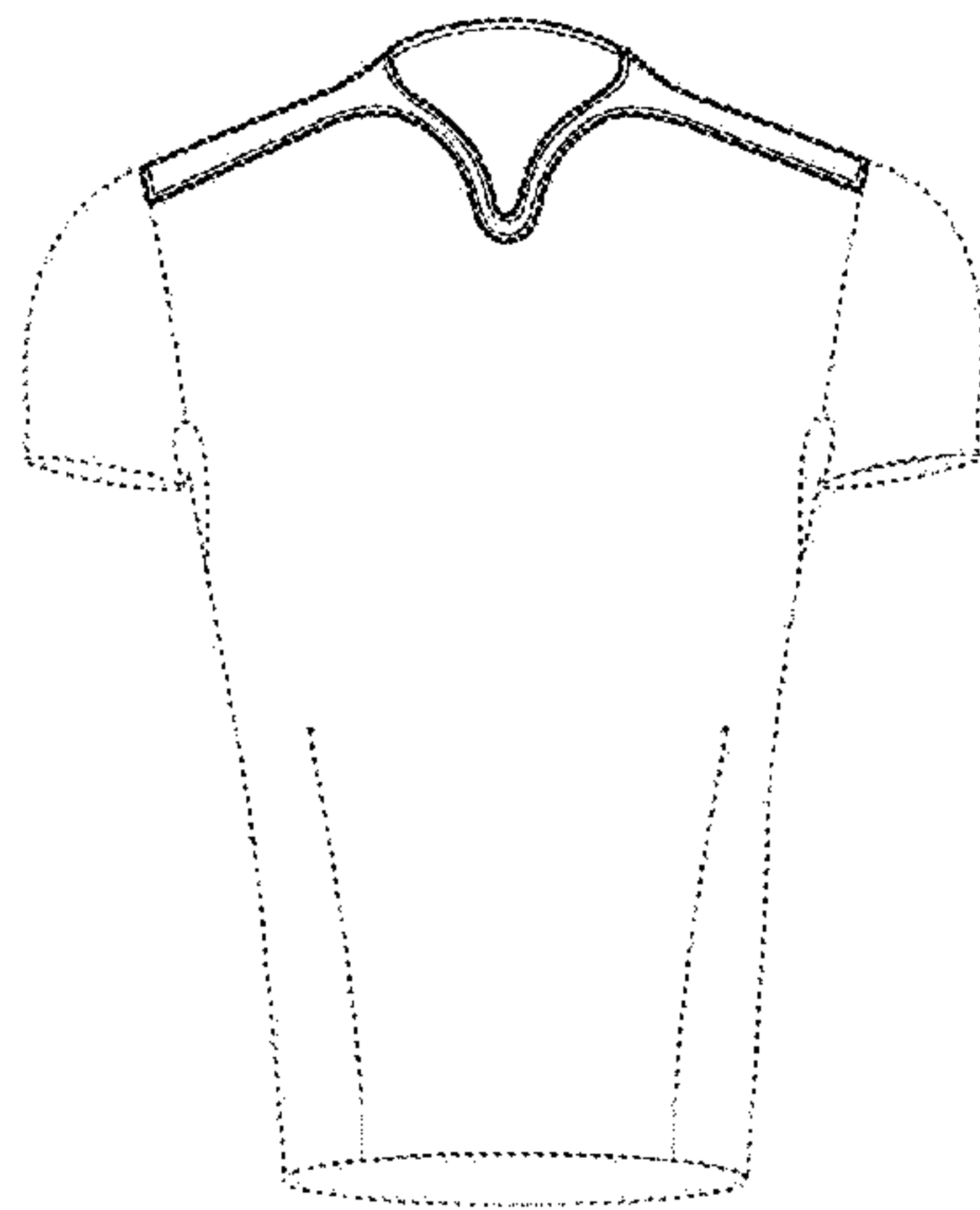

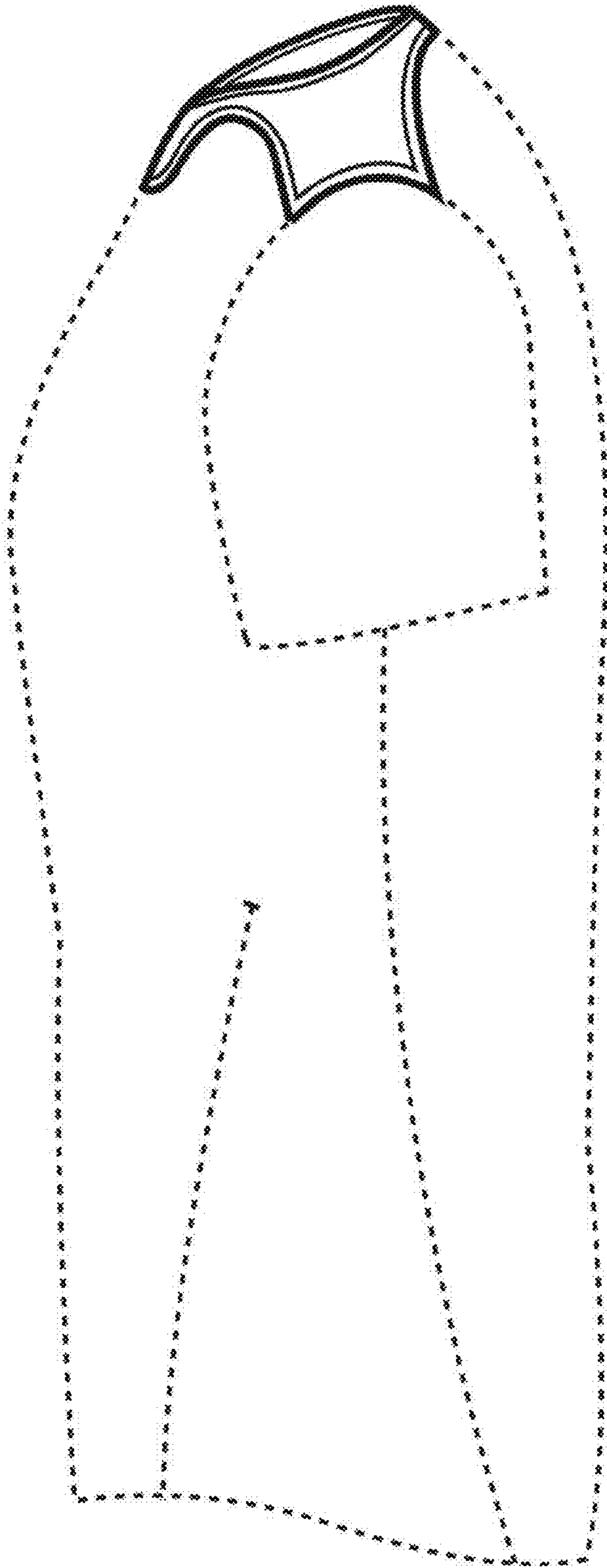

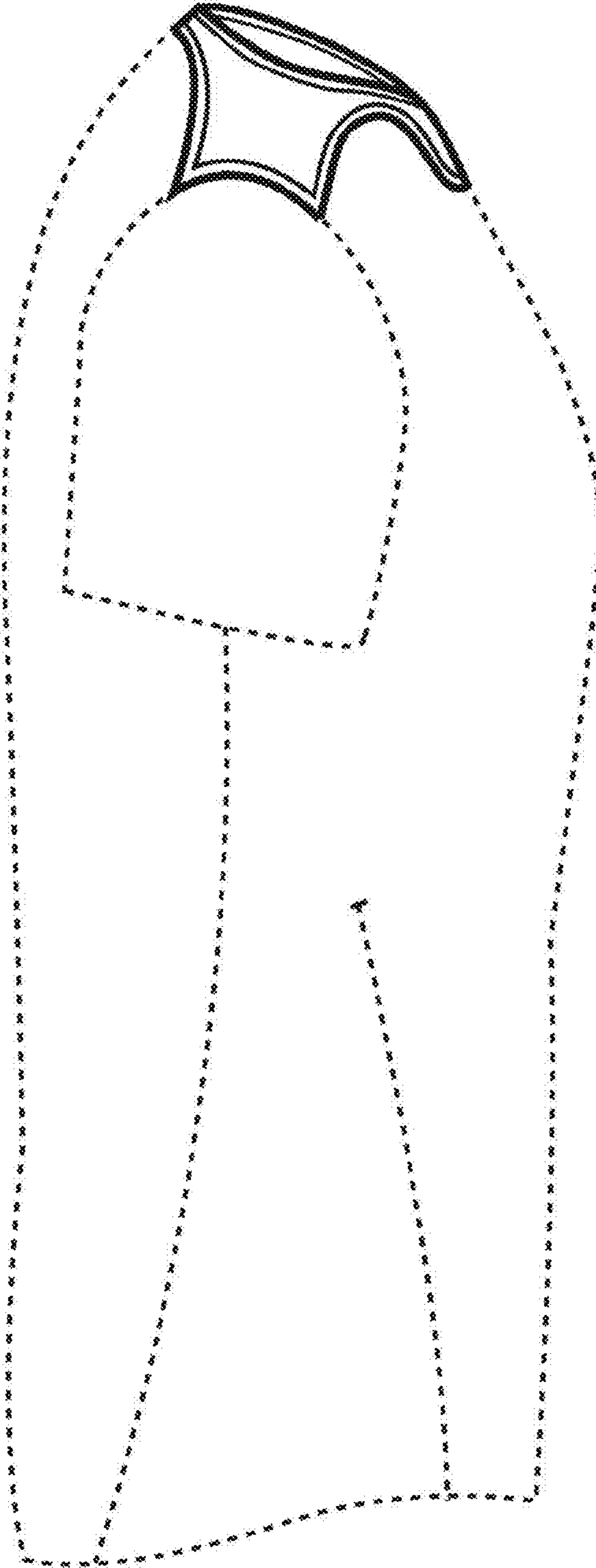

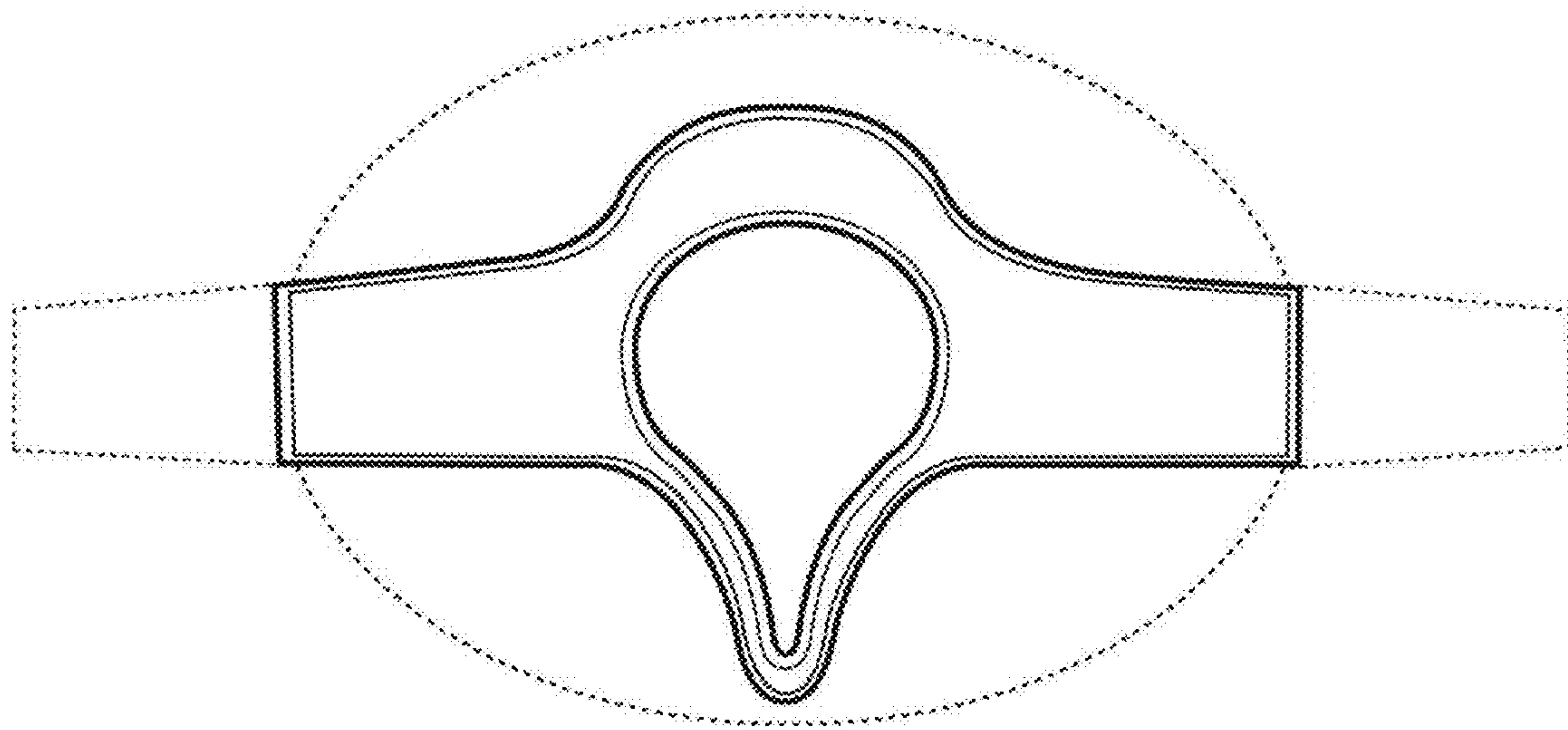

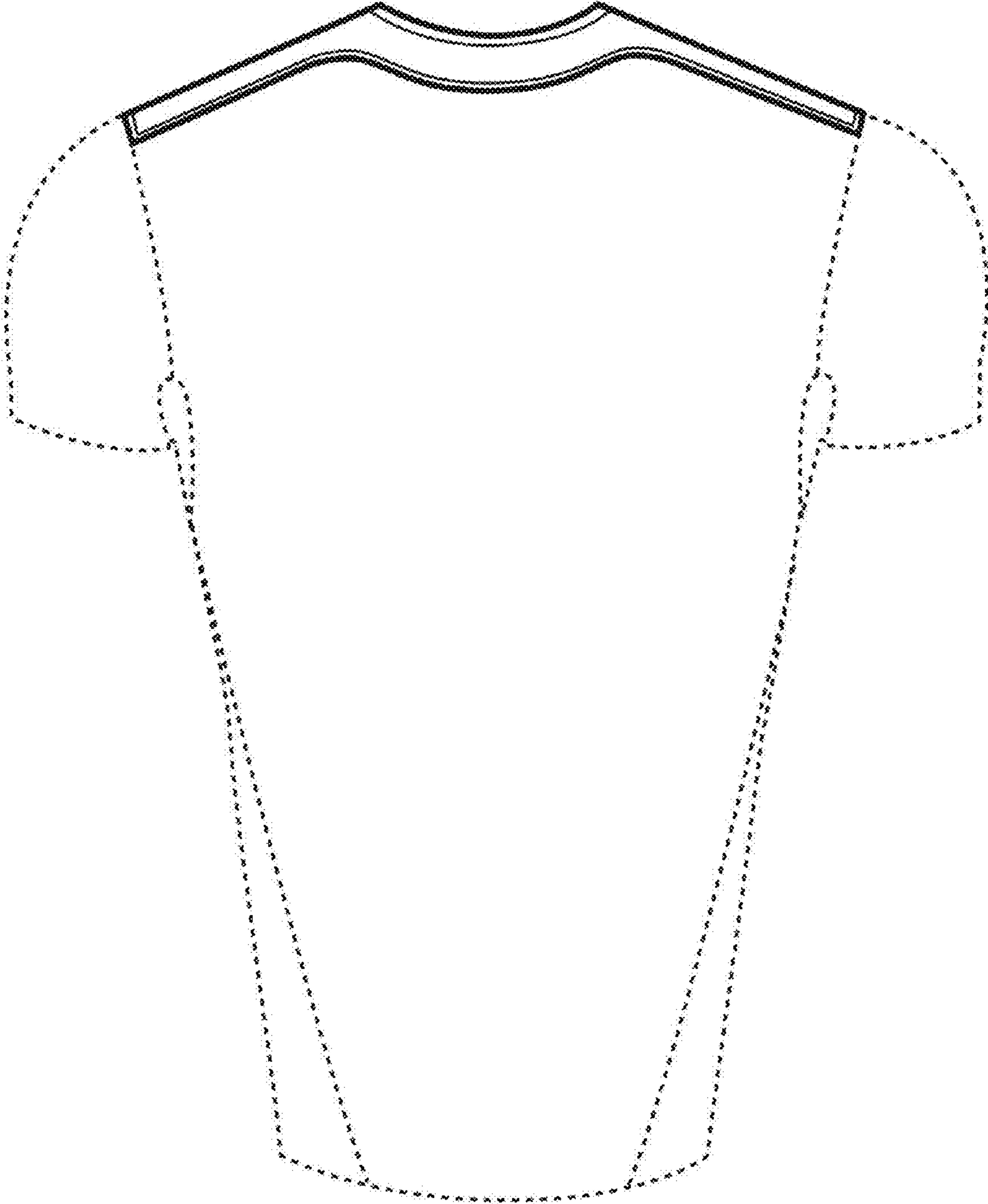
