(57) **CLAIM**

The ornamental design for a headwear cap with size adjustment strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the headwear cap with size adjustment strap according to the invention; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof; FIG. 8 is an exploded view thereof; and, FIG. 9 is perspective view thereof, as shown in a condition of use.

The cap shown in broken lines represents environmental structure that forms no part of the claimed design.

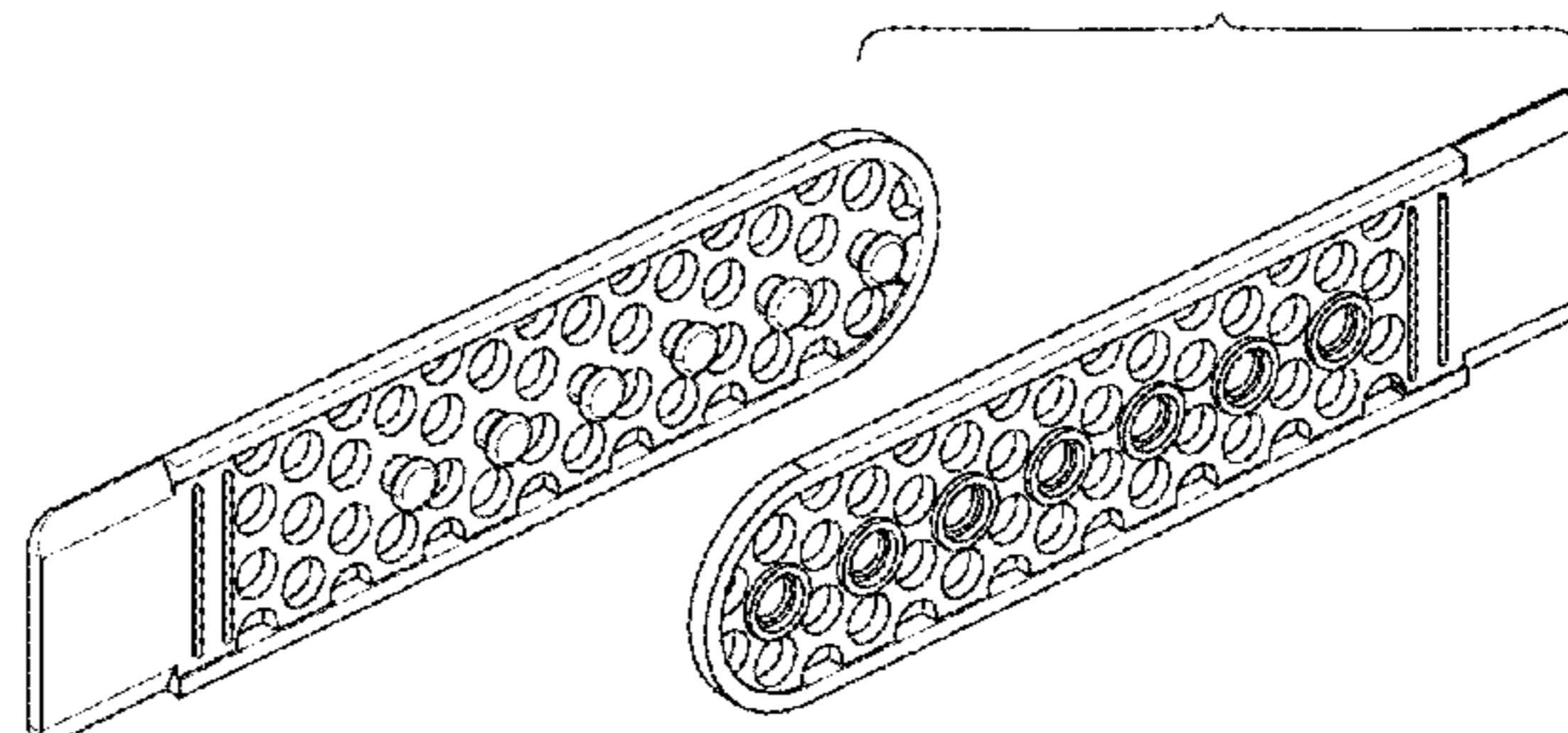
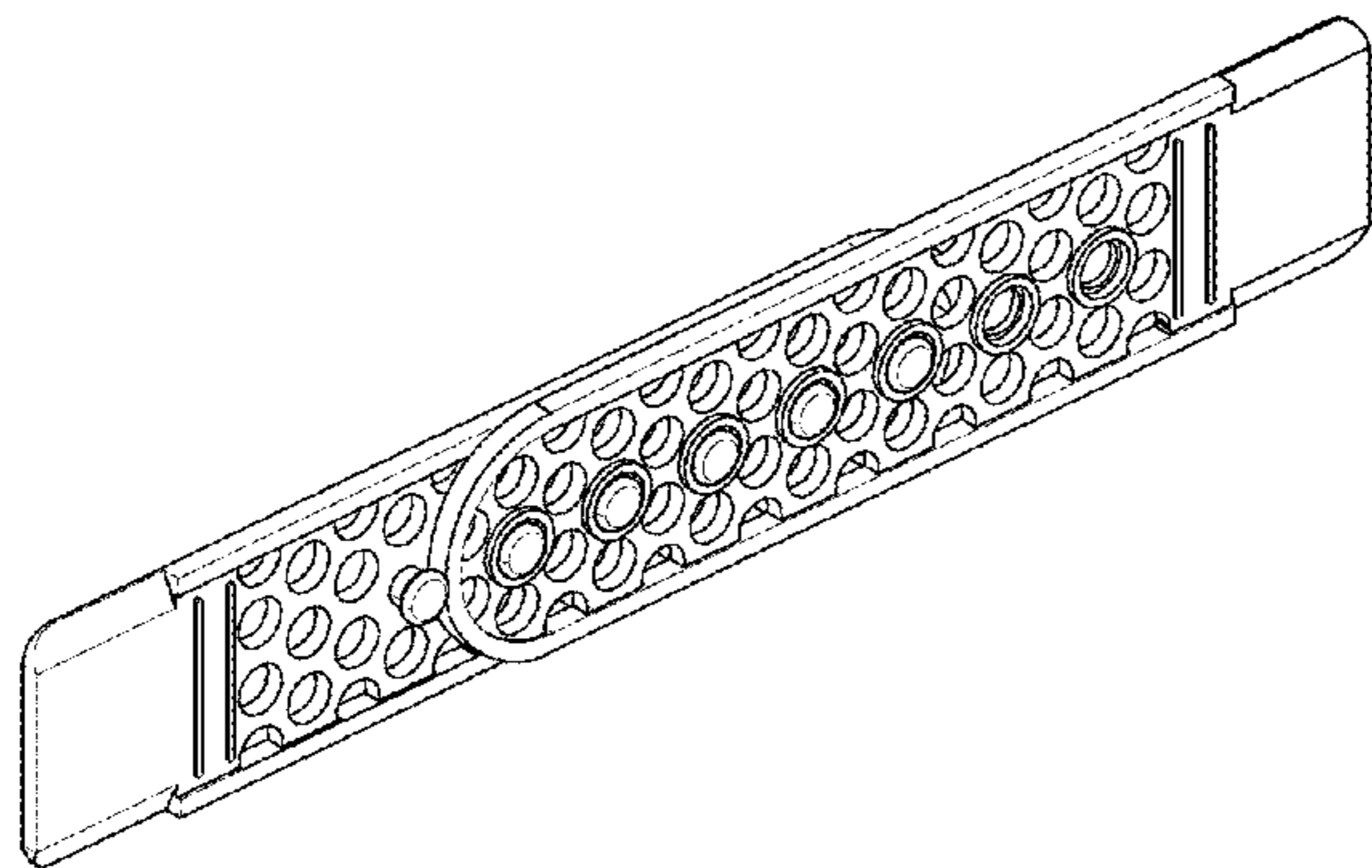

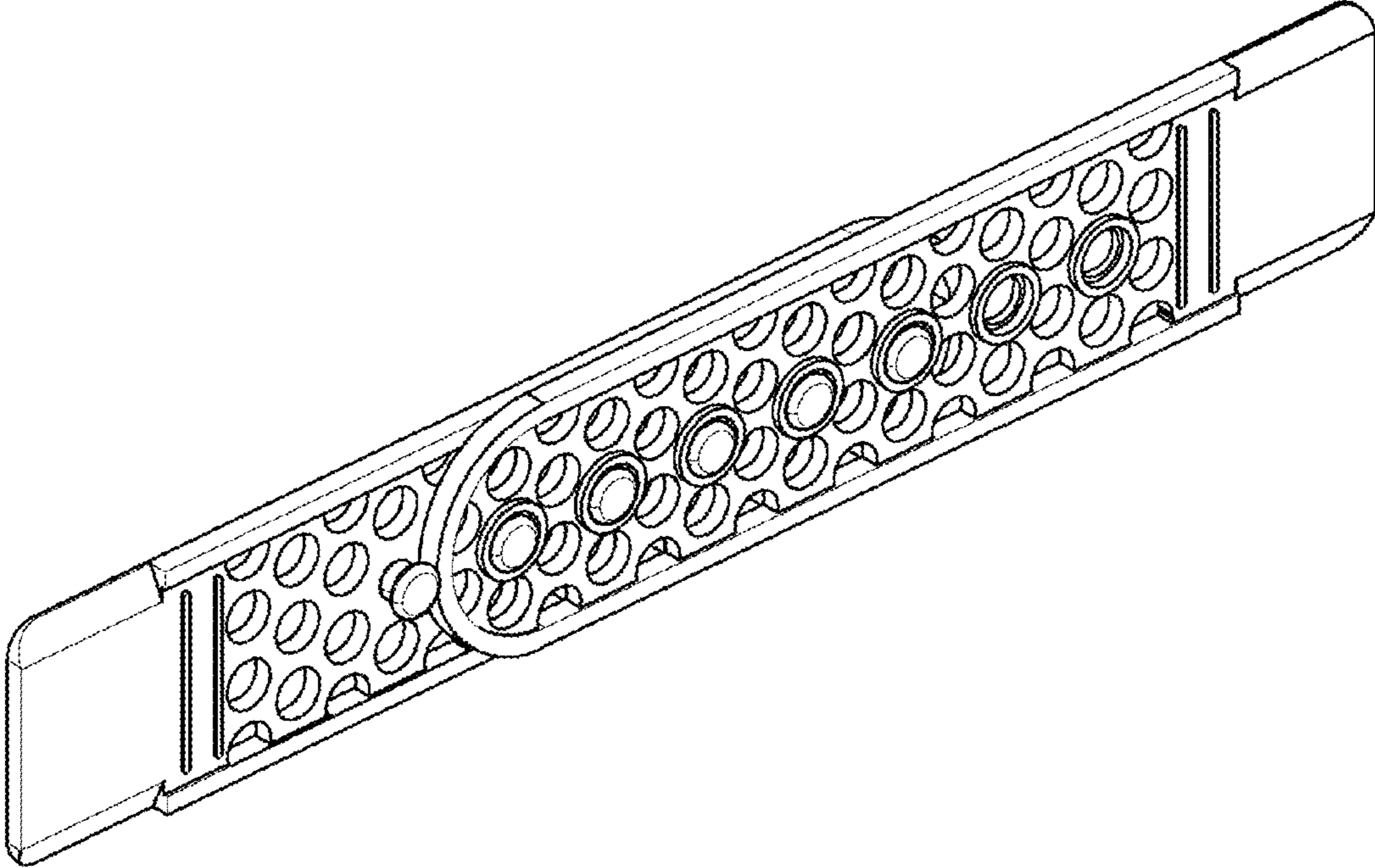

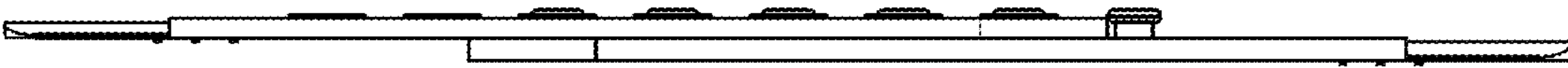

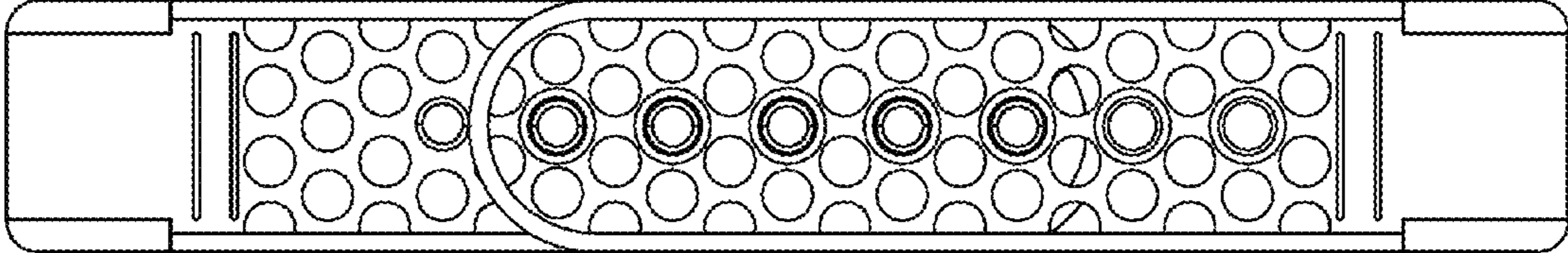

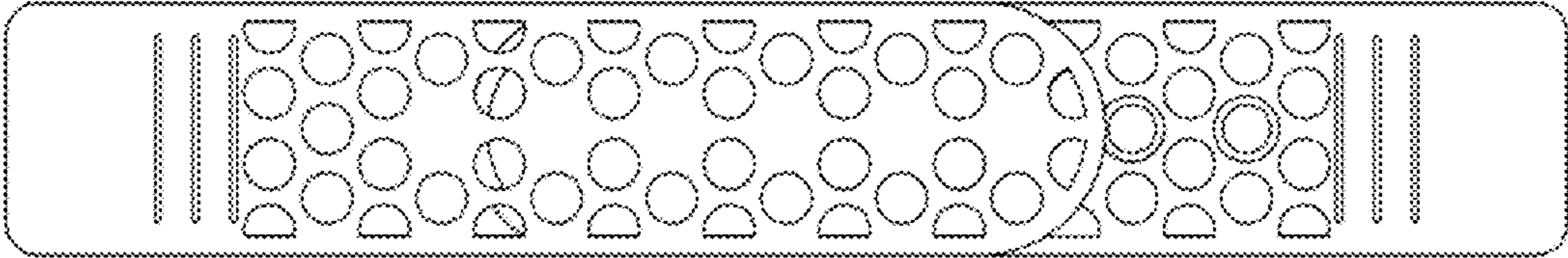

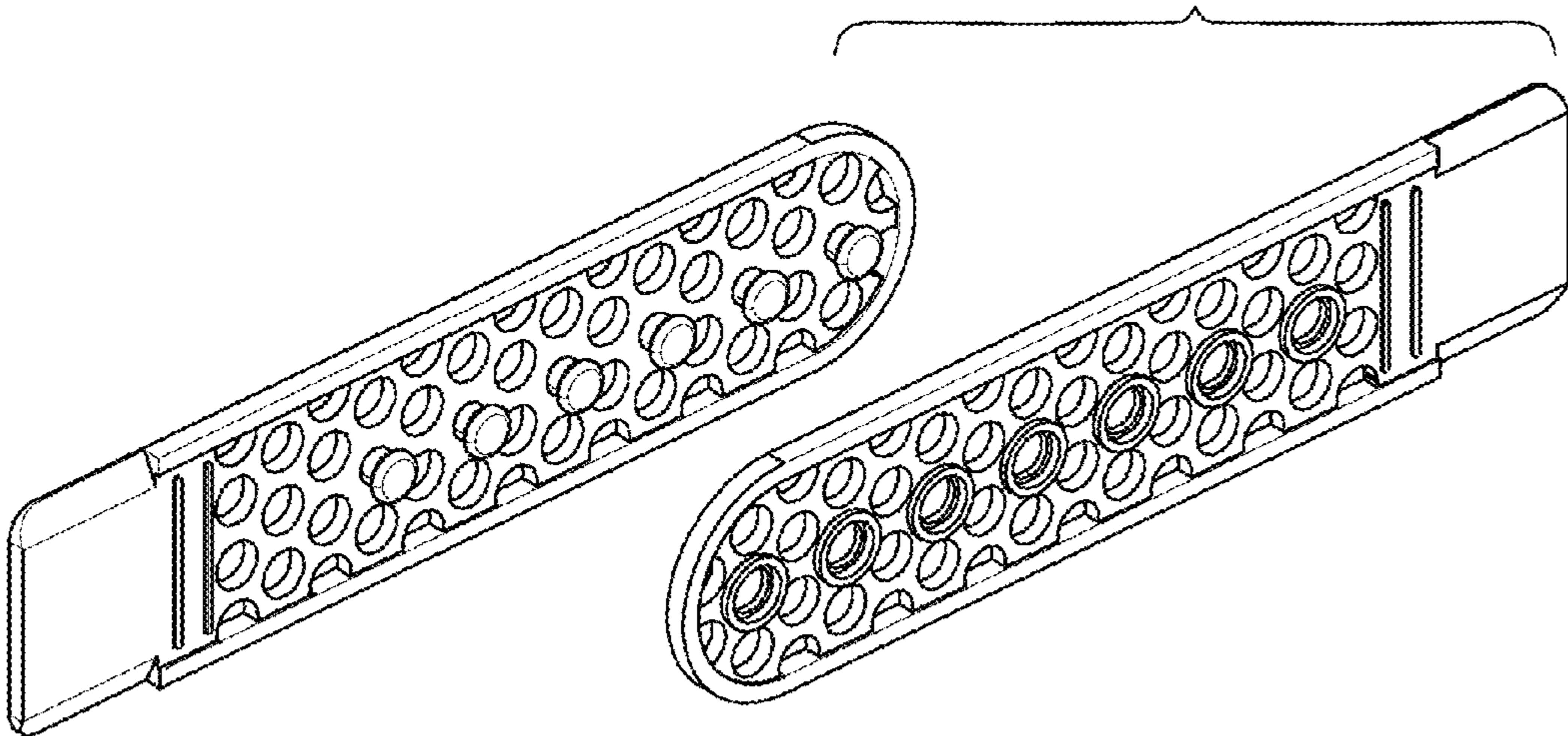
