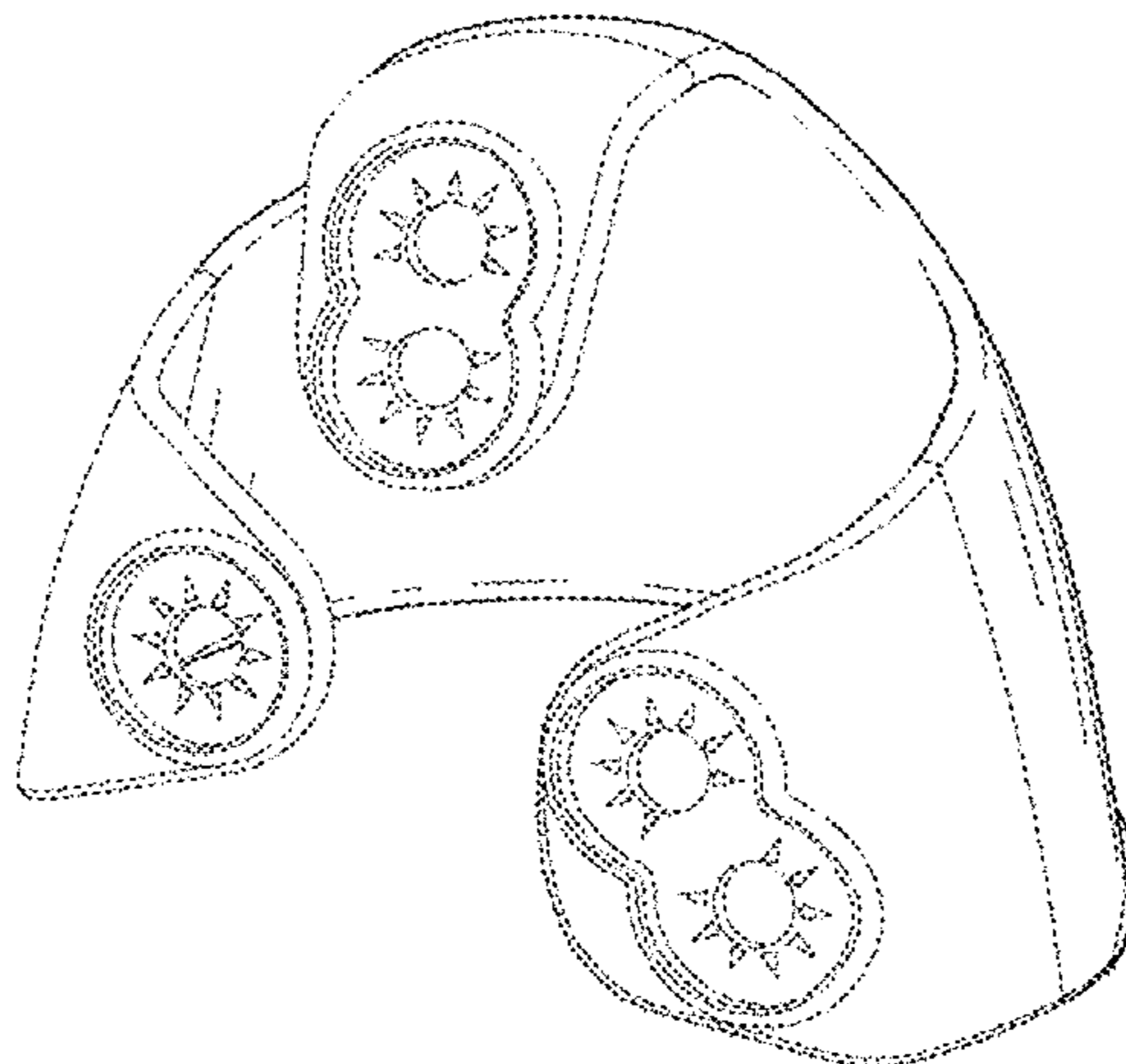

(57) **CLAIM**
The ornamental design for toe protector for athletic footwear having removable cleats, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a toe protector for athletic footwear having removable cleats showing our new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a rear view thereof.
The broken lines in the drawings, which illustrate environmental structure or boundaries of the embodiments of the exemplary toe protector for athletic footwear having removable cleats, do not form a part of the claimed design.

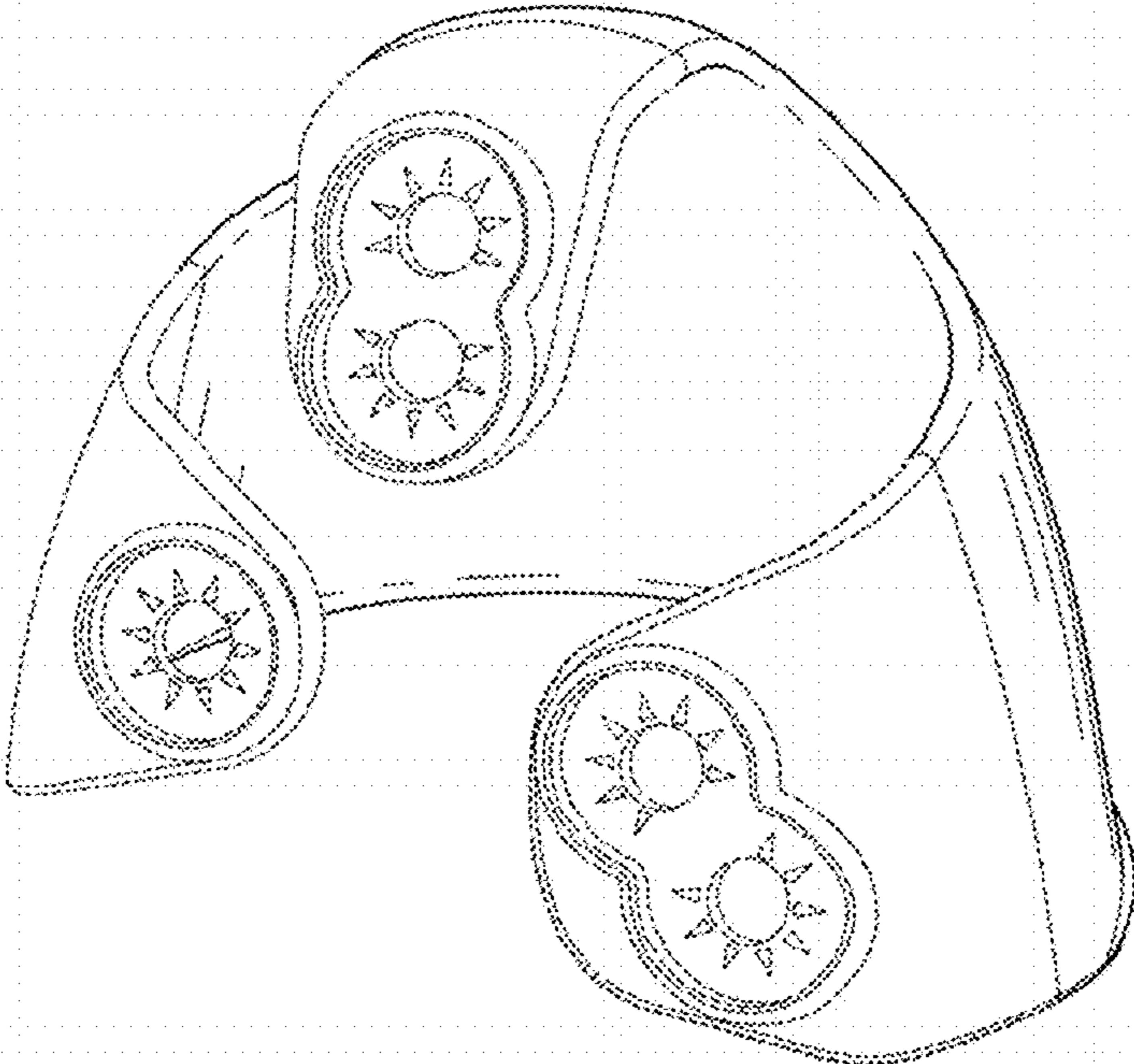

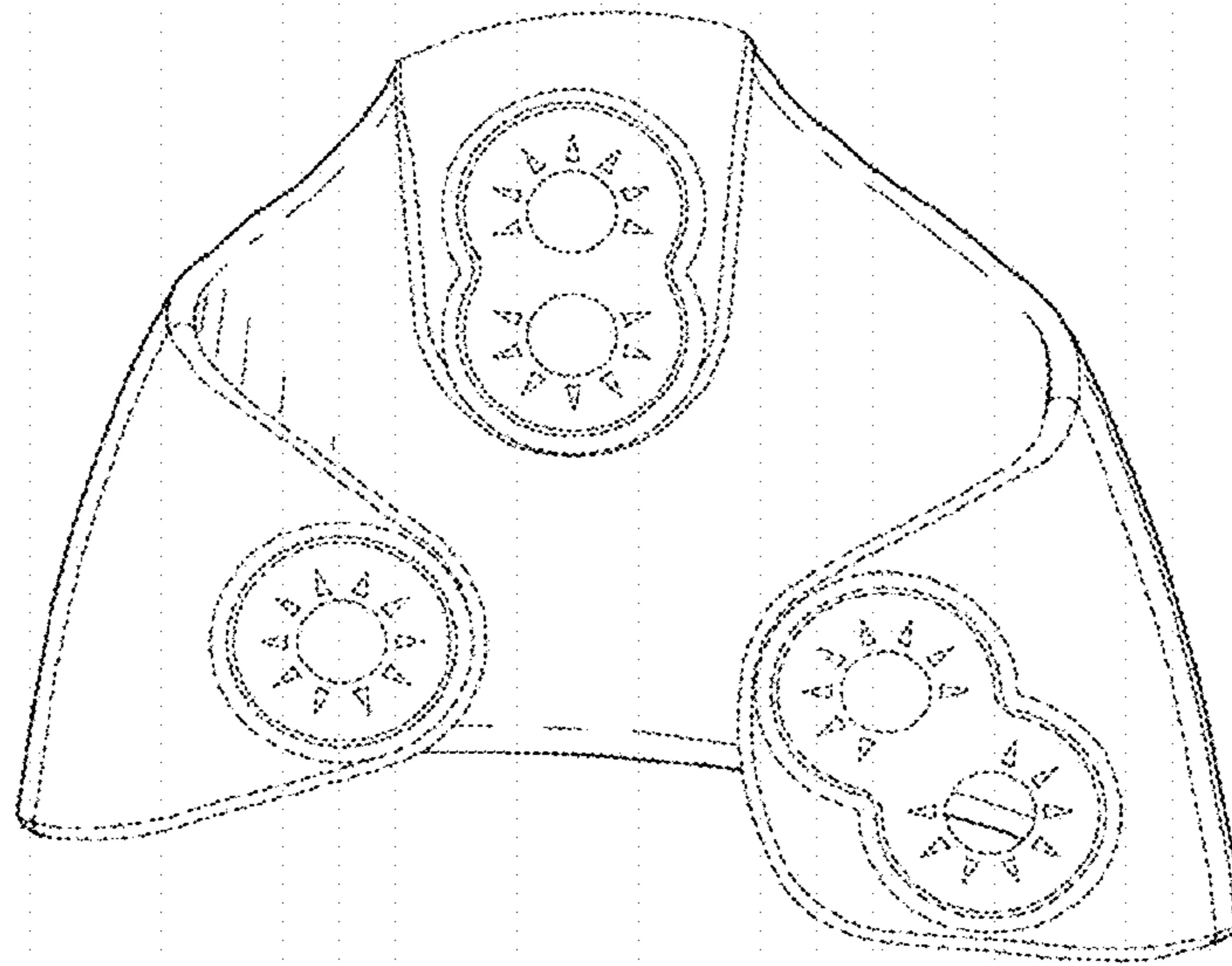

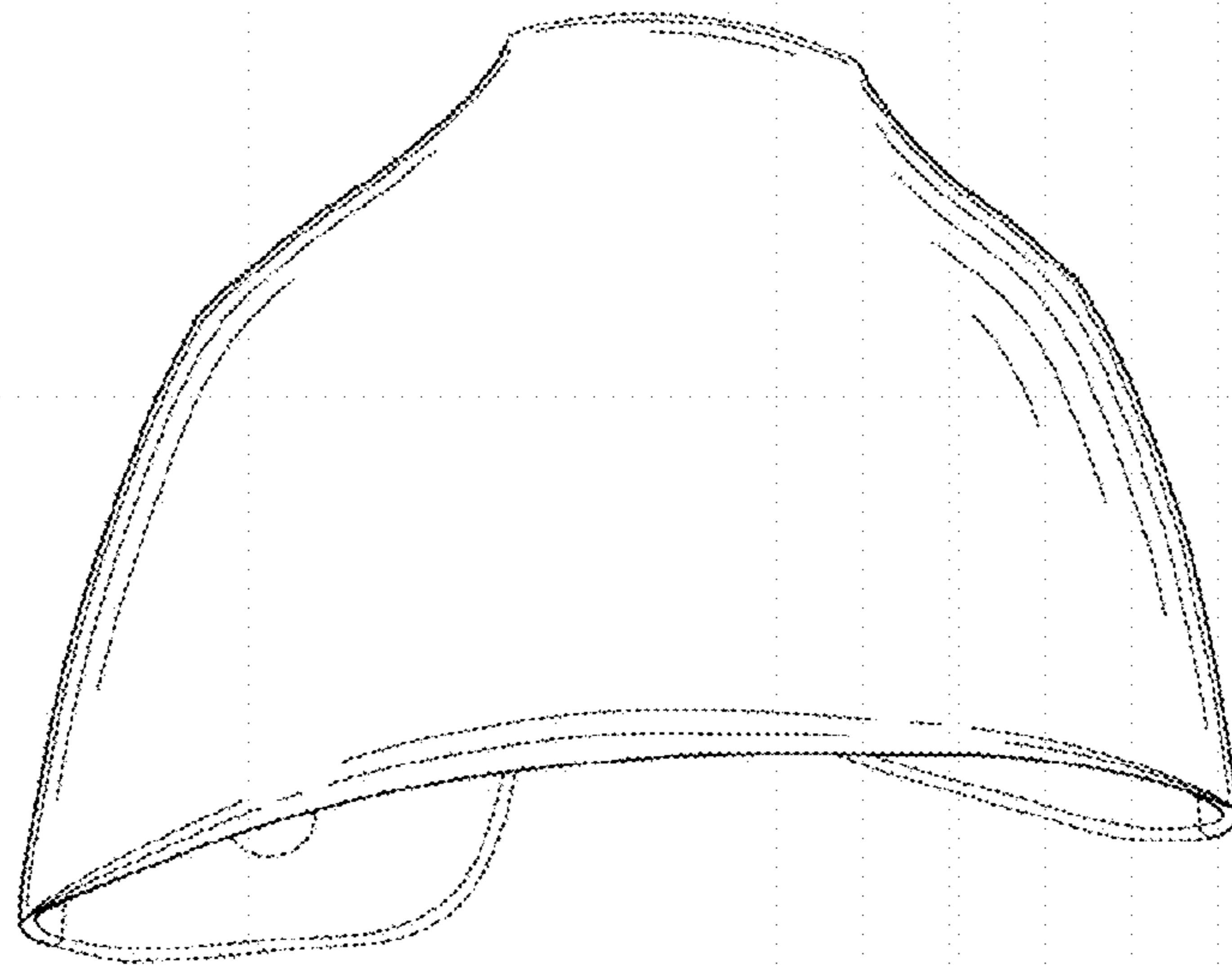

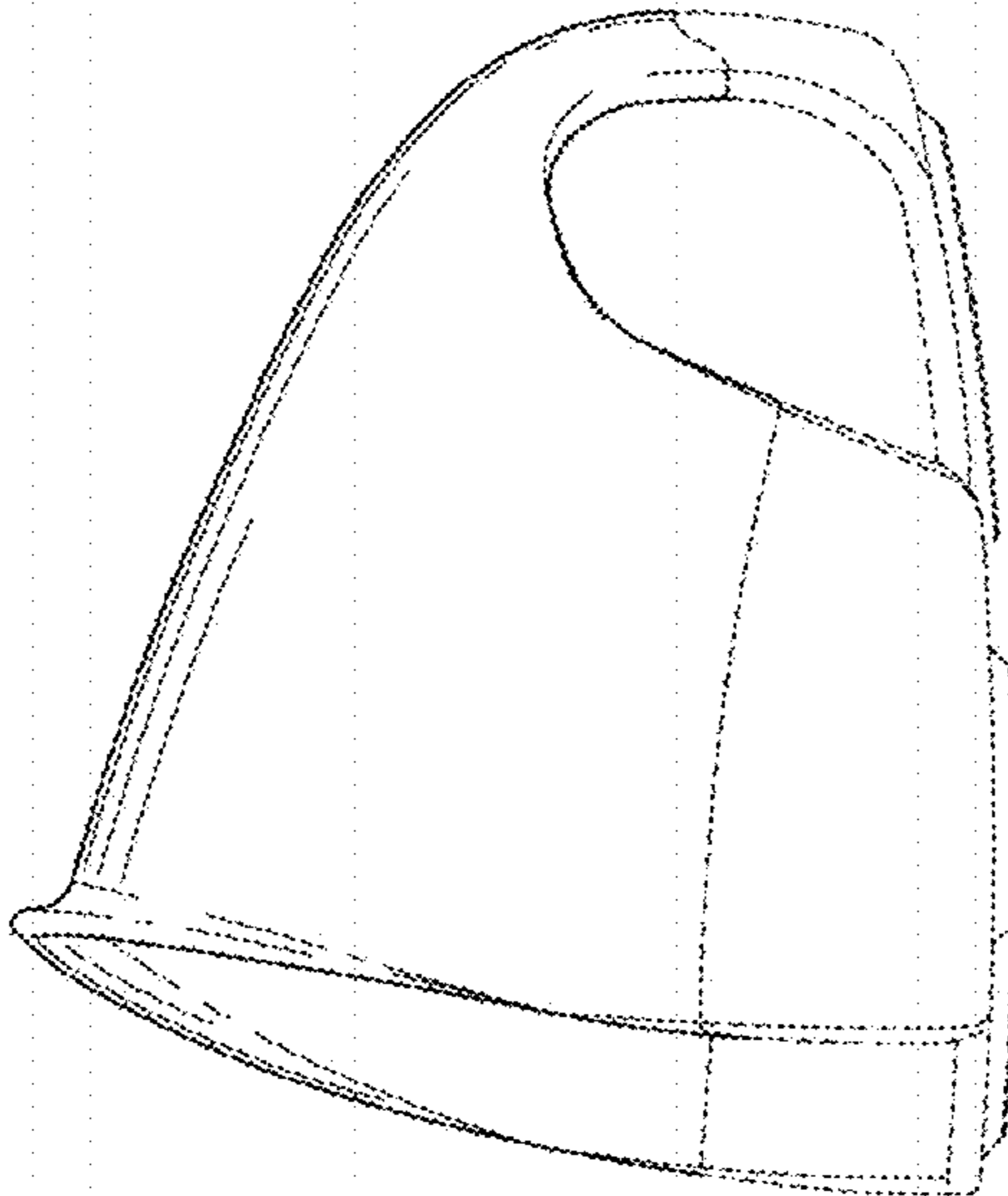

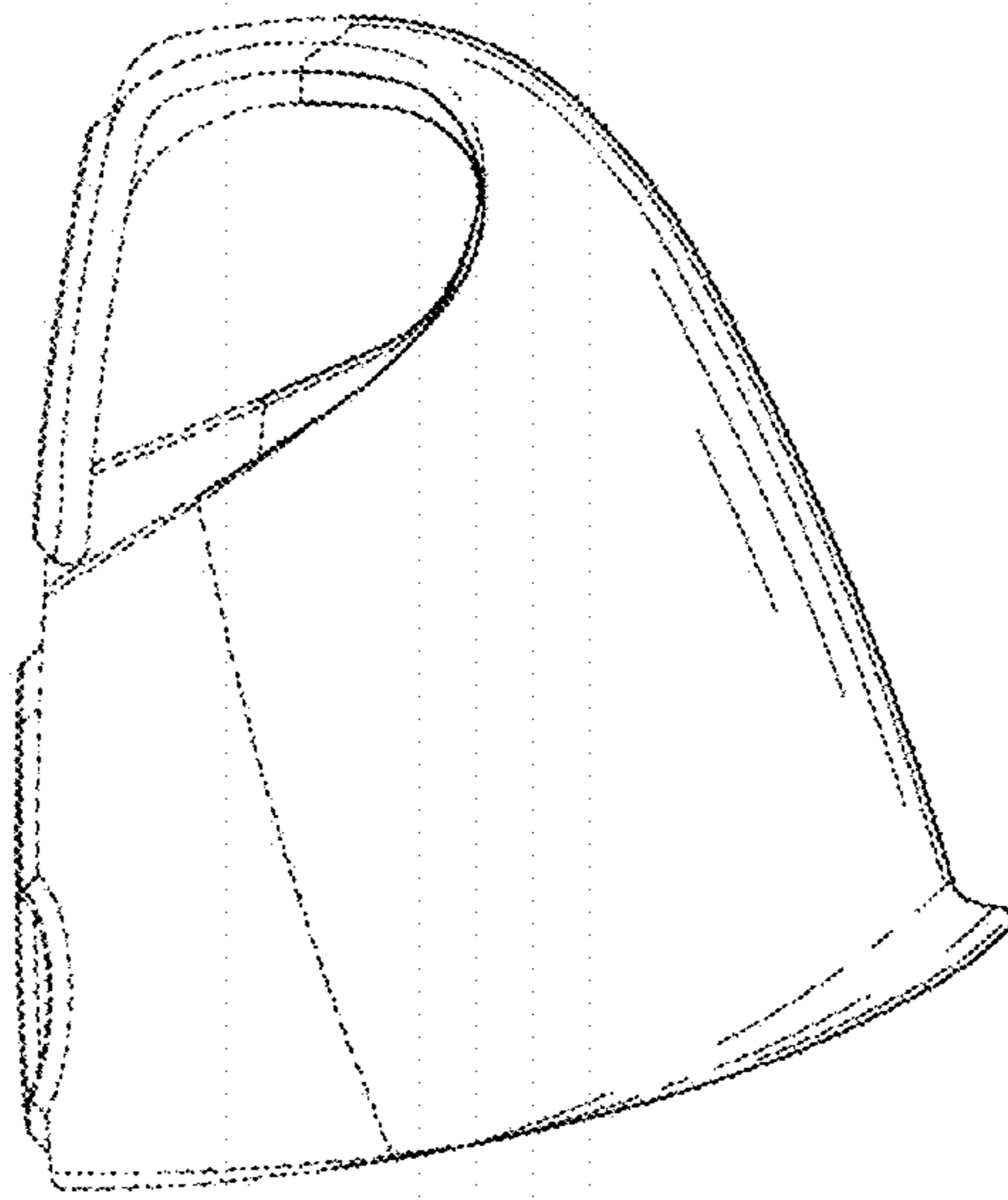

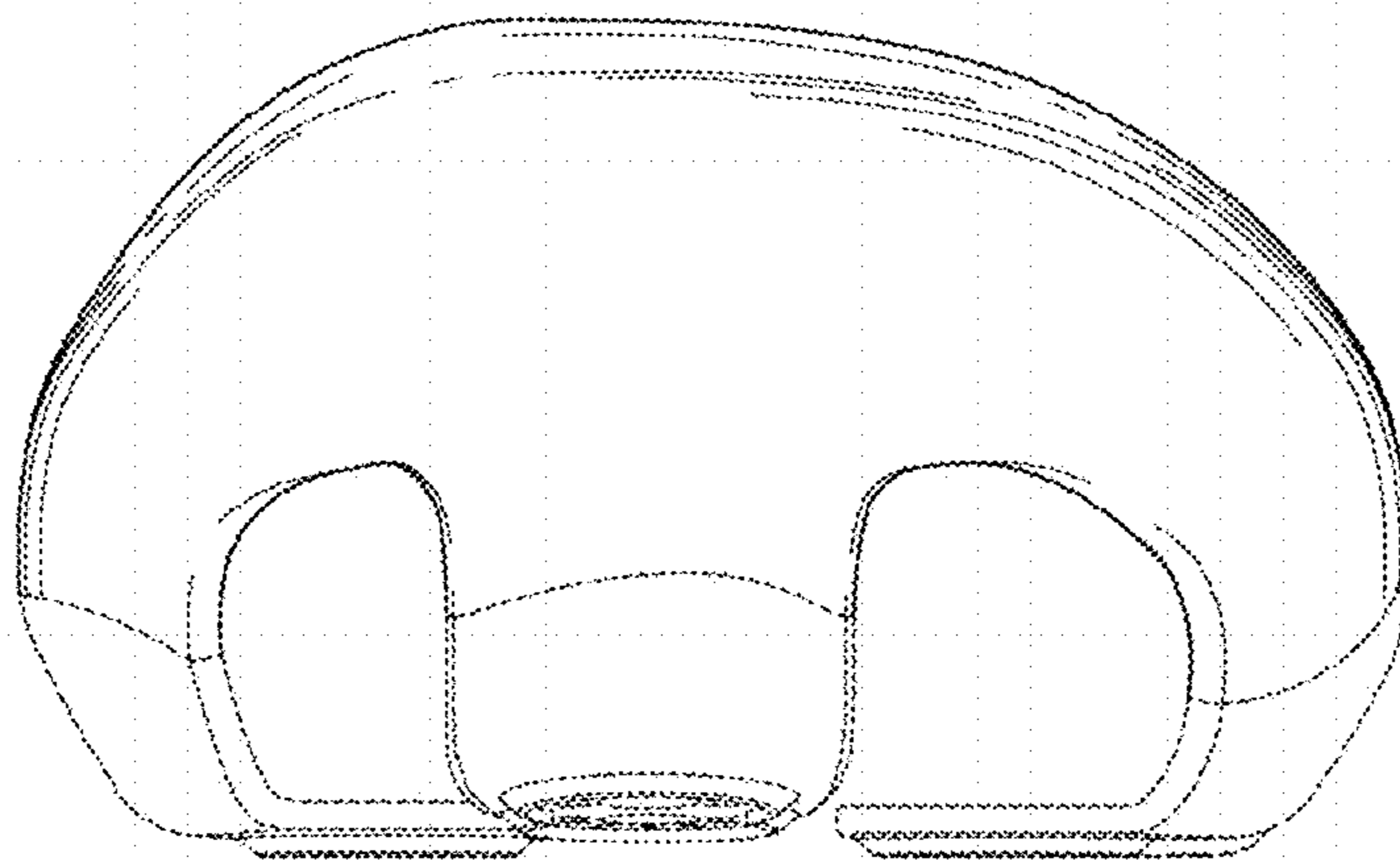

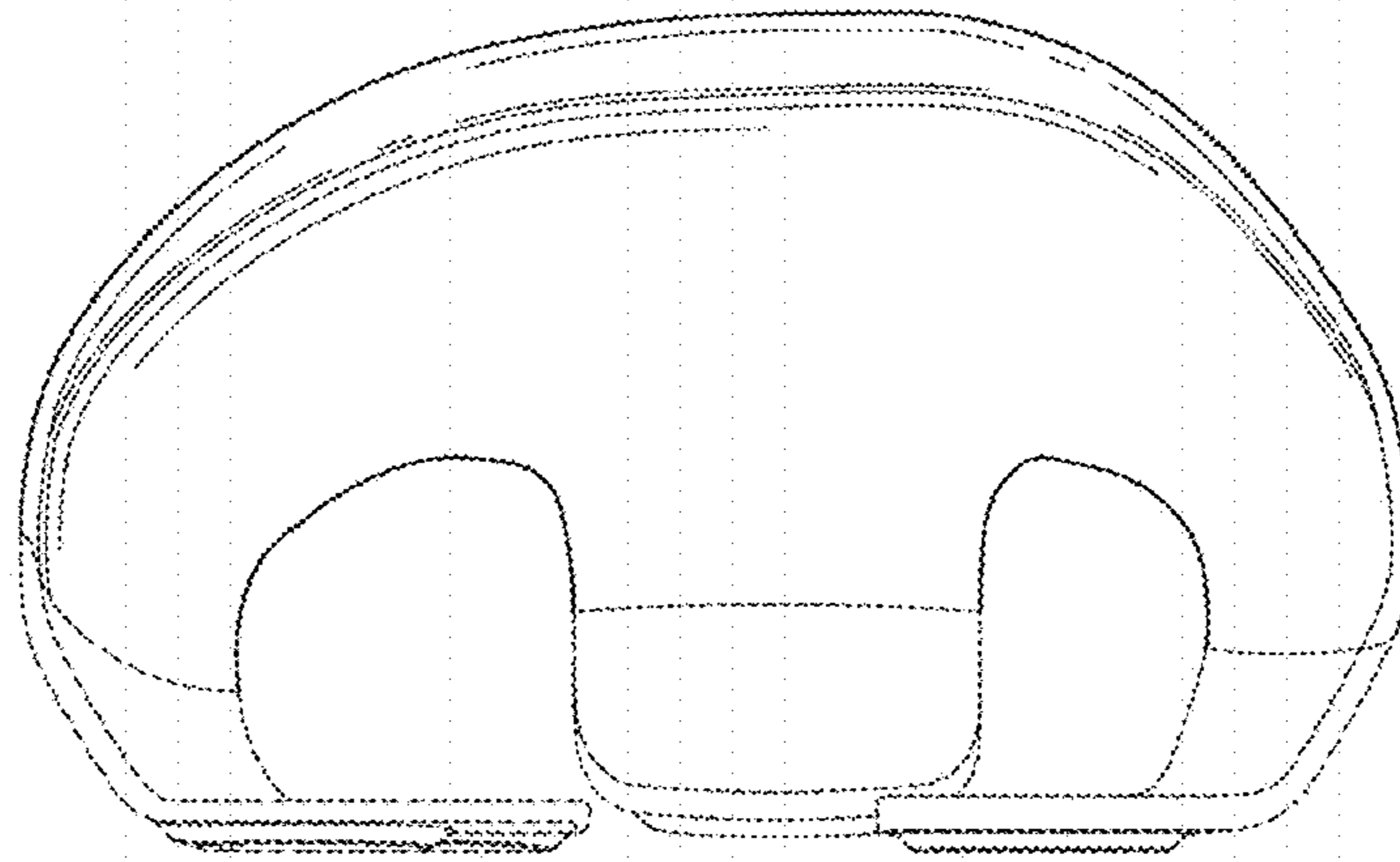
