(57) **CLAIM**

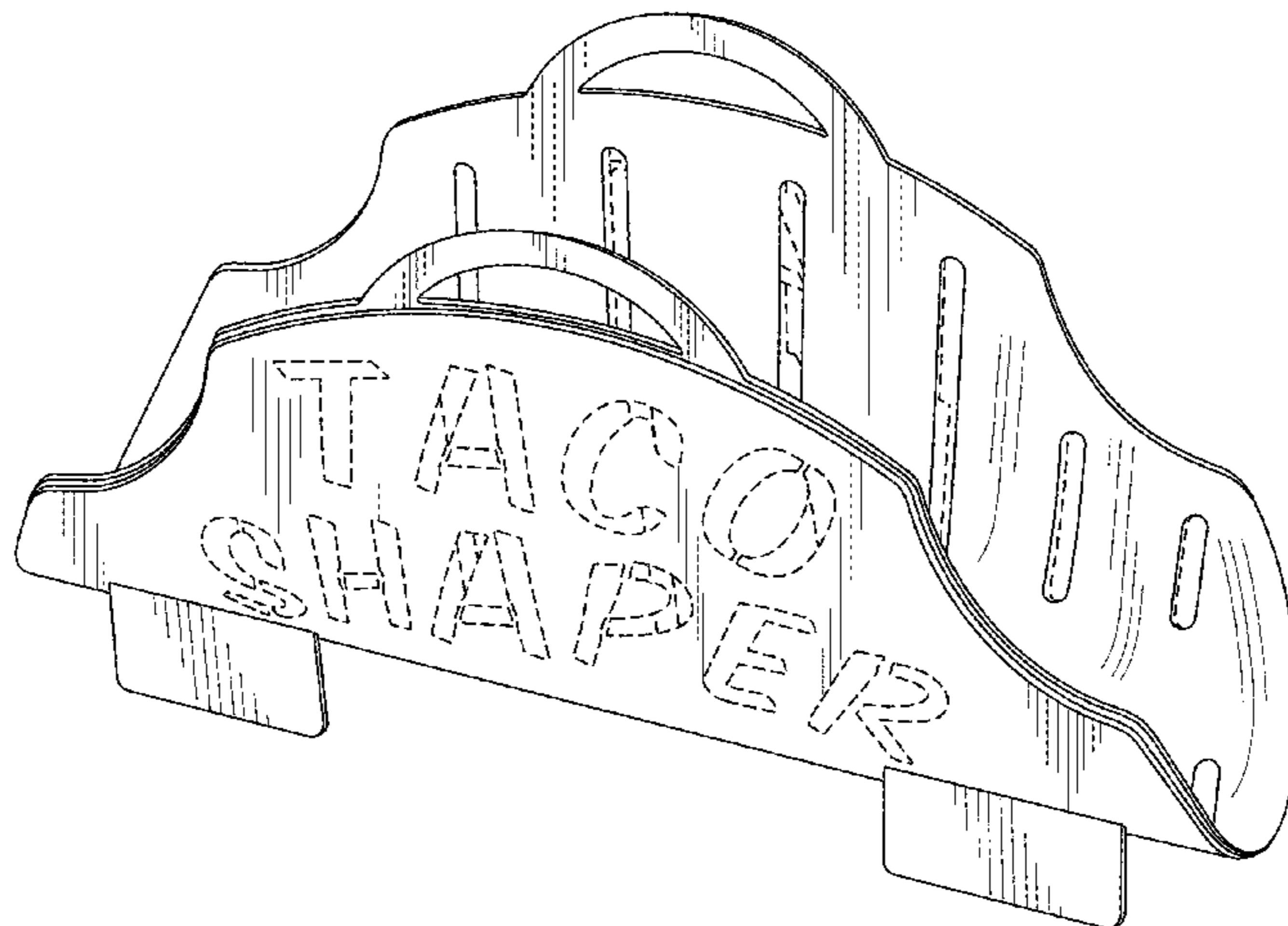
I claim the ornamental design for the taco shaper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the taco shaper;  
FIG. 2 is a front view thereof;

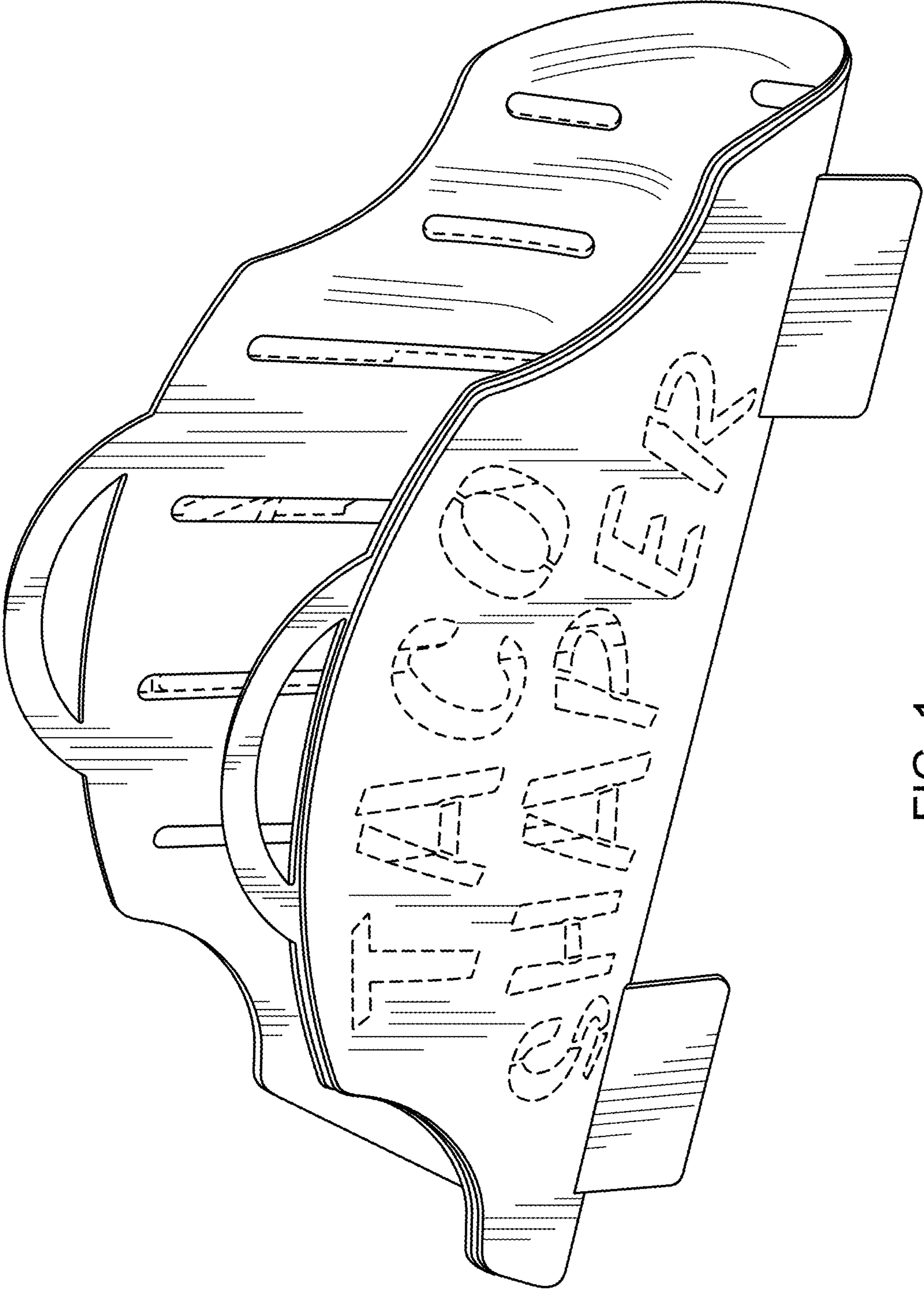

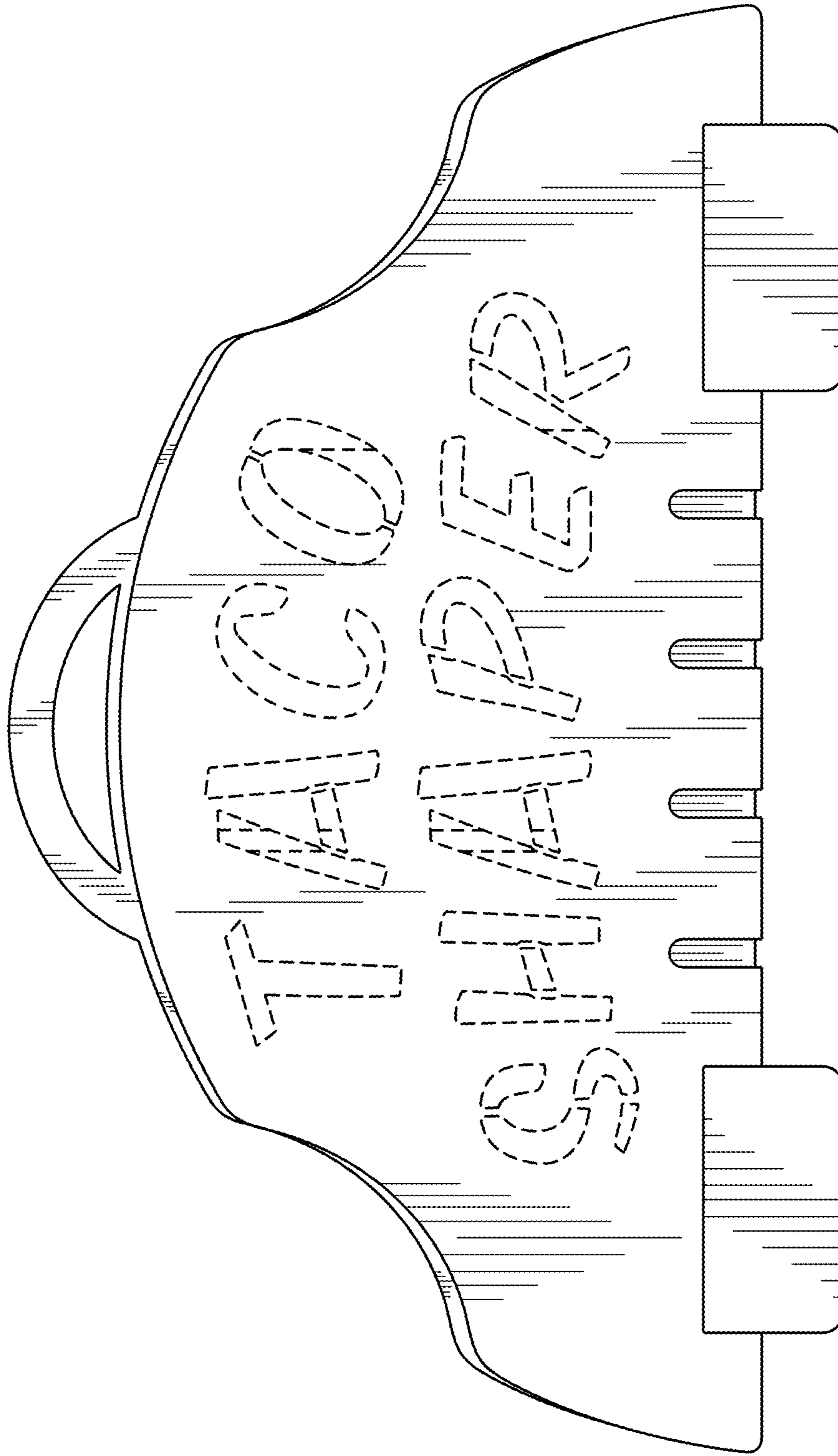

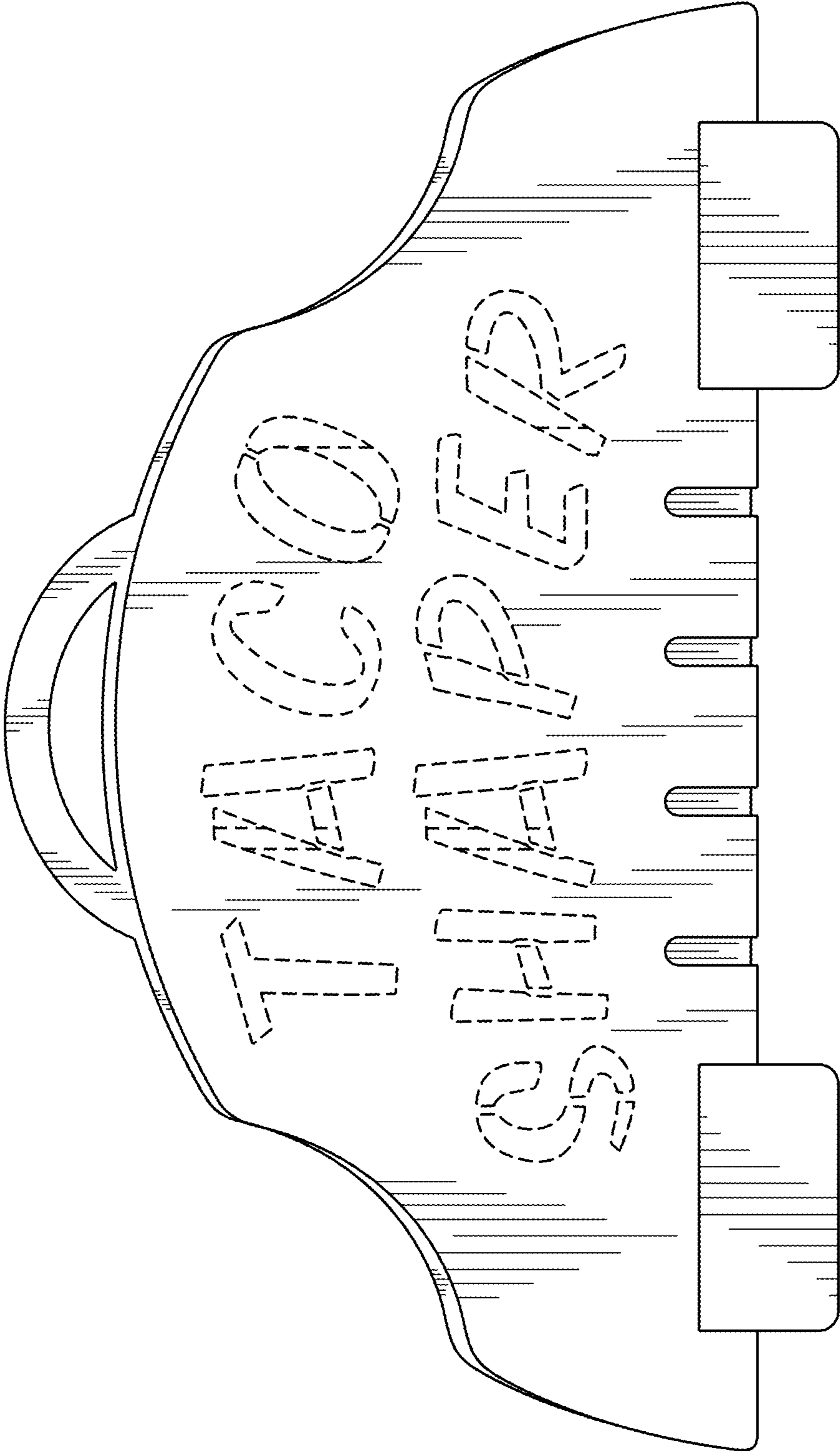

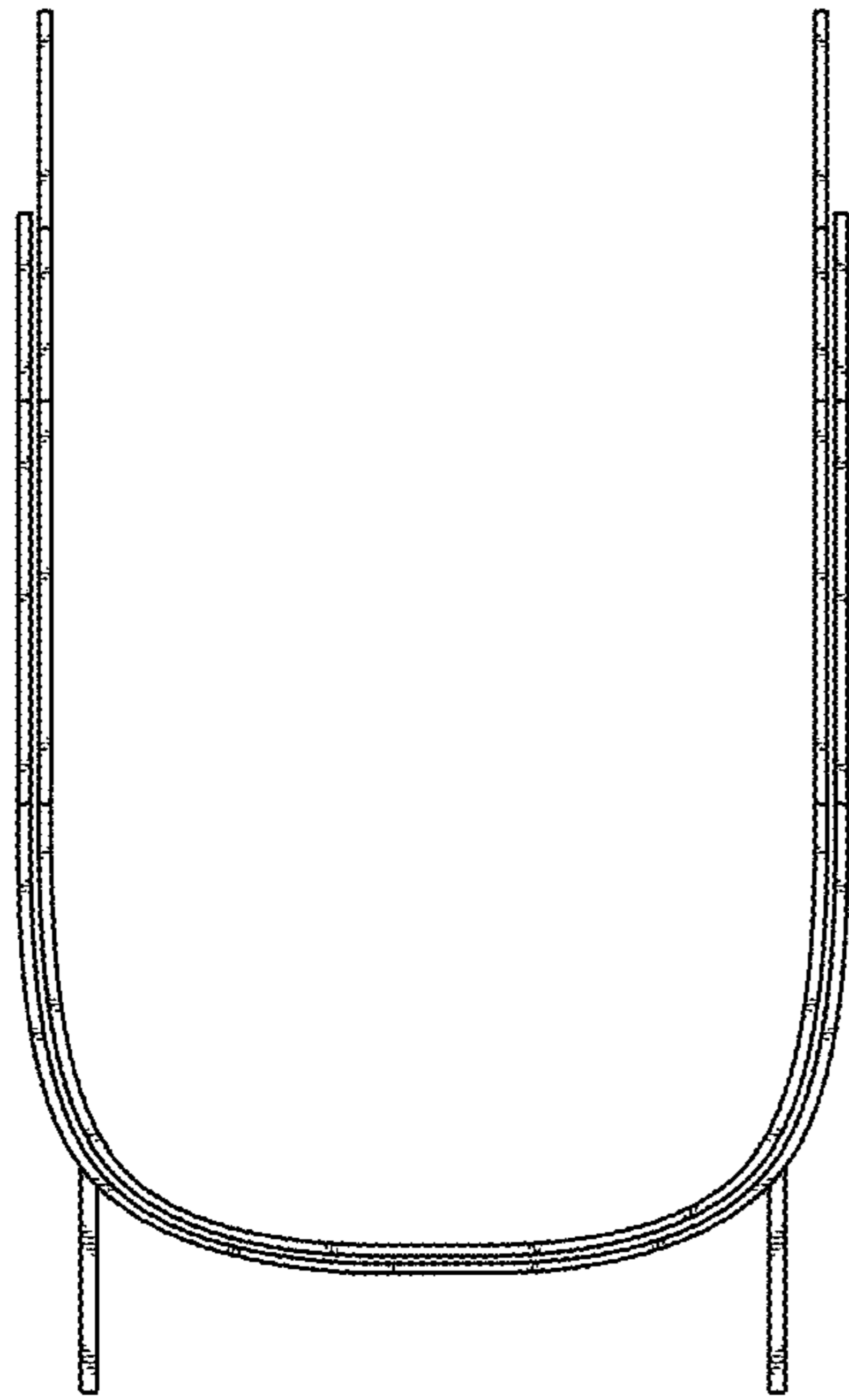

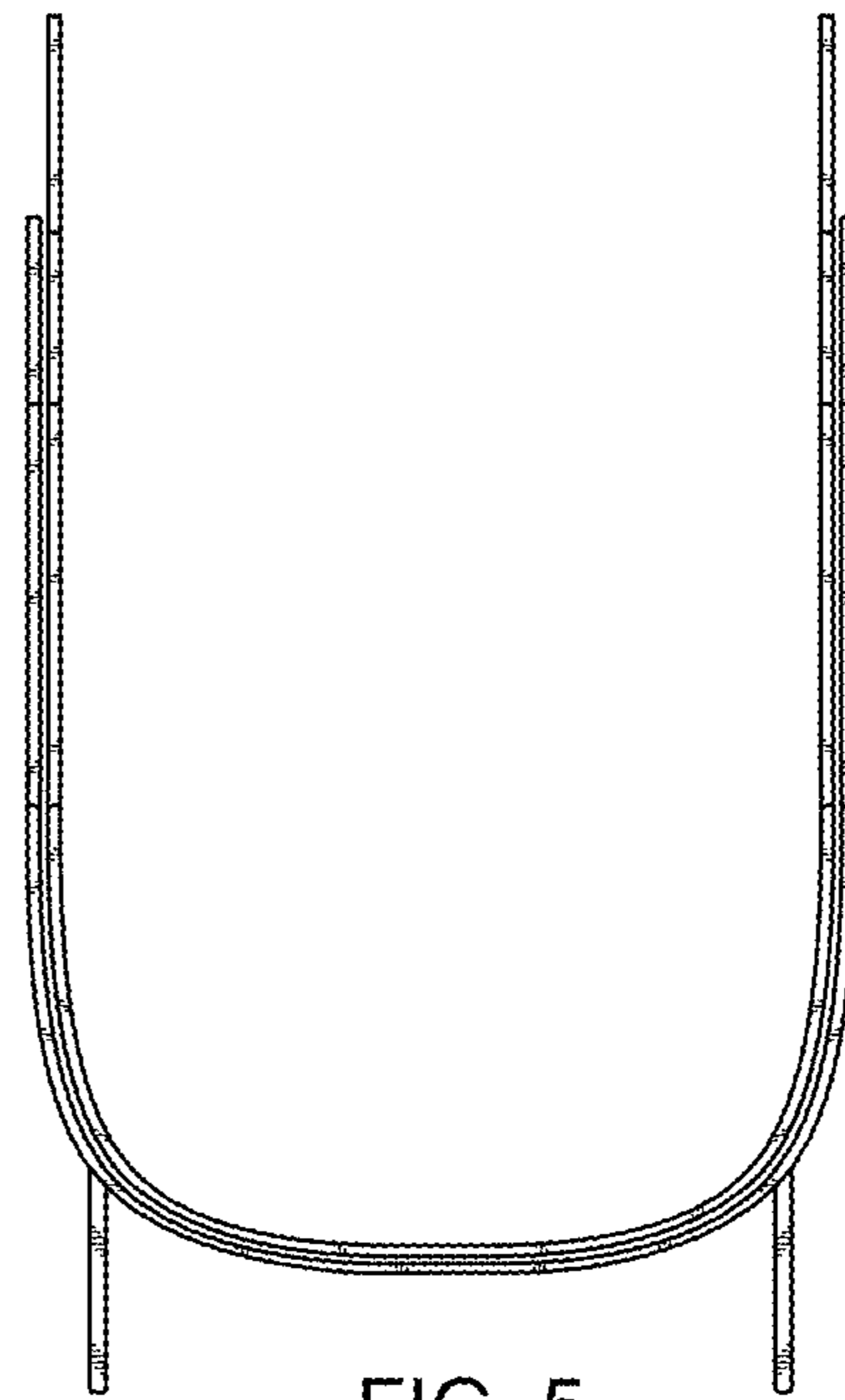

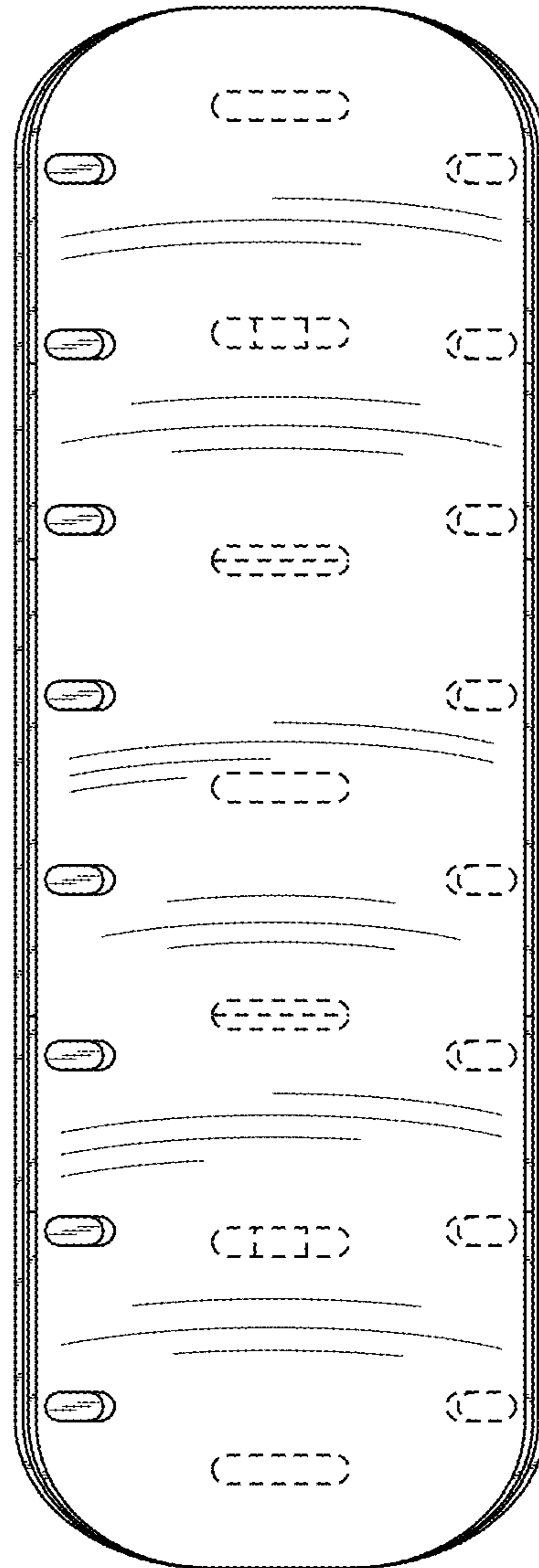

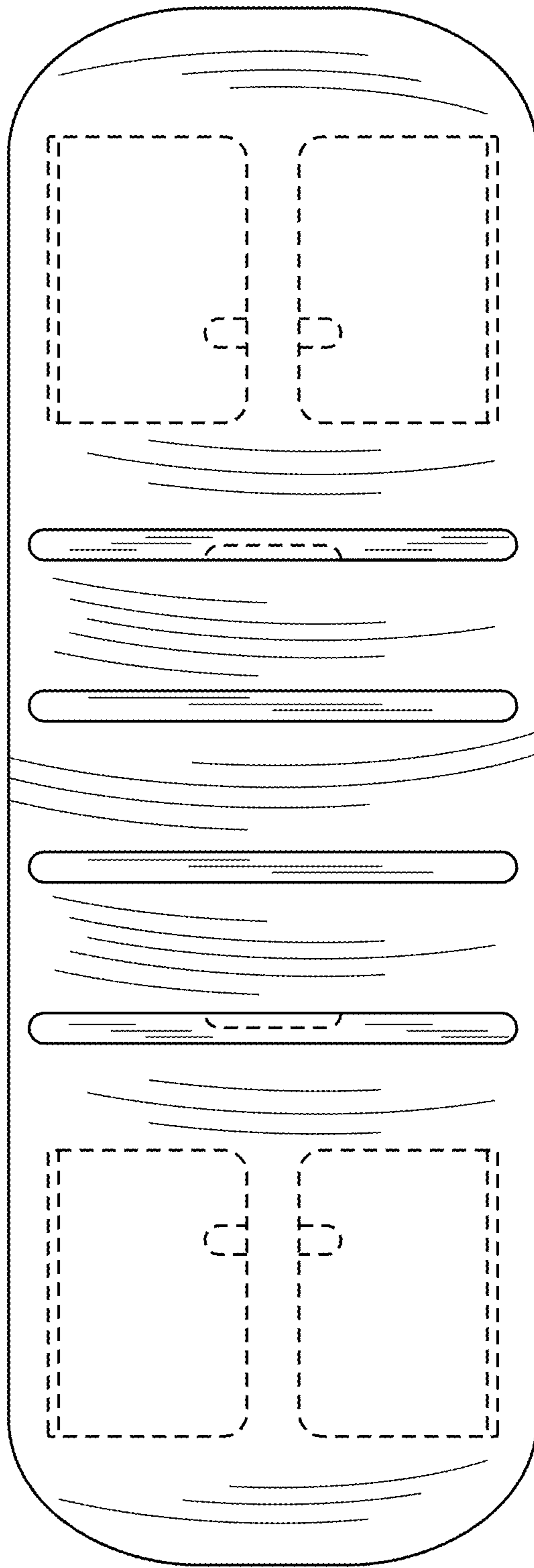
