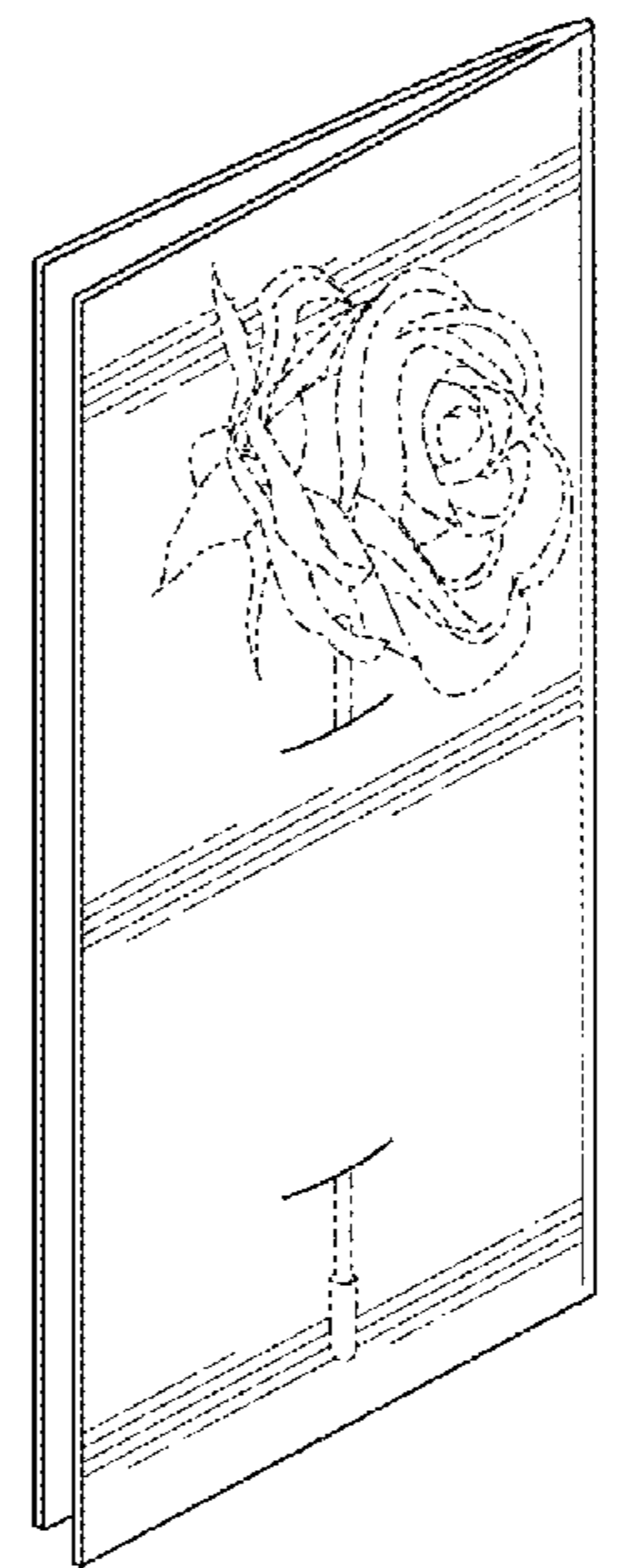

(57) **CLAIM**
The ornamental design for a lapel pin holder for shirt set, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, right perspective view of a lapel pin holder for shirt set showing my new design therefor;
FIG. 2 is a front, top, right perspective view with a lapel pin shown in broken lines and forming no part of the claimed design;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a top plan view thereof, the bottom being identical; and,
FIG. 8 is a perspective view showing my design reduced in scale and in the environment of a shirt set and lapel pin, the shirt set and lapel pin shown in broken lines and forming no part of the claimed design.

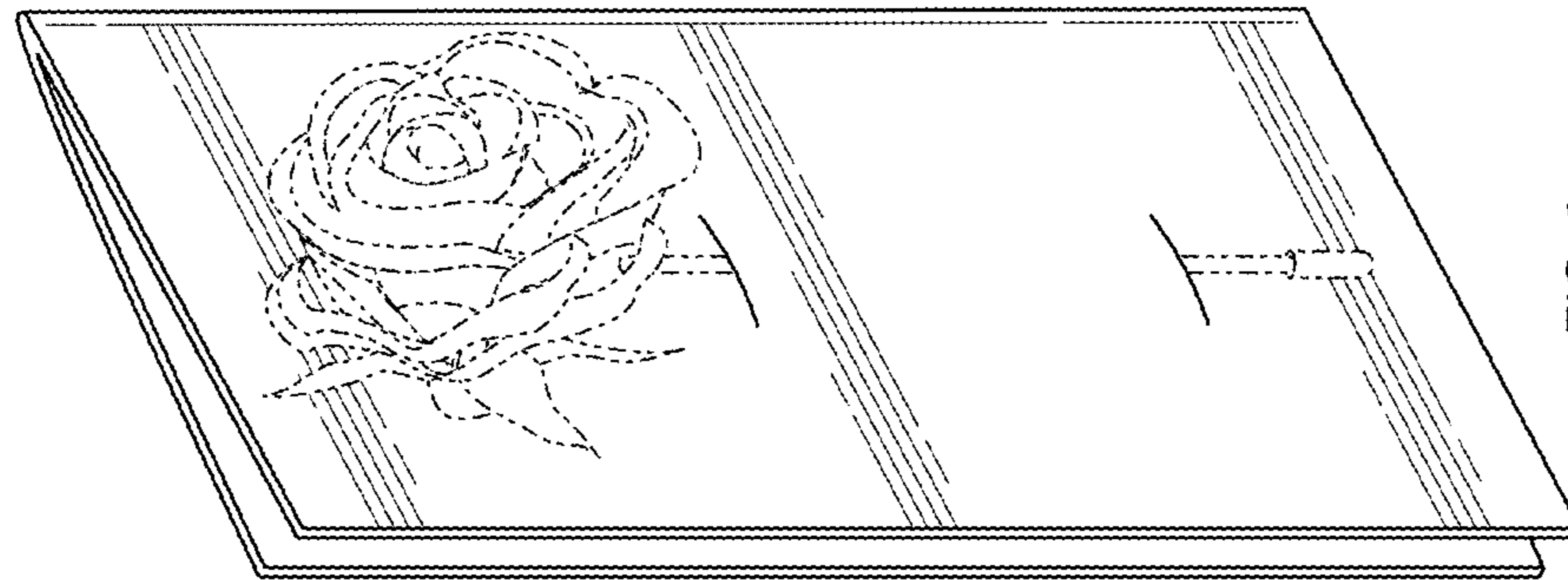

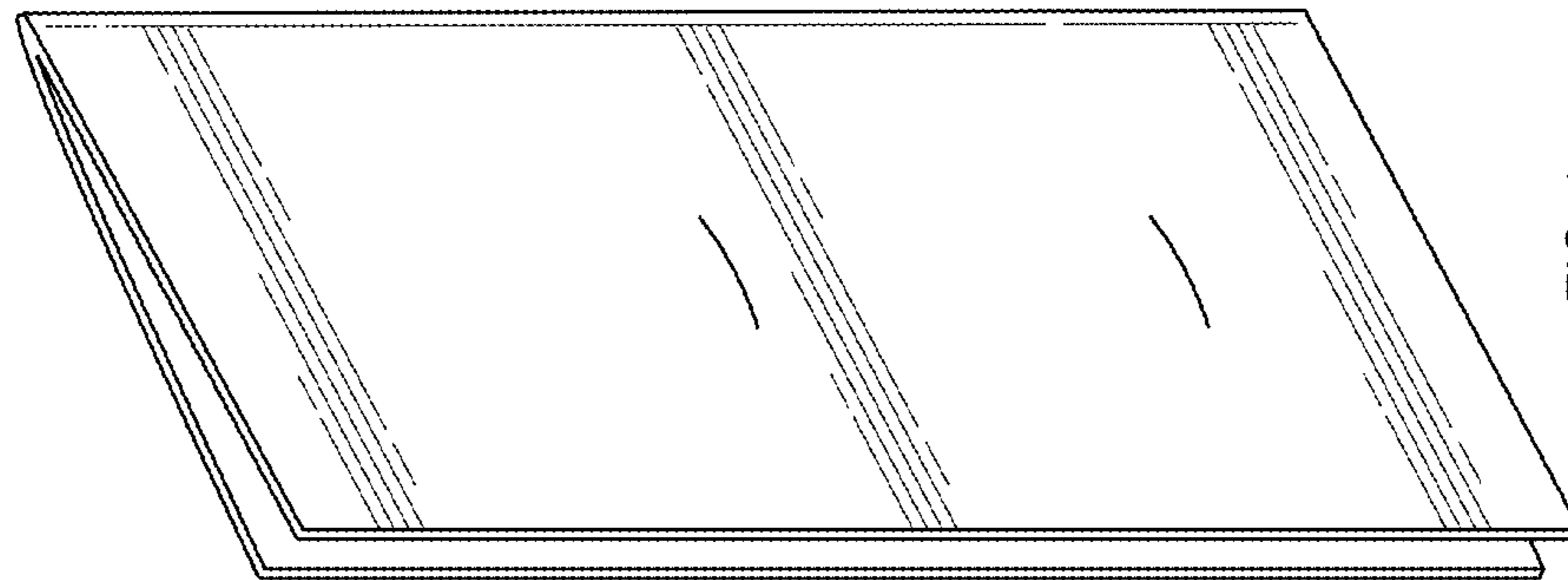

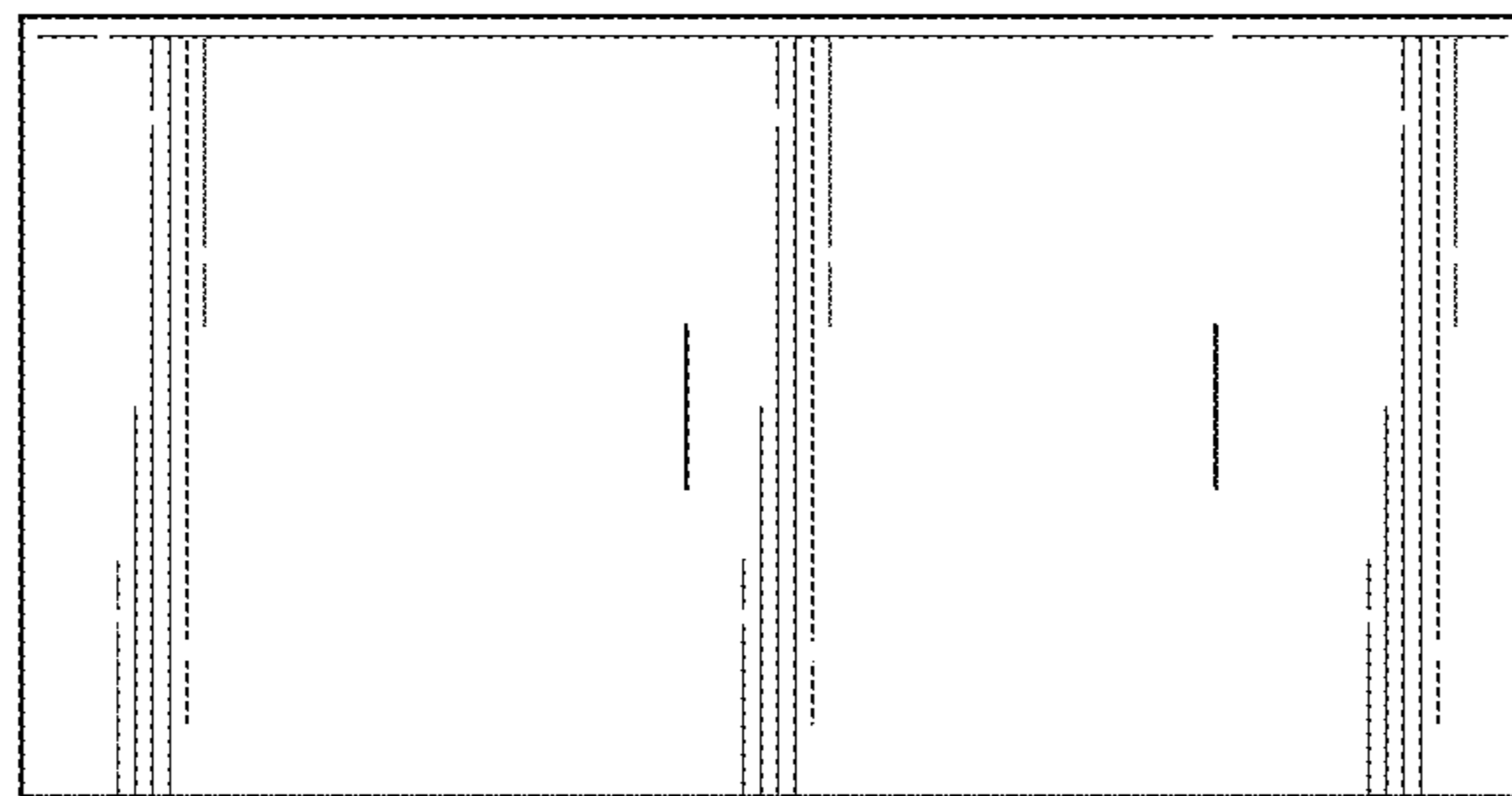

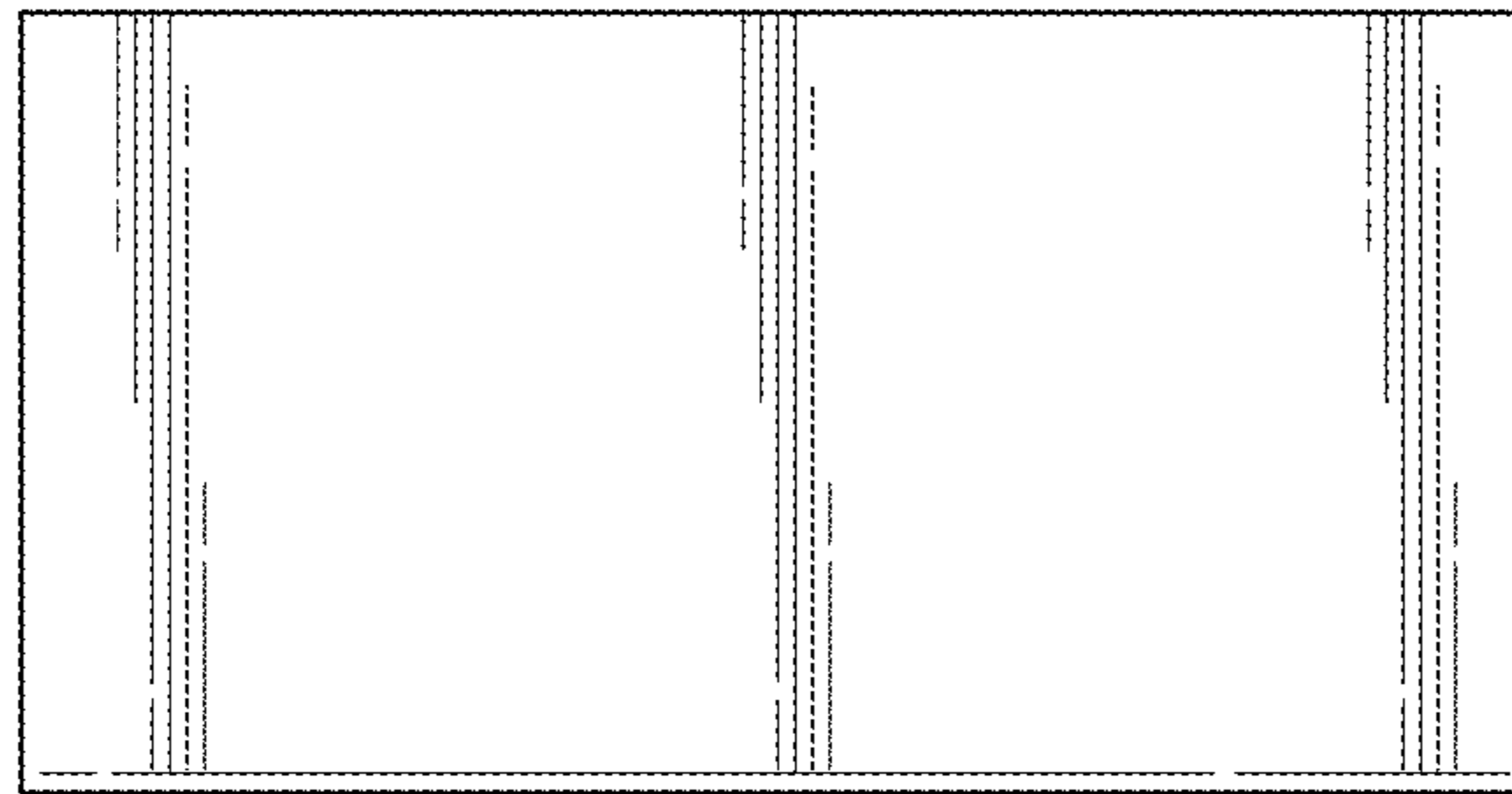

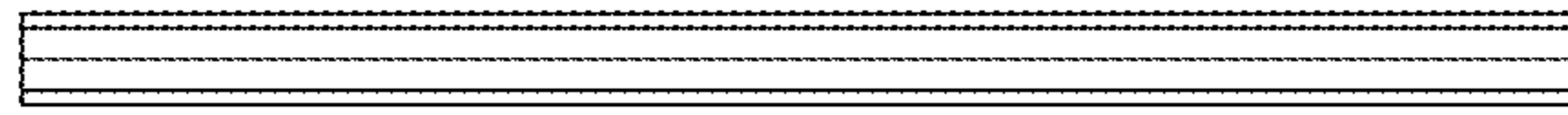

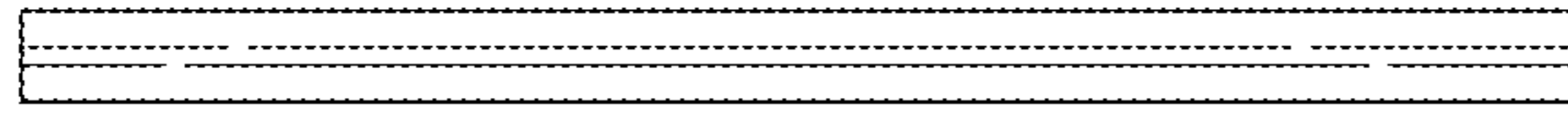

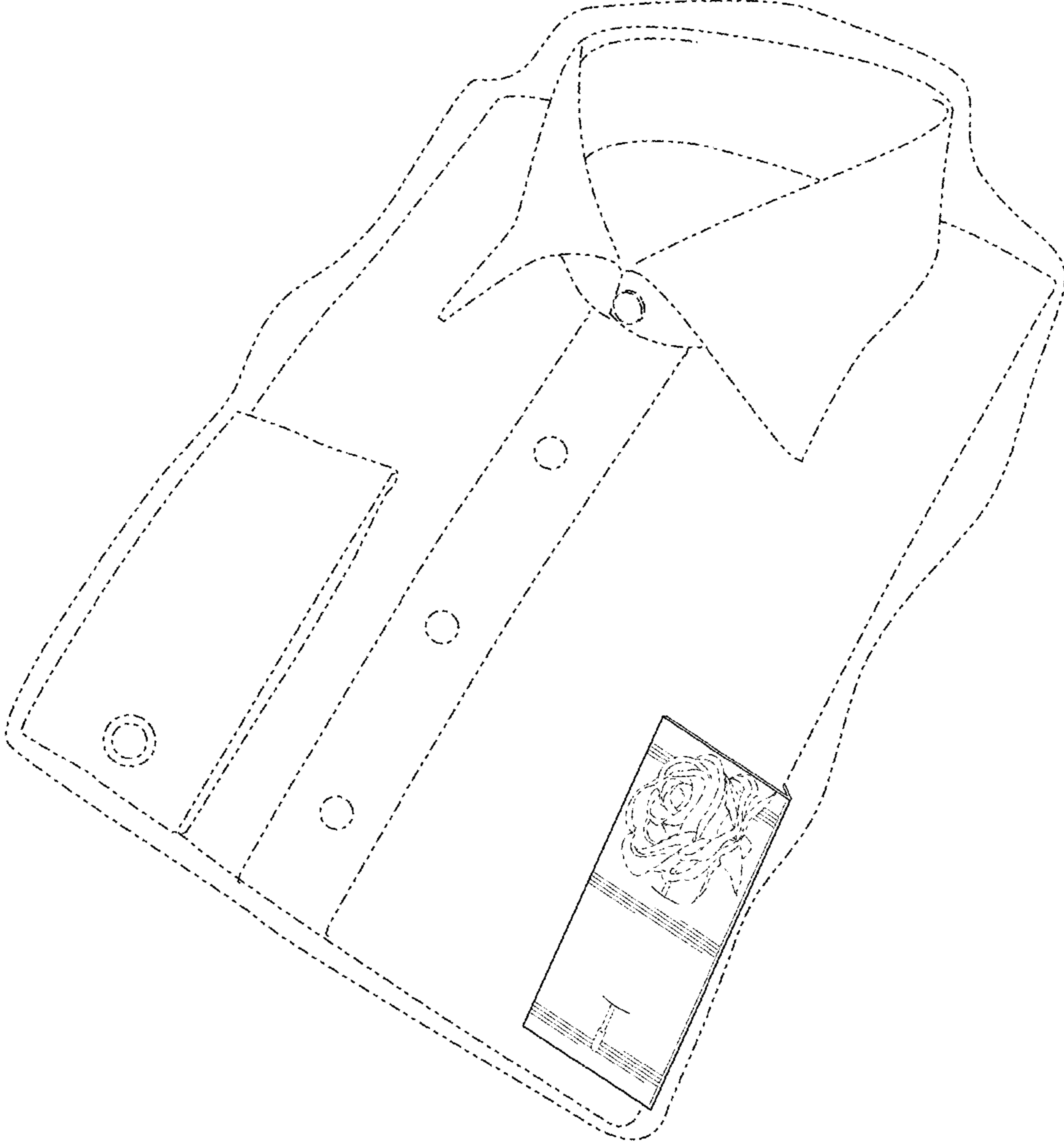
