(57) **CLAIM**

The ornamental design for a glass container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a glass container showing the new design.

FIG. 2 is a rear perspective view of the first embodiment.

FIG. 3 is a front view of the first embodiment. The rear view (not shown) is a mirror image.

FIG. 4 is a right side view of the first embodiment. The left side (not shown) is a mirror image.

FIG. 5 is a top view of the first embodiment.

FIG. 6 is a front perspective view of a second embodiment of a glass container showing the new design.

FIG. 7 is a rear perspective view of the second embodiment.

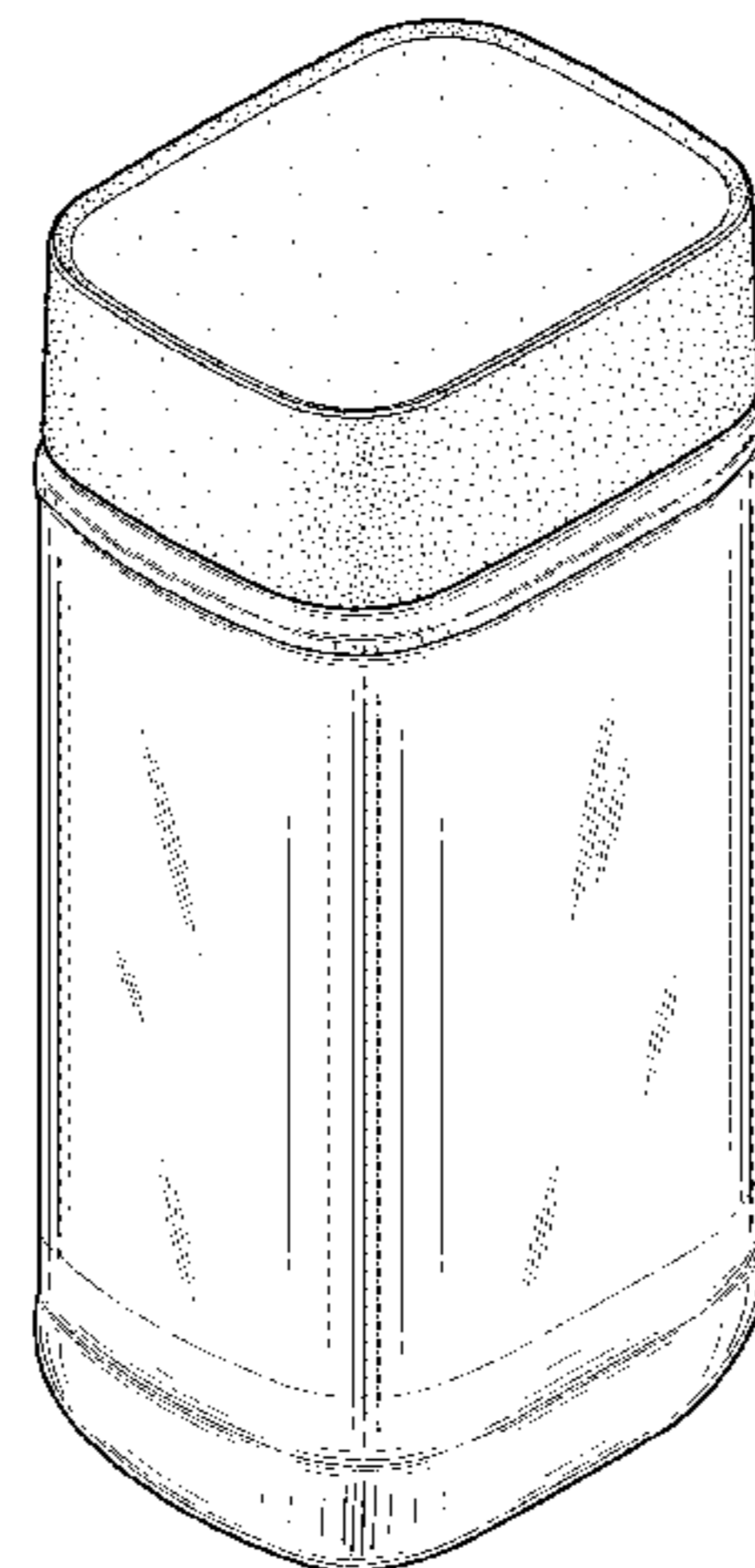
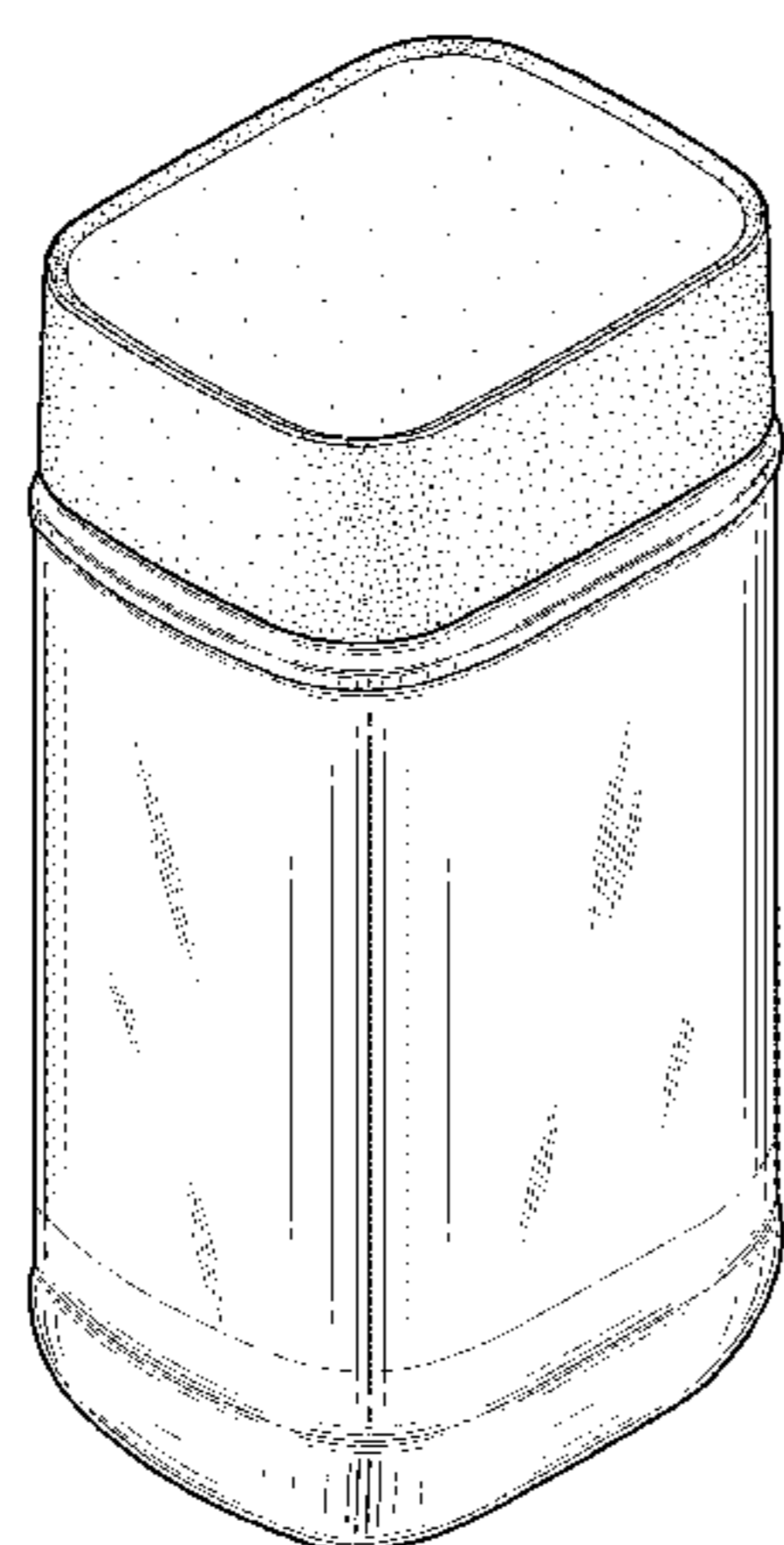
FIG. 8 is a front view of the second embodiment. The rear view (not shown) is a mirror image.

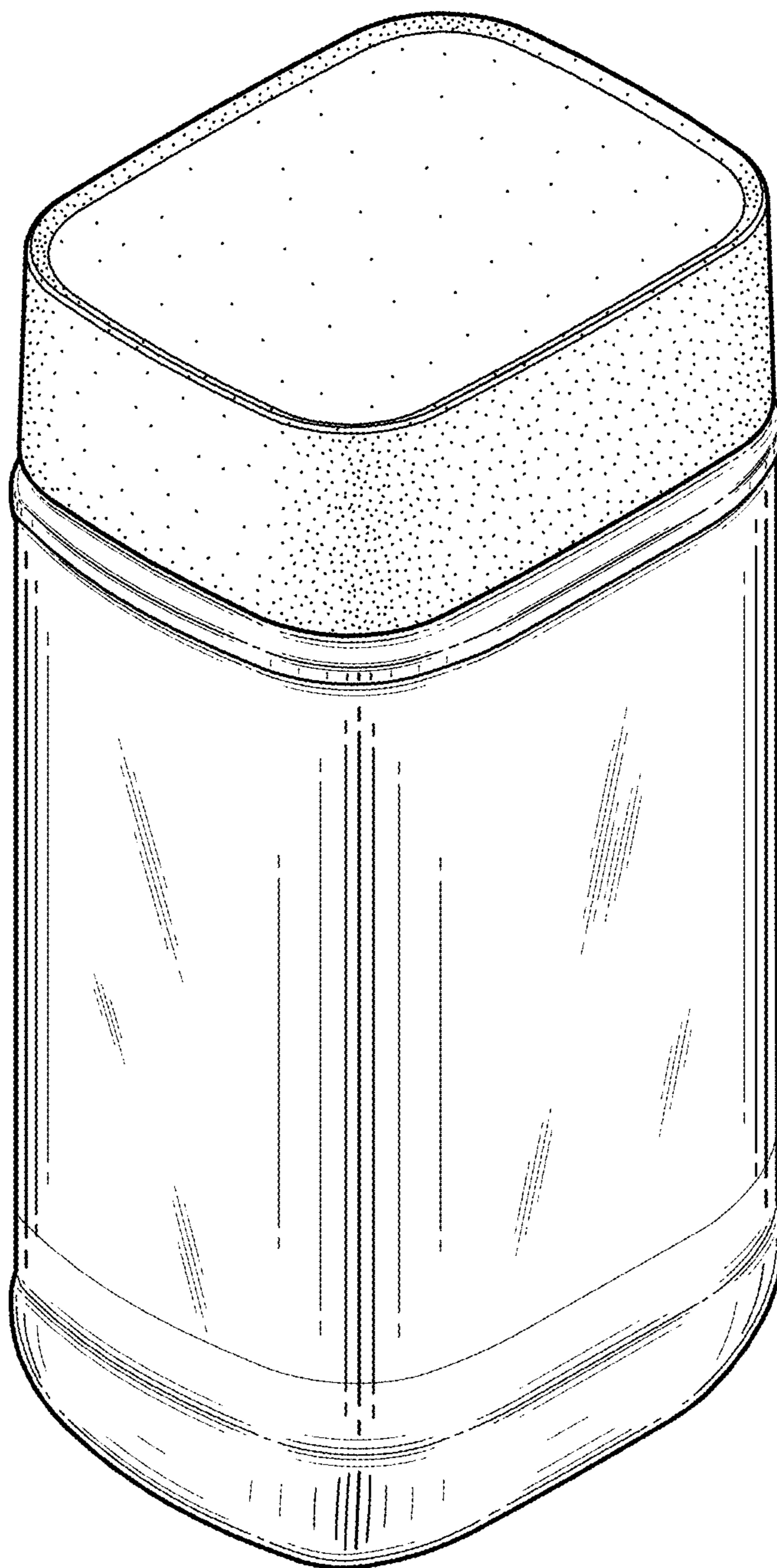

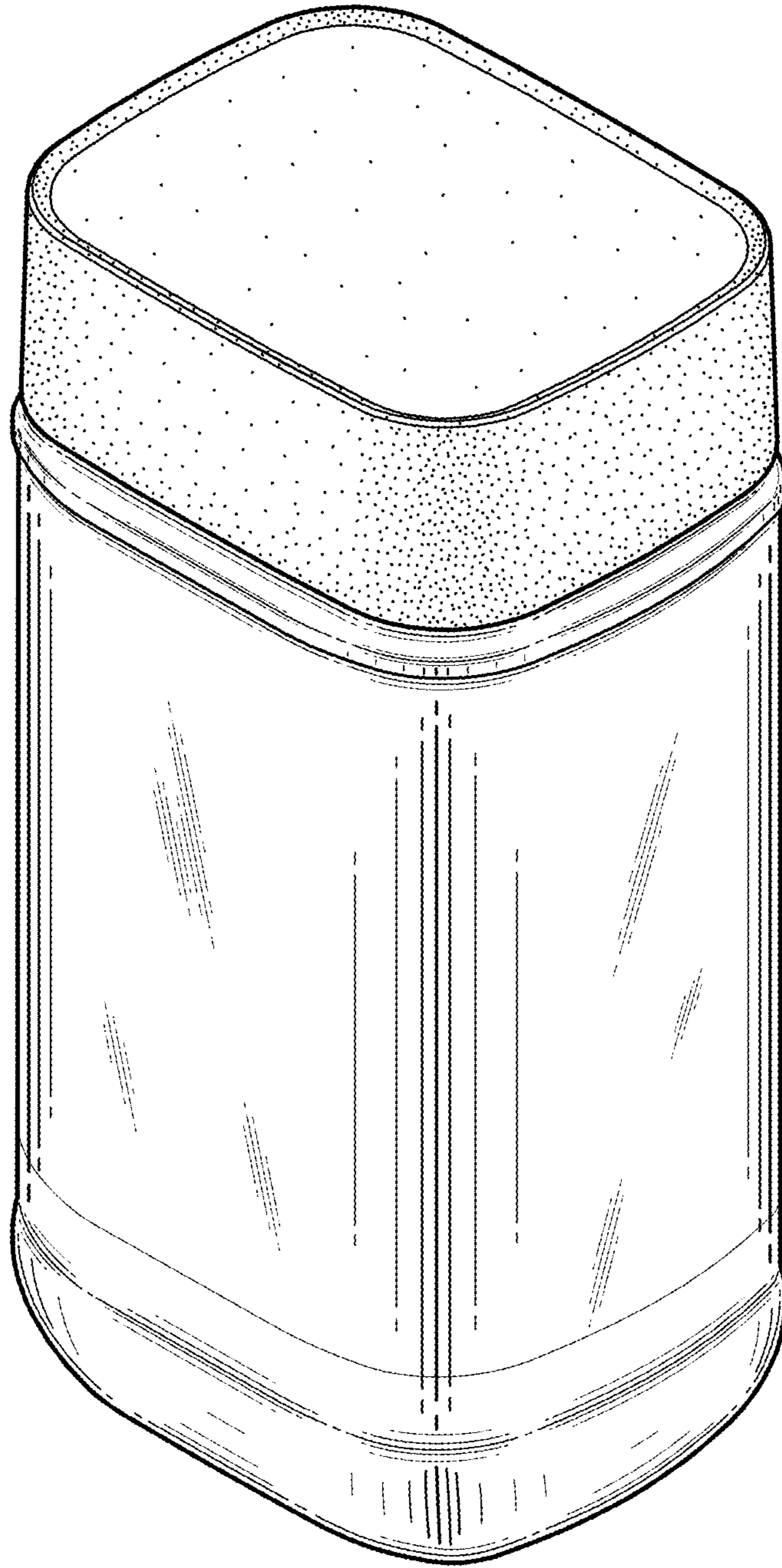

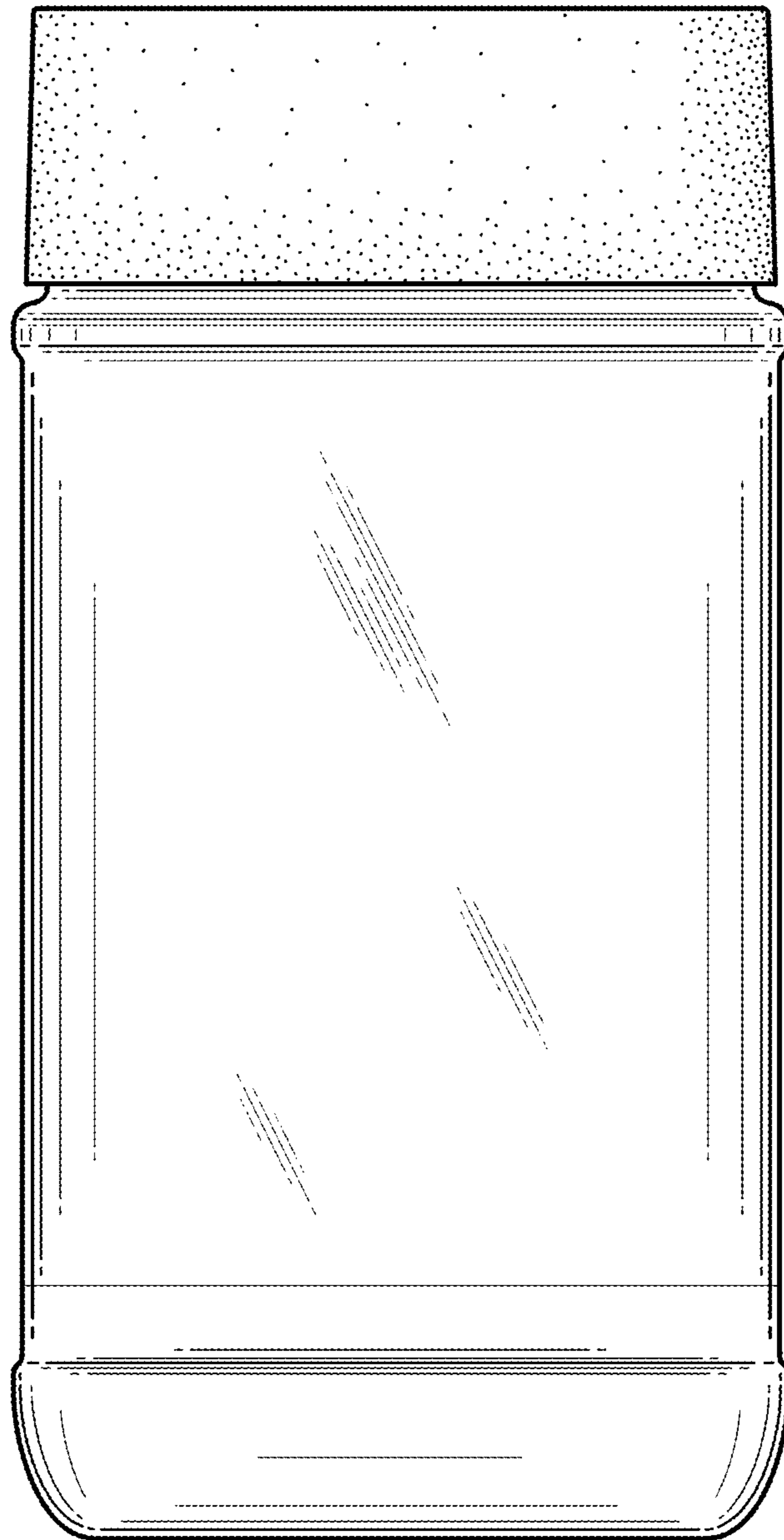

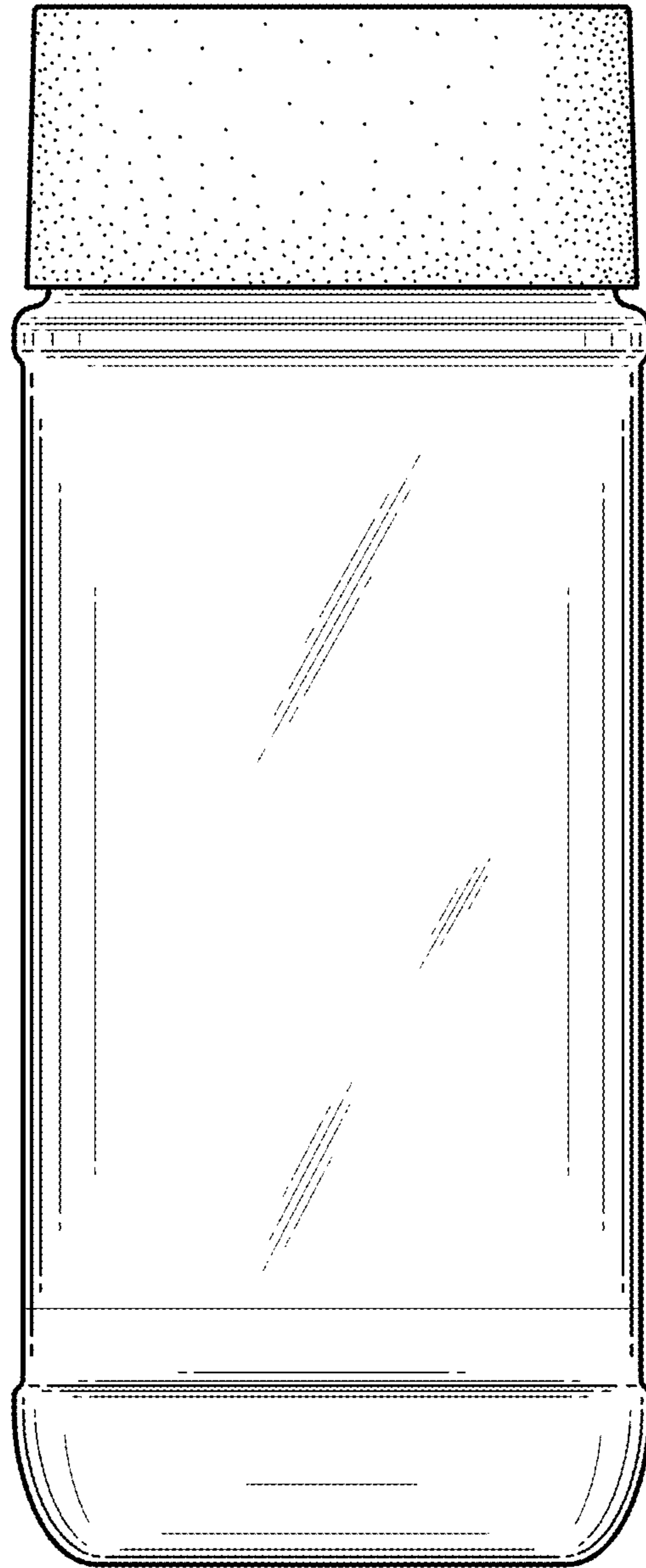

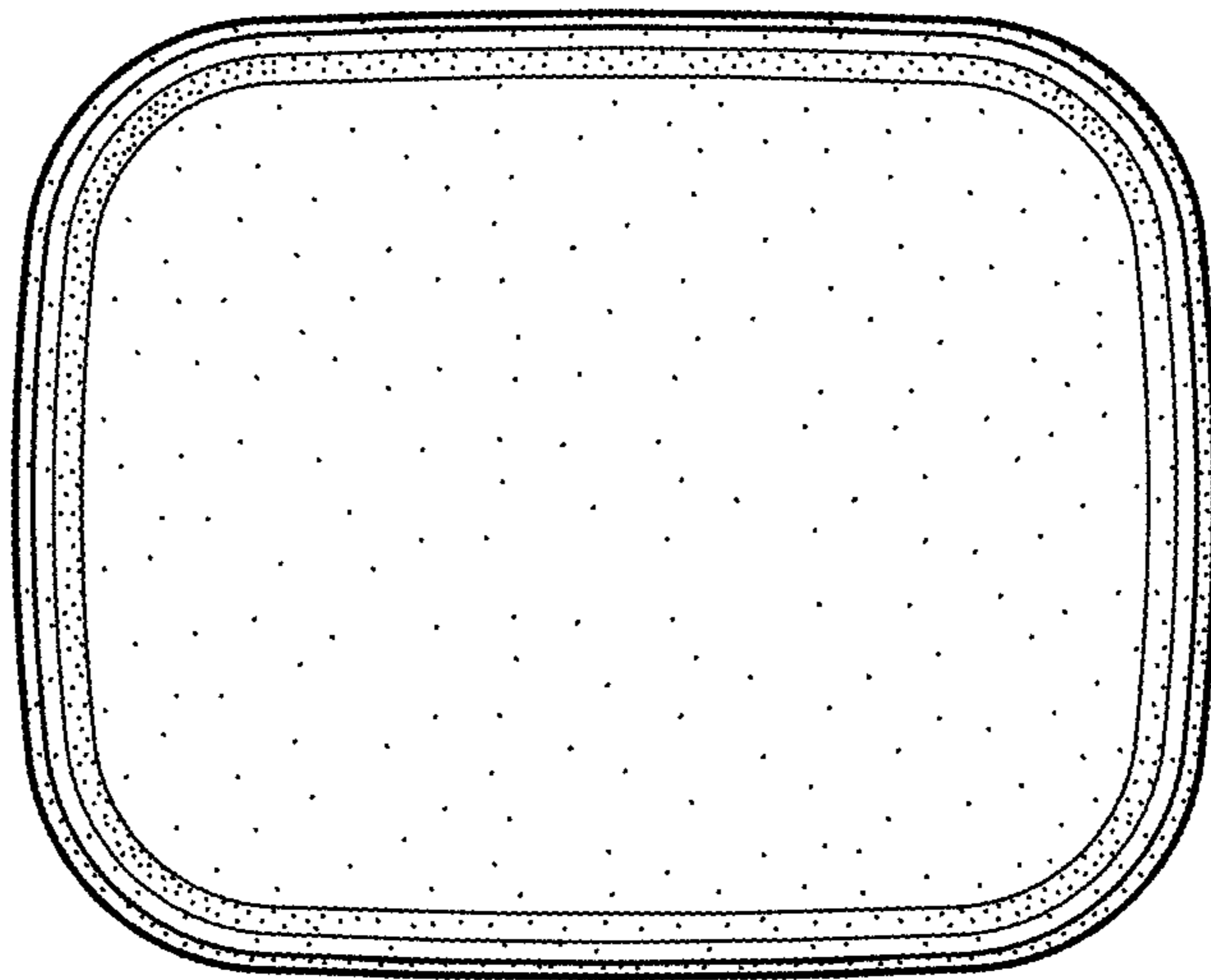

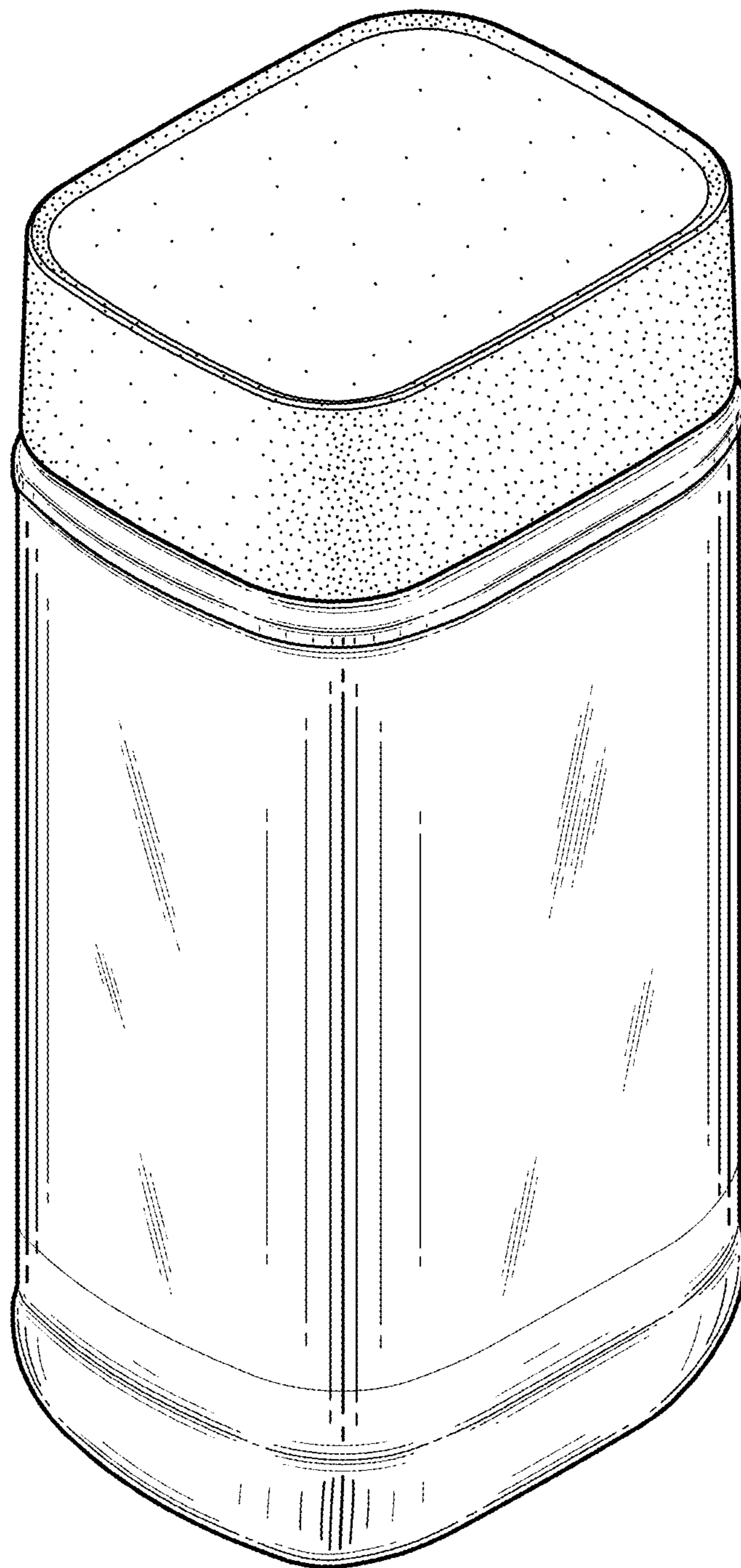

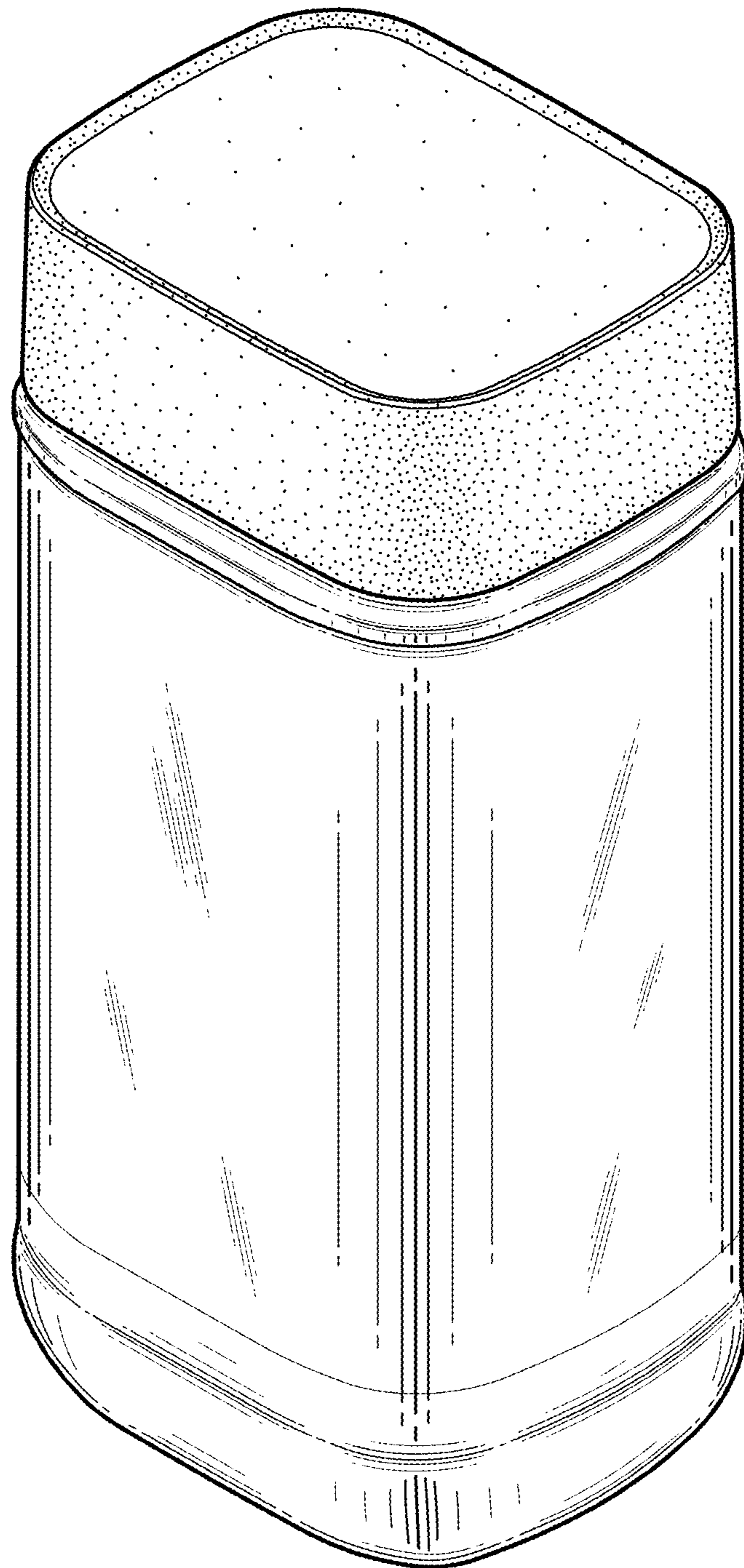

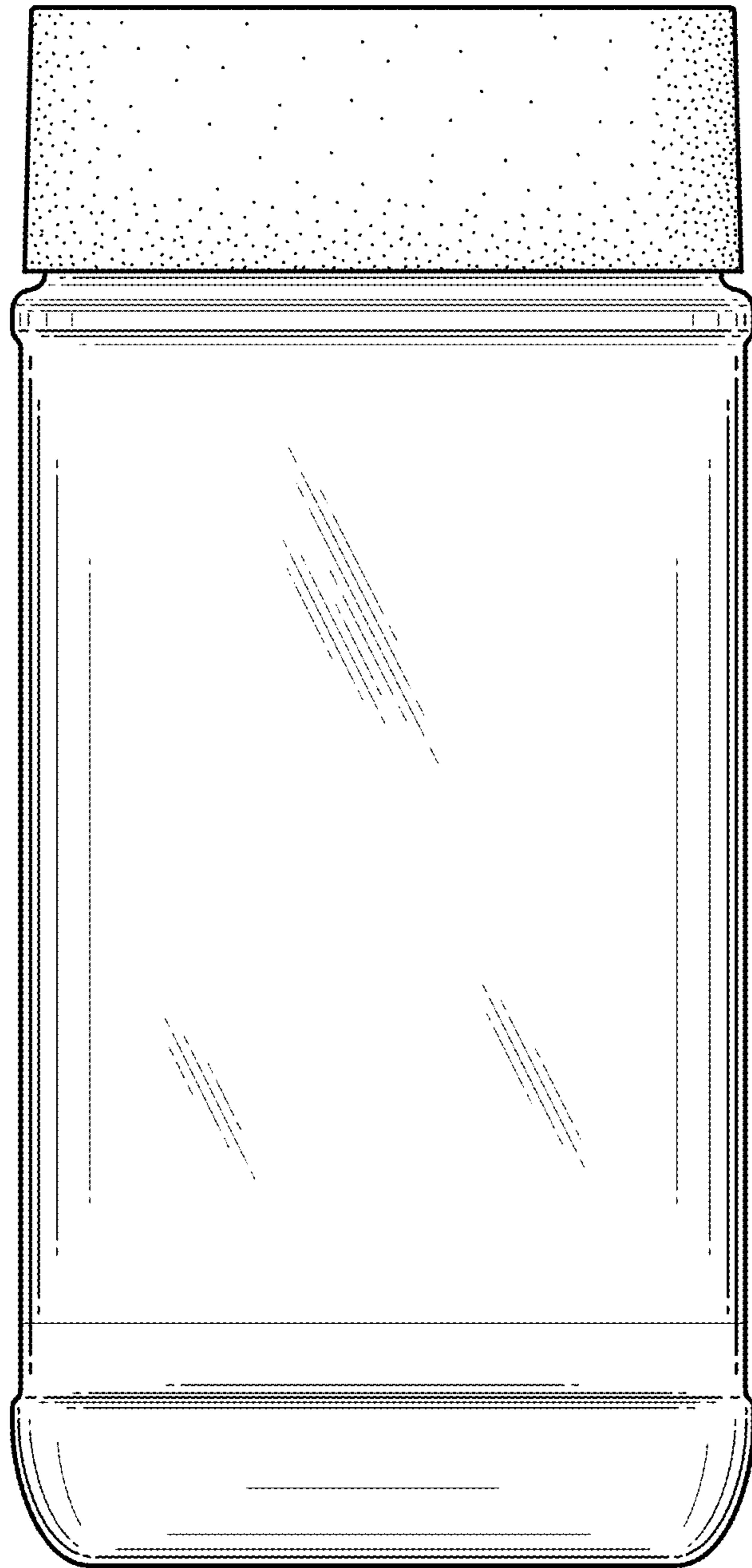

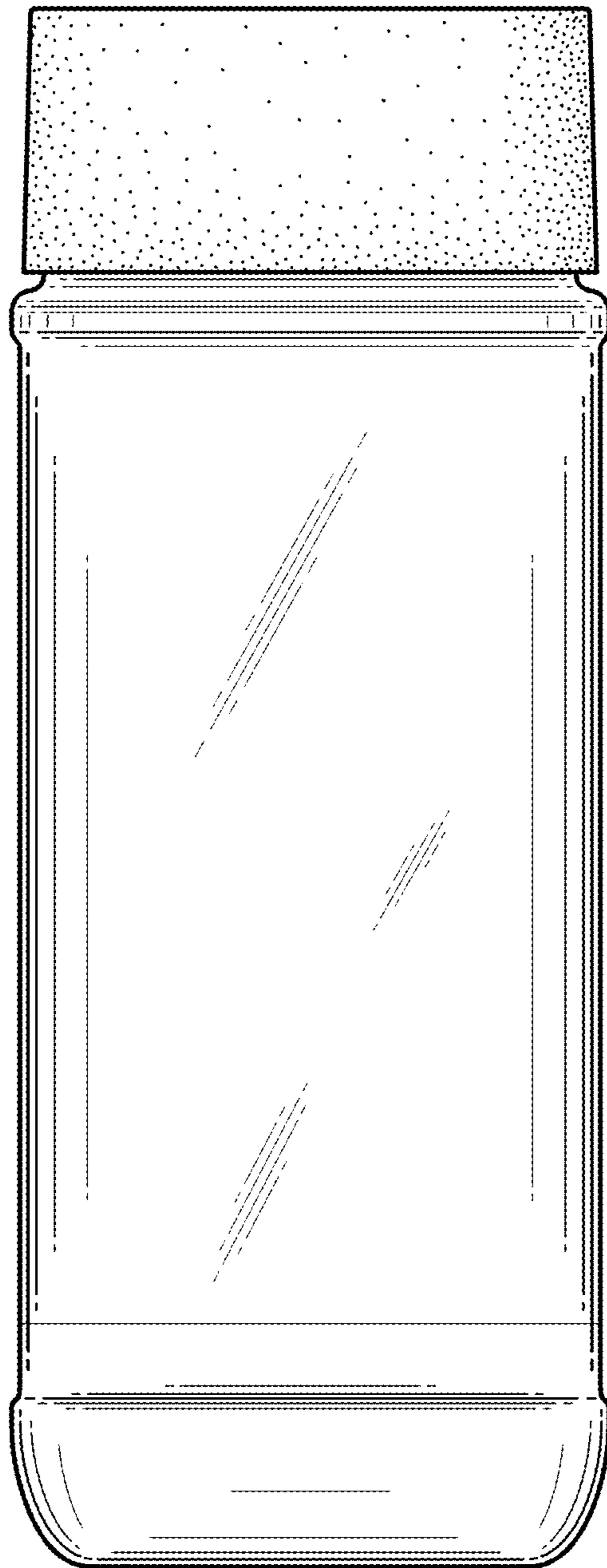

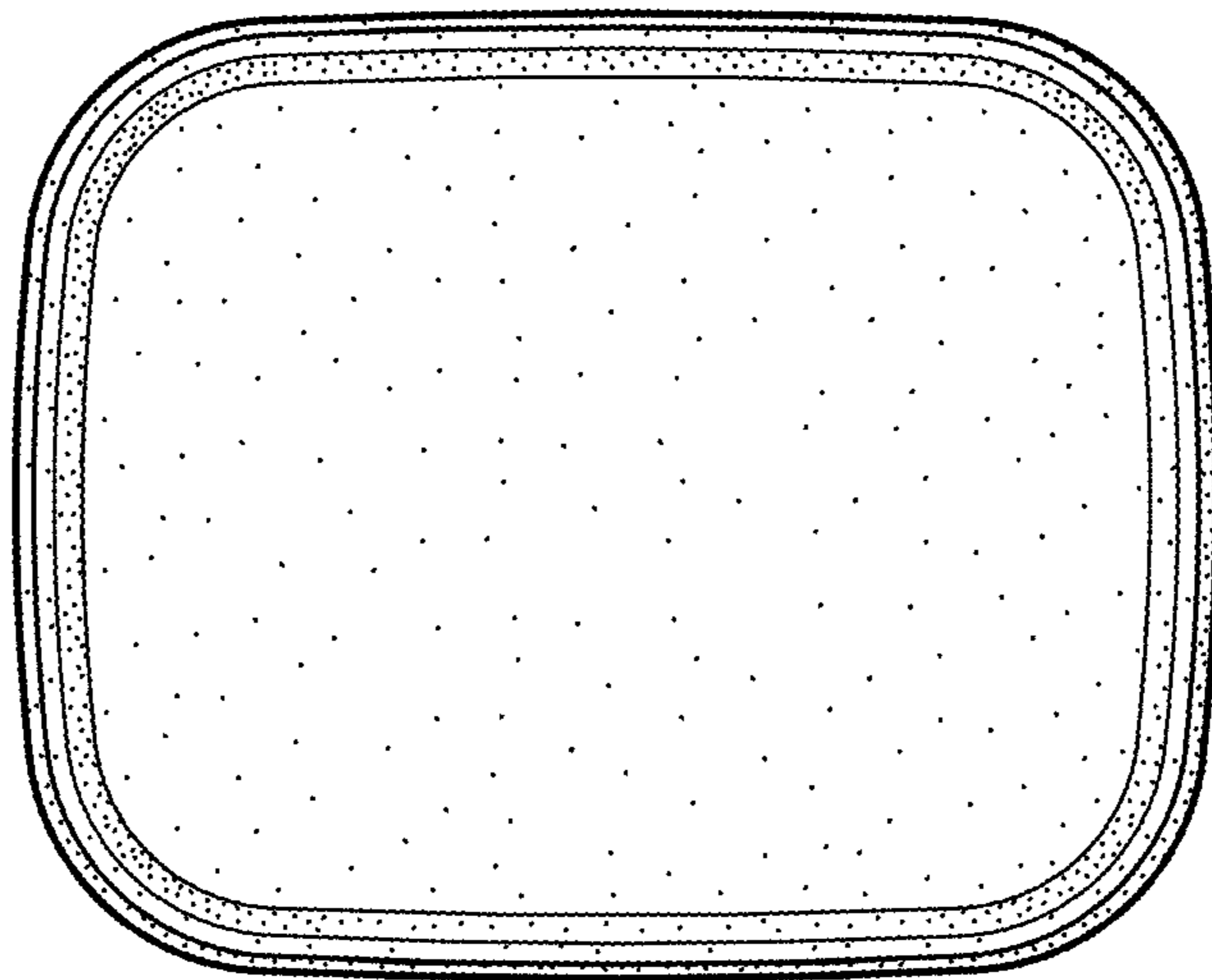
