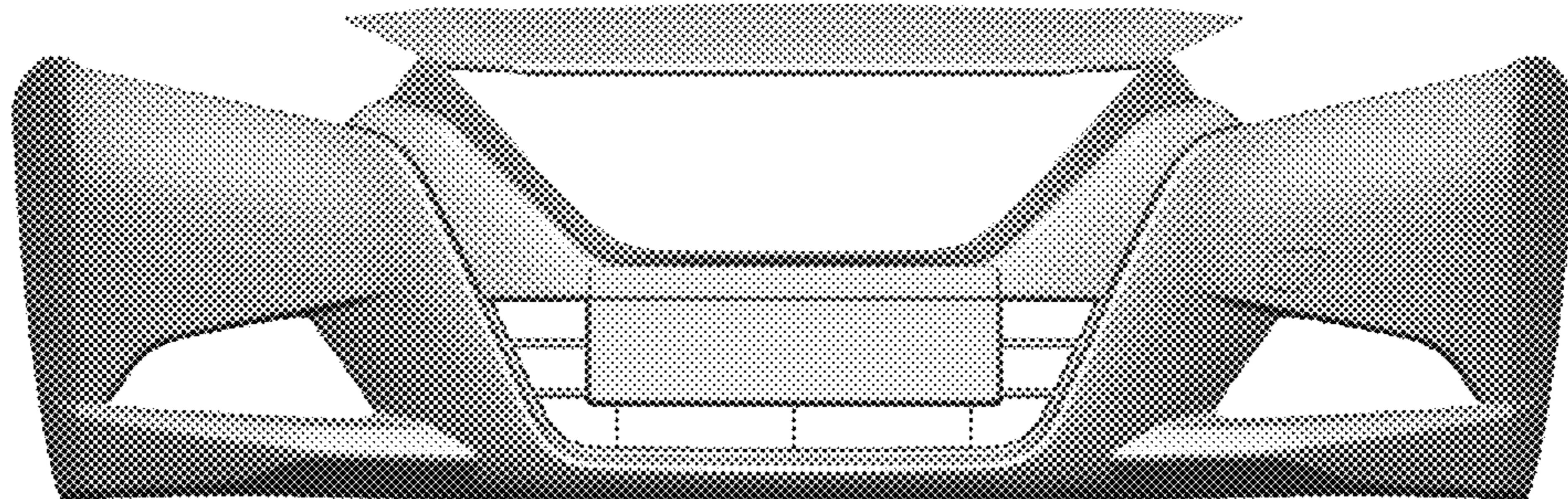
(57) **CLAIM**

The ornamental design for a front bumper for an automobile,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a front bumper for an  
automobile in accordance with our new design;  
FIG. 2 is a top plan view of the front bumper in accordance  
with our new design of FIG. 1;  
FIG. 3 is a bottom plan view of the front bumper in  
accordance with our new design of FIGS. 1 to 2;  
FIG. 4 is a right side elevational view of the front bumper  
in accordance with our new design of FIGS. 1 to 3;  
FIG. 5 is a left side elevational view of the front bumper in  
accordance with our new design of FIGS. 1 to 4;  
FIG. 6 is a front, right and top side perspective view of the  
front bumper in accordance with our new design of FIGS. 1  
to 5; and,  
FIG. 7 is a front, left and bottom side perspective view of the  
front bumper in accordance with our new design of FIGS. 1  
to 6.  
The inside surfaces of the front bumper shown in broken  
lines in FIGS. 2, 3, 6 and 7 form no part of the claimed  
design.

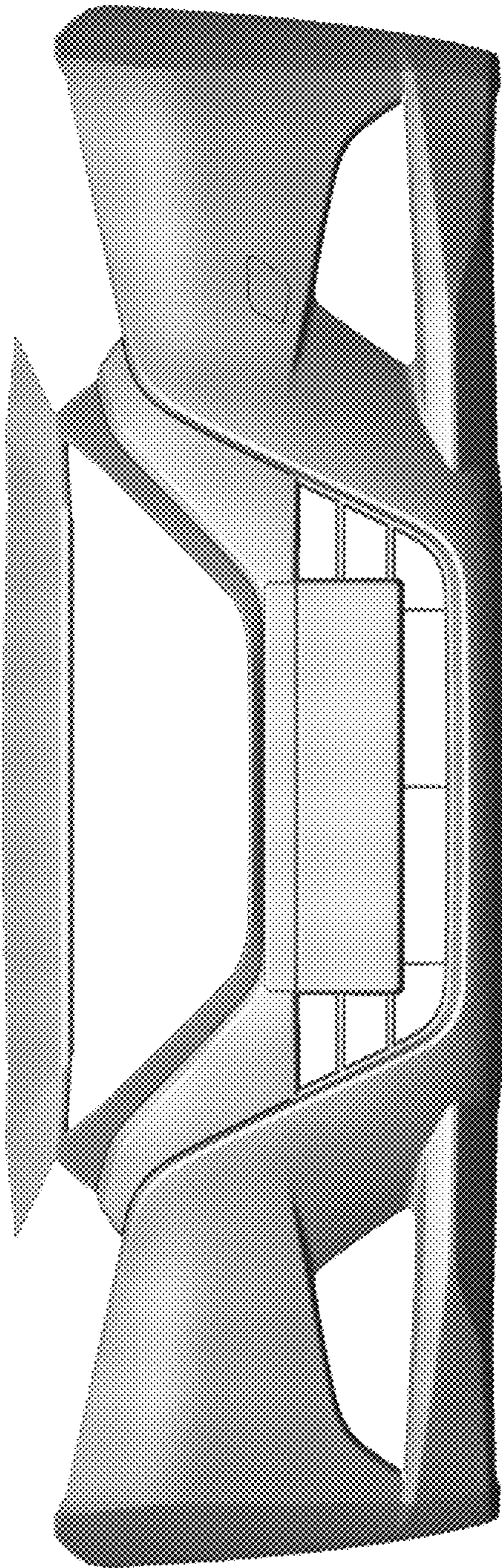

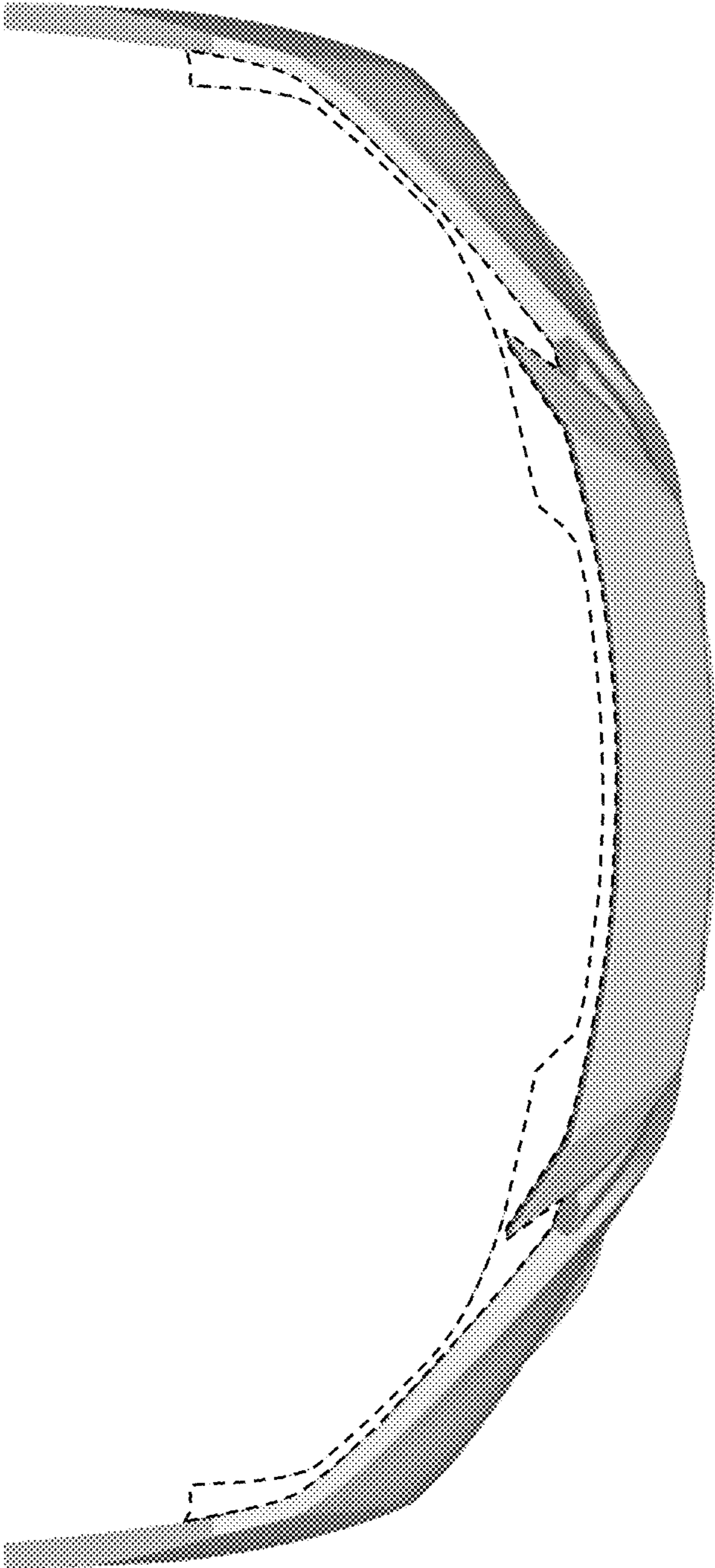

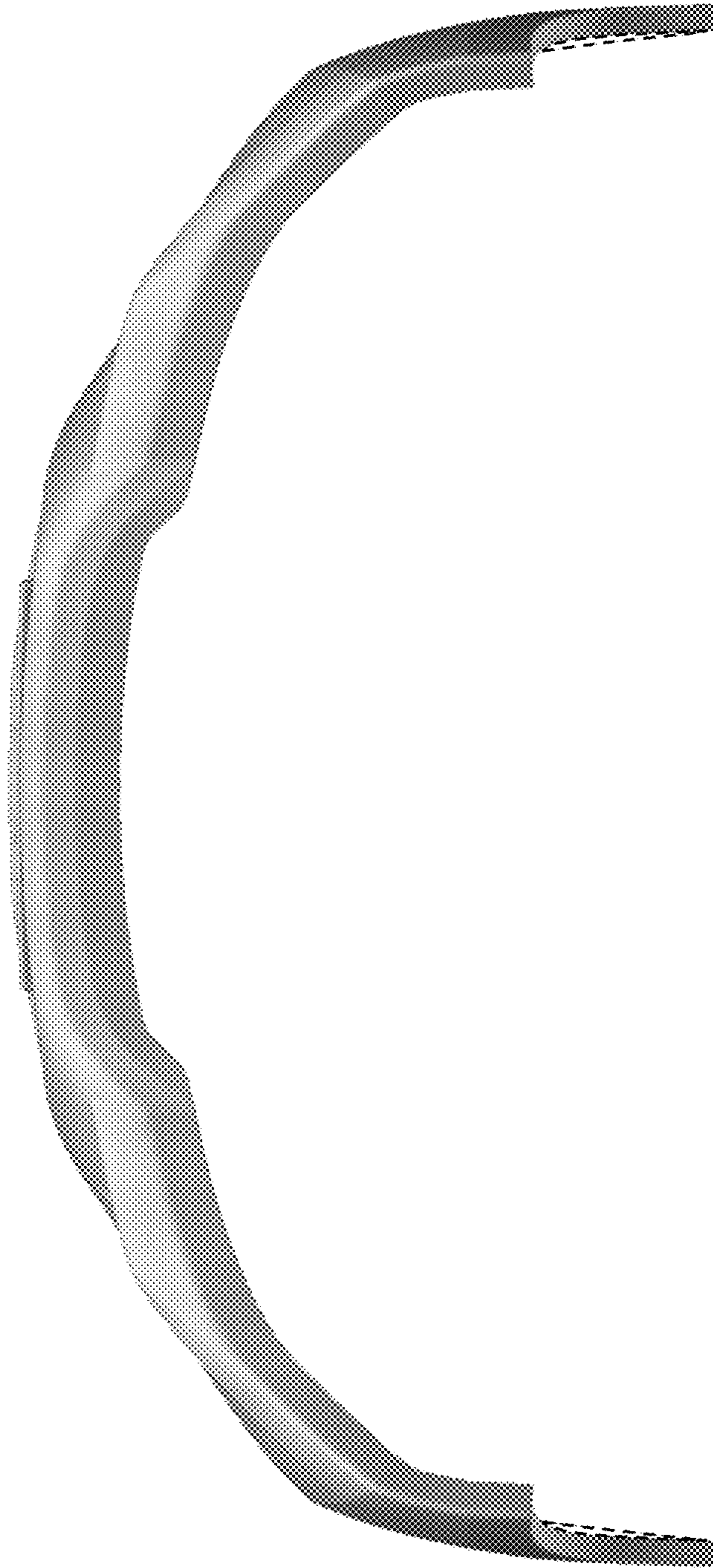

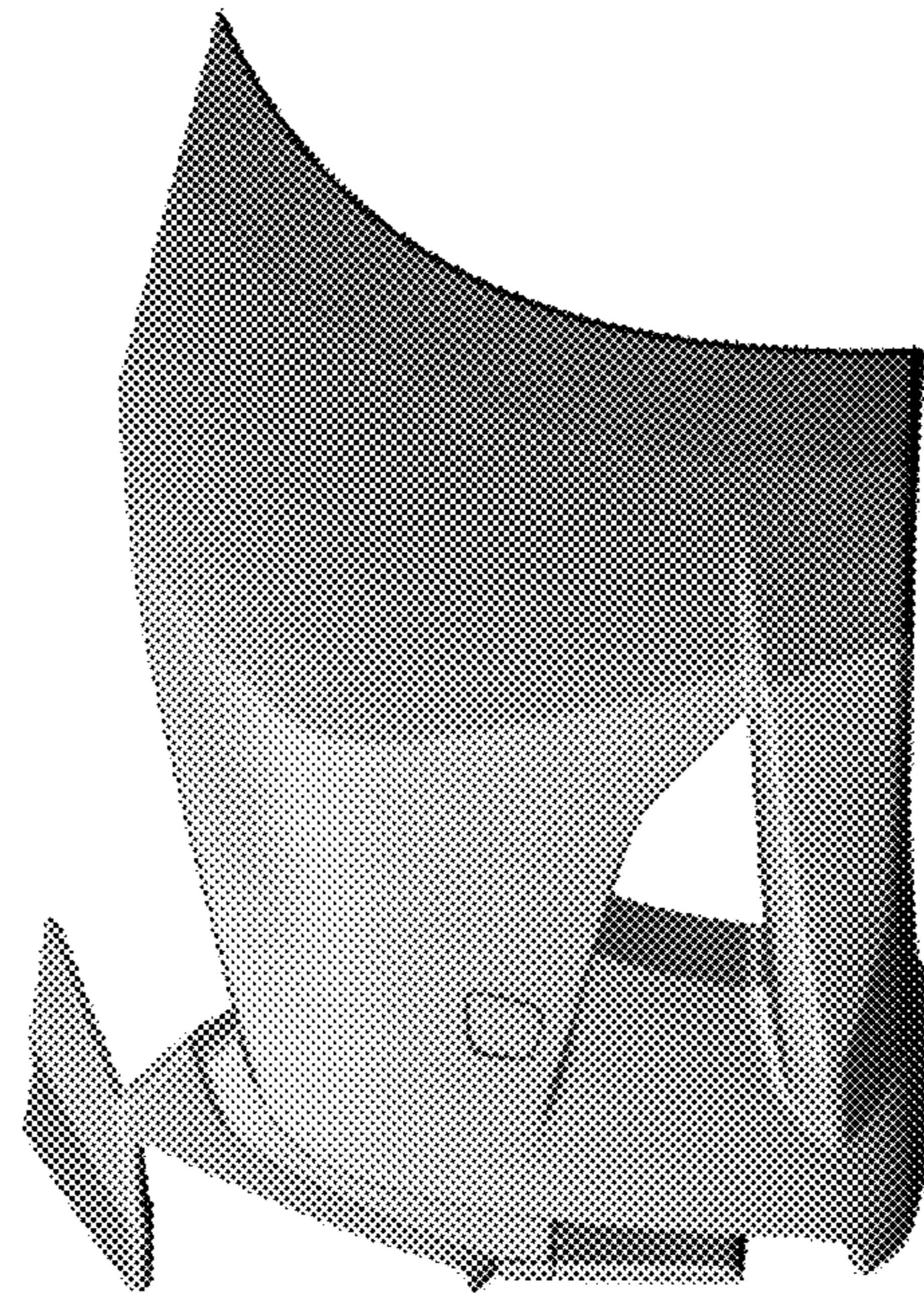

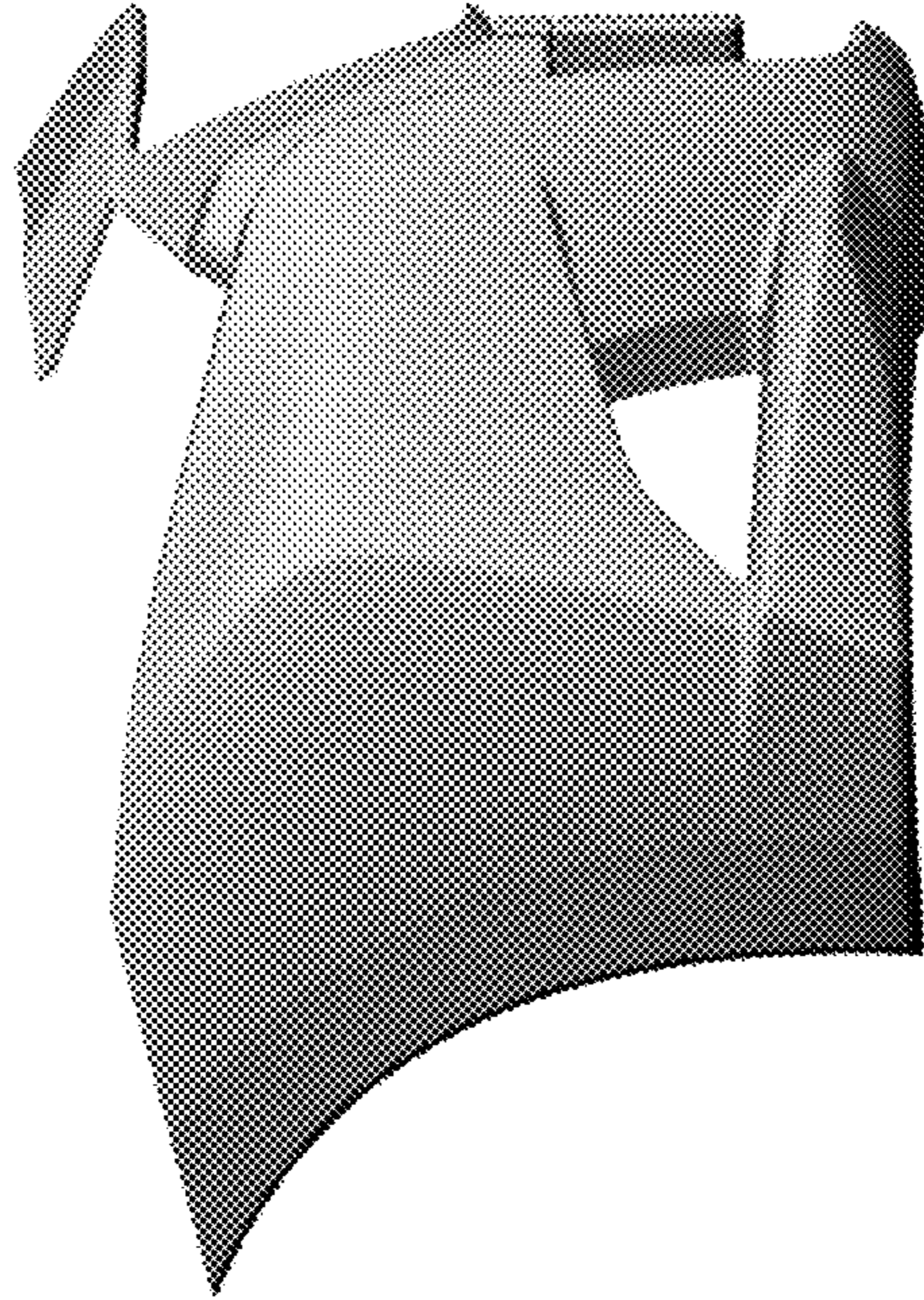

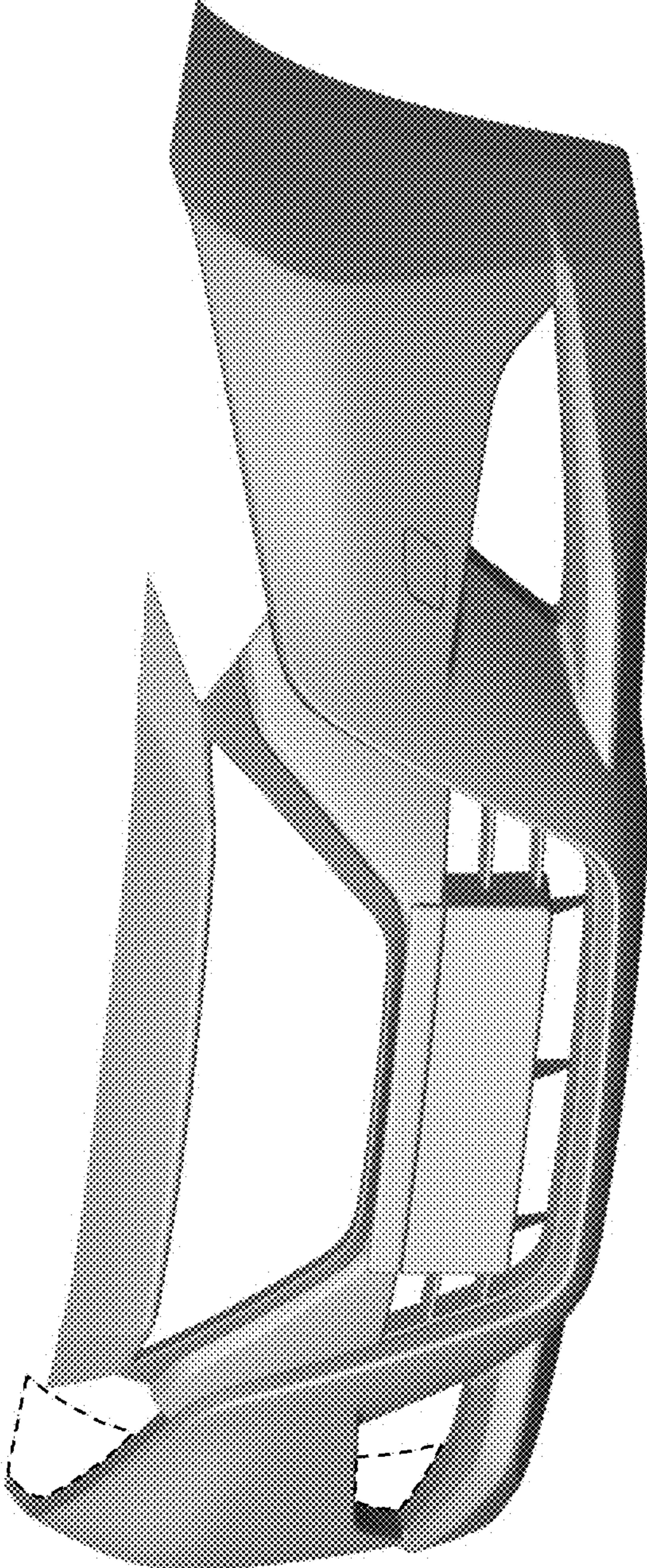

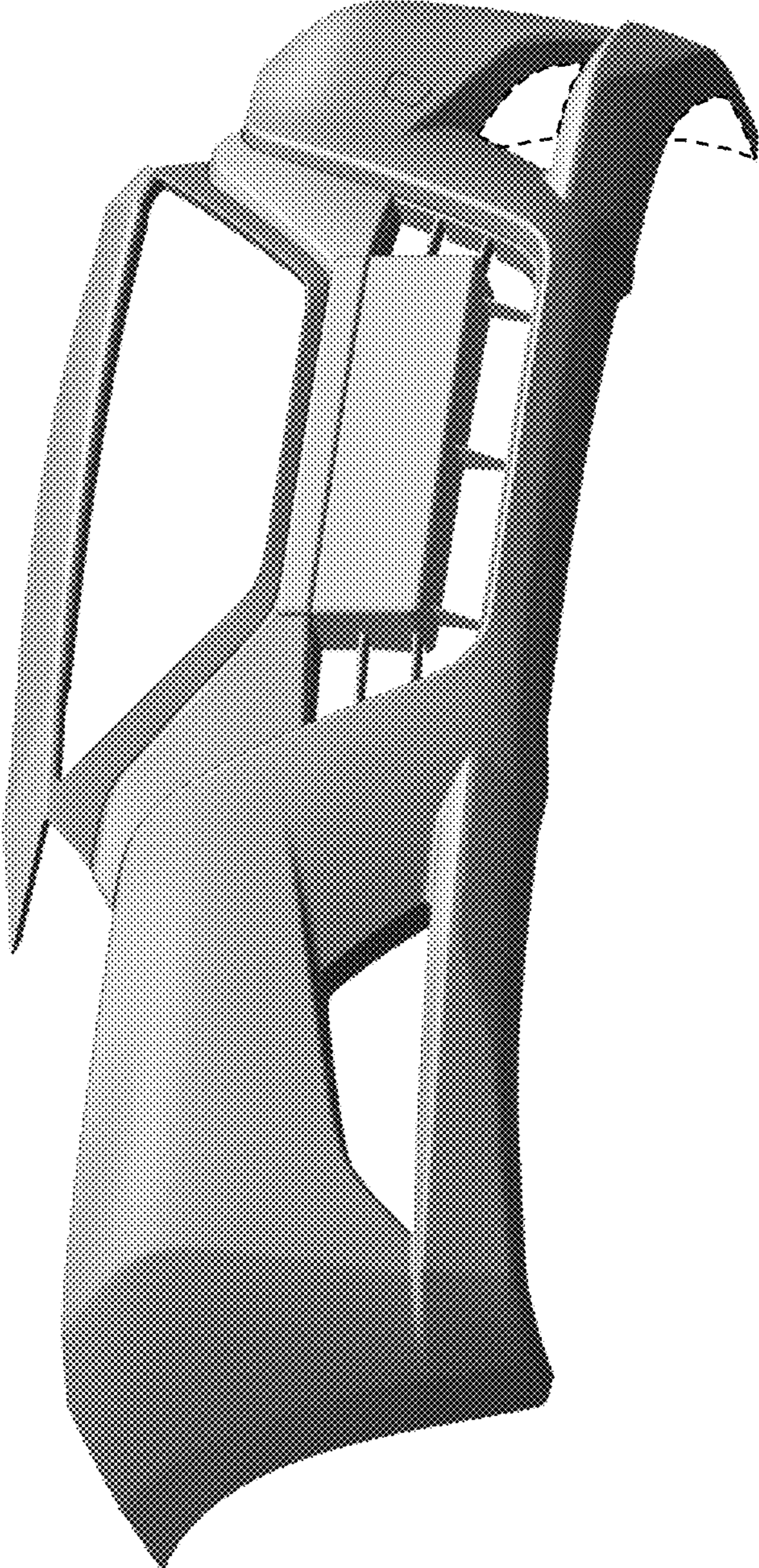
