(57) **CLAIM**

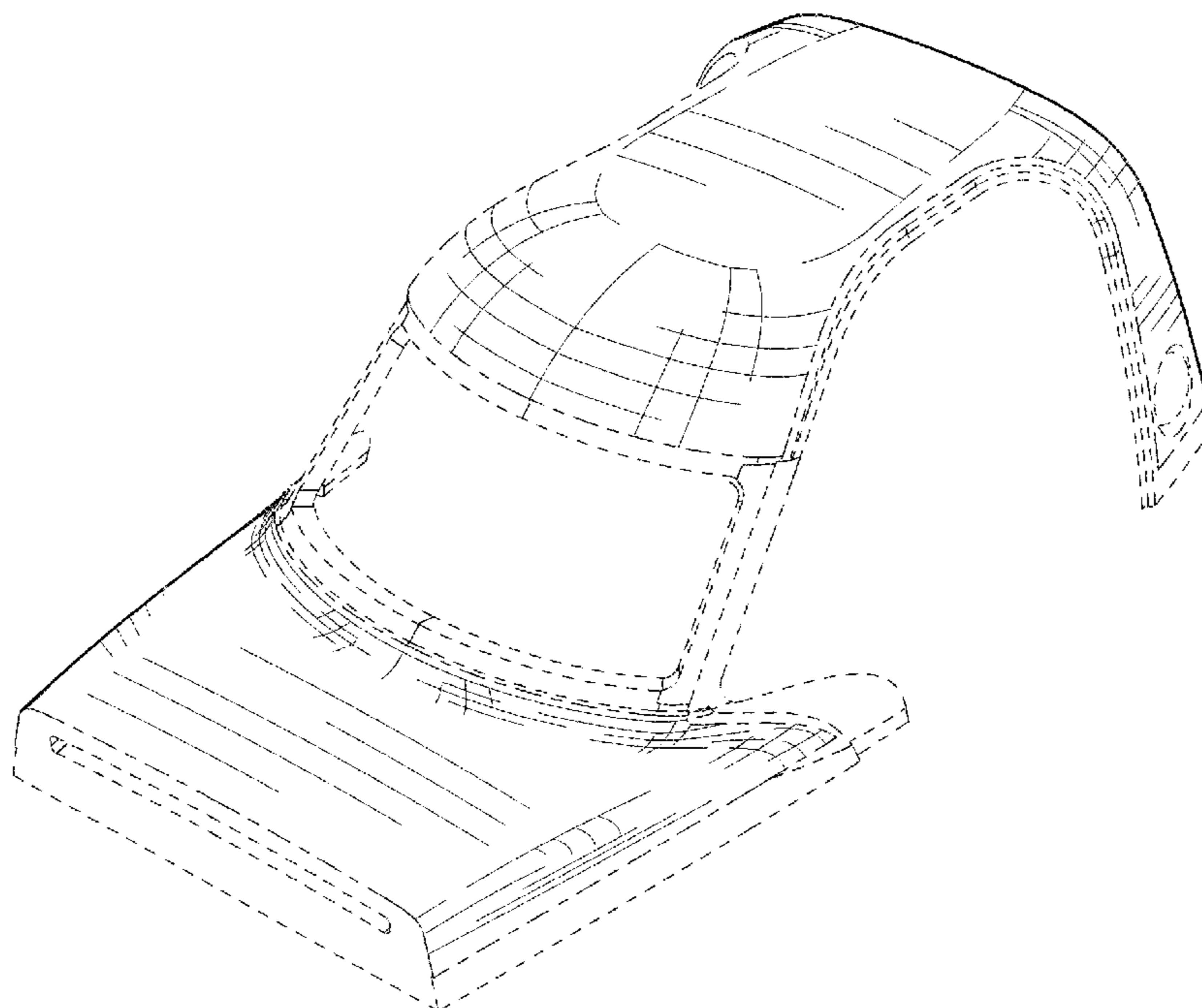
The ornamental design for a hood and roof section for a car body, as shown and described.

DESCRIPTION

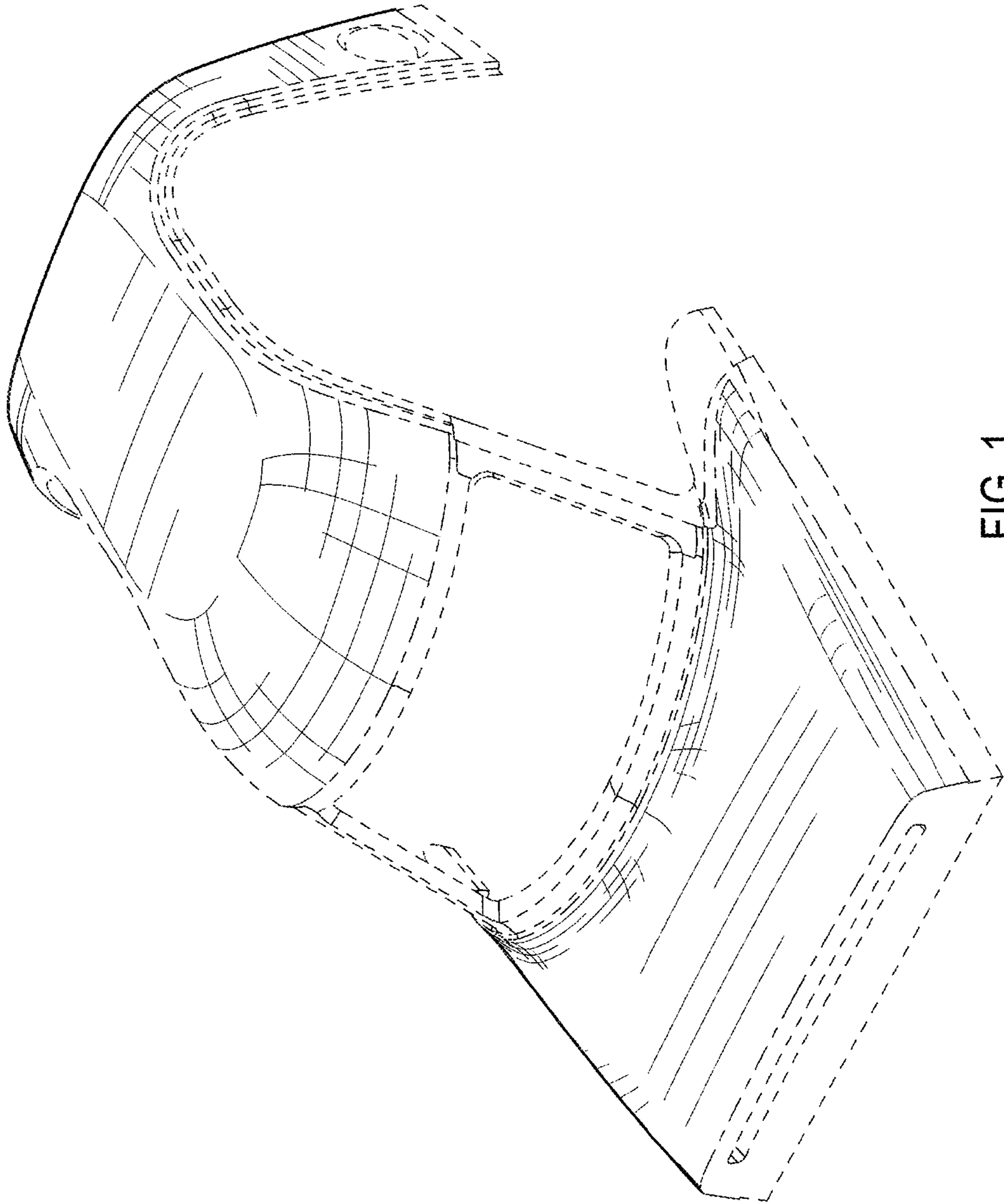

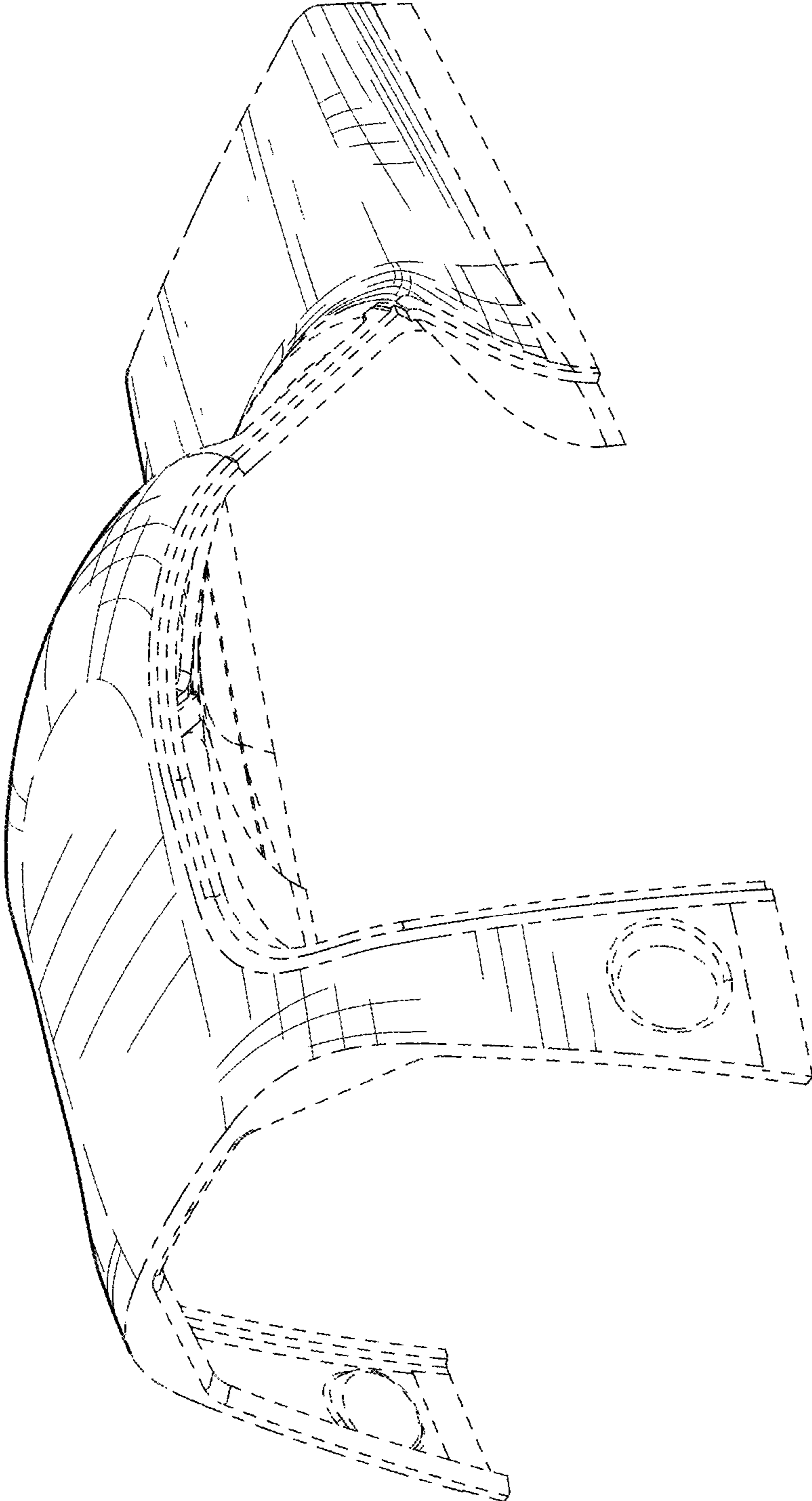

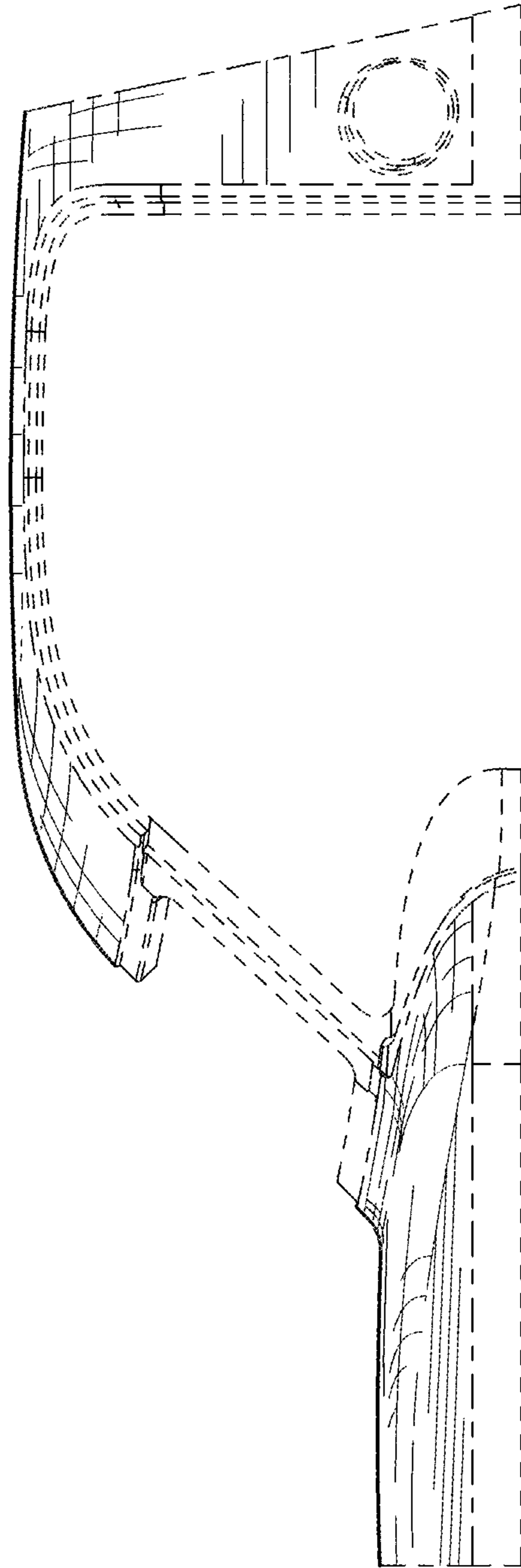

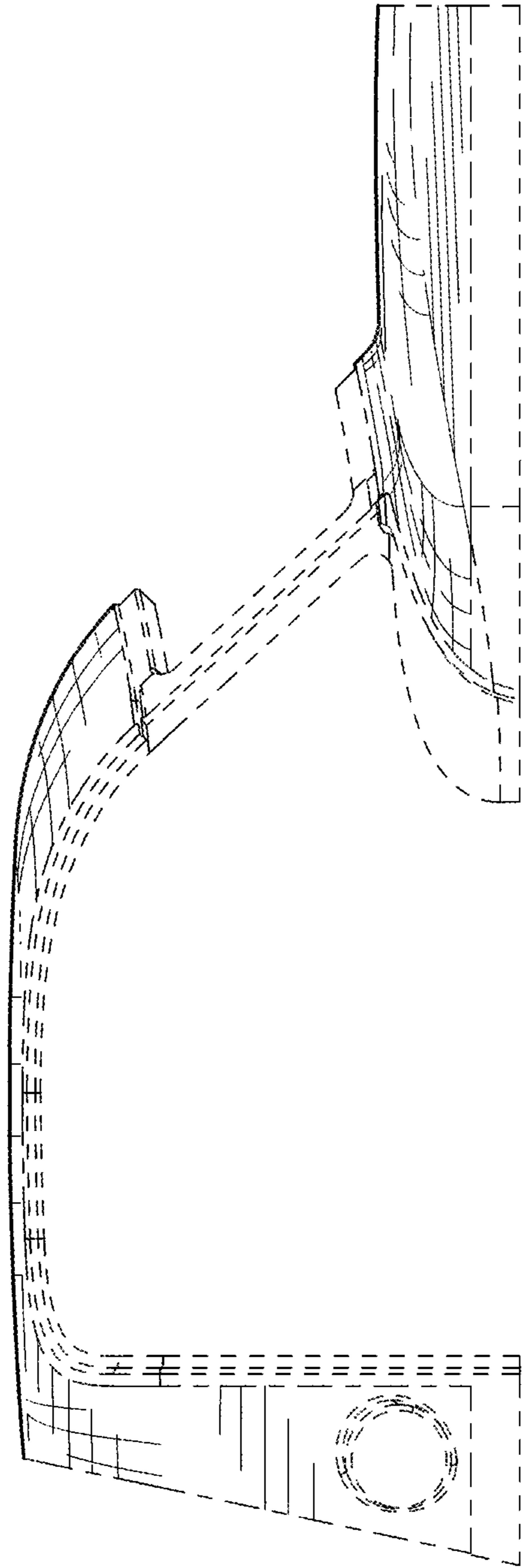

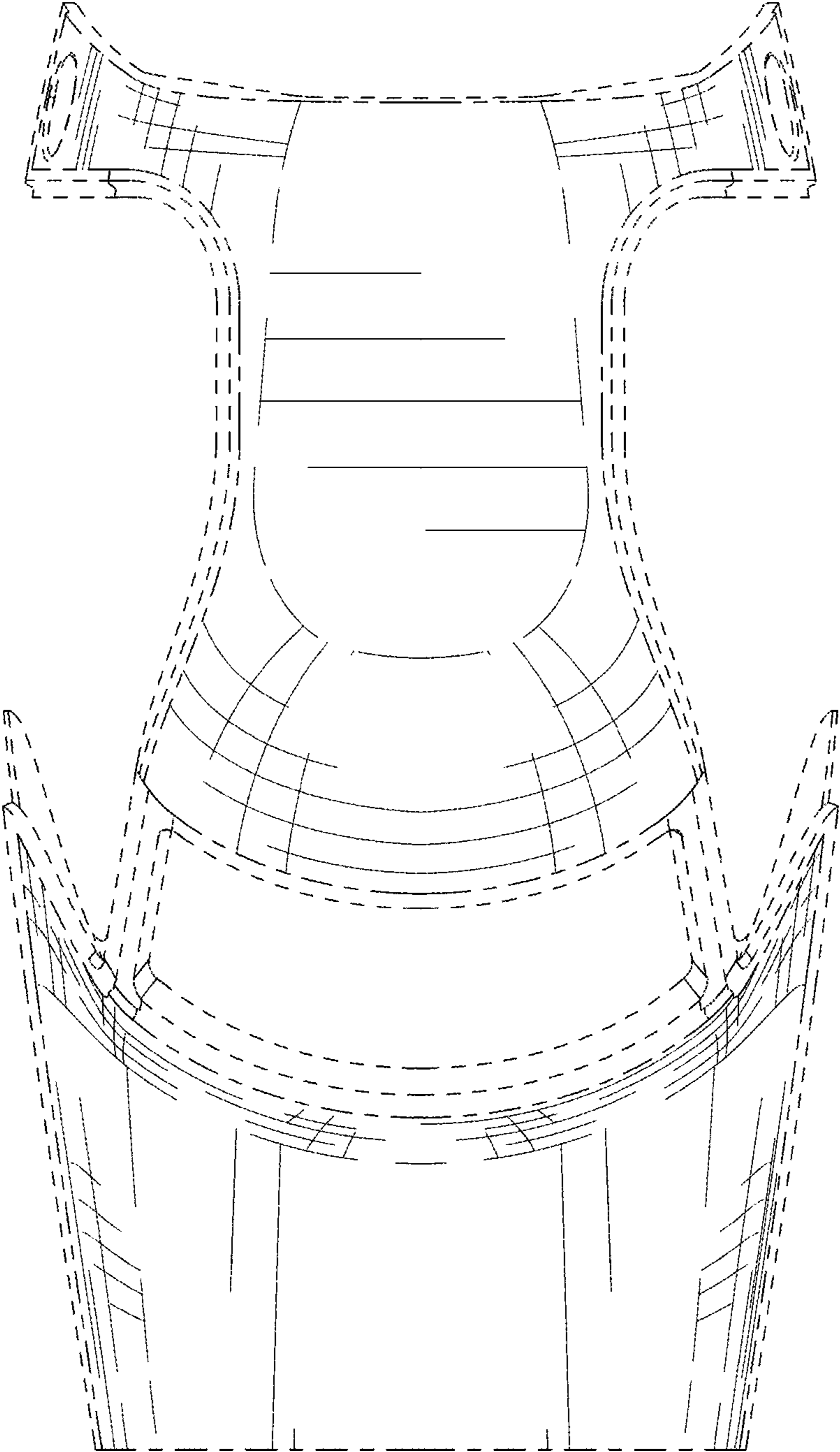

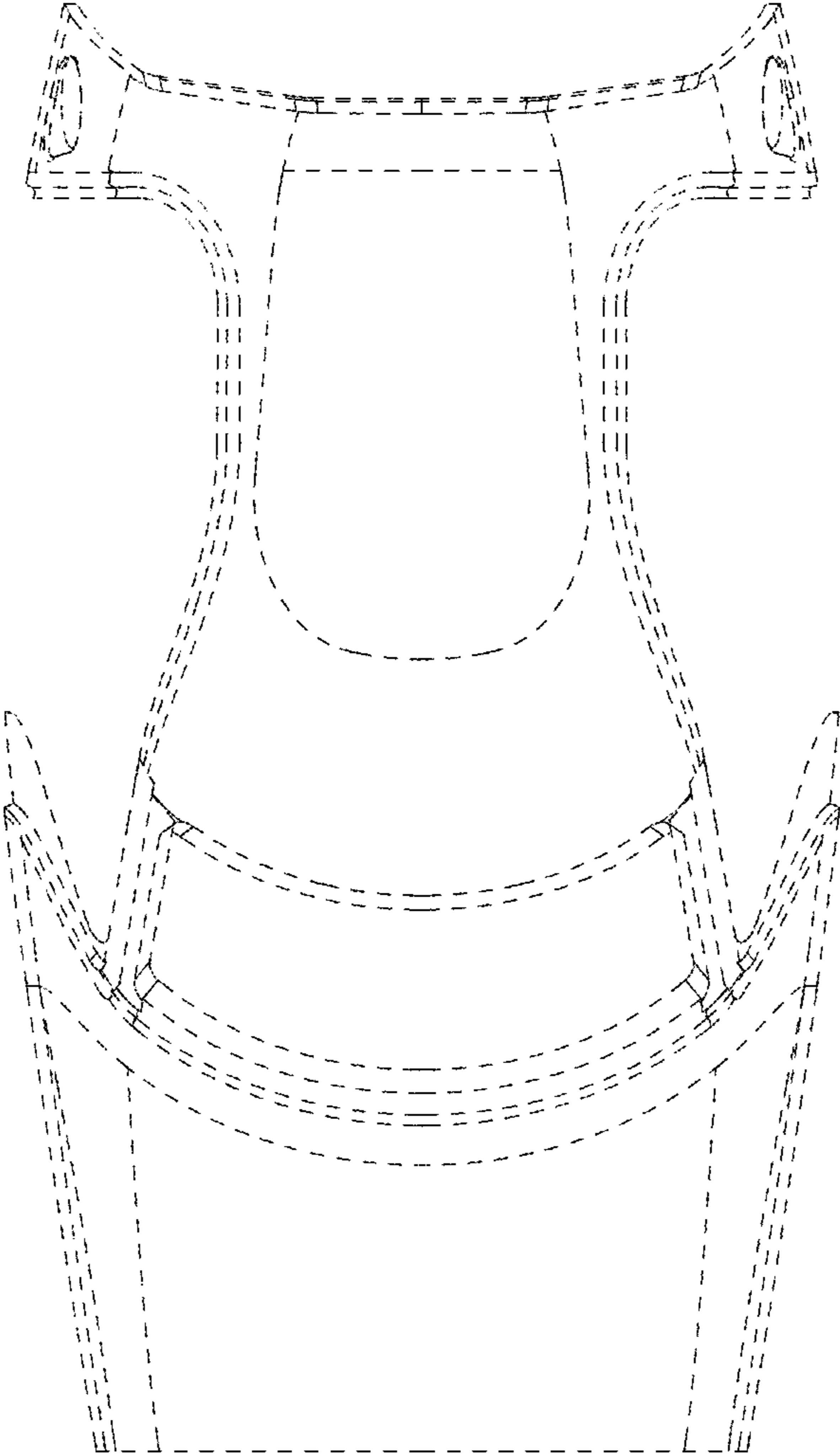

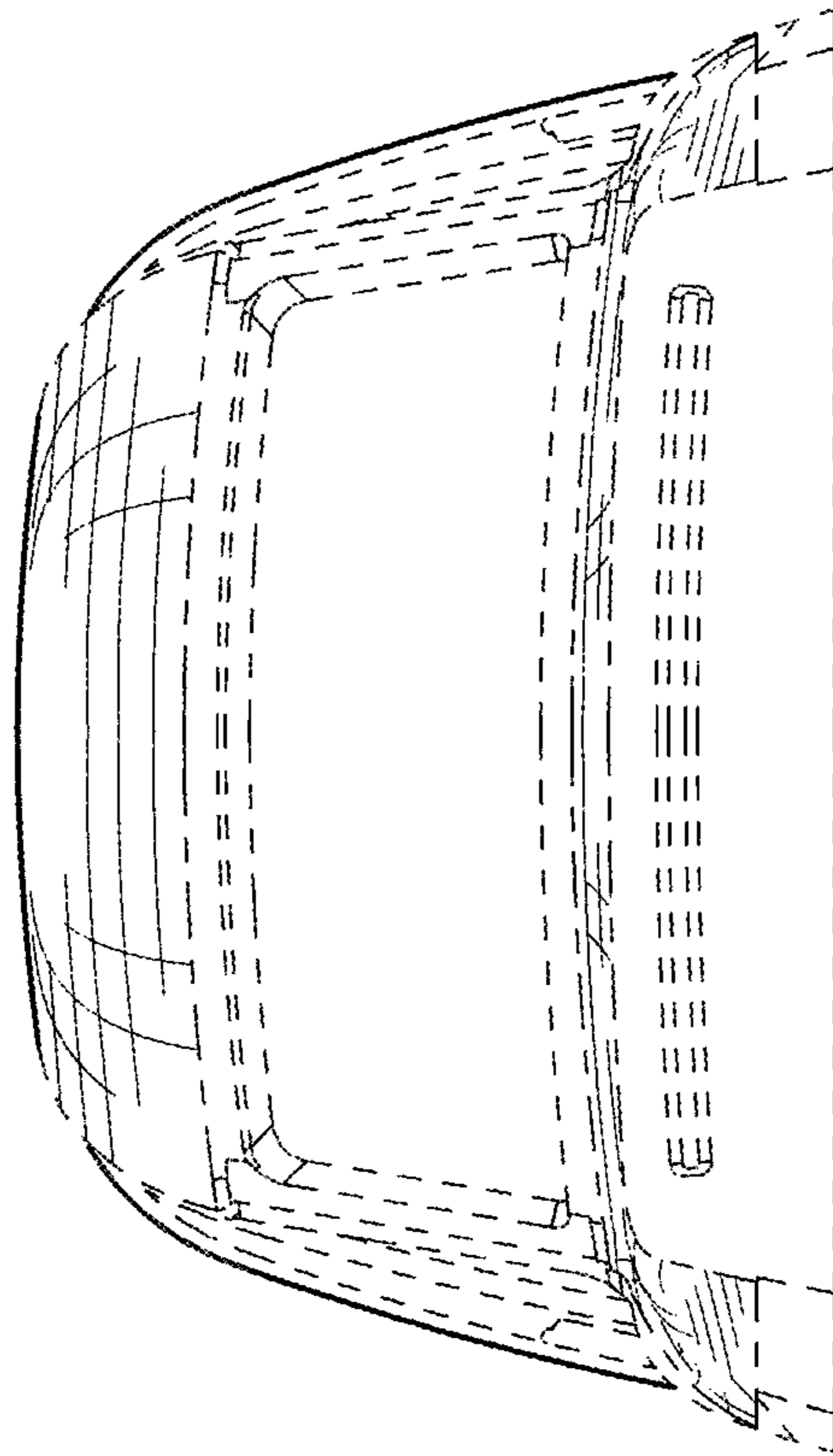

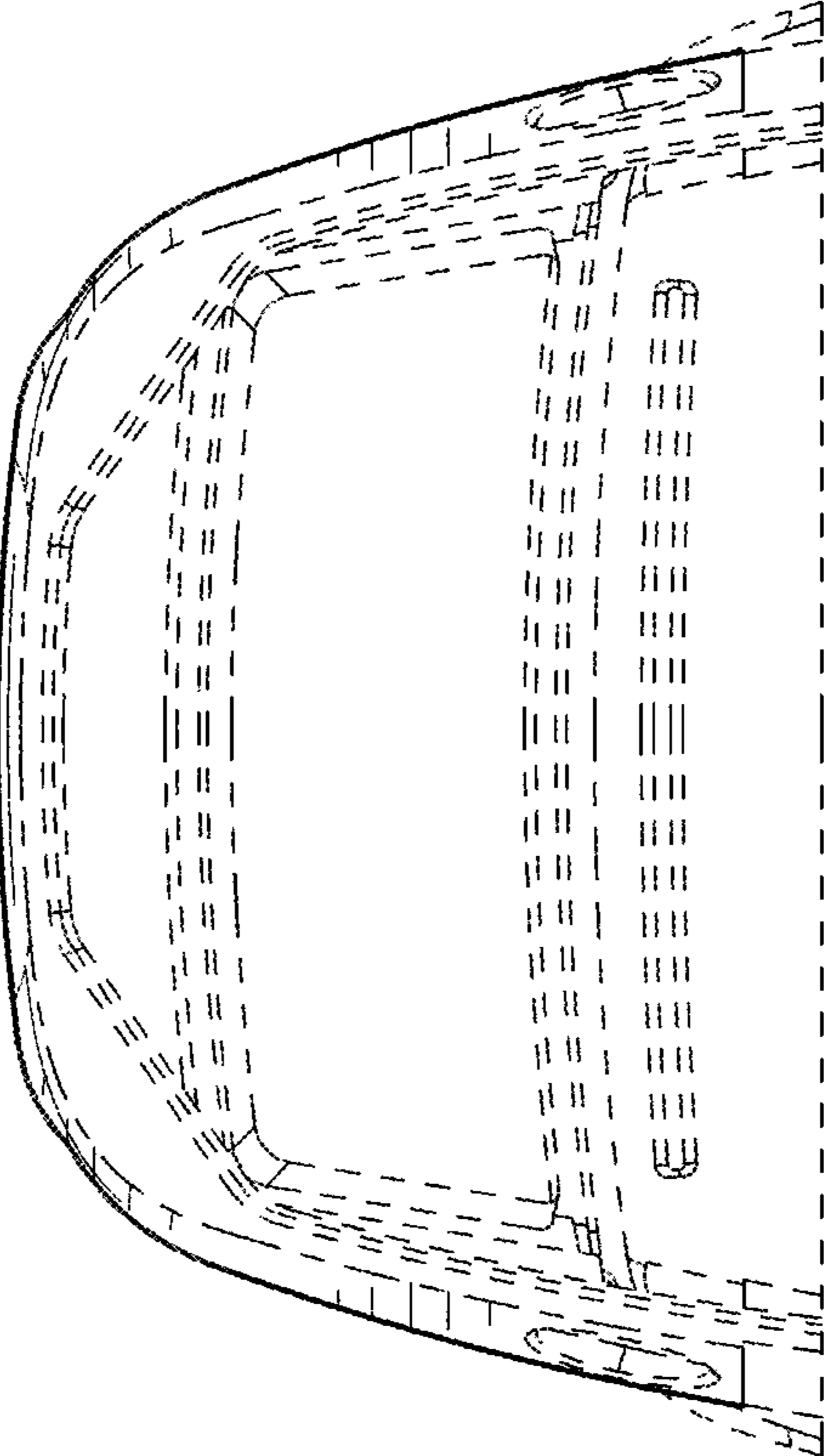
