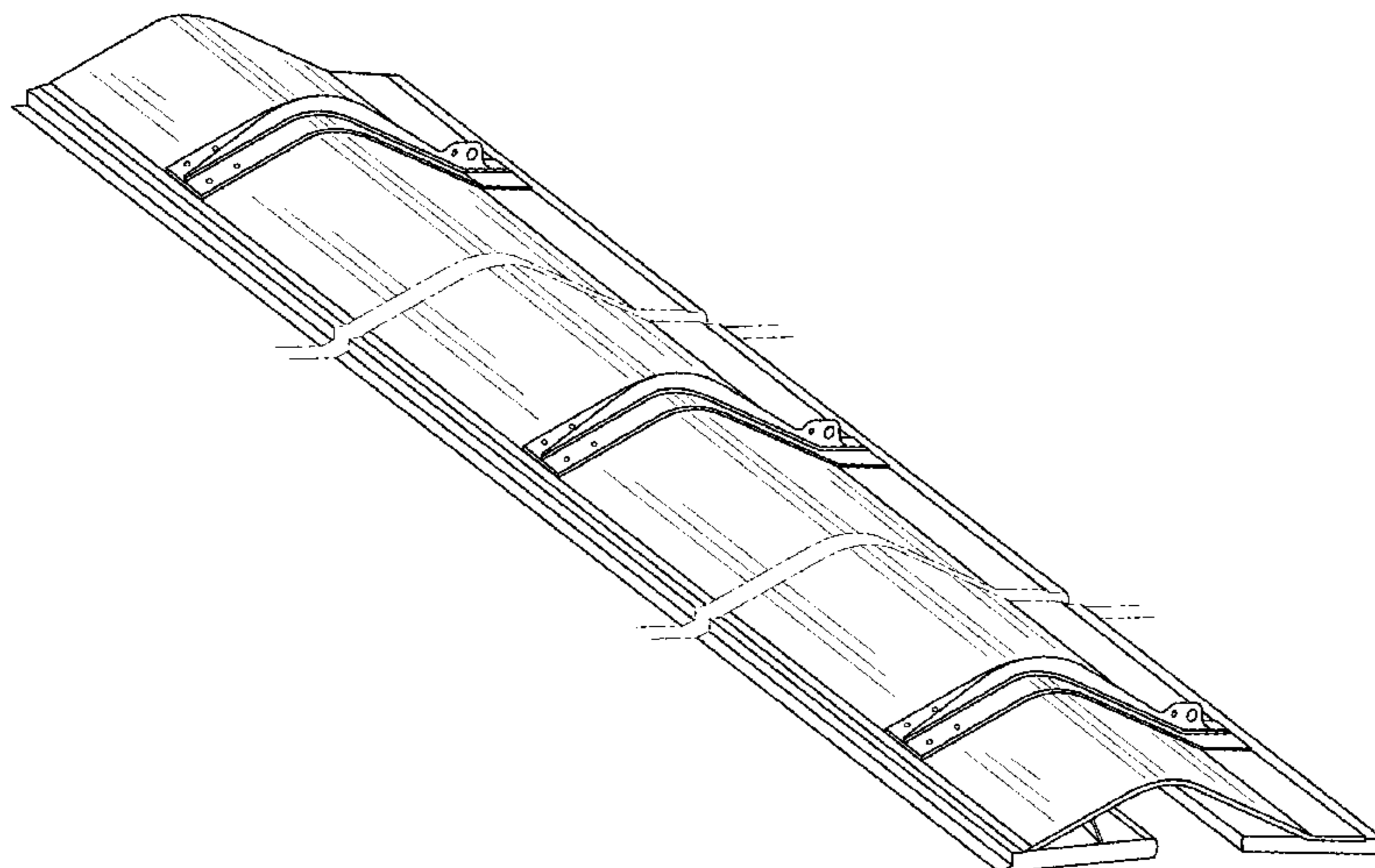
(57) **CLAIM**

The ornamental design for a handrail for an aircraft cabin, as shown and described.

**DESCRIPTION**

FIG. 1. is a front and side perspective view of a handrail for an aircraft cabin;  
FIG. 2 is a top and side perspective view thereof;  
FIG. 3 is a bottom and side perspective view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a side elevational view thereof, the opposite side being a mirror image;  
FIG. 6. is a rear and side perspective view of a handrail for an aircraft cabin shown in an alternate environment of use;  
FIG. 7 is a front and side perspective view thereof;  
FIG. 8 is a bottom and side perspective view thereof;  
FIG. 9 is a top plan view thereof; and,  
FIG. 10 is a side elevational view thereof, the opposite side being a mirror image.  
The handrail for an aircraft is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design. The broken lines in the drawings represent unclaimed environmental subject matter and form no part of the claim.

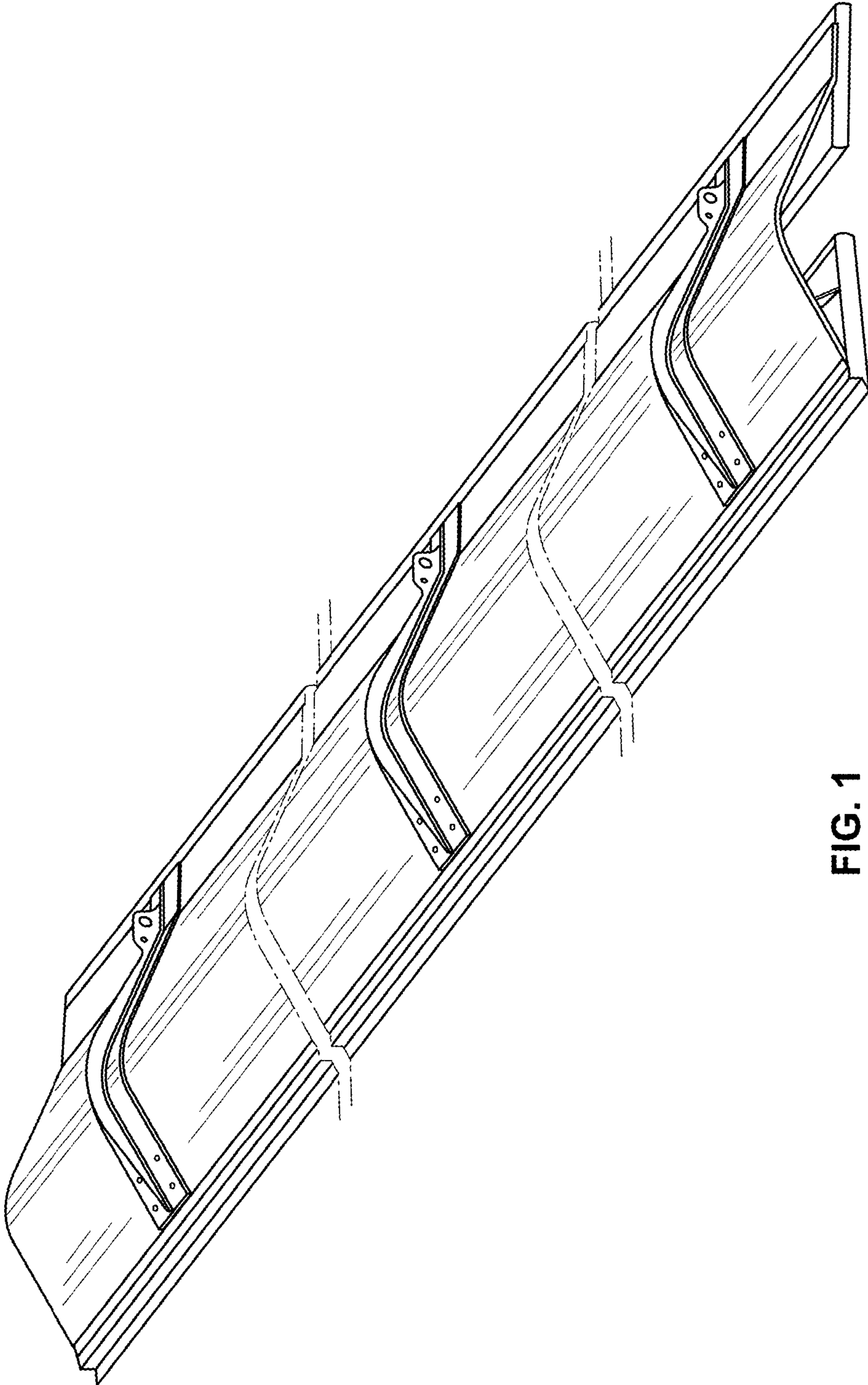

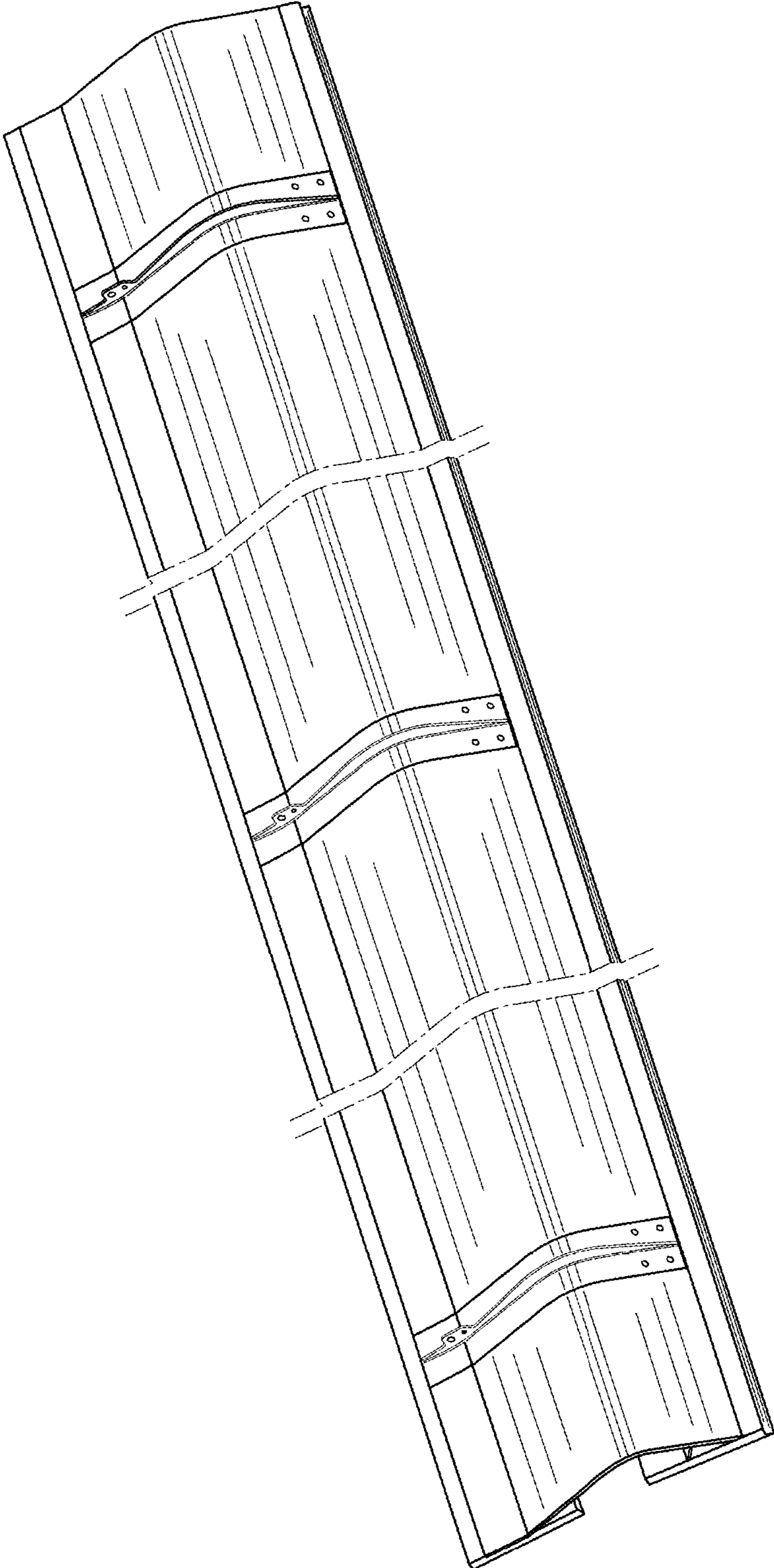

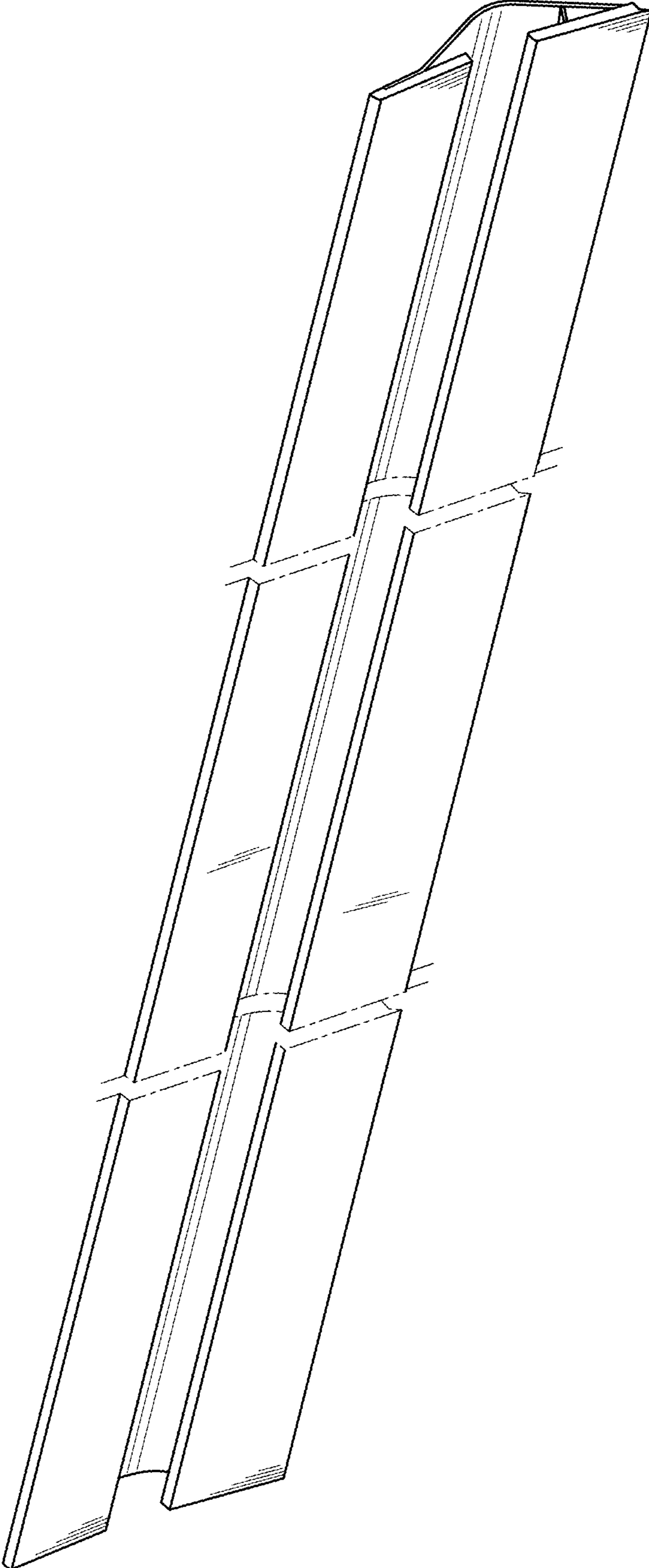

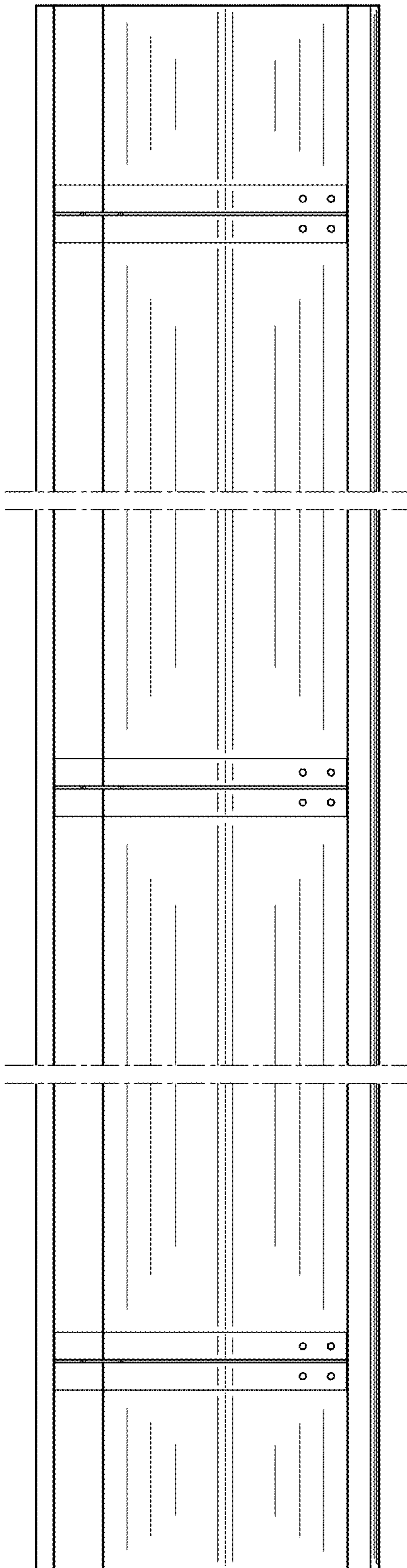

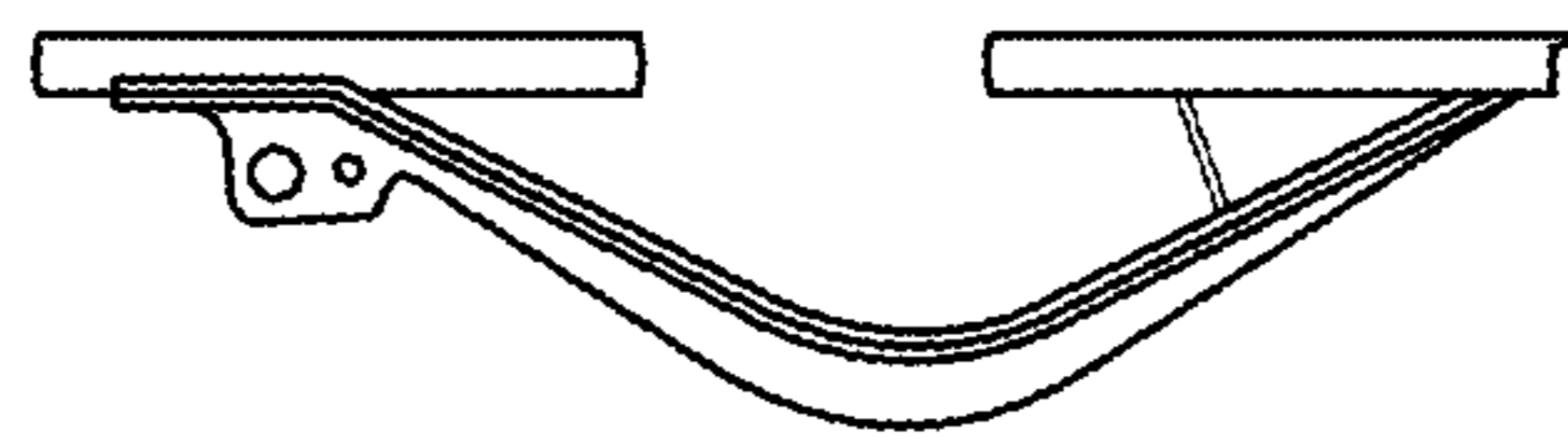

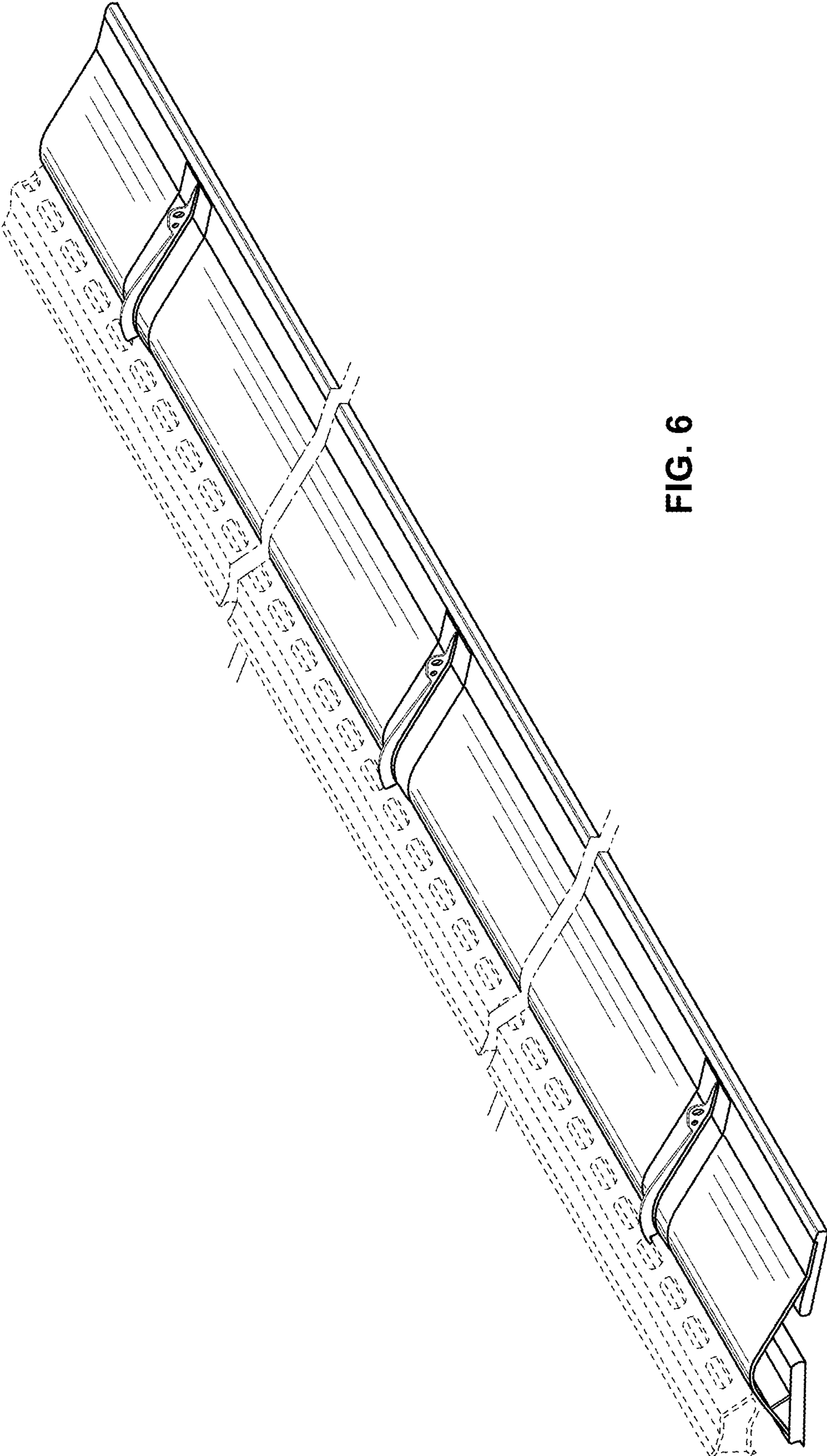

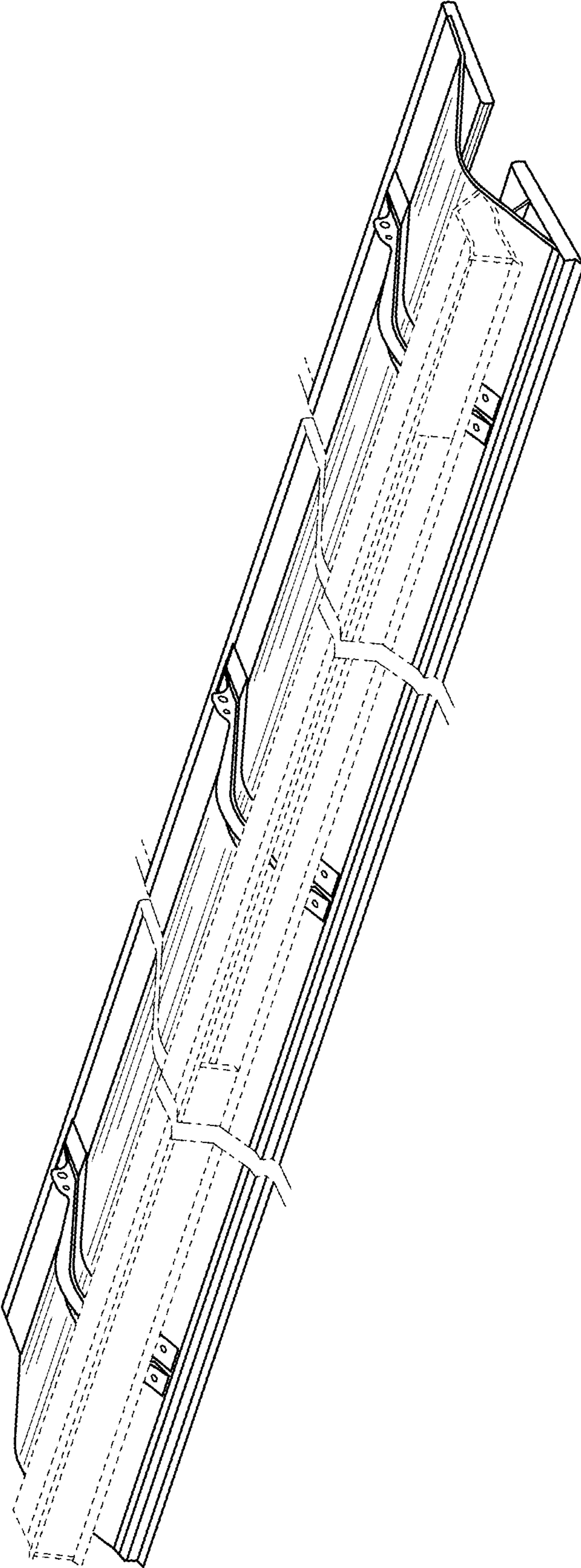

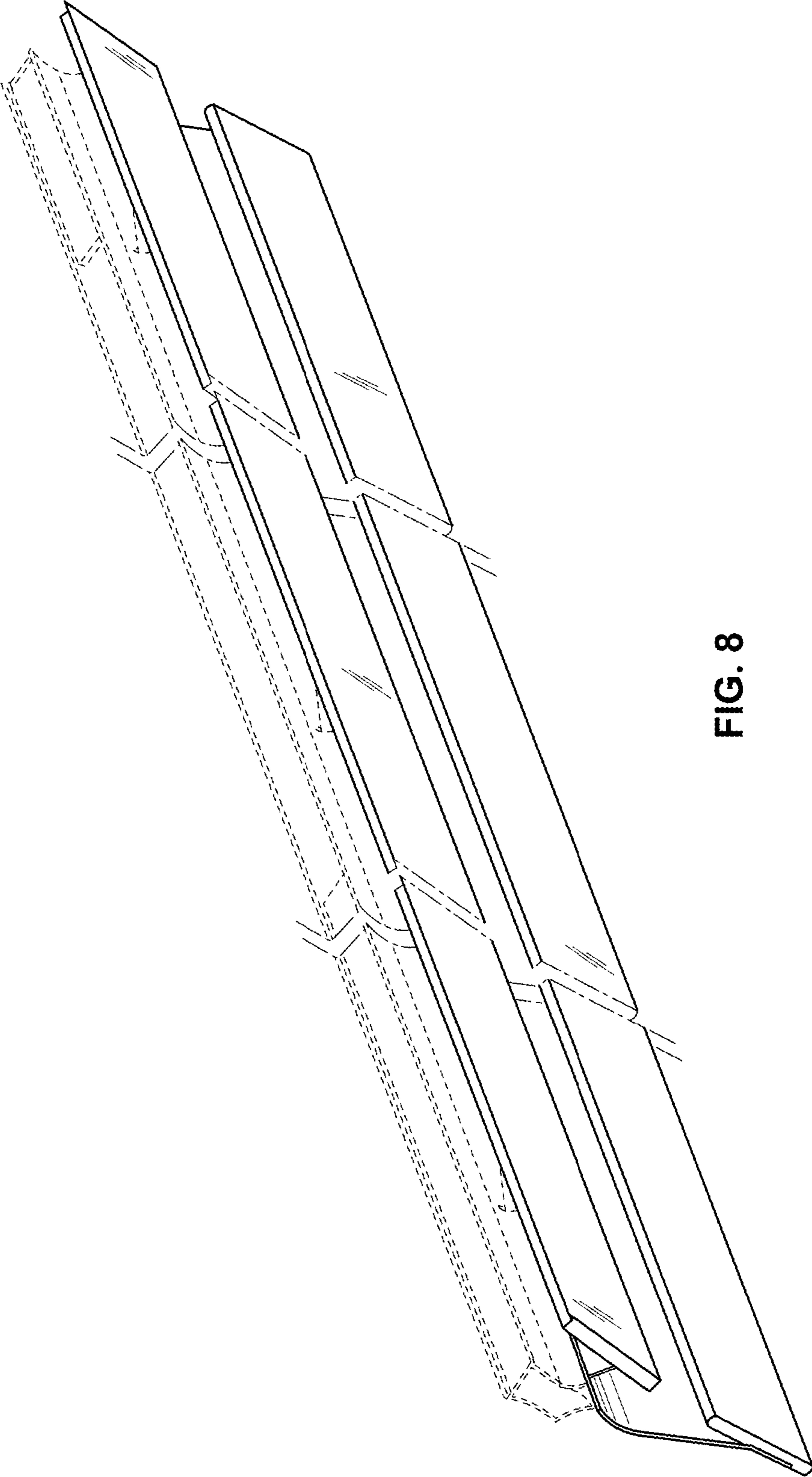

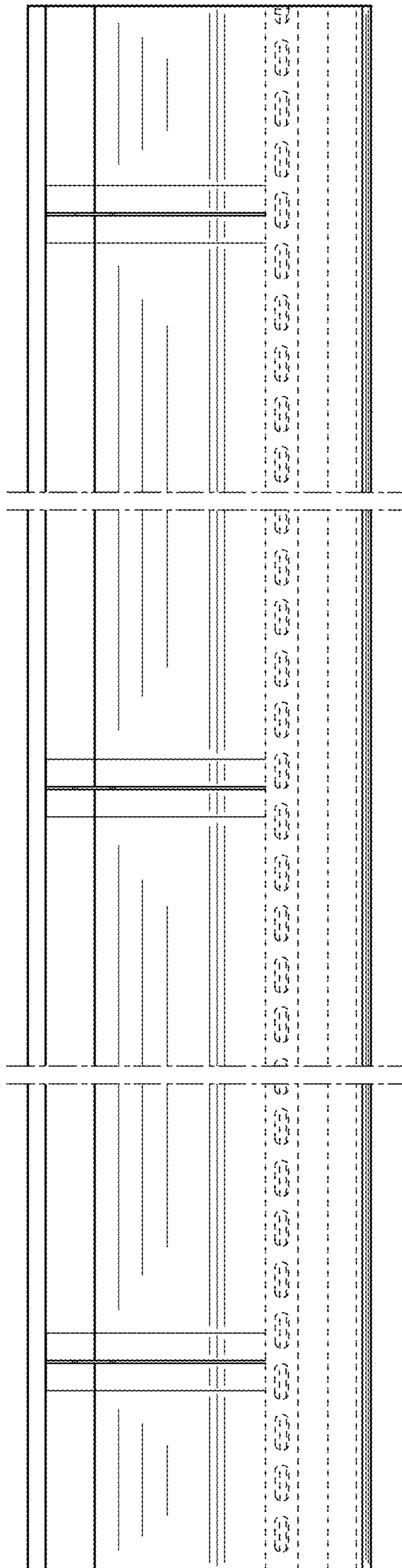

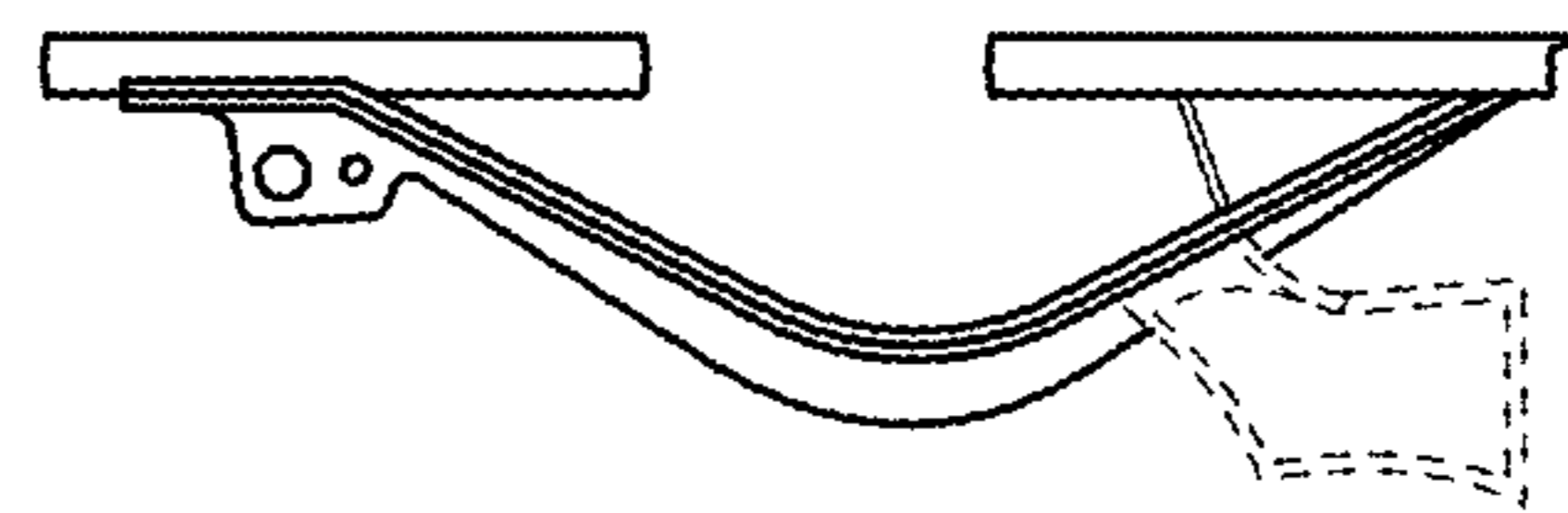
