FIG. 21 is an enlarged view of an indicated portion of FIG. 4;

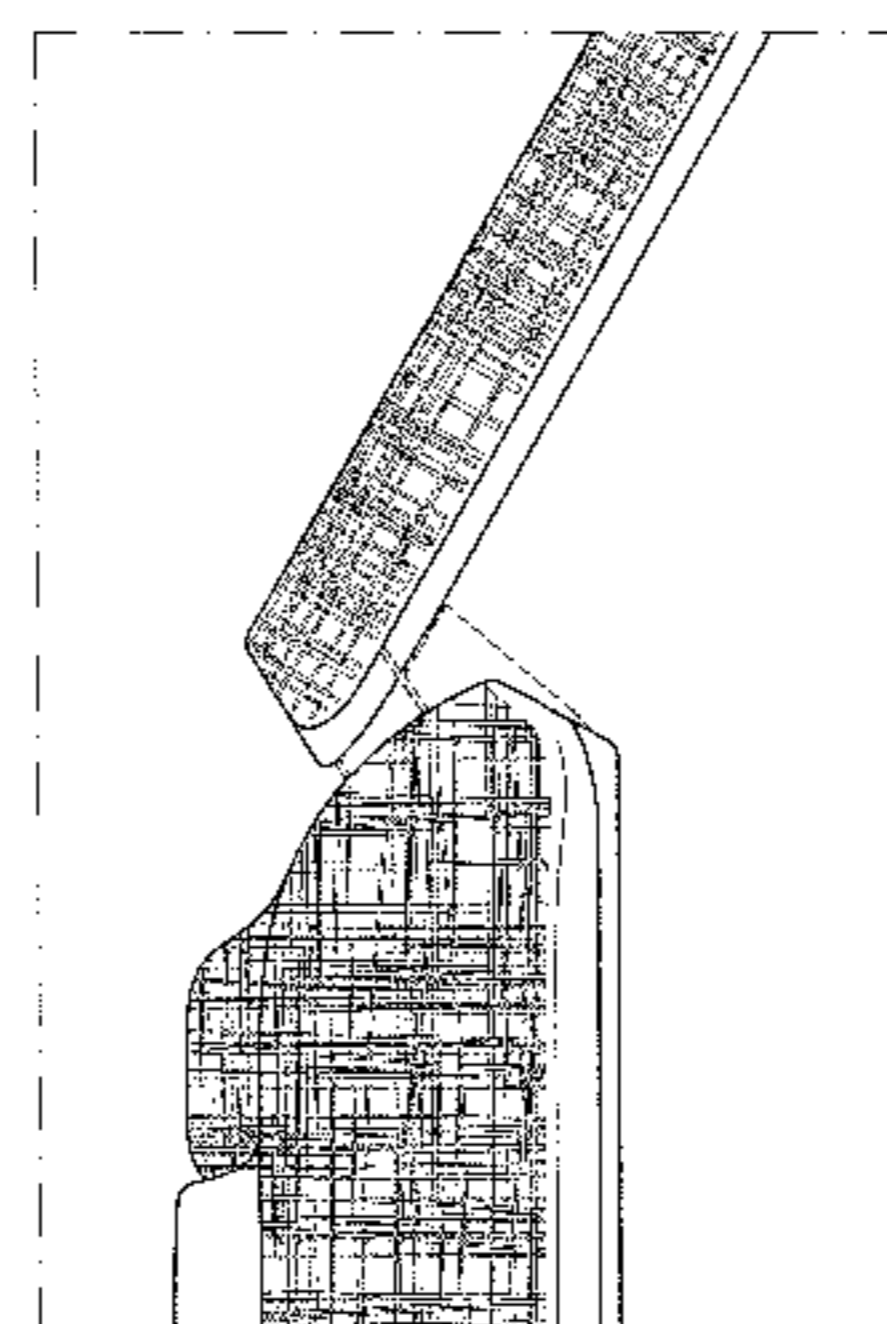
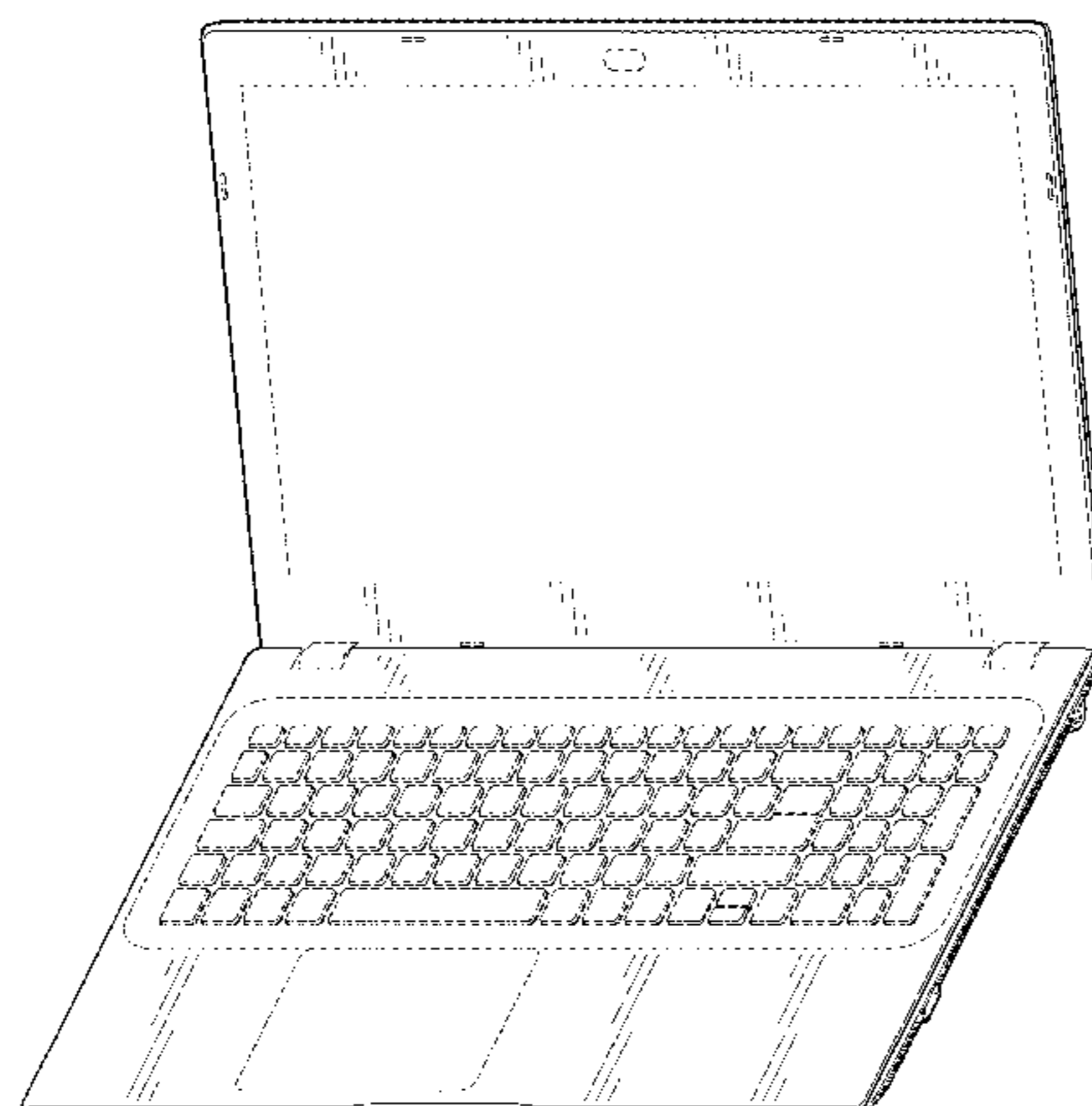


FIG. **22** is an enlarged view of an indicated portion of FIG. **5**;

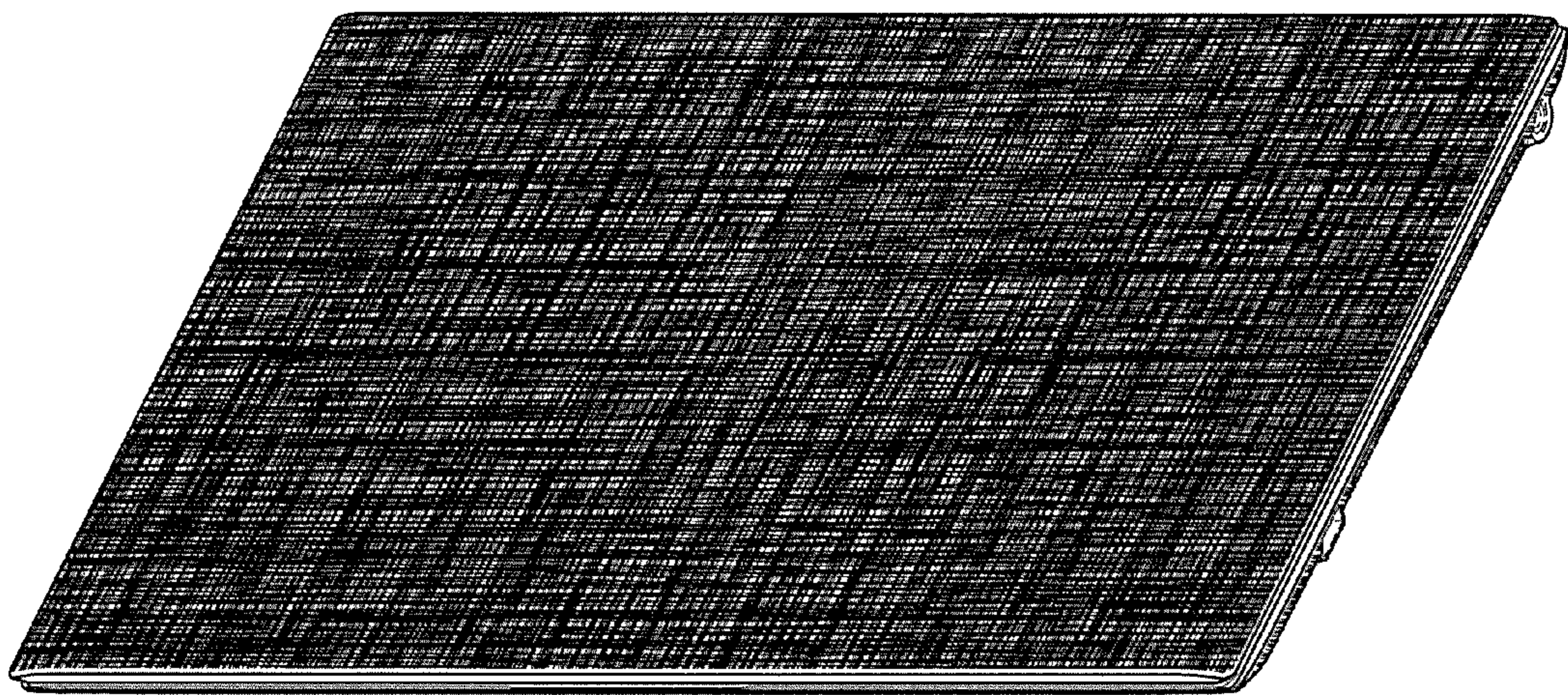

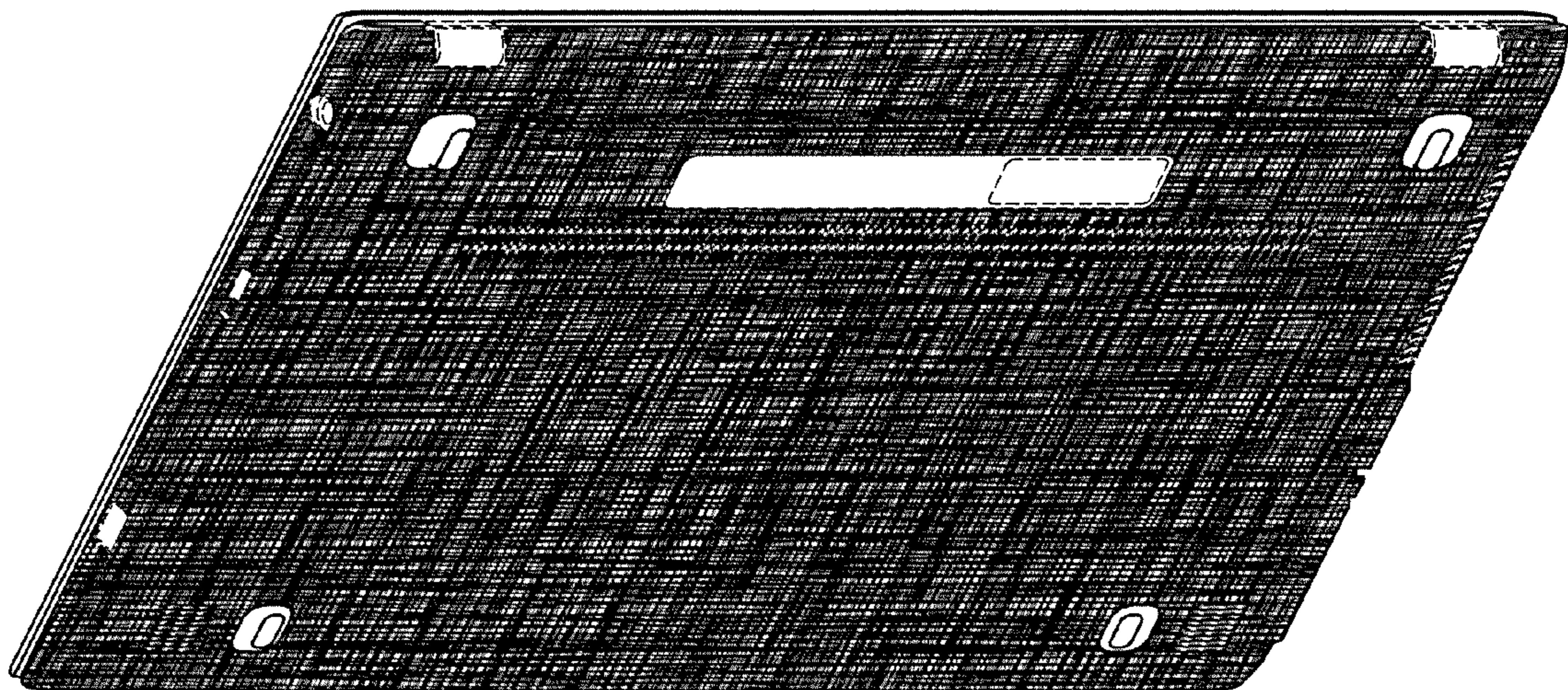

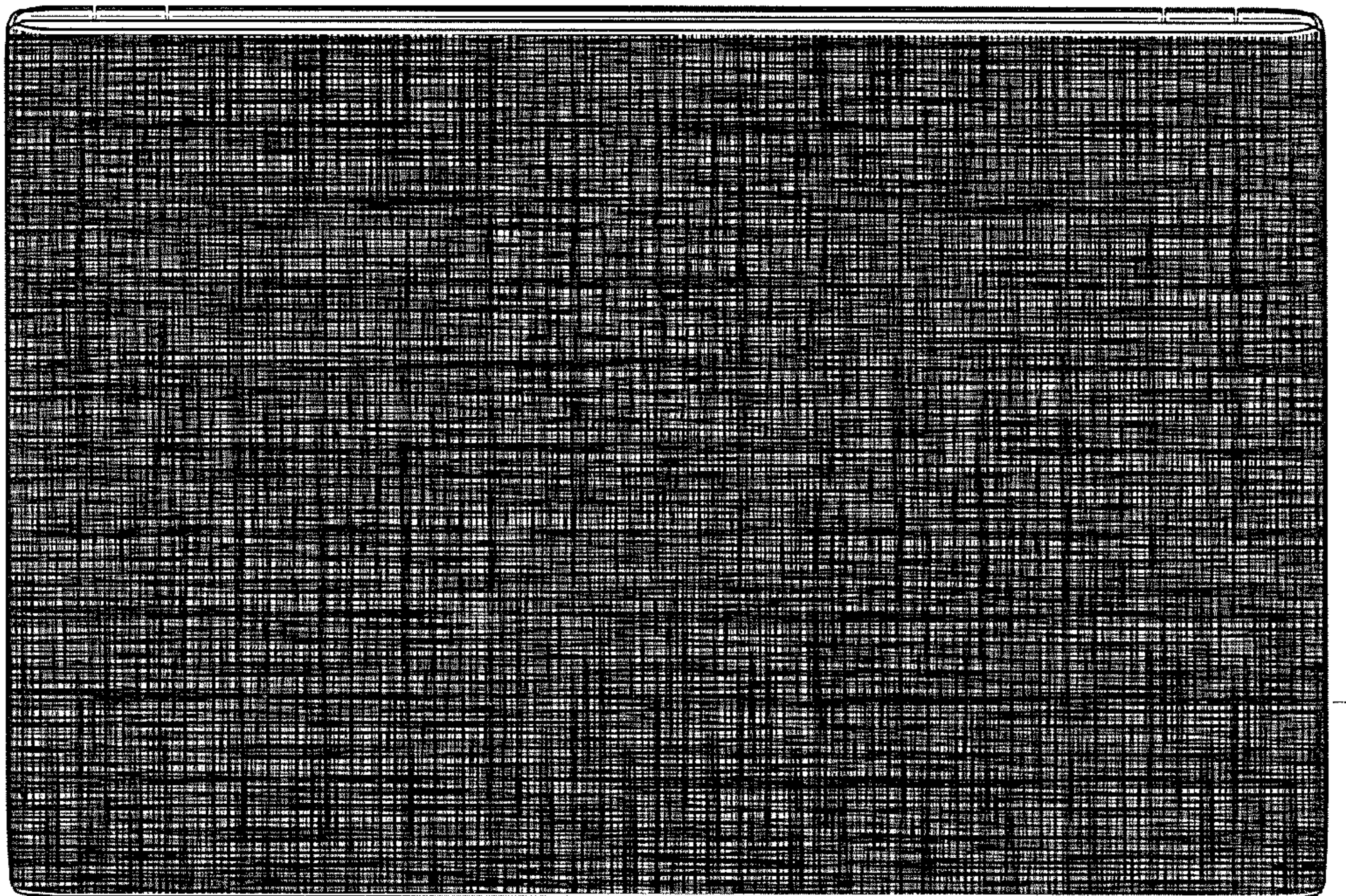

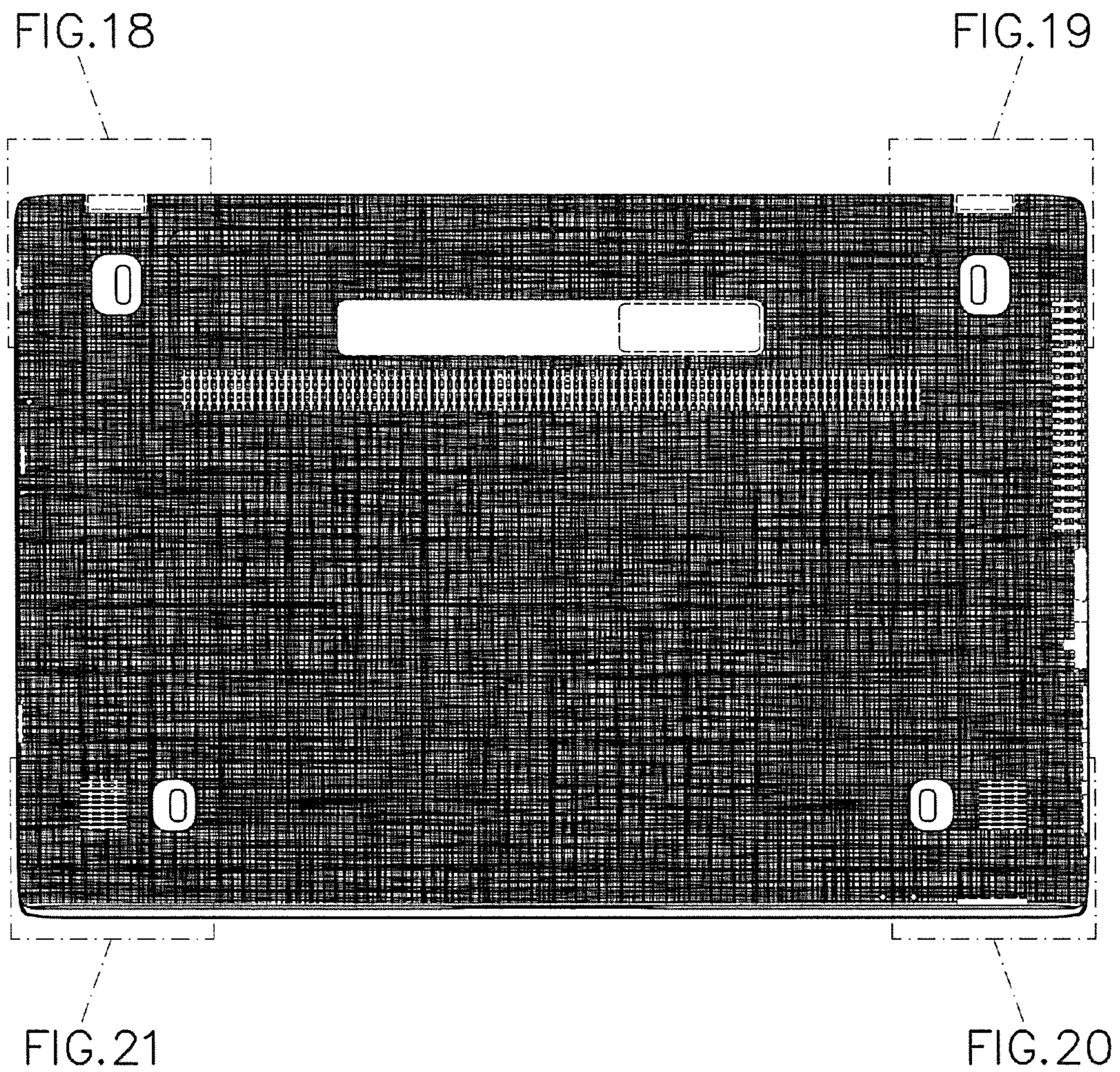

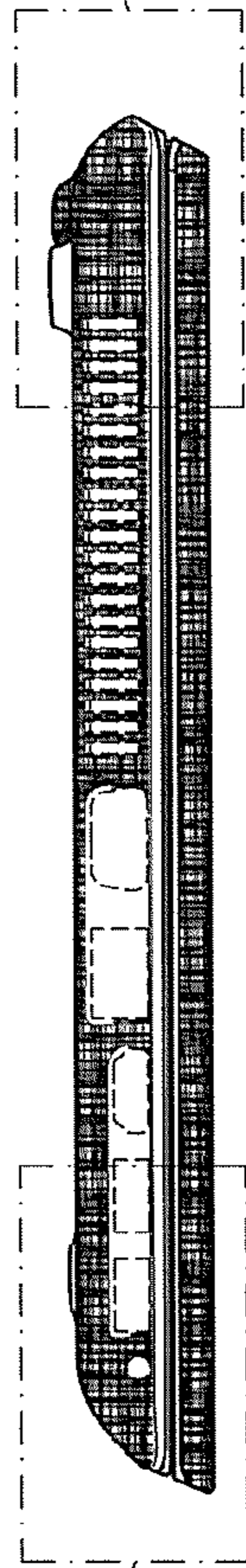

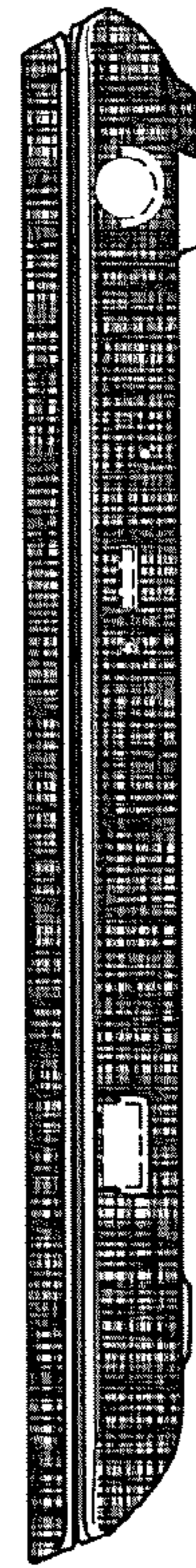

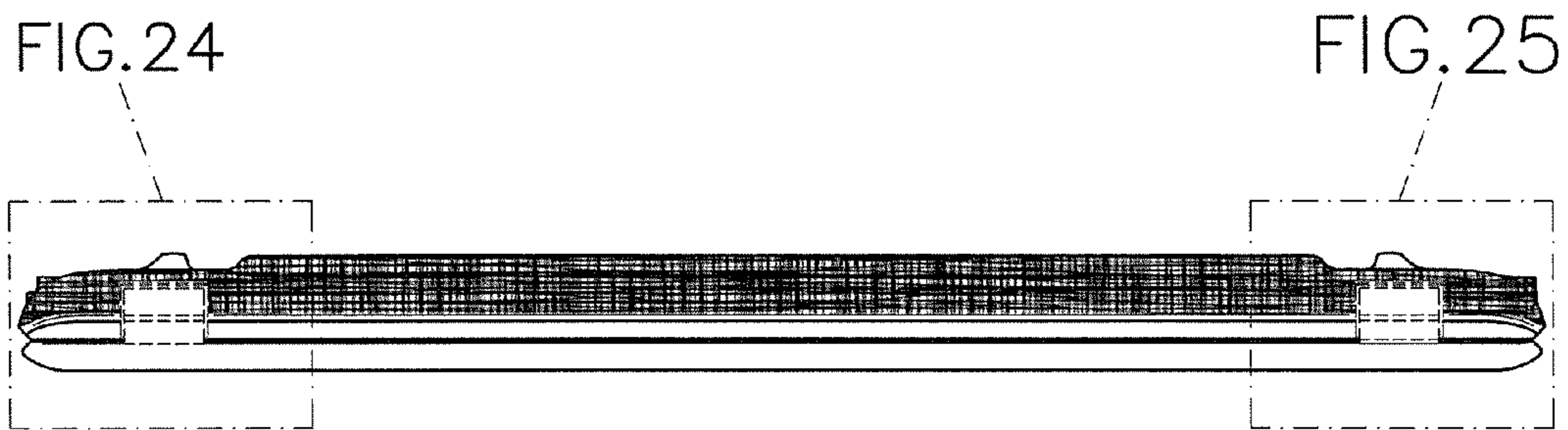

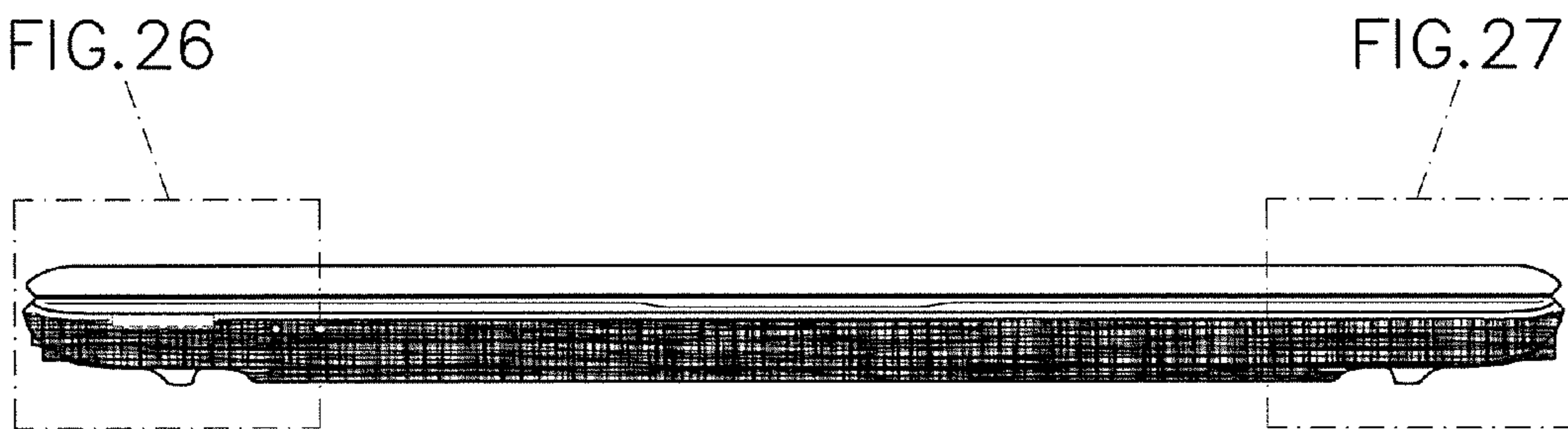

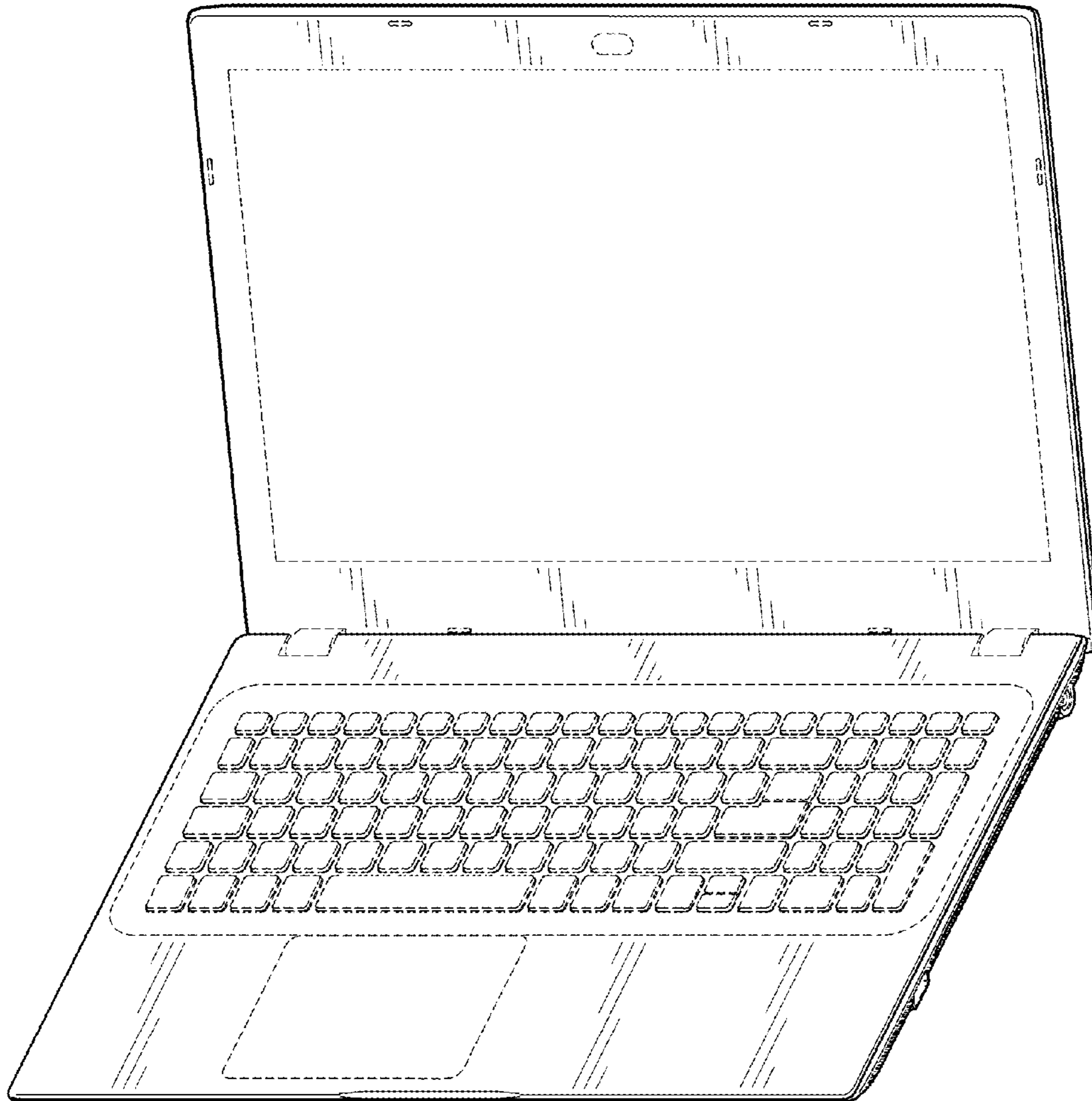

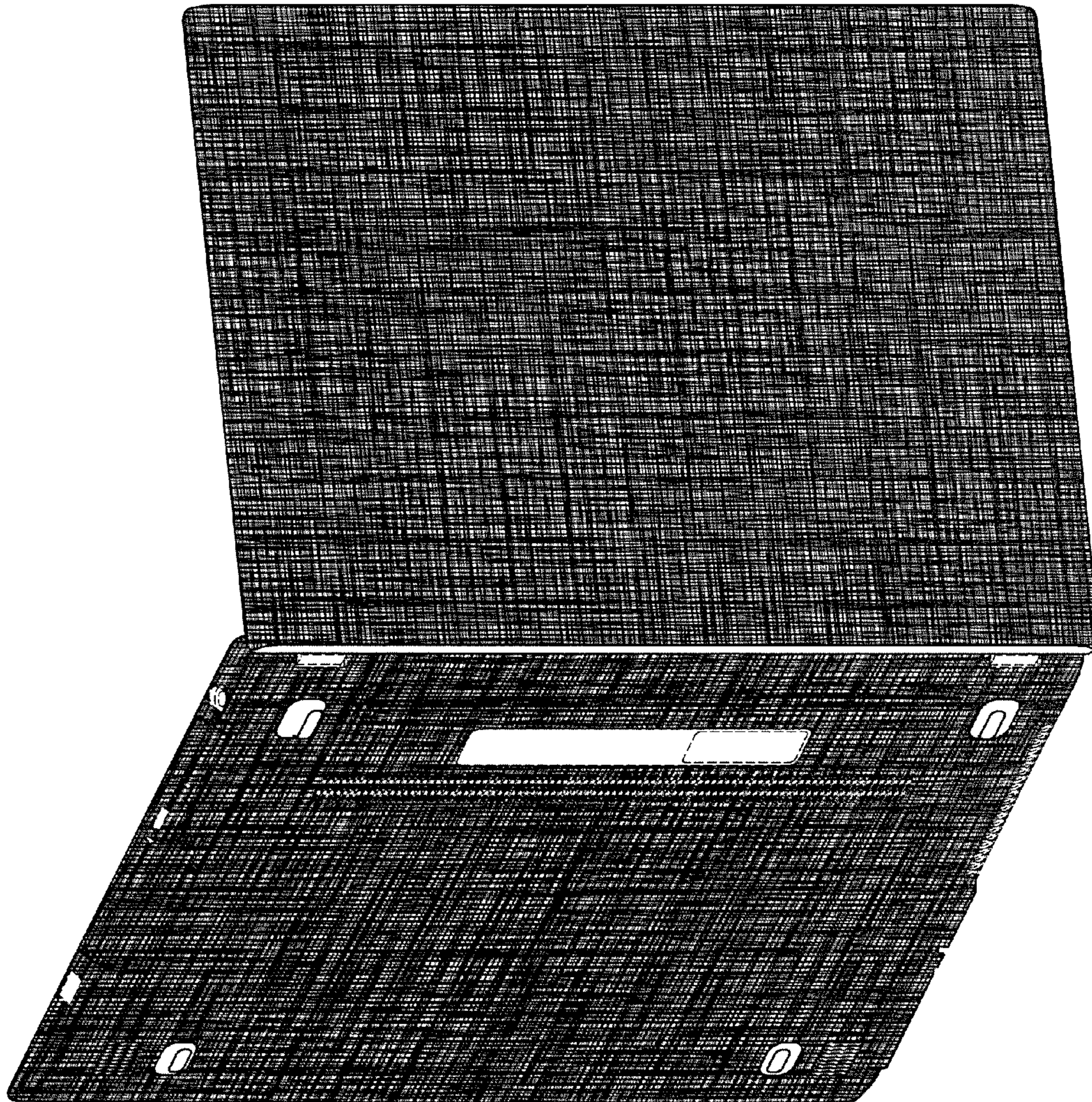

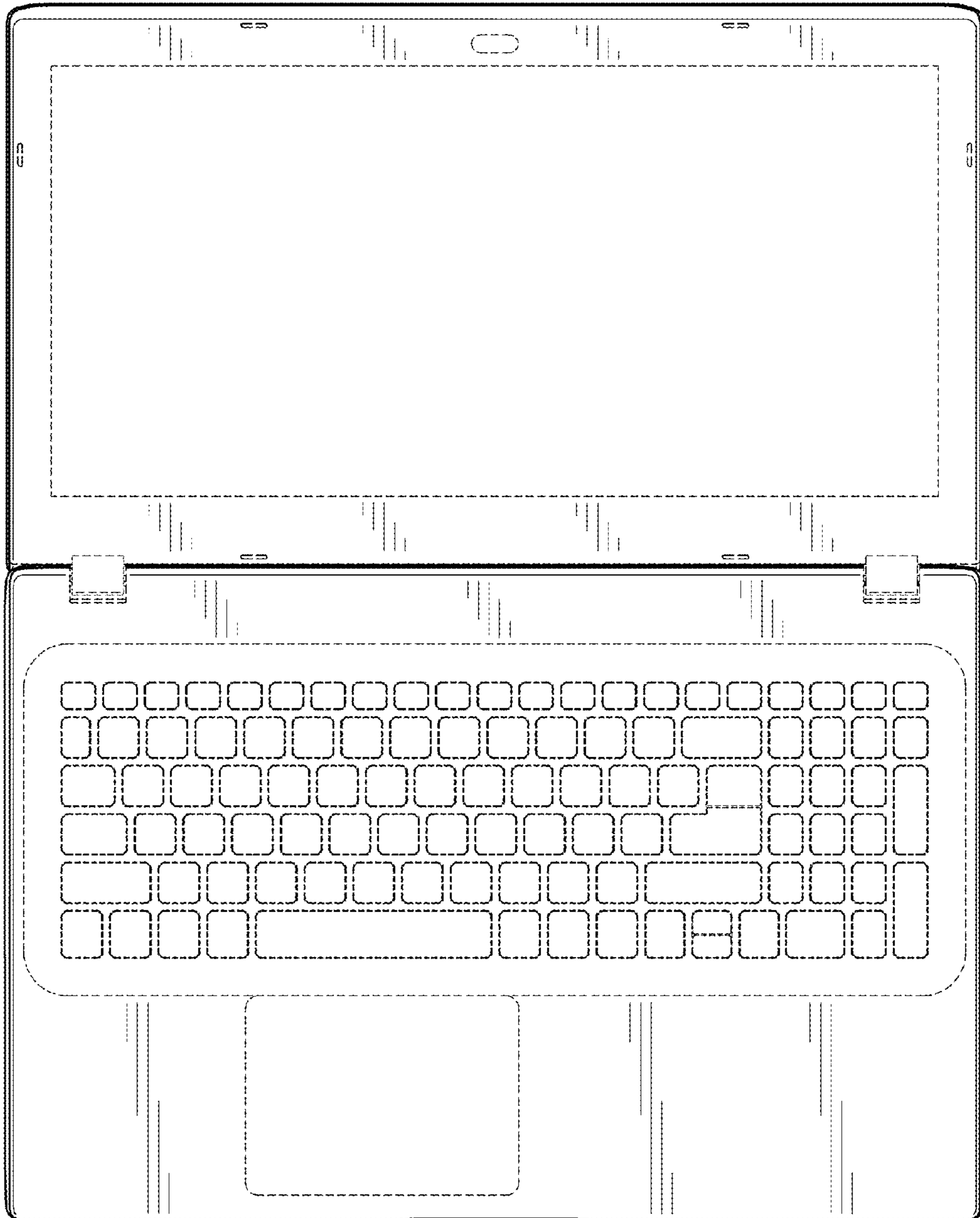

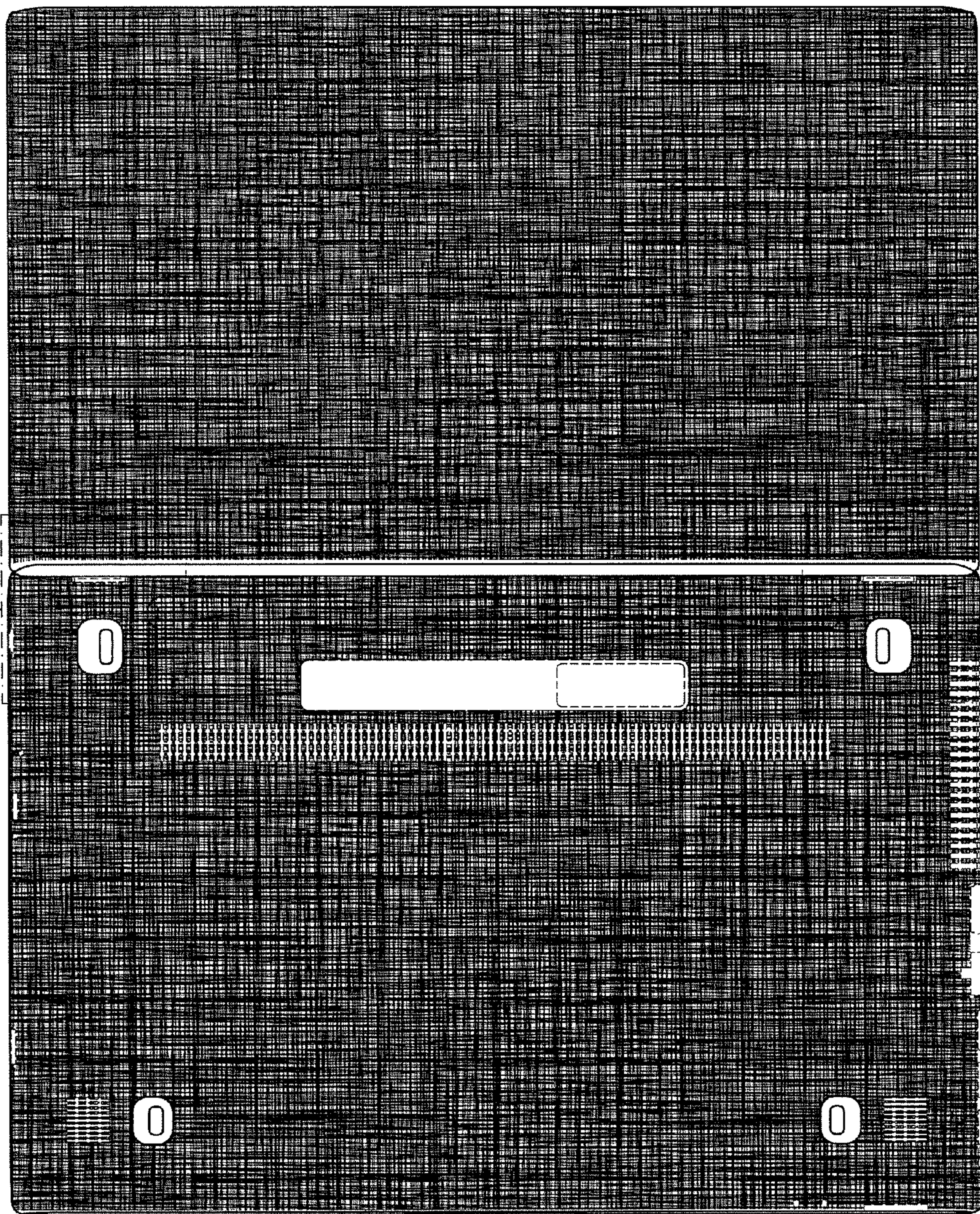

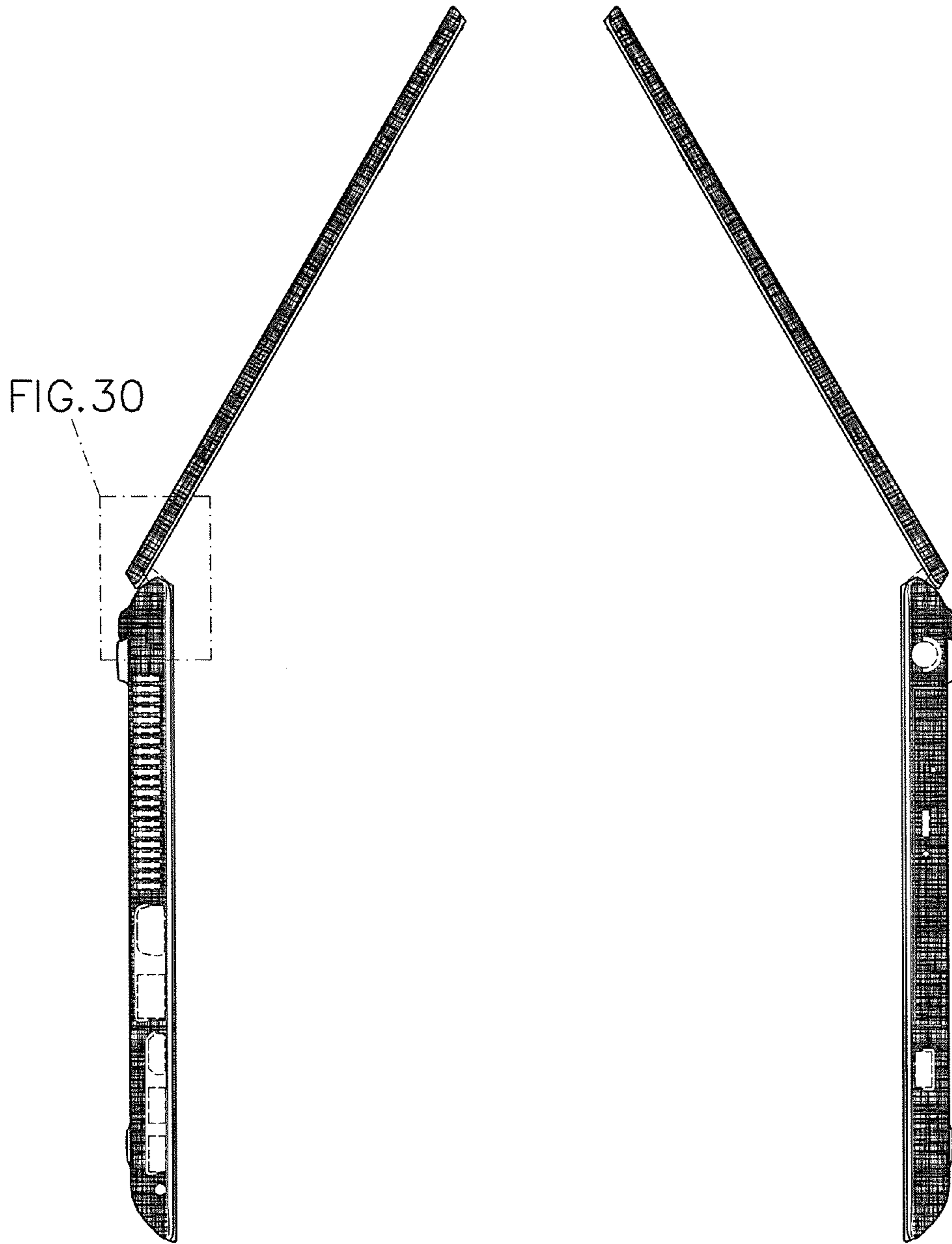

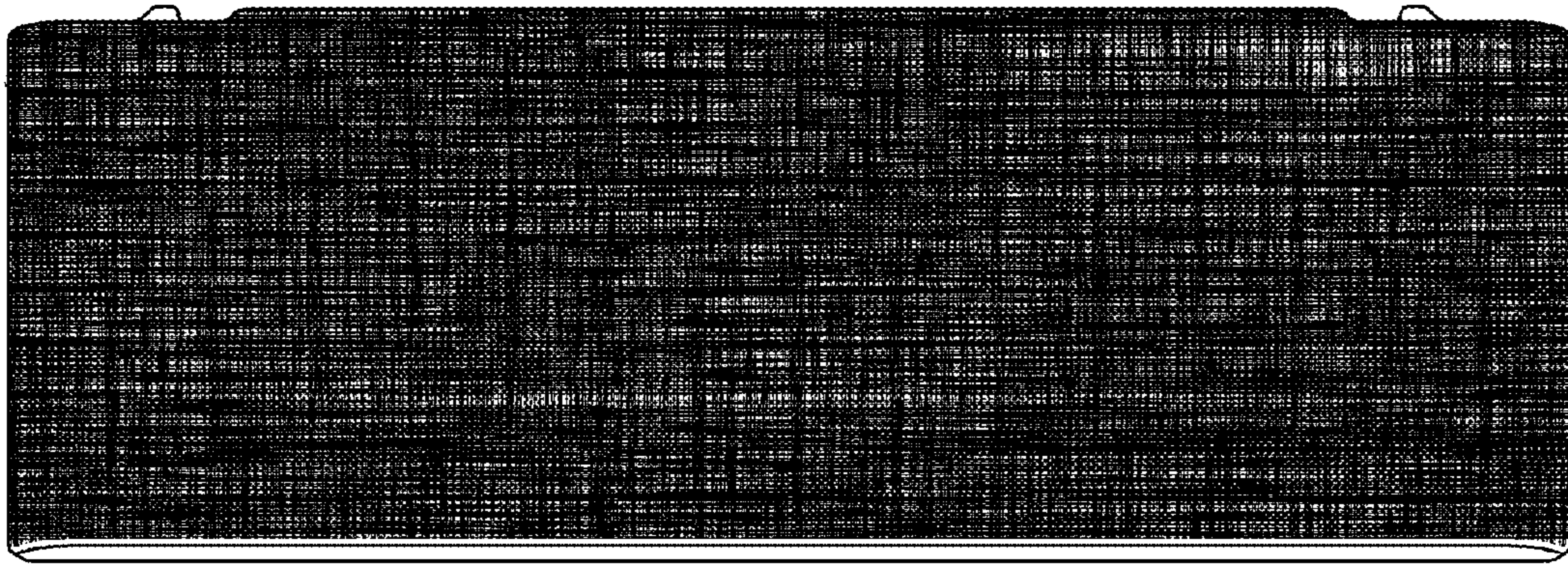

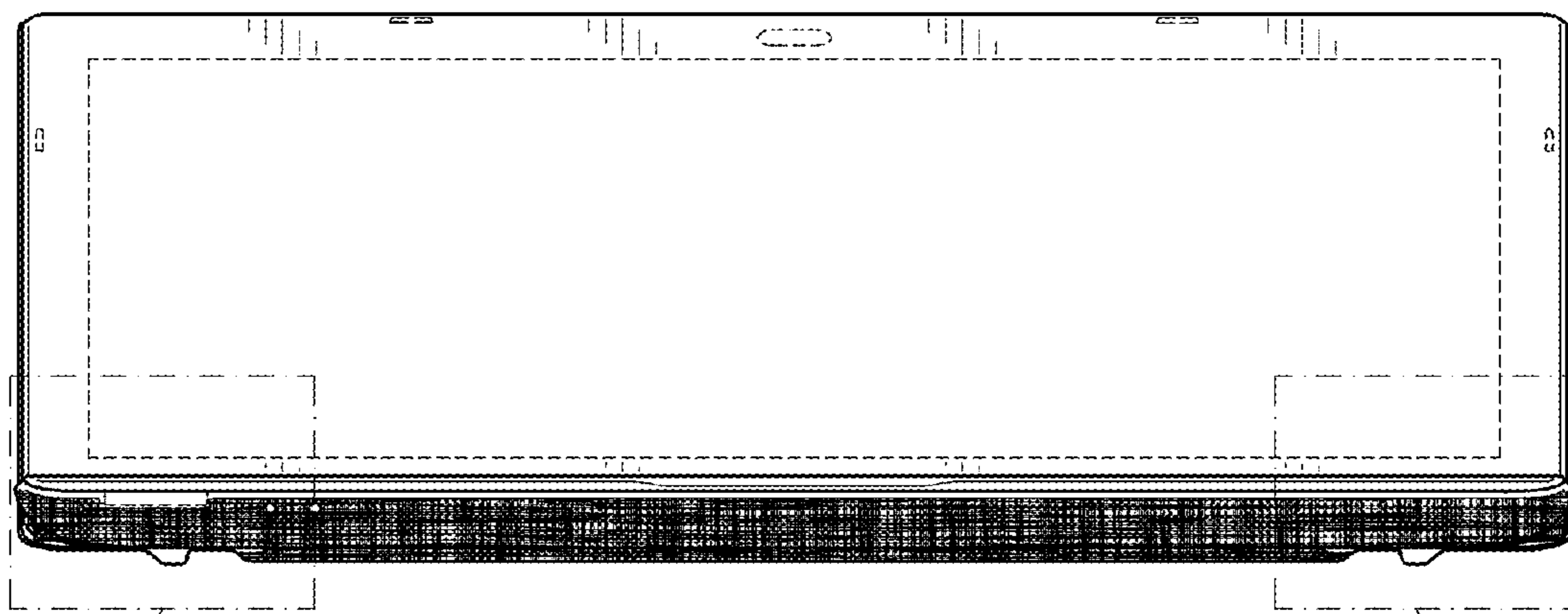

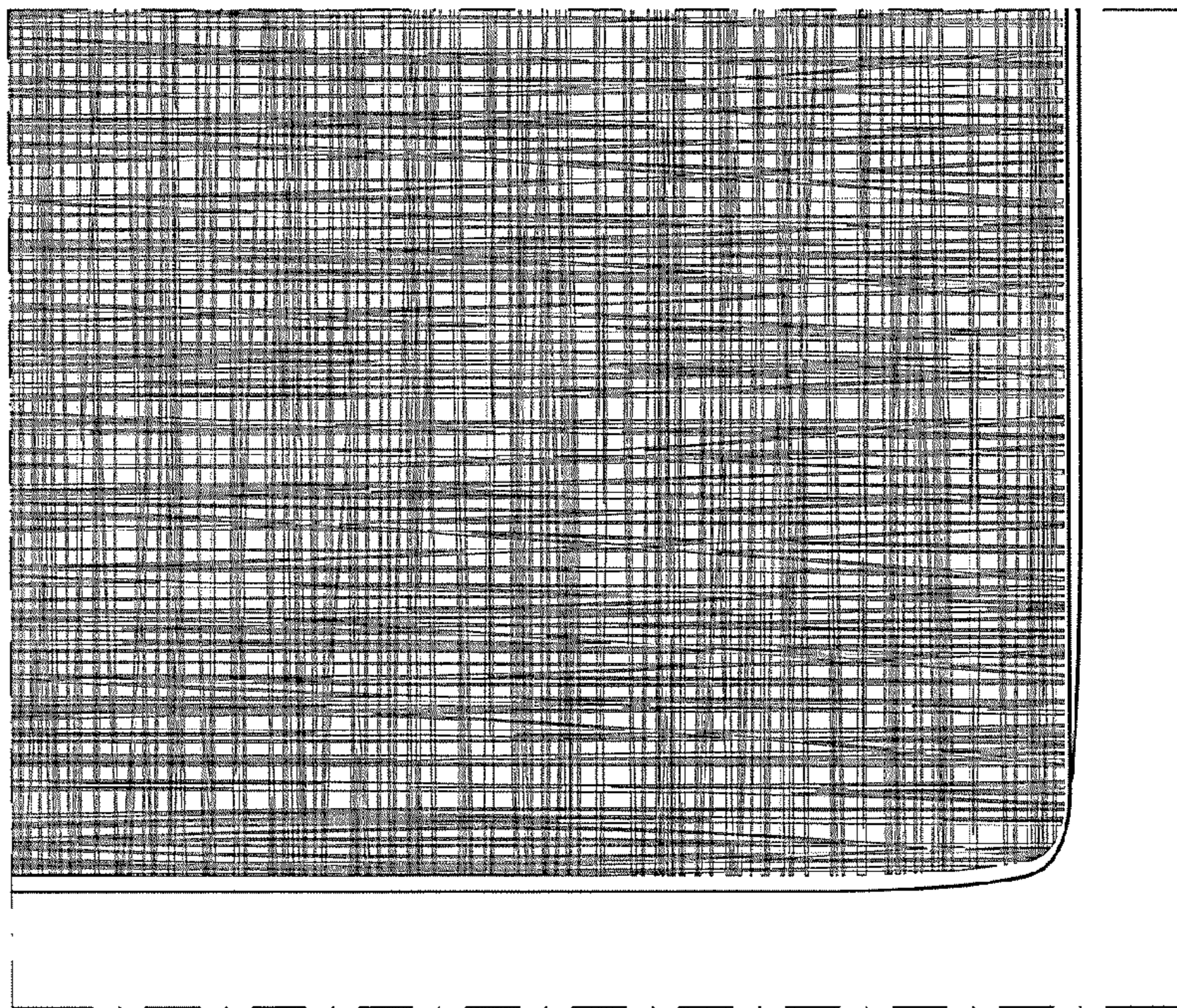

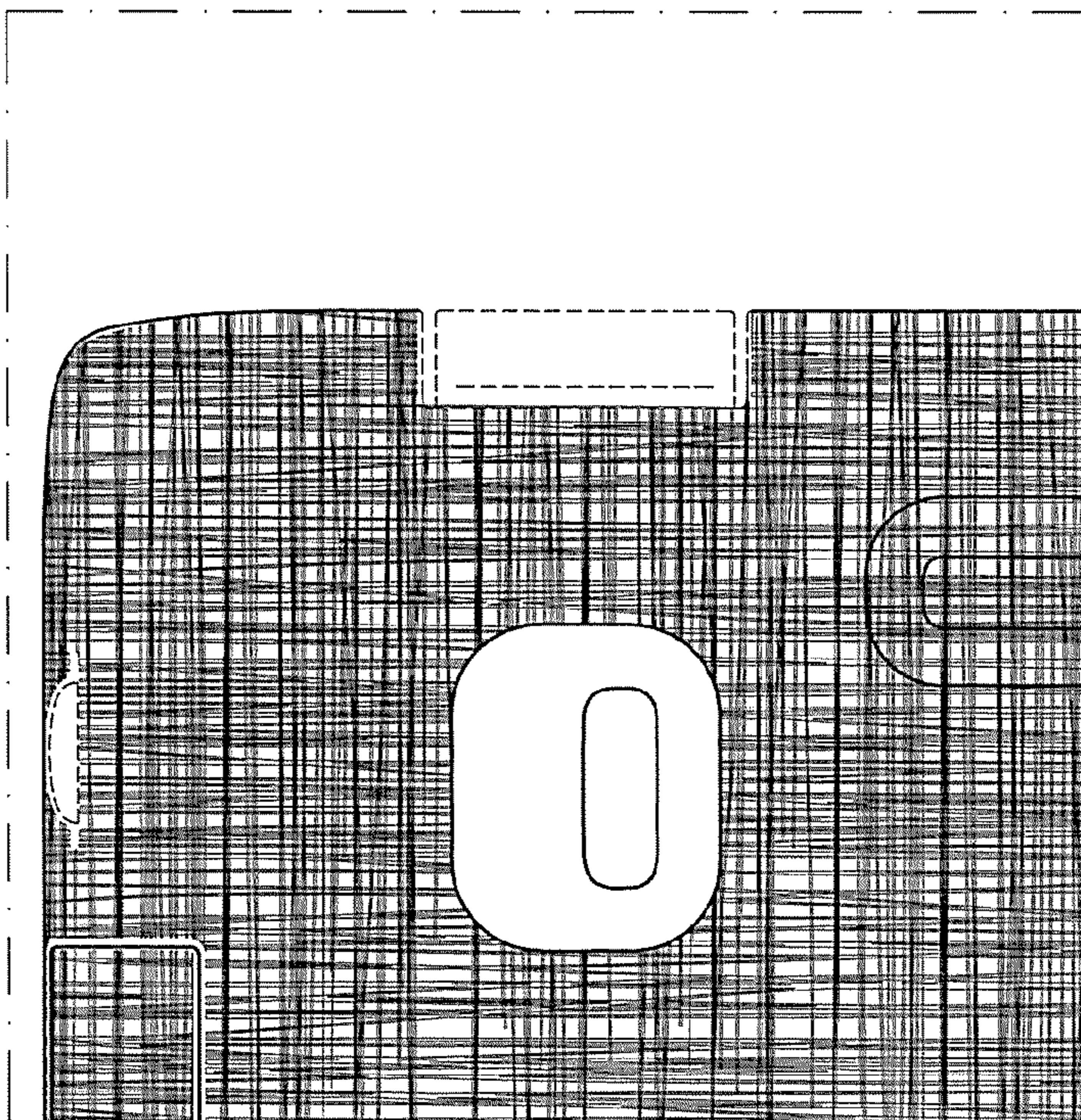

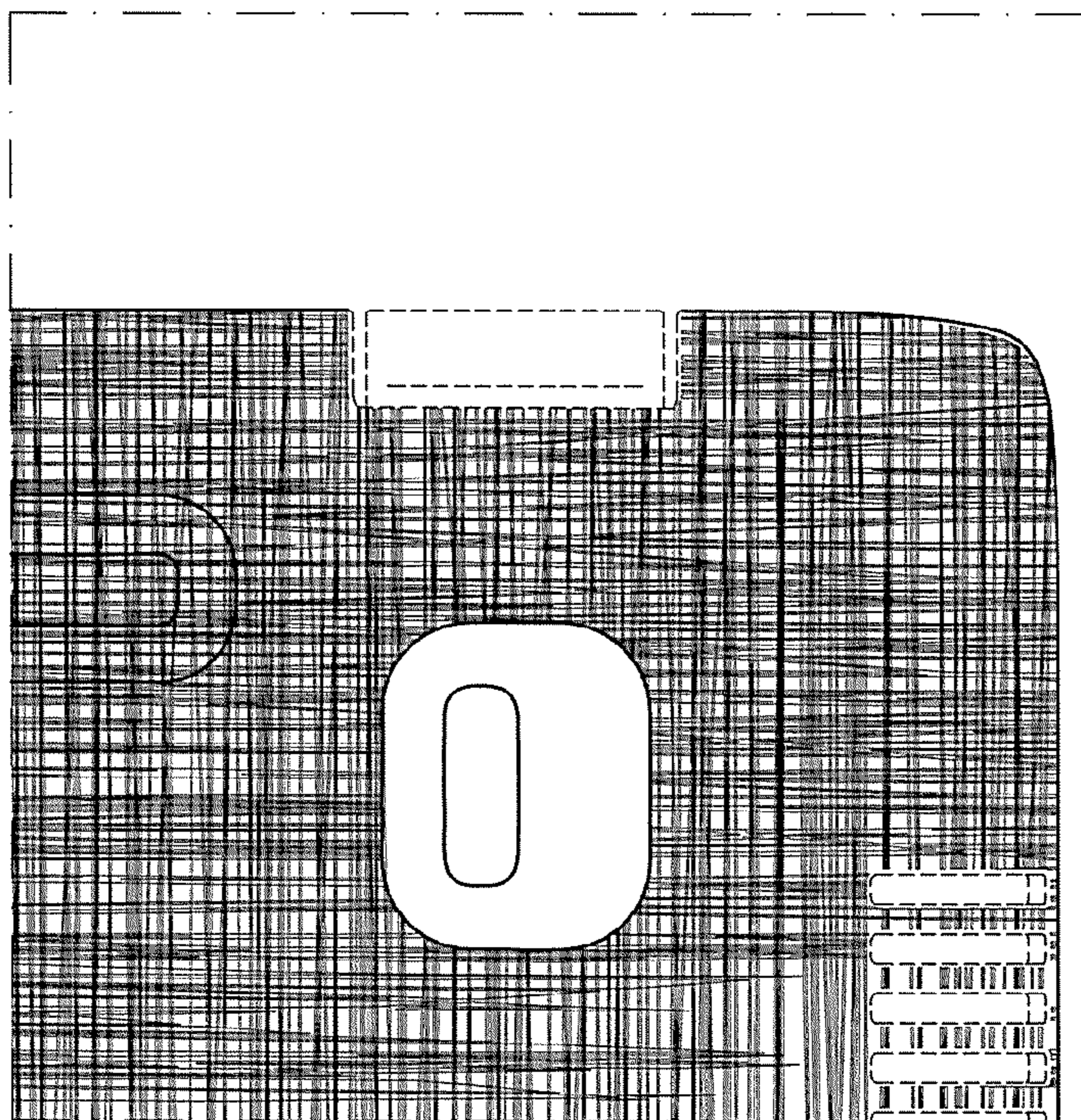

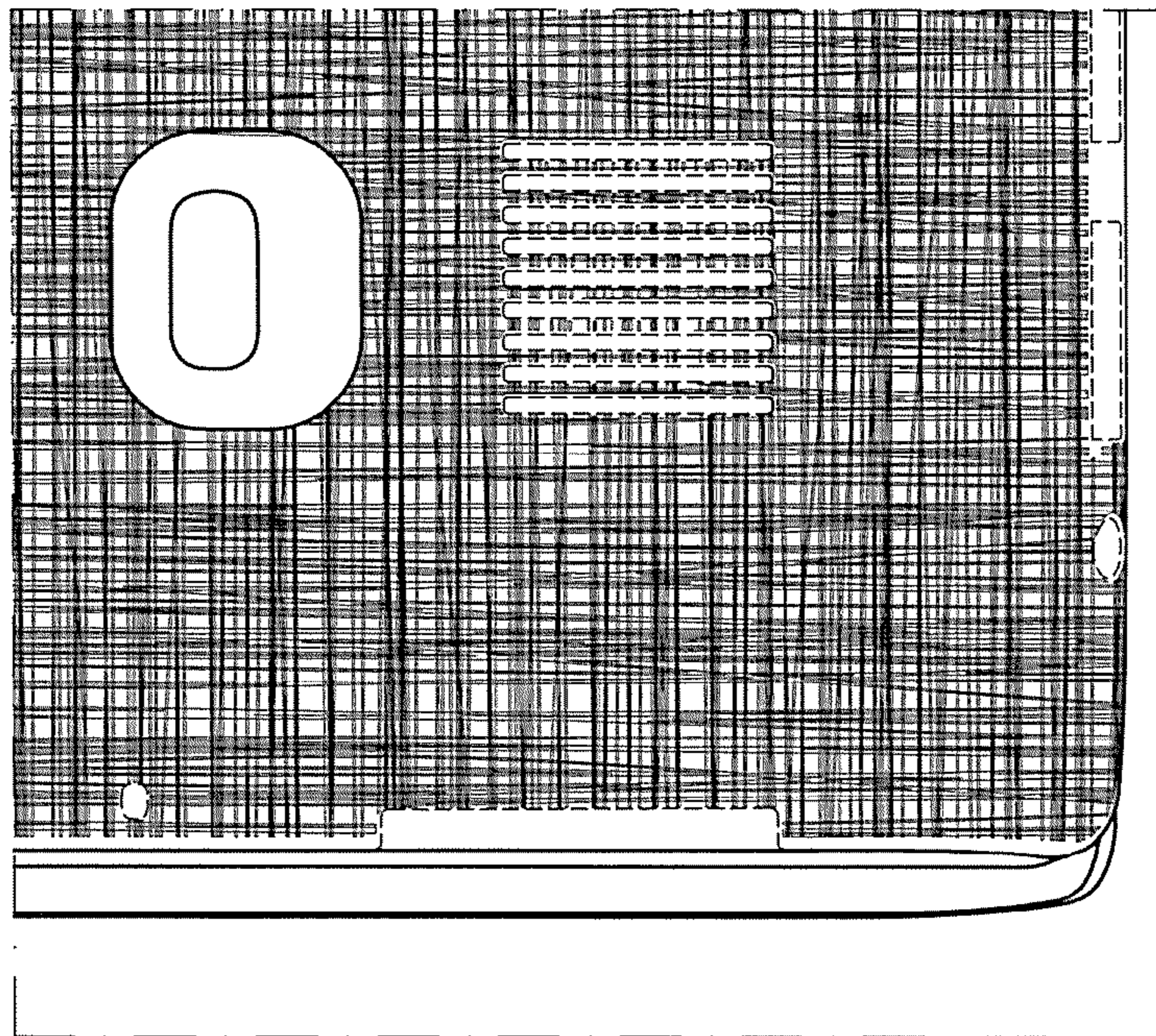

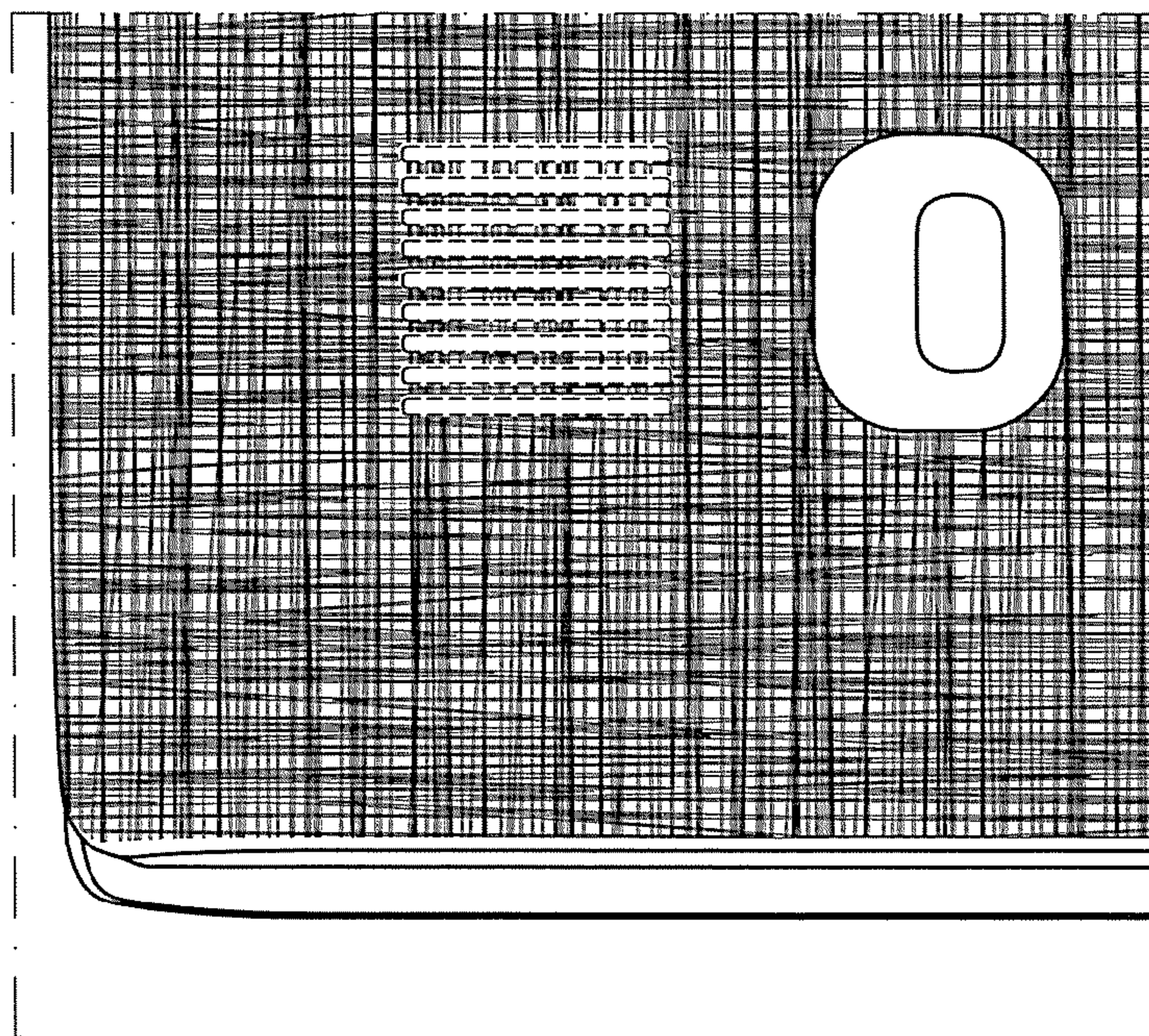

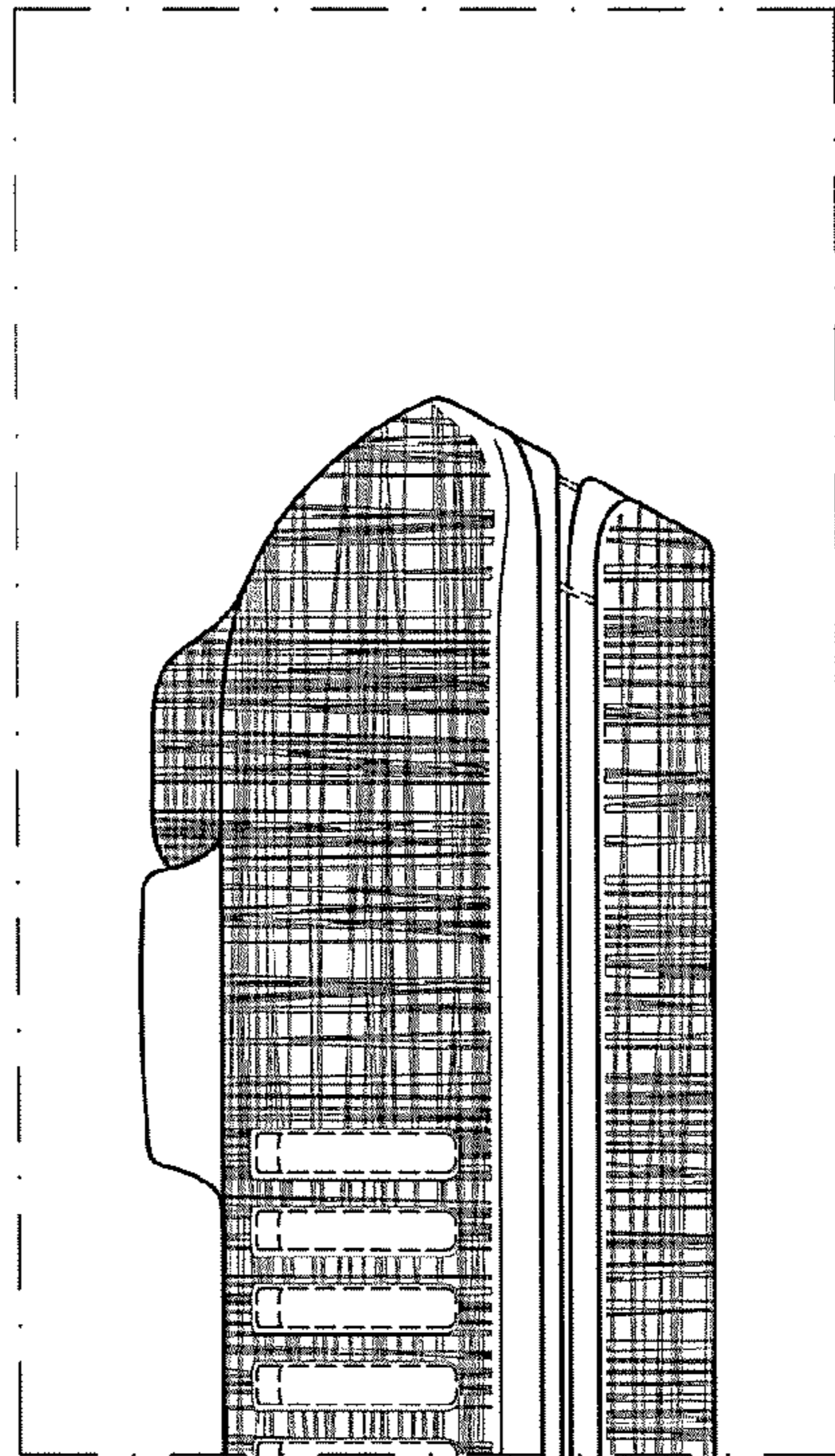

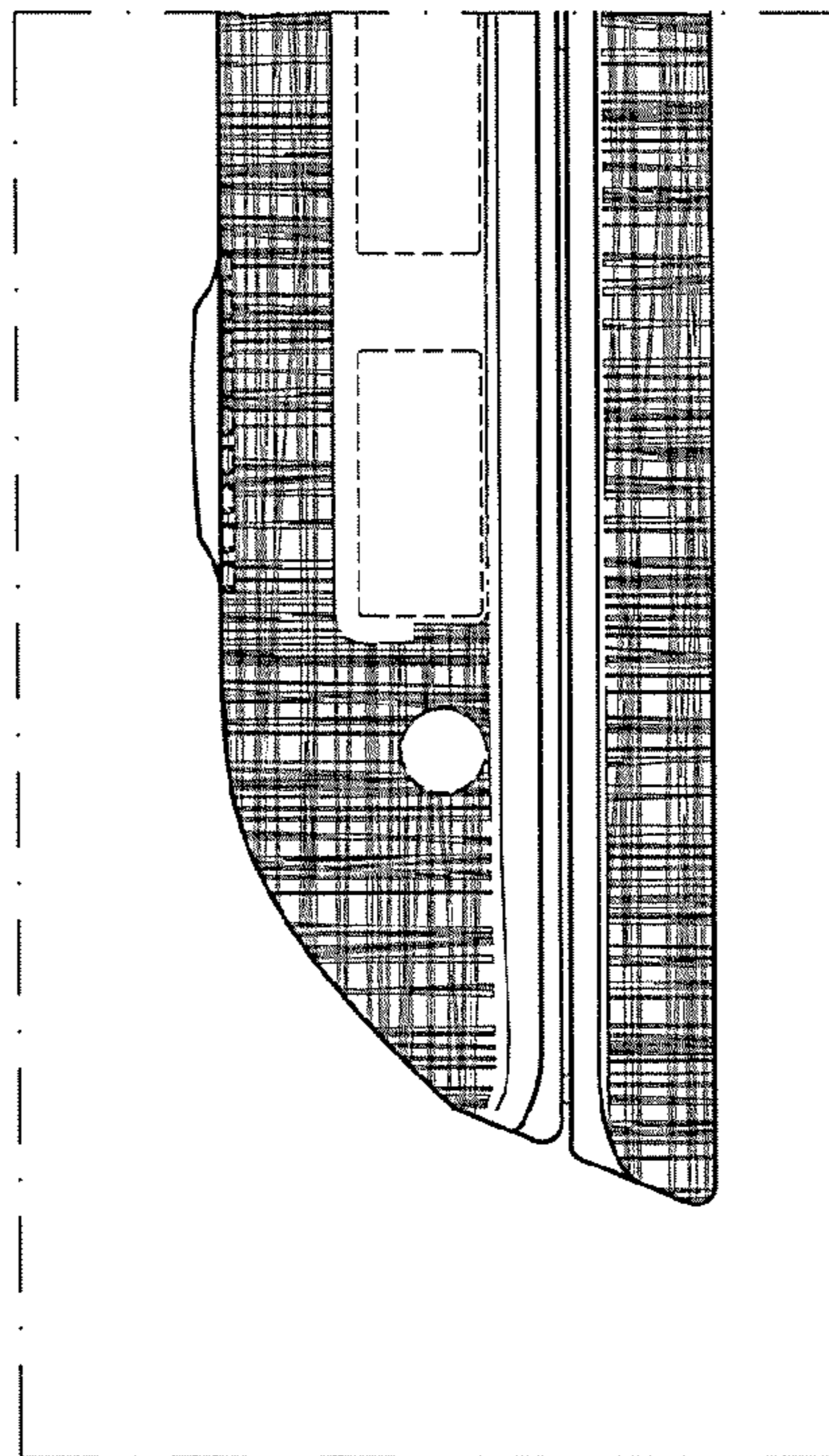

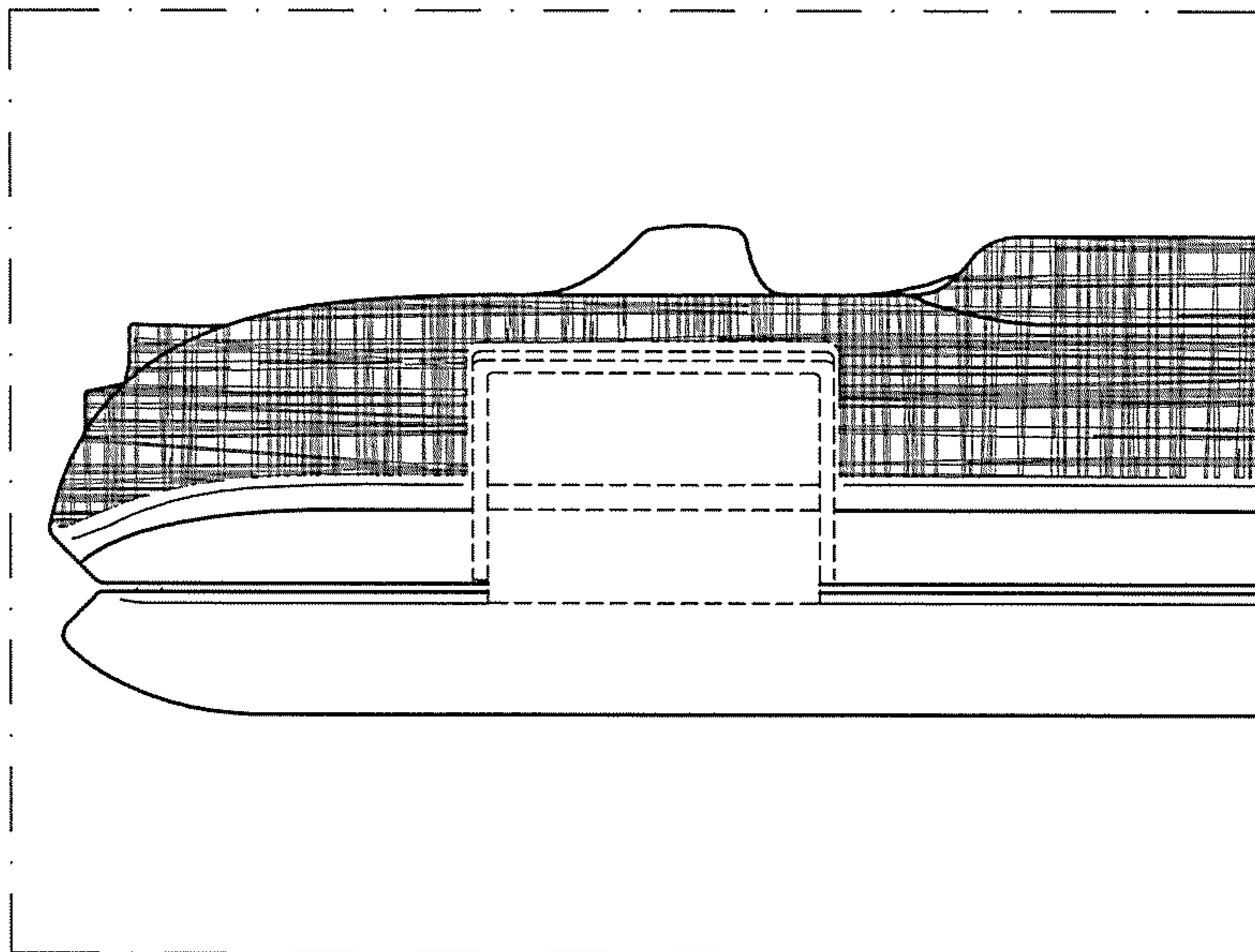

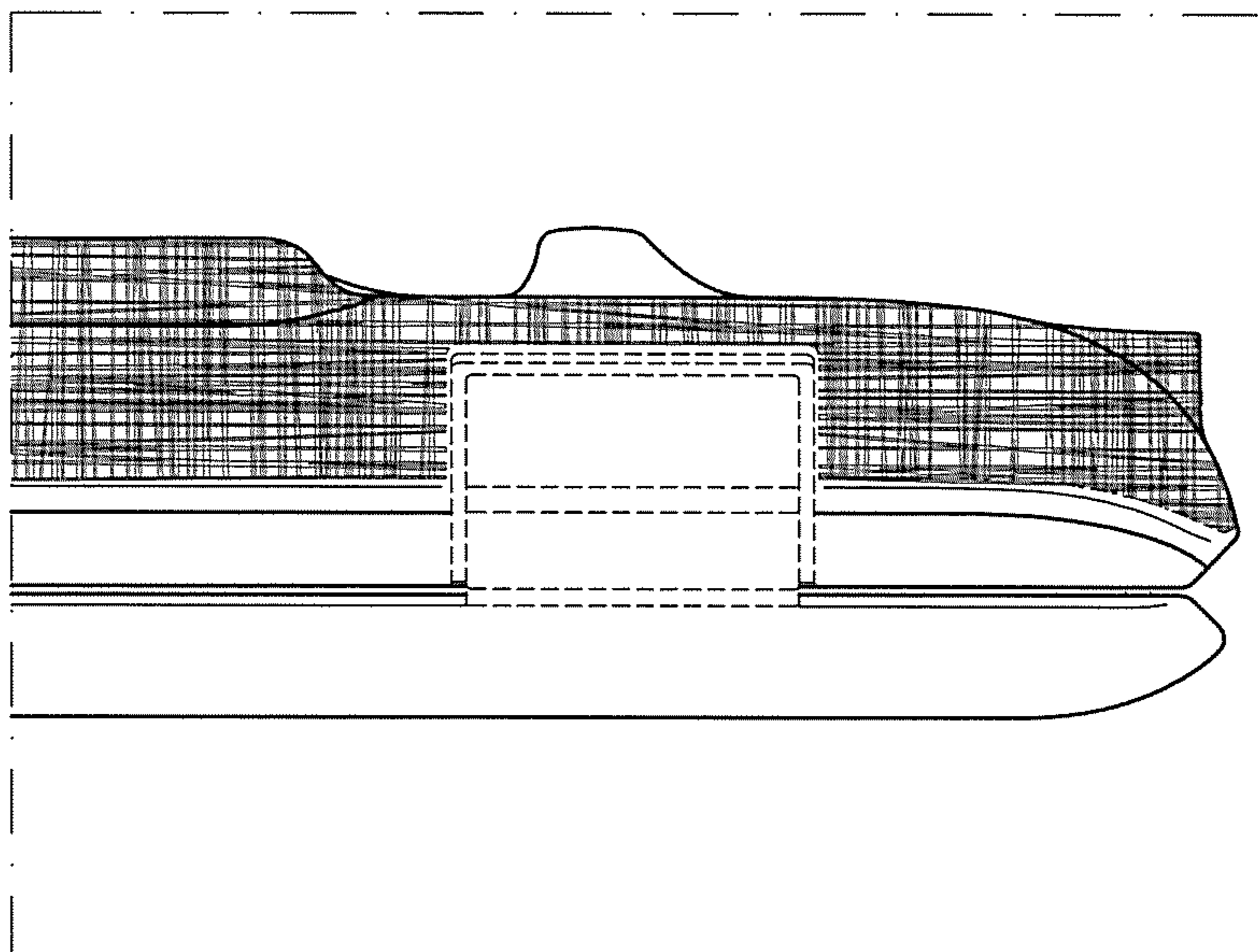

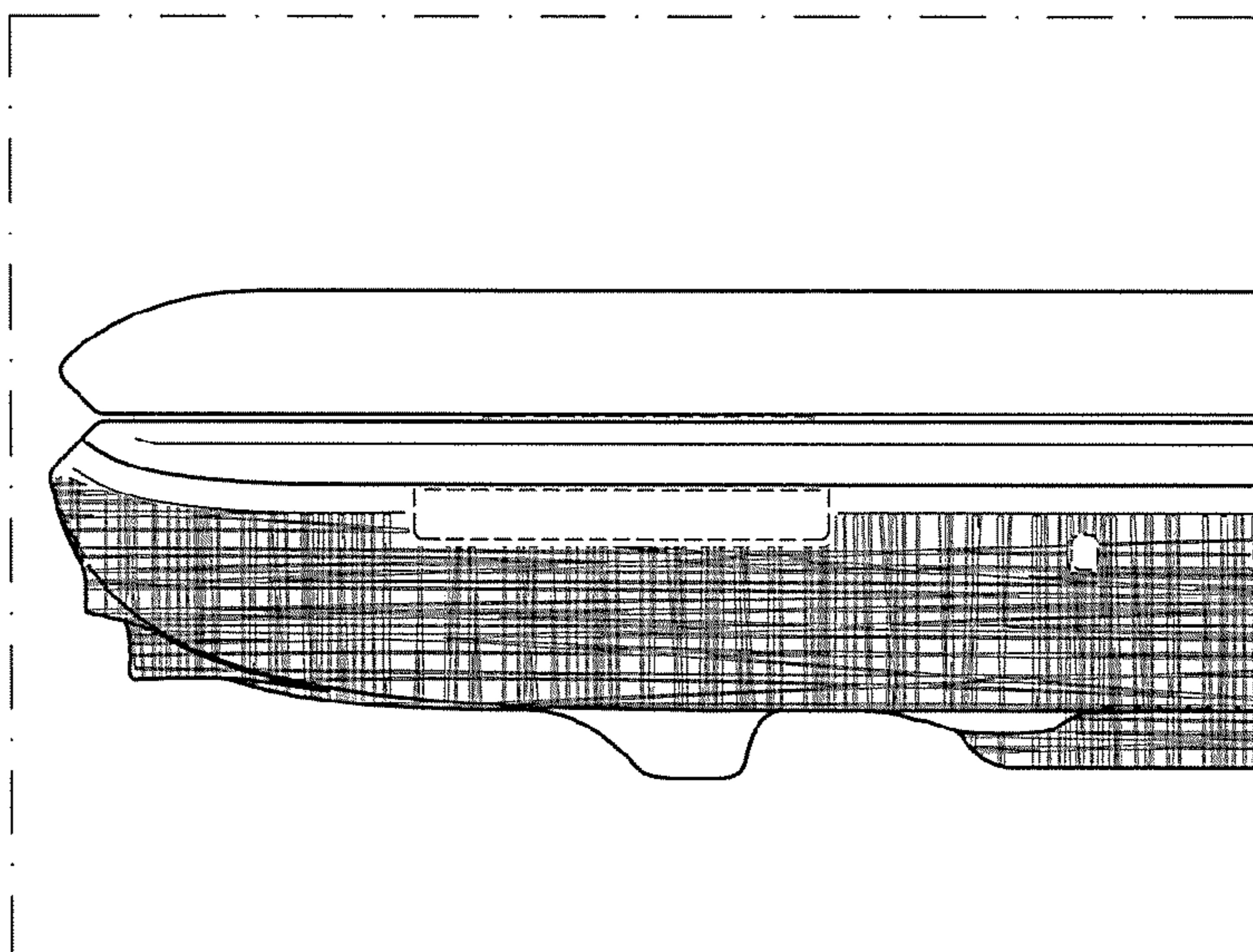

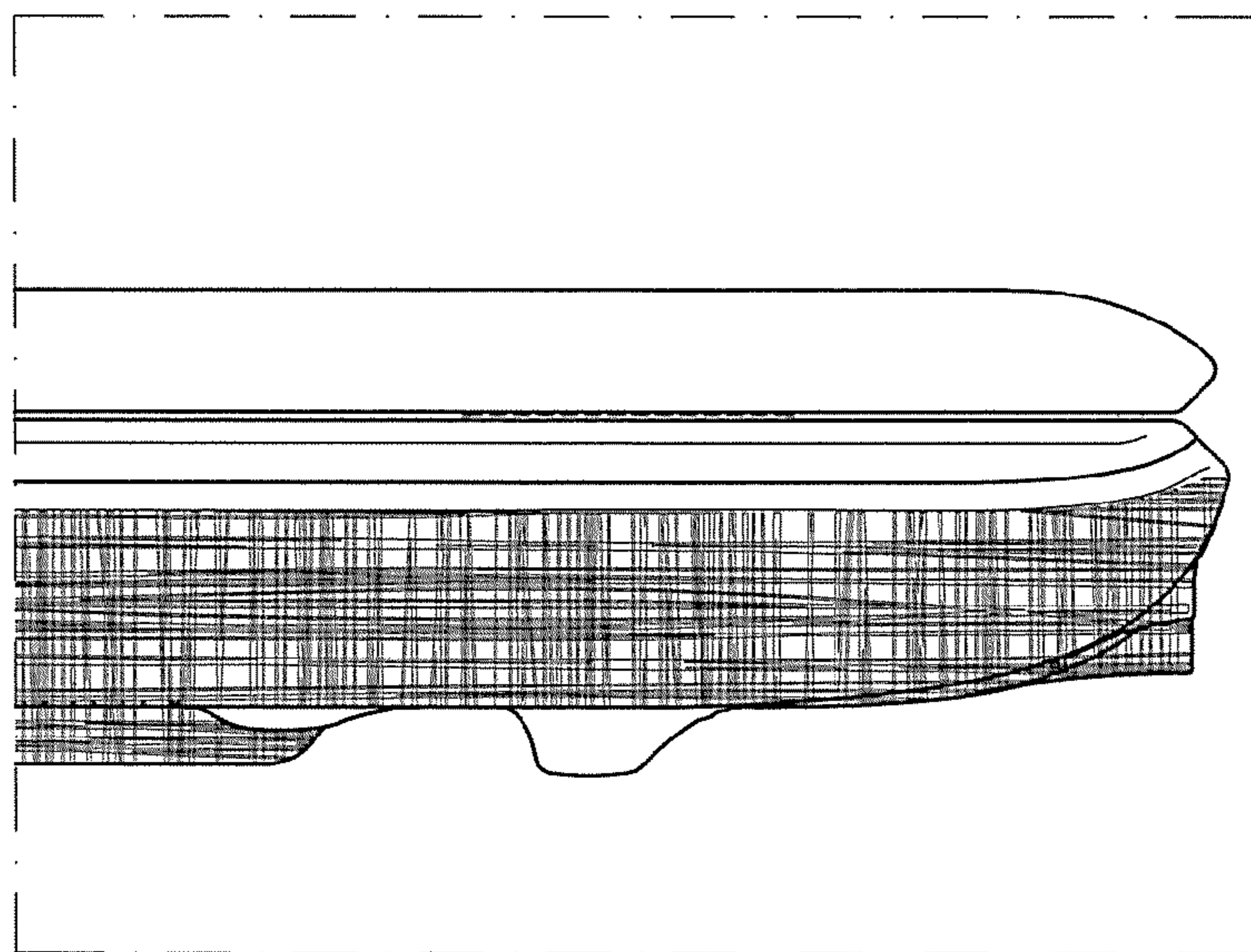

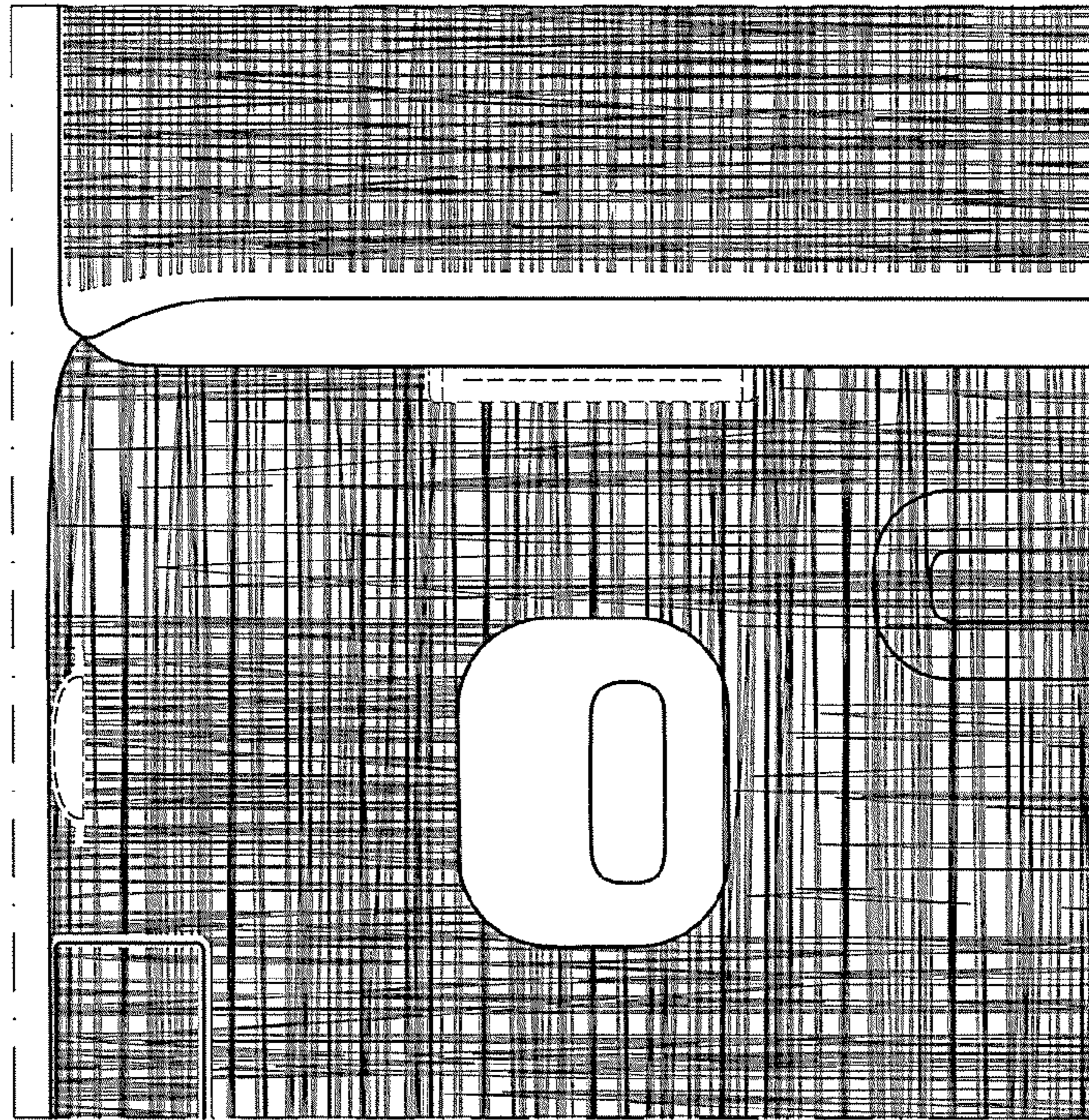

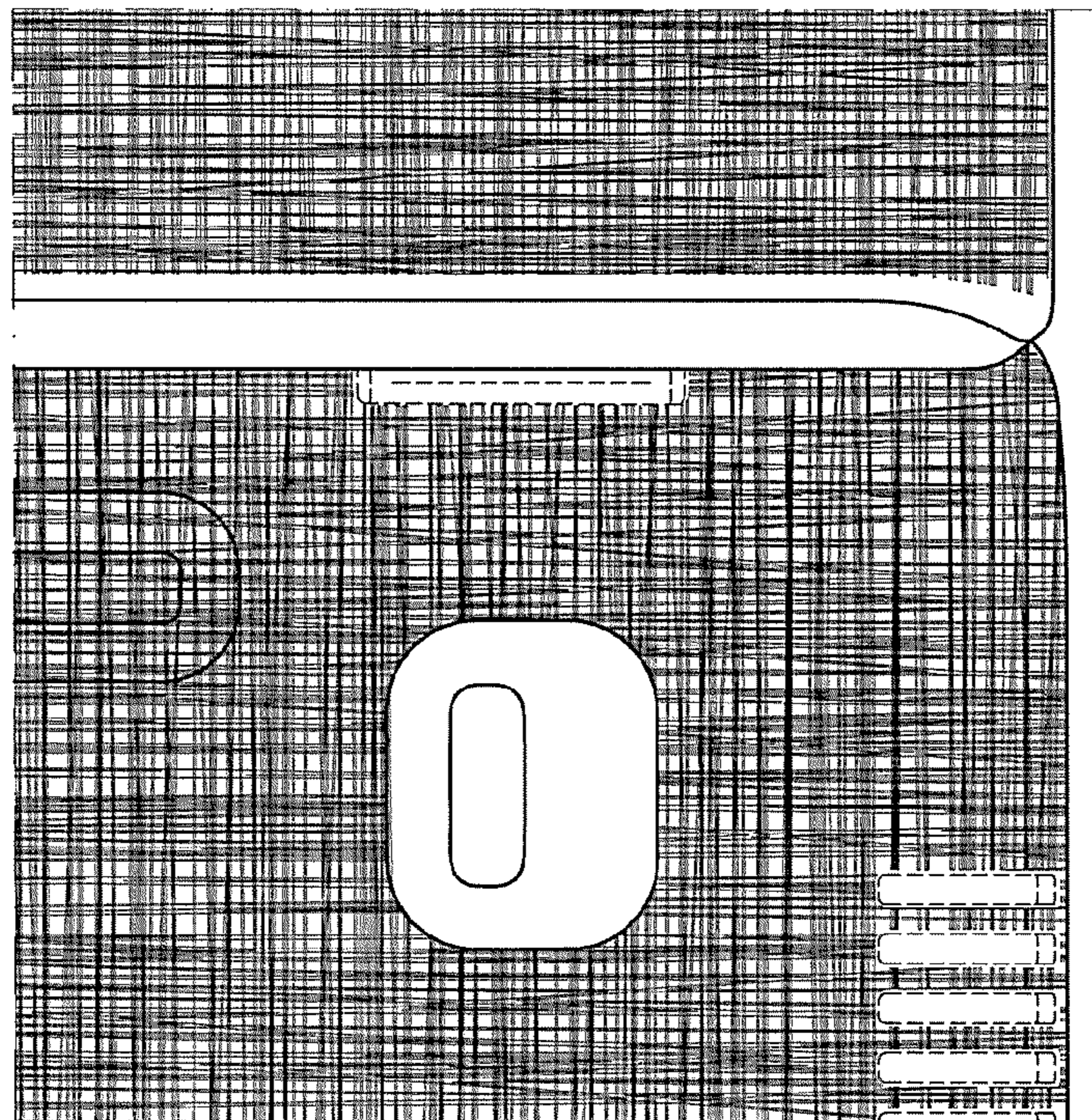

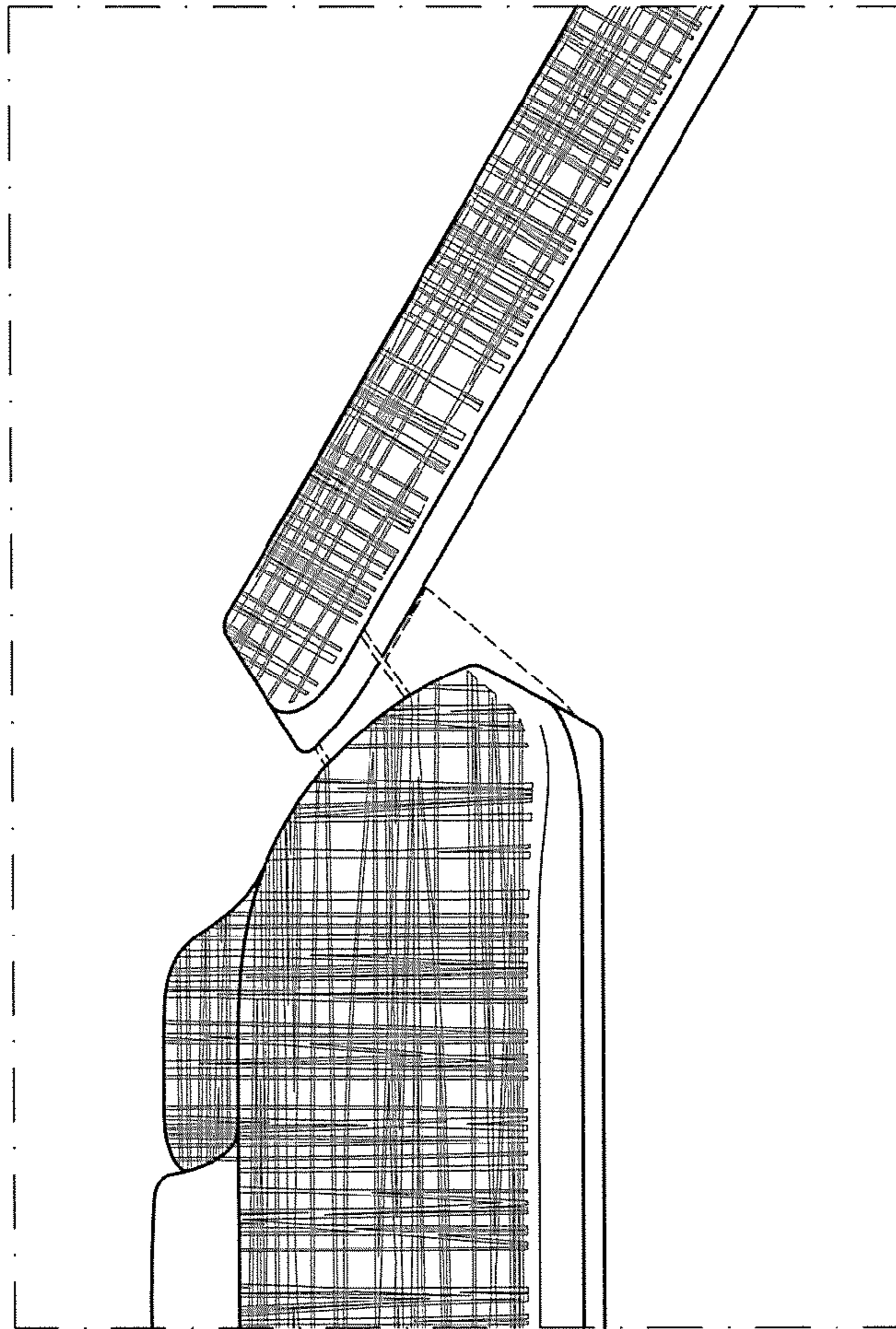

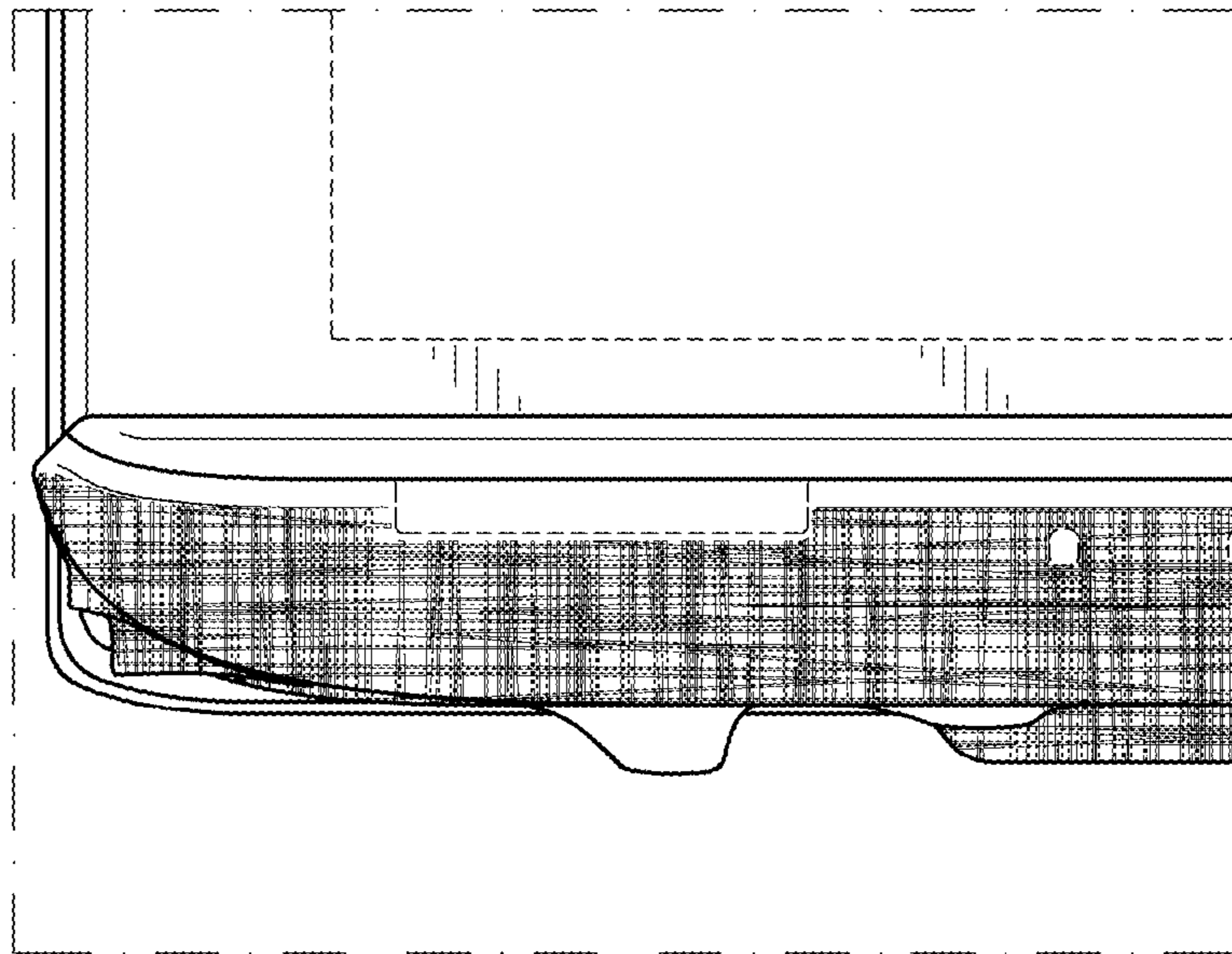

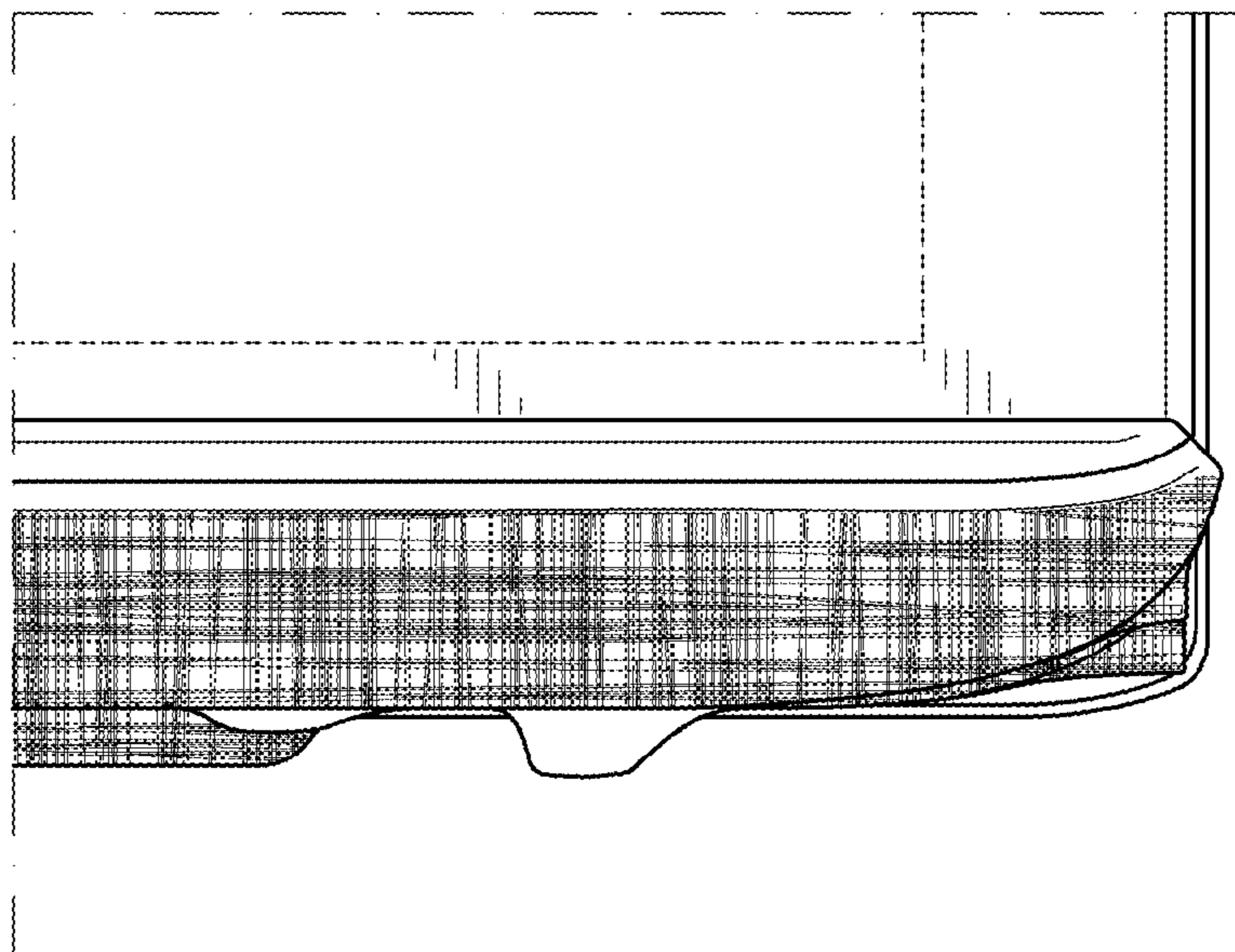
