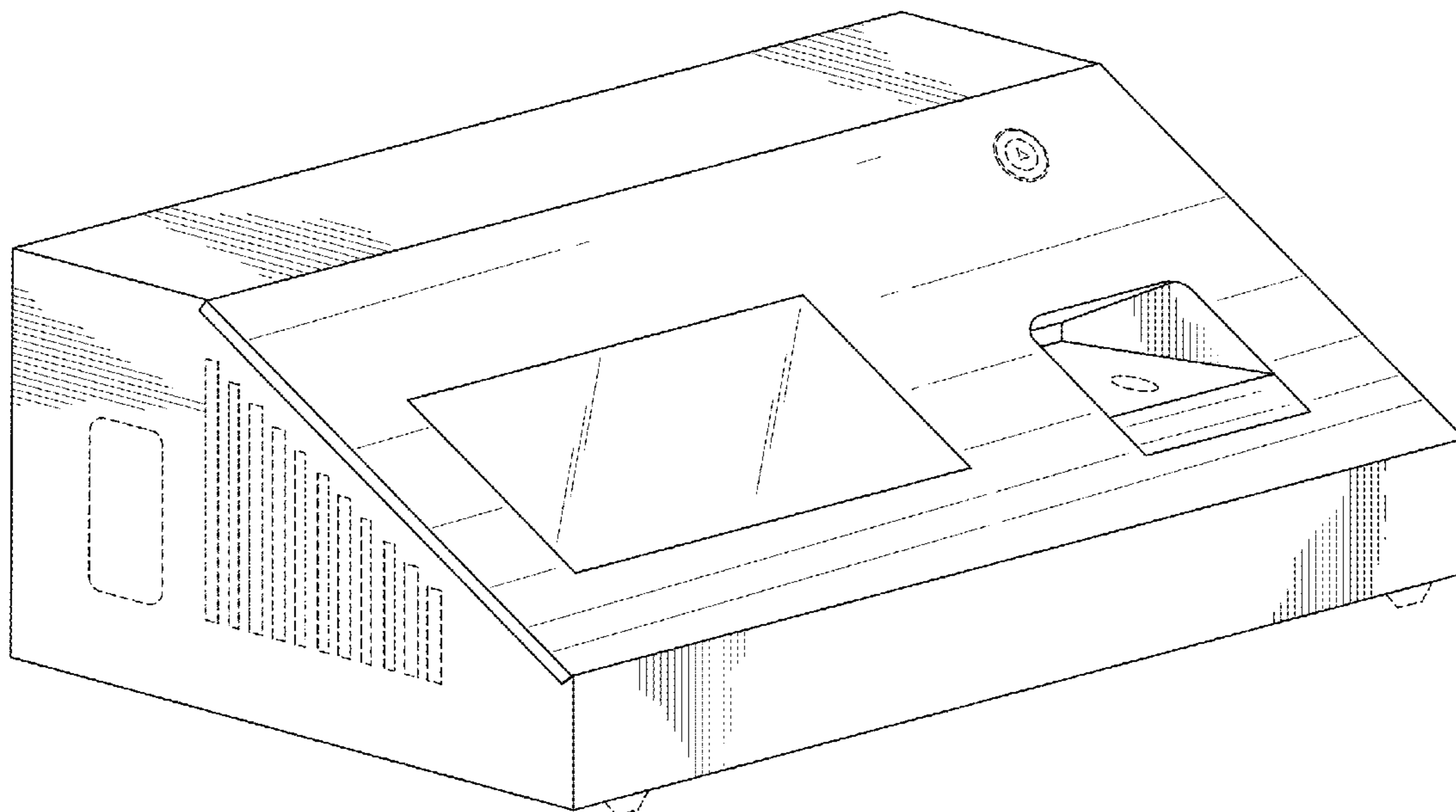
(57) **CLAIM**

The ornamental design for an electronic key control unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an electronic key control unit according to our new design, as viewed from the front, above and to the left of the device;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

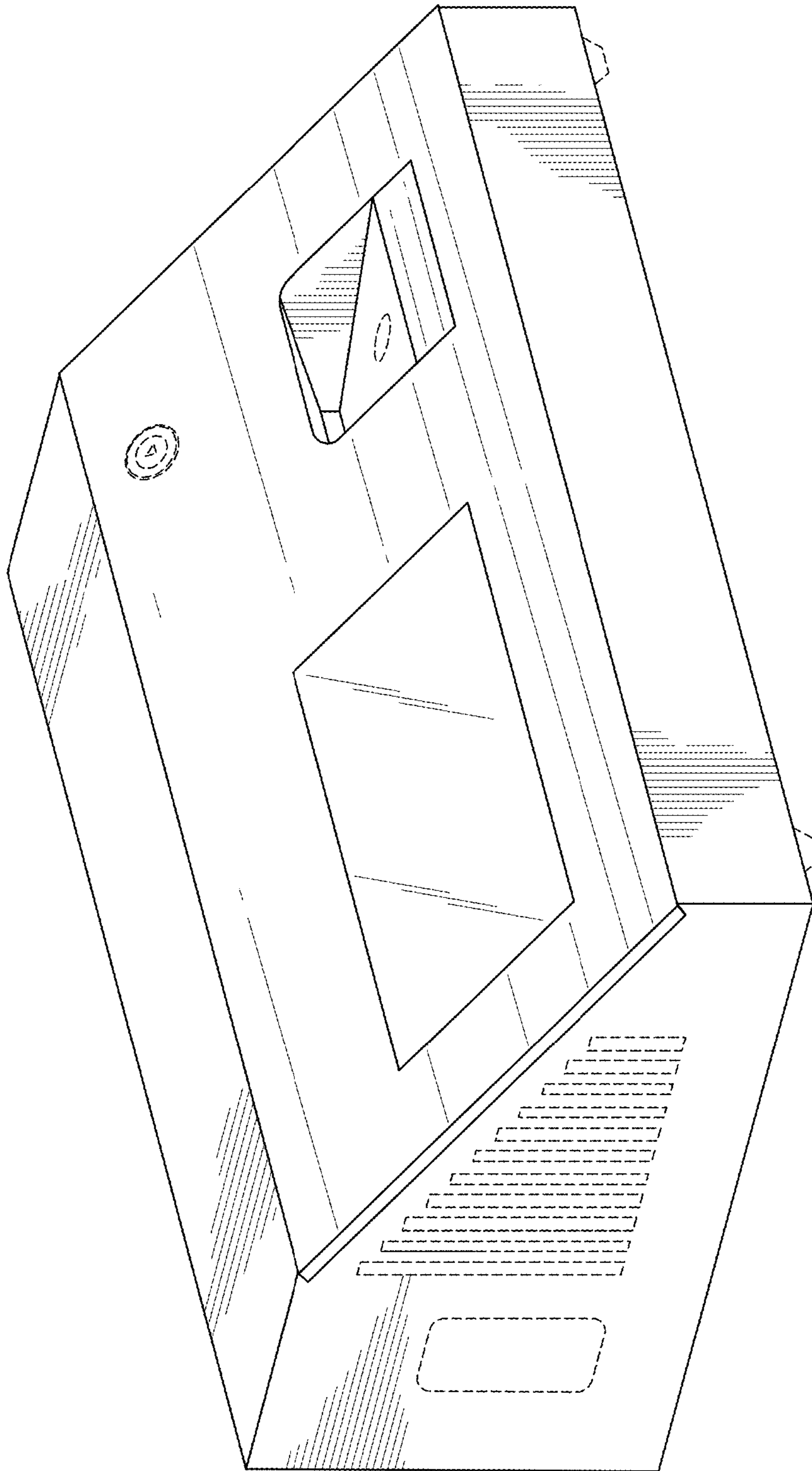

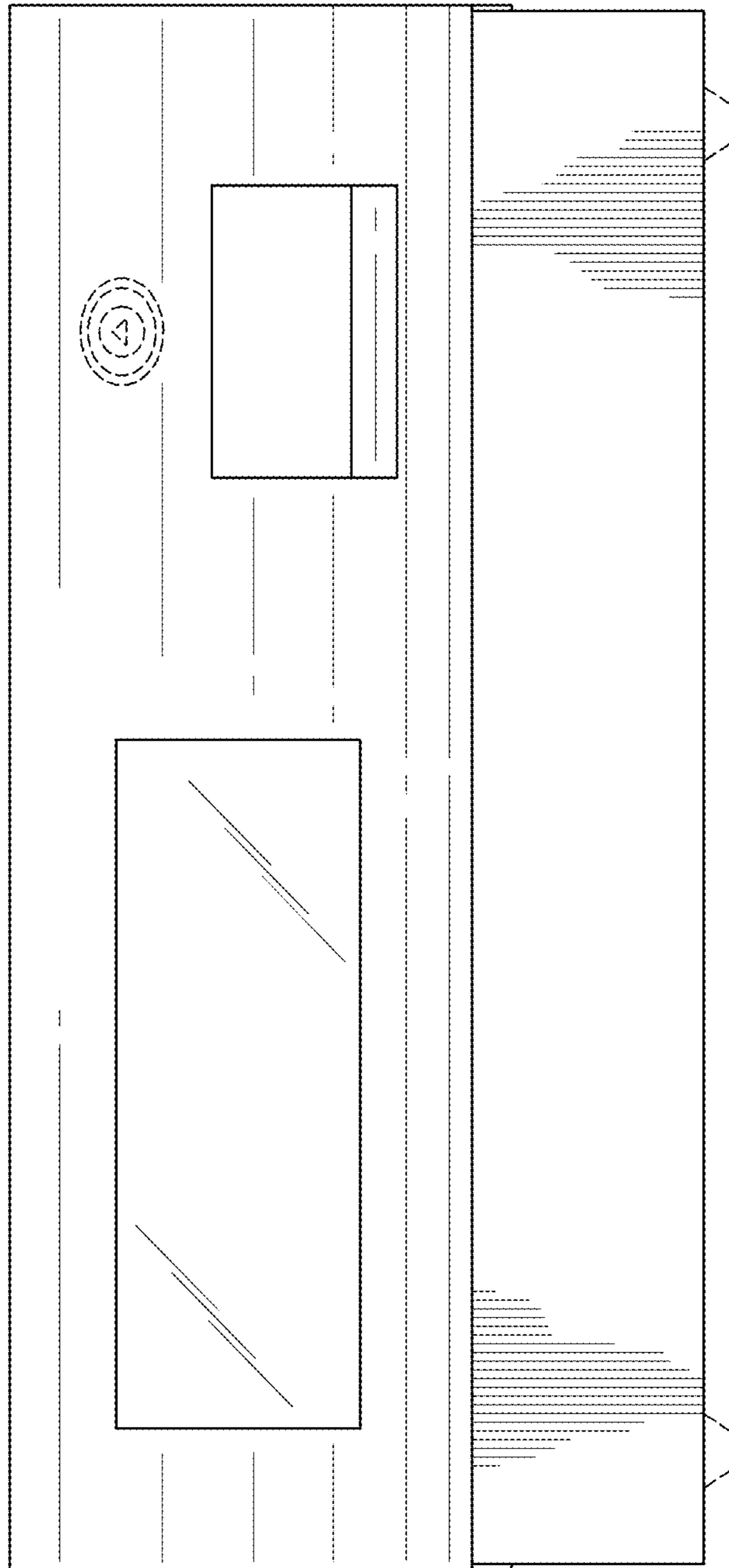

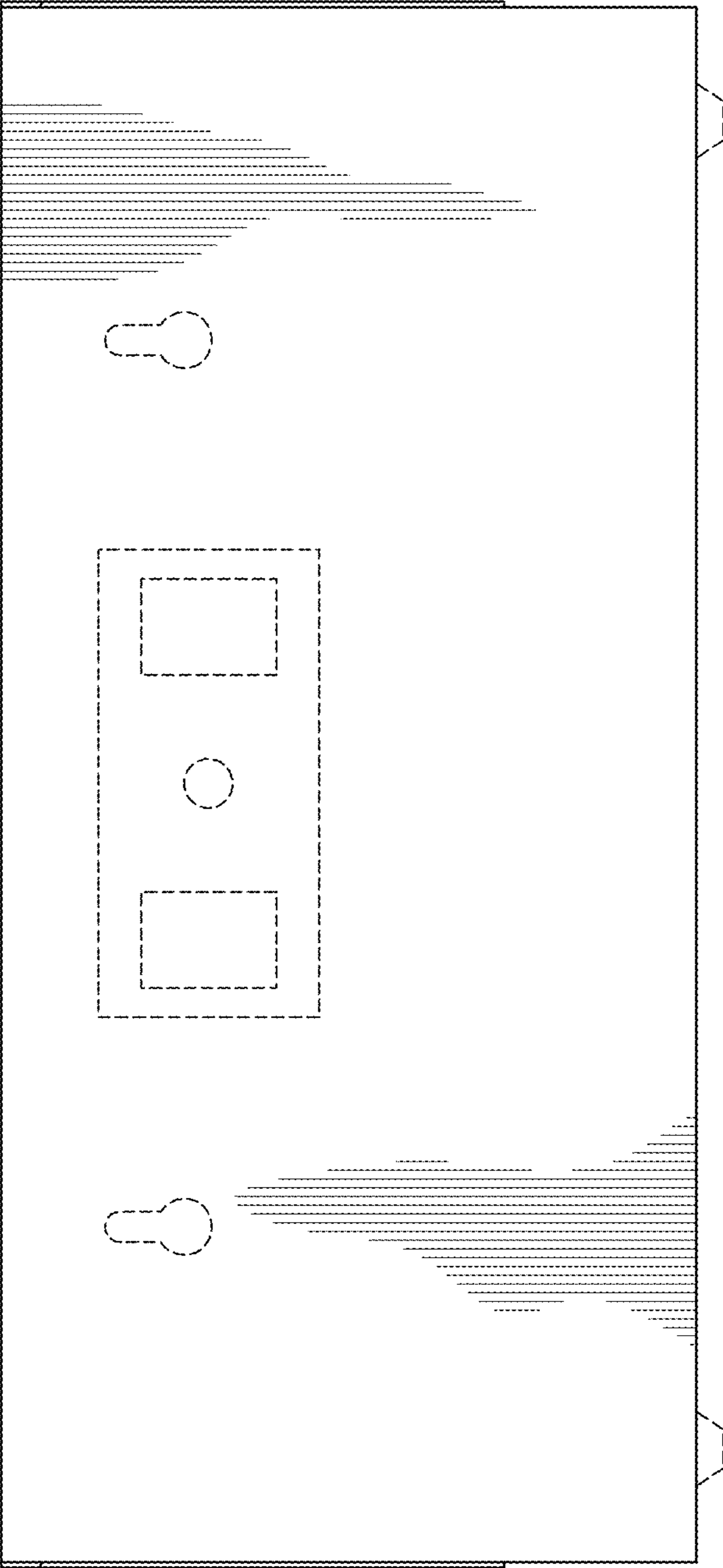

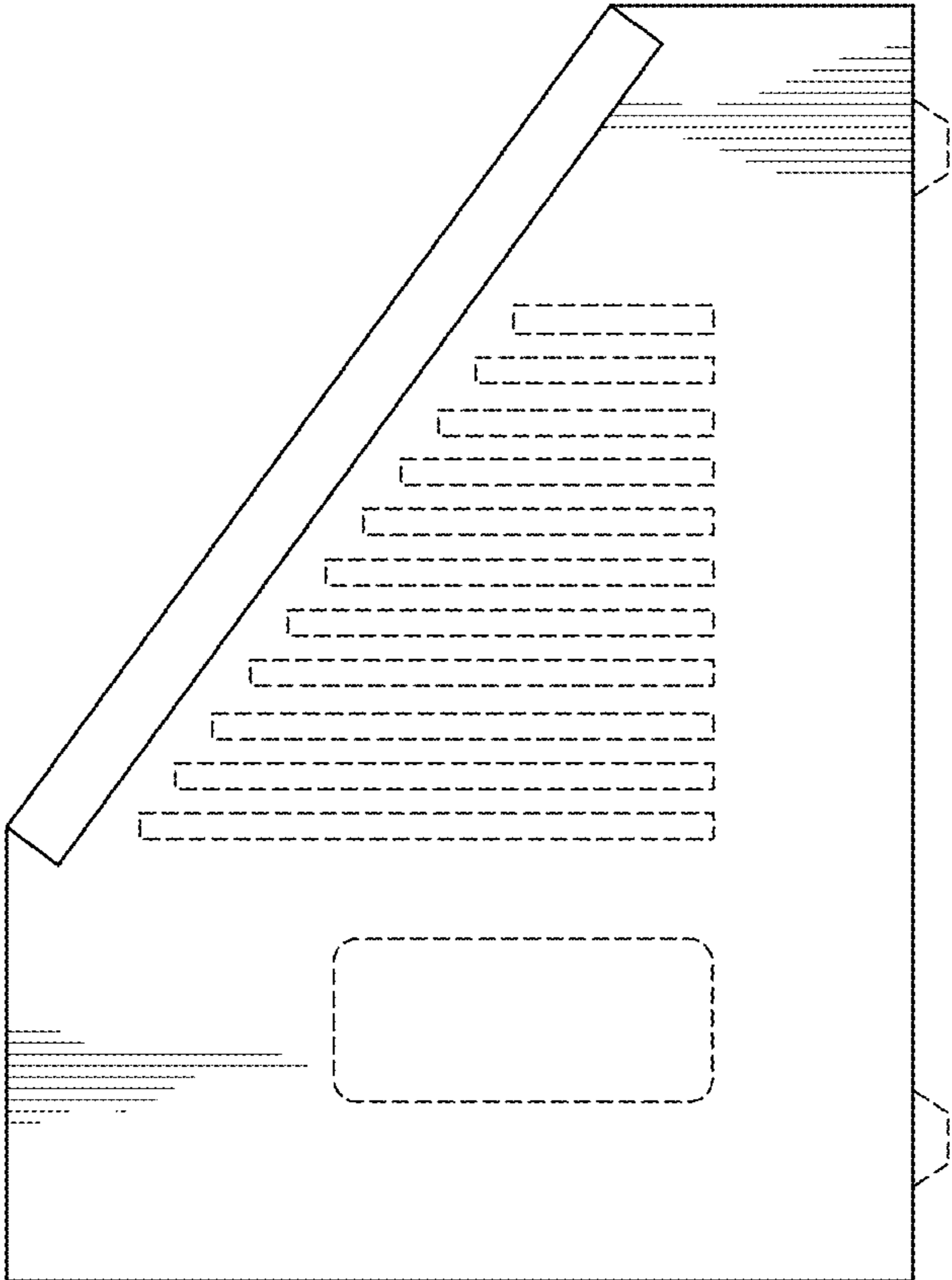

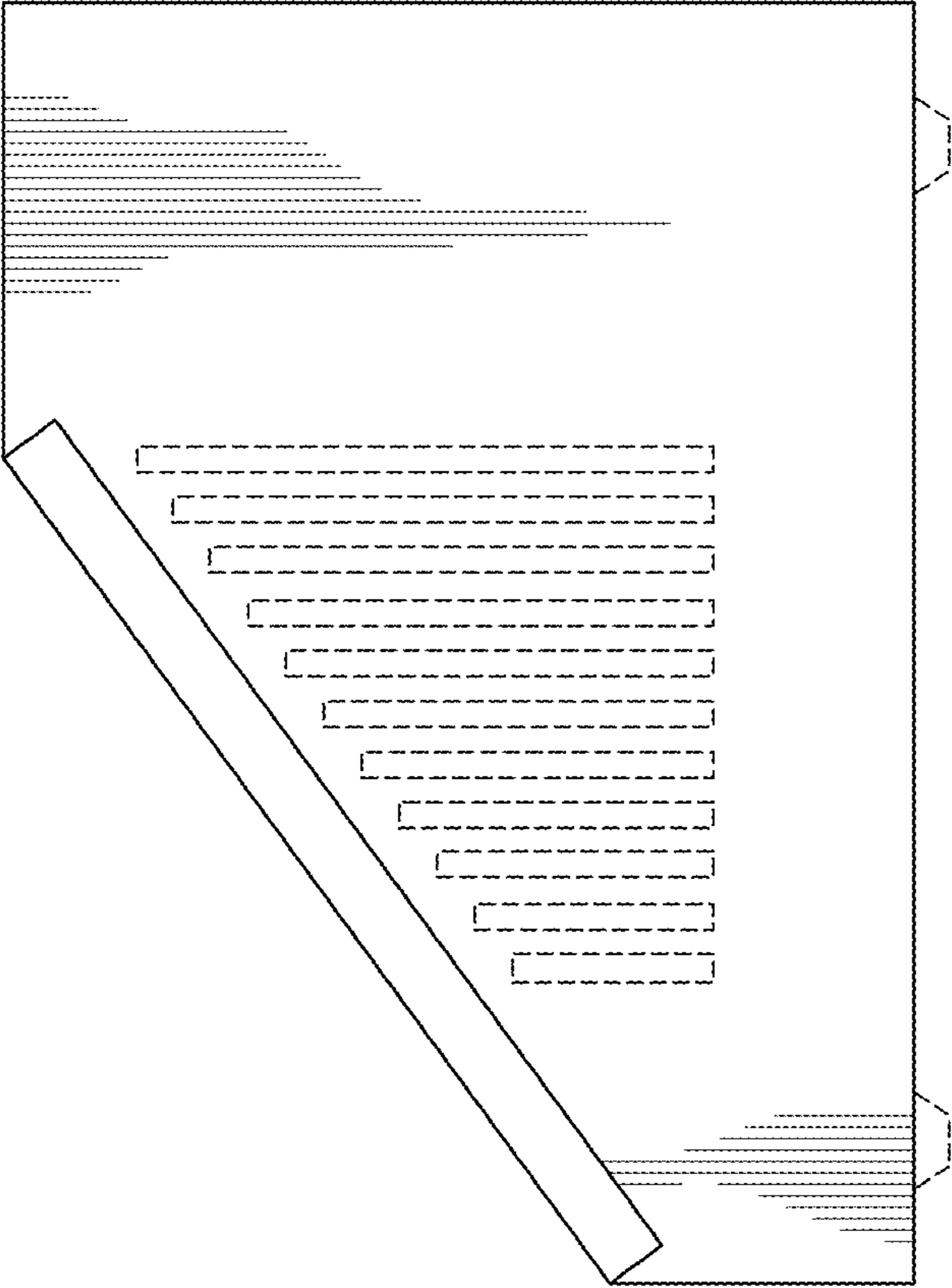

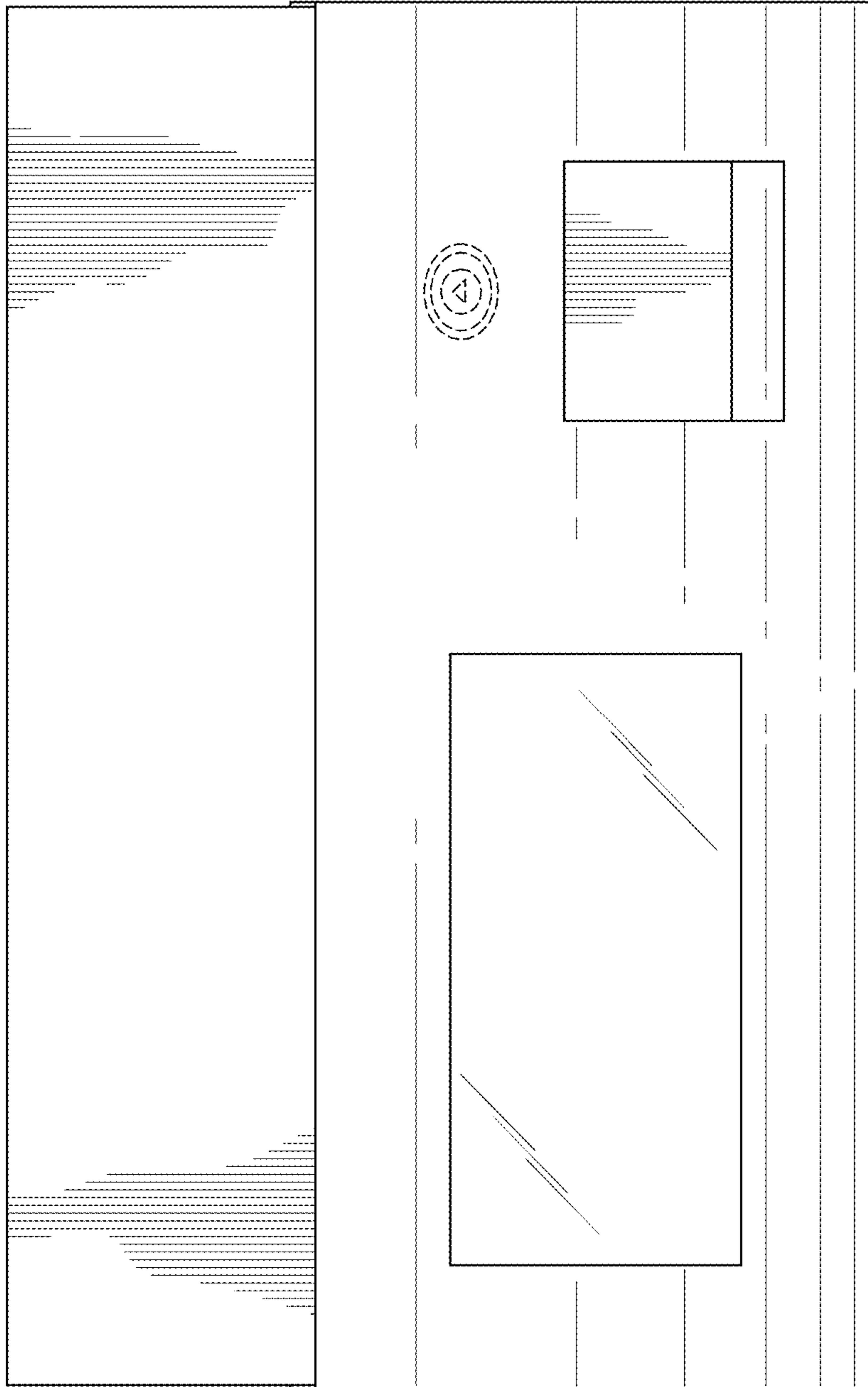
