(57) **CLAIM**

The ornamental design for a mobile cash register, as shown and described.

DESCRIPTION

FIG. 1 is a front View of a mobile cash register;
FIG. 2 is a rear View thereof;
FIG. 3 is a bottom View thereof;
FIG. 4 is a top plan View thereof;
FIG. 5 is a right side View thereof;
FIG. 6 is a left side View thereof;
FIG. 7 is a perspective front View thereof;

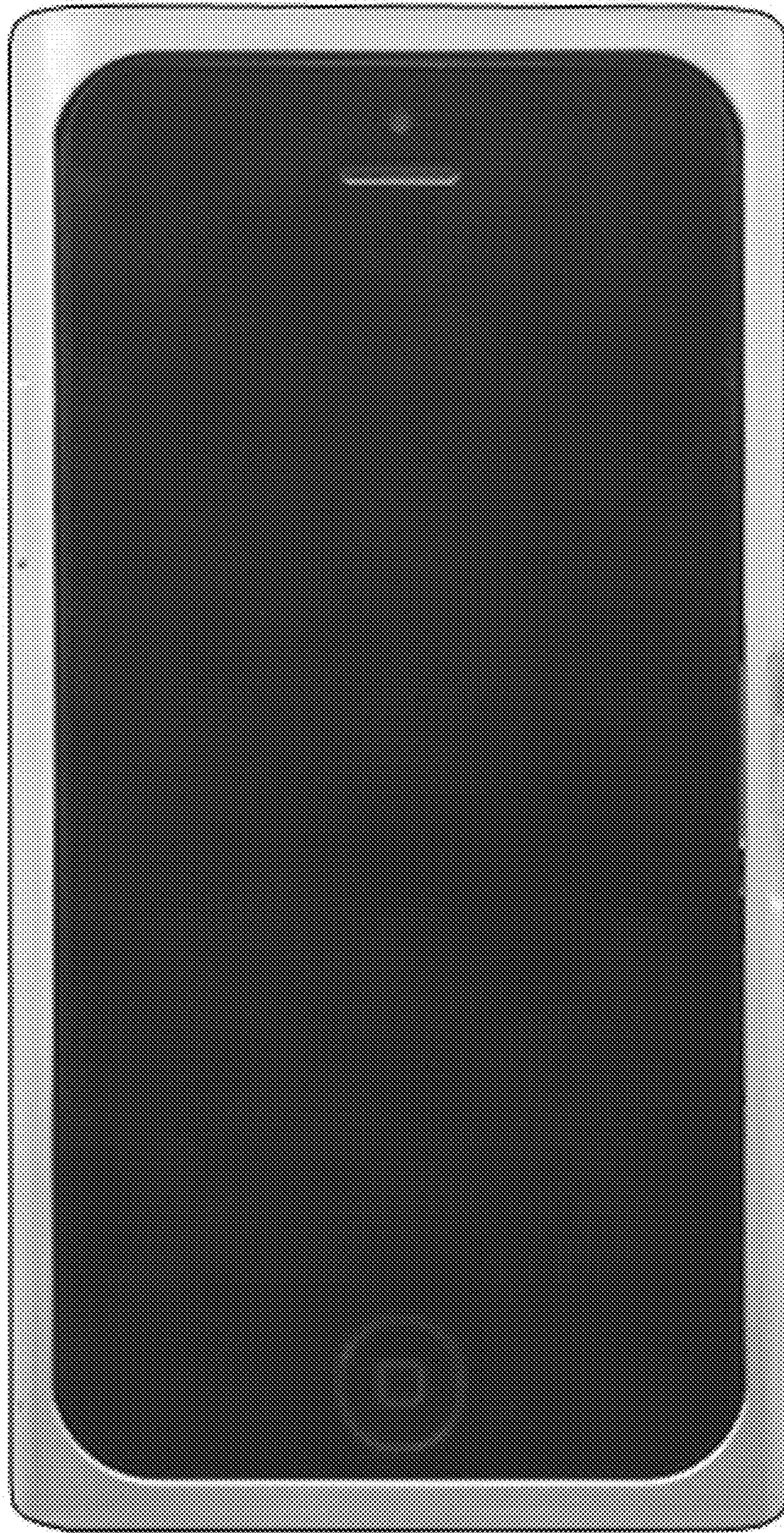

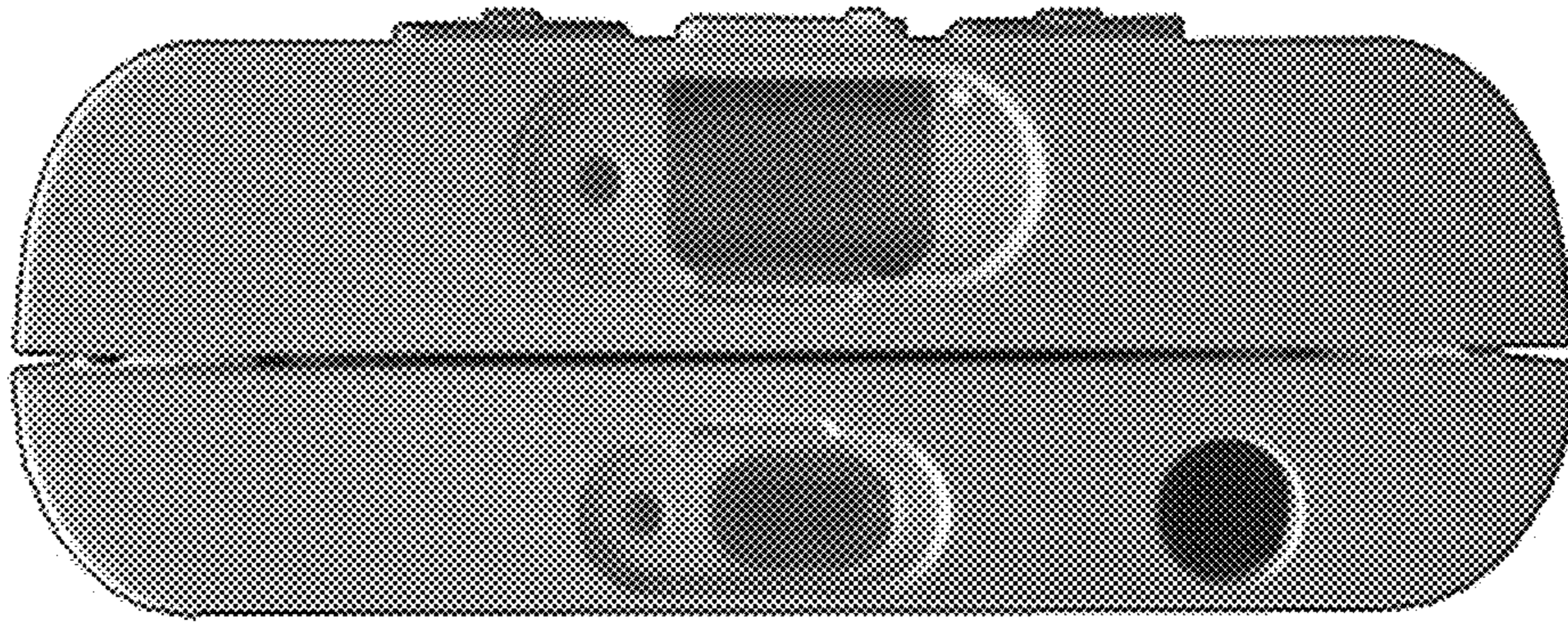

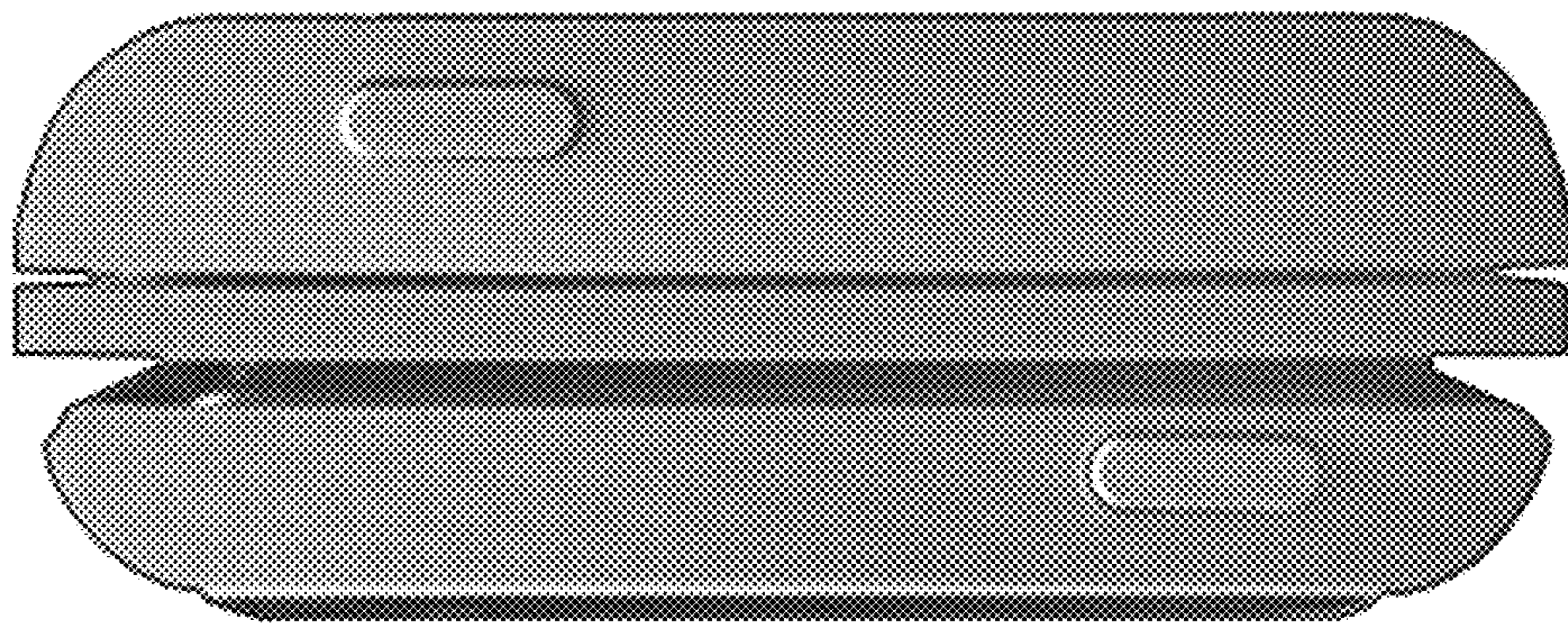

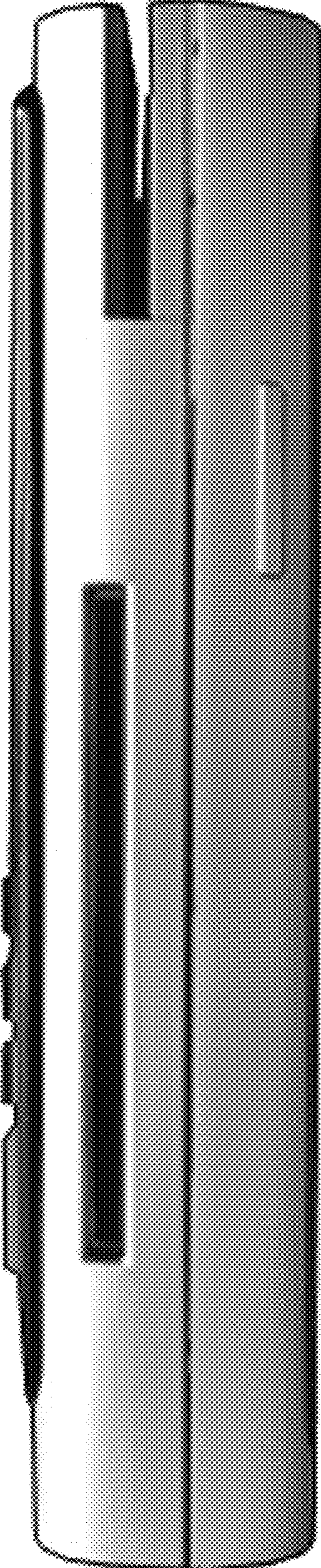

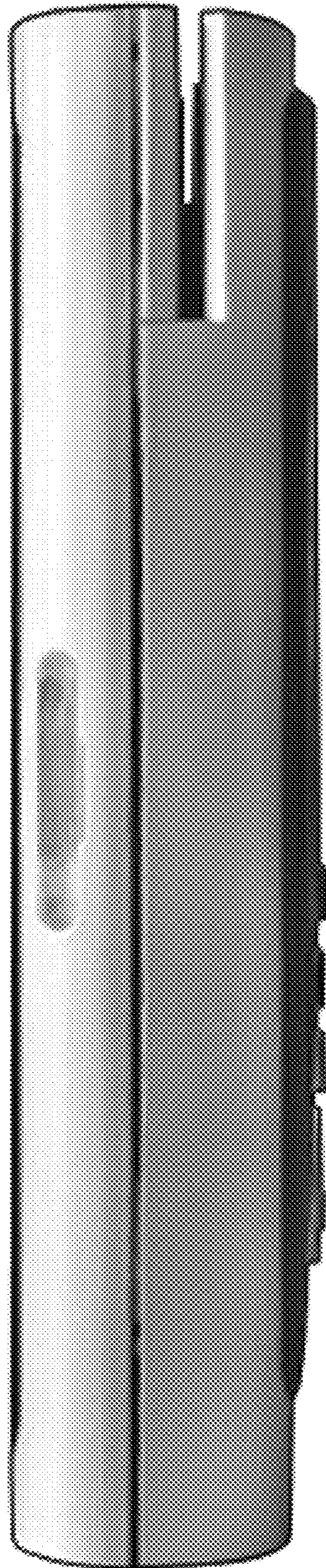

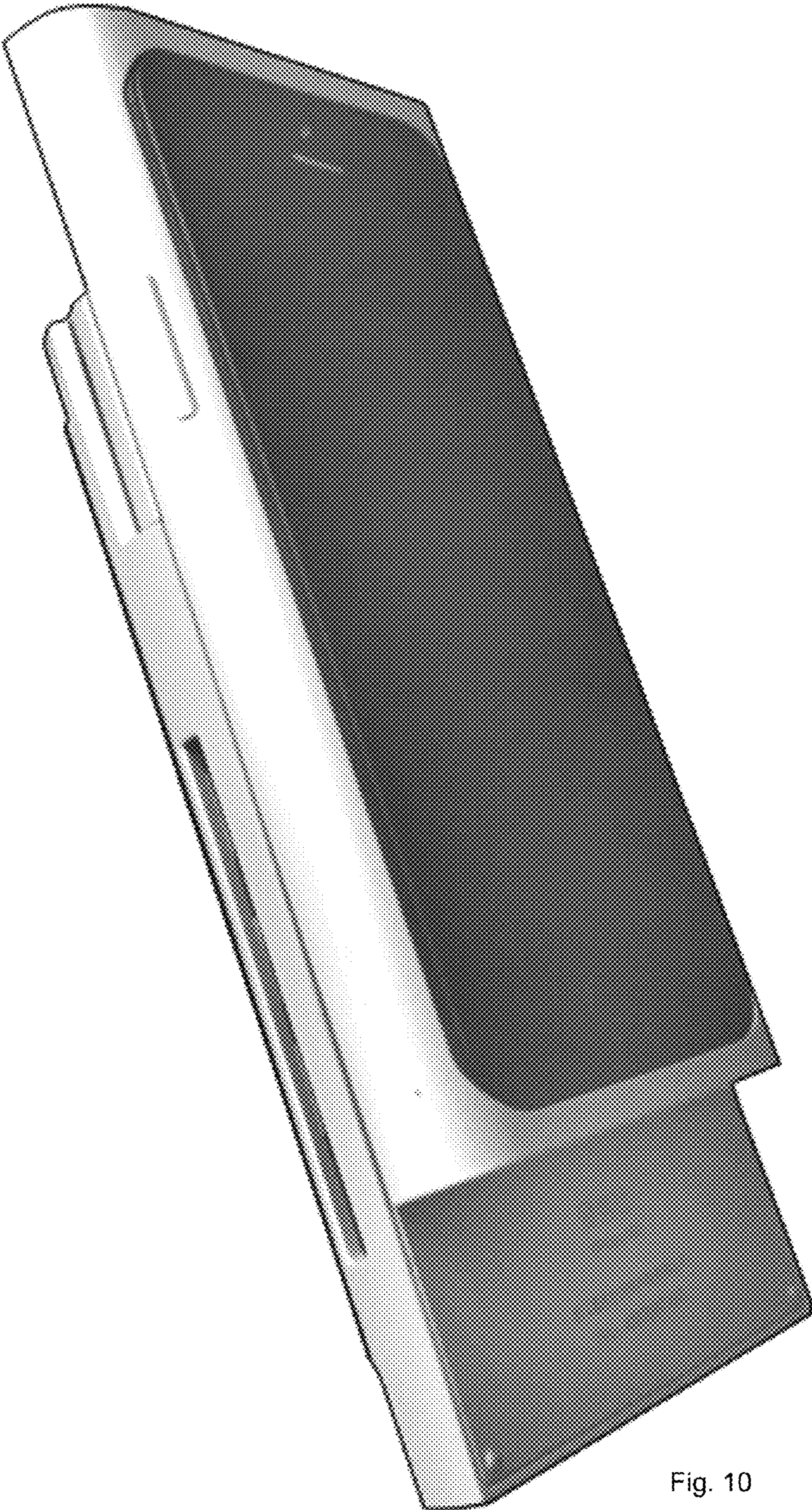
