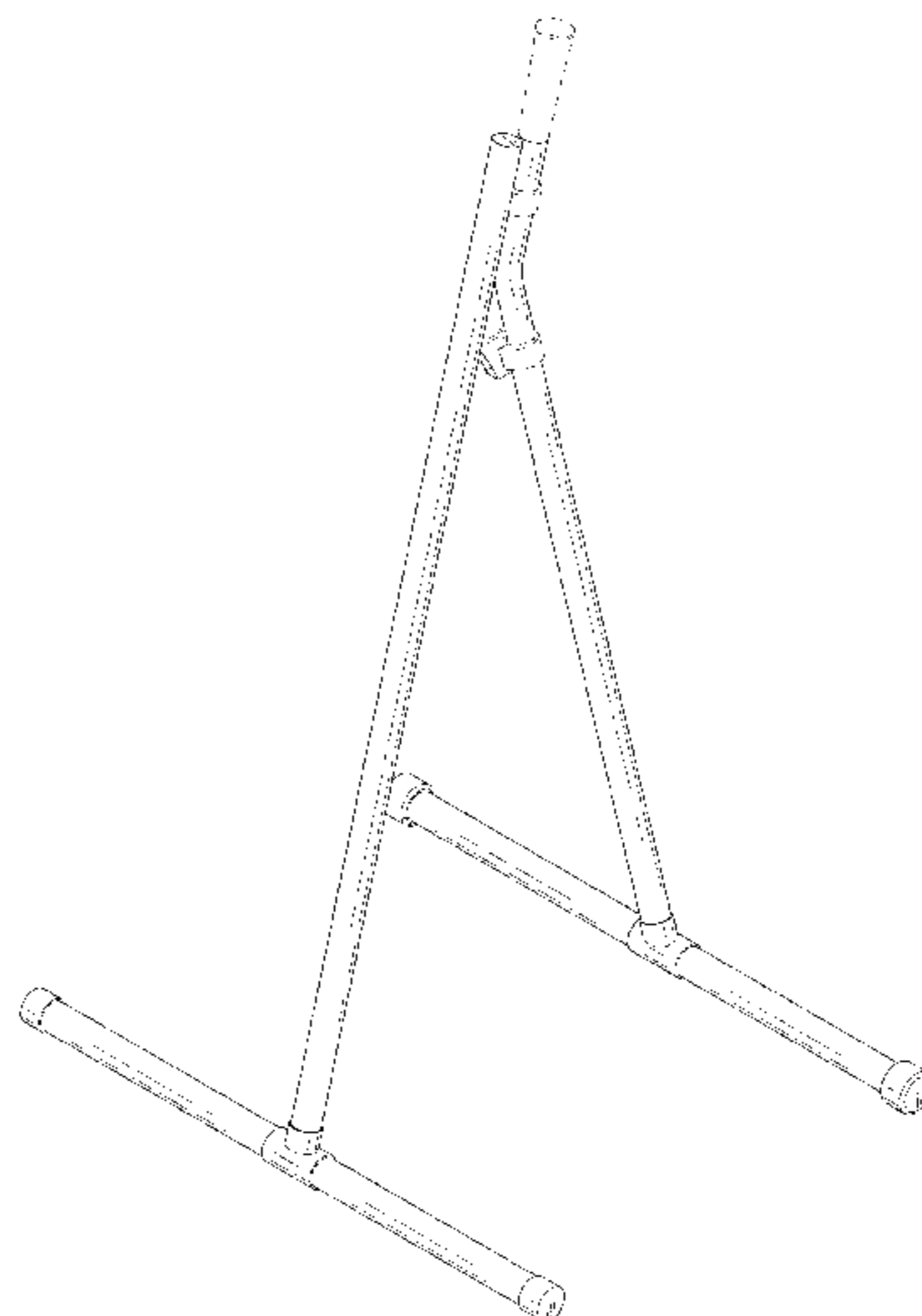
(57) **CLAIM**

The ornamental design for a stand for monitor, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a stand for monitor, showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is another side view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is another front perspective view, in which a monitor in broken lines is provided to illustrate an example environment; and,  
FIG. 9 is another side view thereof in a folded state.  
The broken line in FIGS. 1 to 7 and 9 shows portions of the stand for monitor which form no part of the claimed design. The broken line showing of the monitor in FIG. 8 is for environmental purposes only and forms no part of the claimed design.

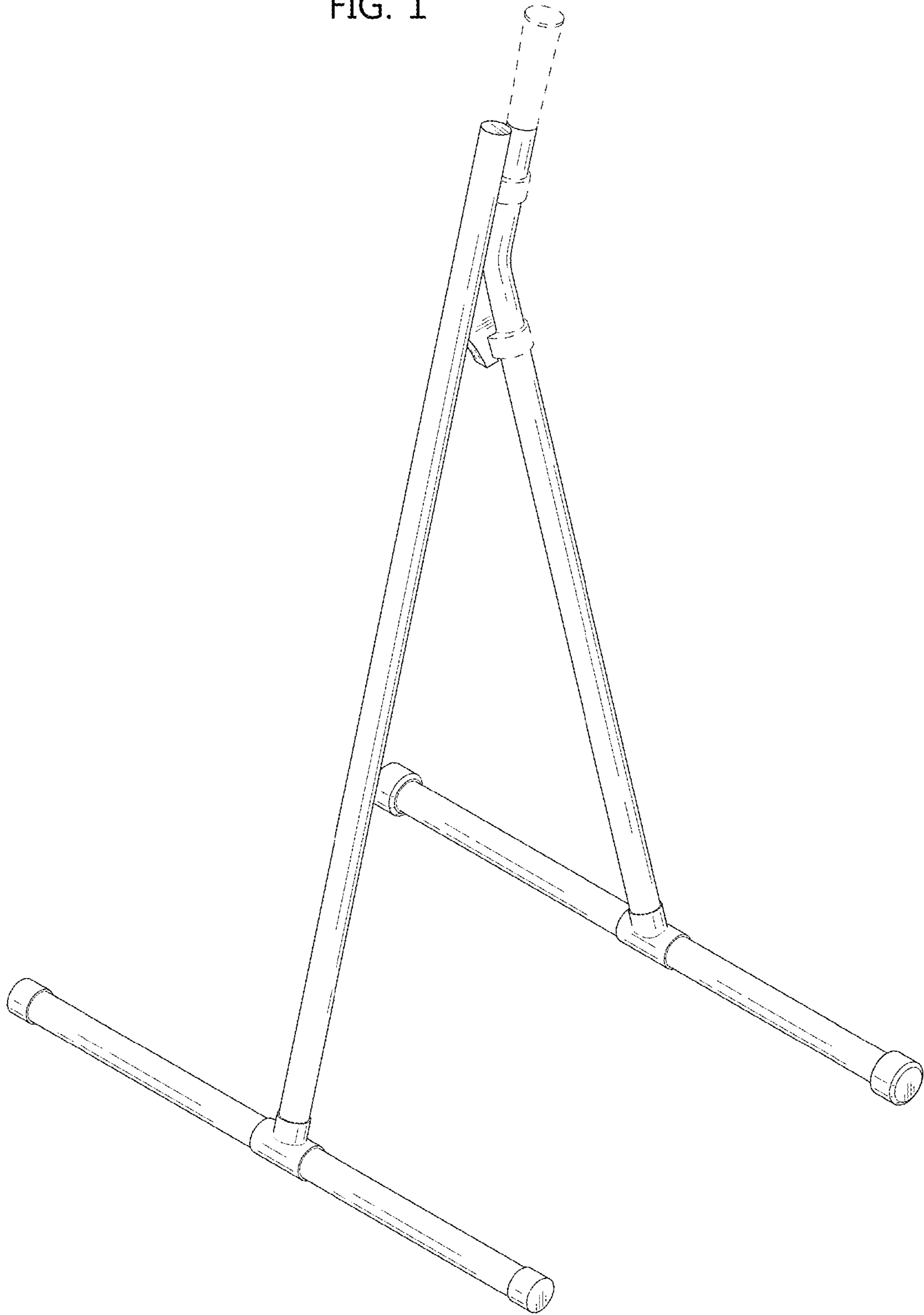

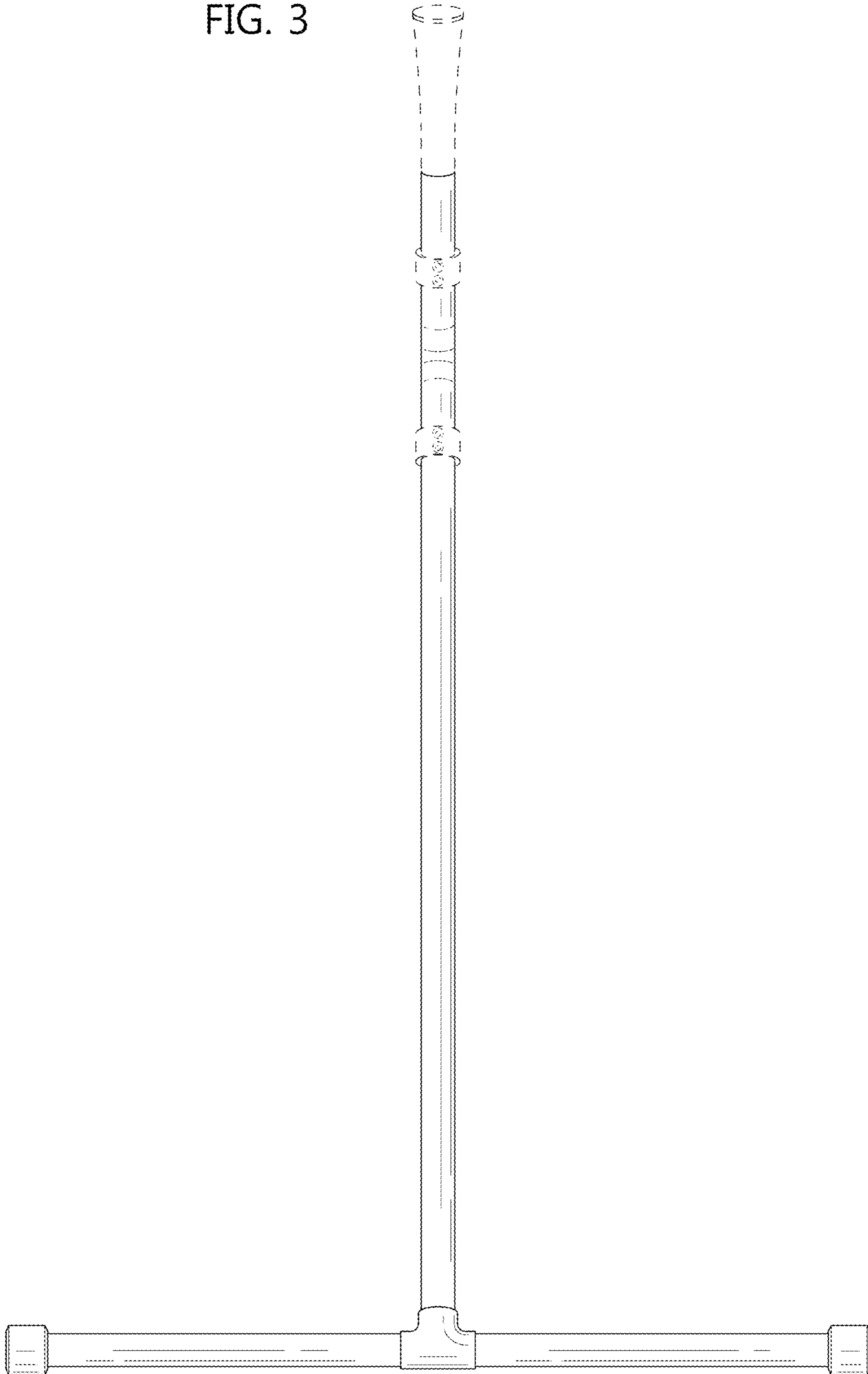

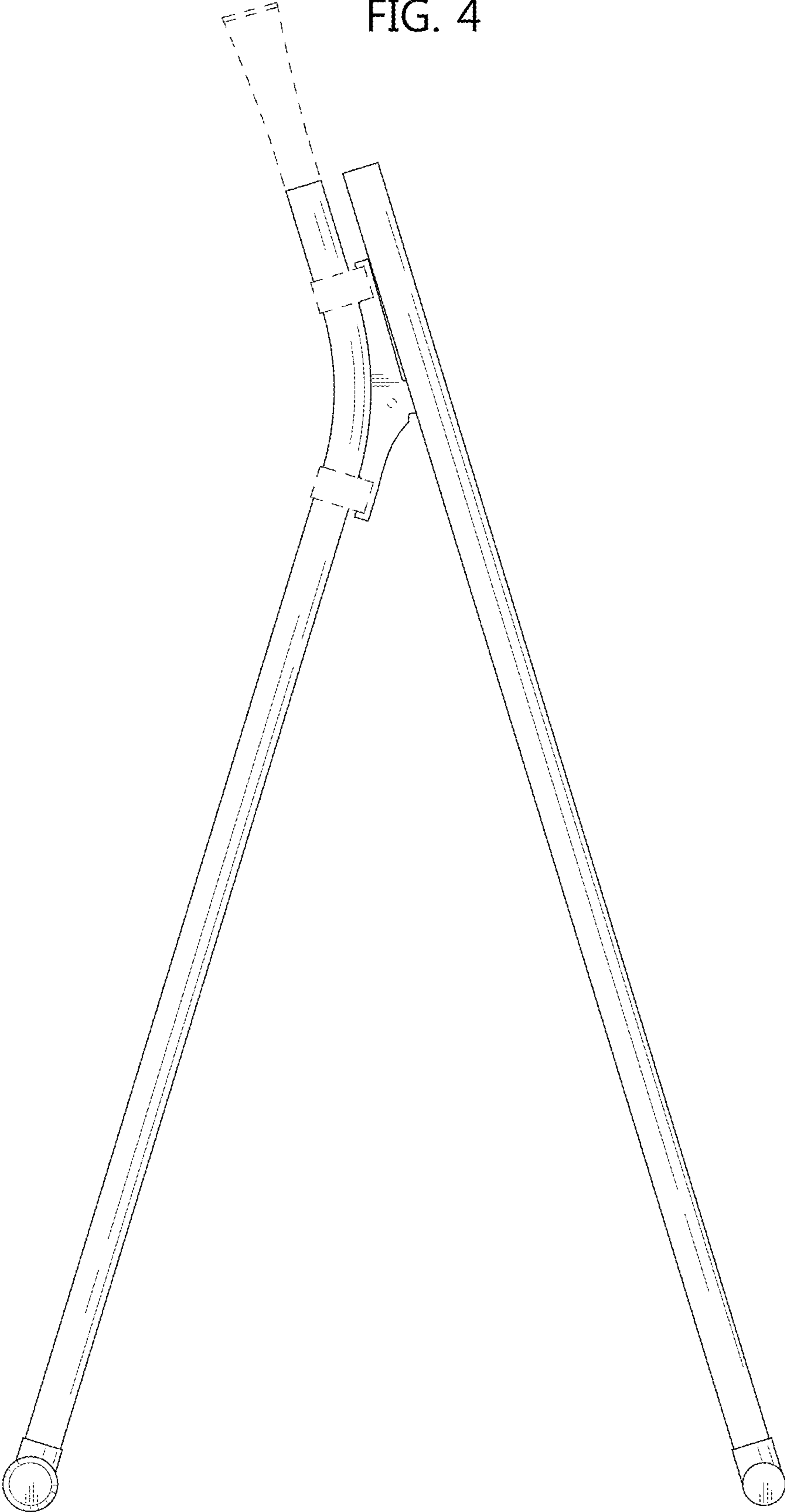

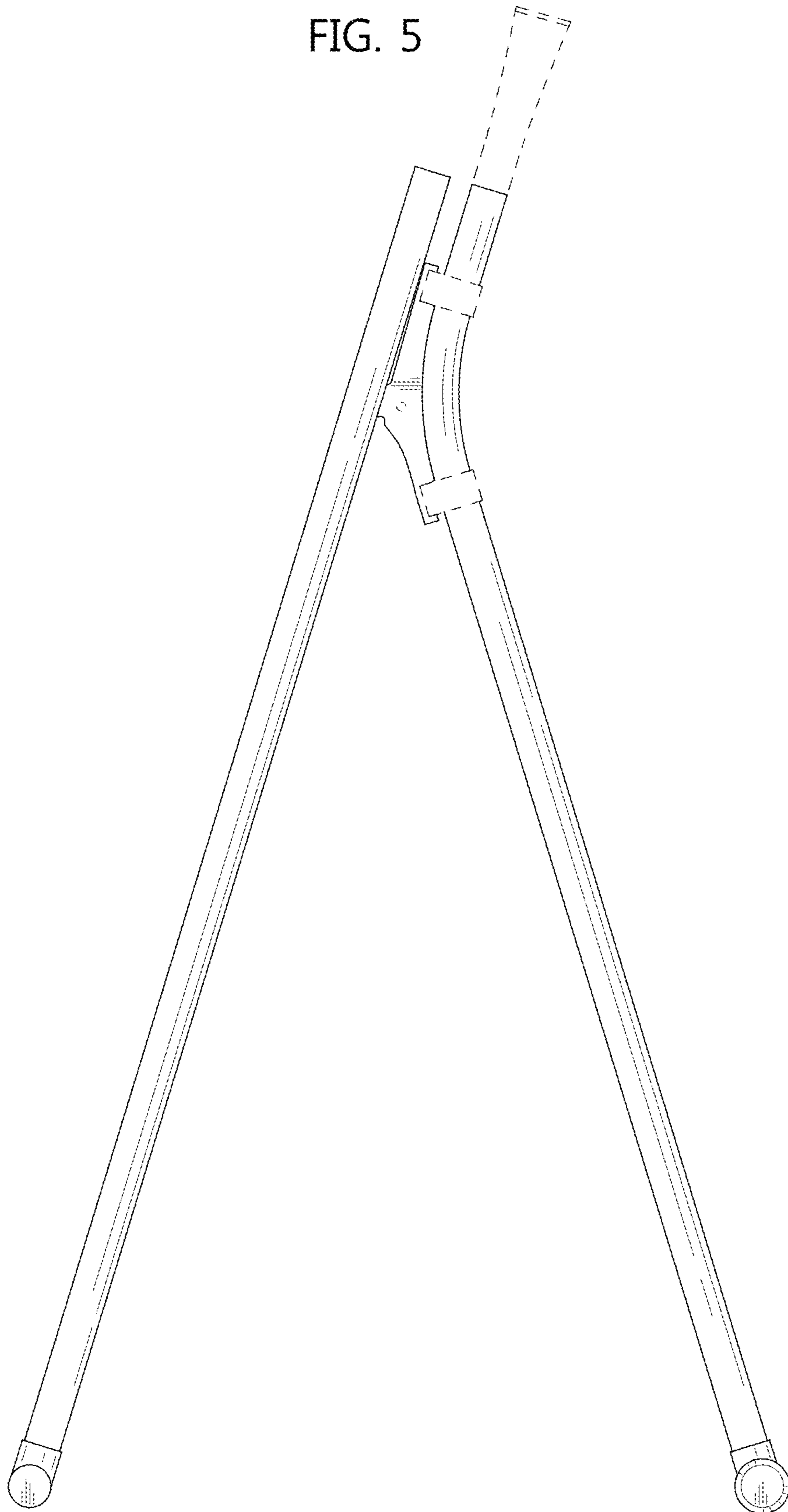

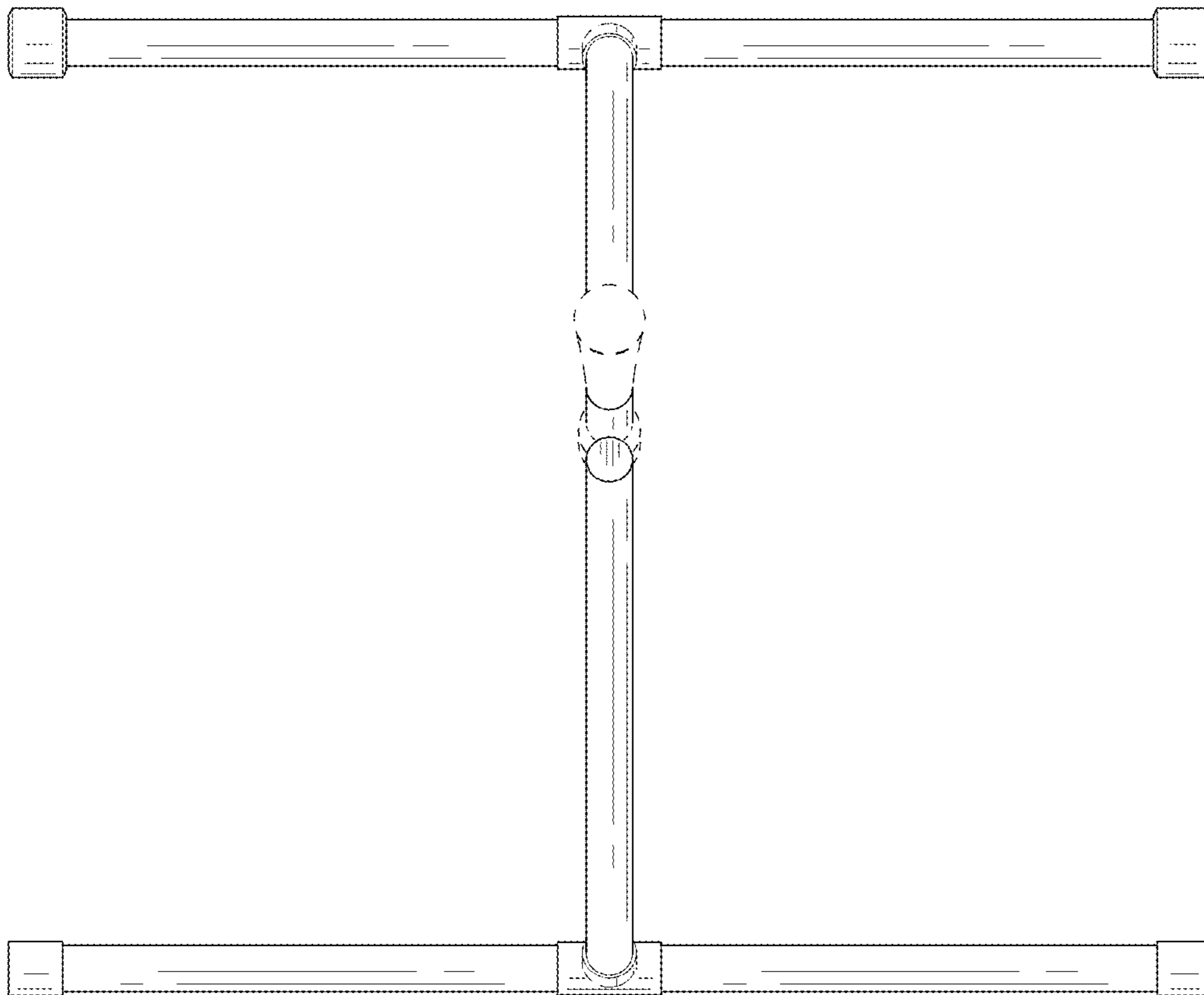

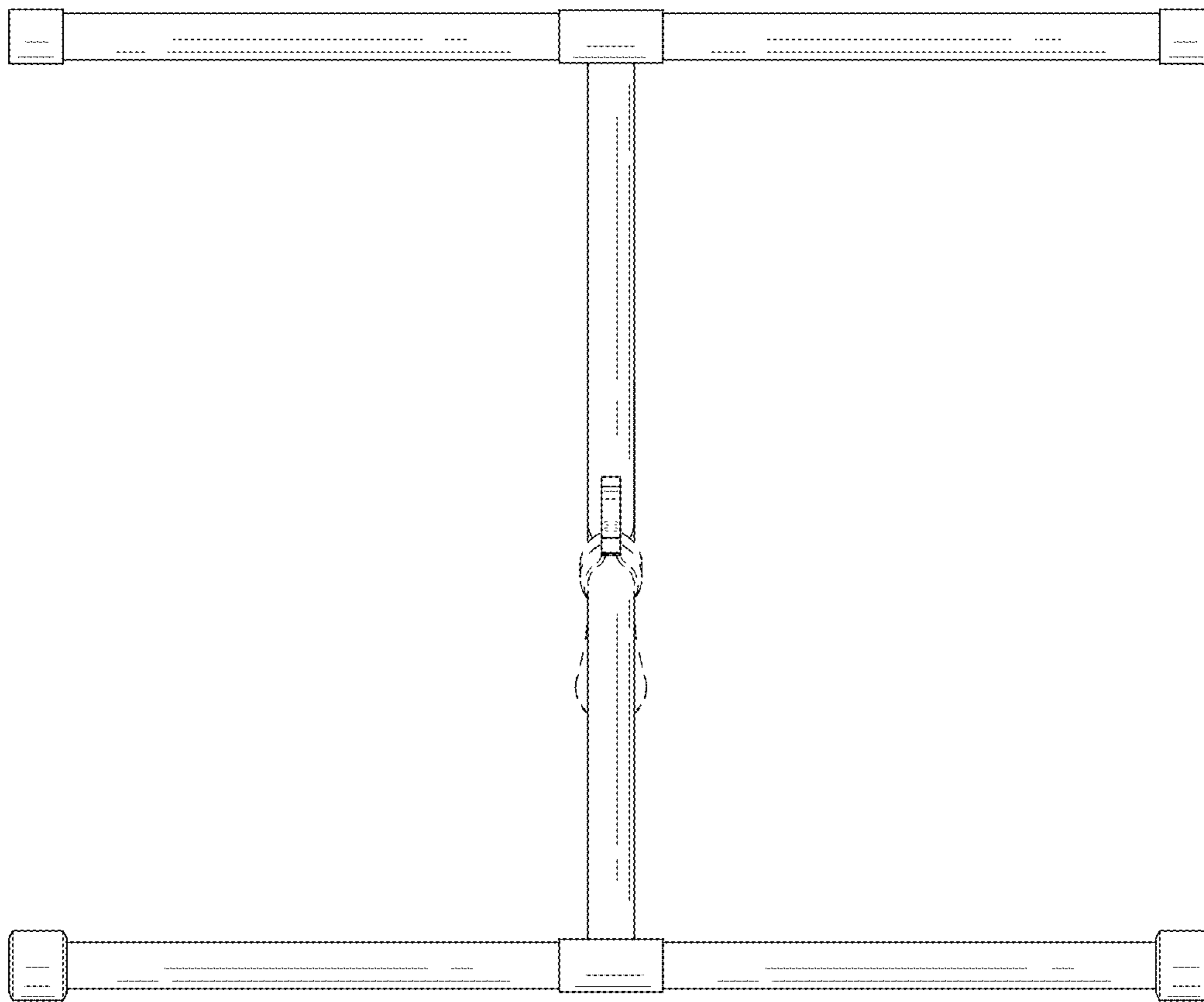

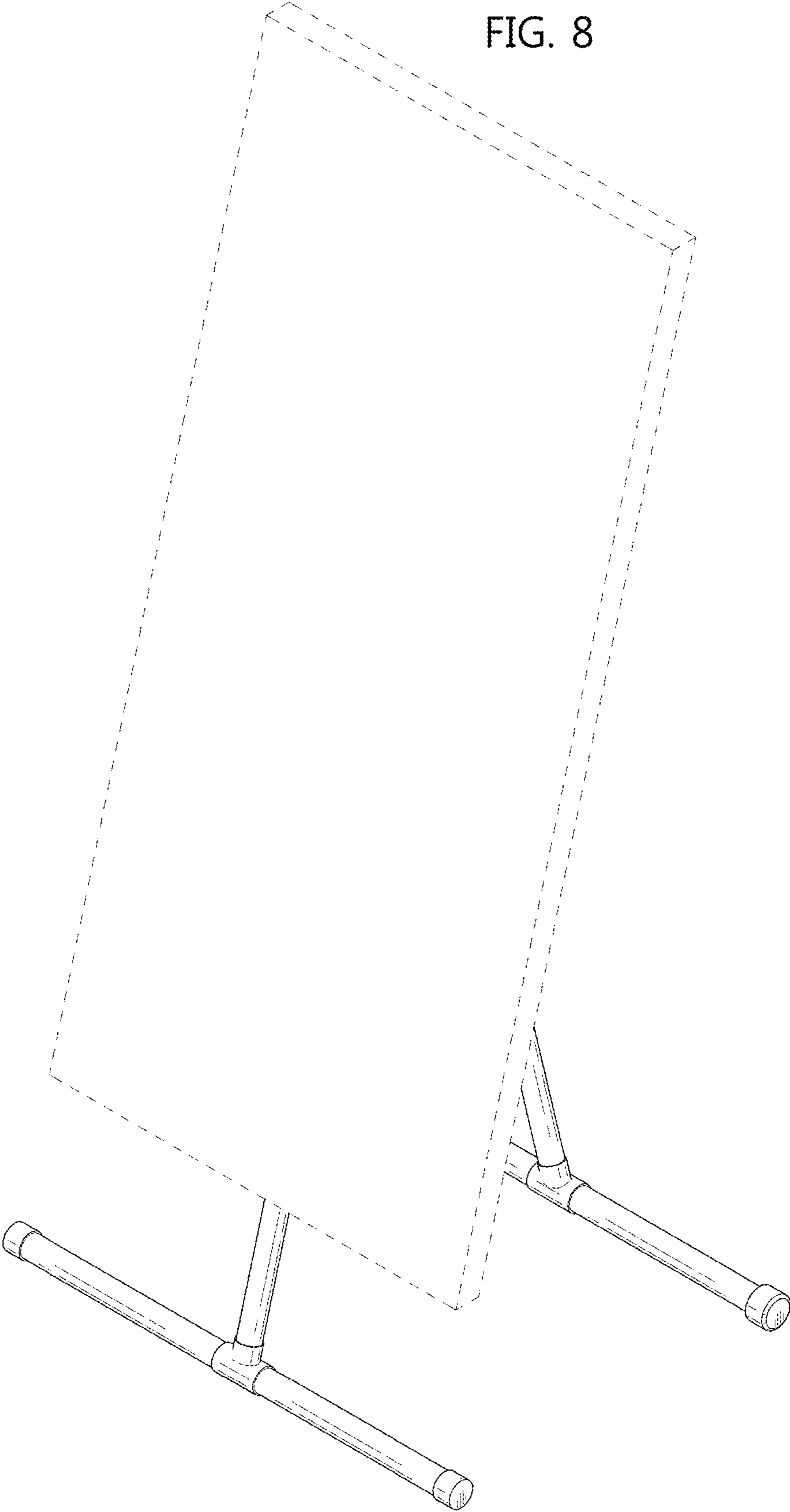
