The ornamental design for a display screen or portion thereof with graphical user interface for clinical practice guidelines, as shown and described.

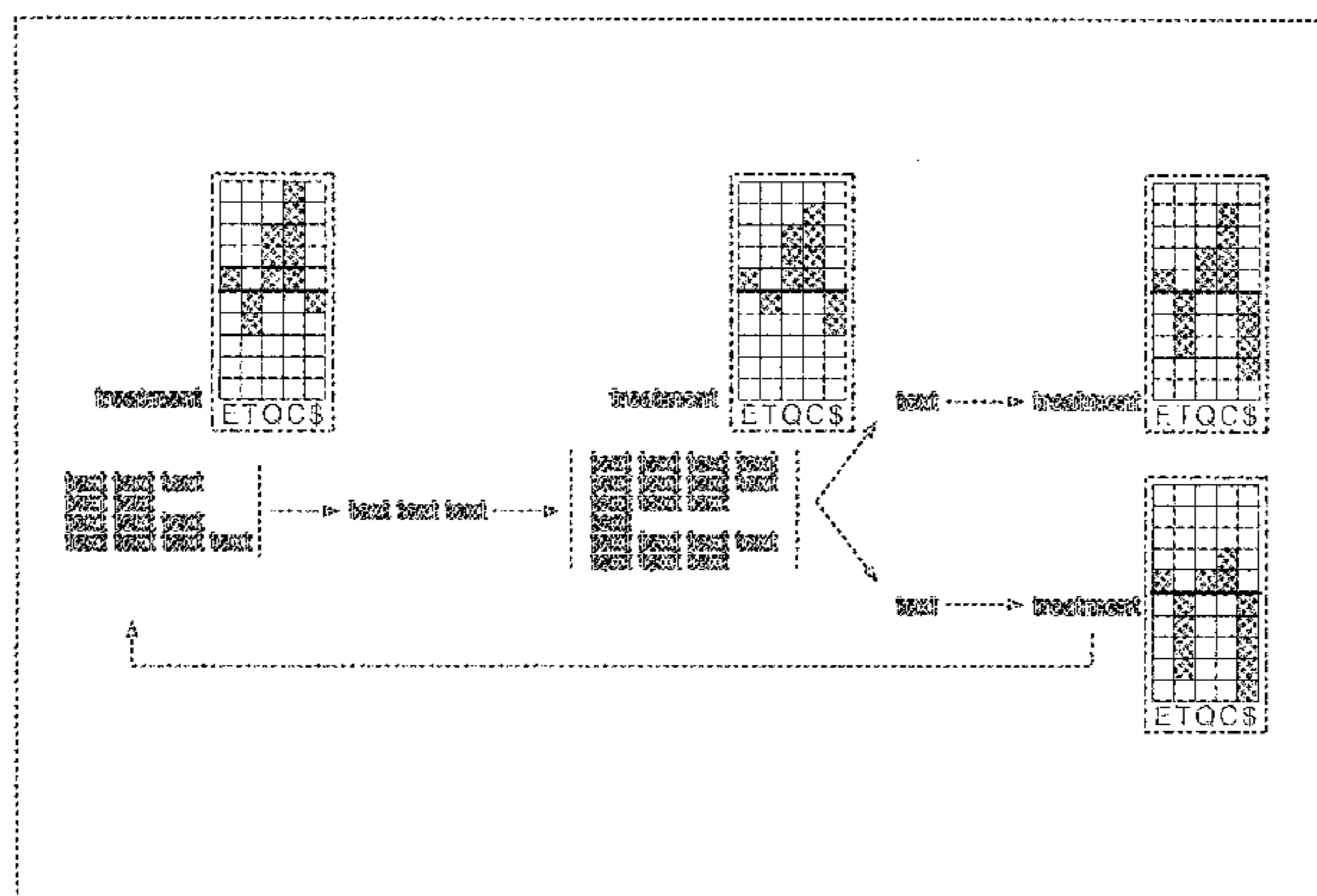
**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with graphical user interface for clinical practice guidelines in accordance with our new design; and,

FIG. 2 is a second embodiment showing an enlarged view of the area indicated with dot-dot-dash boundary lines in FIG. 1.

**1.** The dotted broken lines showing portions of the graphical user interface and the display screen or portion thereof represent environmental structure and form no part of the claimed design. The dot-dot-dash broken lines represent boundaries and form no part of the claimed design. Elements that are shown outside of the rectangular dot-dot-dash boundaries form no part of the claimed design.

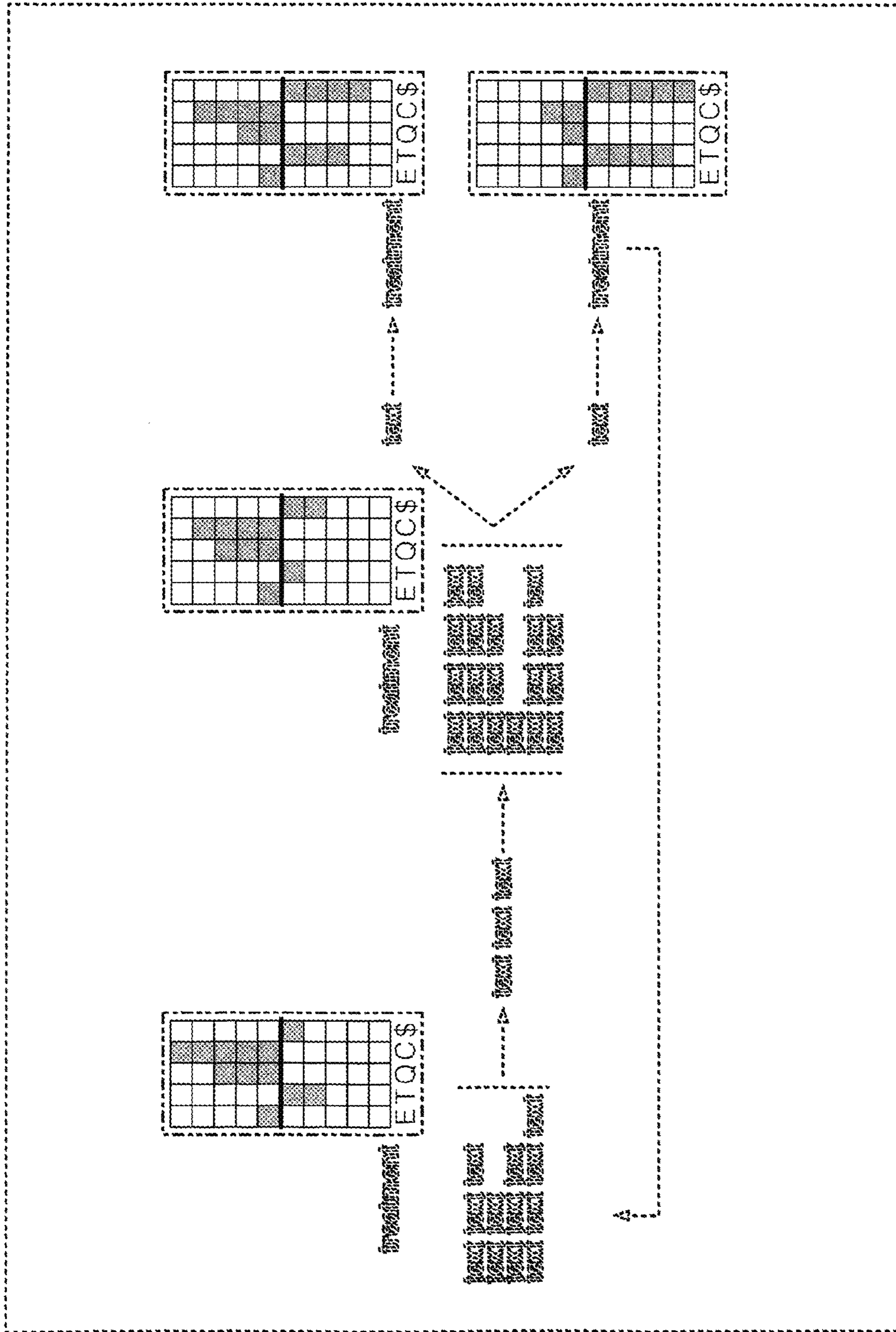

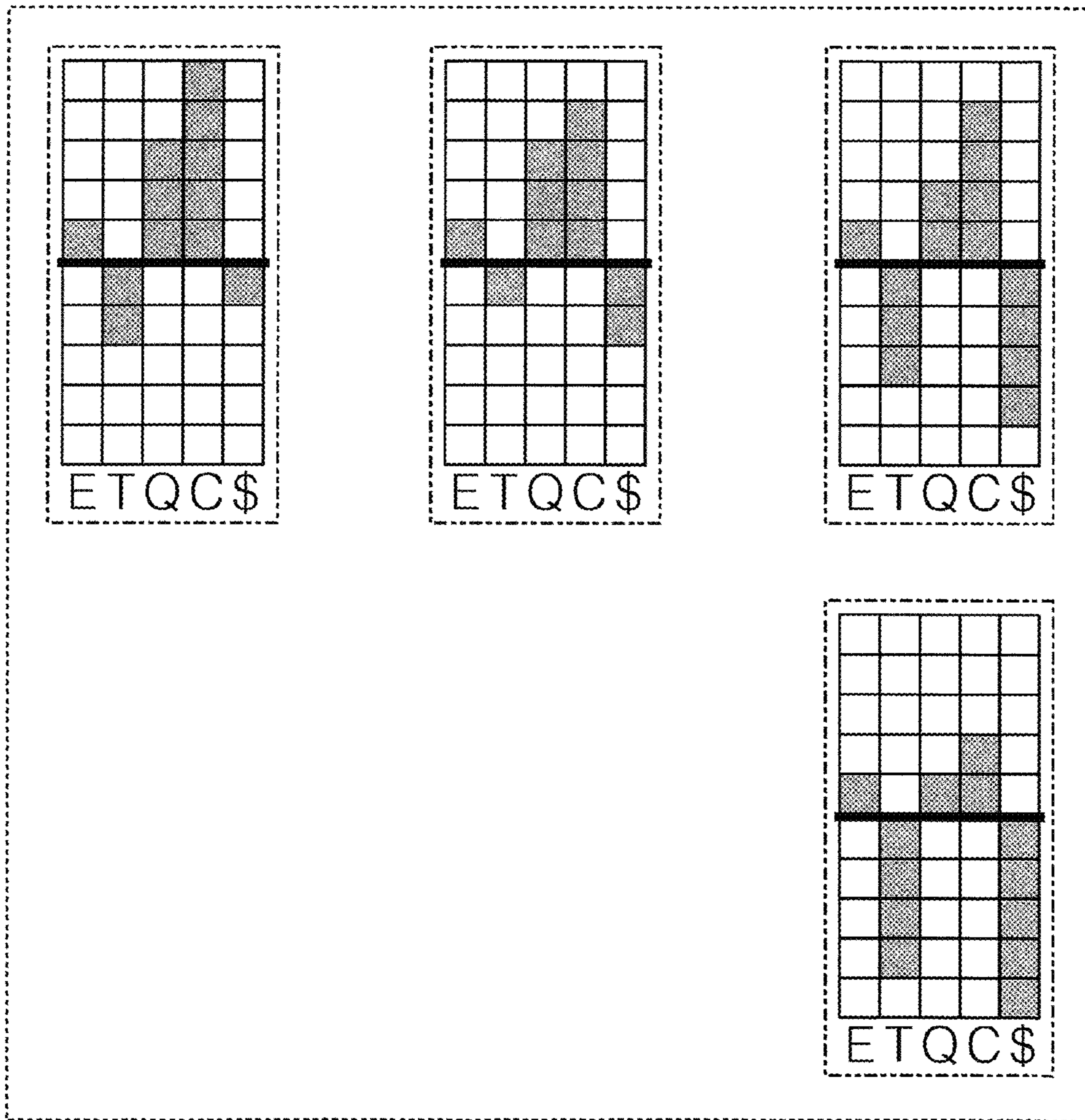
