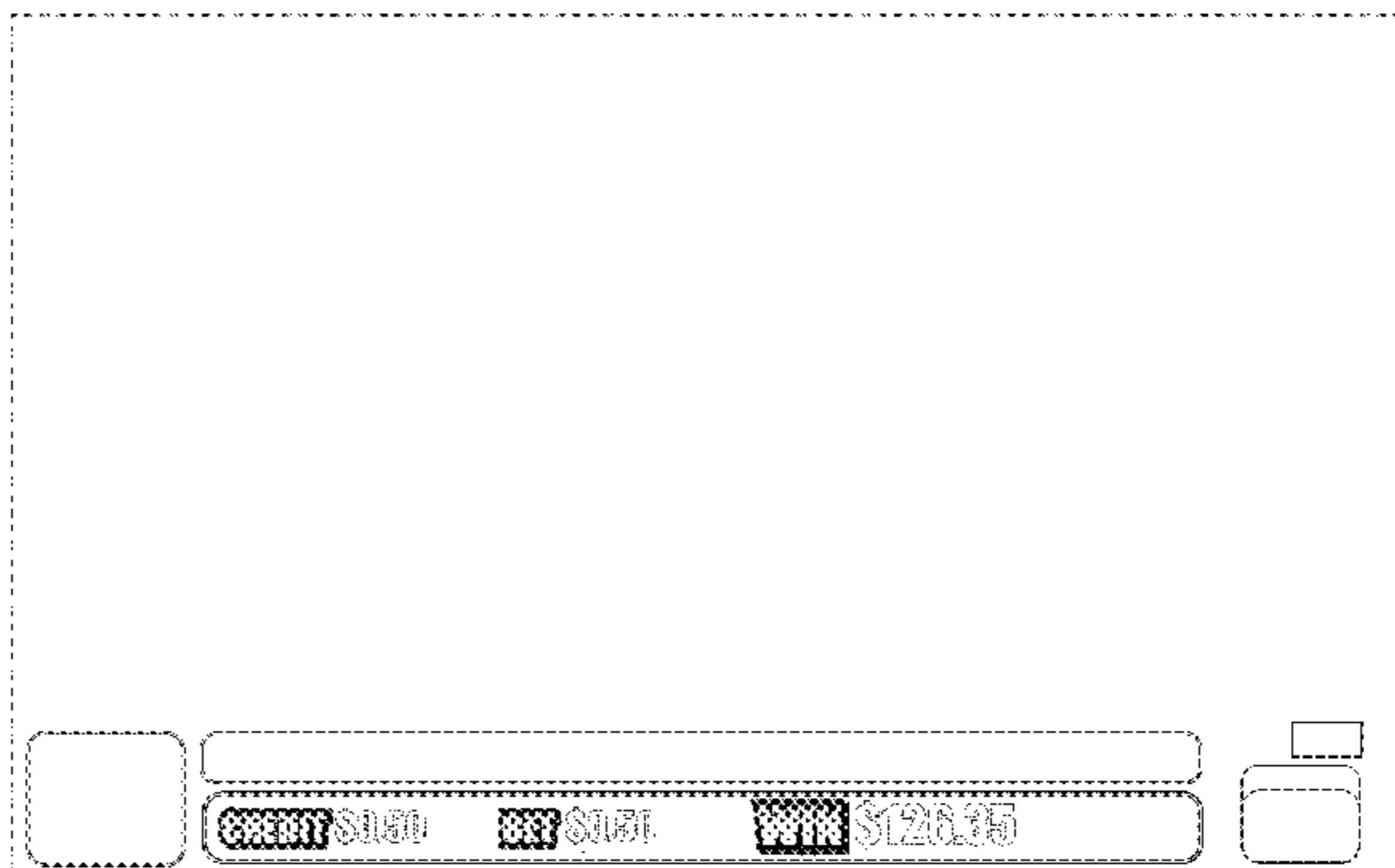
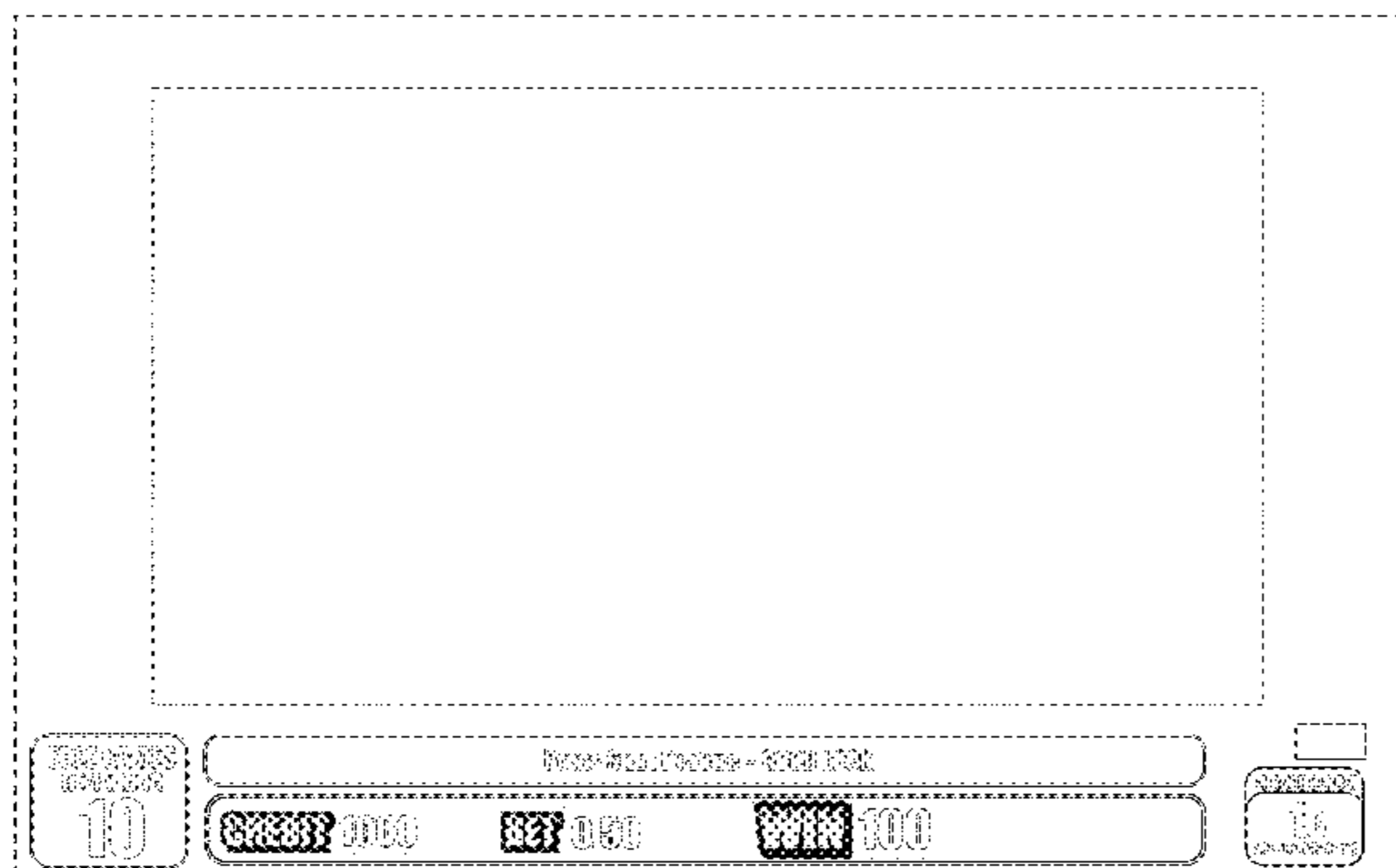

The ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with graphical user interface showing my new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; and, FIG. 4 is a front view of a fourth embodiment thereof. The broken lines shown in the drawings illustrate portions of the display screen with graphical user interface that form no part of the claimed design.

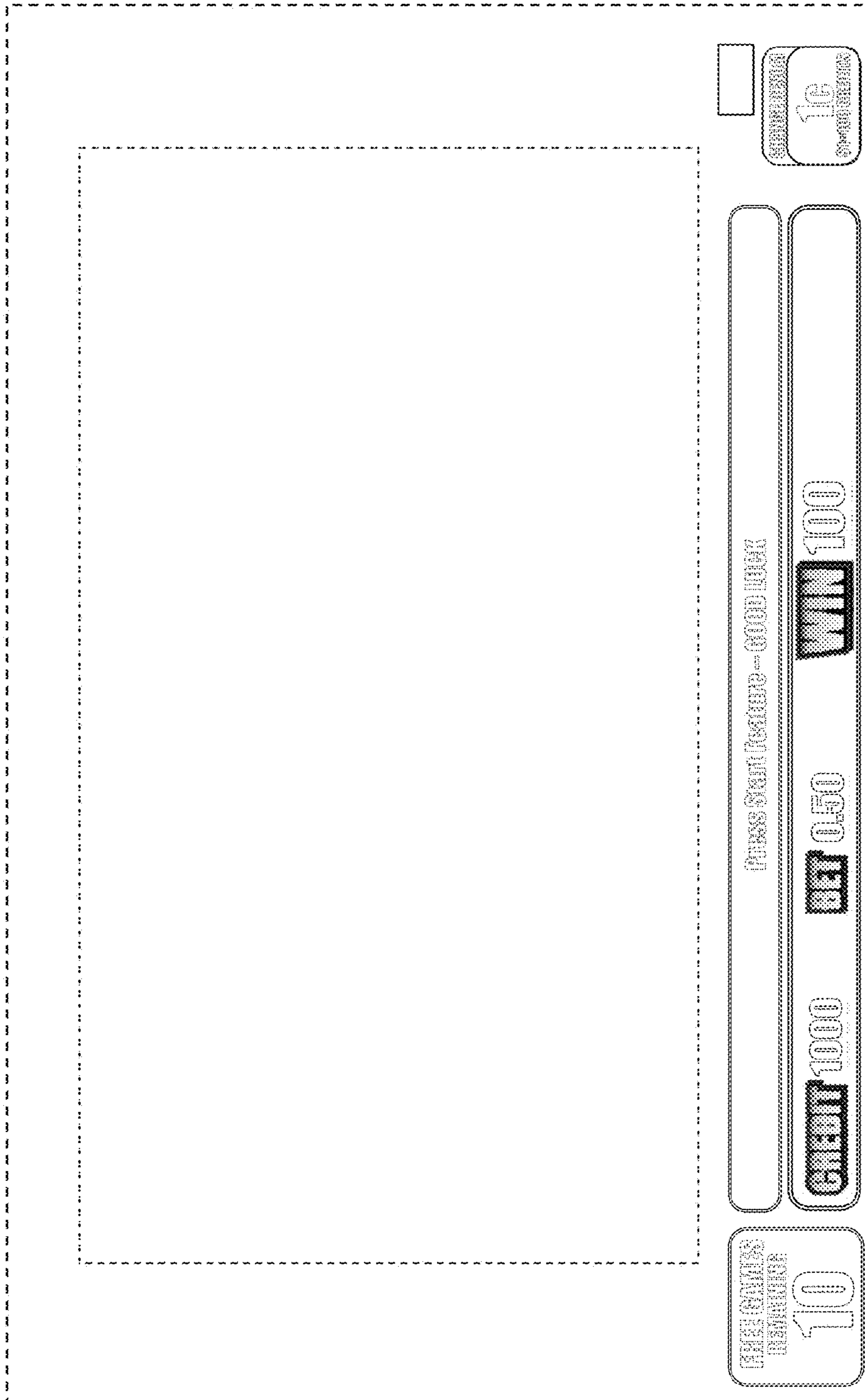

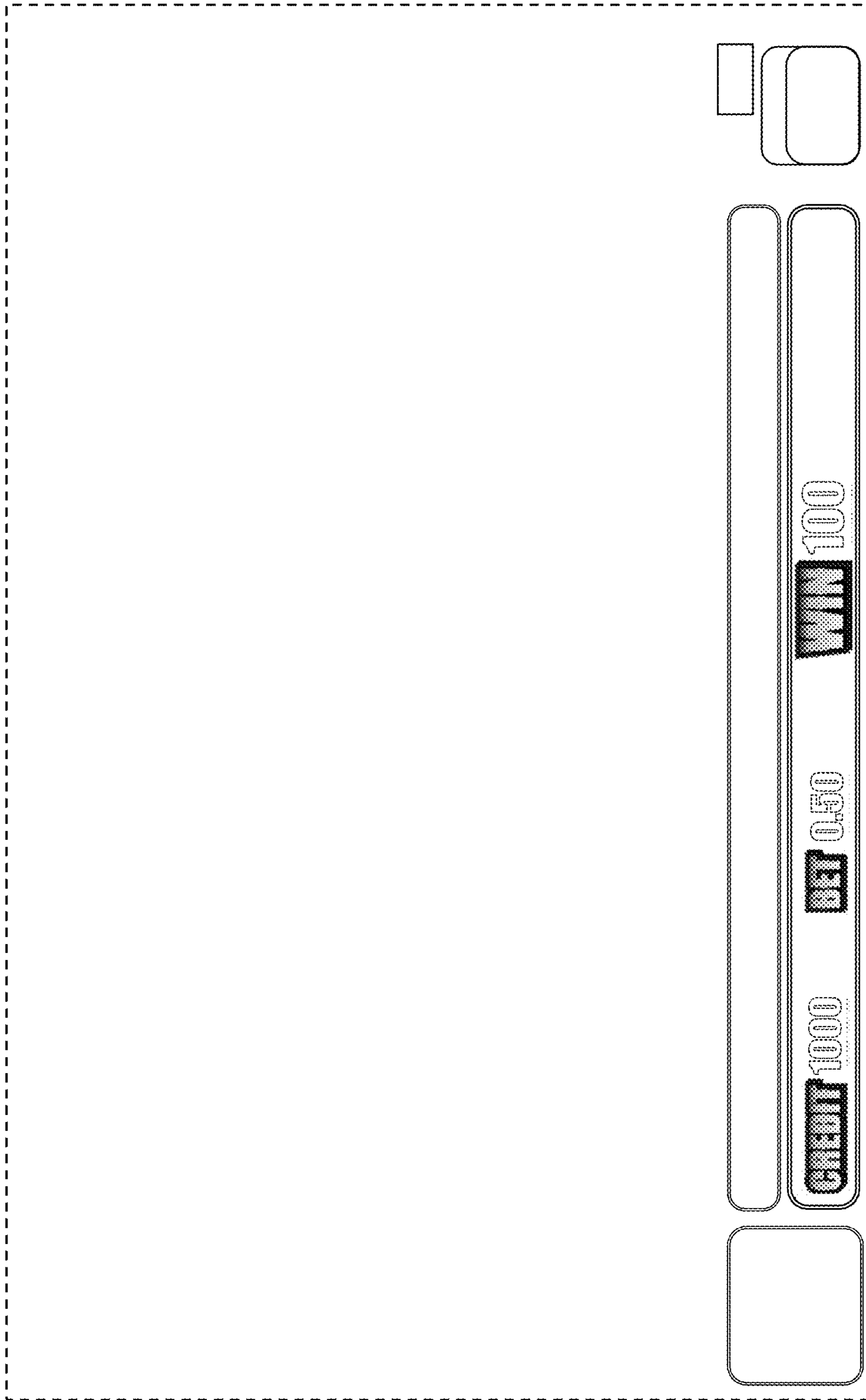

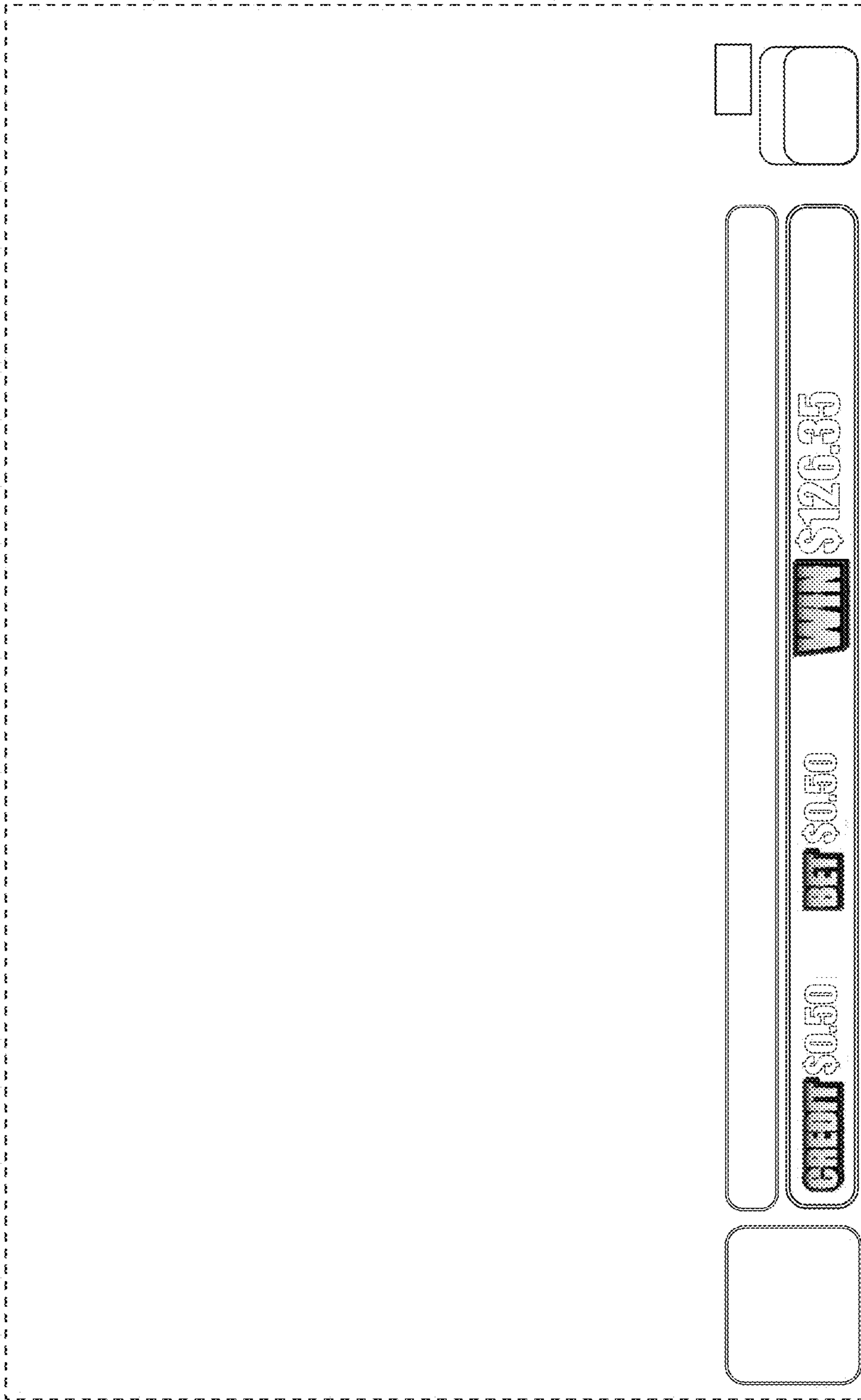
