FIG. 5 is a left side elevation view of a video camera;

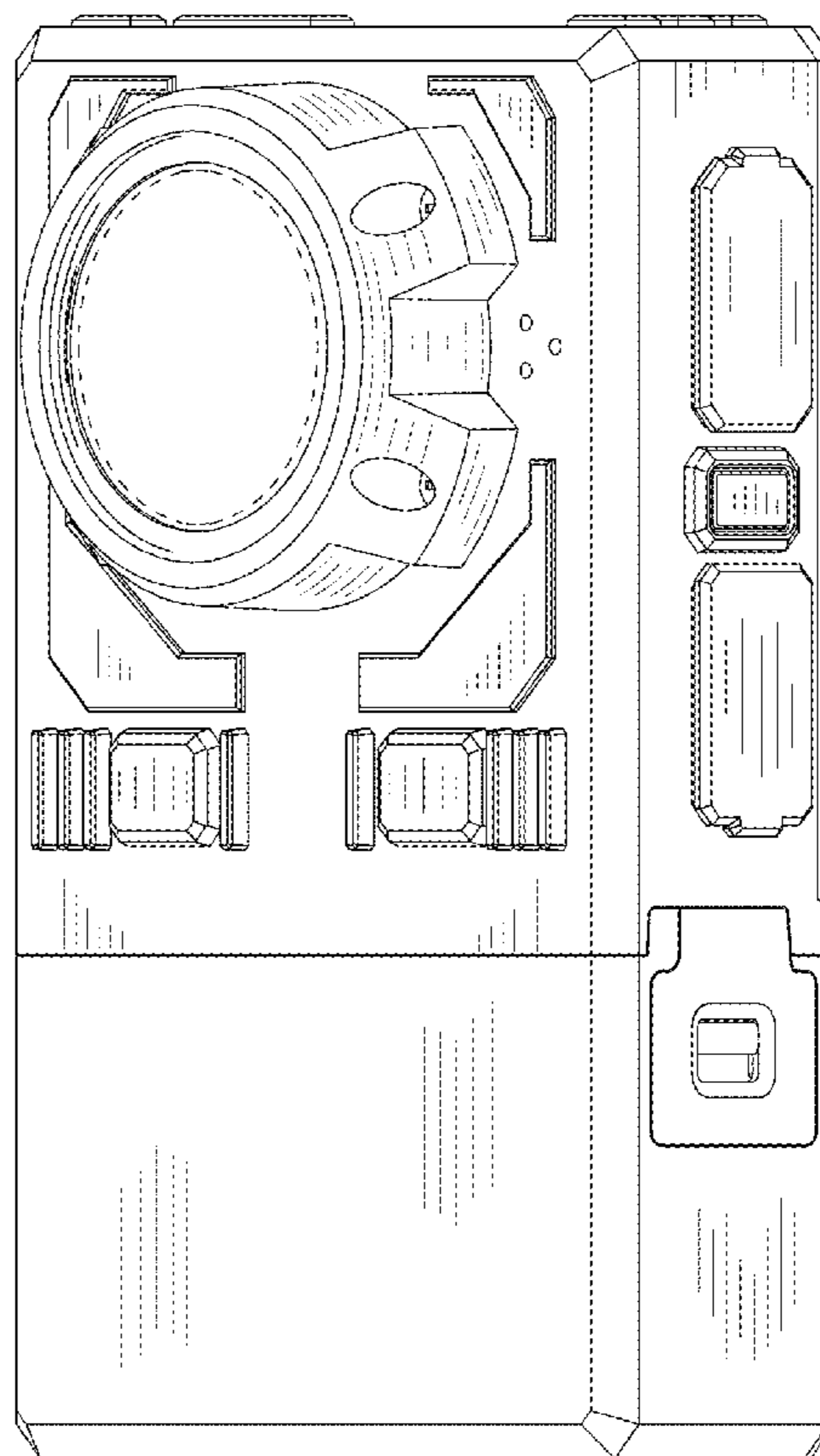
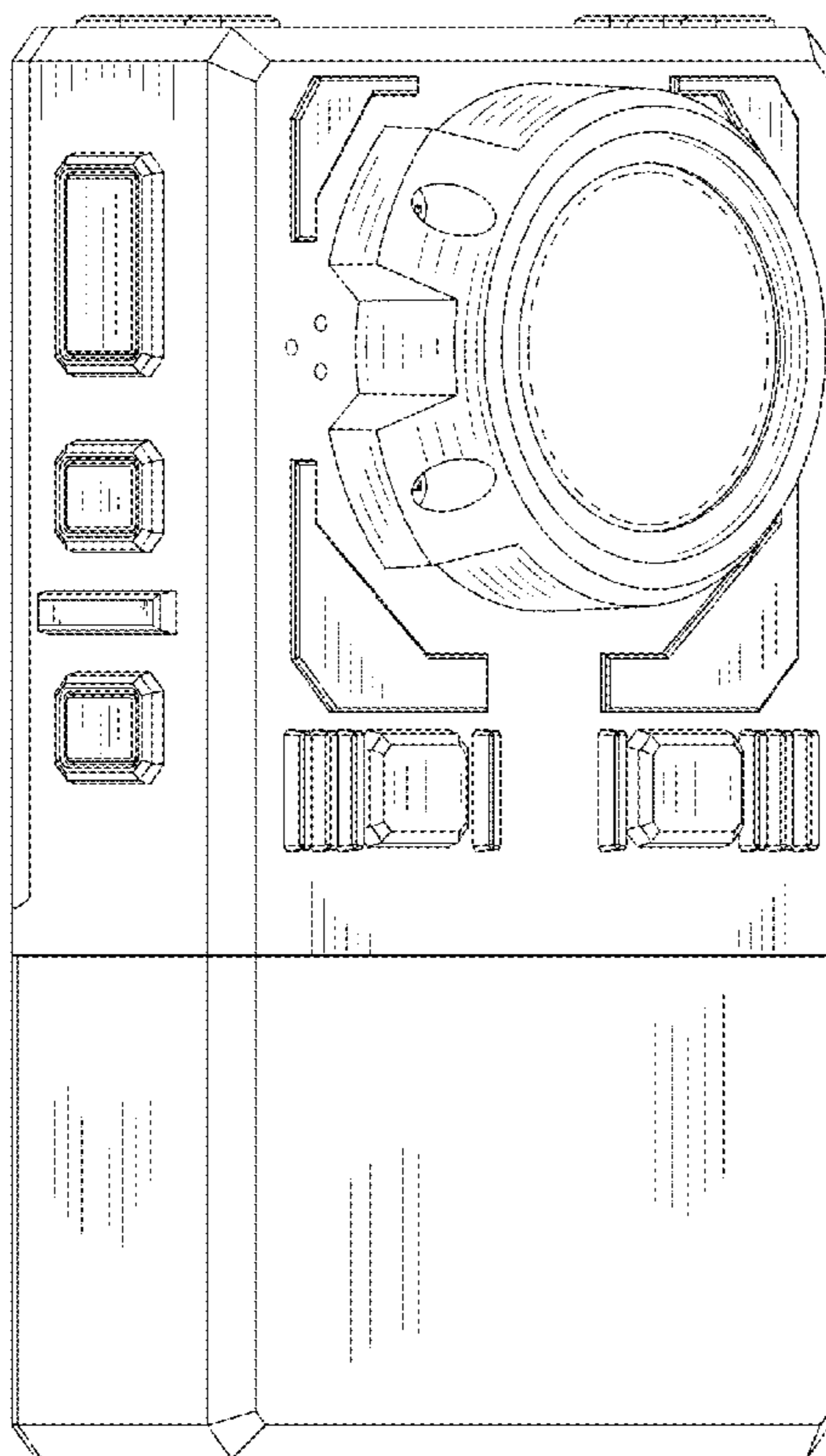
FIG. 6 is a right side elevation view of a video camera;

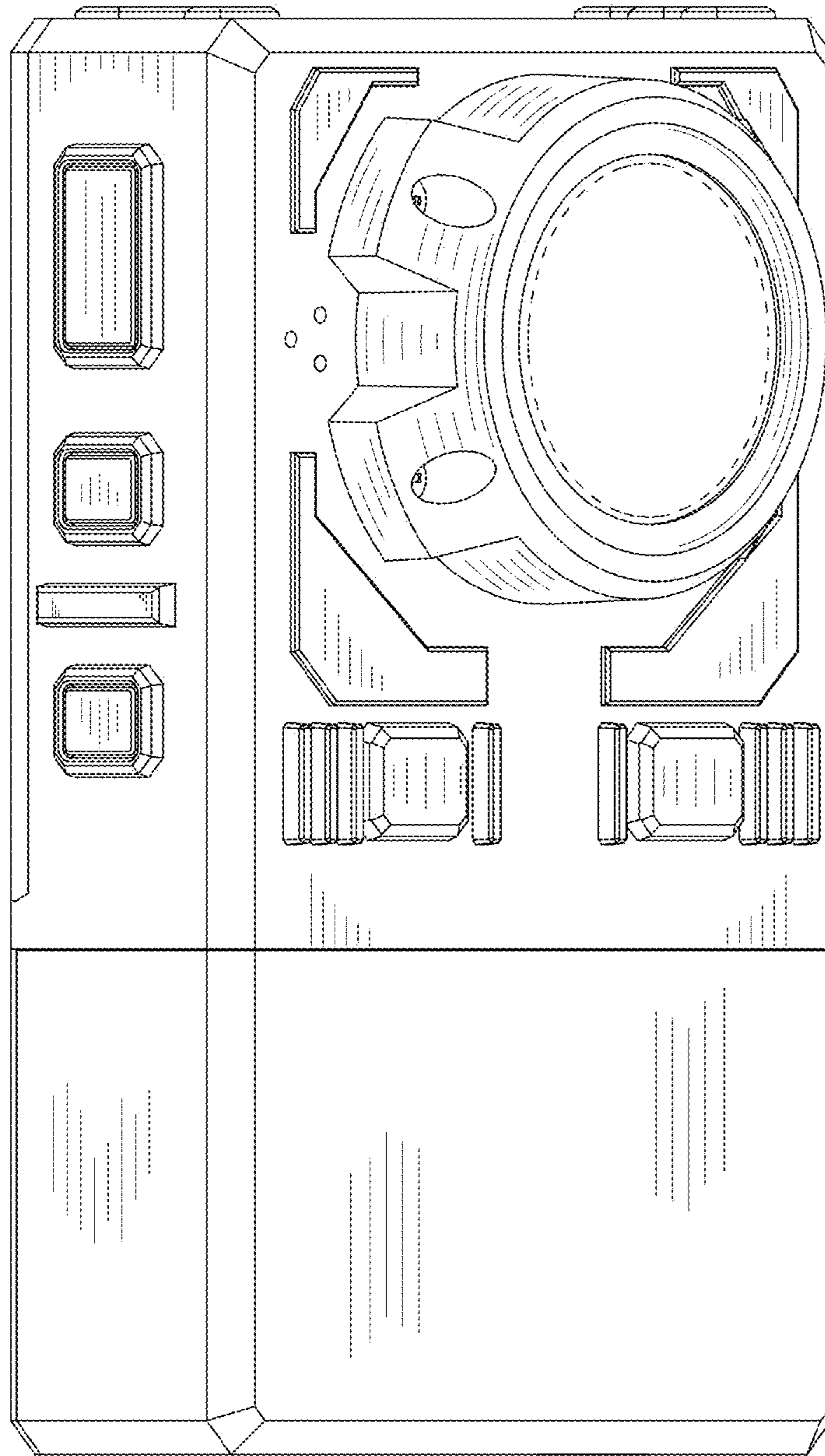

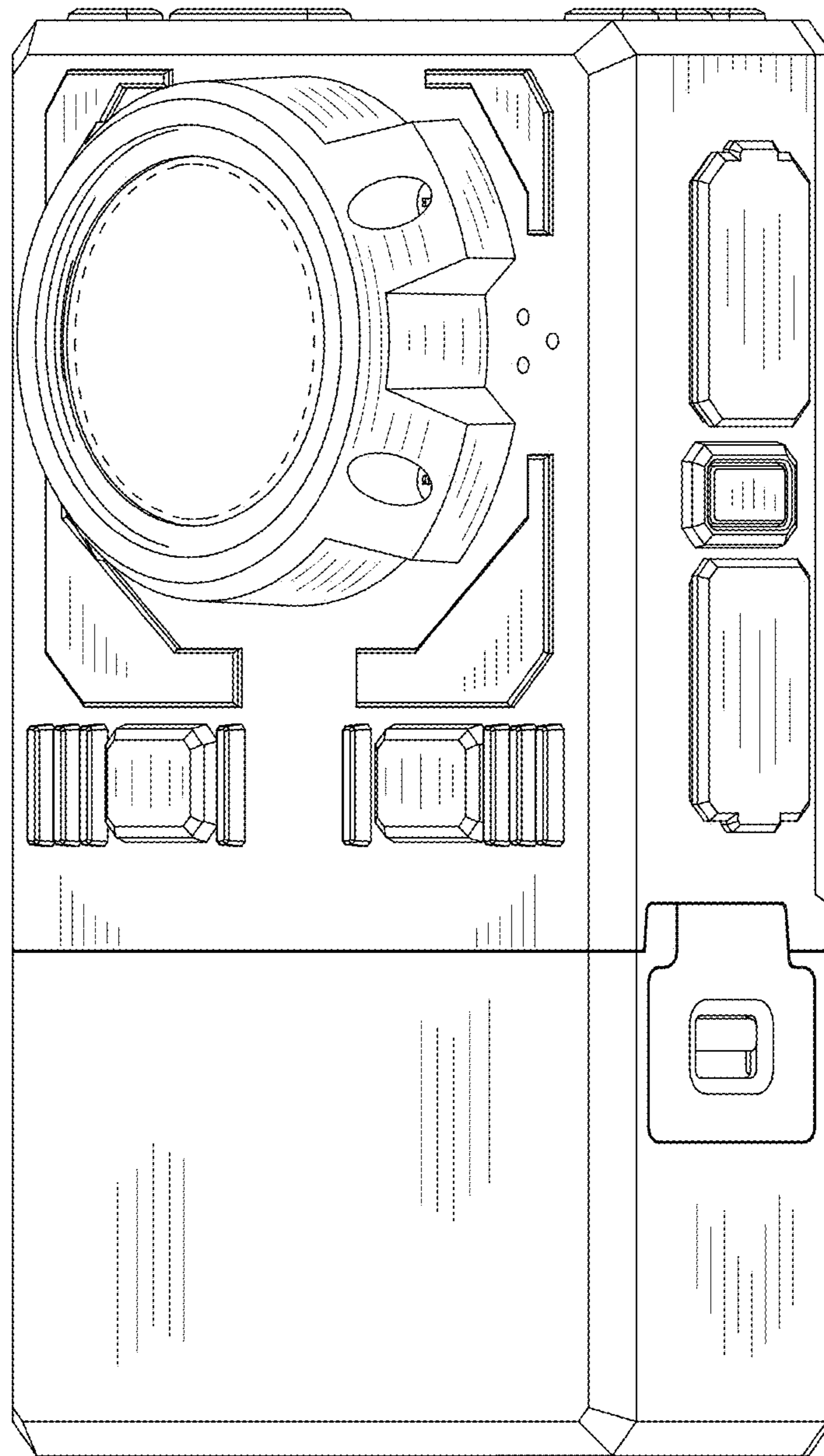

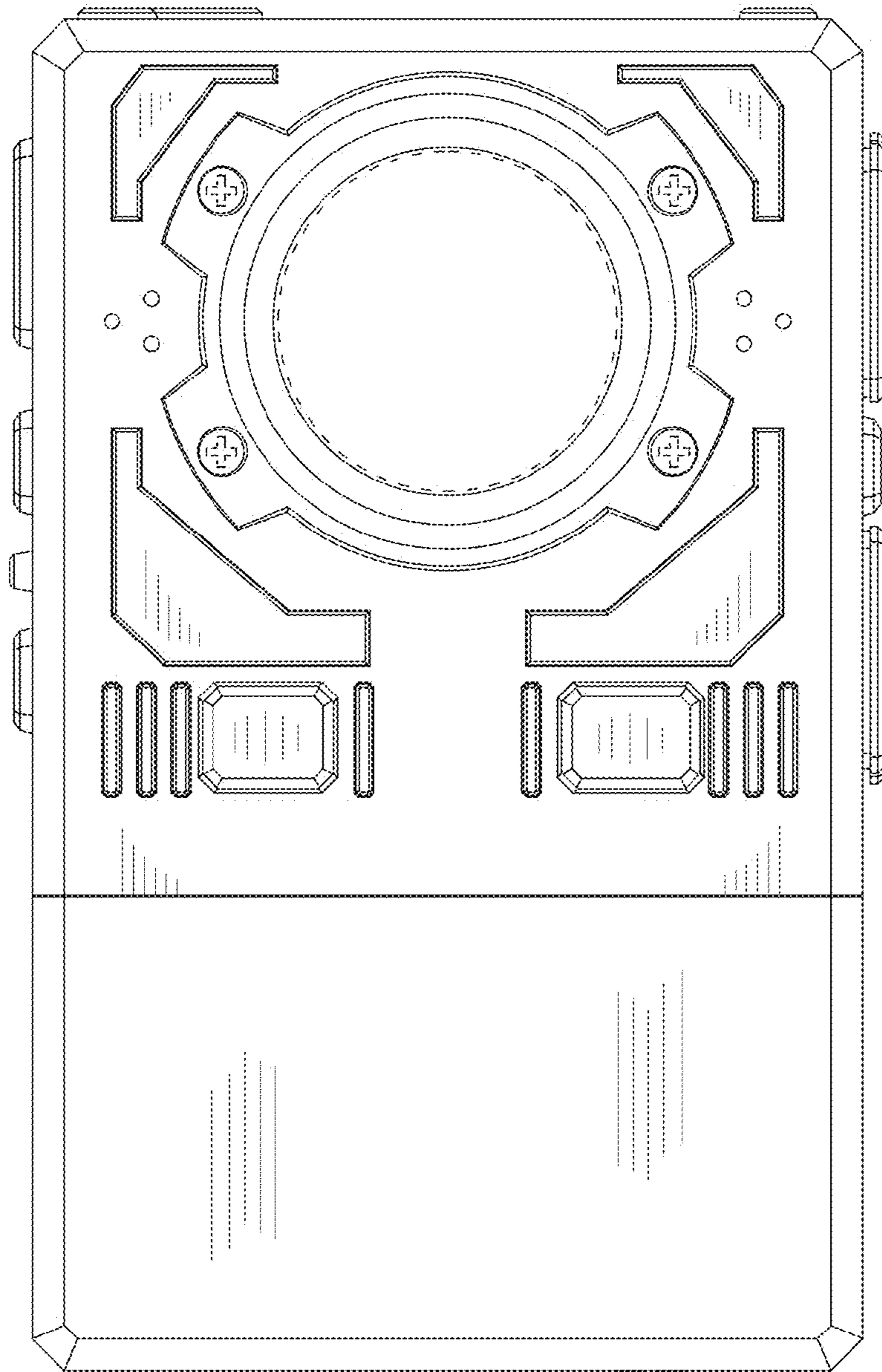

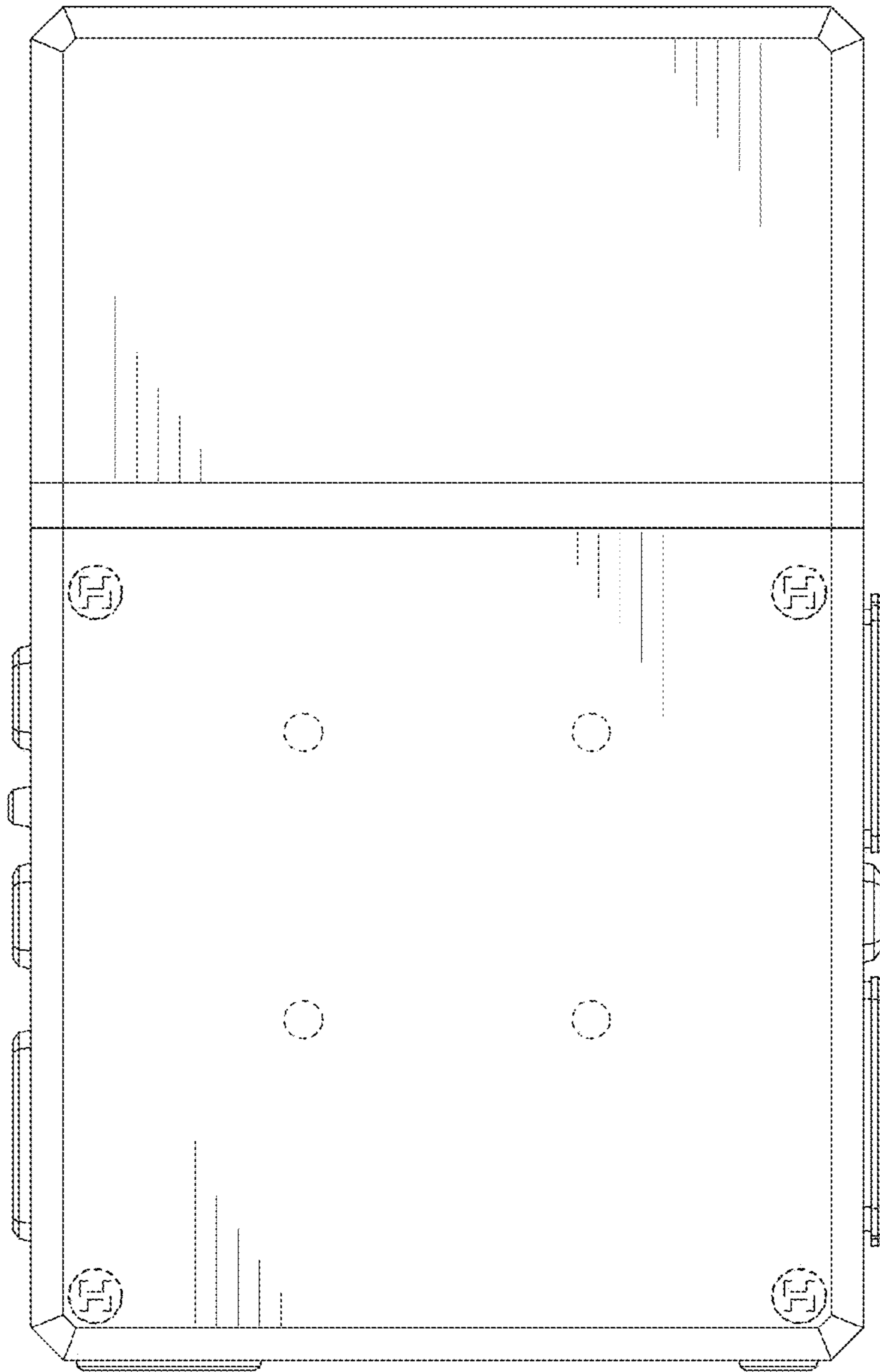

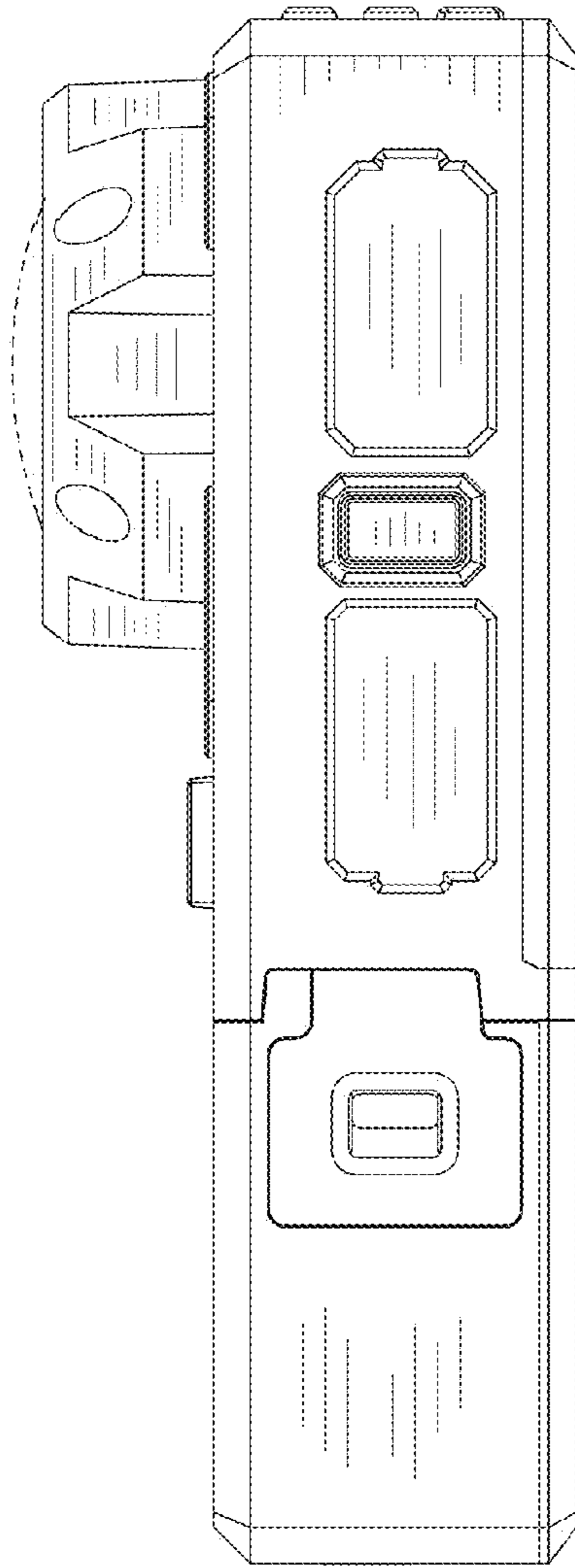

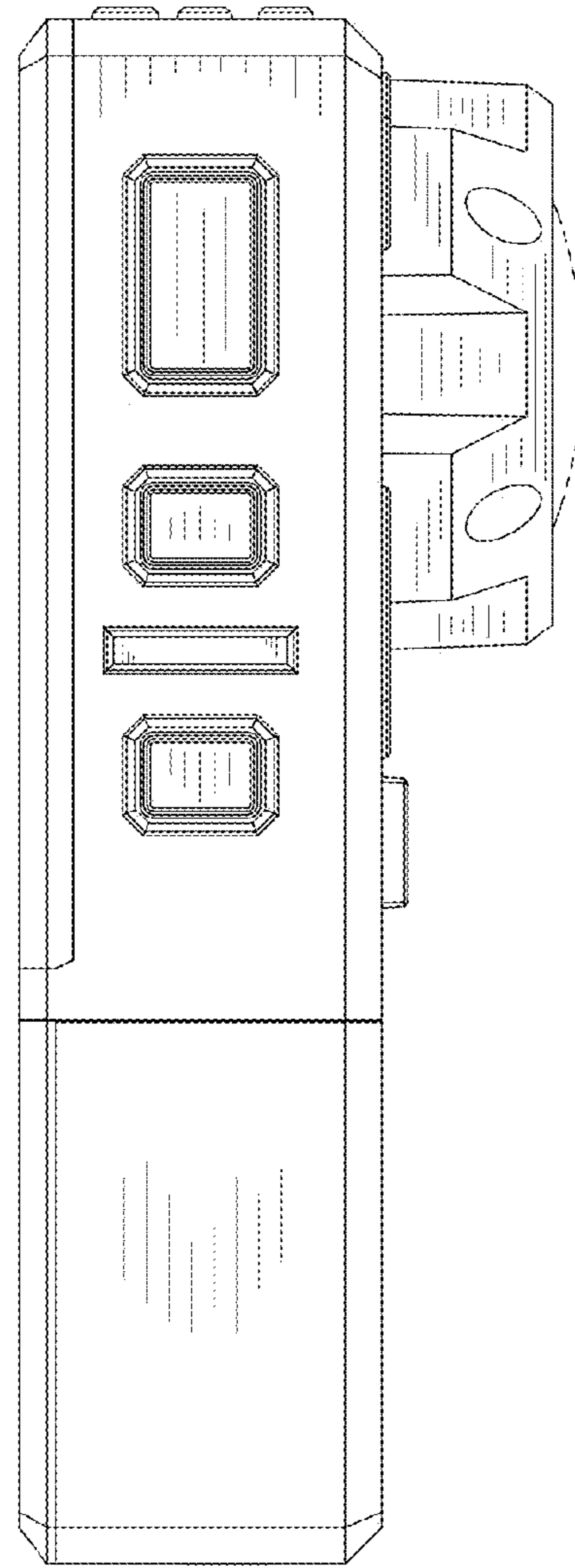

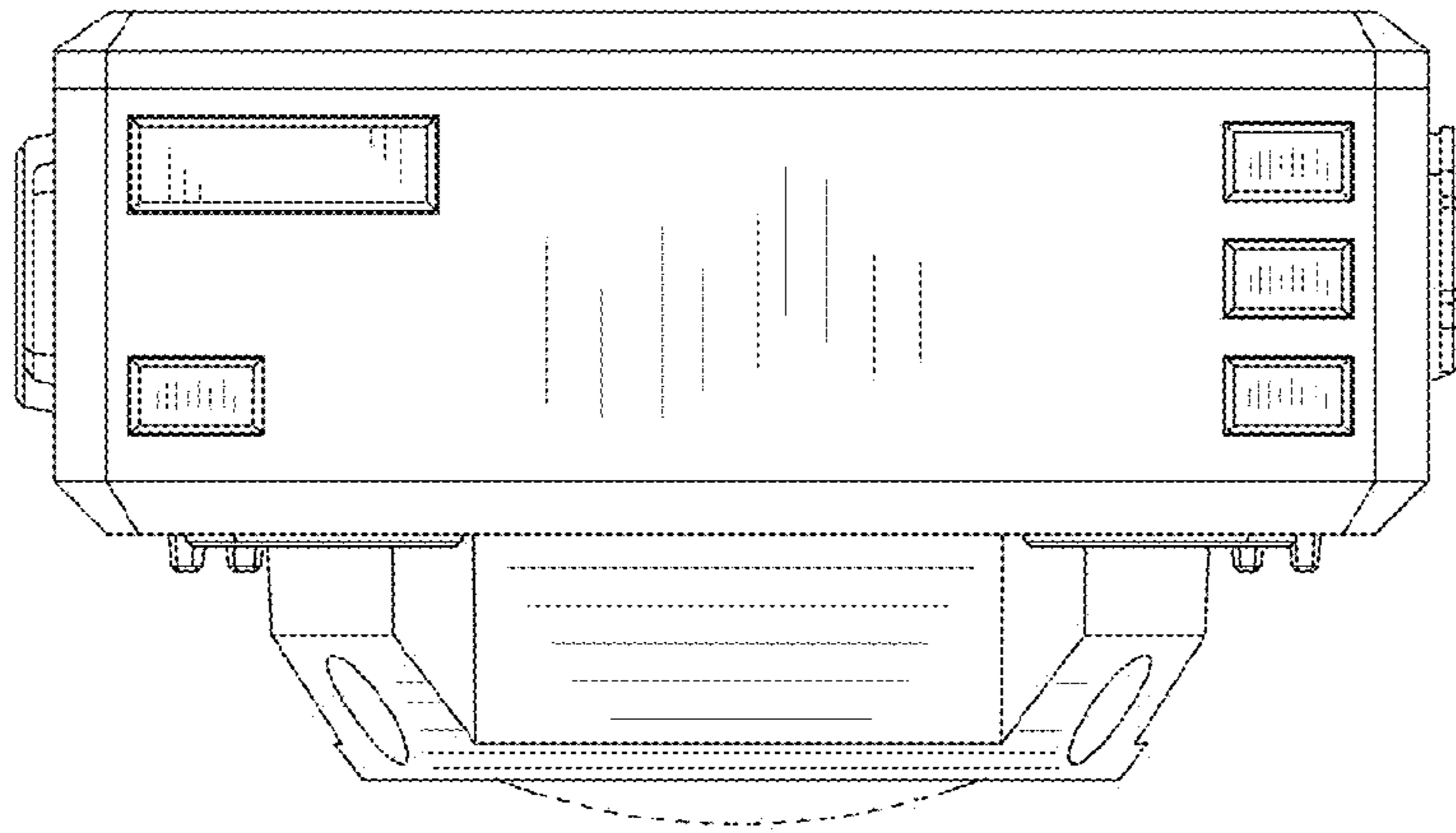

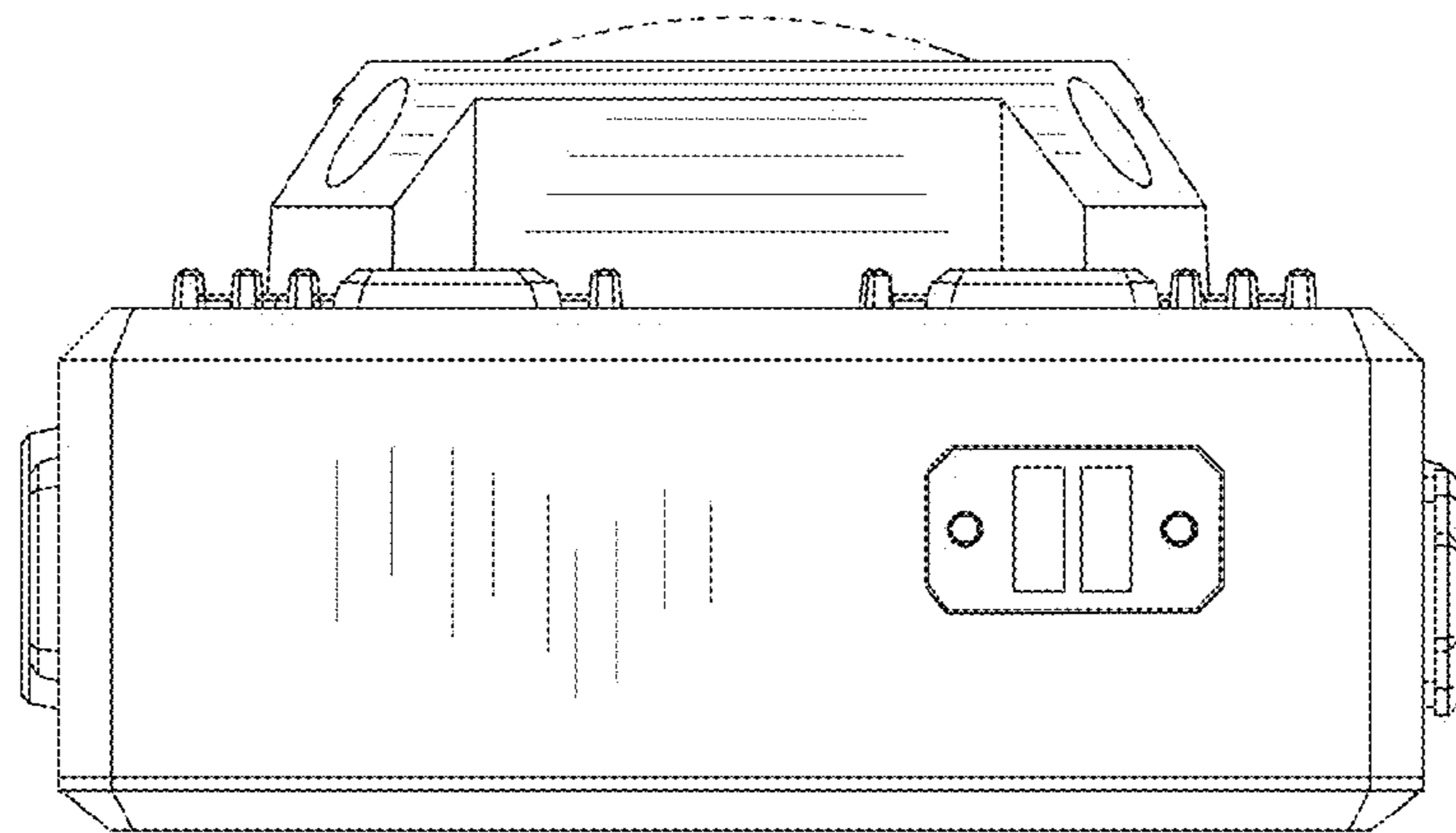
