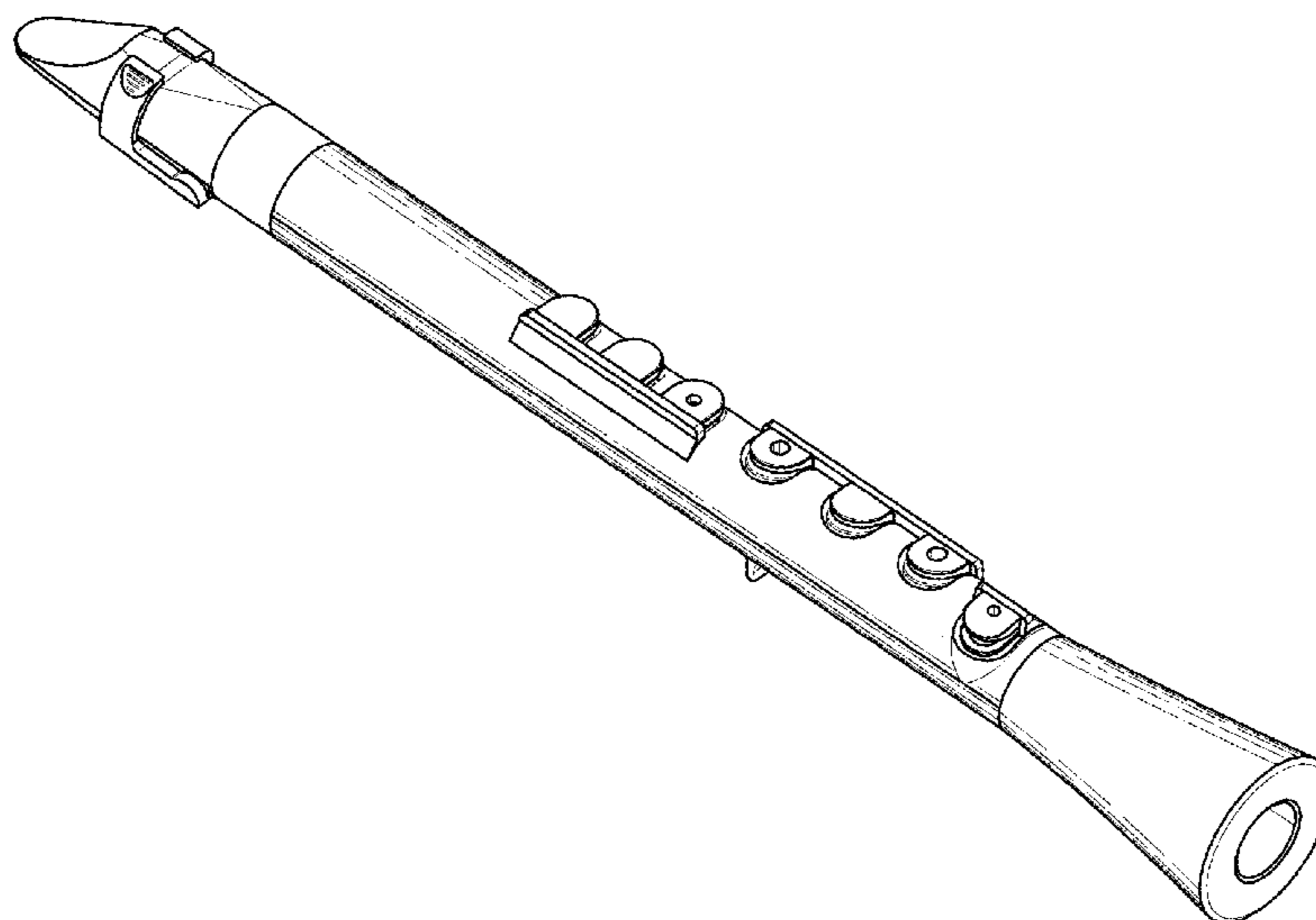

(57) **CLAIM**
The ornamental design for a musical wind instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective of a musical wind instrument; FIG. 2 is a right side elevation thereof; FIG. 3 is a left side elevation thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a front view thereof; and, FIG. 7 is a rear view thereof. The broken lines are included for the purpose of illustrating portions of the musical wind instrument that form no part of the claimed design.

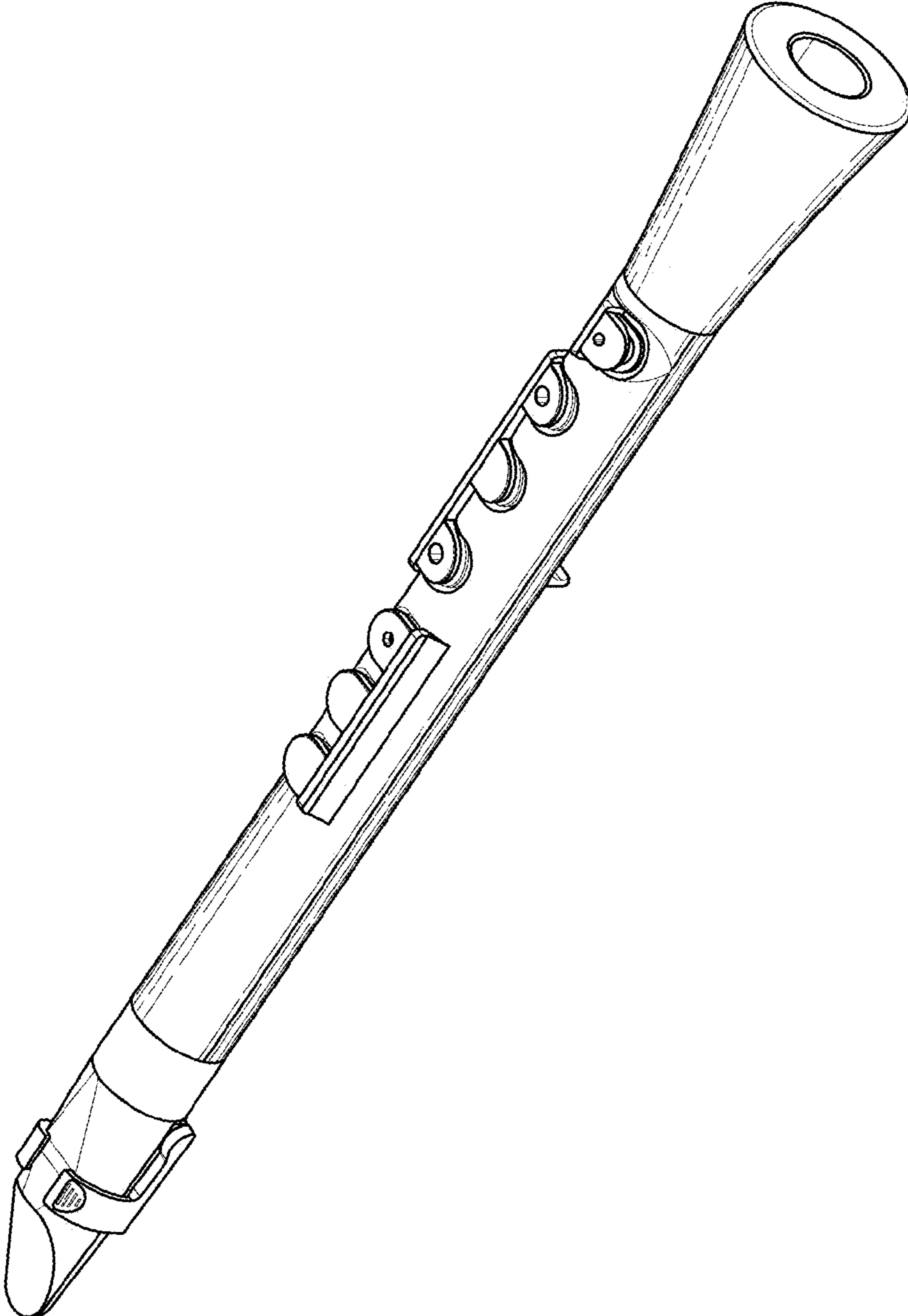

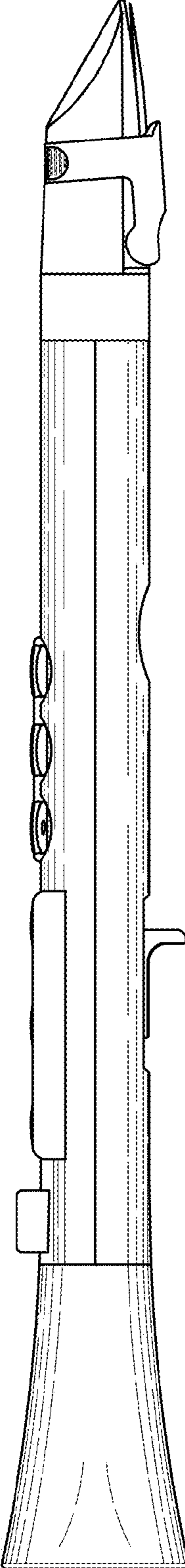

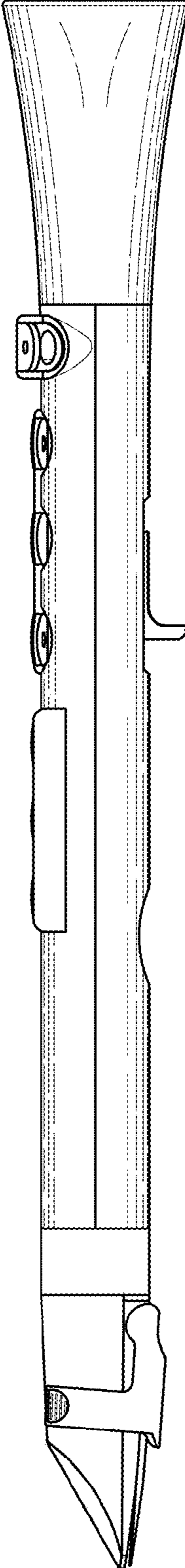

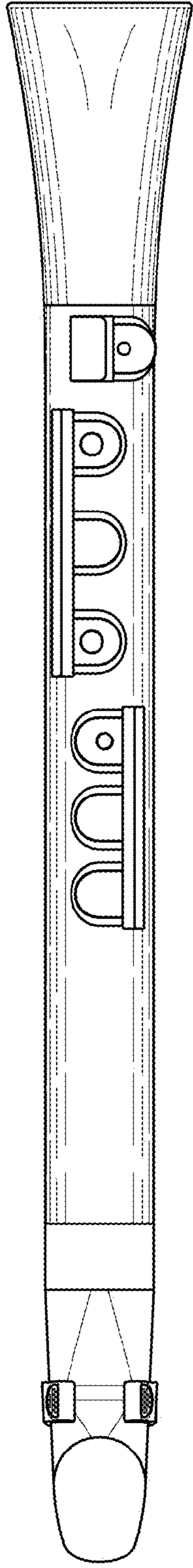

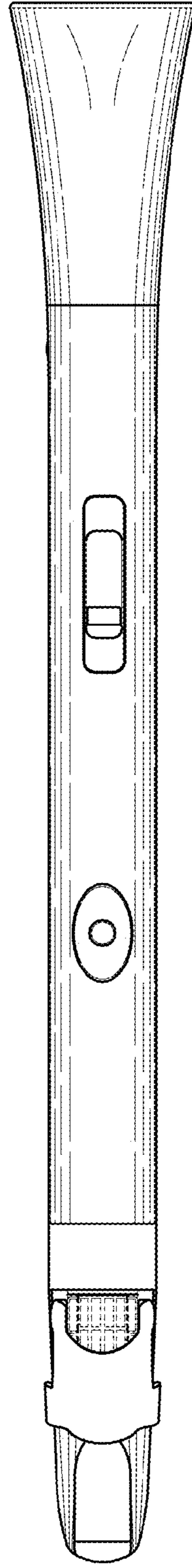

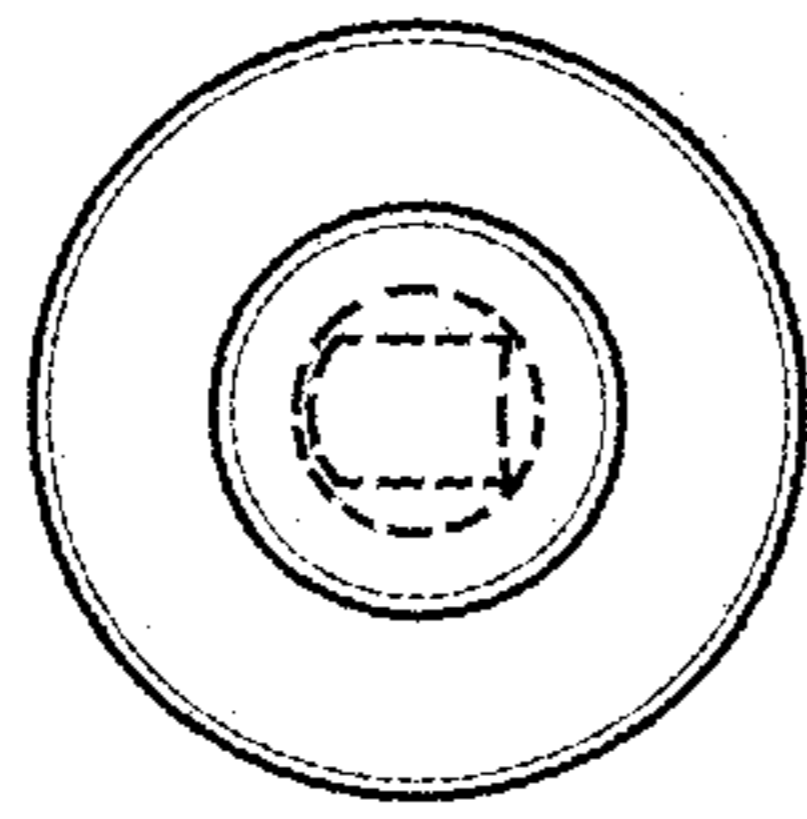
