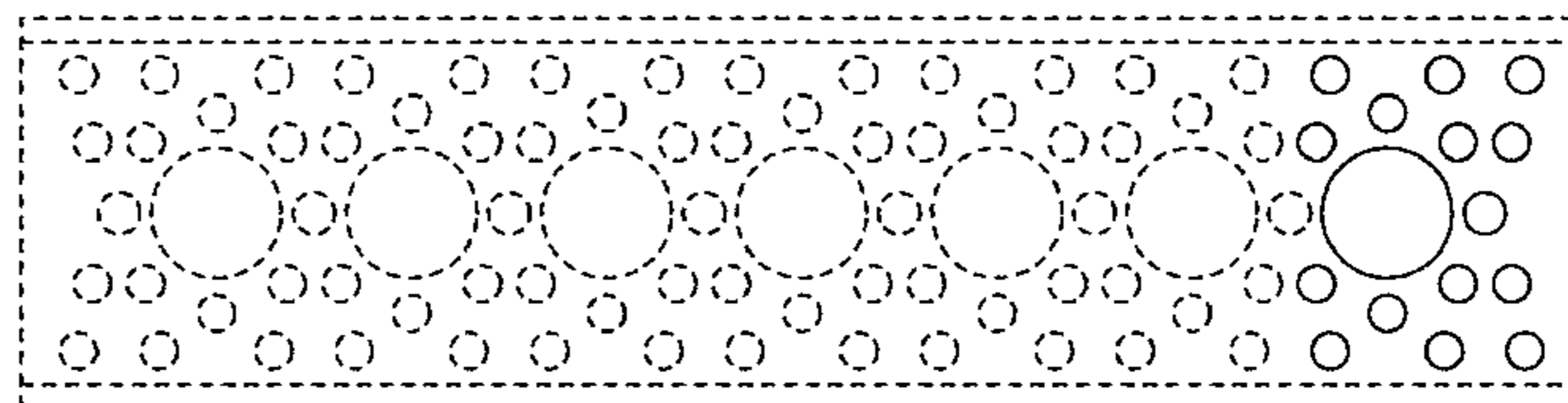
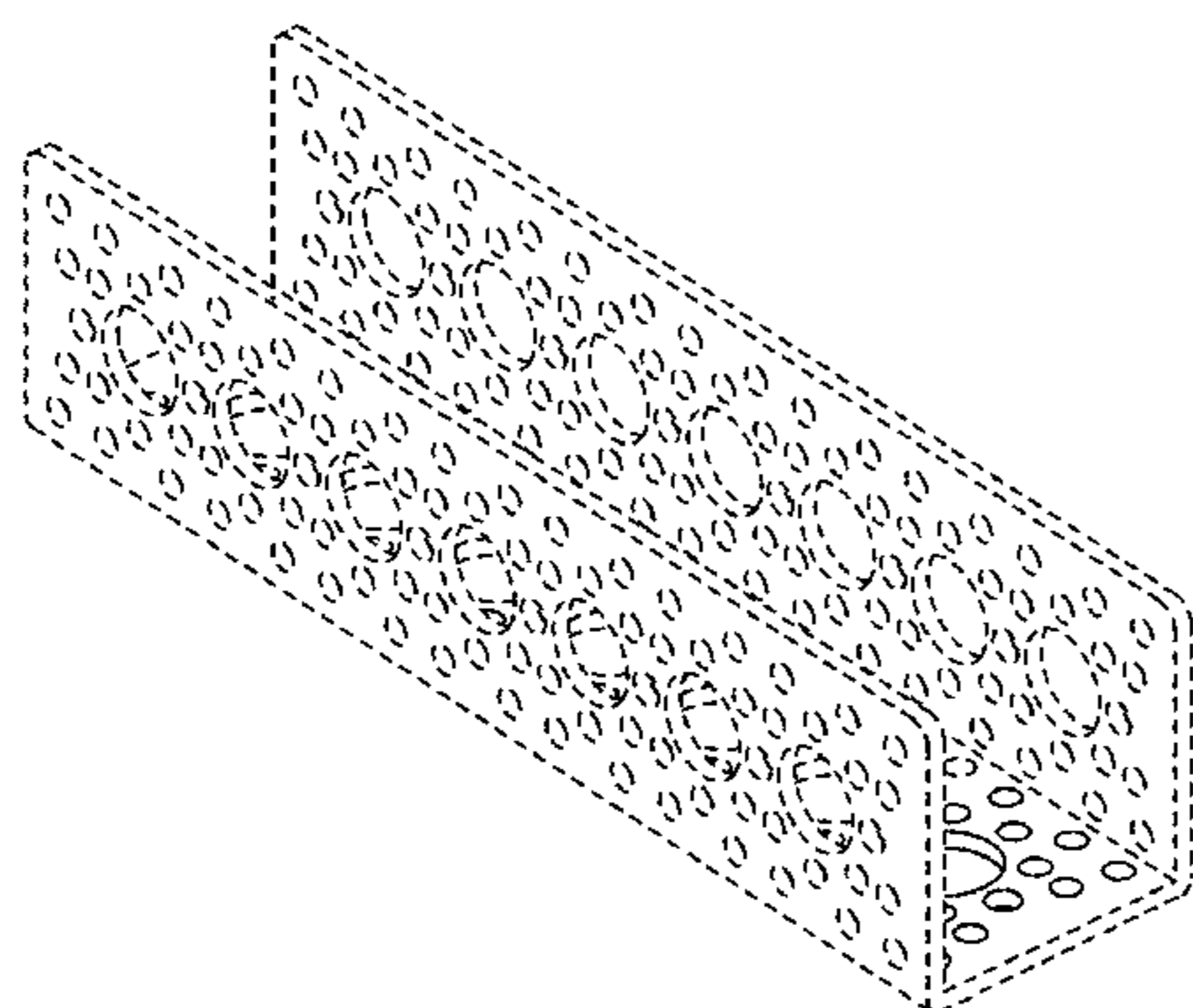
(57) **CLAIM**

The ornamental design for a channel hole pattern, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the channel hole pattern. FIG. 2 is a side view of the channel hole pattern. FIG. 3 is an end view of the channel hole pattern. FIG. 4 is a top view of the channel hole pattern; and, FIG. 5 is a bottom view of the channel hole pattern. The broken lines of FIGS. 1-5 are included for the purpose of illustrating environmental structure and form no part of the claimed design.

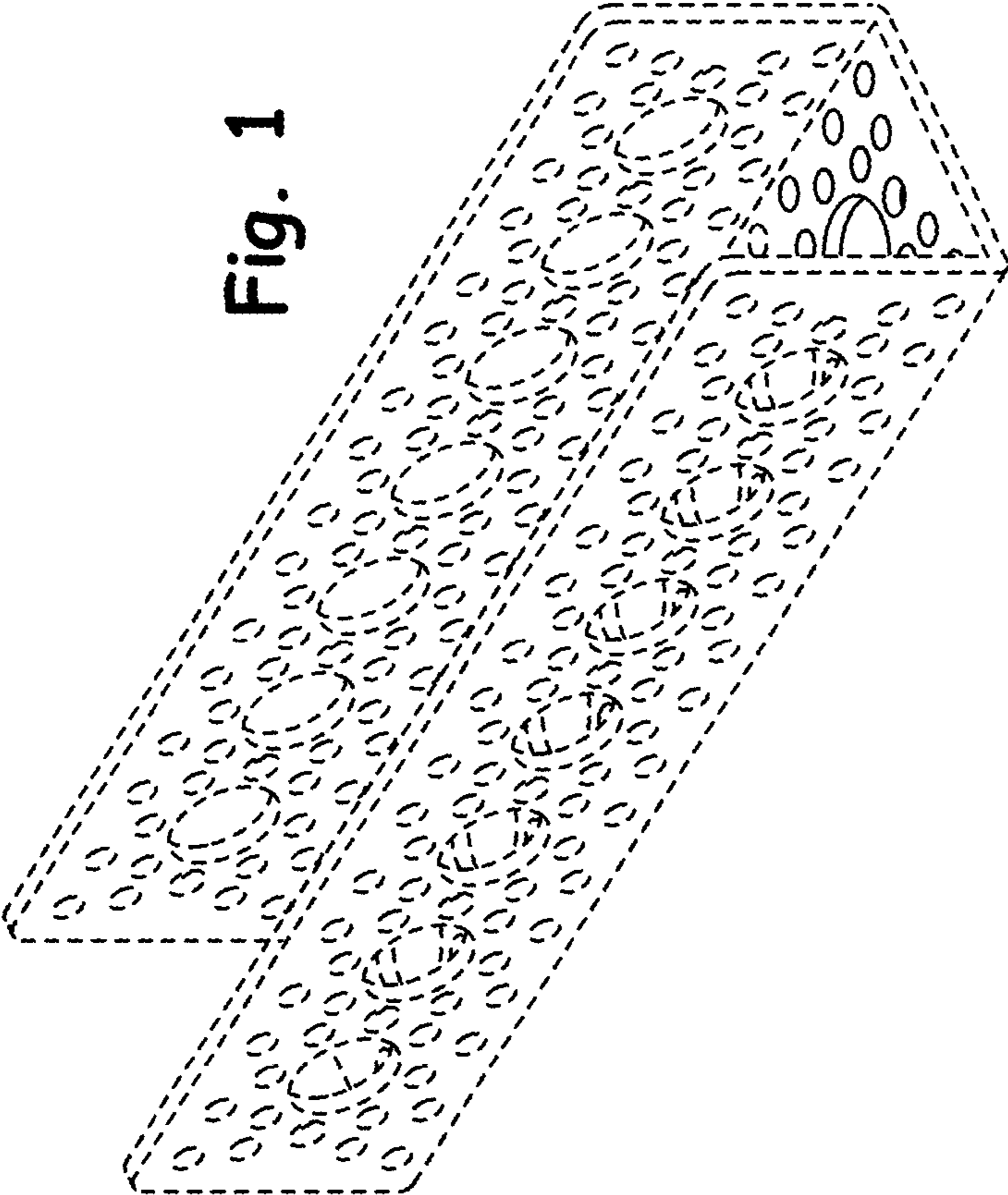

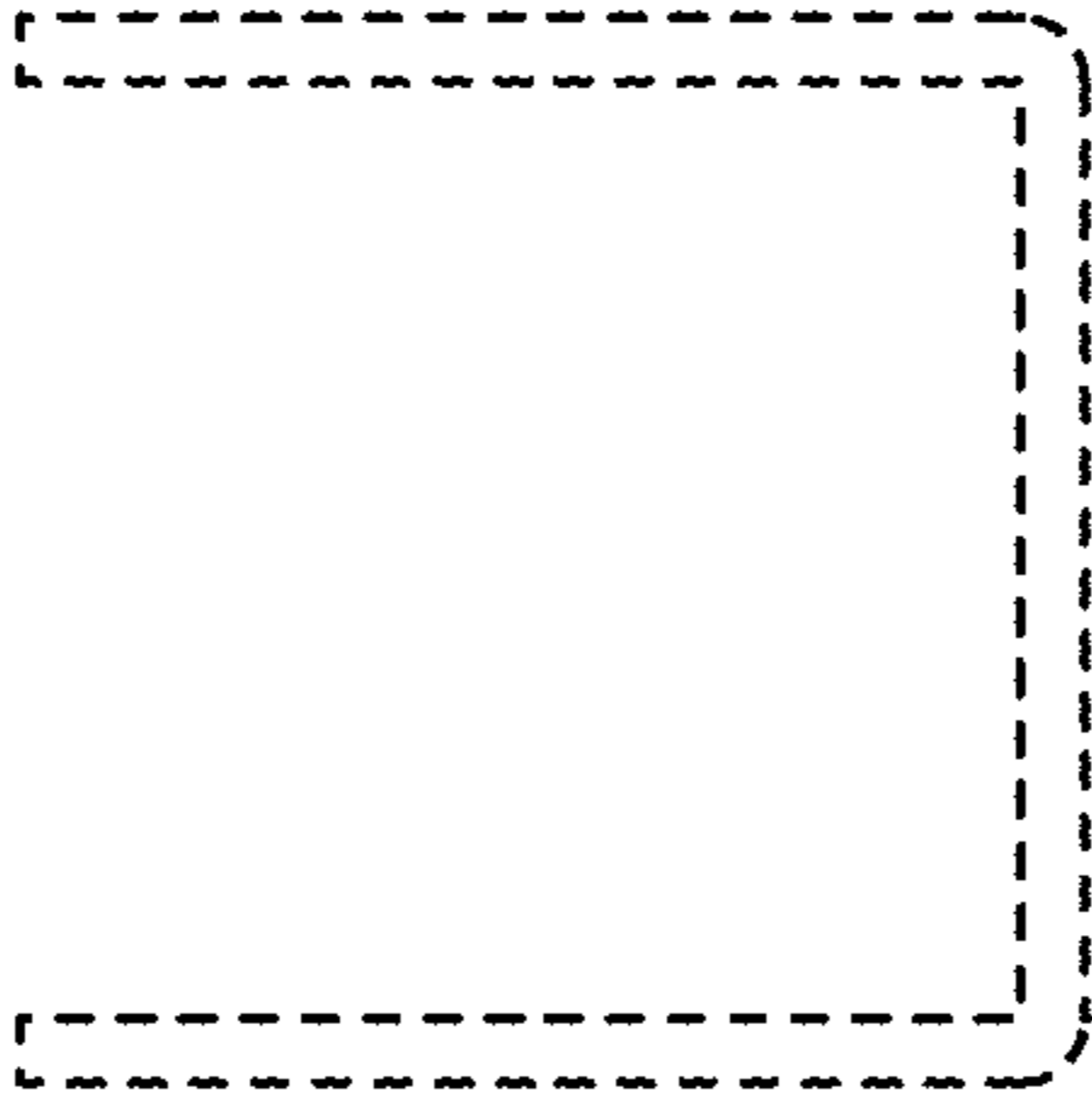

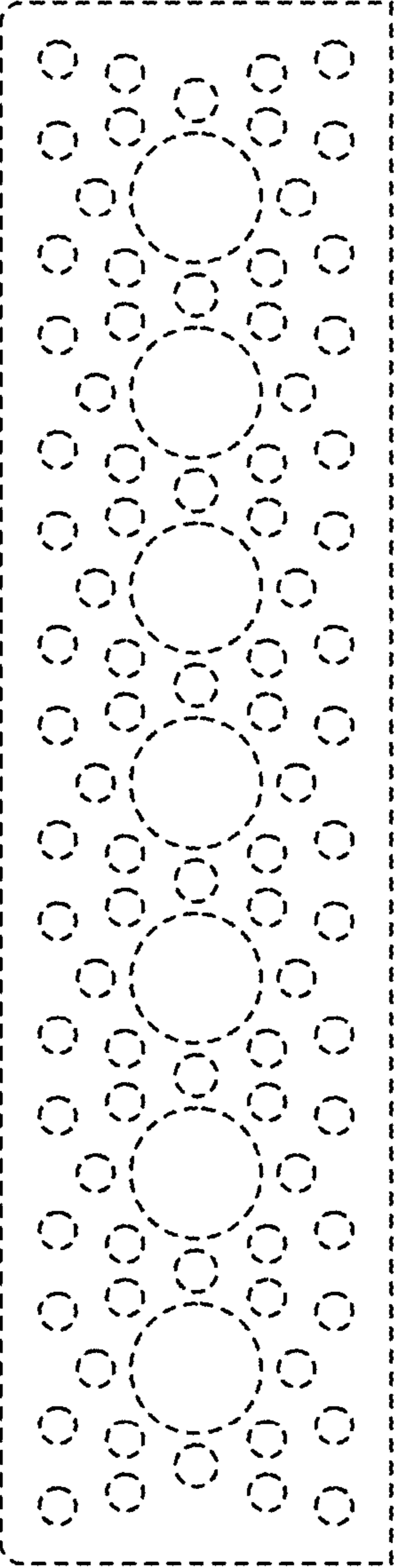

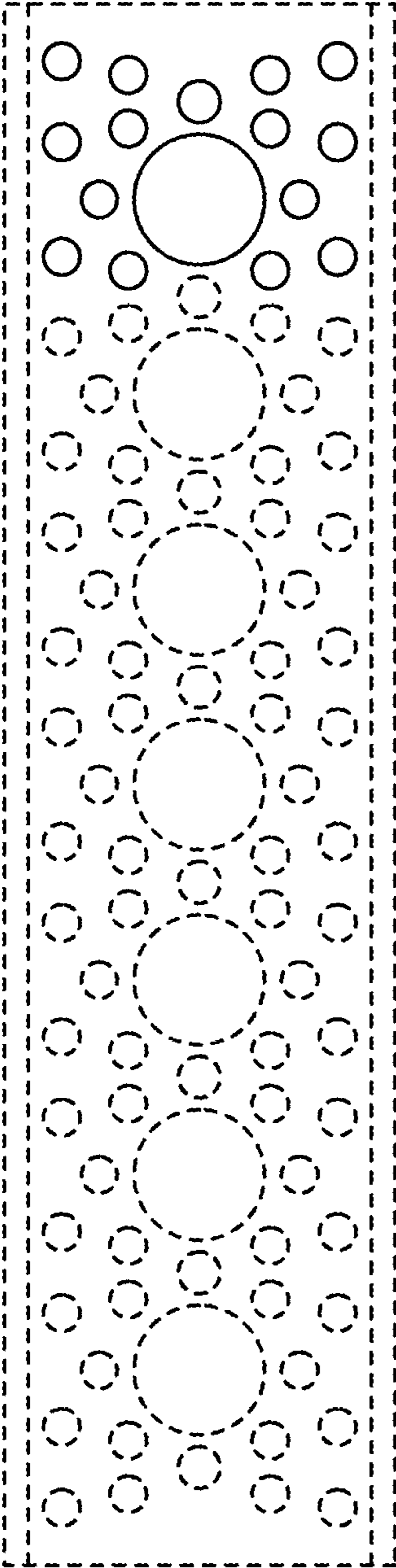

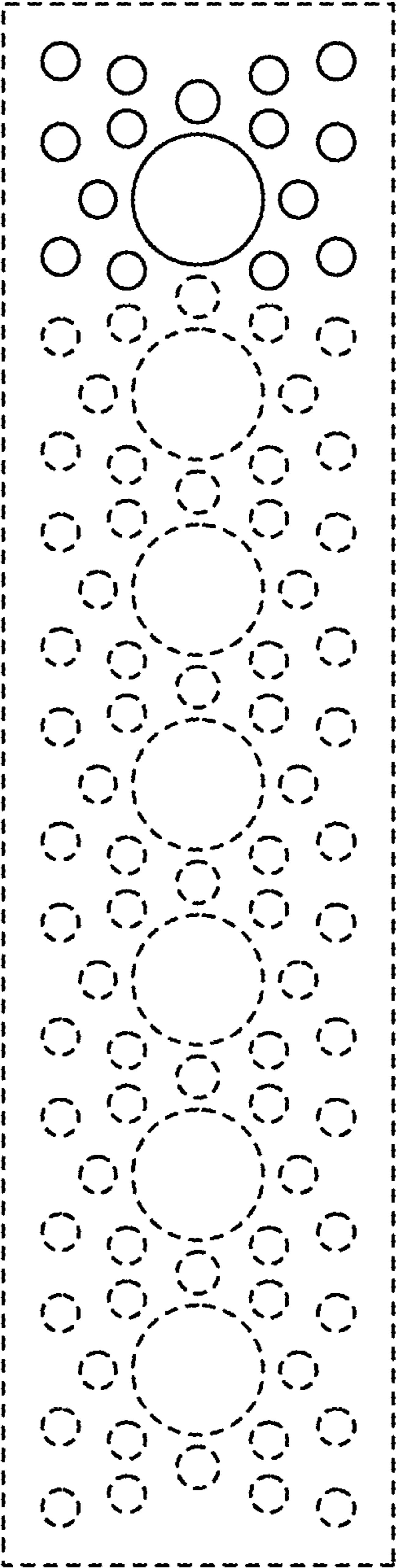
