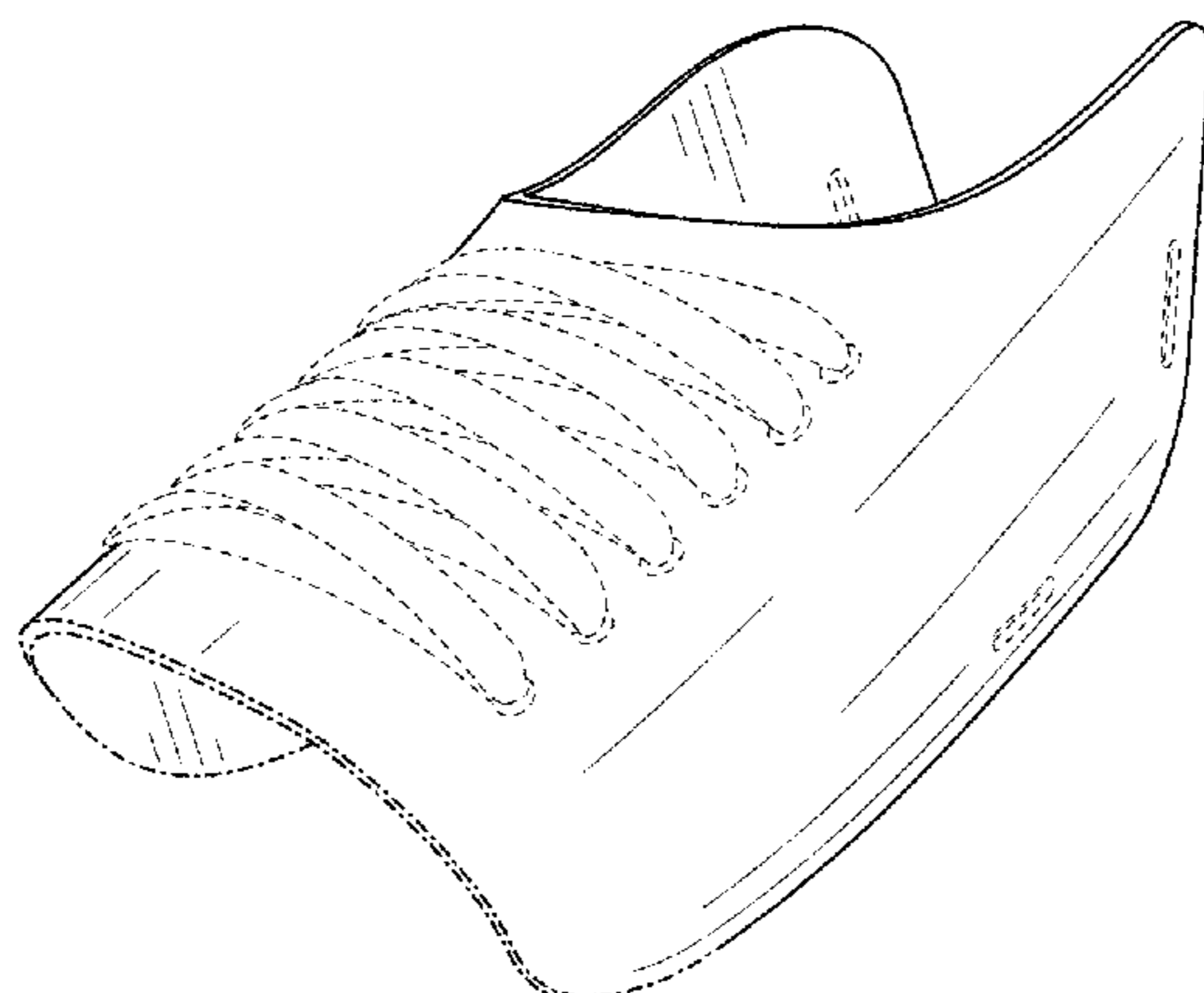
(57) **CLAIM**

The ornamental design for a skate guard, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a skate guard showing our new design;
FIG. 2 is a front side elevation view;
FIG. 3 is a rear side elevation view;
FIG. 4 is a right side elevation view;
FIG. 5 is a left side elevation view;
FIG. 6 is a top side plan view; and,
FIG. 7 is a bottom side plan view.

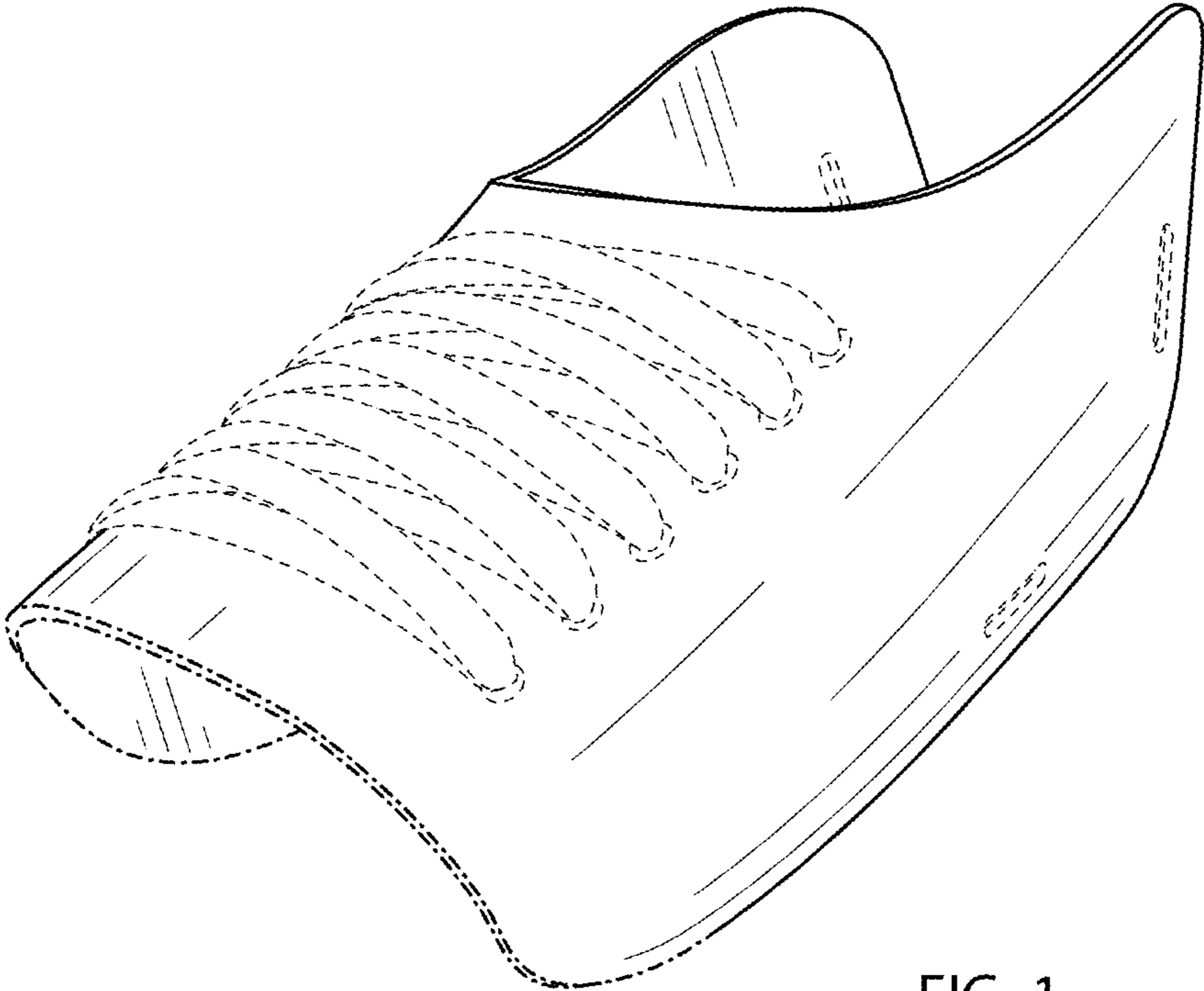

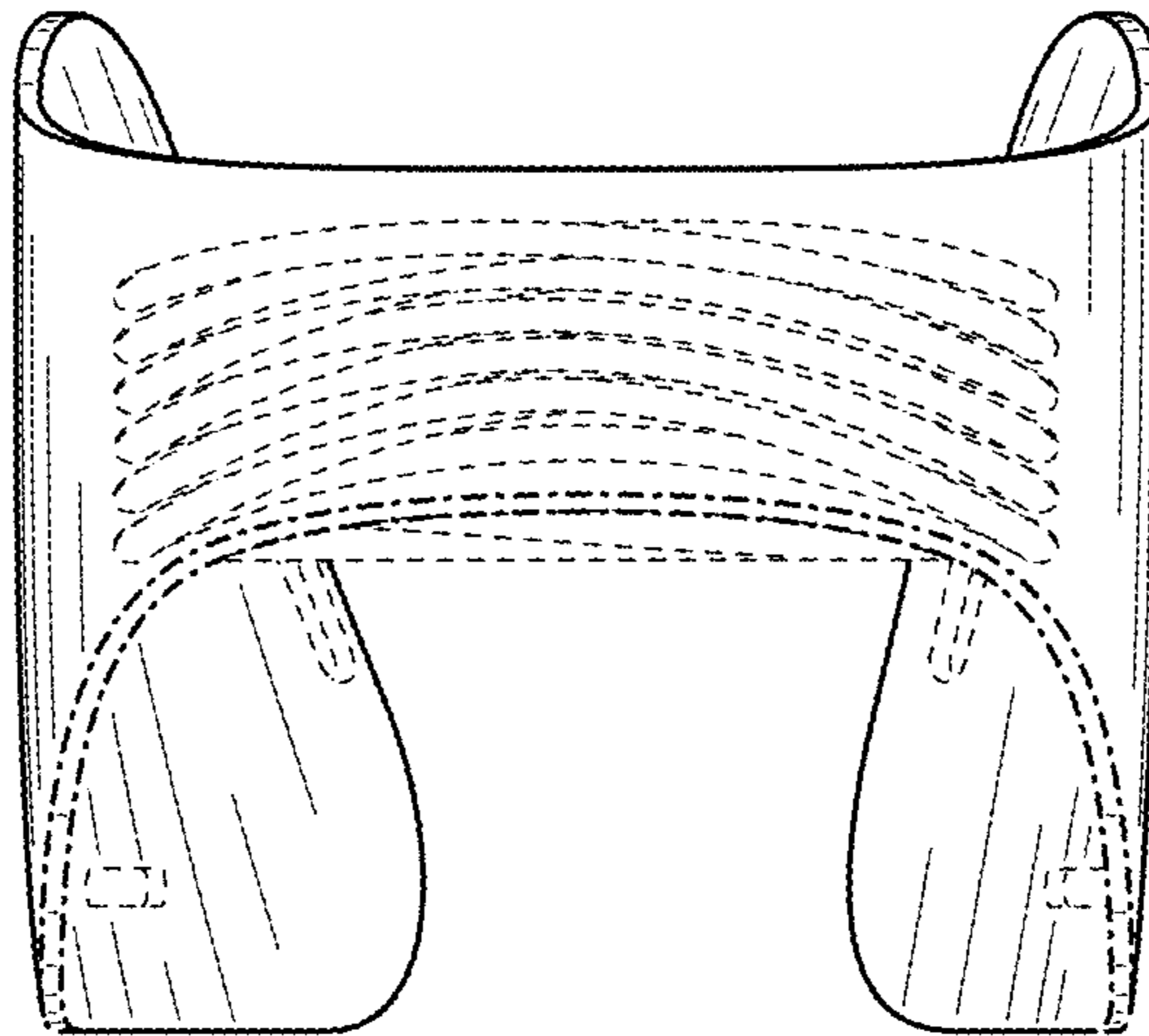

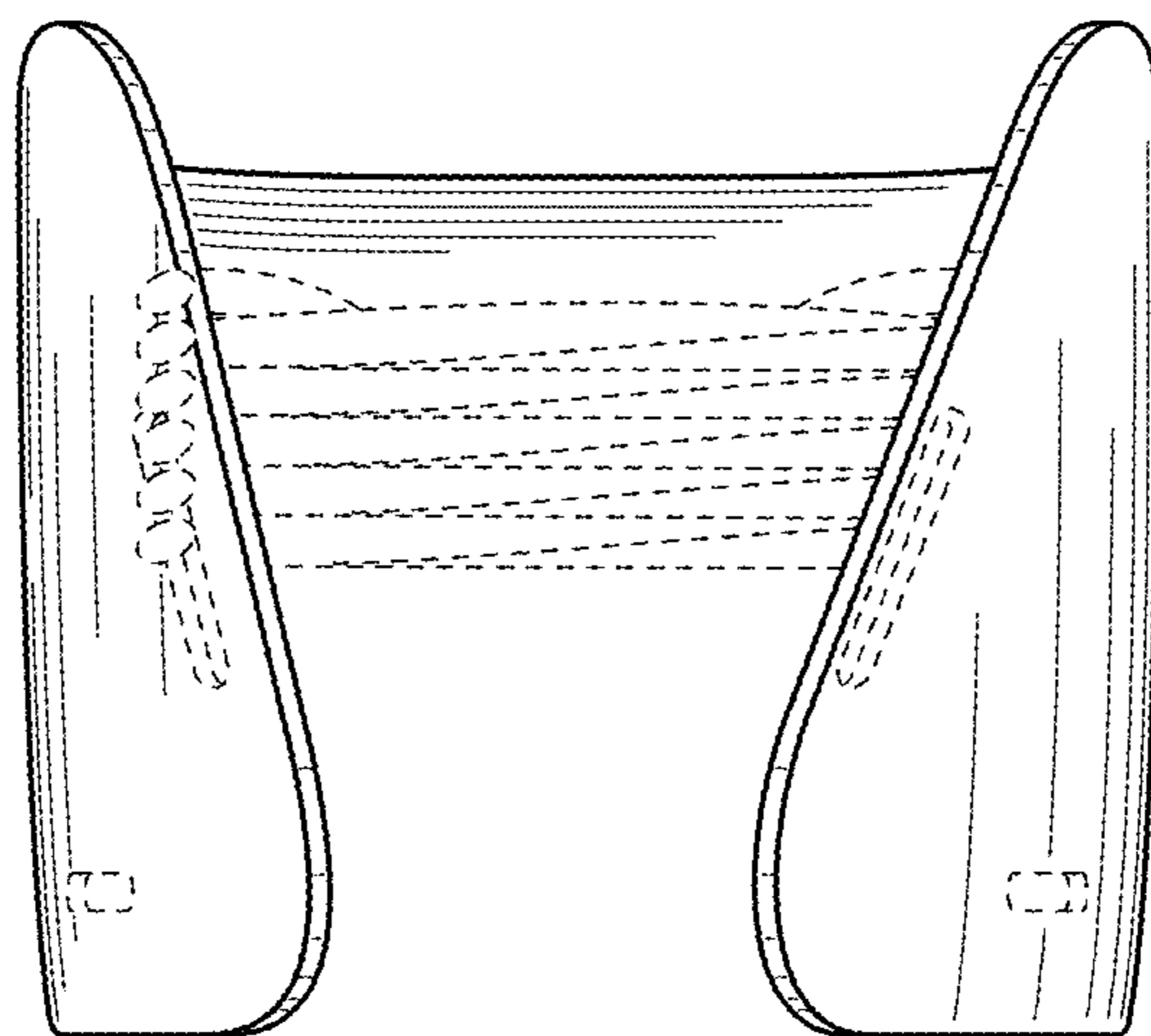

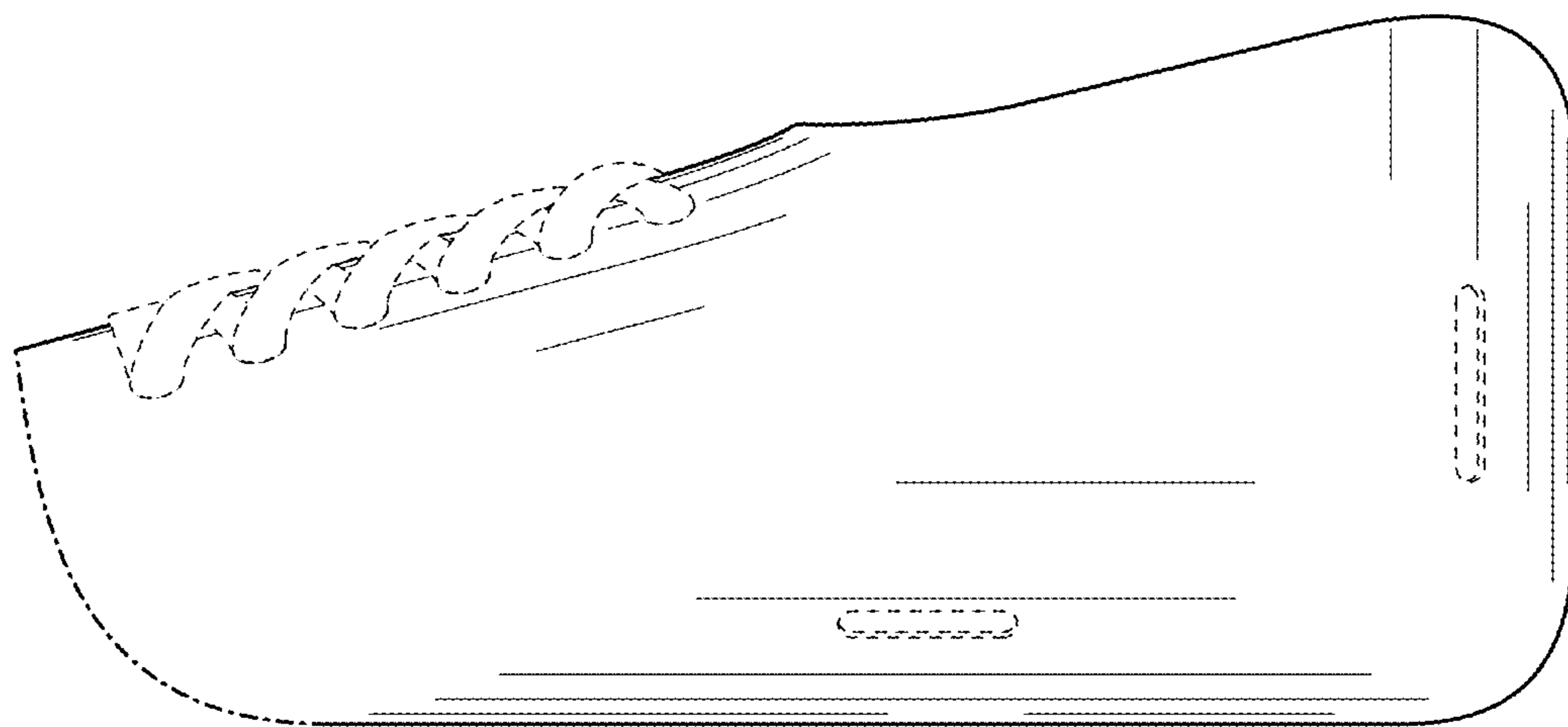

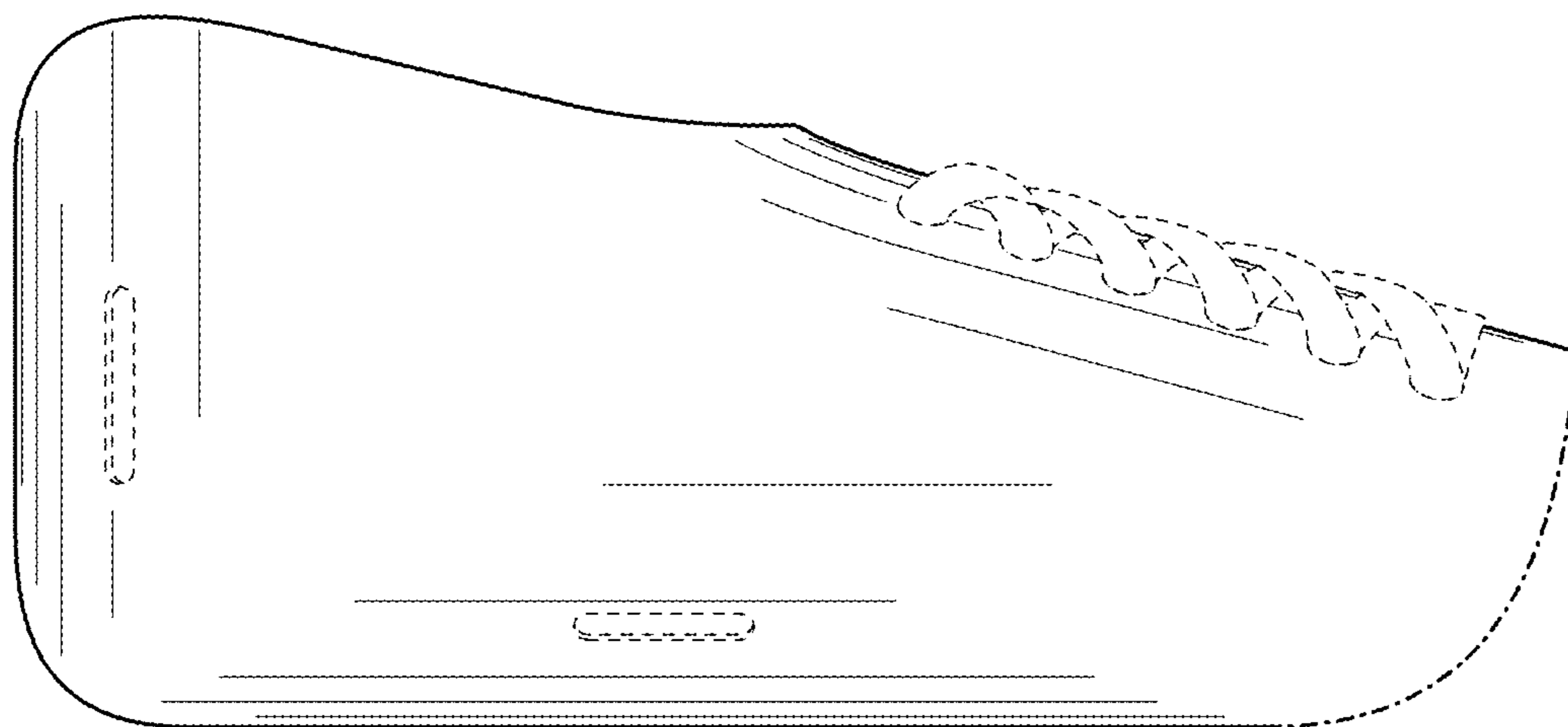

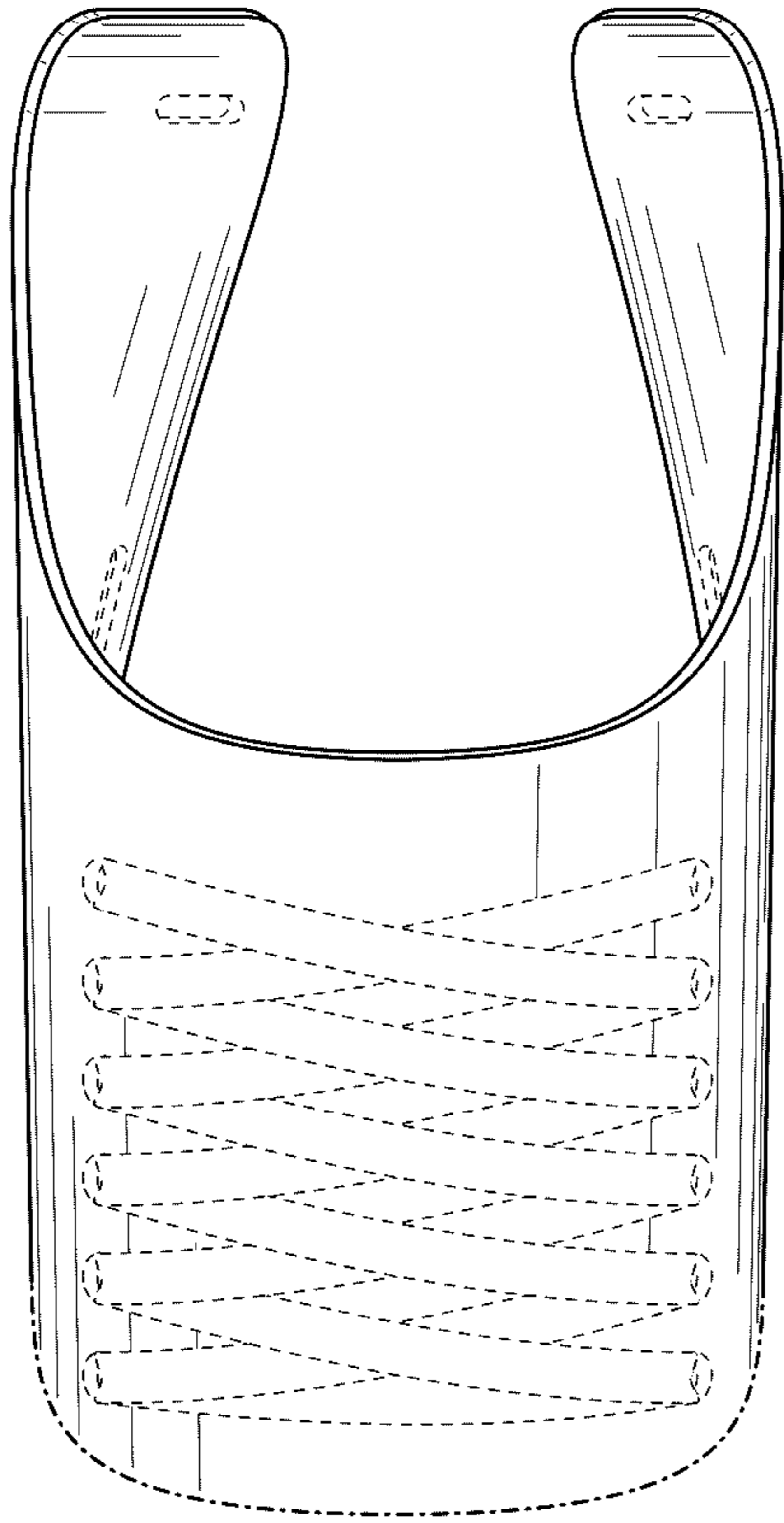

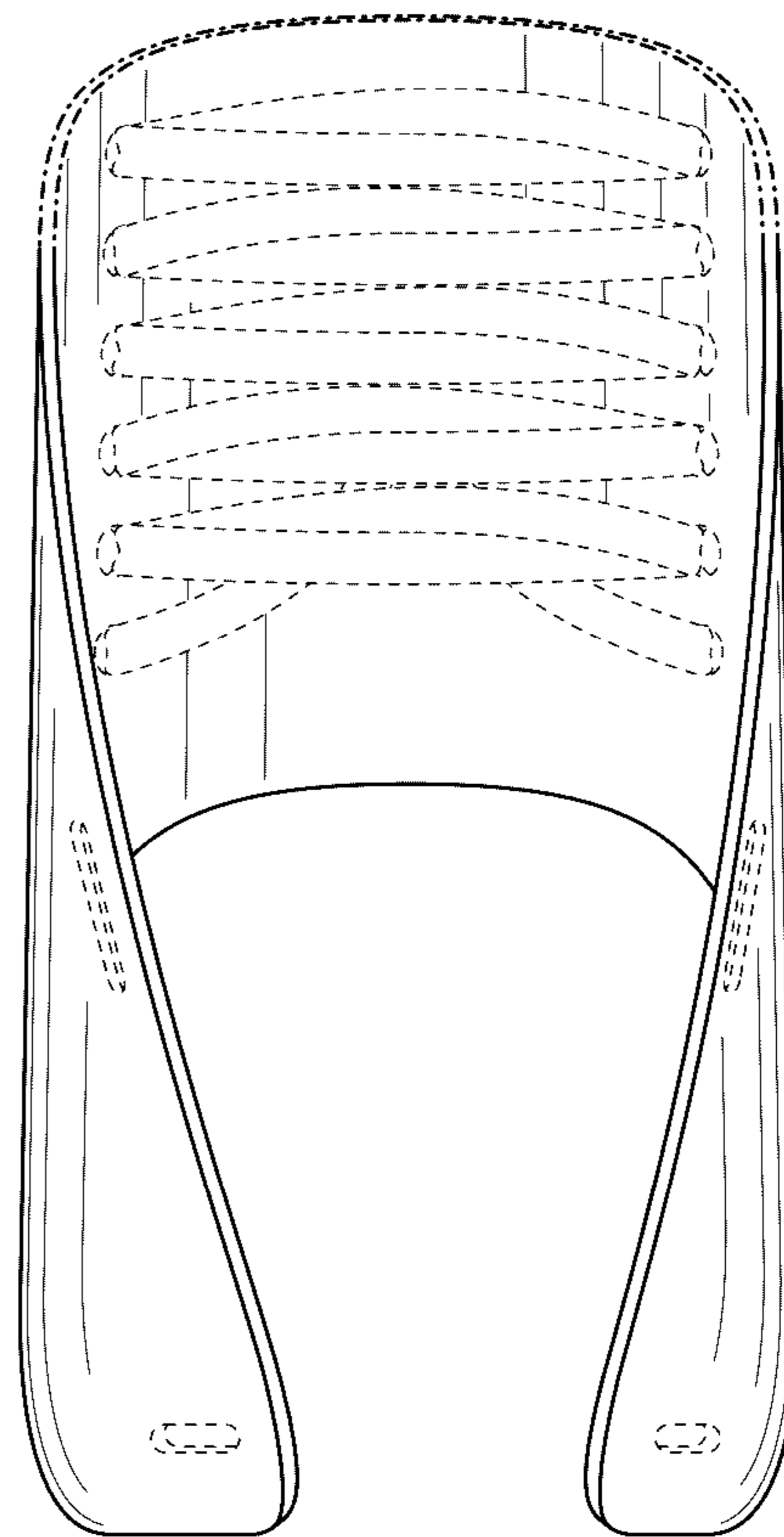
