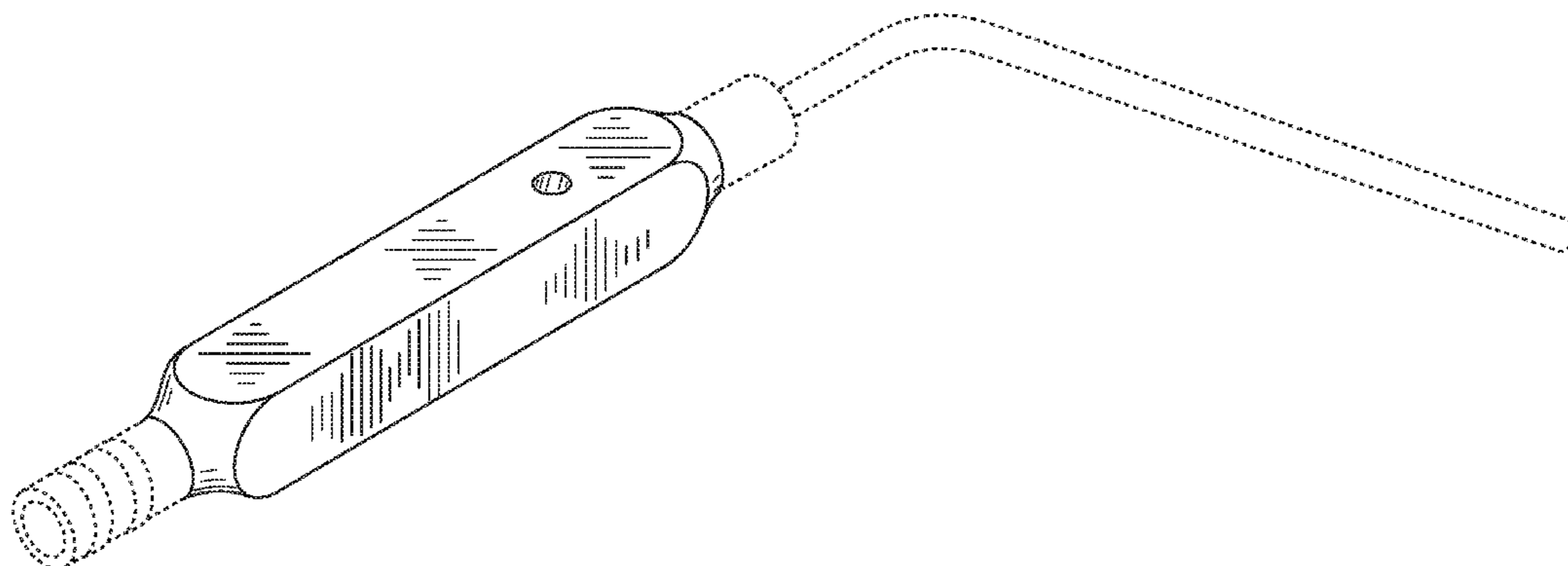
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view thereof;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a front elevation view thereof;
FIG. 8 is a cross-sectional rear elevational view thereof, taken along line 8-8 in FIG. 2; and,
FIG. 9 is a cross-sectional right side elevational view thereof, taken along line 9-9 in FIG. 2.

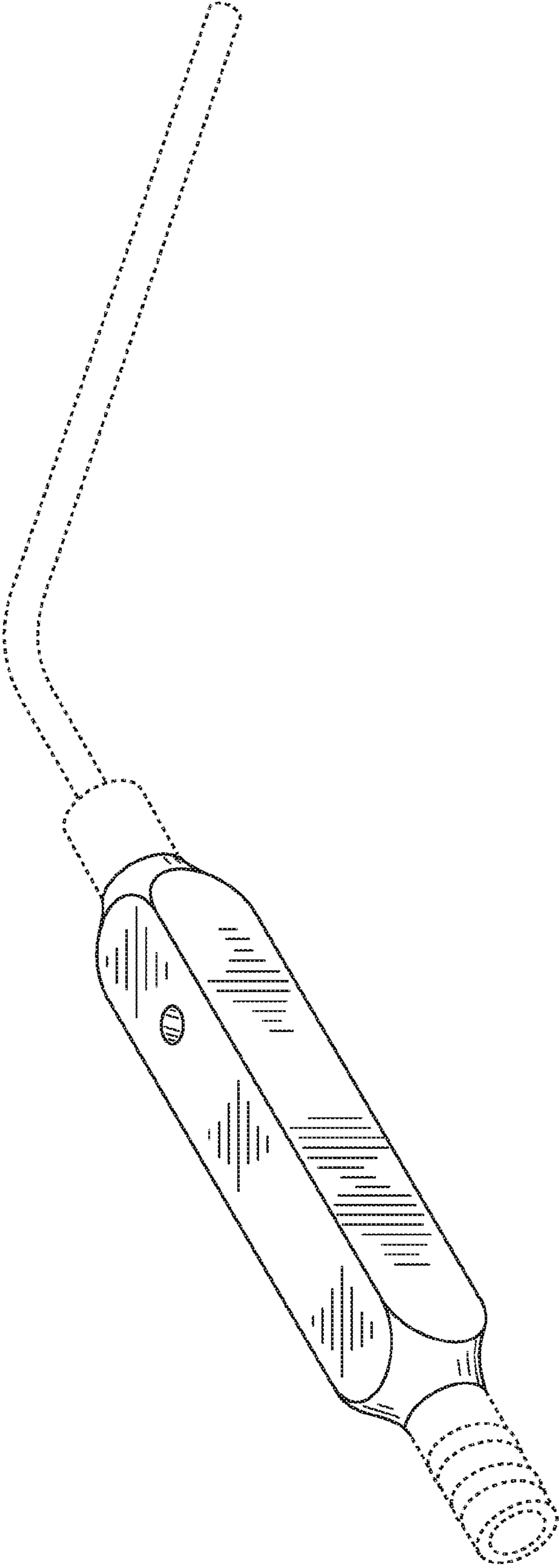

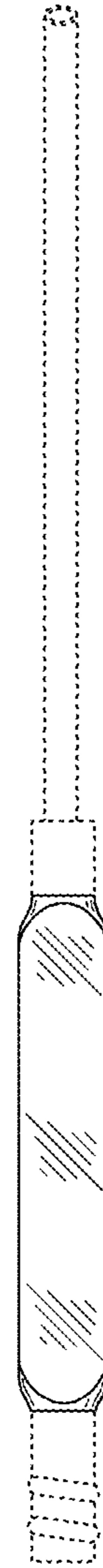
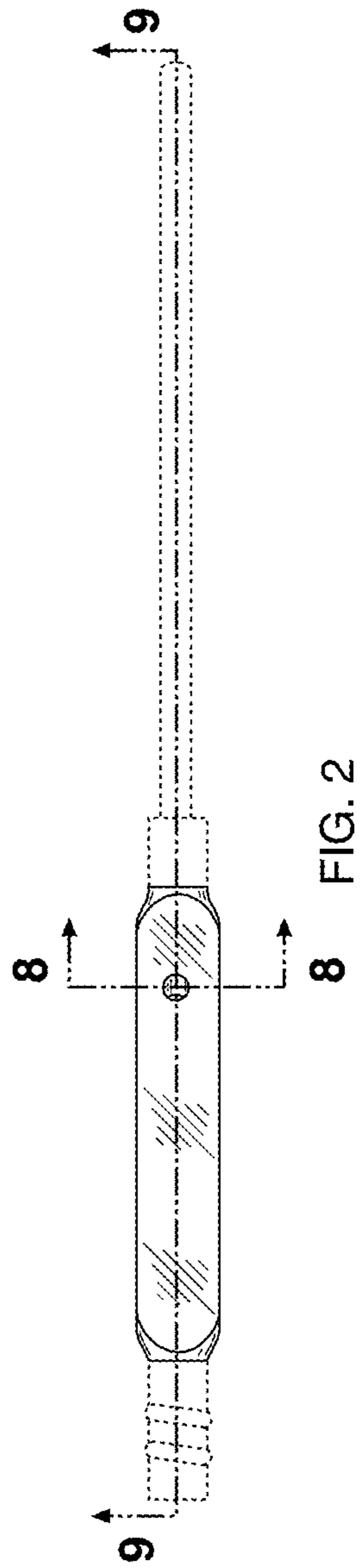

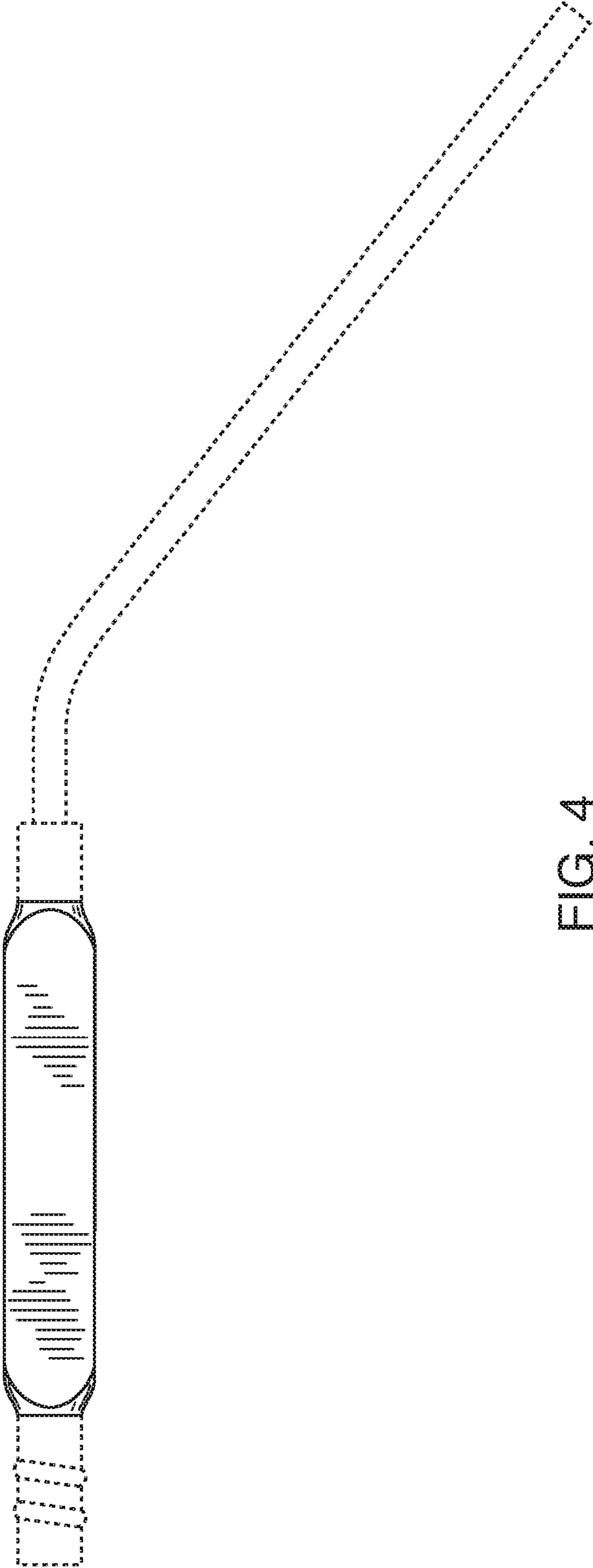

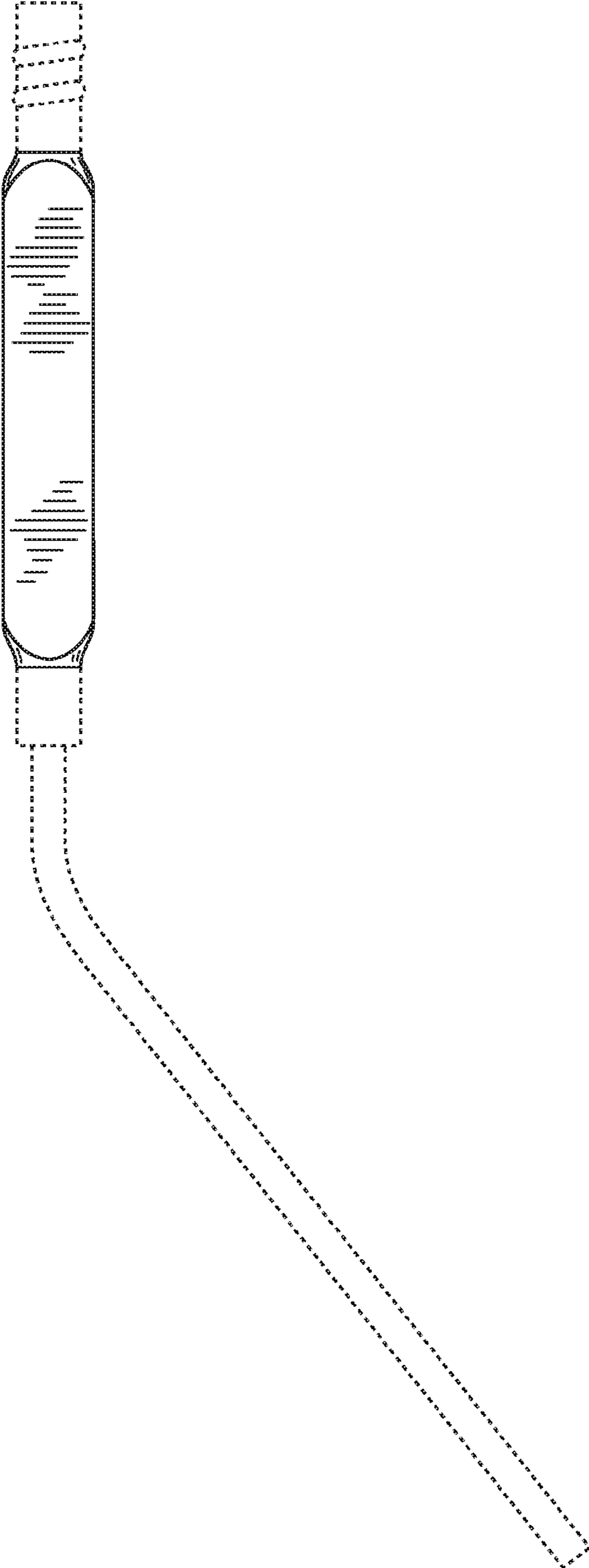

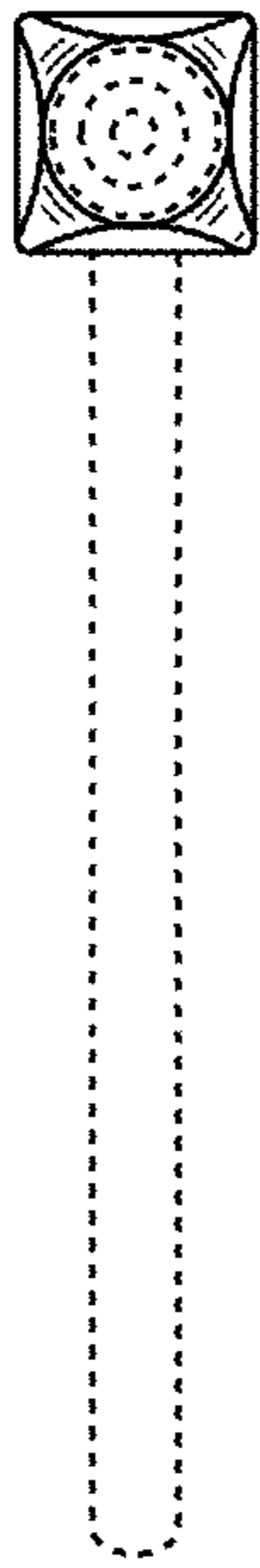

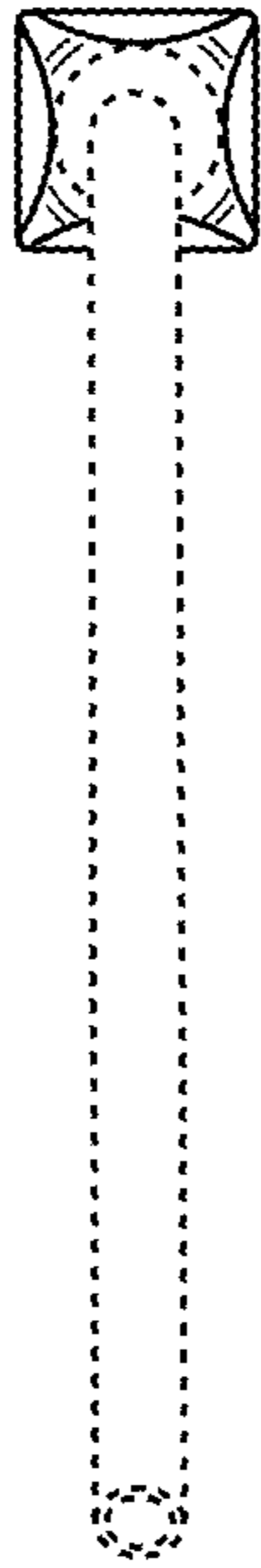

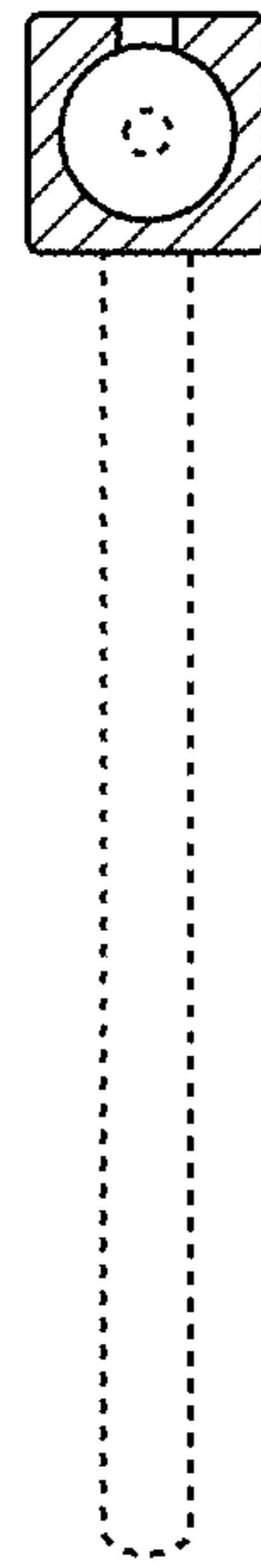

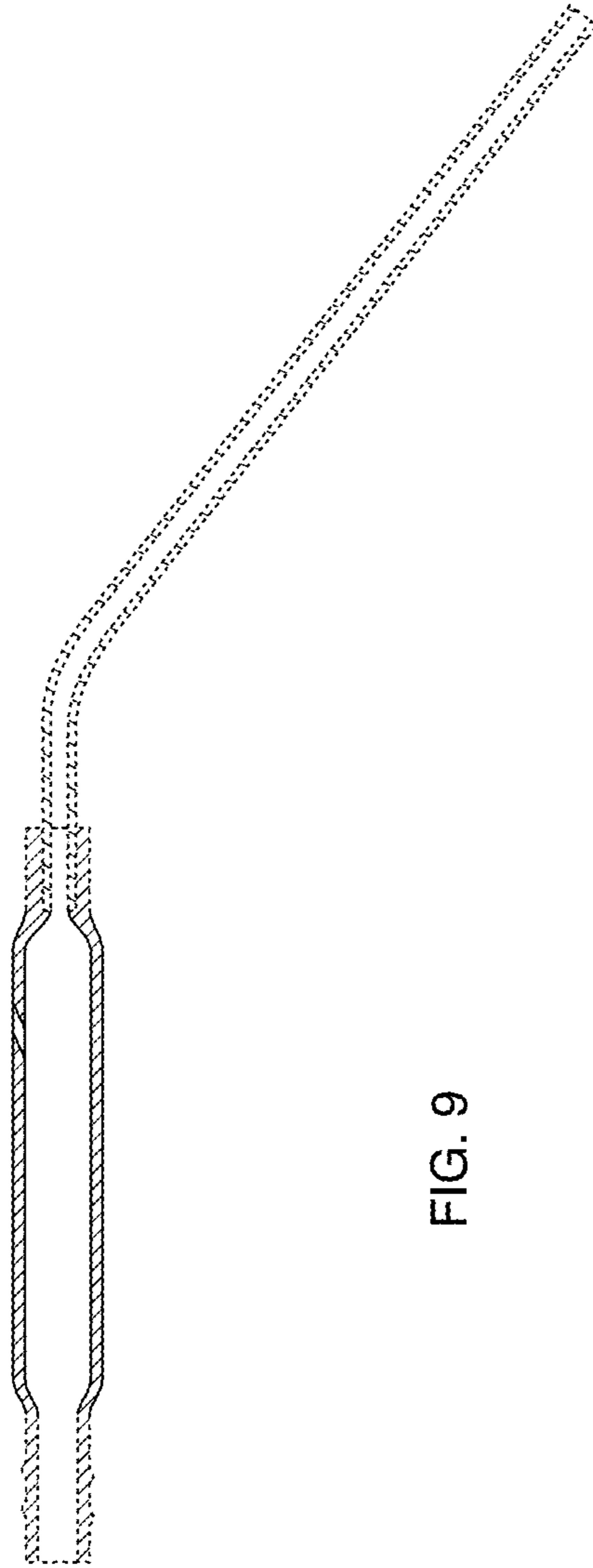
