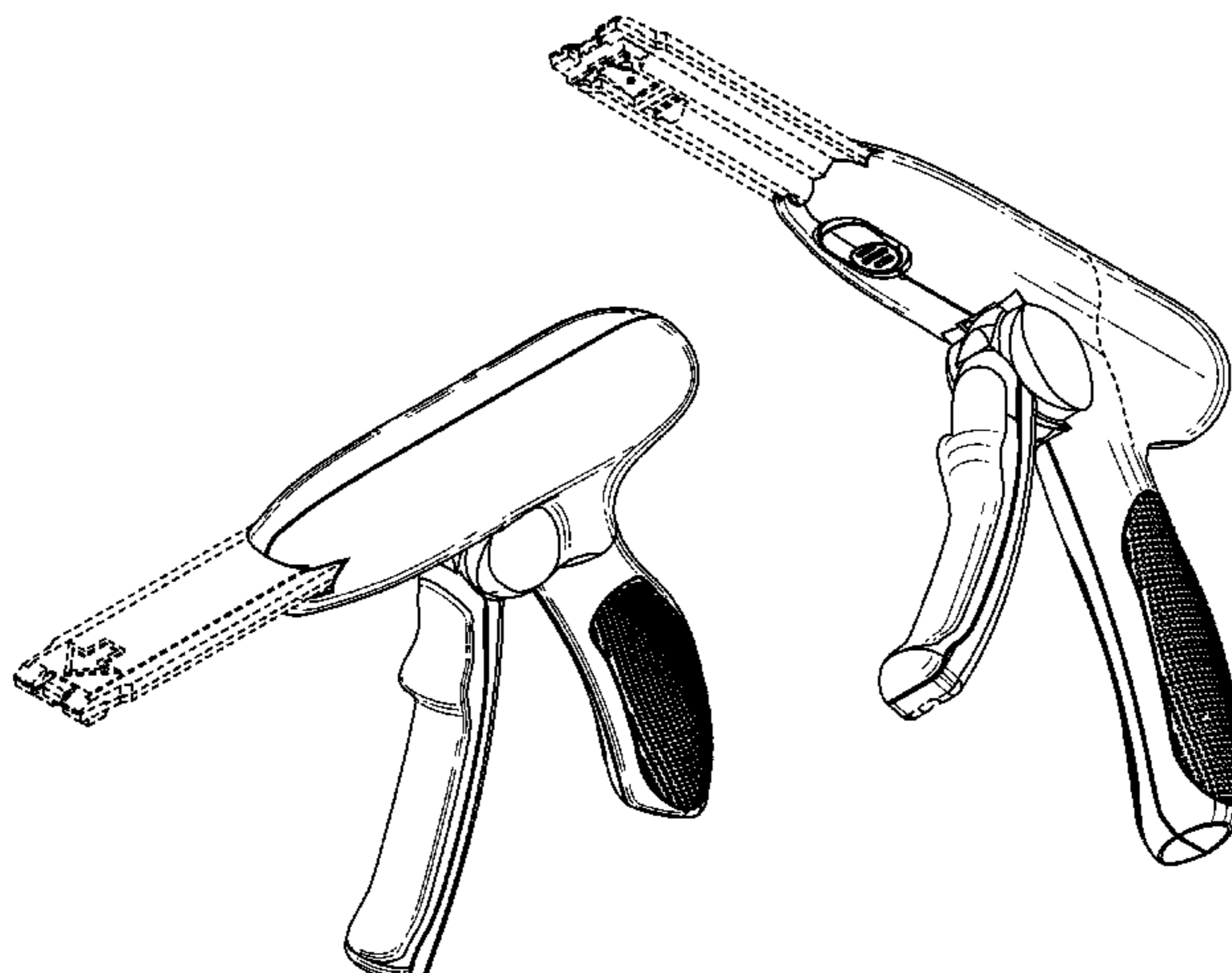
(57) **CLAIM**

The ornamental design for a skin stapler, as shown and described.

**DESCRIPTION**

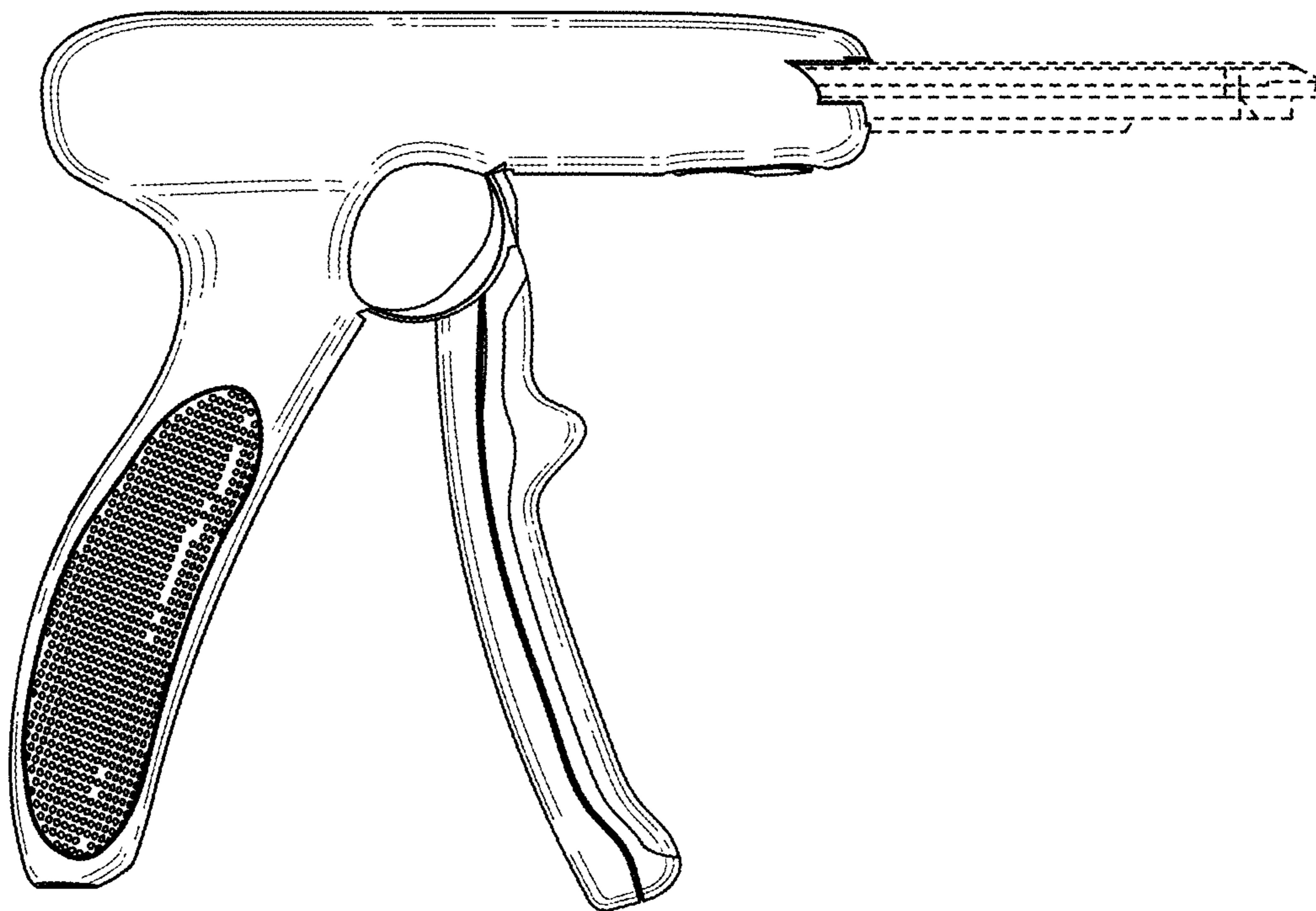

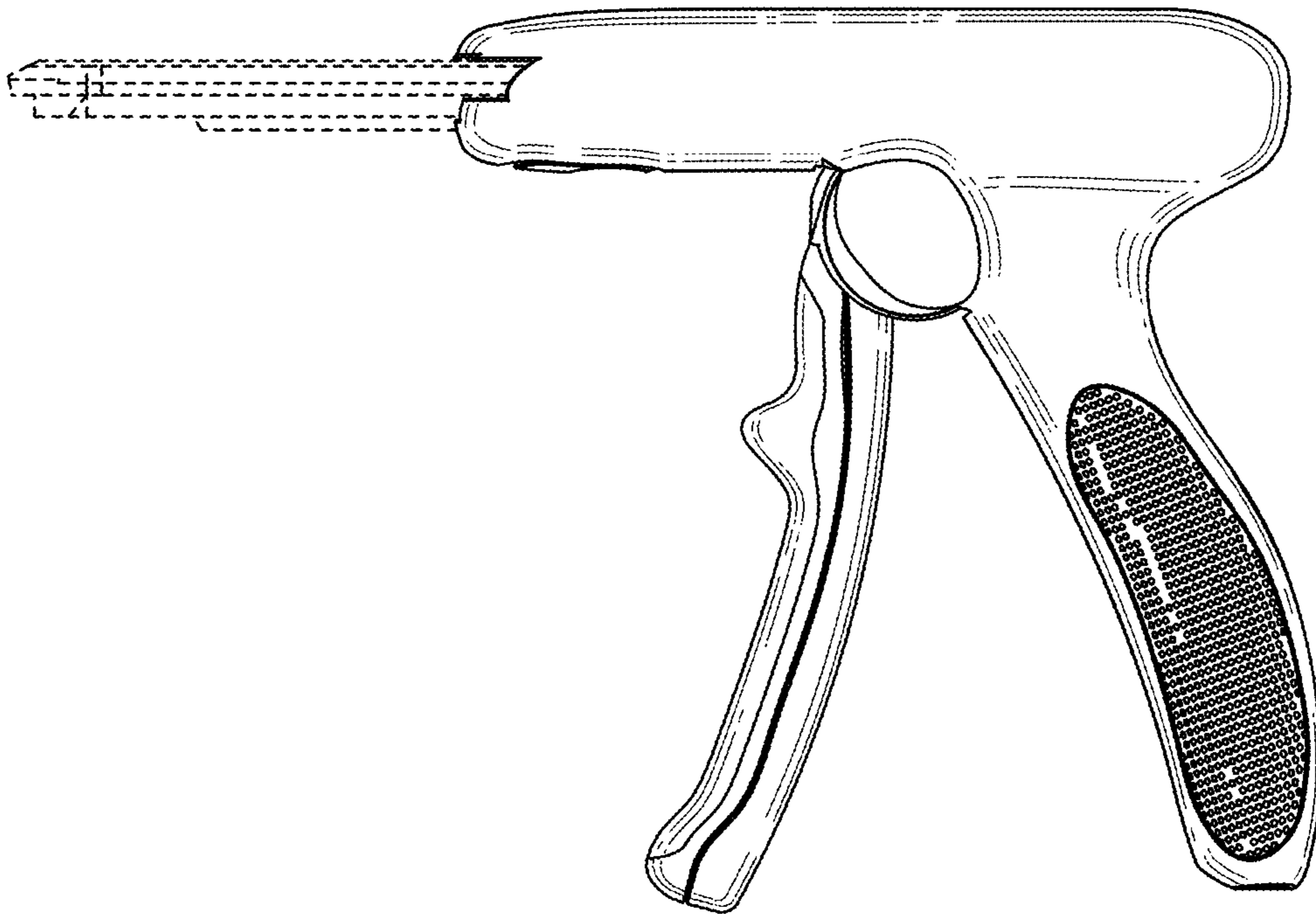

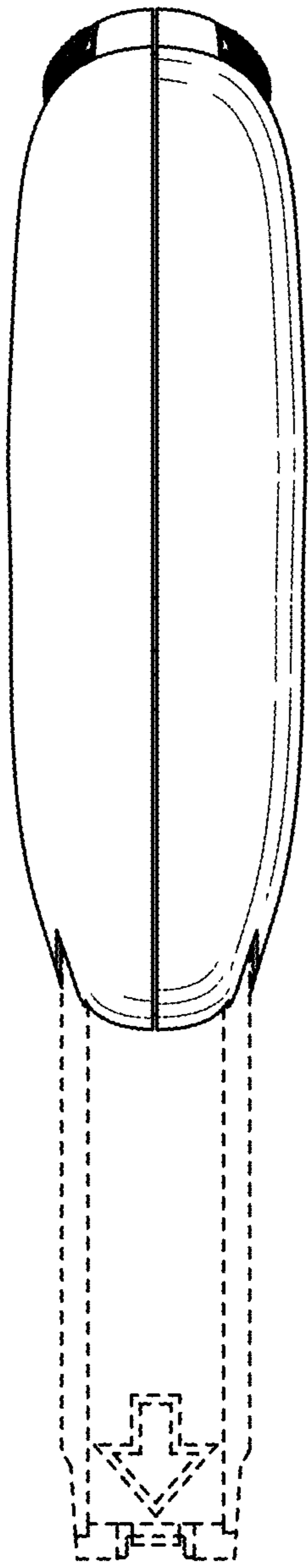

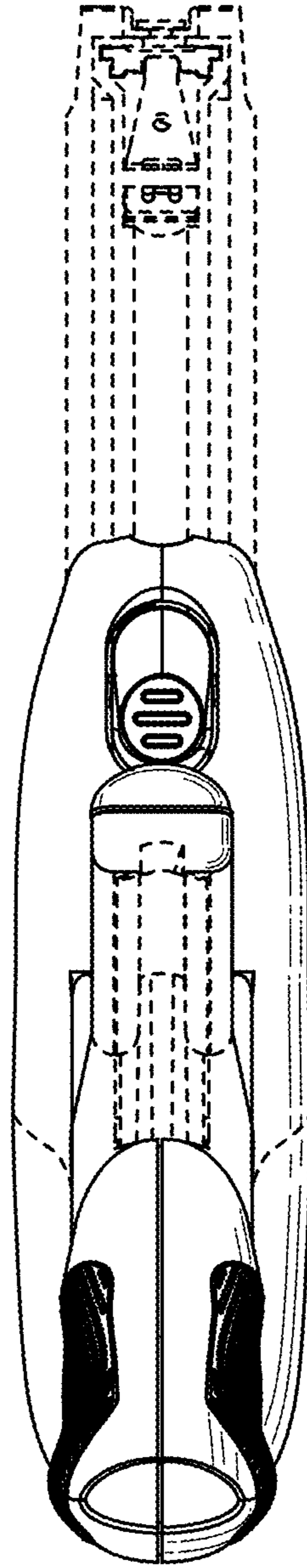

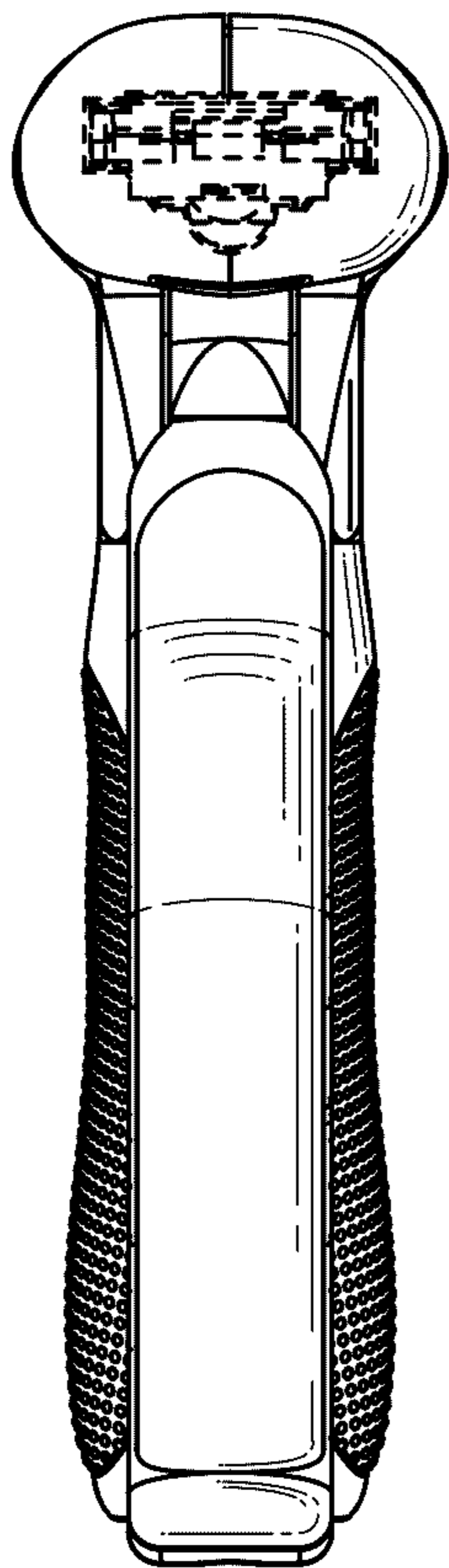

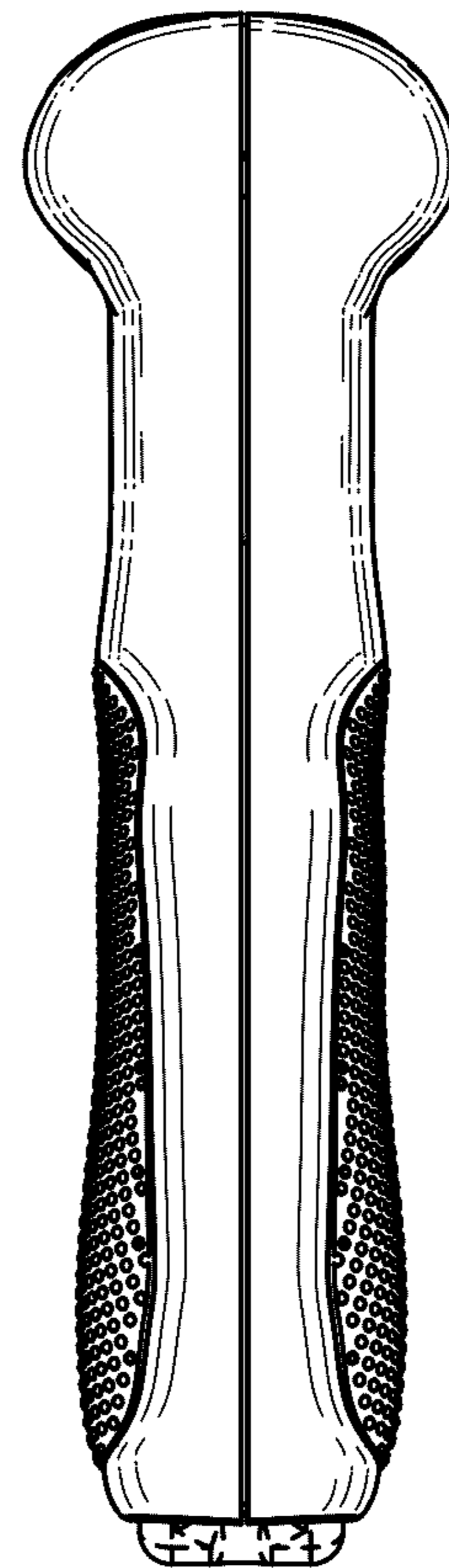

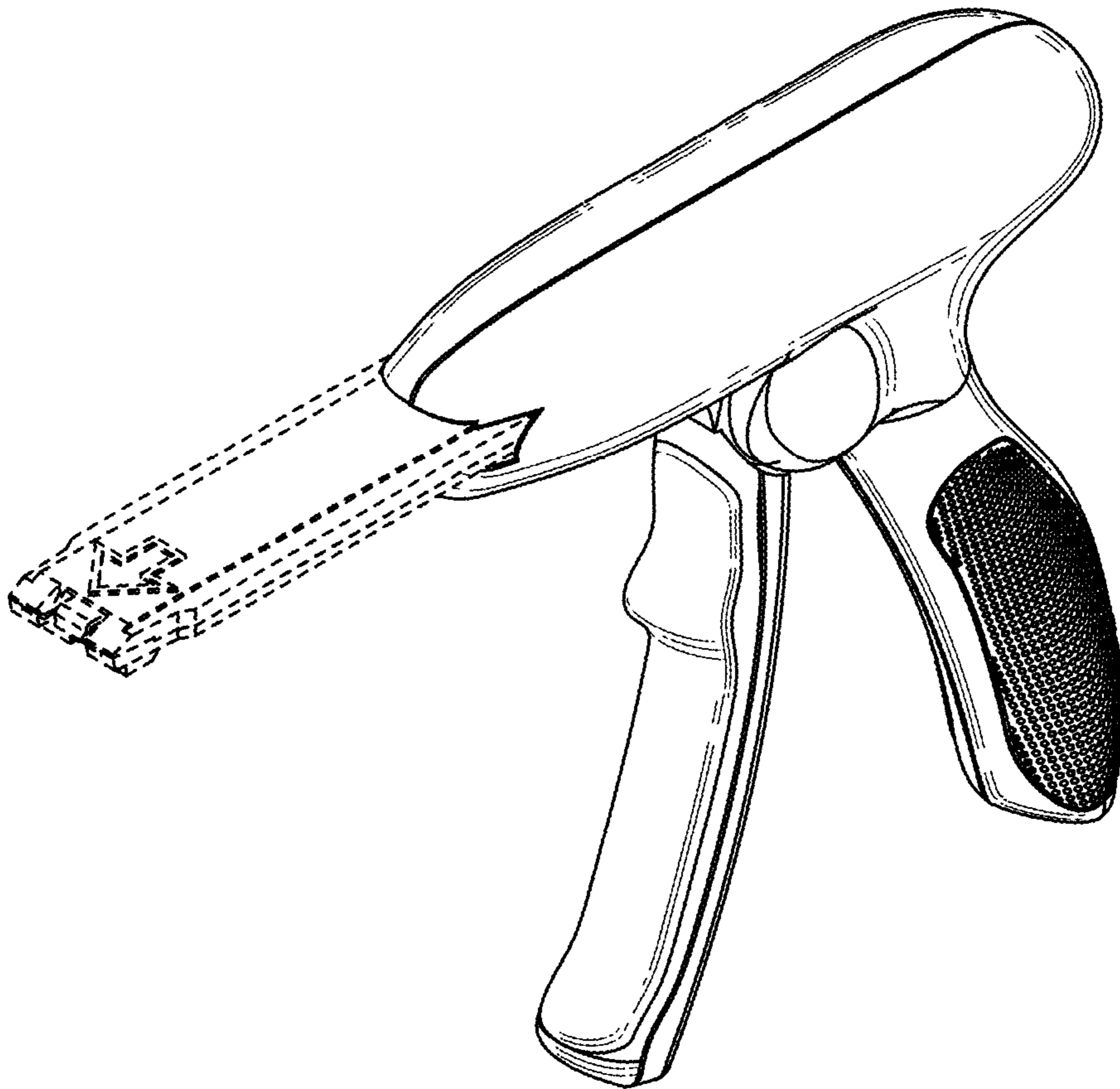

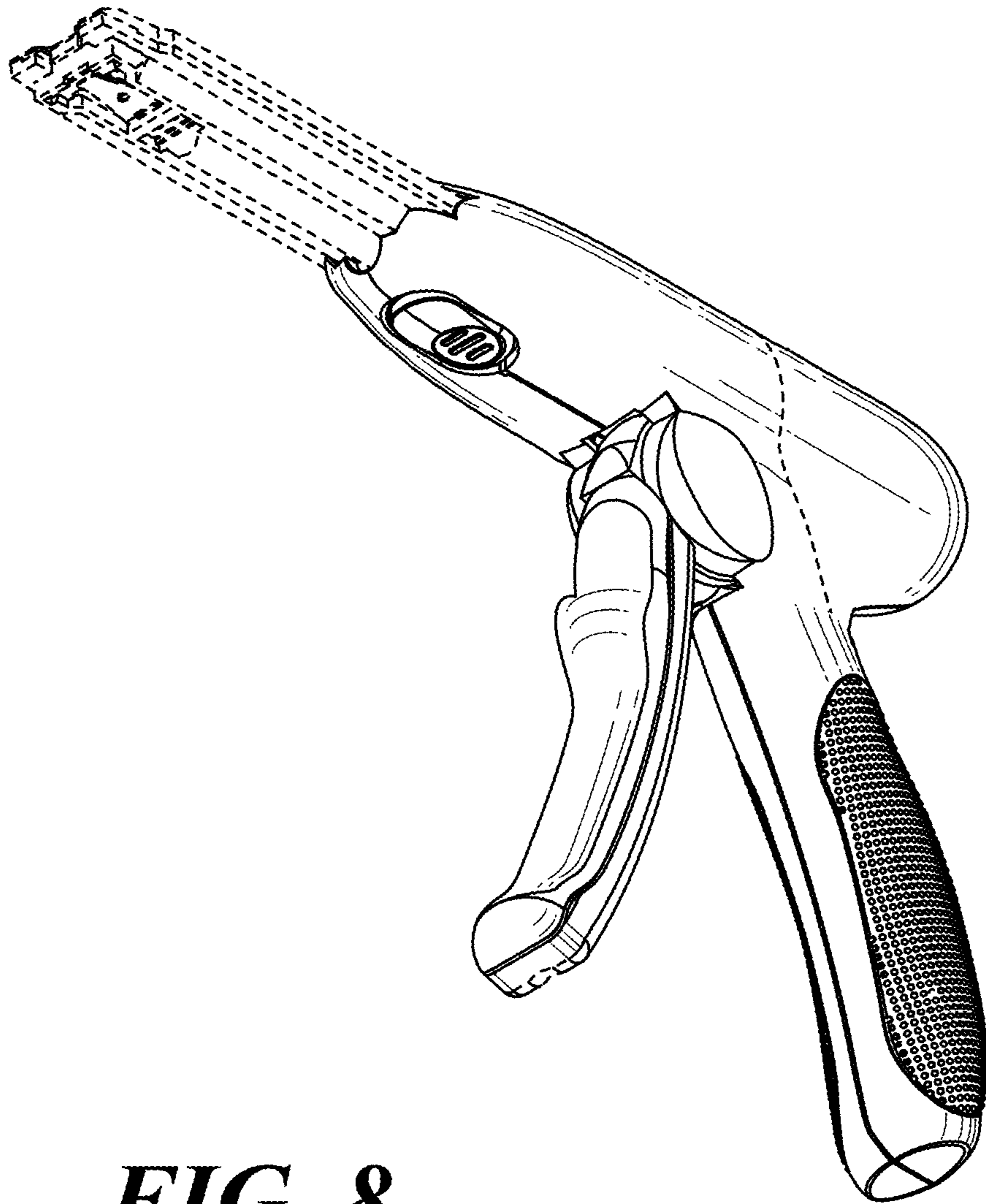

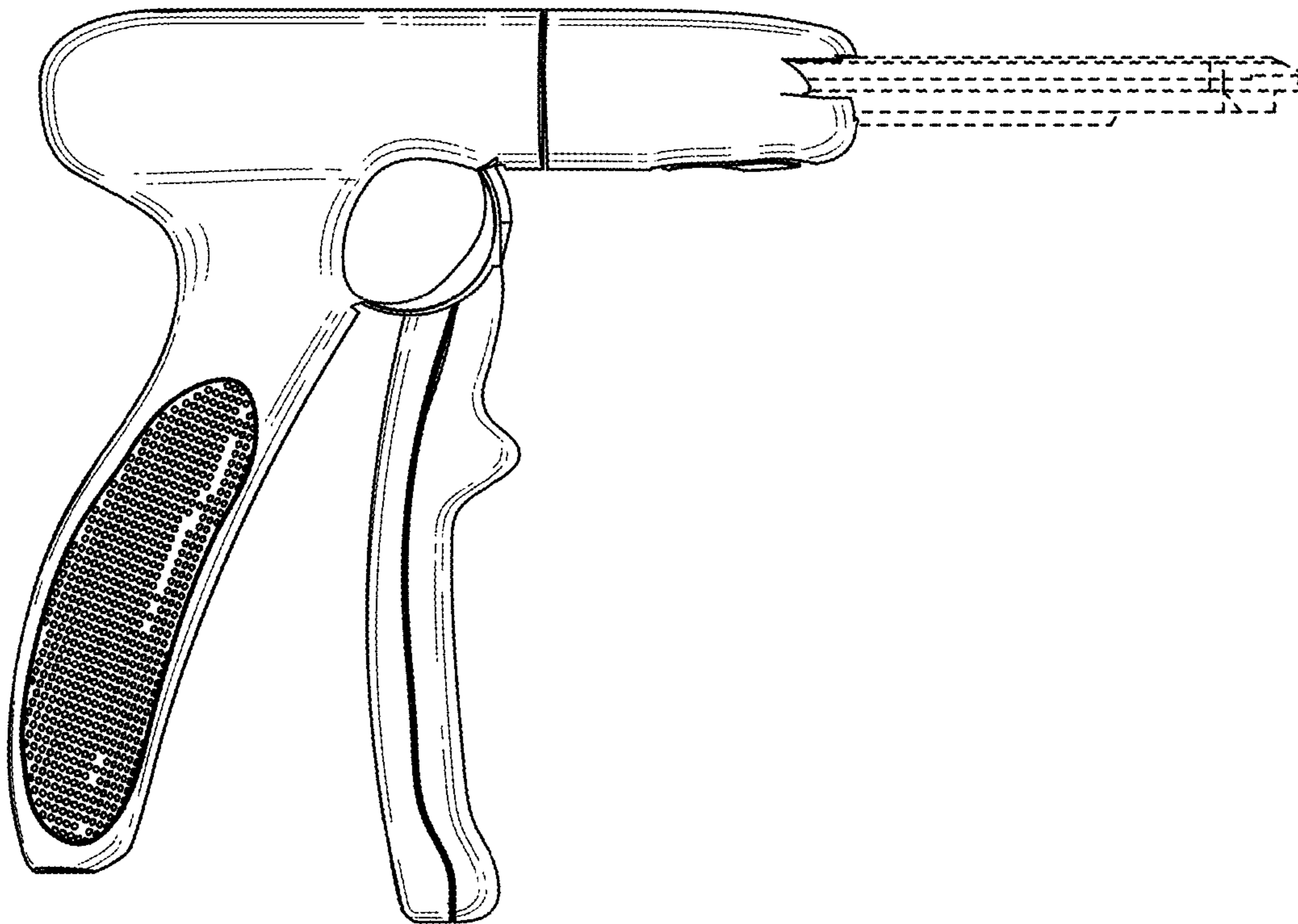

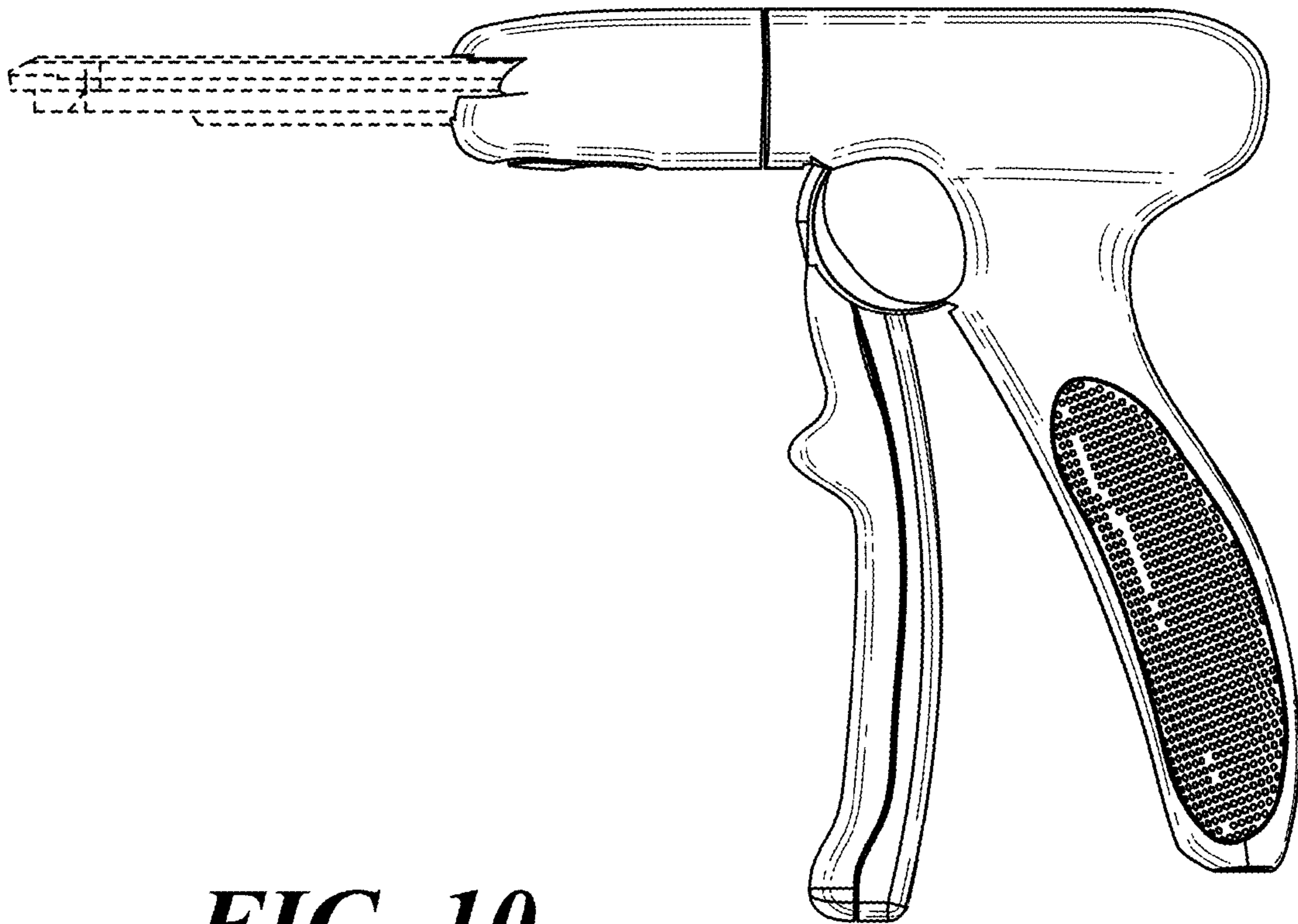

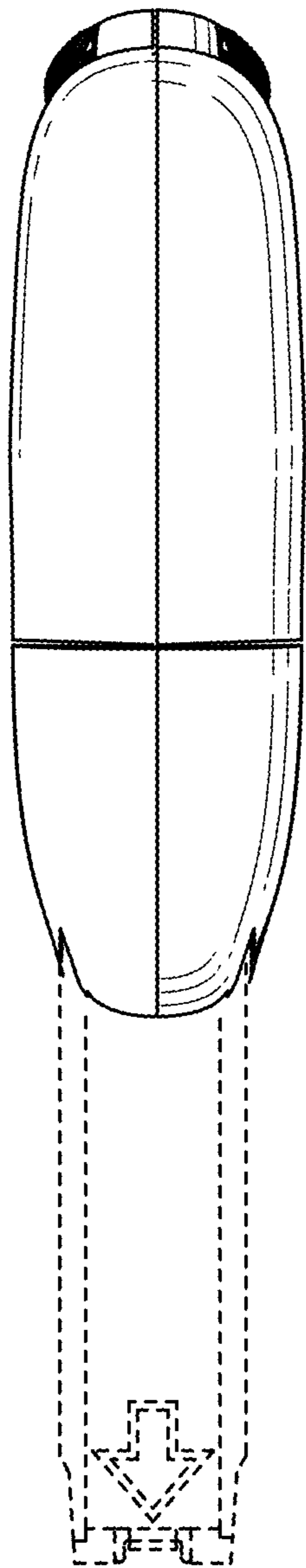




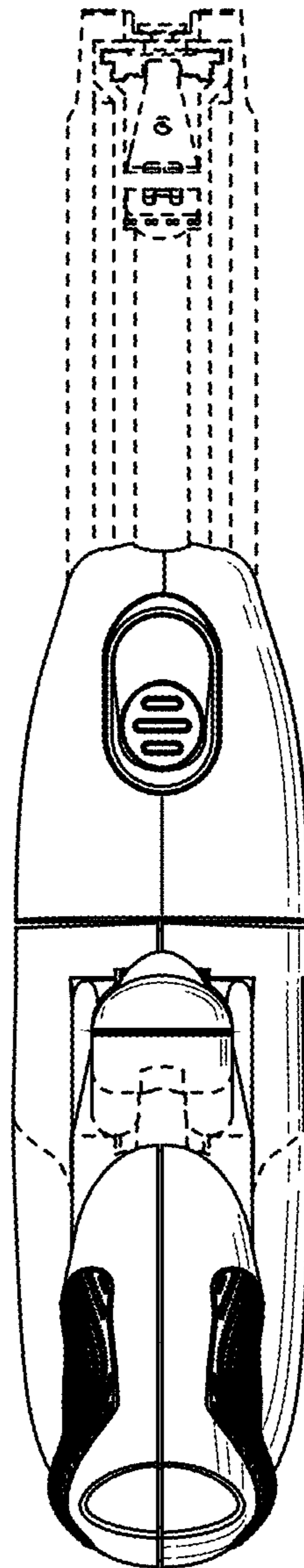

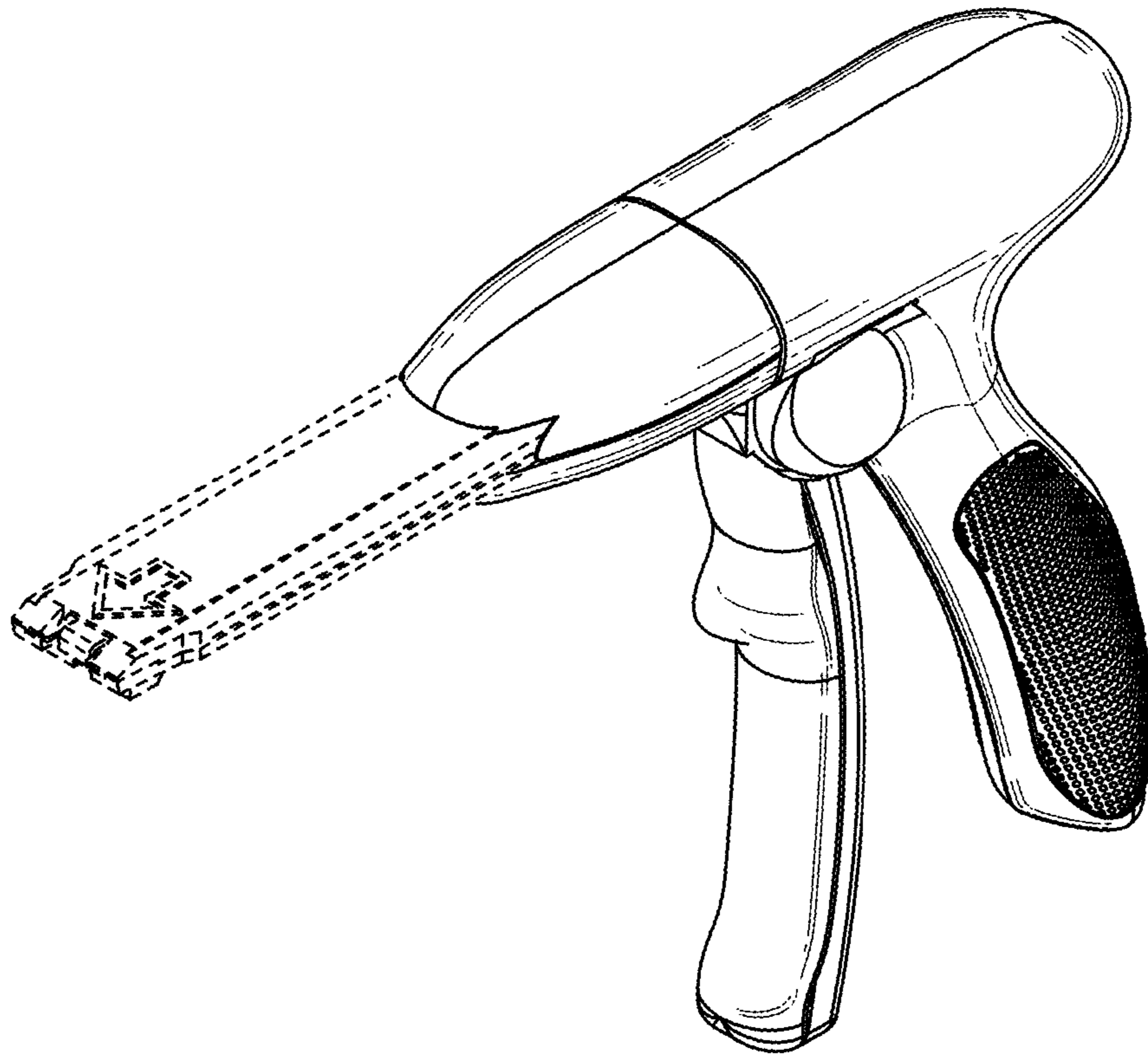
***FIG. 10***



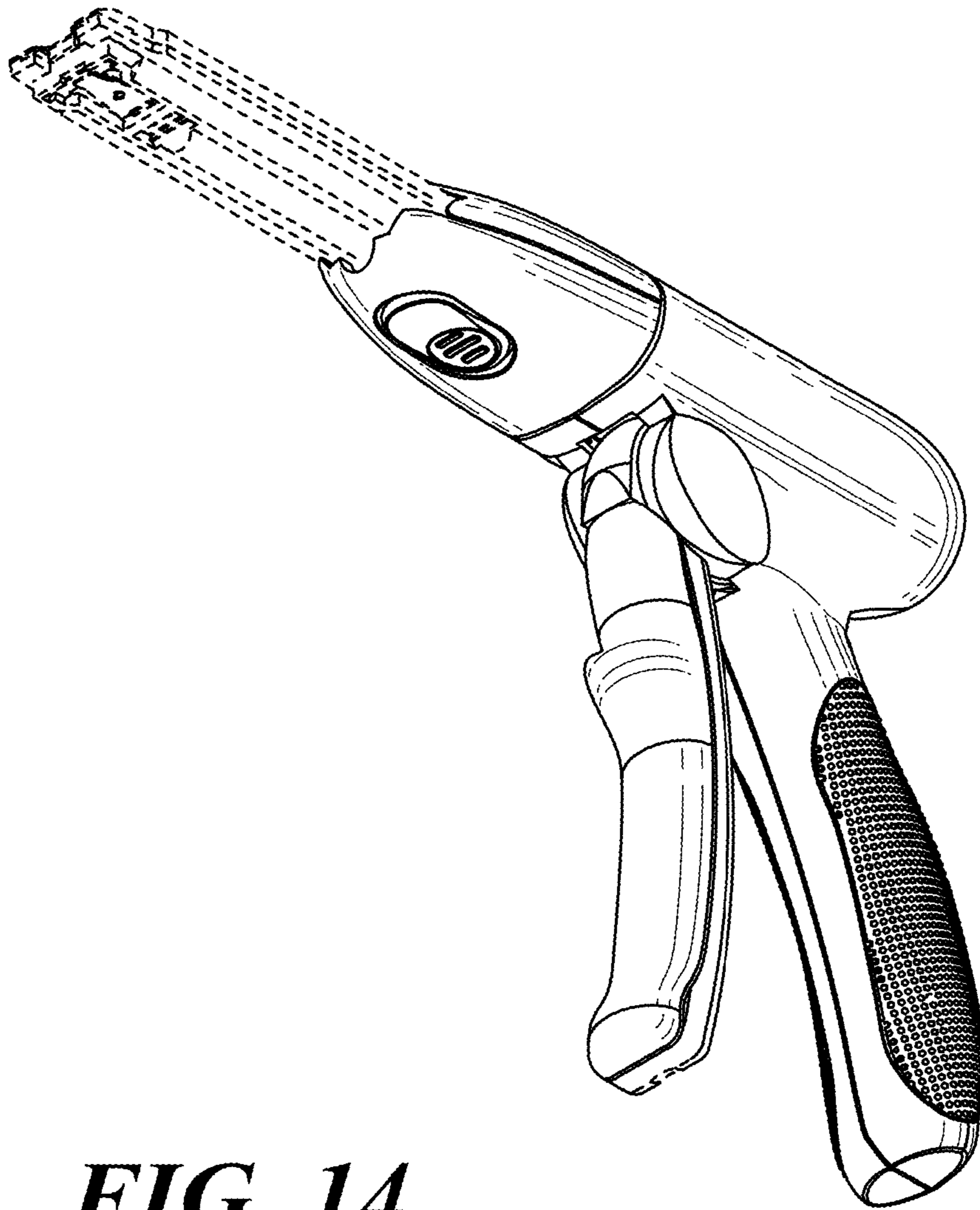
***FIG. 11***



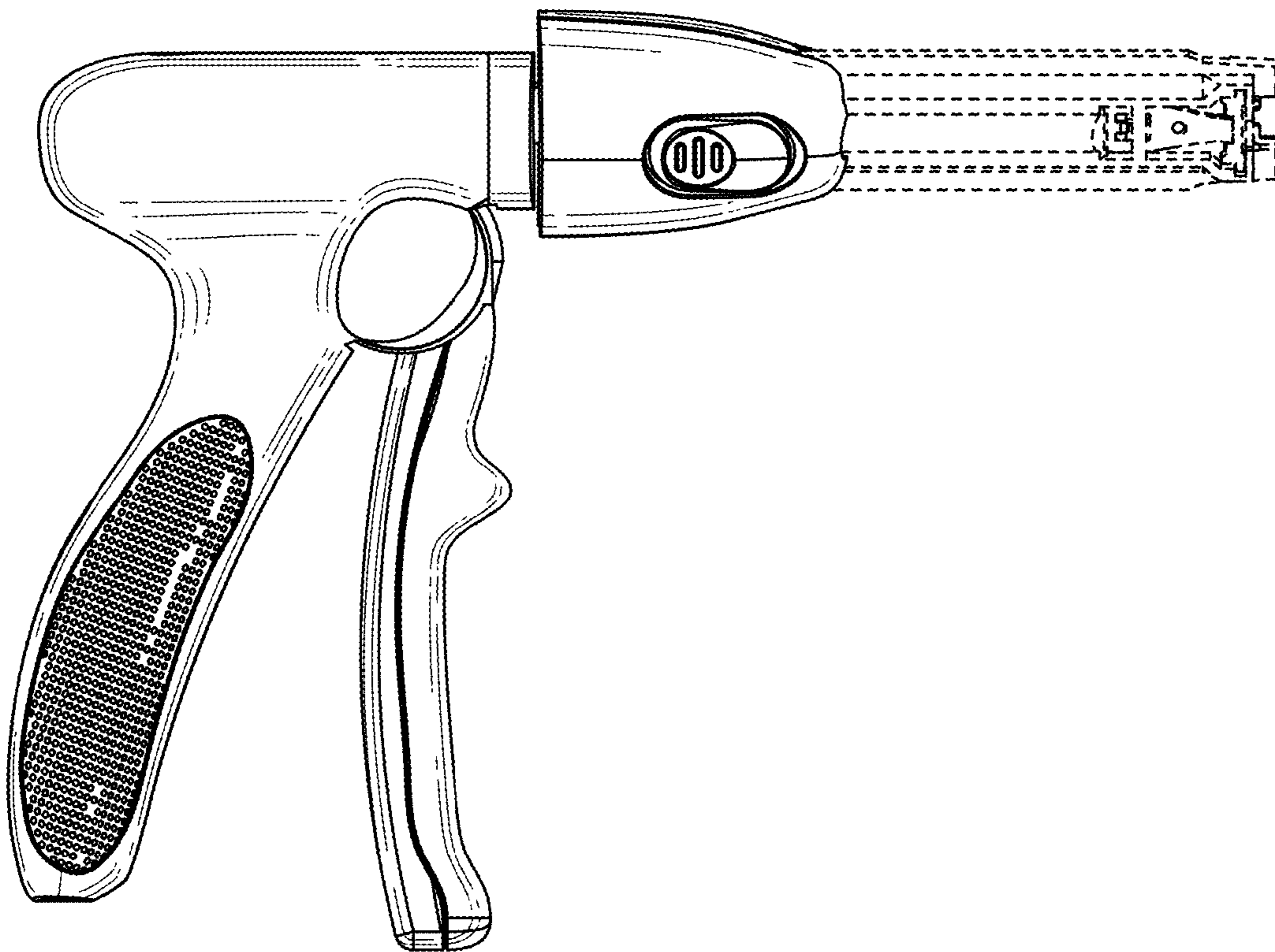
***FIG. 12***



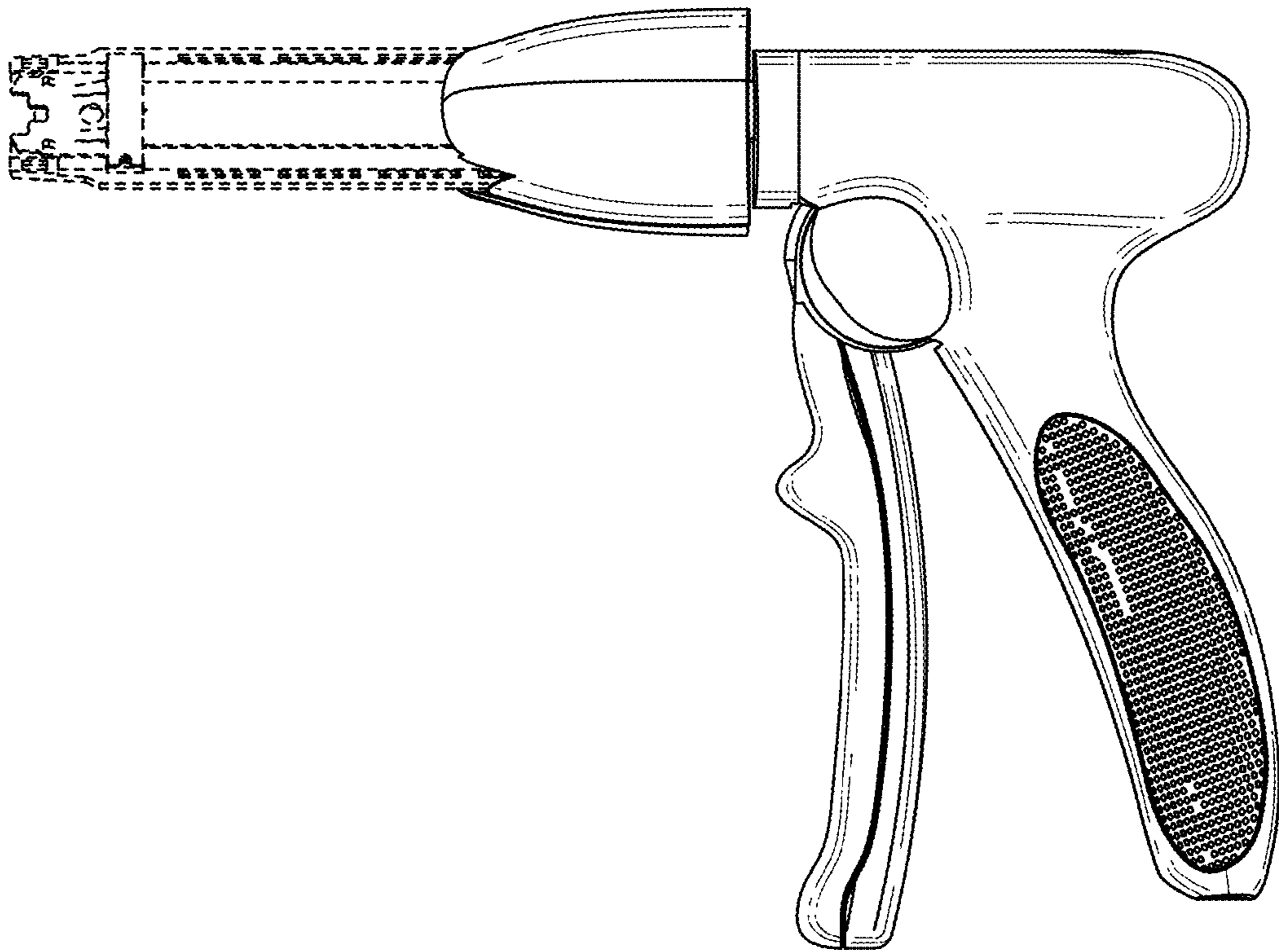
***FIG. 13***



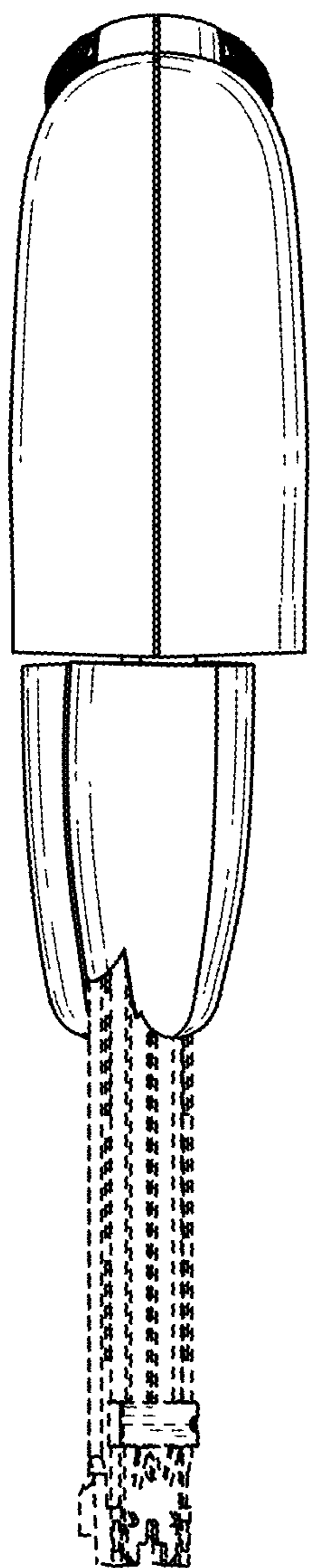
***FIG. 14***



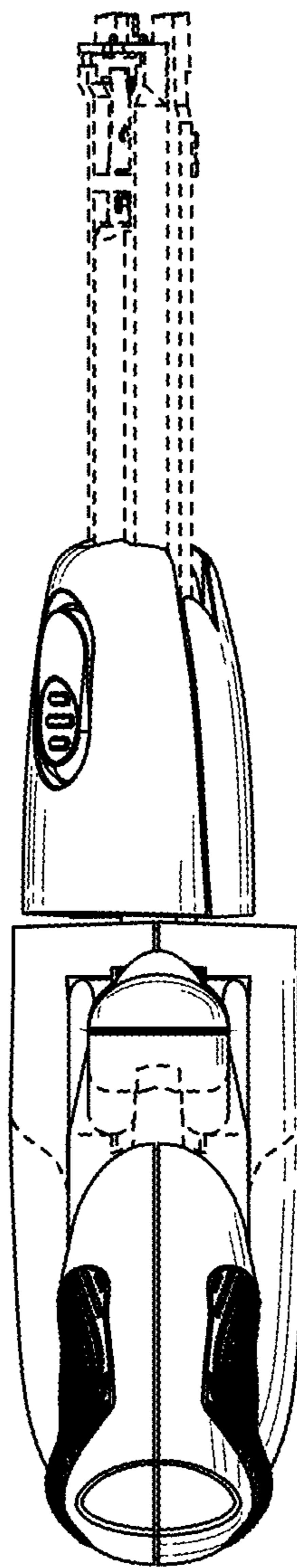
***FIG. 15***

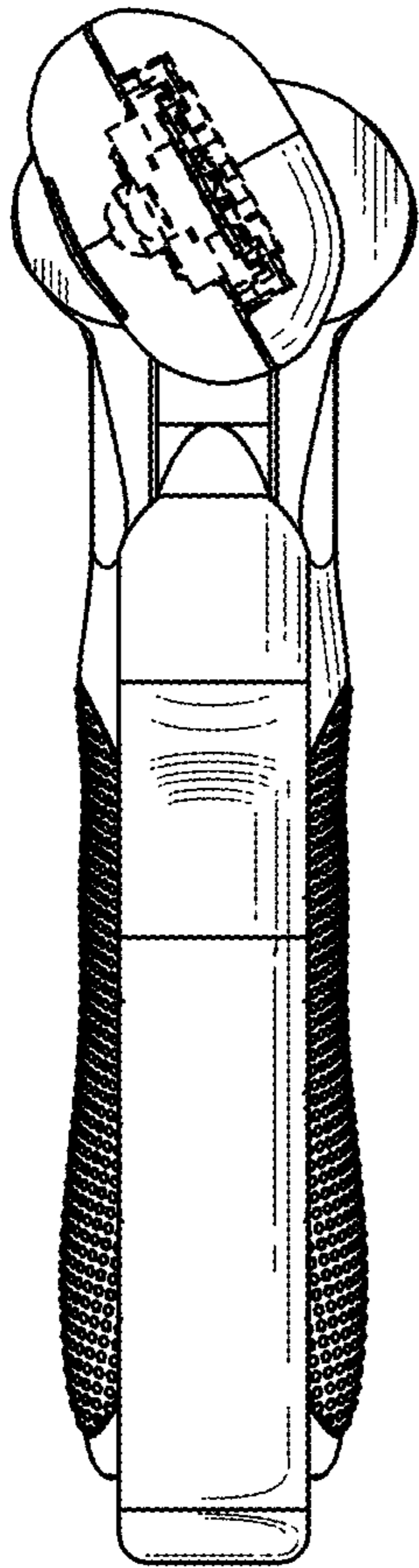


***FIG. 17***

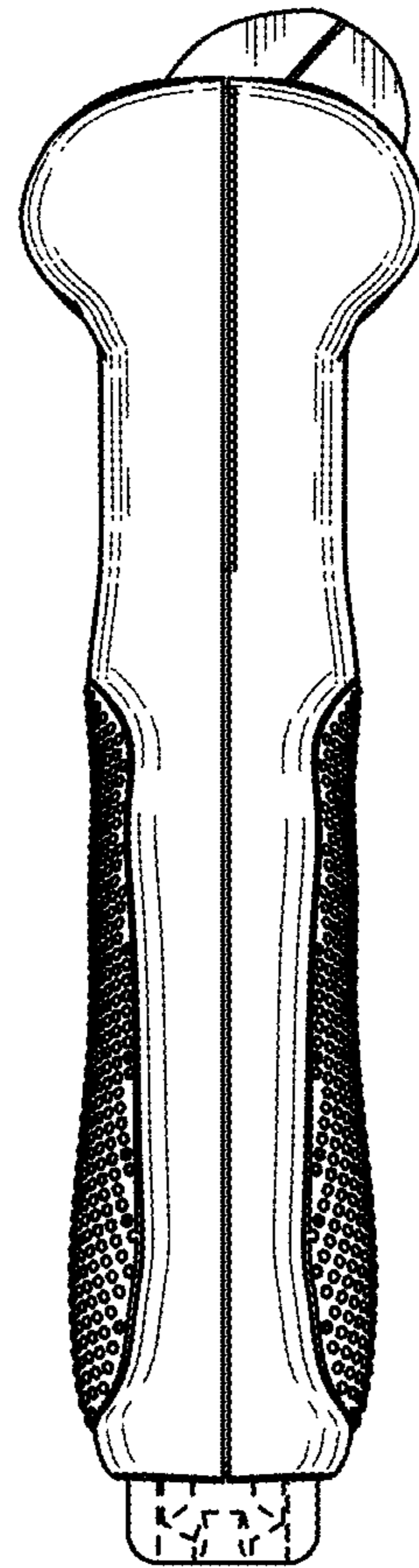


***FIG. 18***

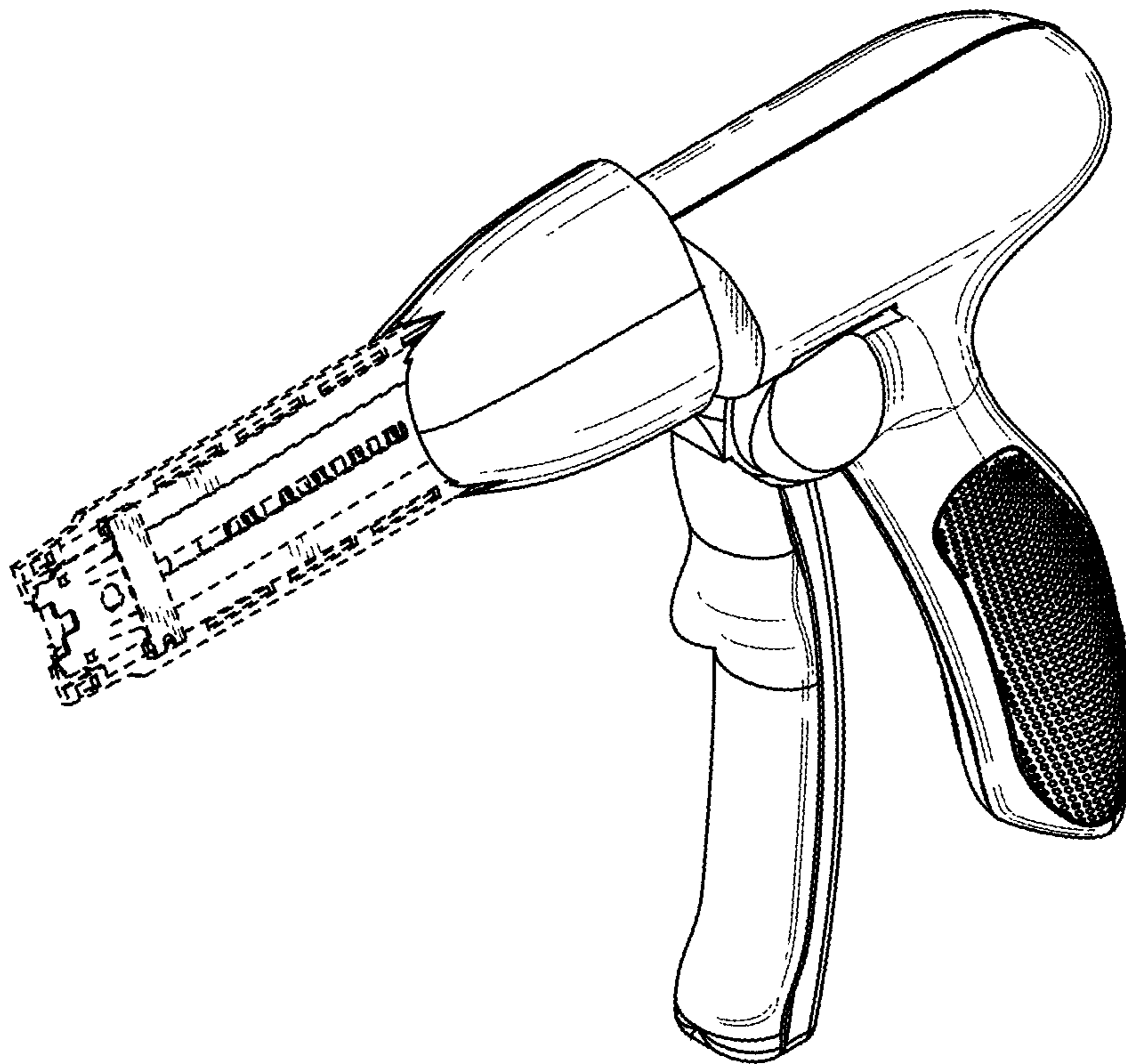




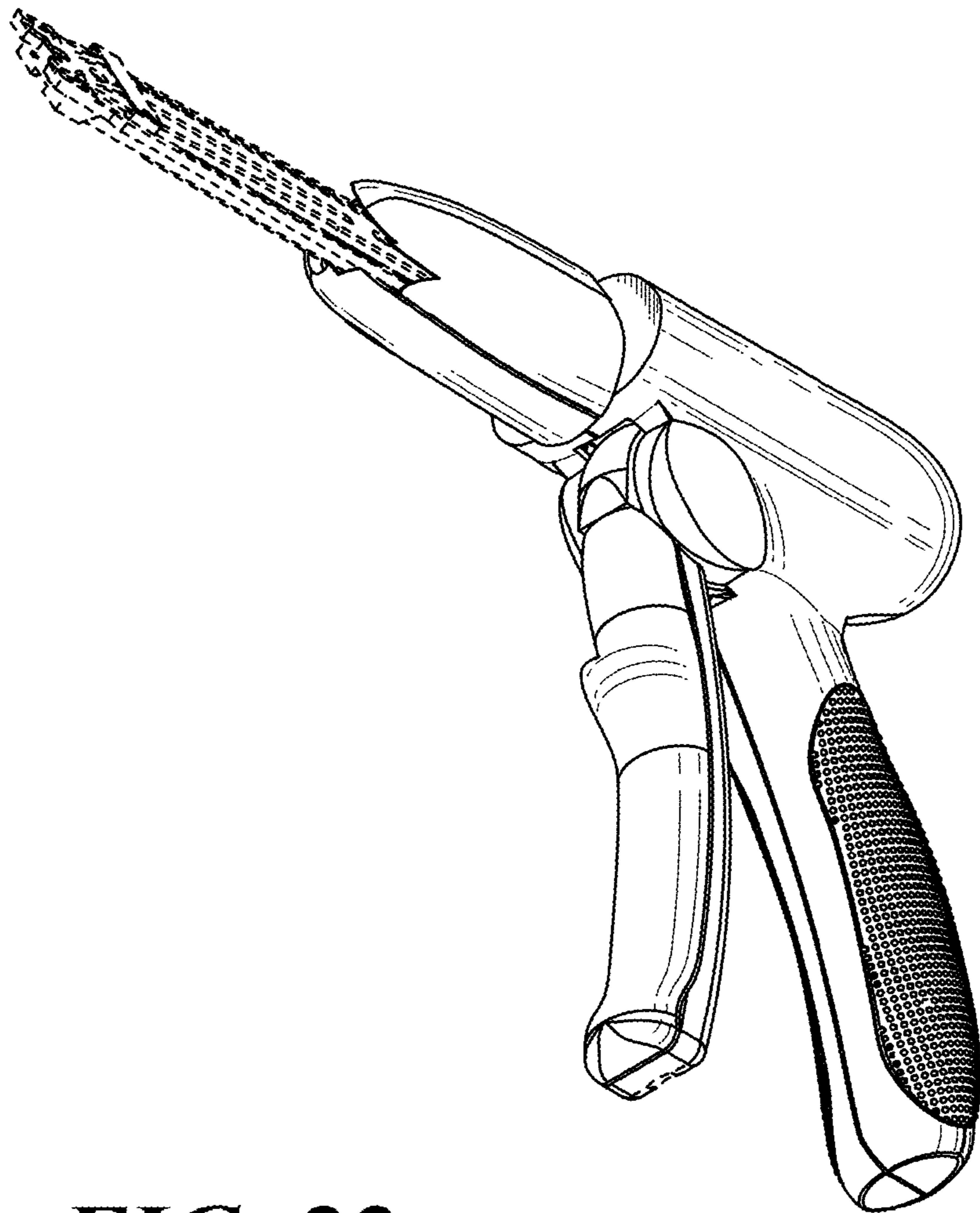
***FIG. 19***
