(57) **CLAIM**

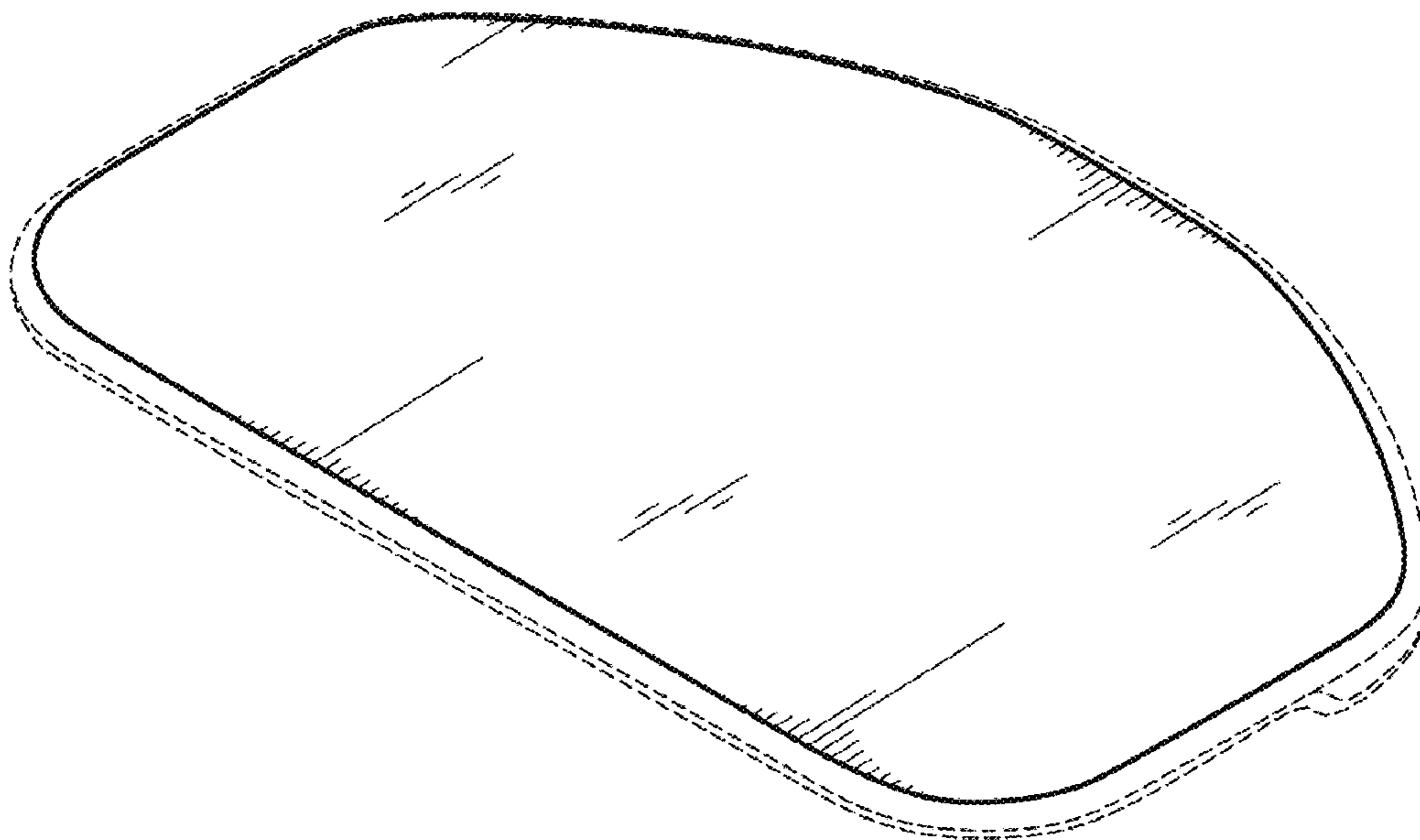
The ornamental design of a nasal support device, substantially shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an embodiment of a nasal support device;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a first side view thereof;
FIG. 4 is a second side view thereof, wherein the second side view is opposed to the first side view;
FIG. 5 is a third side view thereof;

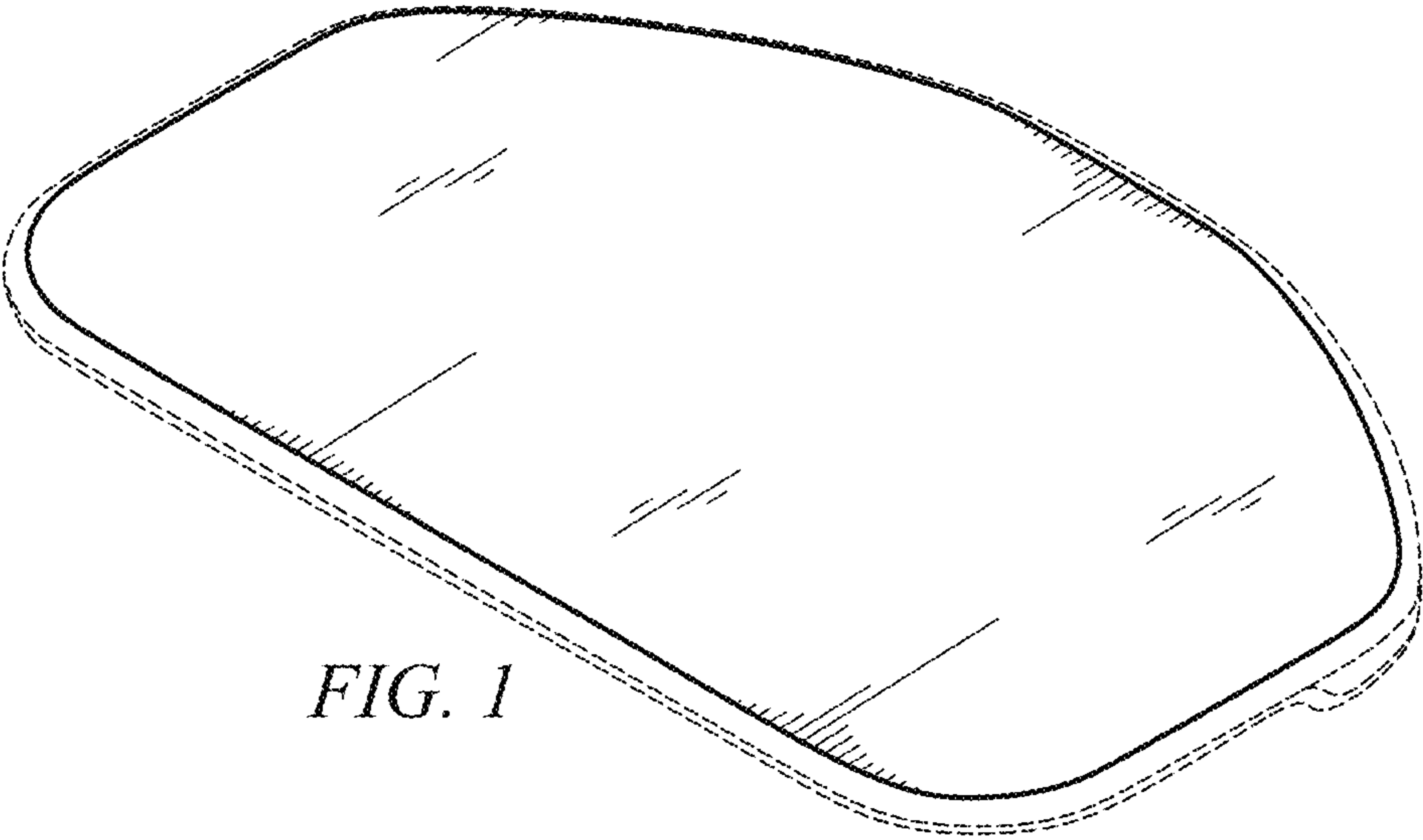

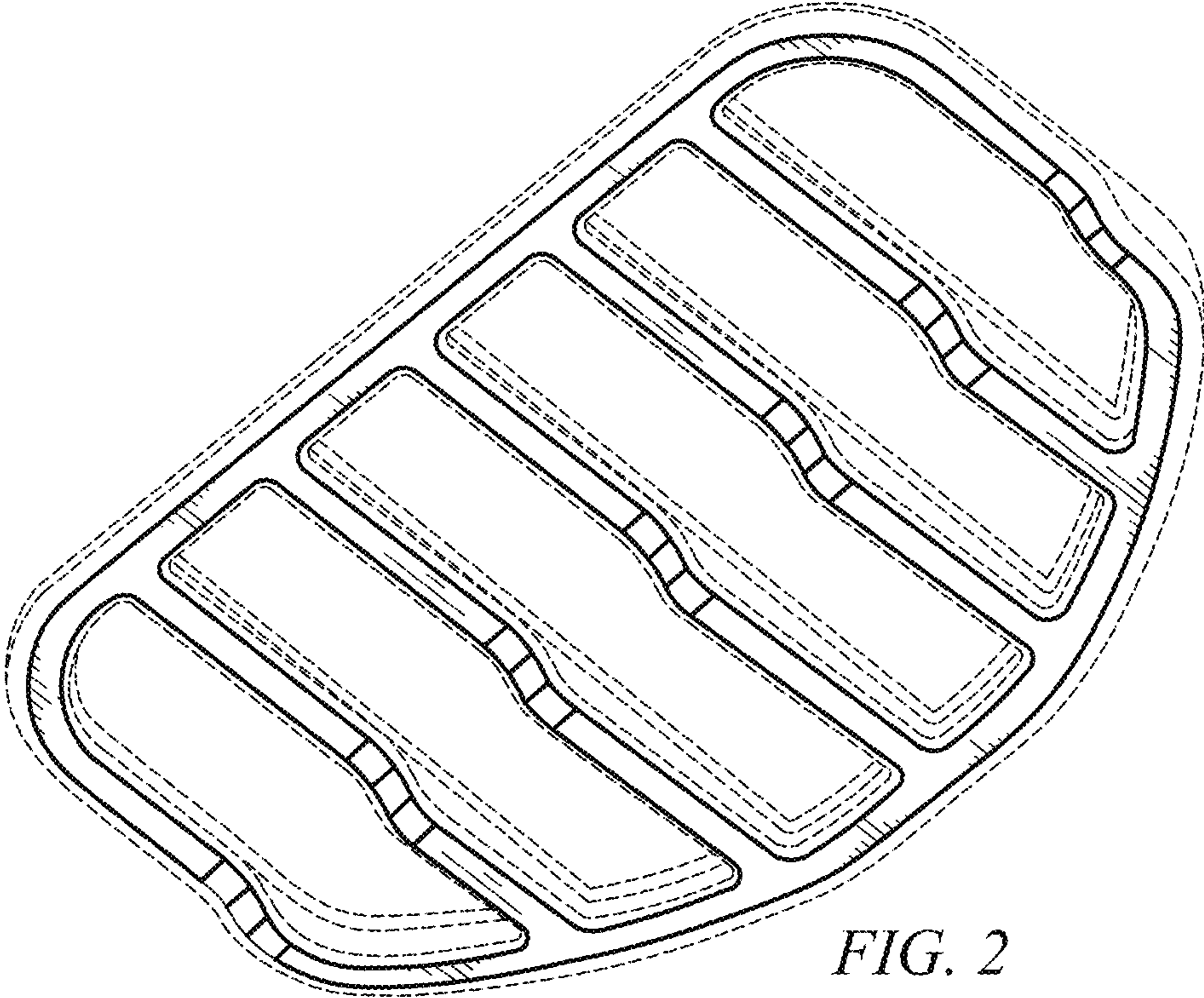

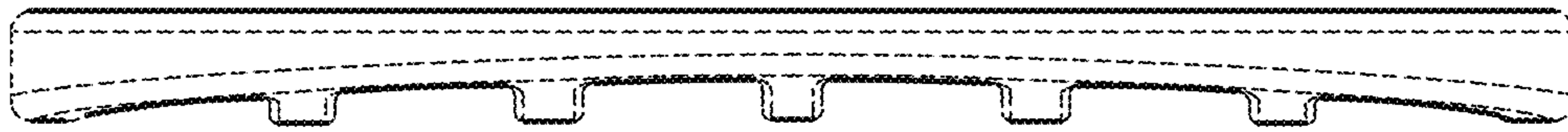

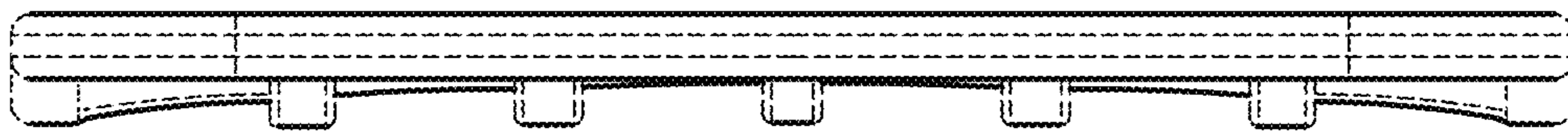

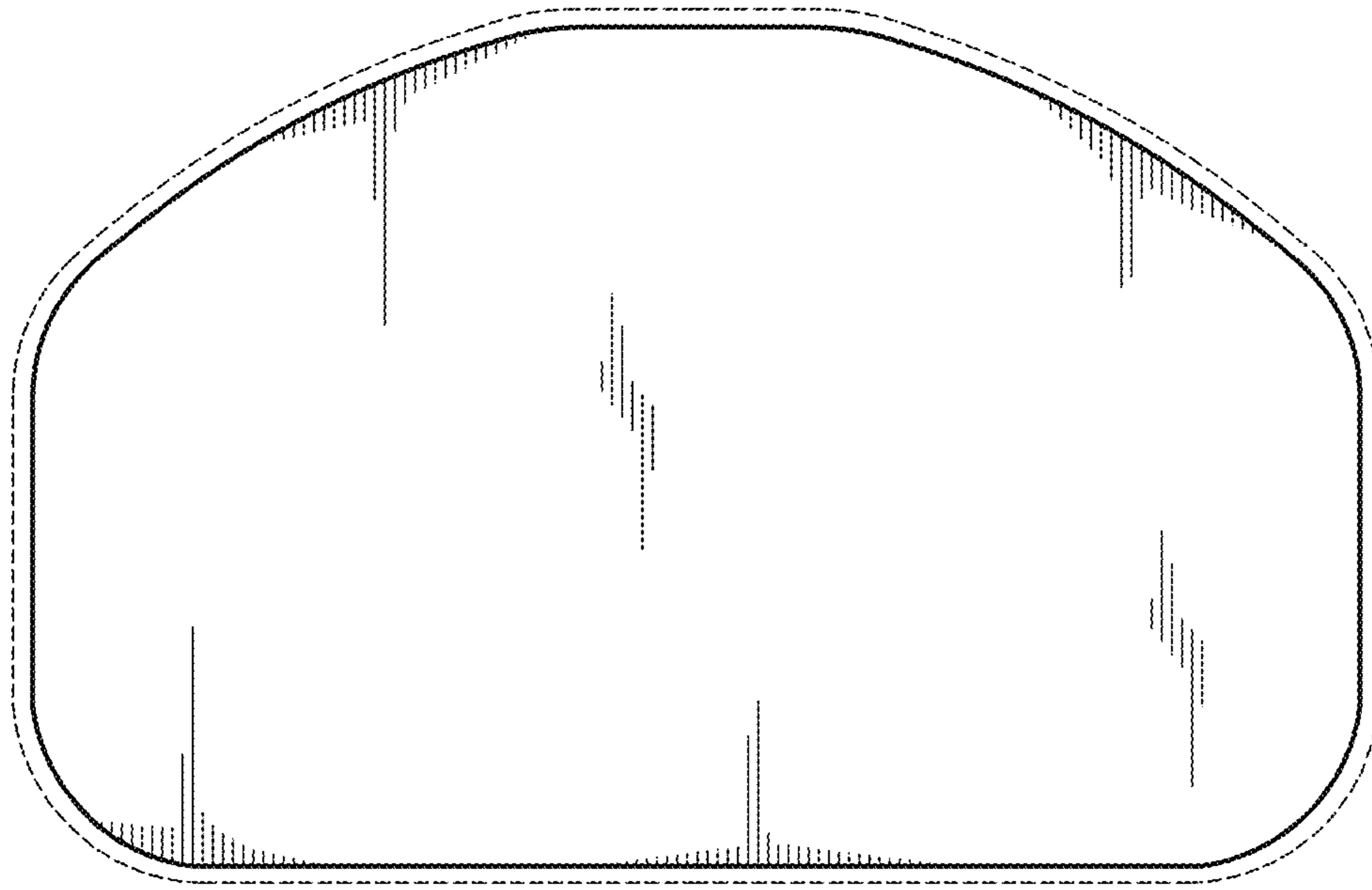

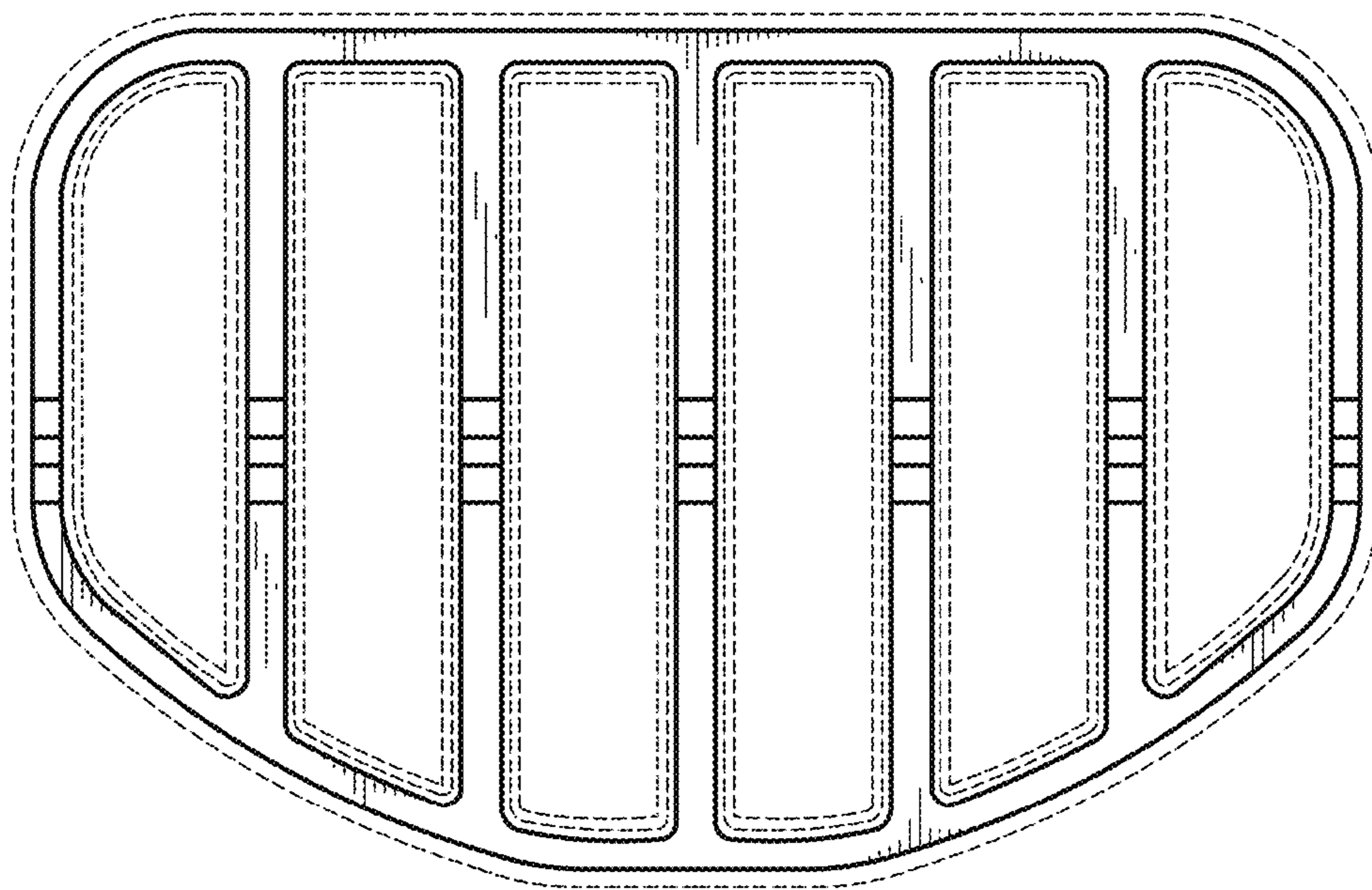
