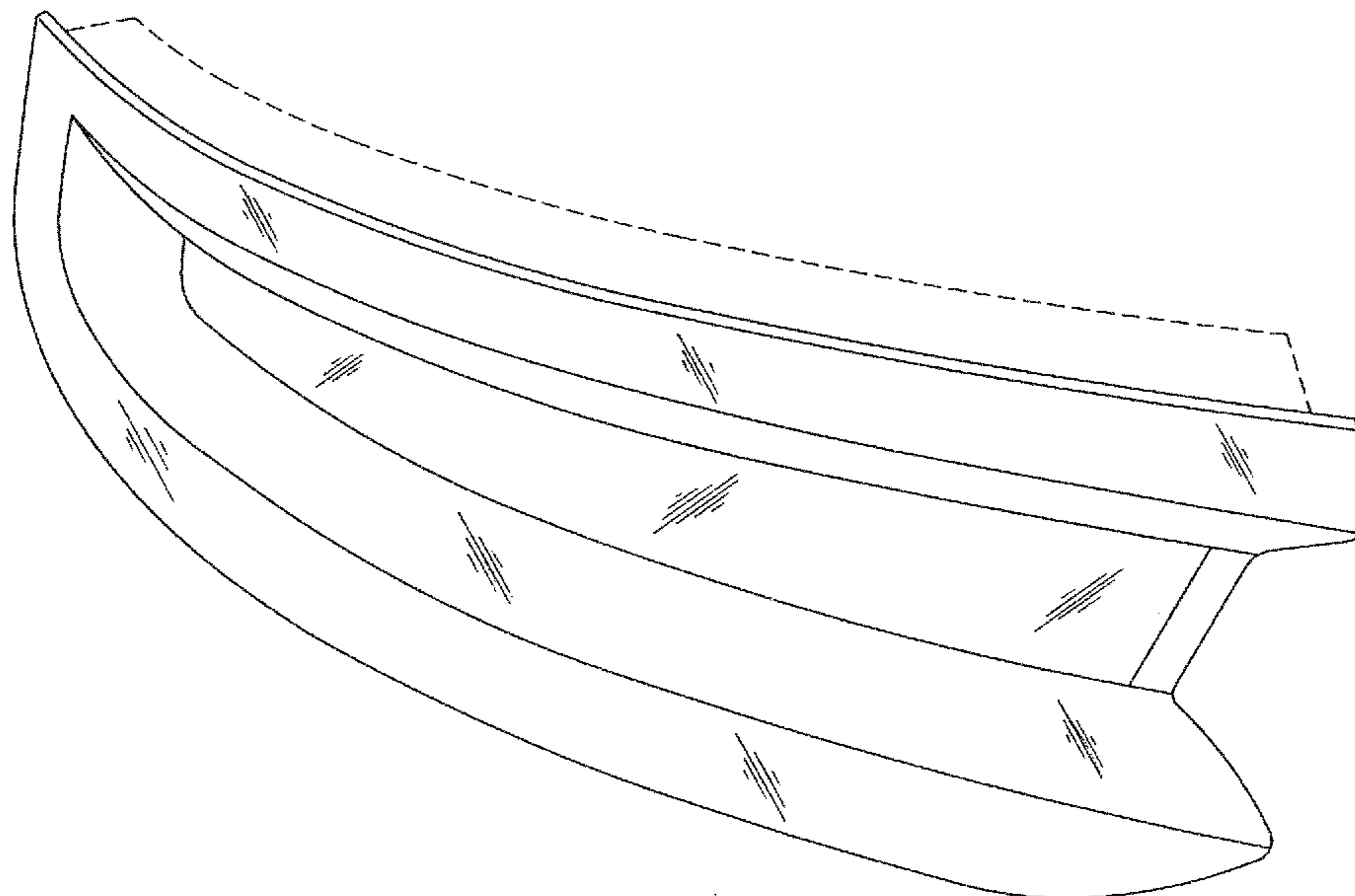
(57) **CLAIM**

The ornamental design of a lighting device for a motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a lighting device for a motor vehicle in accordance with my design;
FIG. 2 is a left side perspective view of the lighting device of FIG. 1;
FIG. 3 is a front elevational view of the lighting device of FIGS. 1 and 2;
FIG. 4 is a top plan view thereof;
FIG. 5 is a left side elevation view;
FIG. 6 is a right side elevation view;
FIG. 7 is a rear elevational view thereof; and,
FIG. 8 is a bottom plan view of thereof.

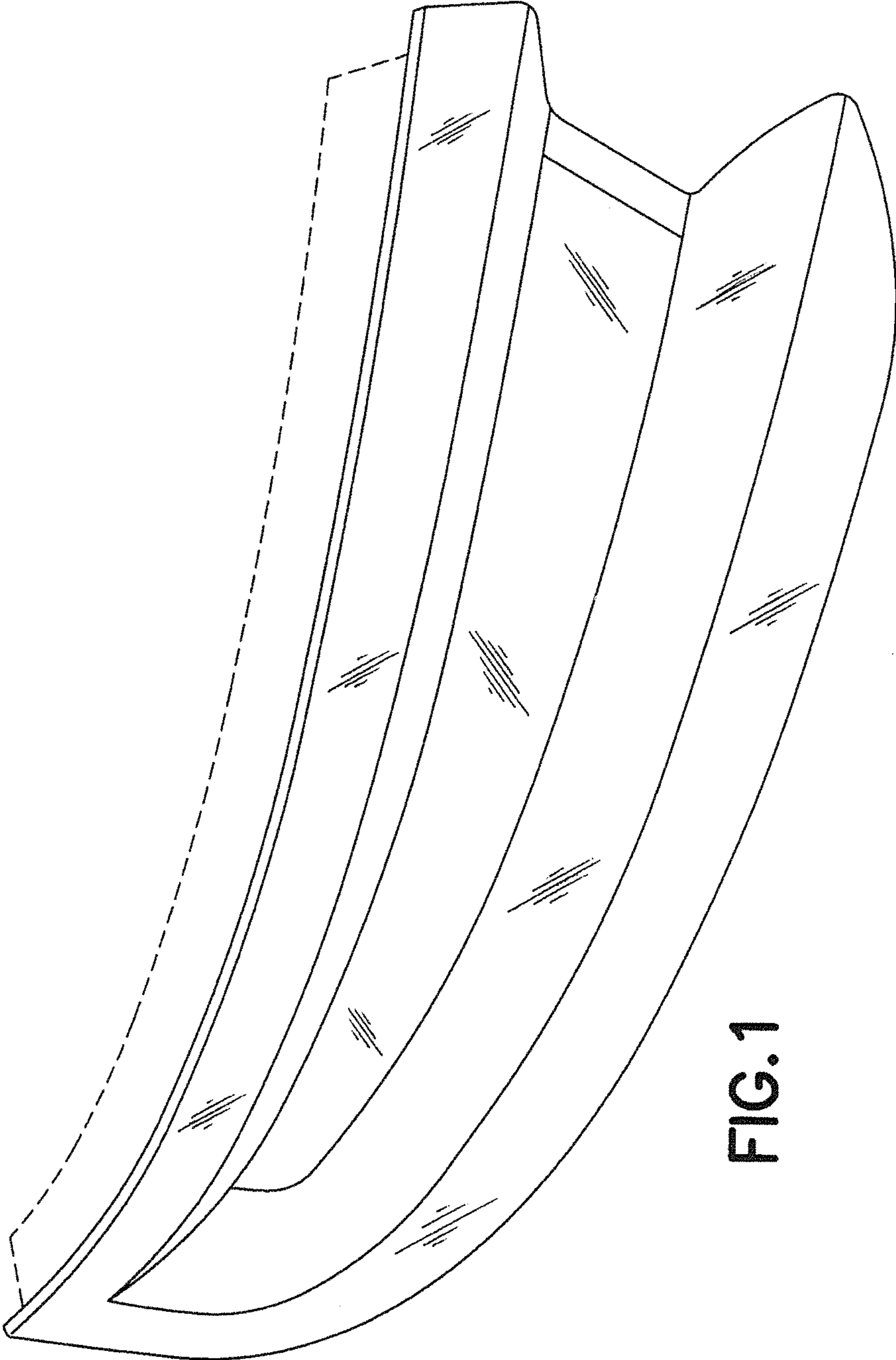

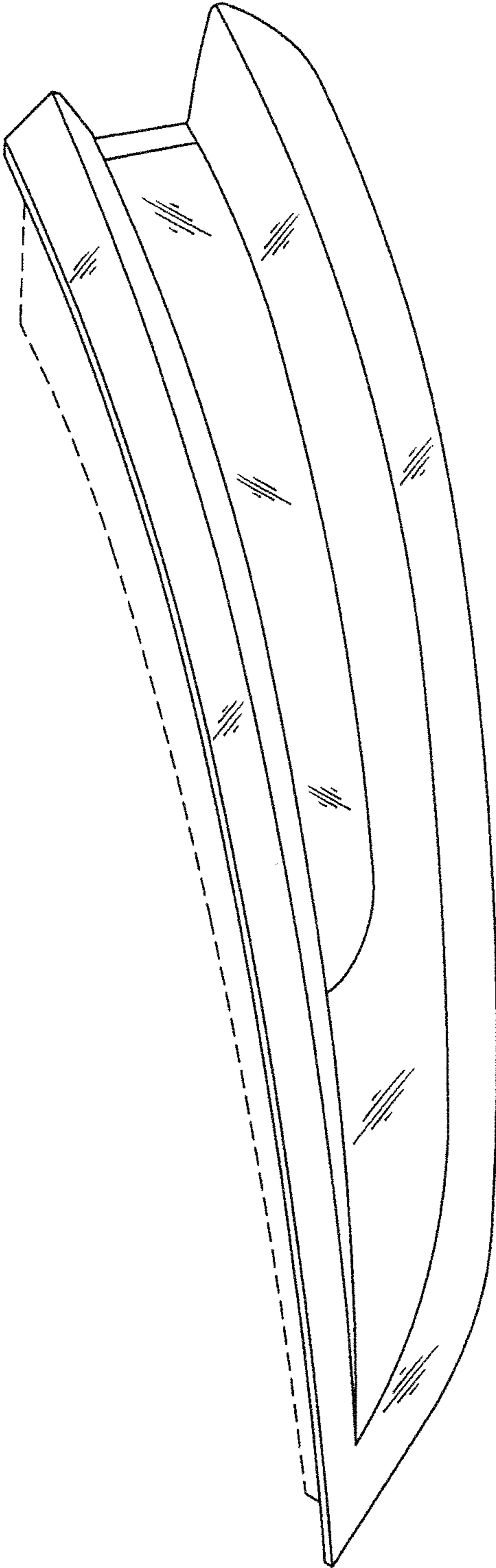

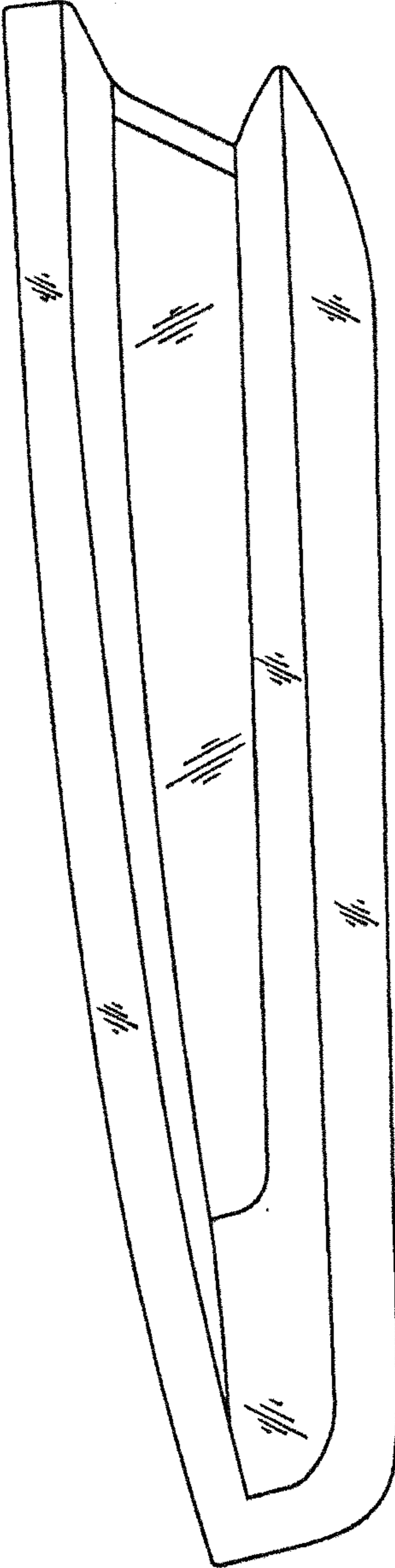

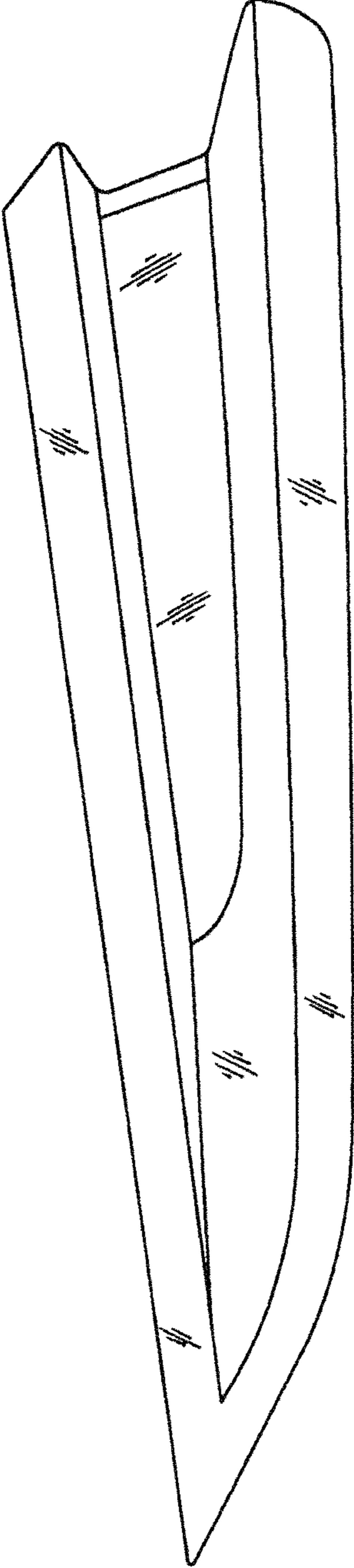

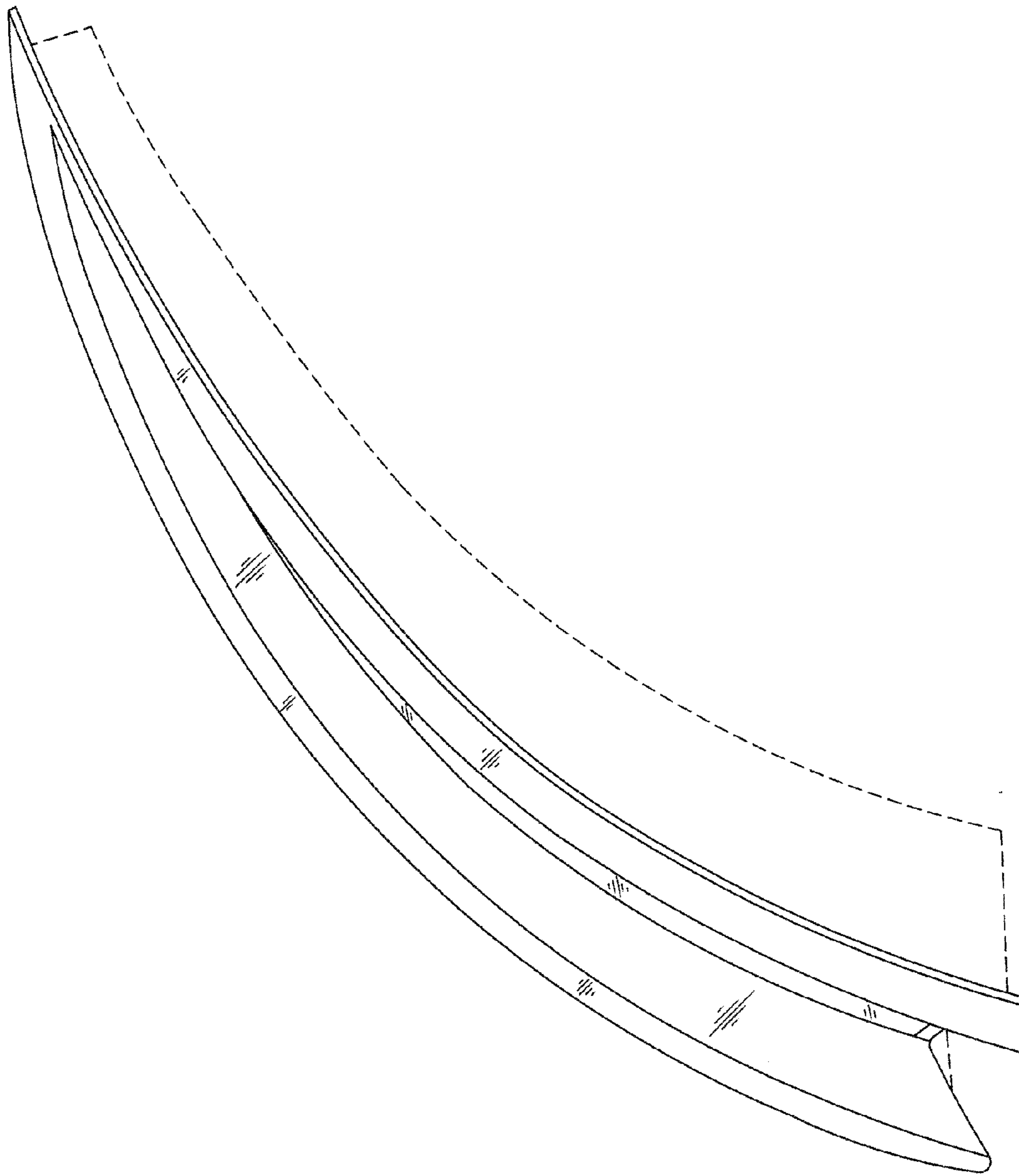

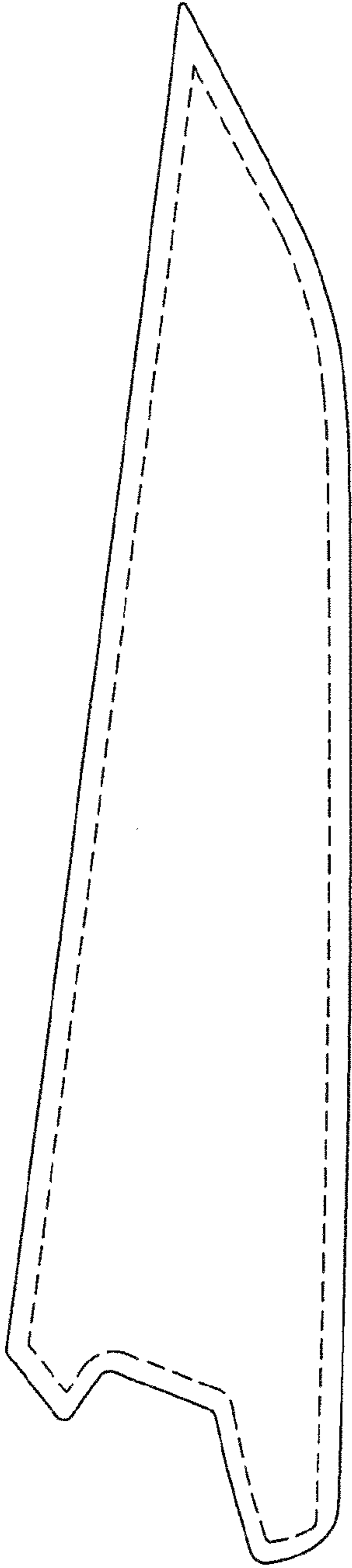

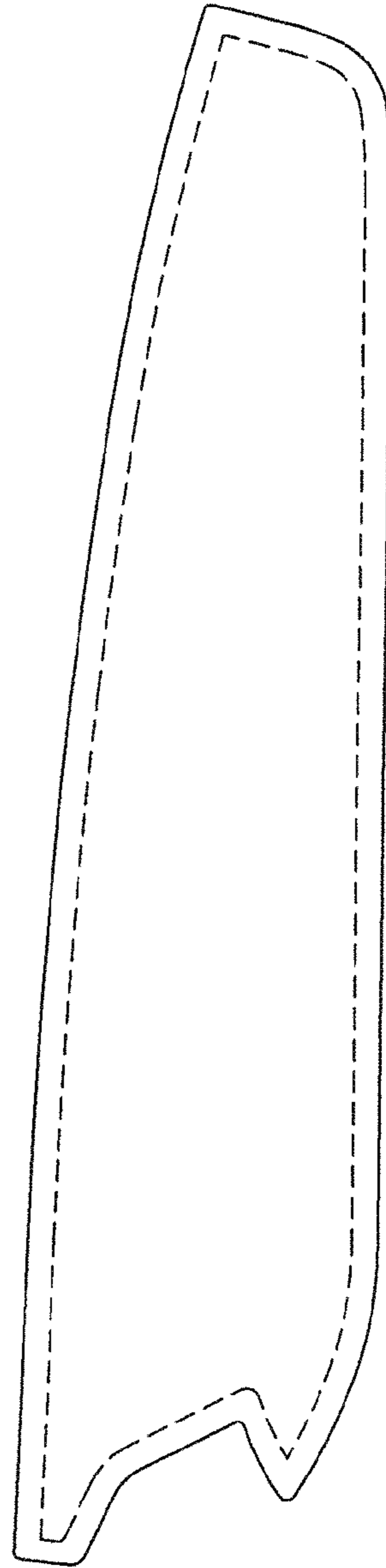

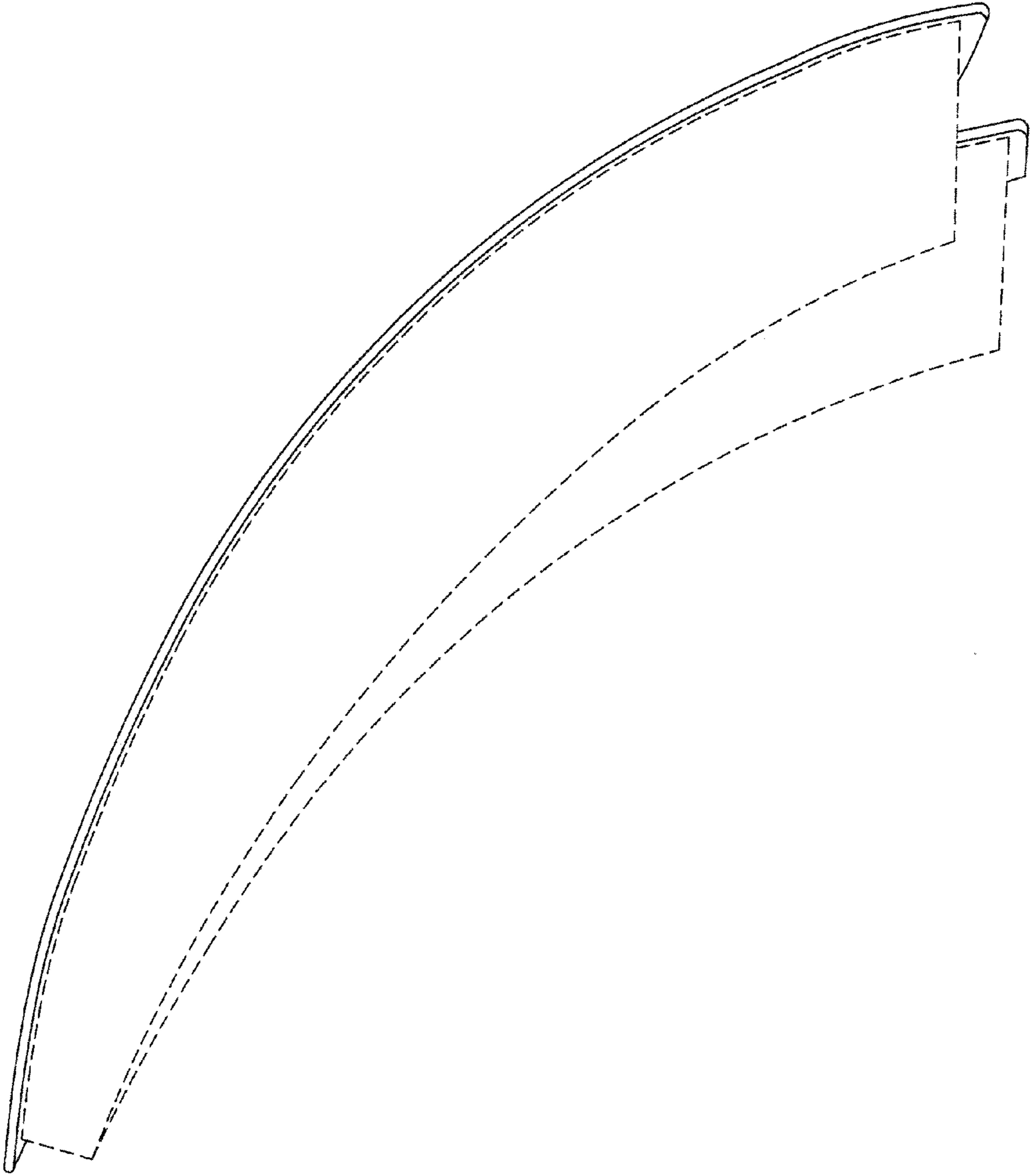
