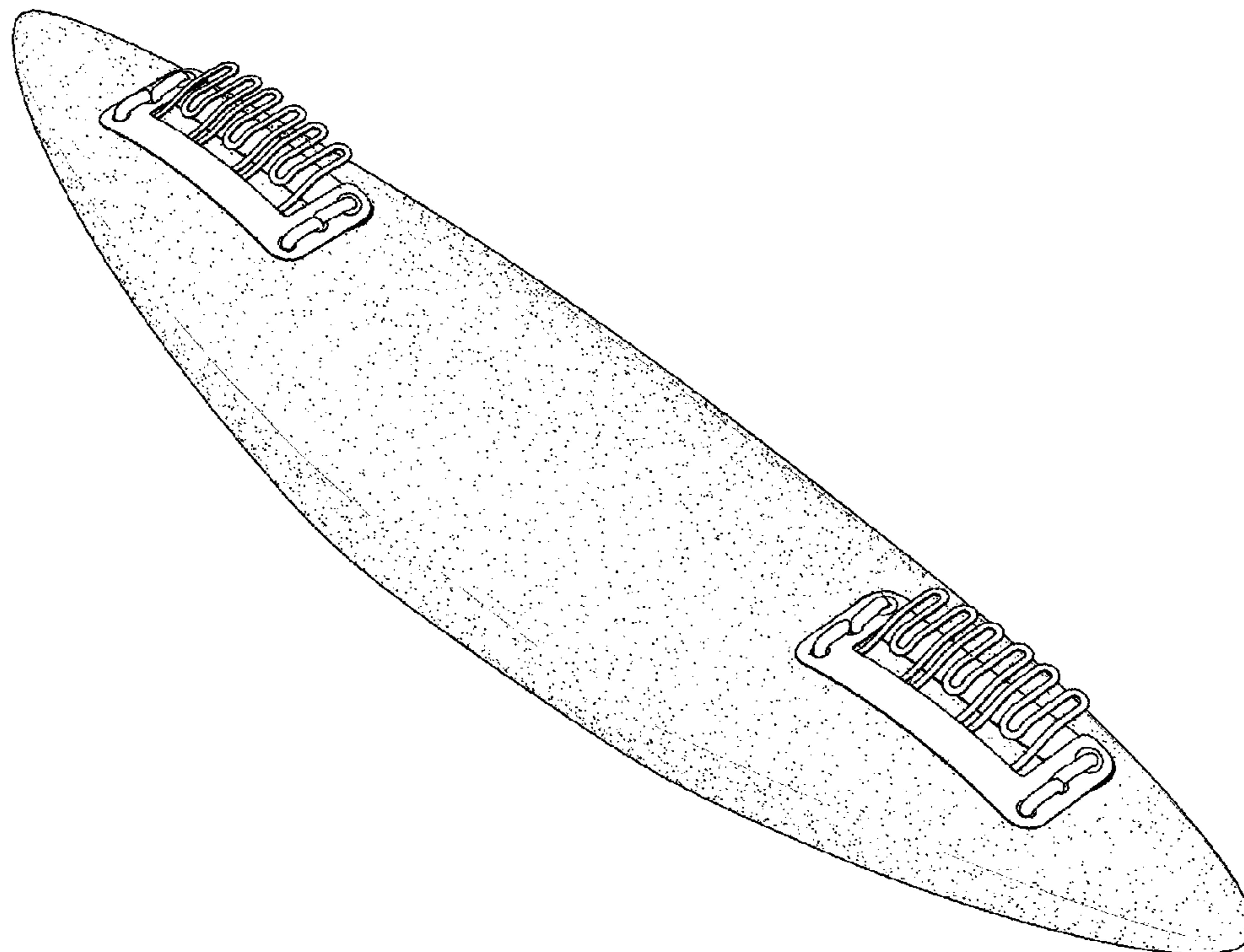
(57) **CLAIM**  
The ornamental design for a hair ornament, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of my new ornamental  
design for a hair ornament, shown with its hair clips in an  
open position;  
FIG. 2 is a bottom perspective view of the hair ornament of  
FIG. 1, shown with the hair clips in a closed position;  
FIG. 3 is a bottom view of the hair ornament of FIG. 2;  
FIG. 4 is a top view of the hair ornament of FIG. 2;  
FIG. 5 is a right-end view of the hair ornament of FIG. 2;  
FIG. 6 is a left-end view of the hair ornament of FIG. 2;  
FIG. 7 is a right-side view of the hair ornament of FIG. 2;  
and,  
FIG. 8 is a left-side view of the hair ornament of FIG. 2.  
The shading in the drawings of the hair ornament represents  
a foam-like material.

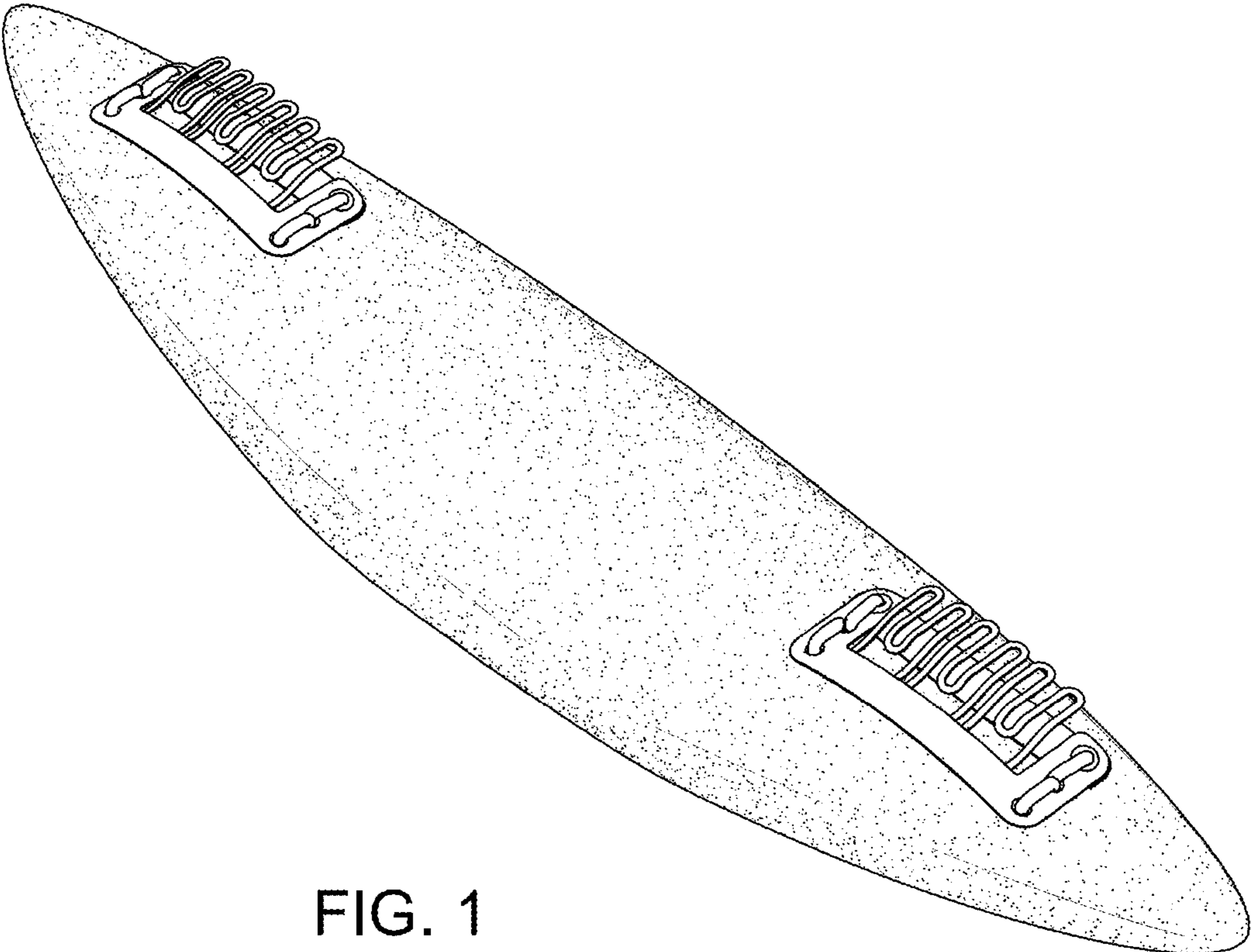

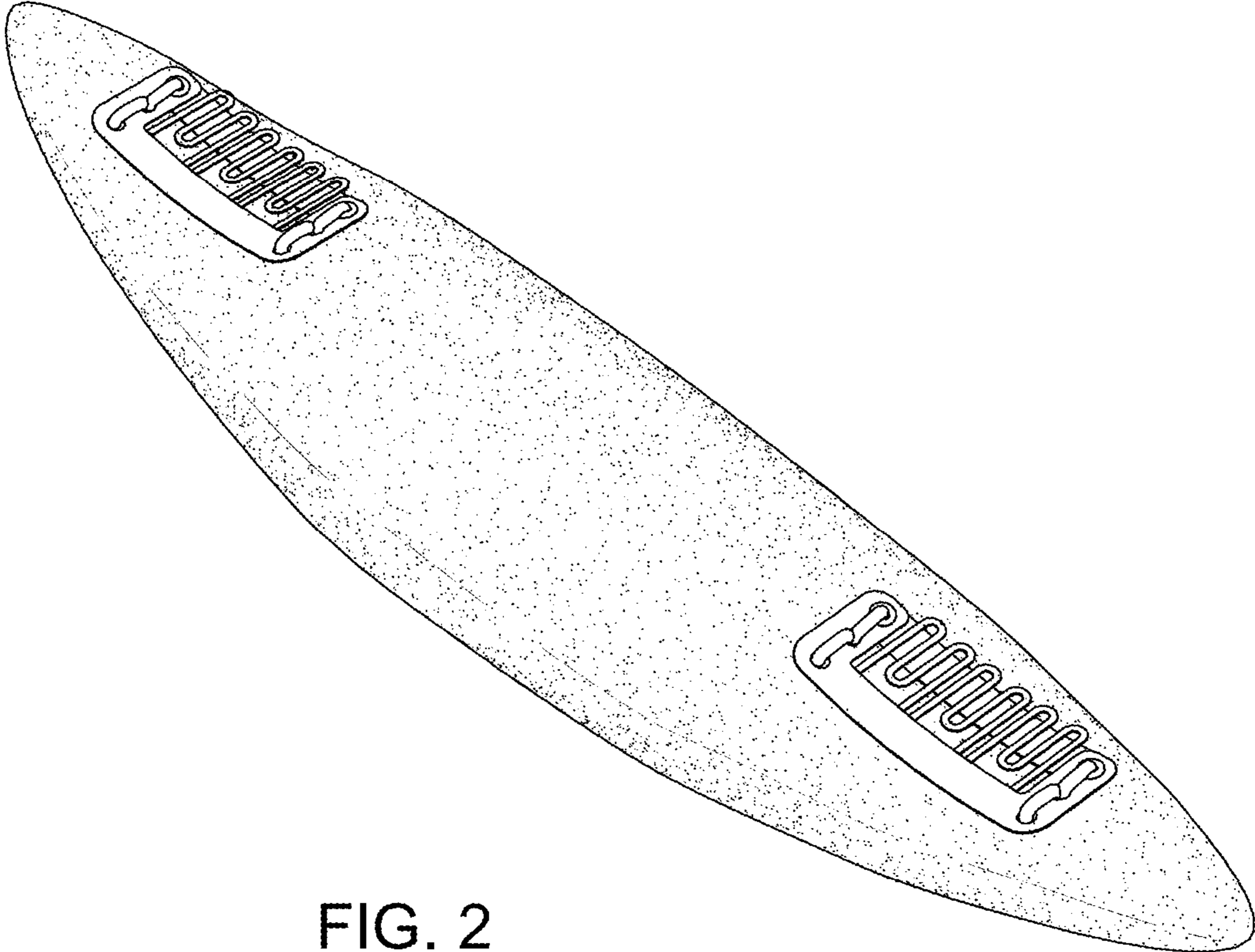

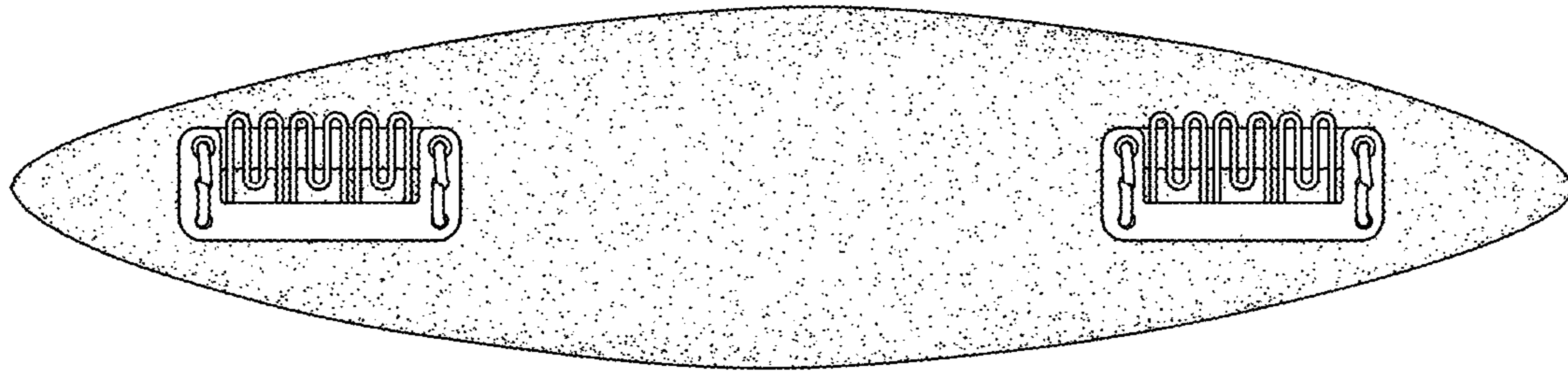

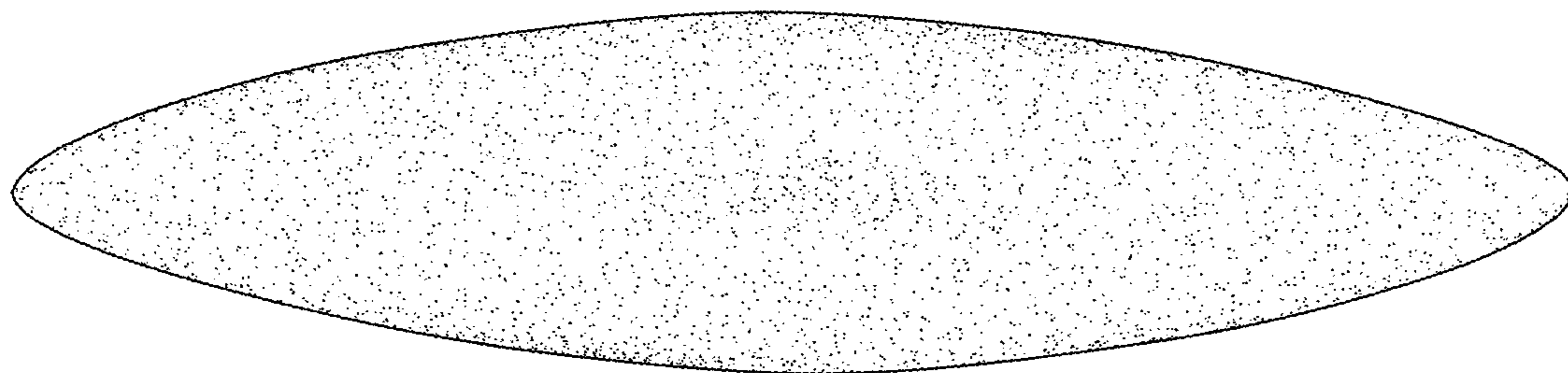

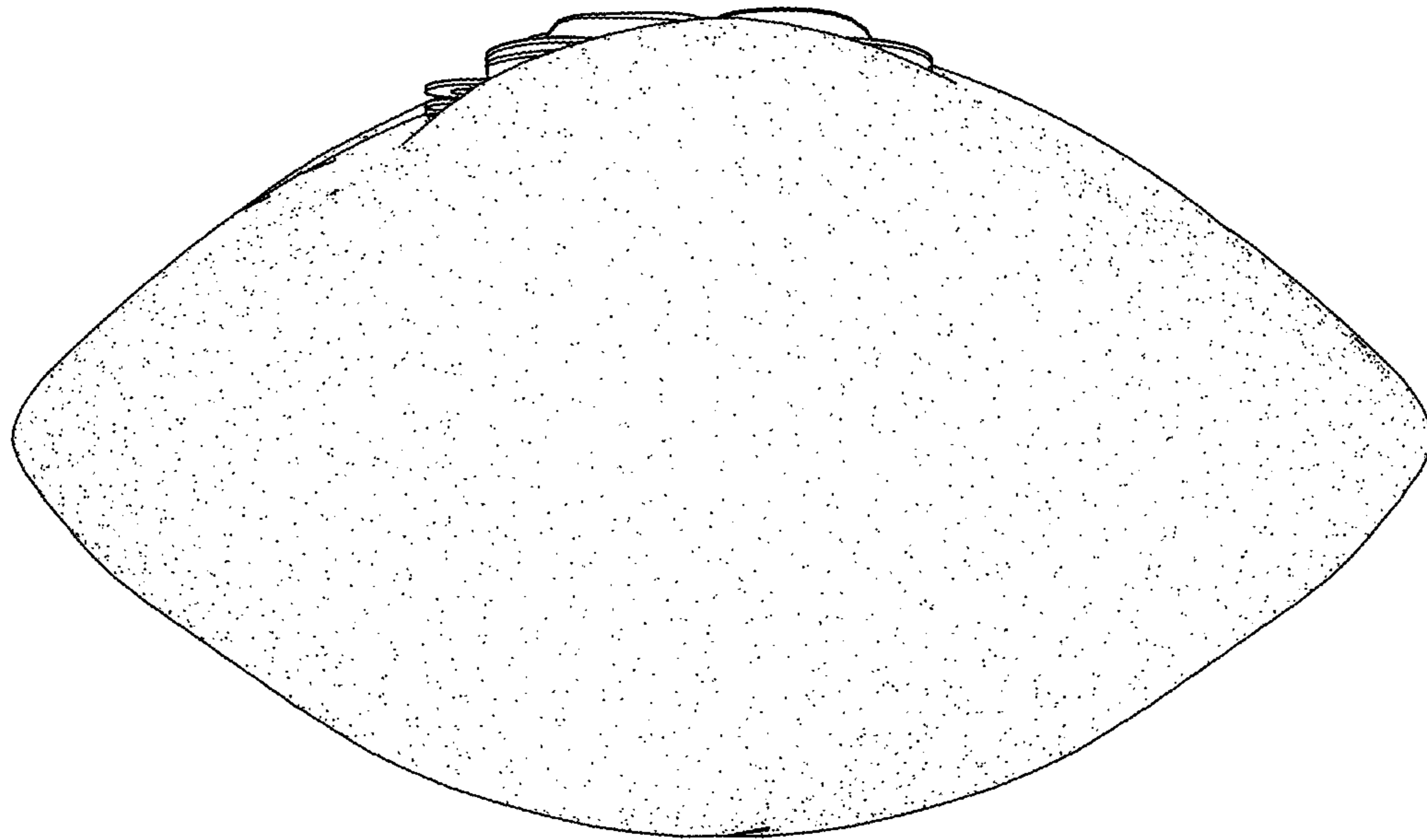

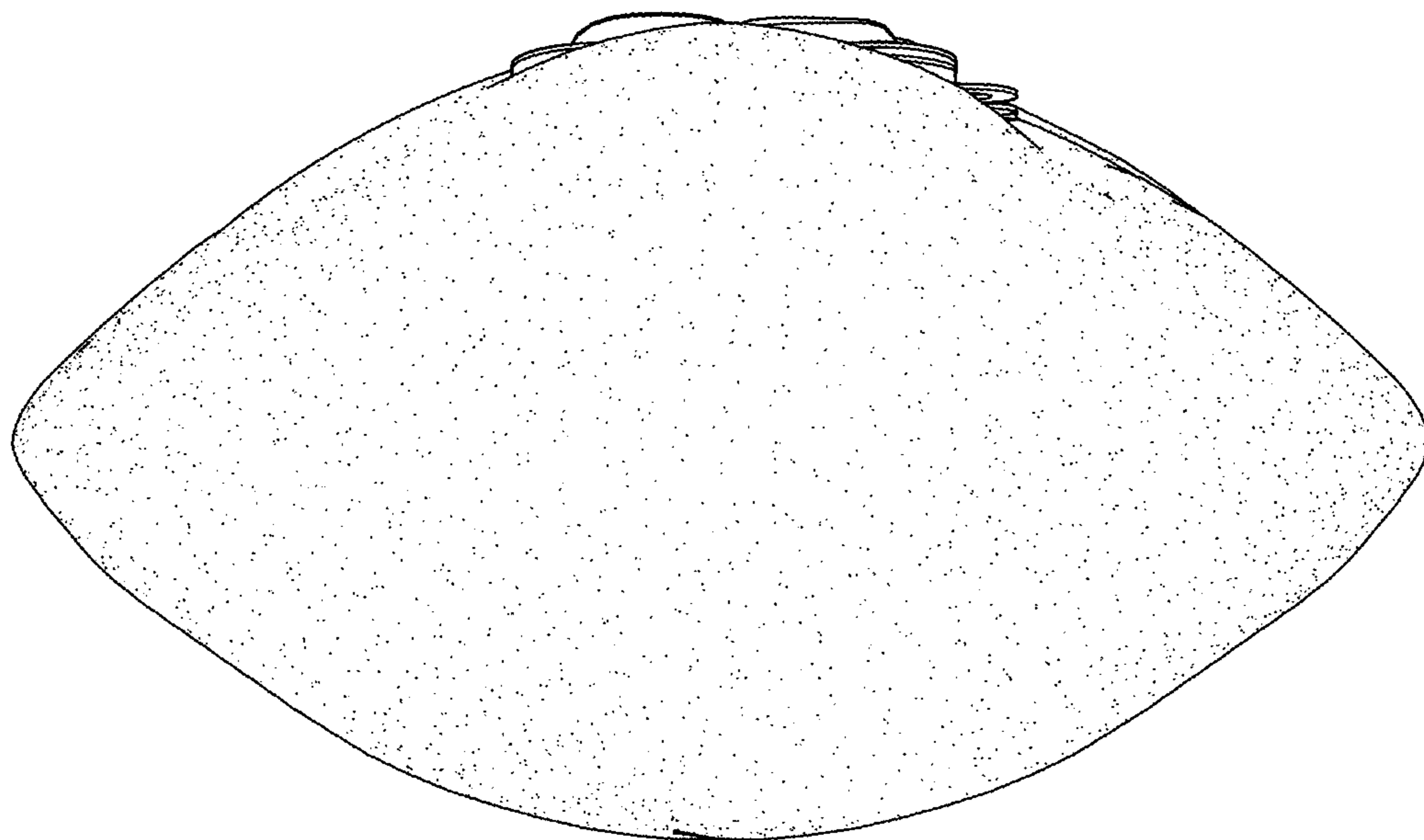

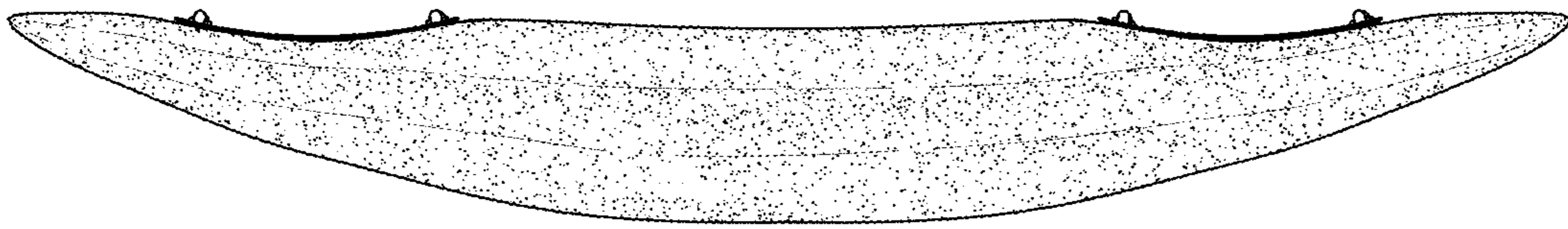

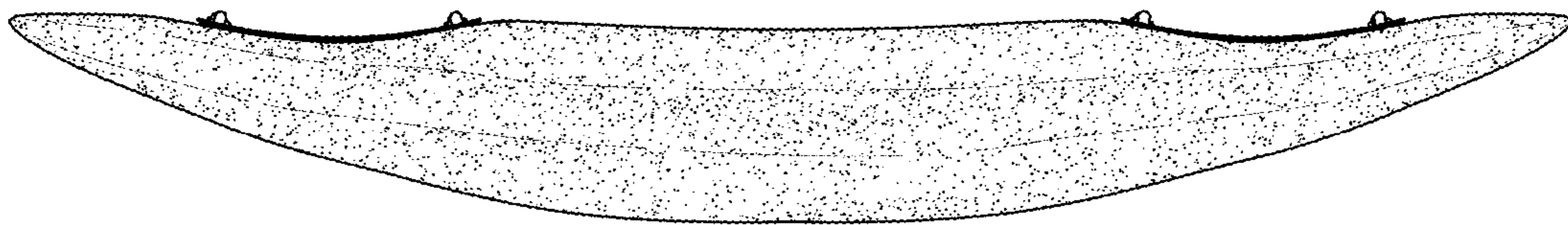
