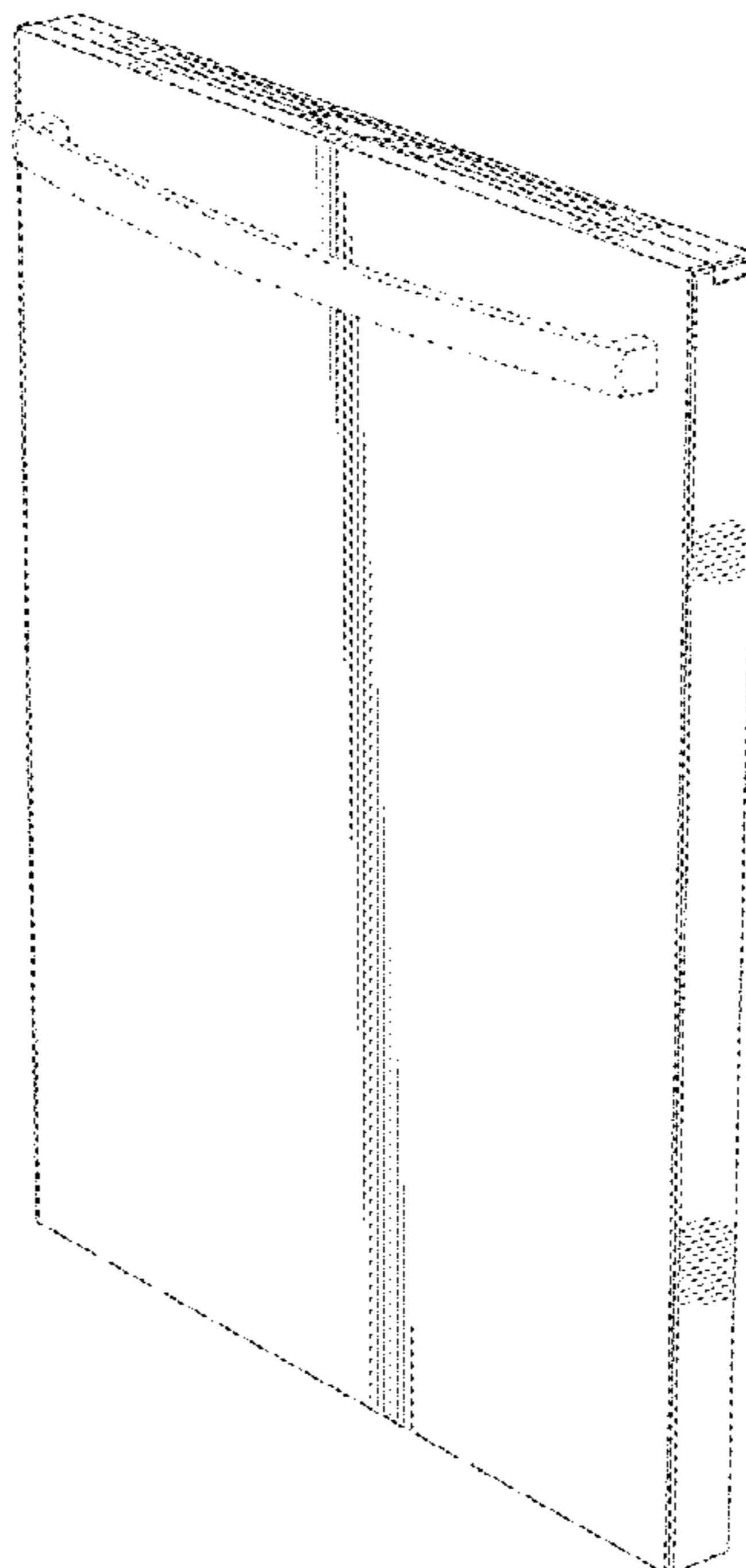
(57) **CLAIM**

The ornamental design for a dishwasher and/or components thereof, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view, from the top, of a dishwasher door according to our new ornamental design; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a left side view thereof, with the right side view thereof being a mirror image thereof; and, FIG. 5 is a front perspective view thereof from the bottom. The broken lines of the dishwasher, dishwasher compartment and/or components thereof show surrounding structure or environment and do not form part of the claimed design. Where included, the dotted lines represent the border between claimed and non-claimed subject matter. The bottom, front and rear parts of the dishwasher door, and the bottom, front, rear and top of the dishwasher compartment are unornamented and form no part of the claimed design.

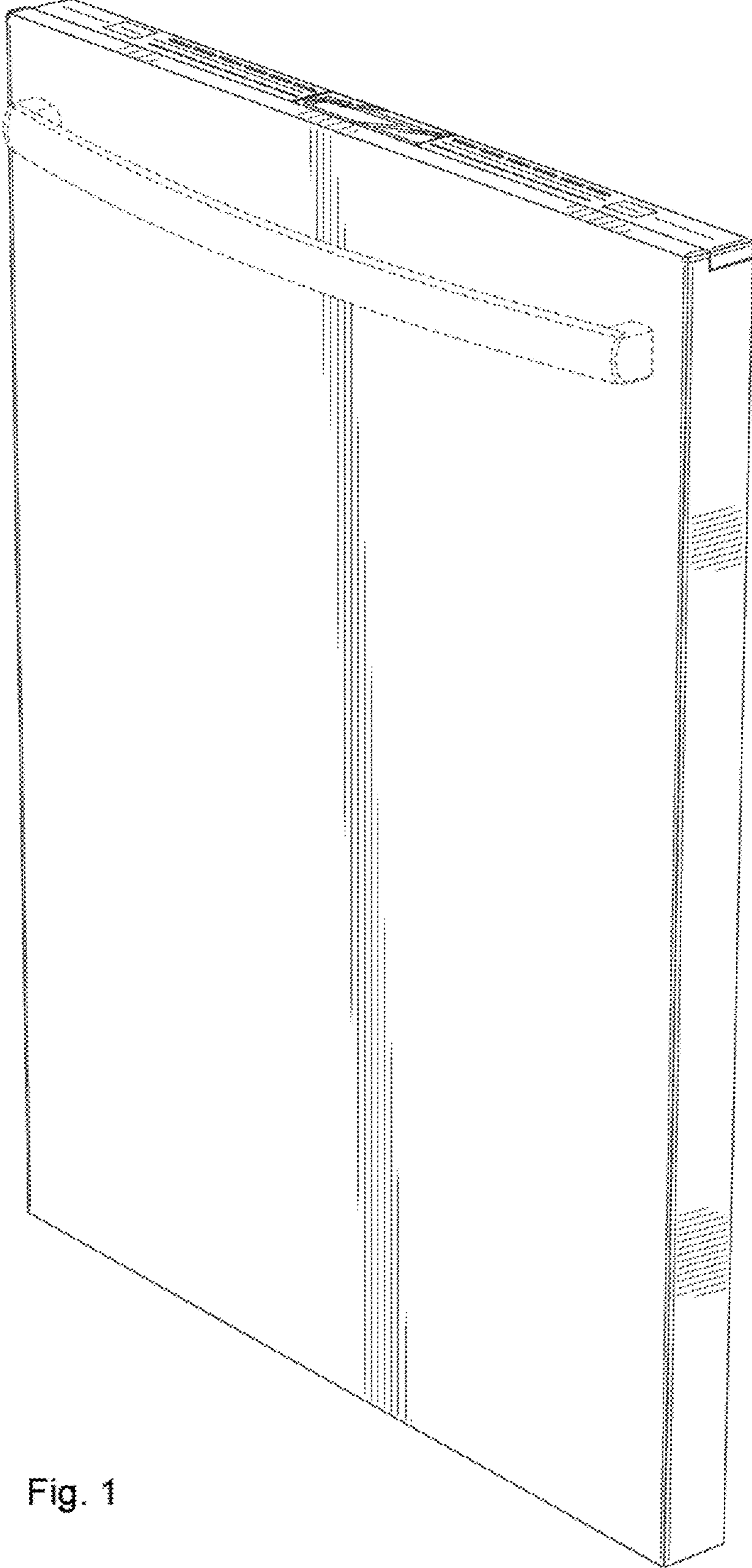

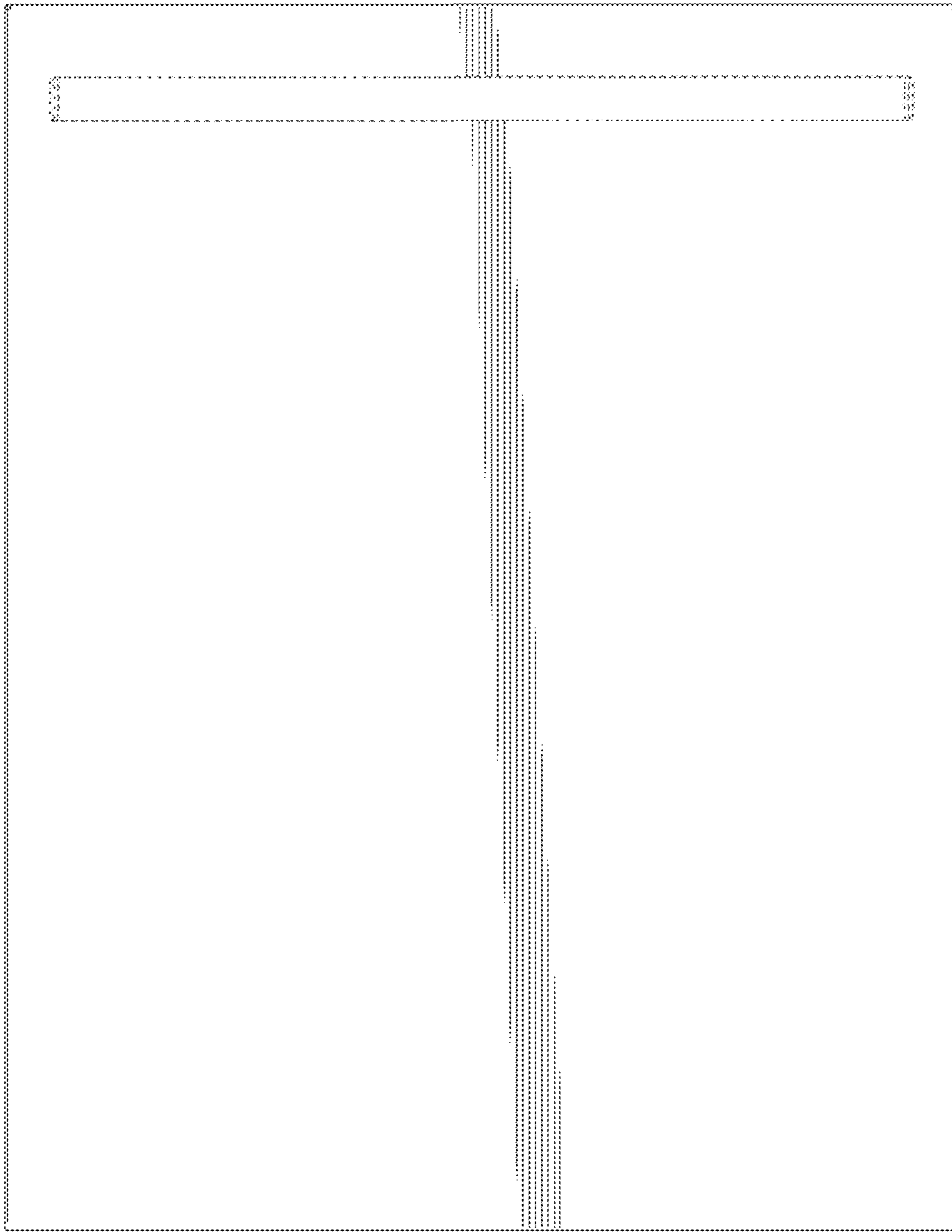

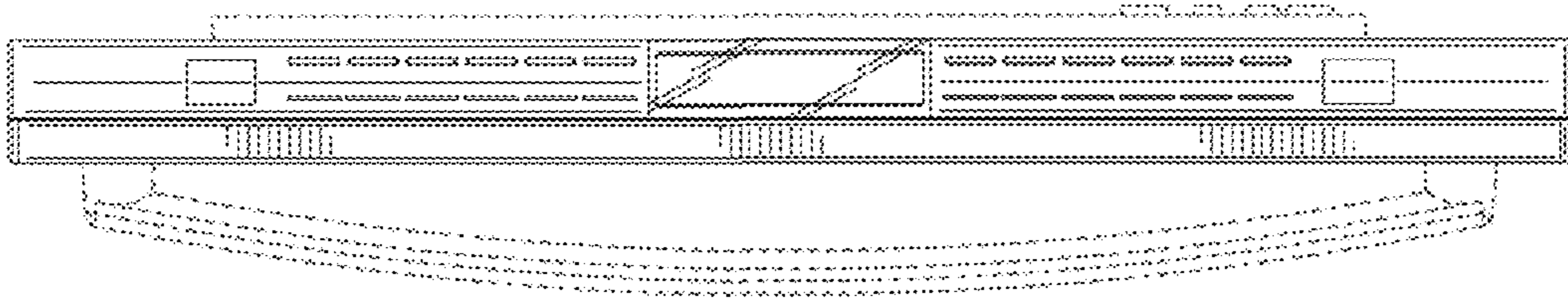

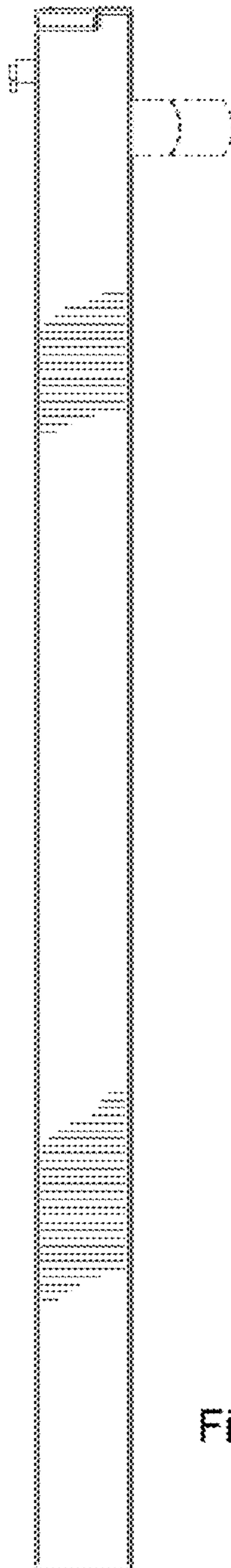

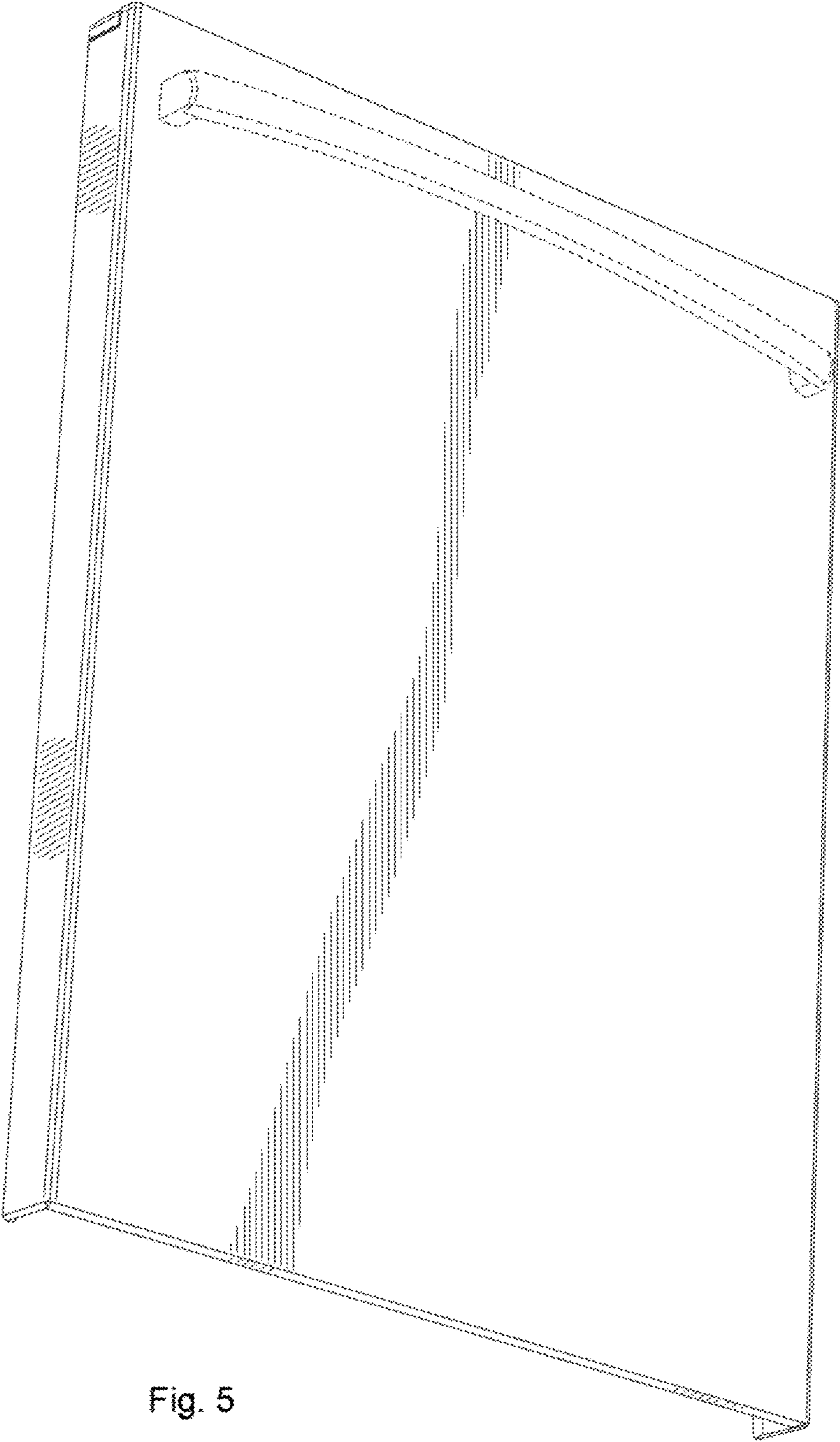
