(57) **CLAIM**

The ornamental design for a pair of working gloves, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a left hand glove of a pair of working gloves, the right hand glove, which is not shown, is a mirror image of the left hand glove shown in FIGS. 1-7.

FIG. 2 is a top plan view of FIG. 1.

FIG. 3 is a bottom plan view of FIG. 1.

FIG. 4 is a rear elevation view of FIG. 1.

FIG. 5 is a front elevation view of FIG. 1.

FIG. 6 is a left side elevation view of FIG. 1.

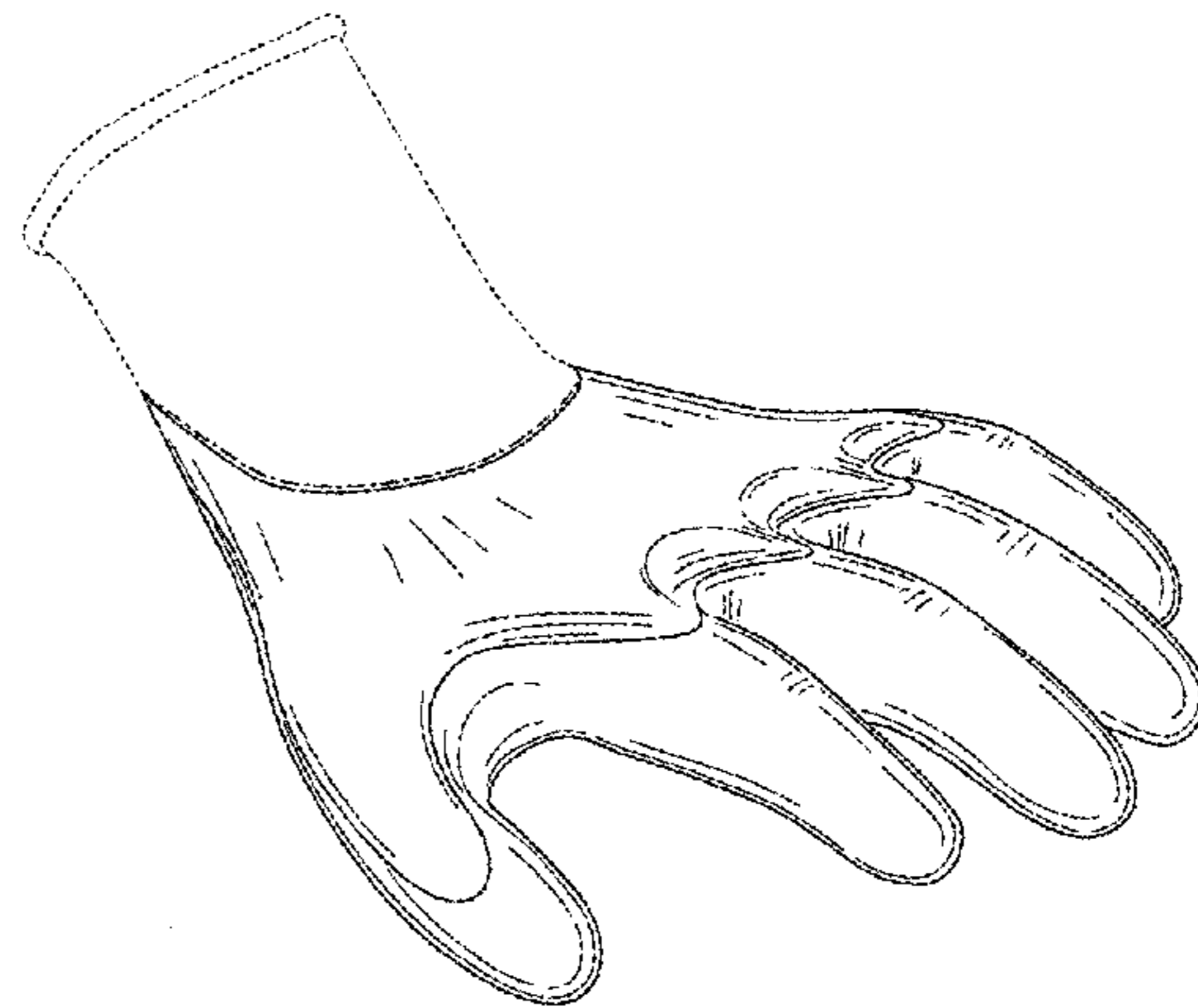
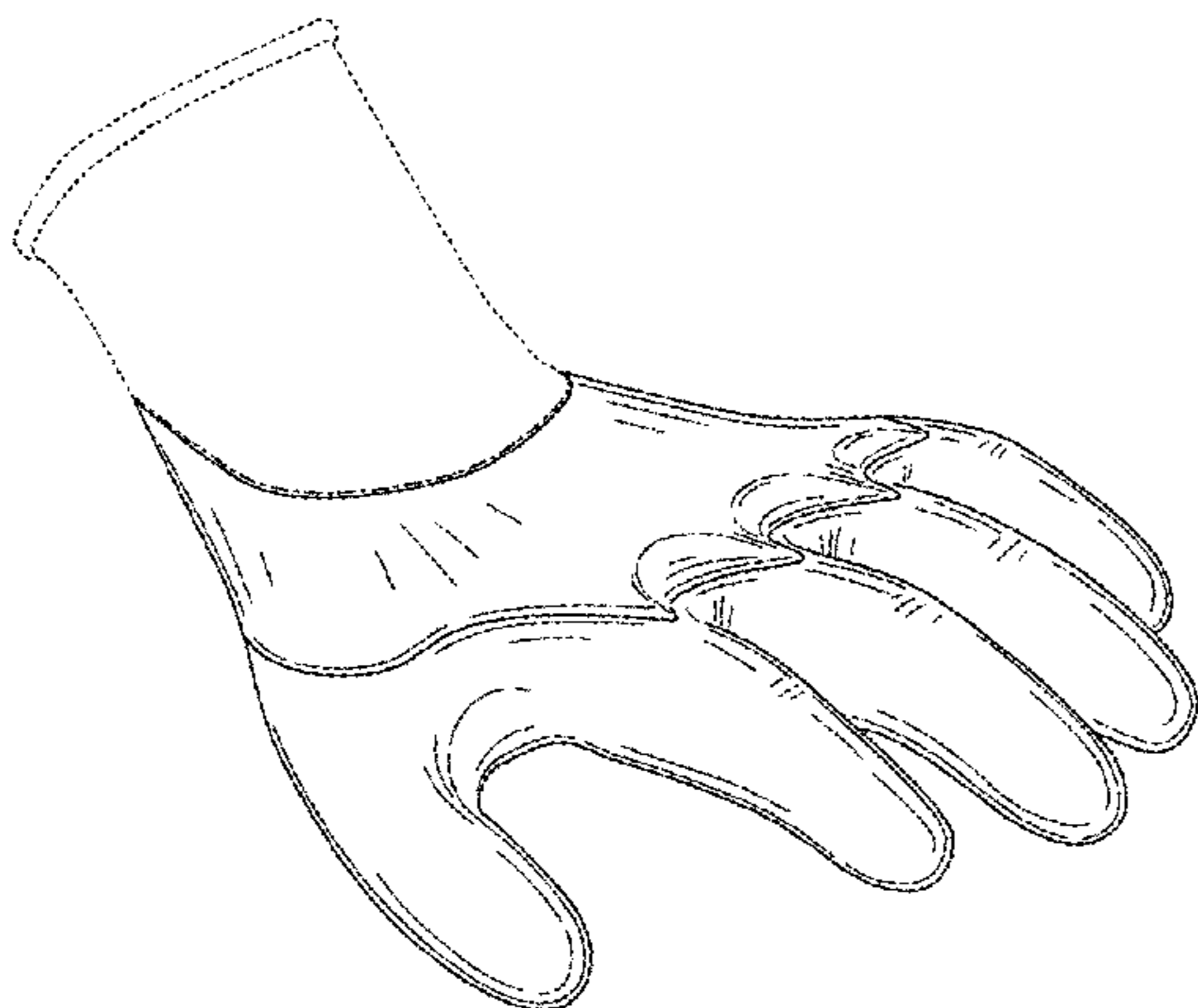


FIG. 7 is a right side elevation view of FIG. 1.
FIG. 8 is a front perspective view of second embodiment of a left hand glove of a pair of working gloves, the right hand glove, which is not shown, is a mirror image of the left hand glove shown in FIGS. 8-14.

FIG. 10 is a bottom plan view of FIG. 8.

FIG. 11 is a rear elevation view of FIG. 8.

FIG. 12 is a front elevation view of FIG. 8.

FIG. 13 is a left side elevation view of FIG. 8; and,
FIG. 14 is a right side elevation view of FIG. 8.

The dot dash line represents the boundary of the claim and forms no part thereof.

The evenly spaced broken lines show a portion of the glove that forms no part of the claimed design. The surface is lightly lined for contour.

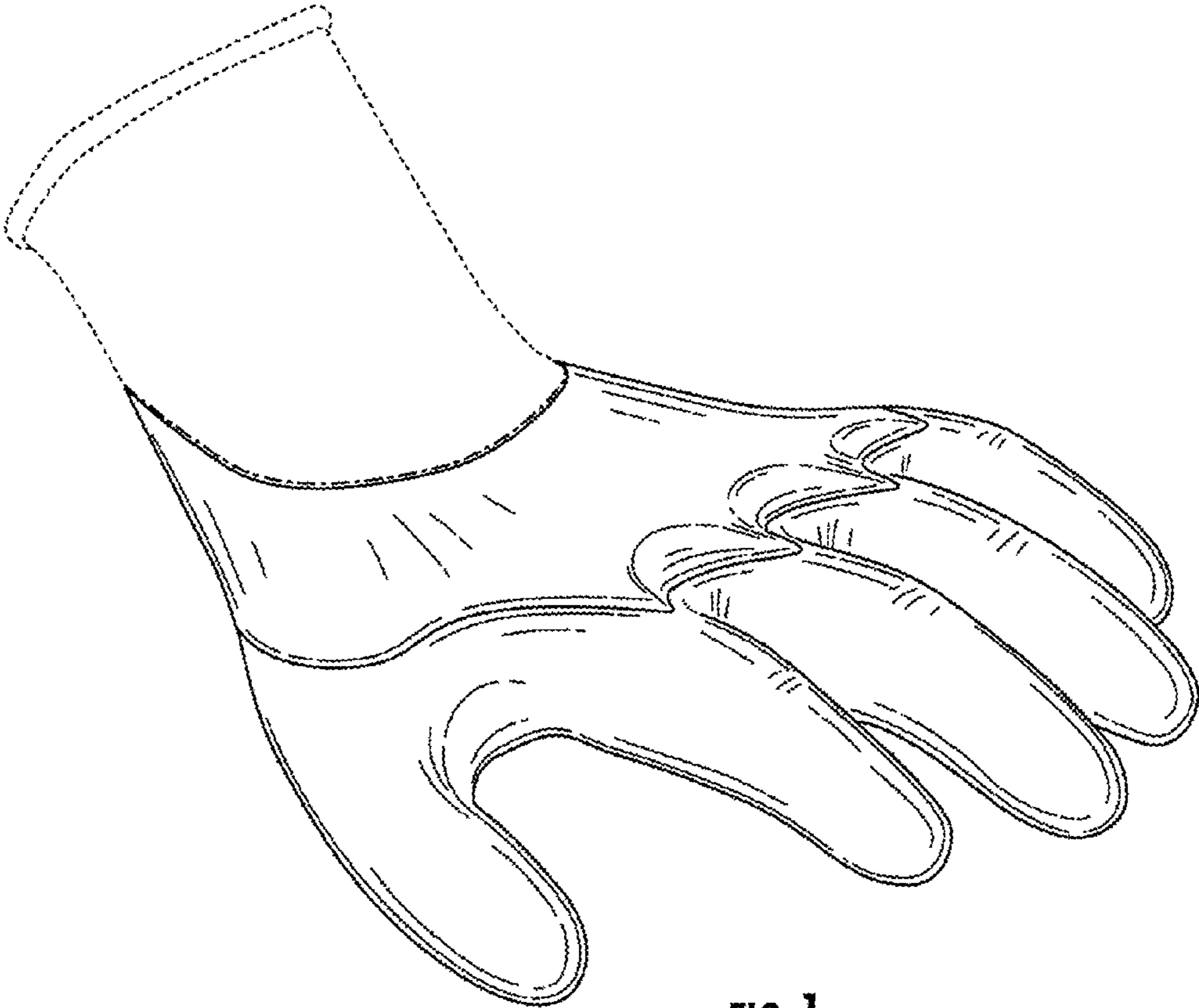

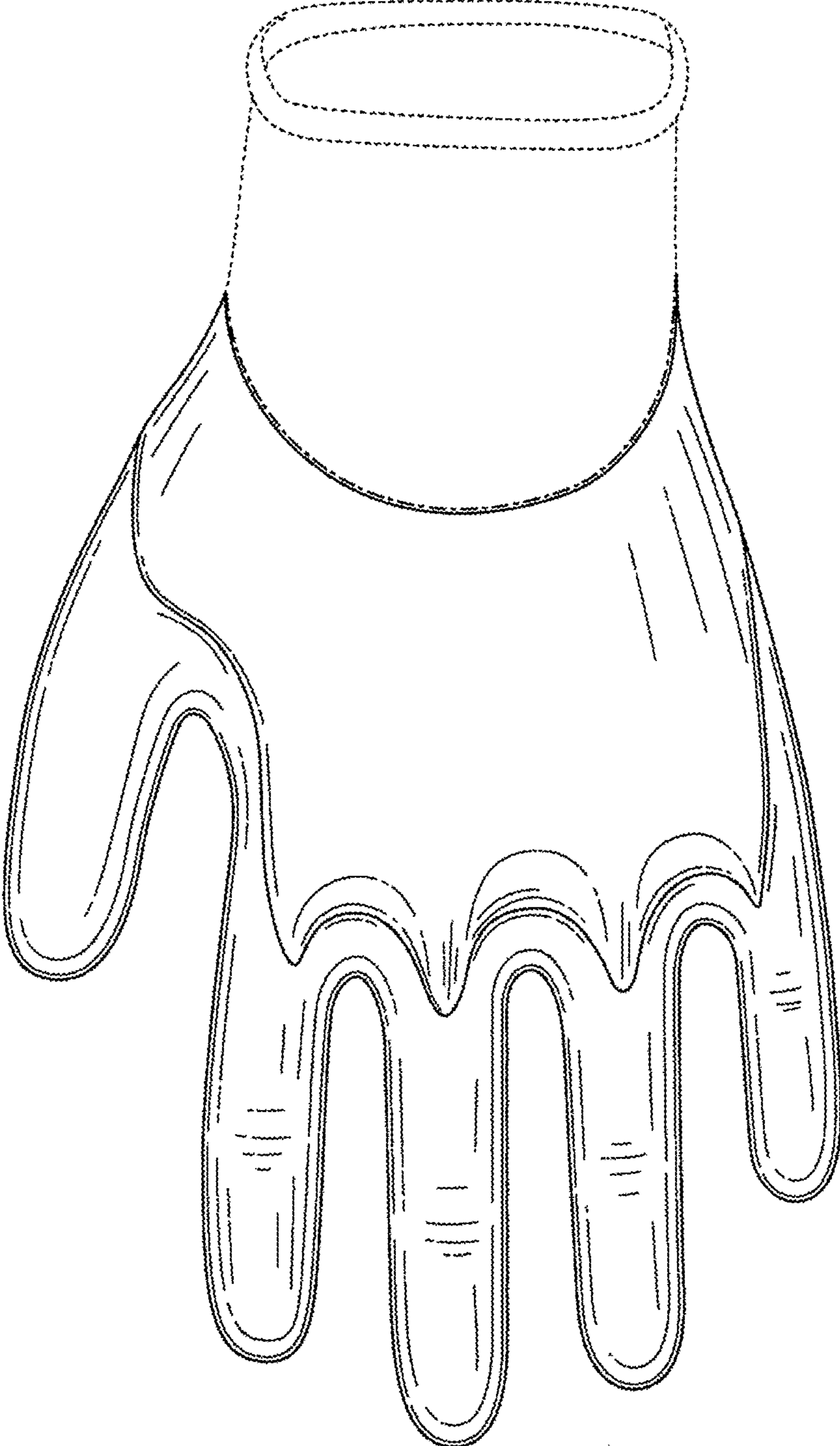

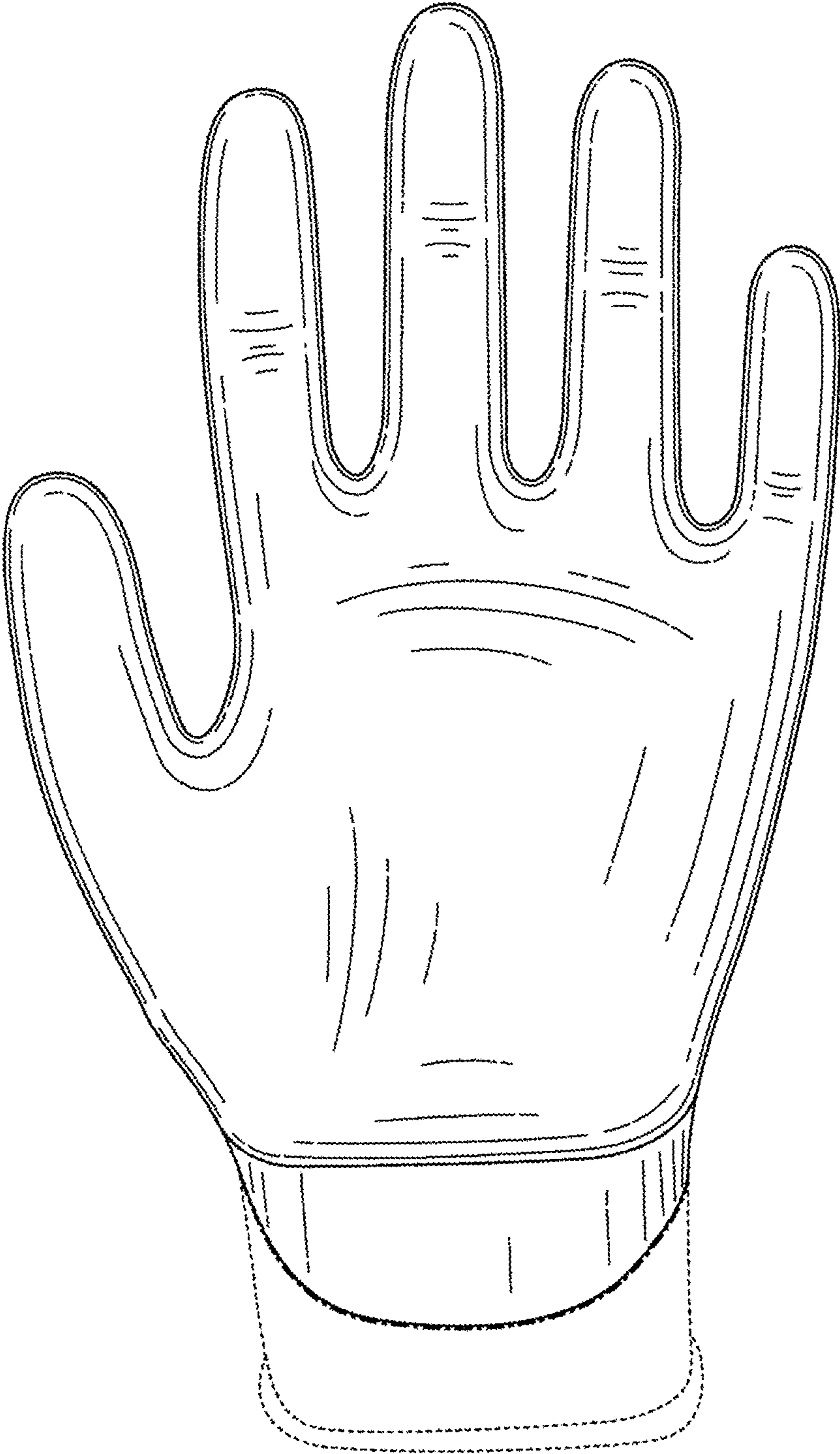

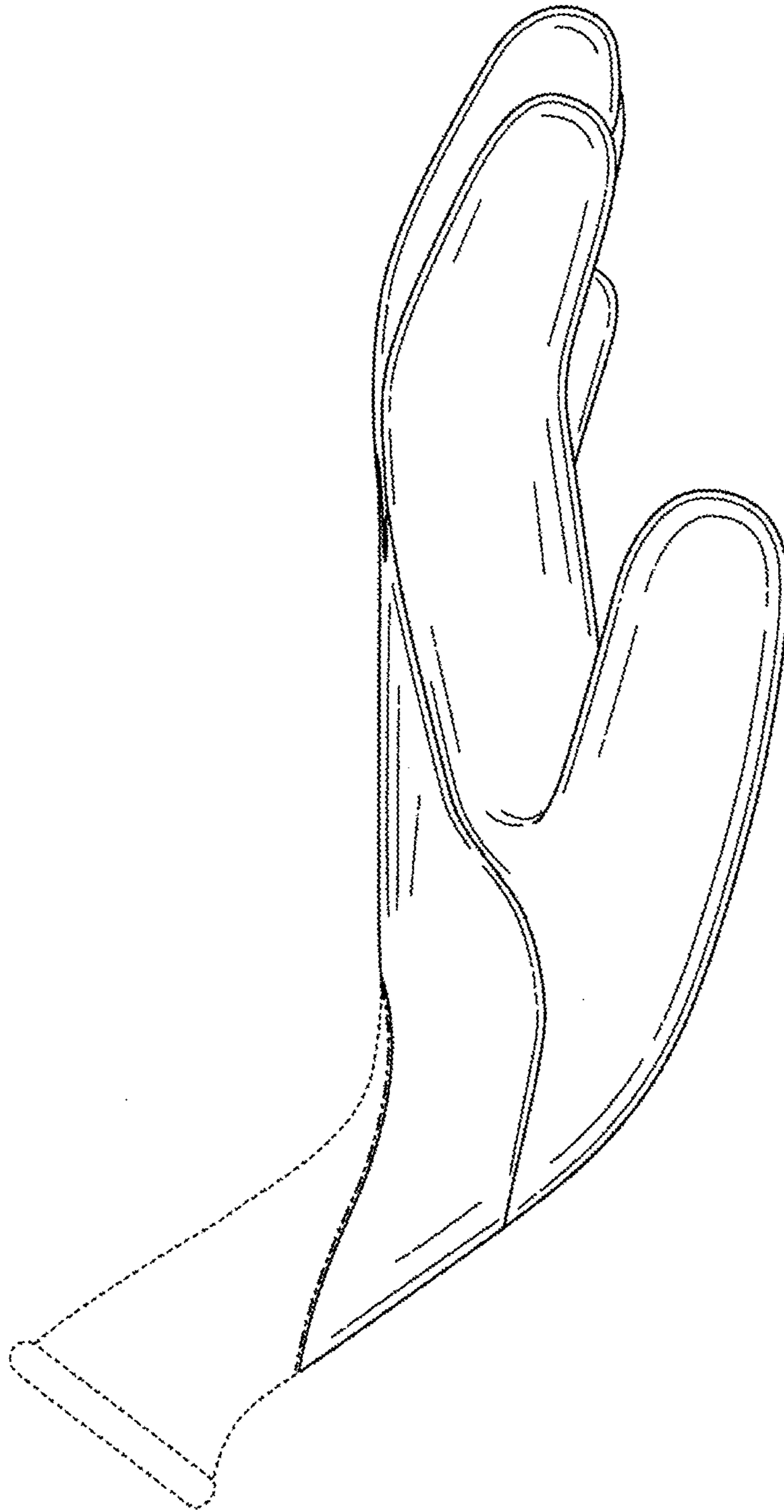

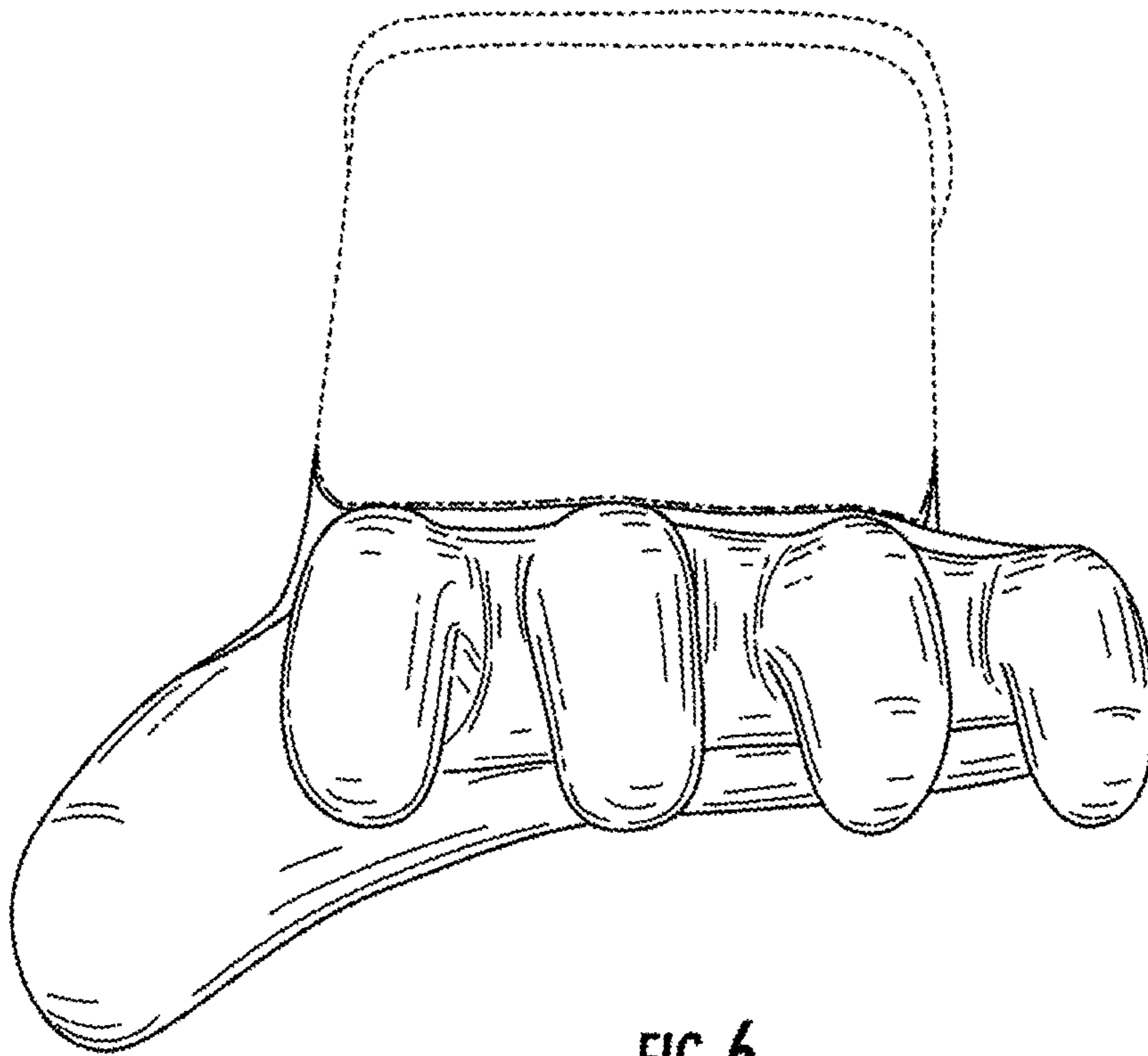

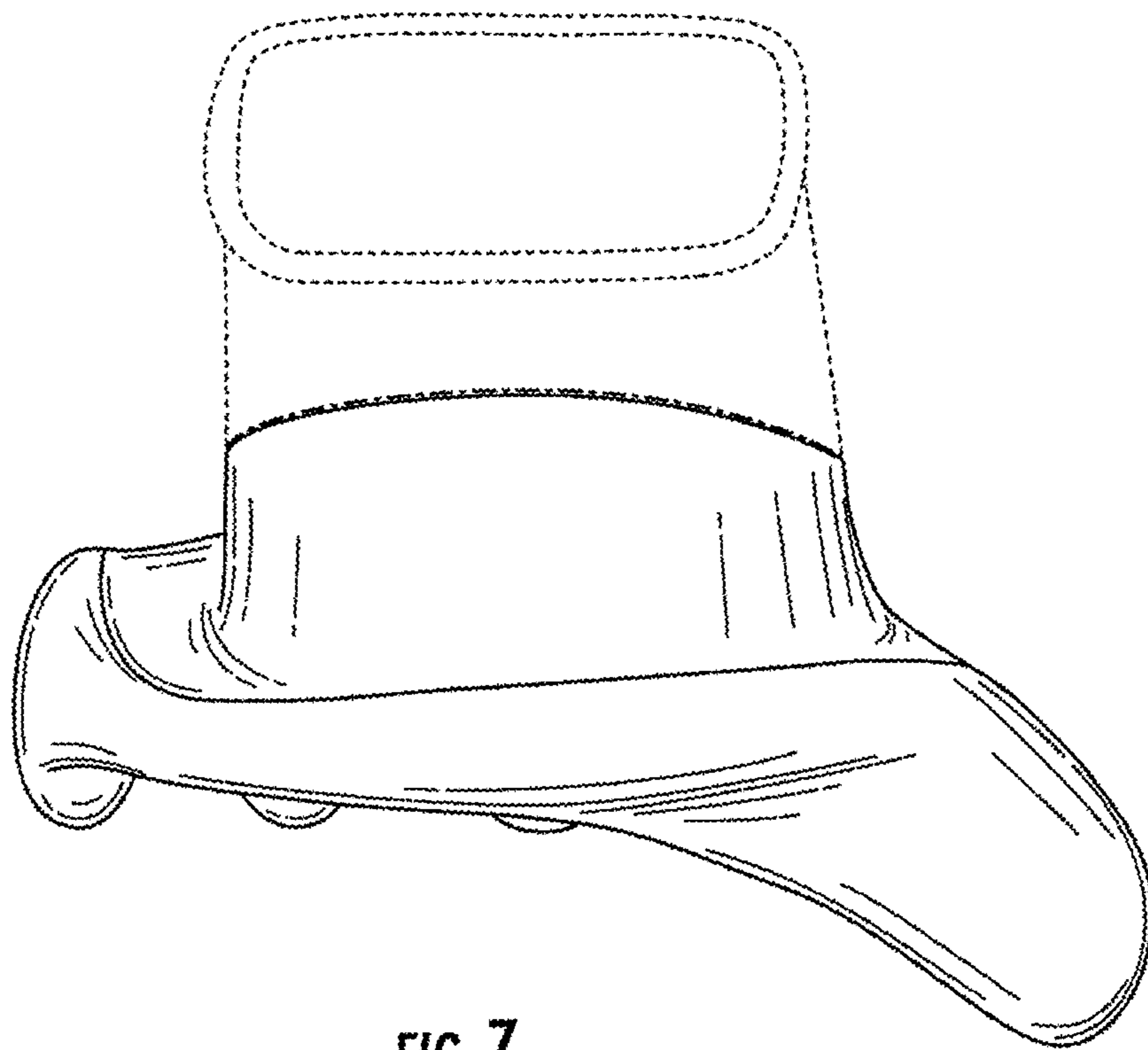

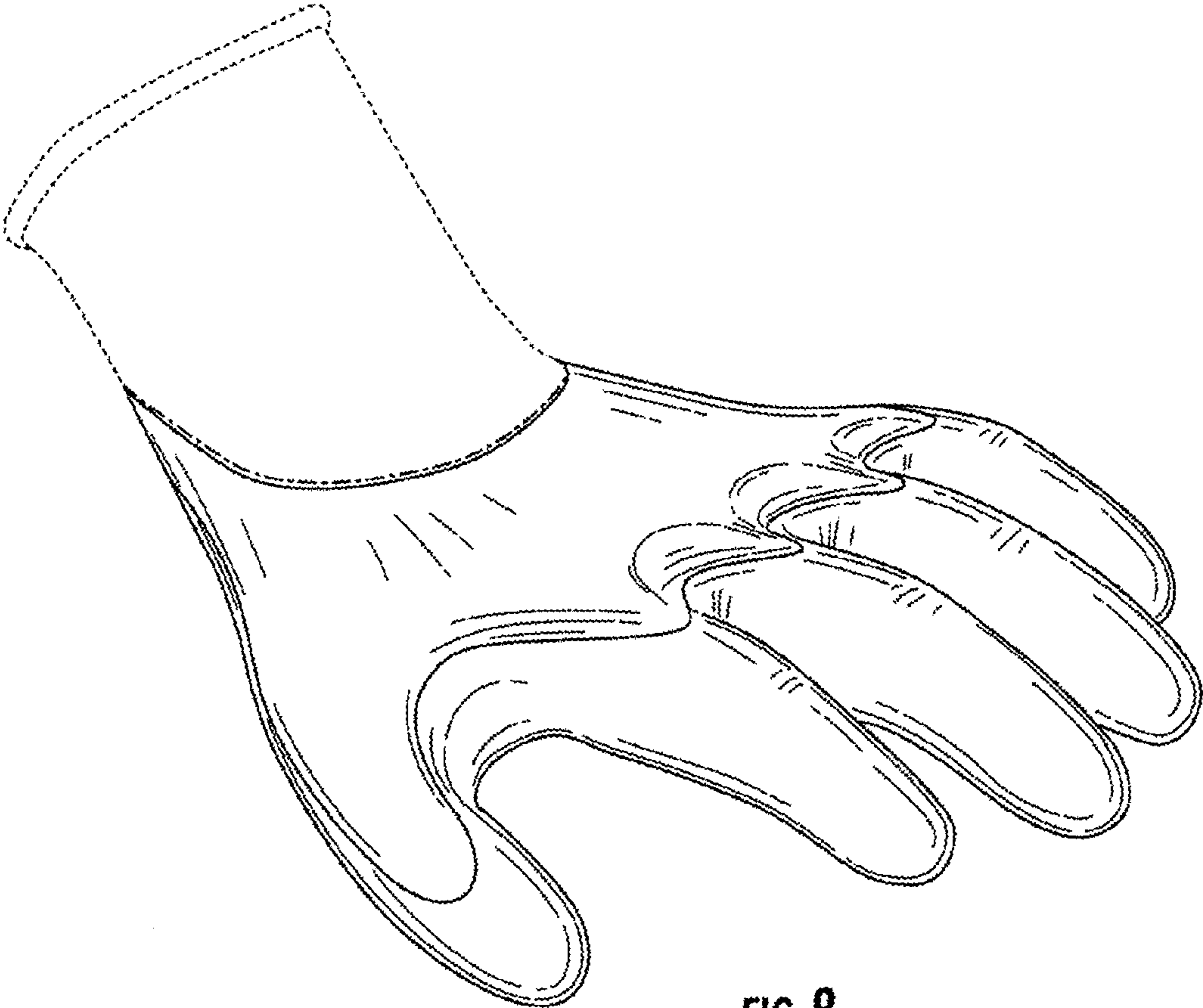

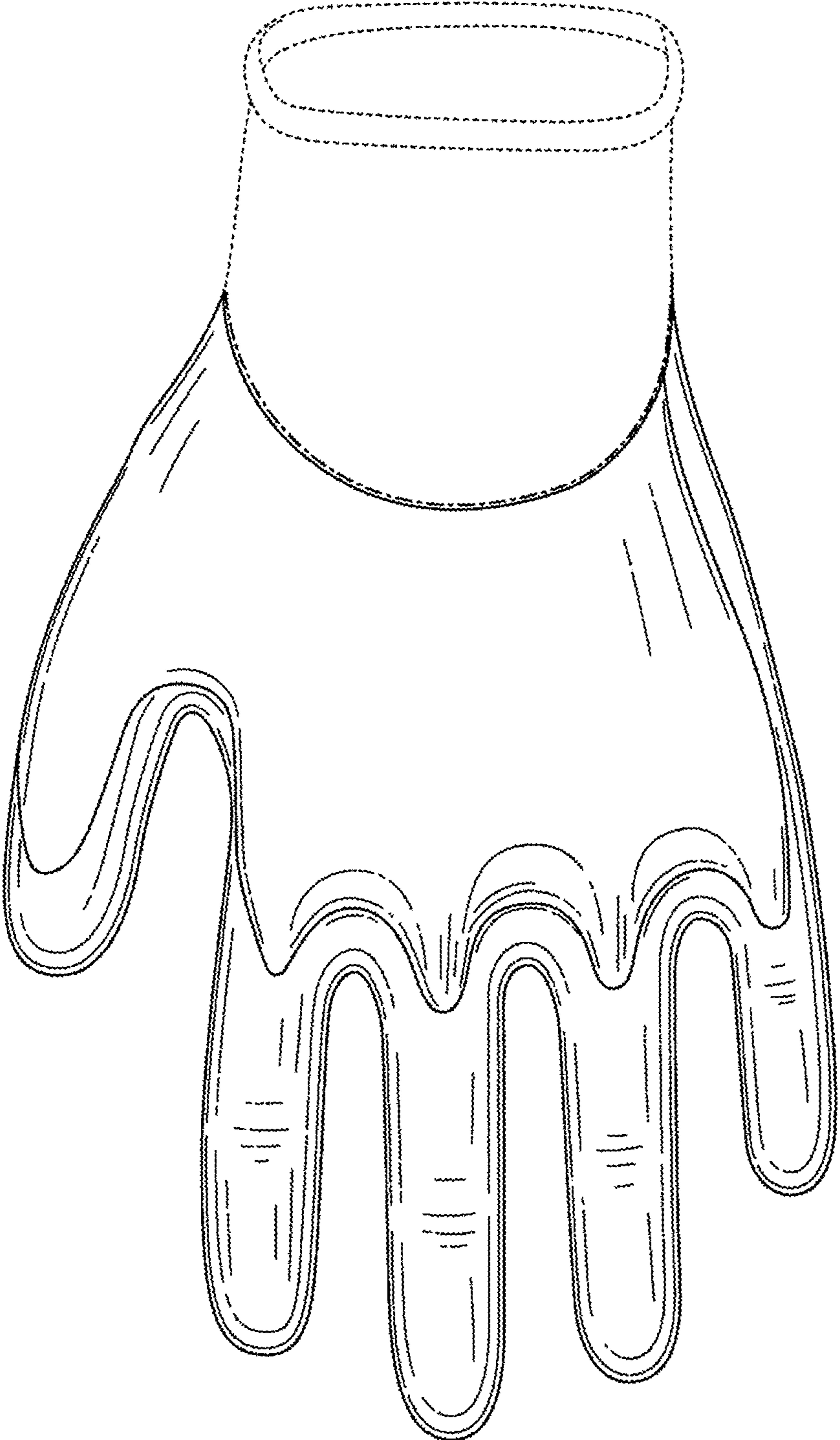

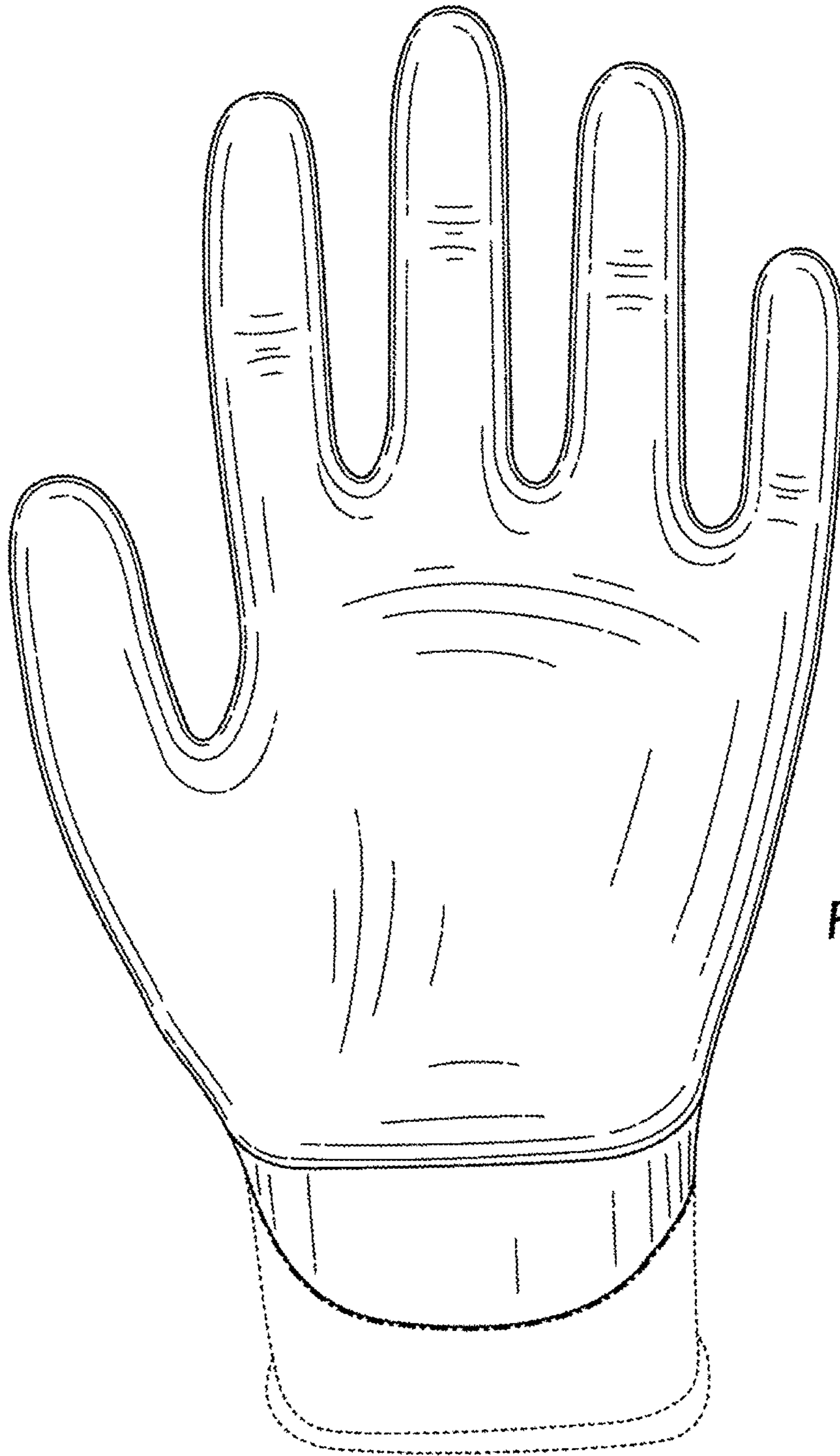

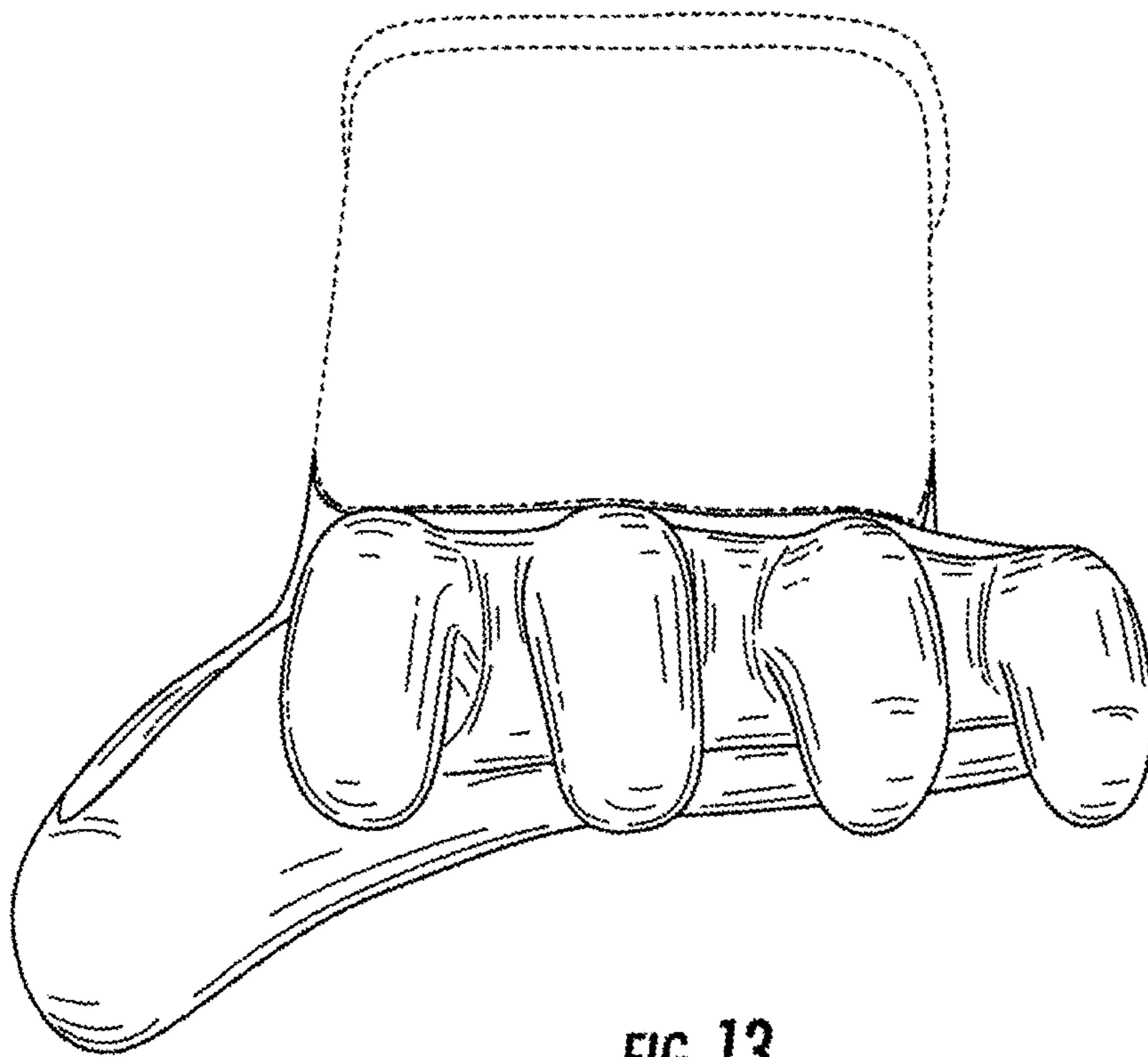

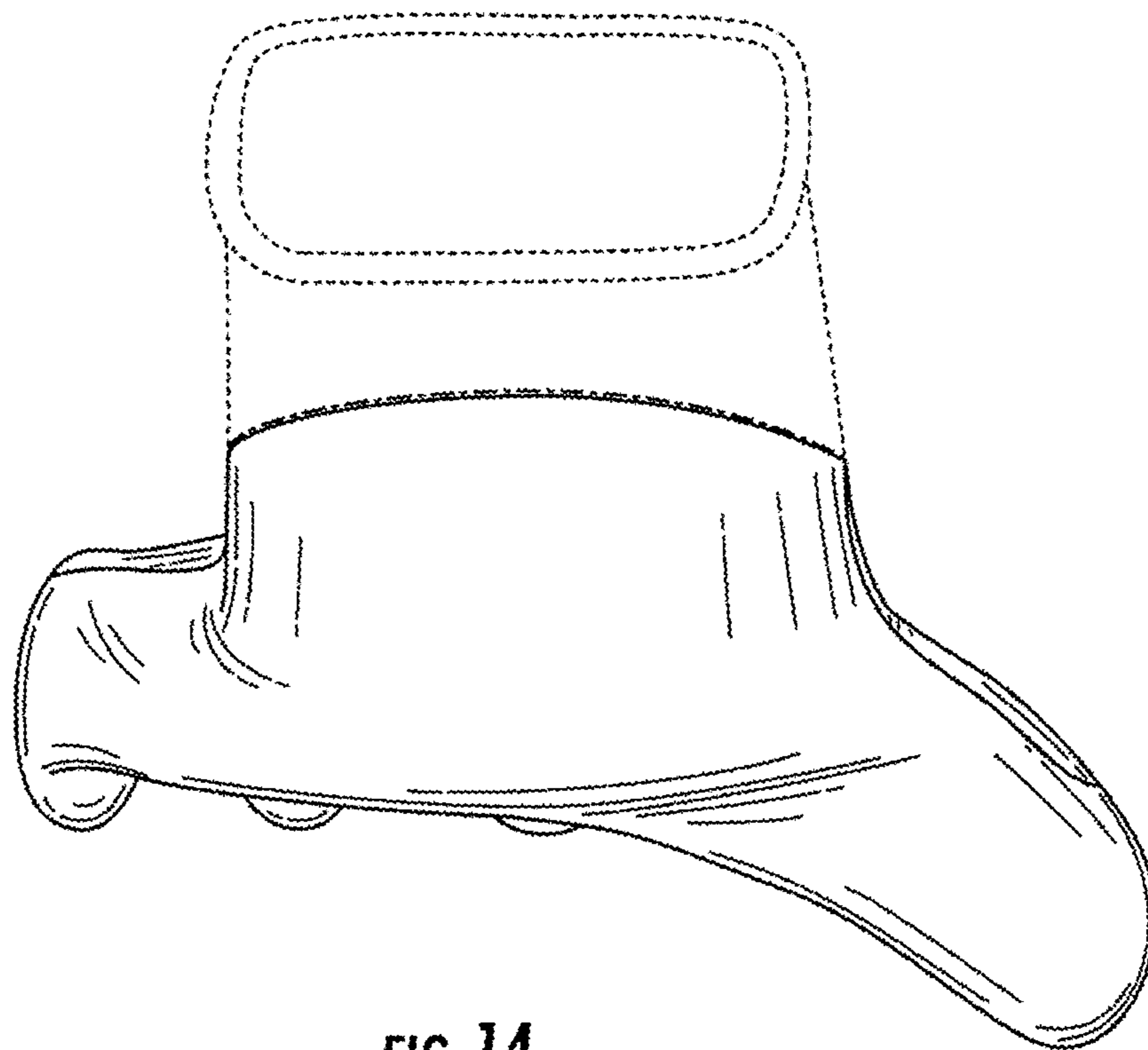
