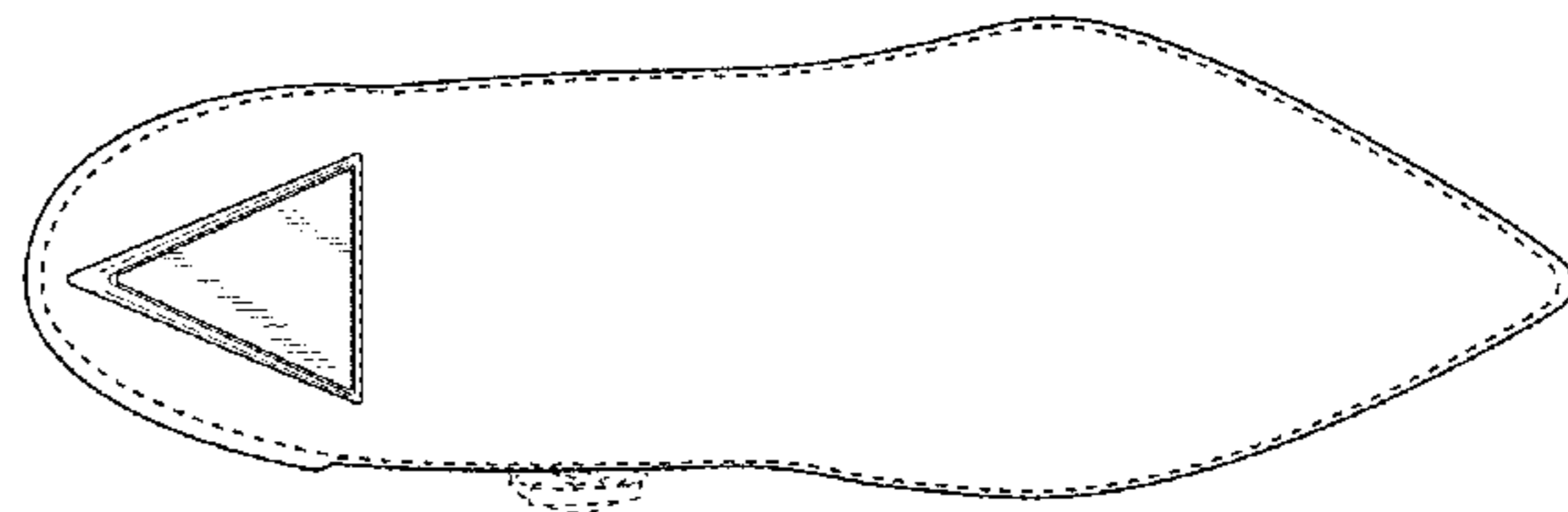
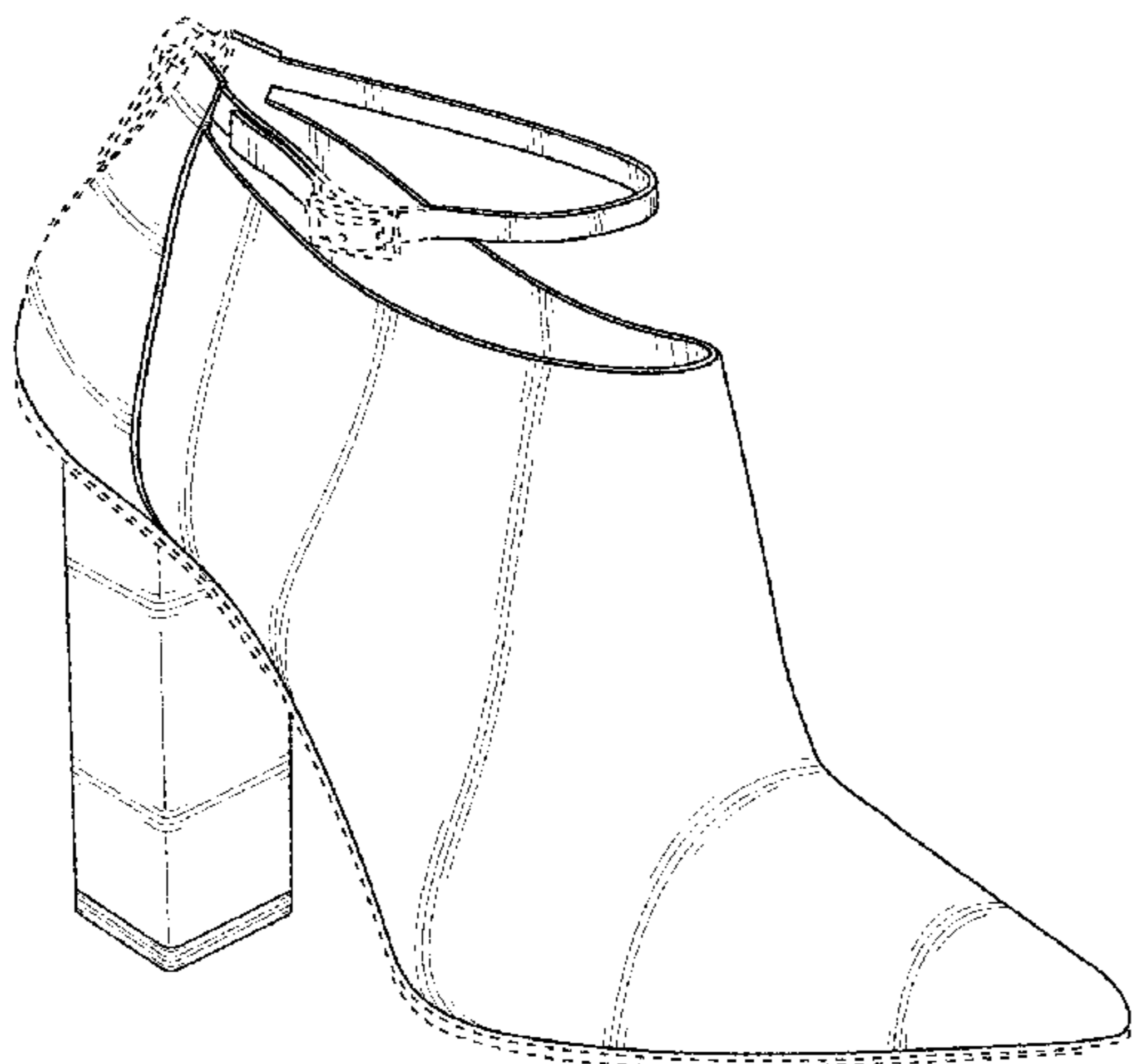
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of footwear showing my new design;
FIG. 2 is a right side view of the footwear shown in FIG. 1;

FIG. 4 is a front view of the footwear shown in FIG. 1;

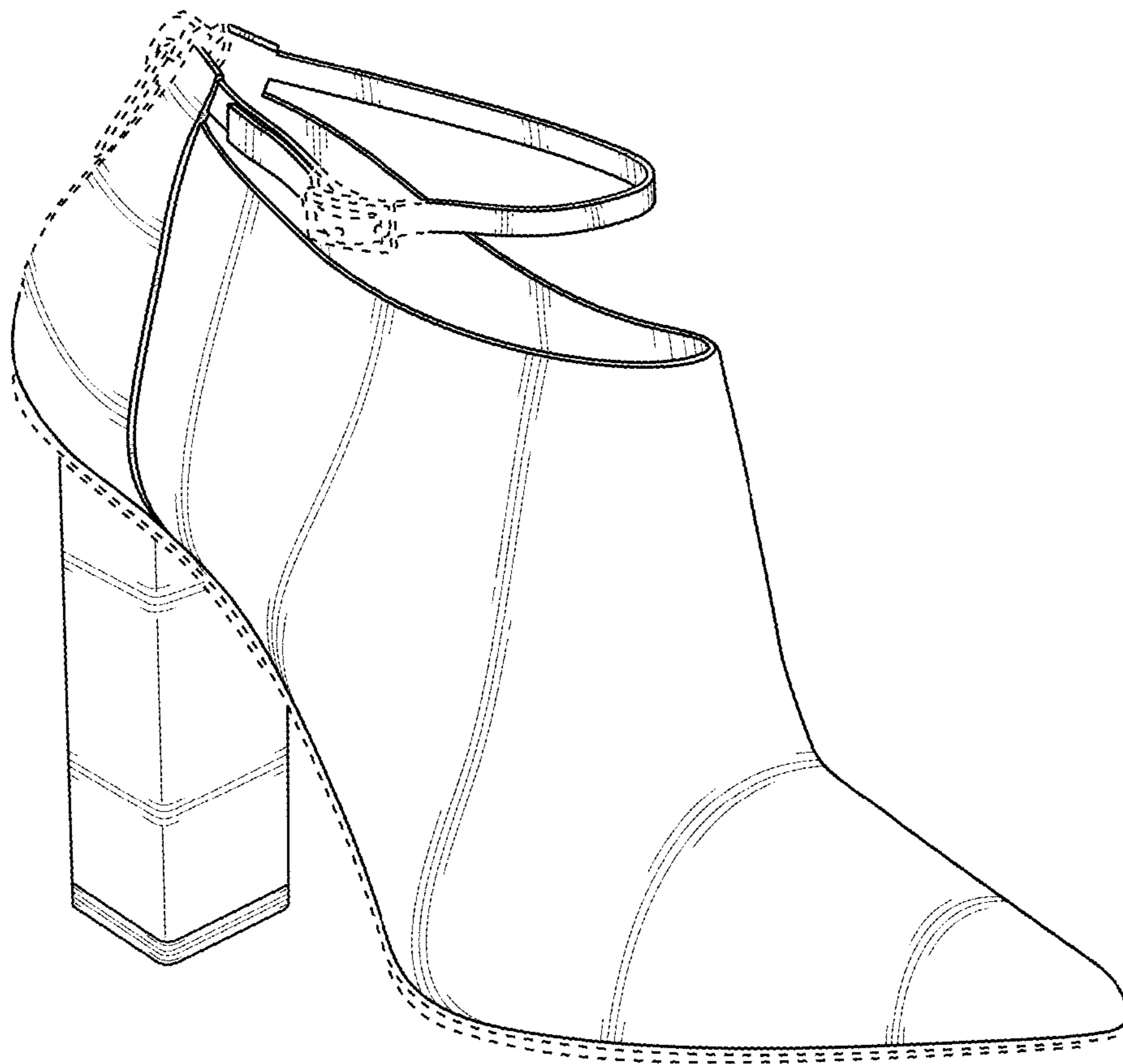

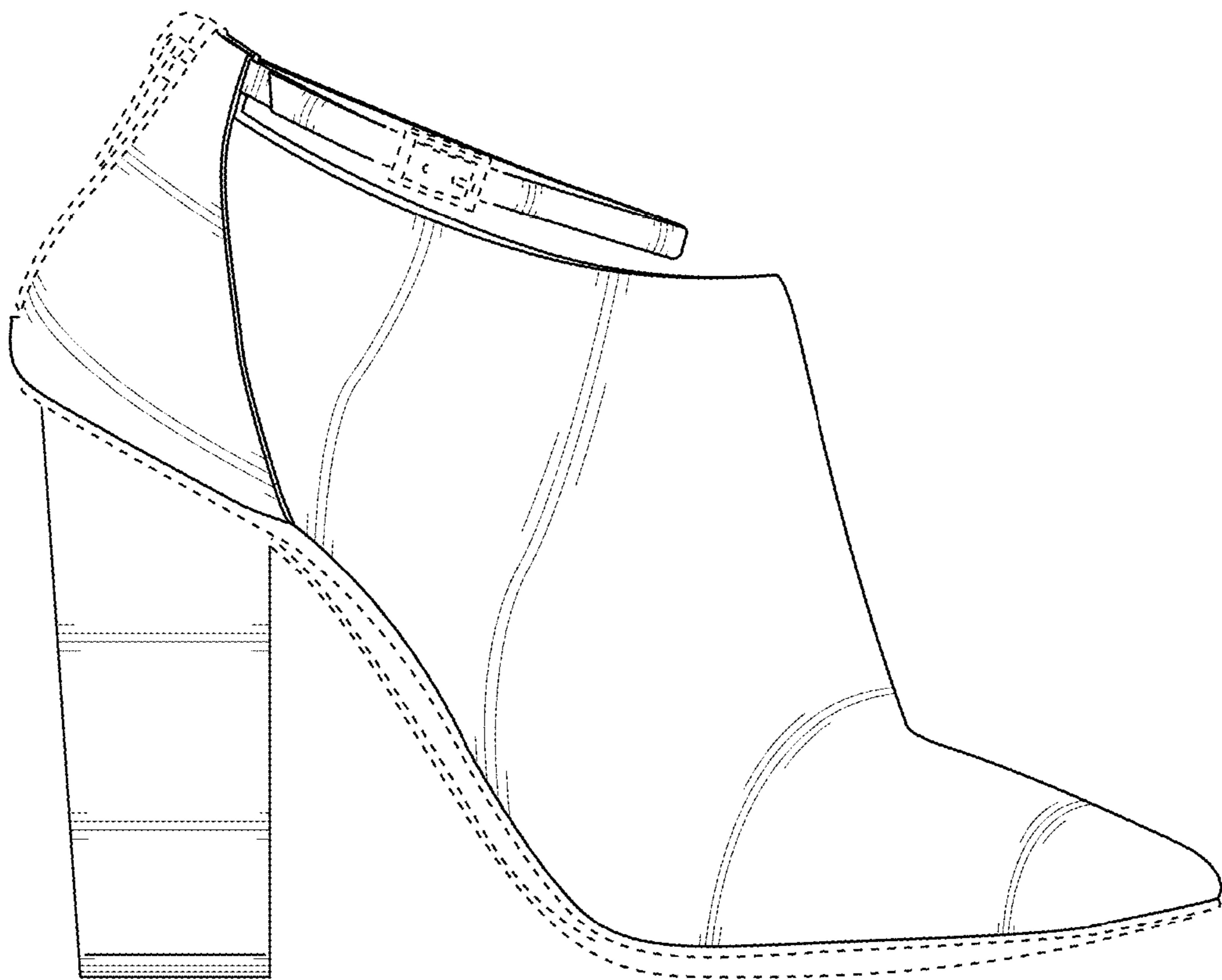

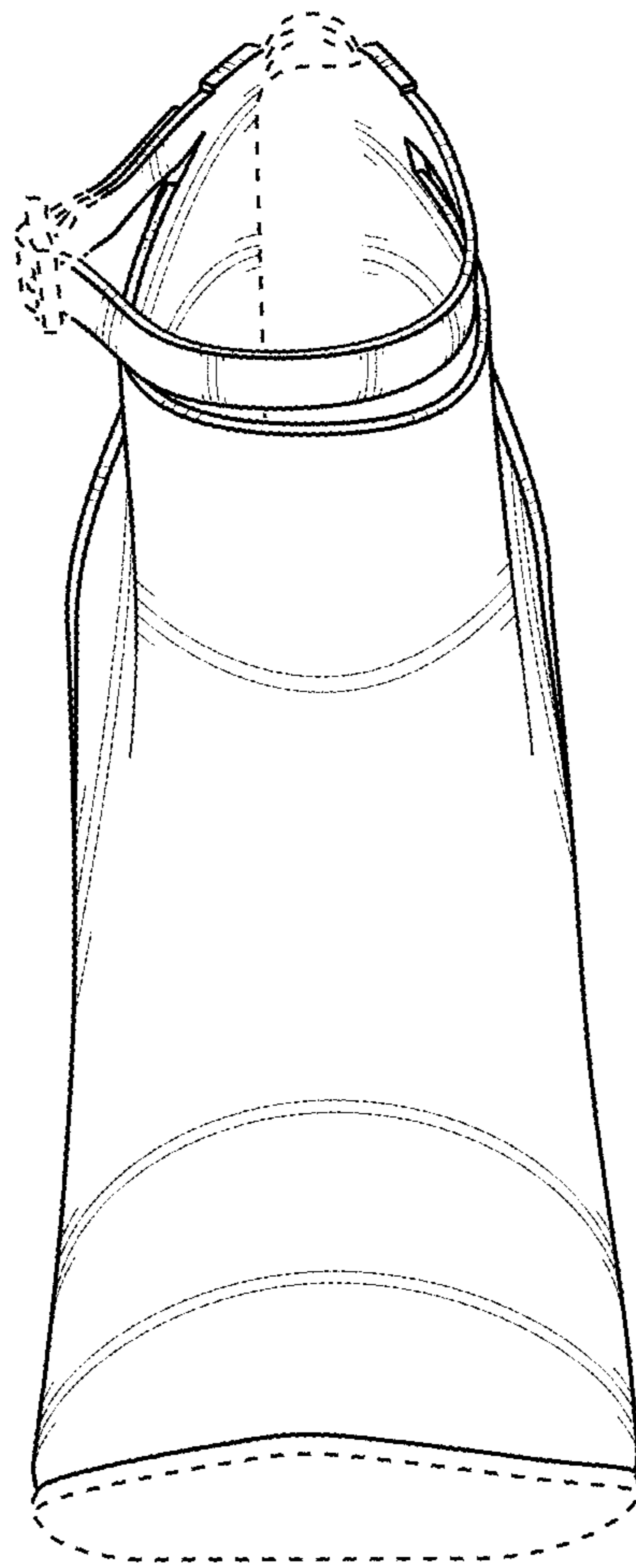

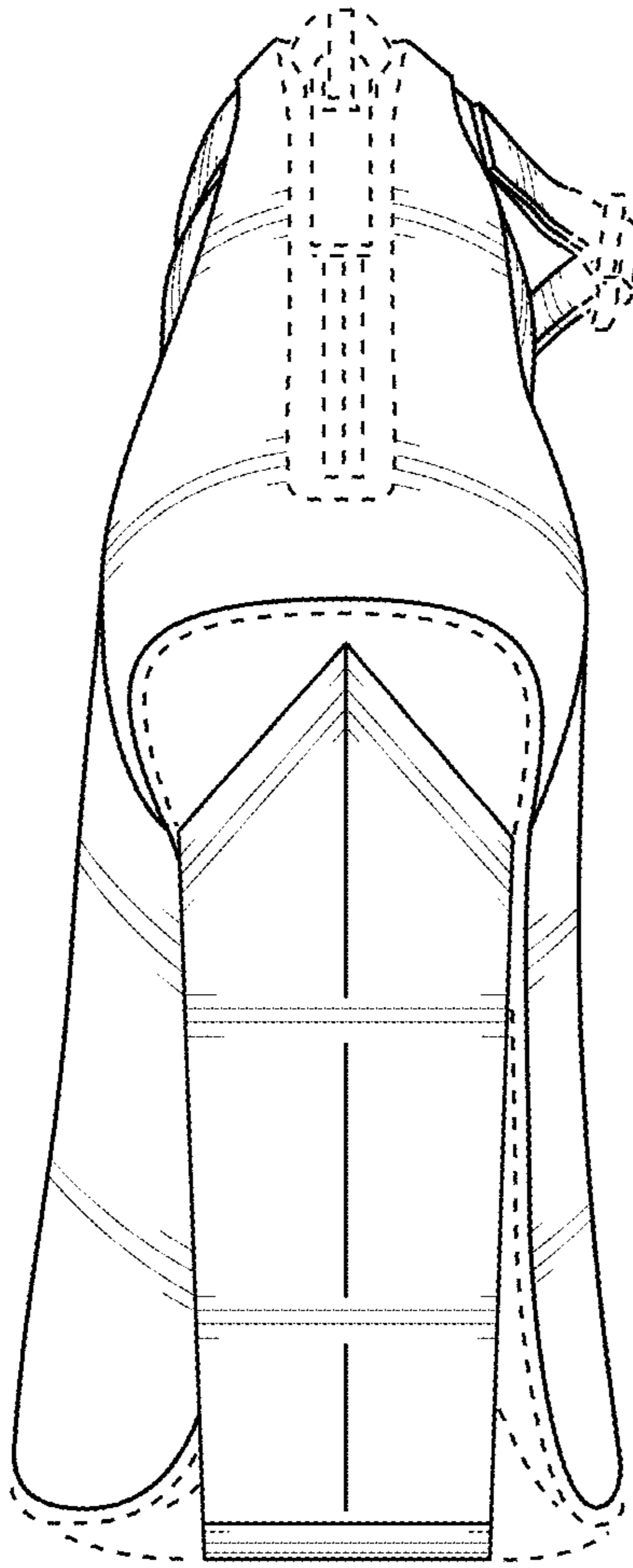

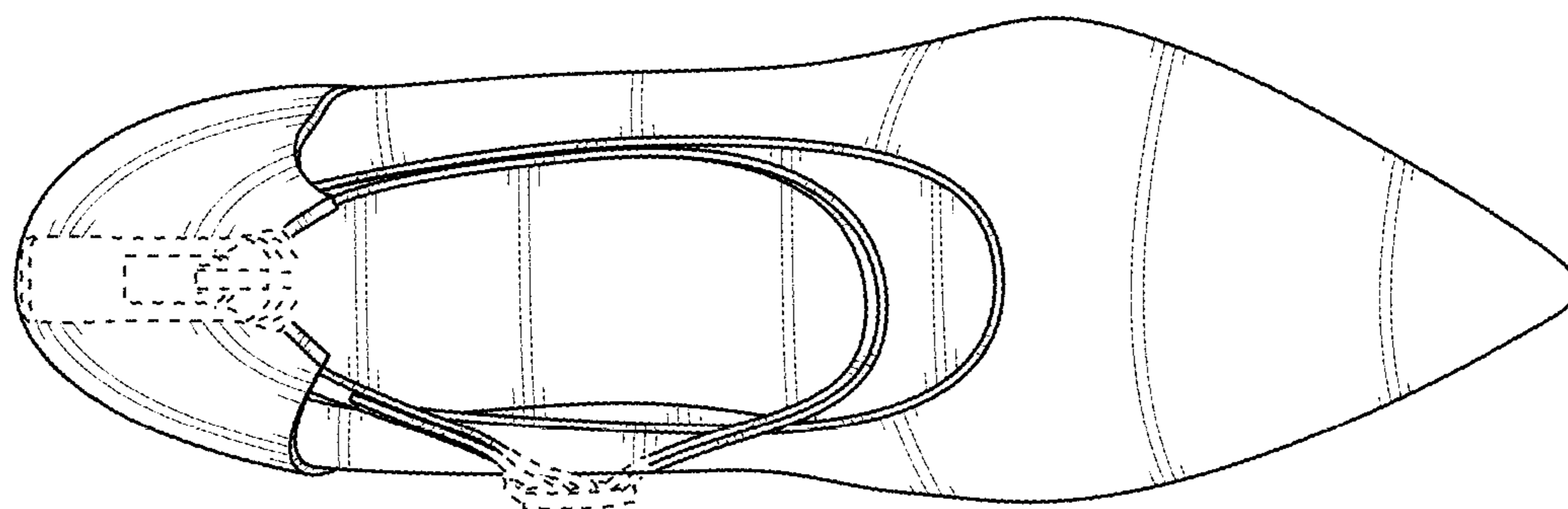

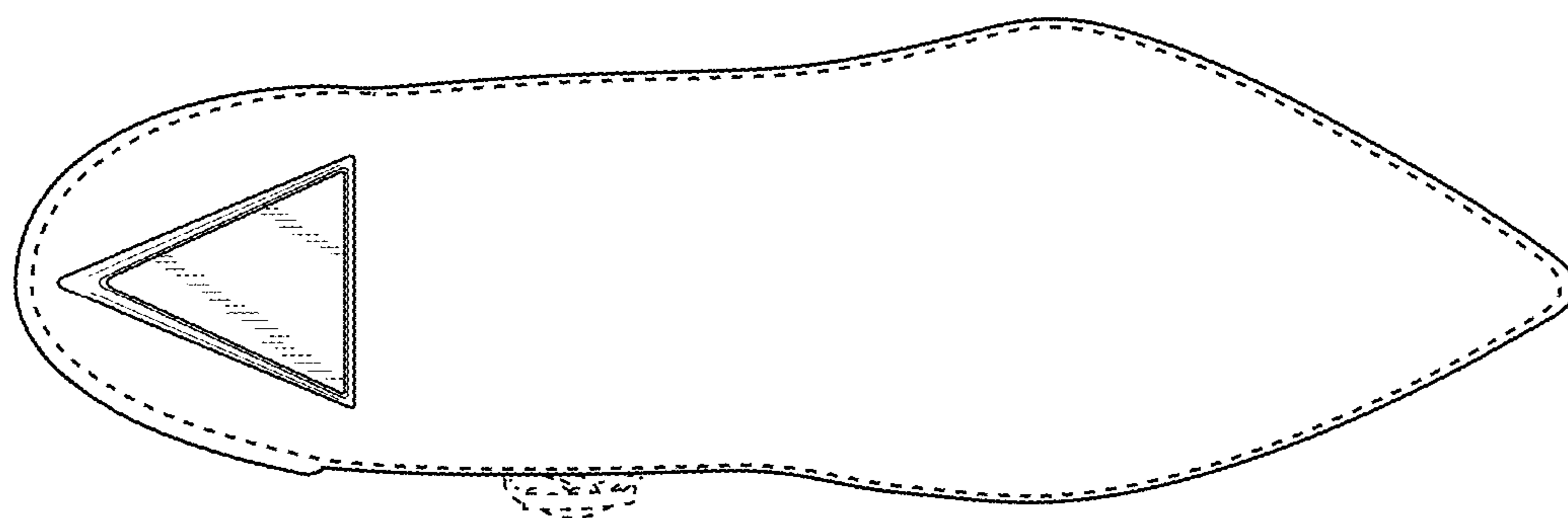
