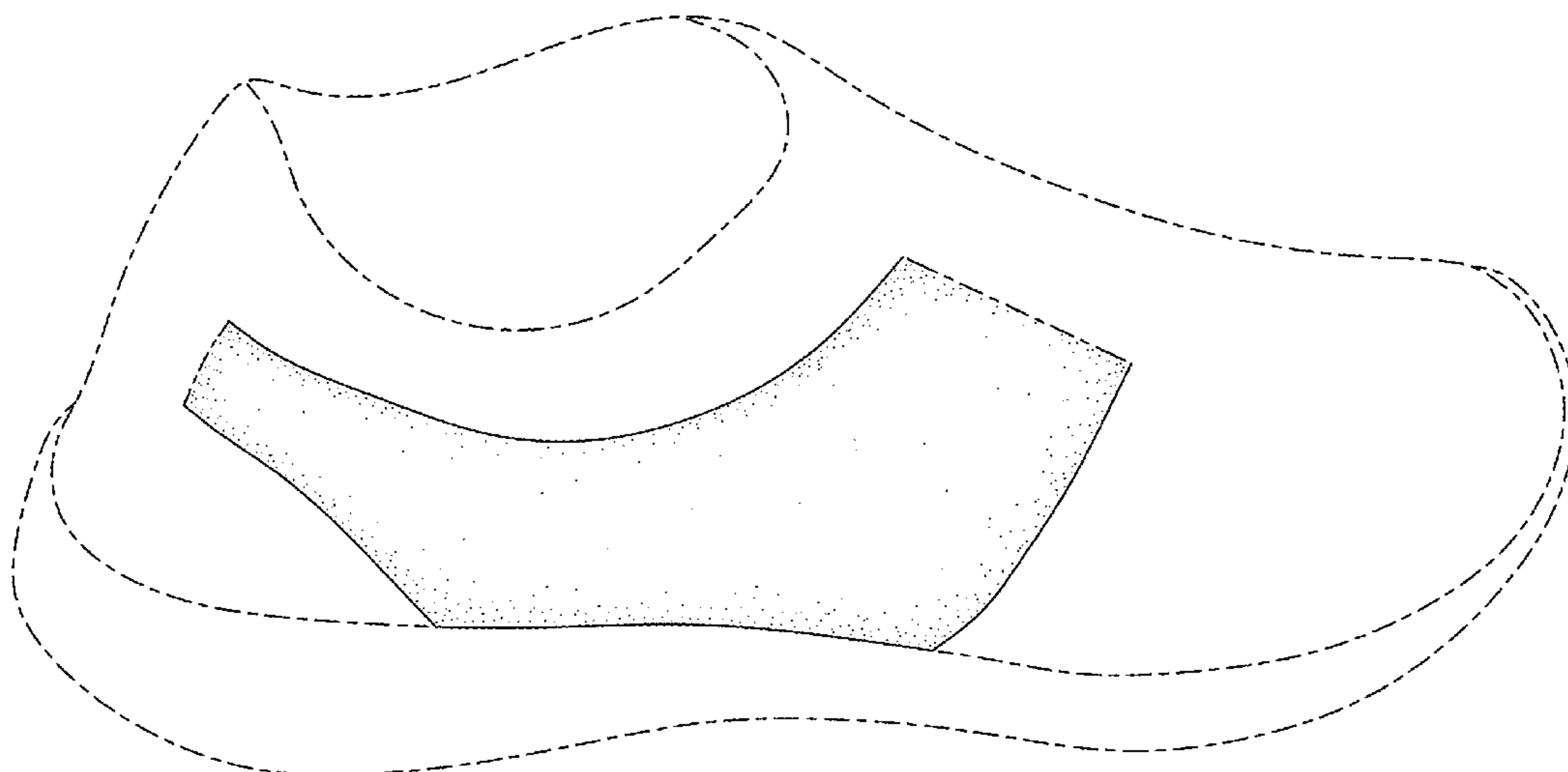

**DESCRIPTION**

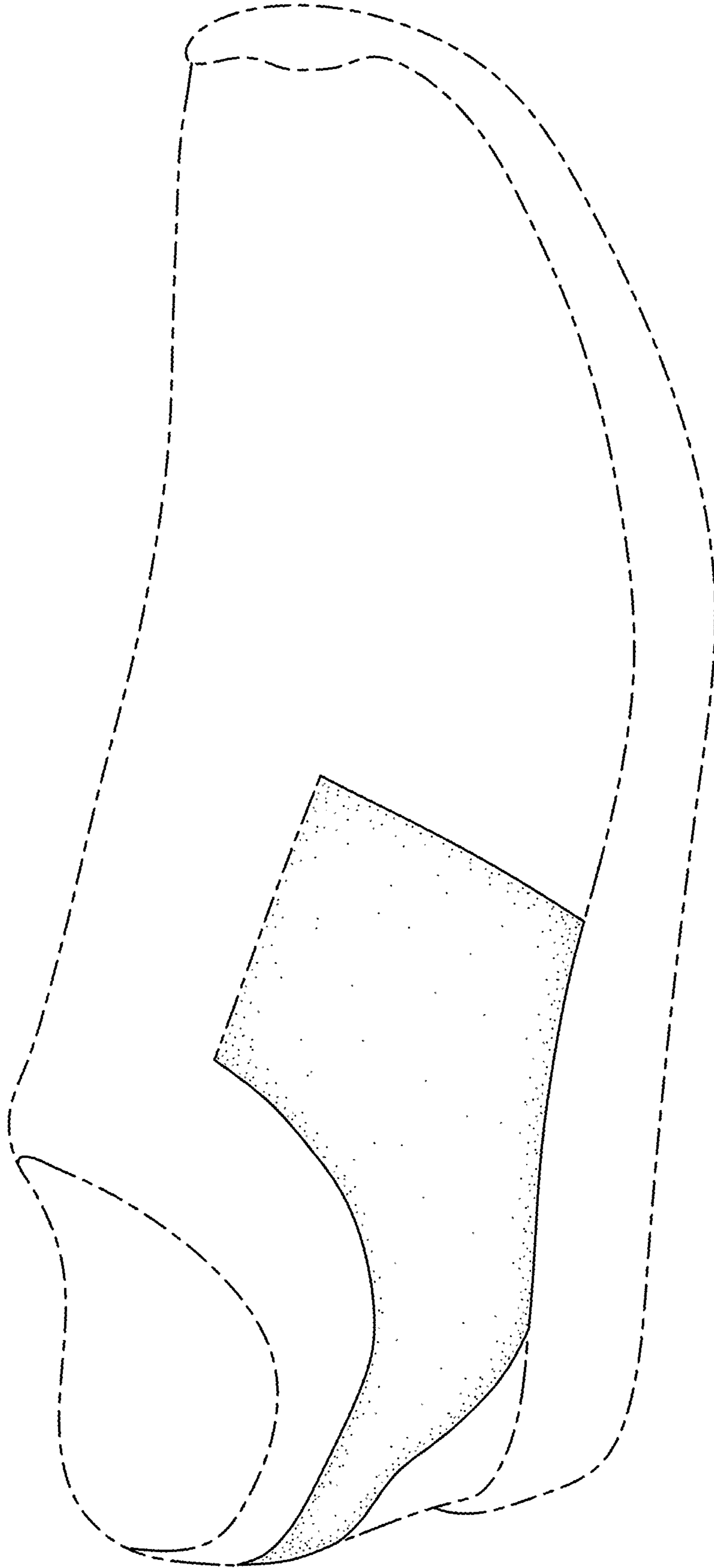

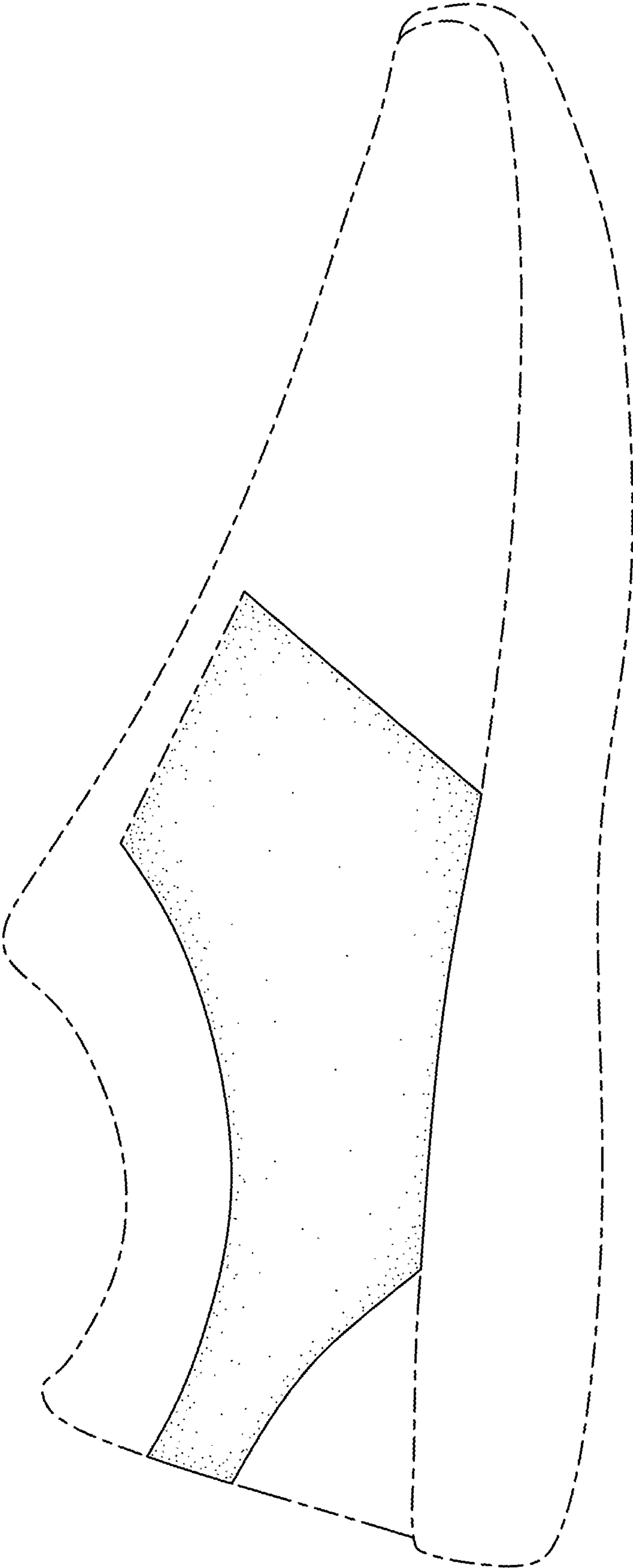

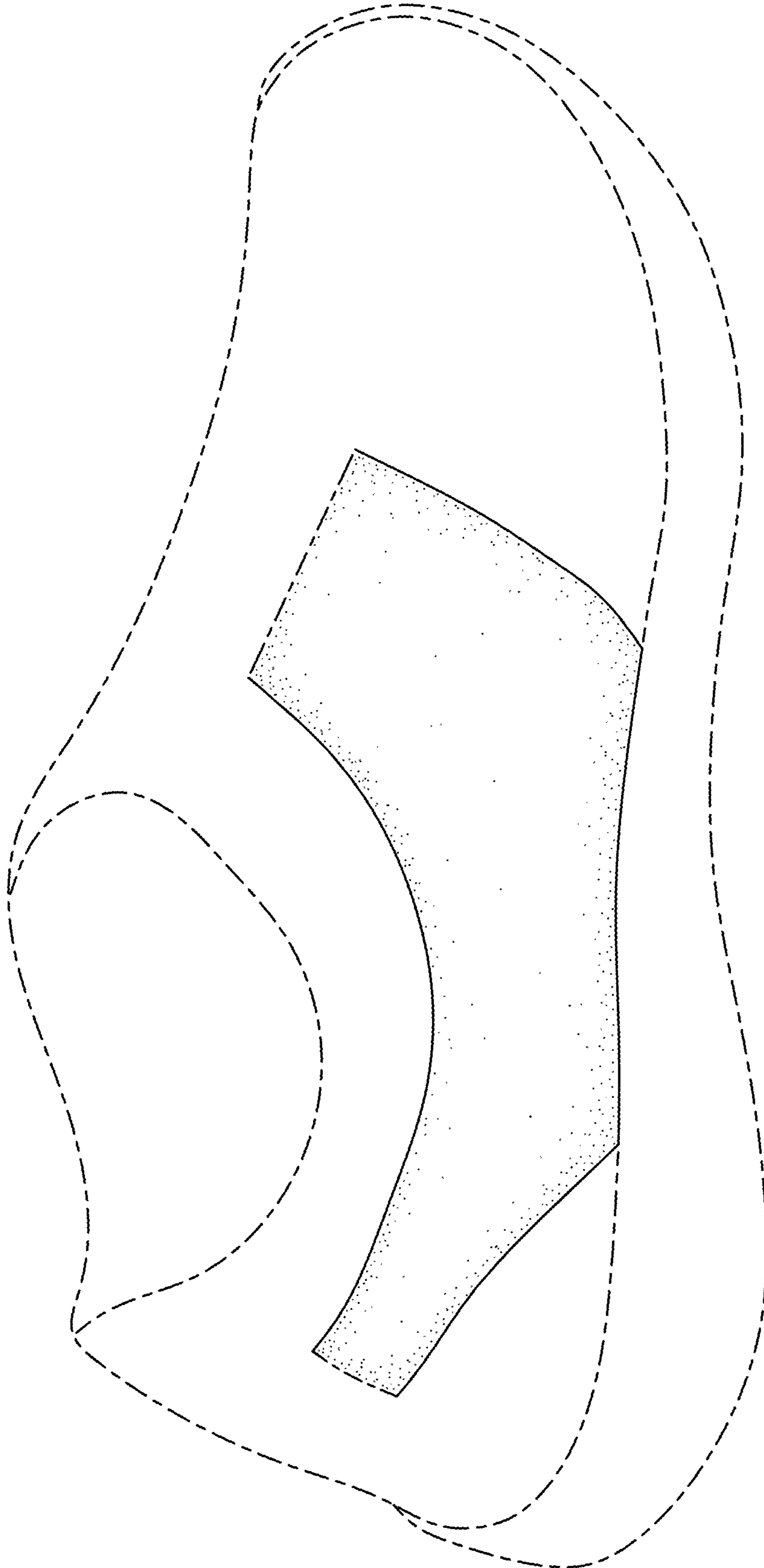
