(57) **CLAIM**

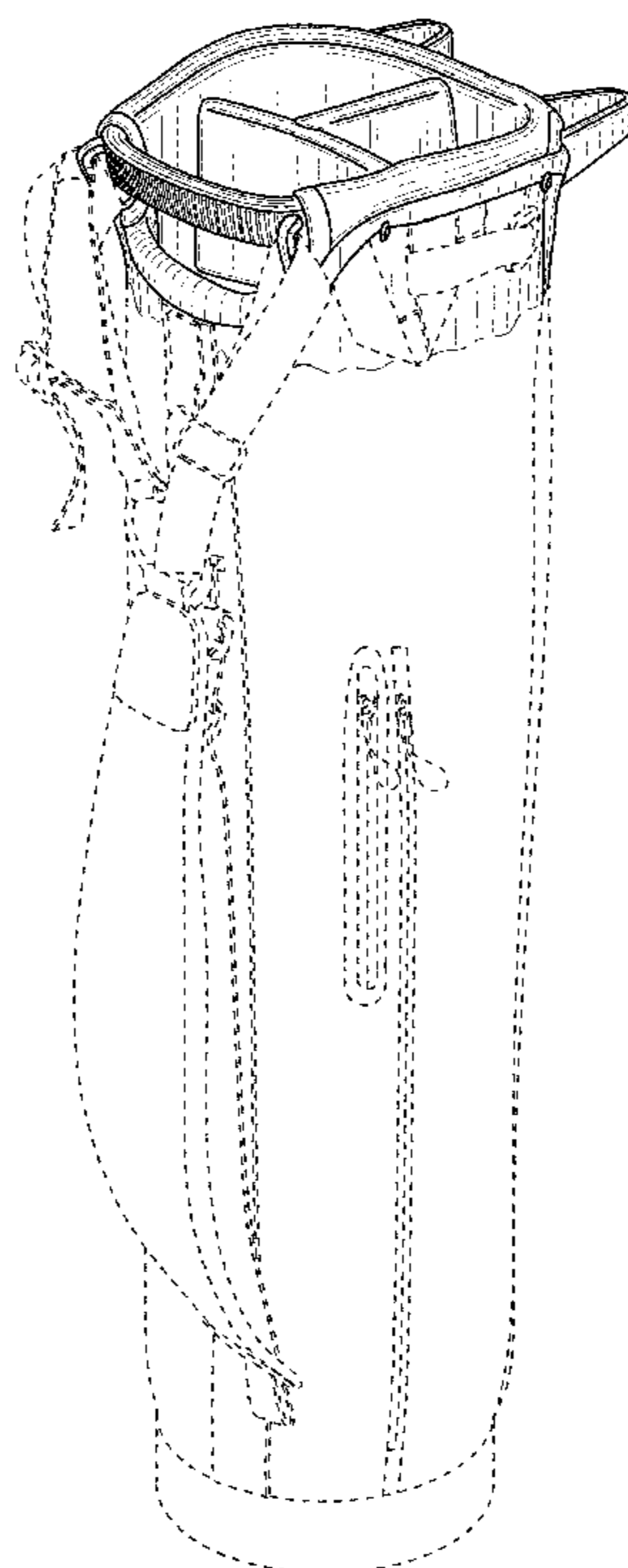
The ornamental design for a golf bag top, as shown and described.

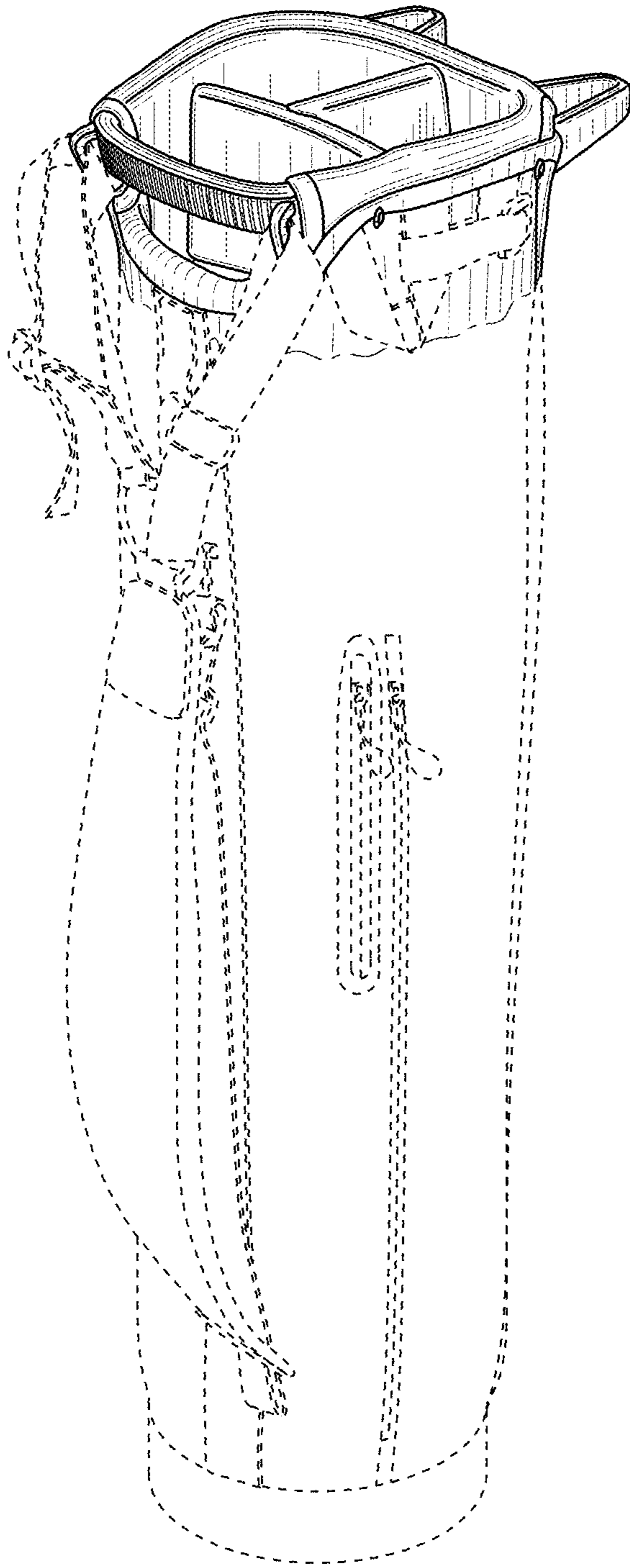

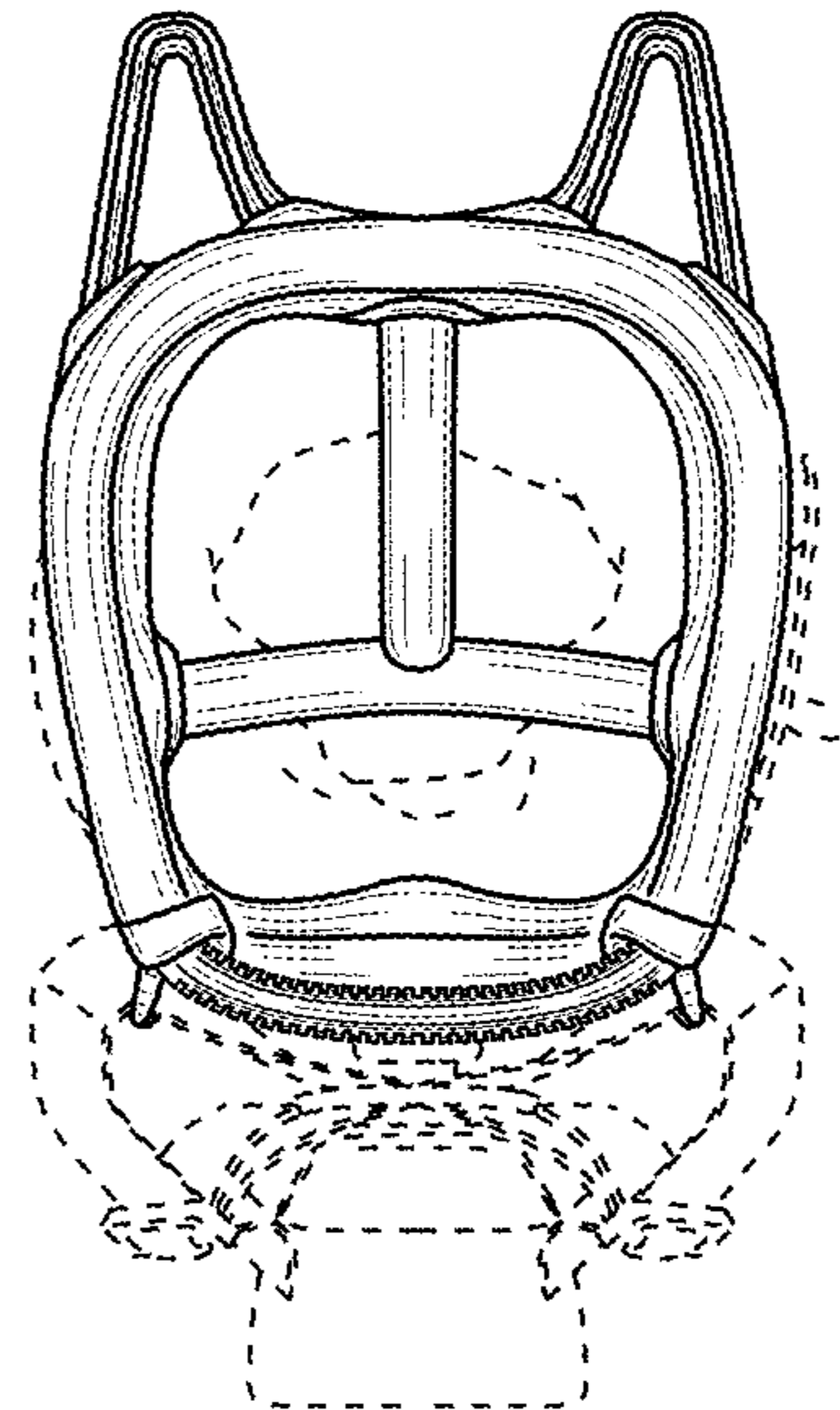

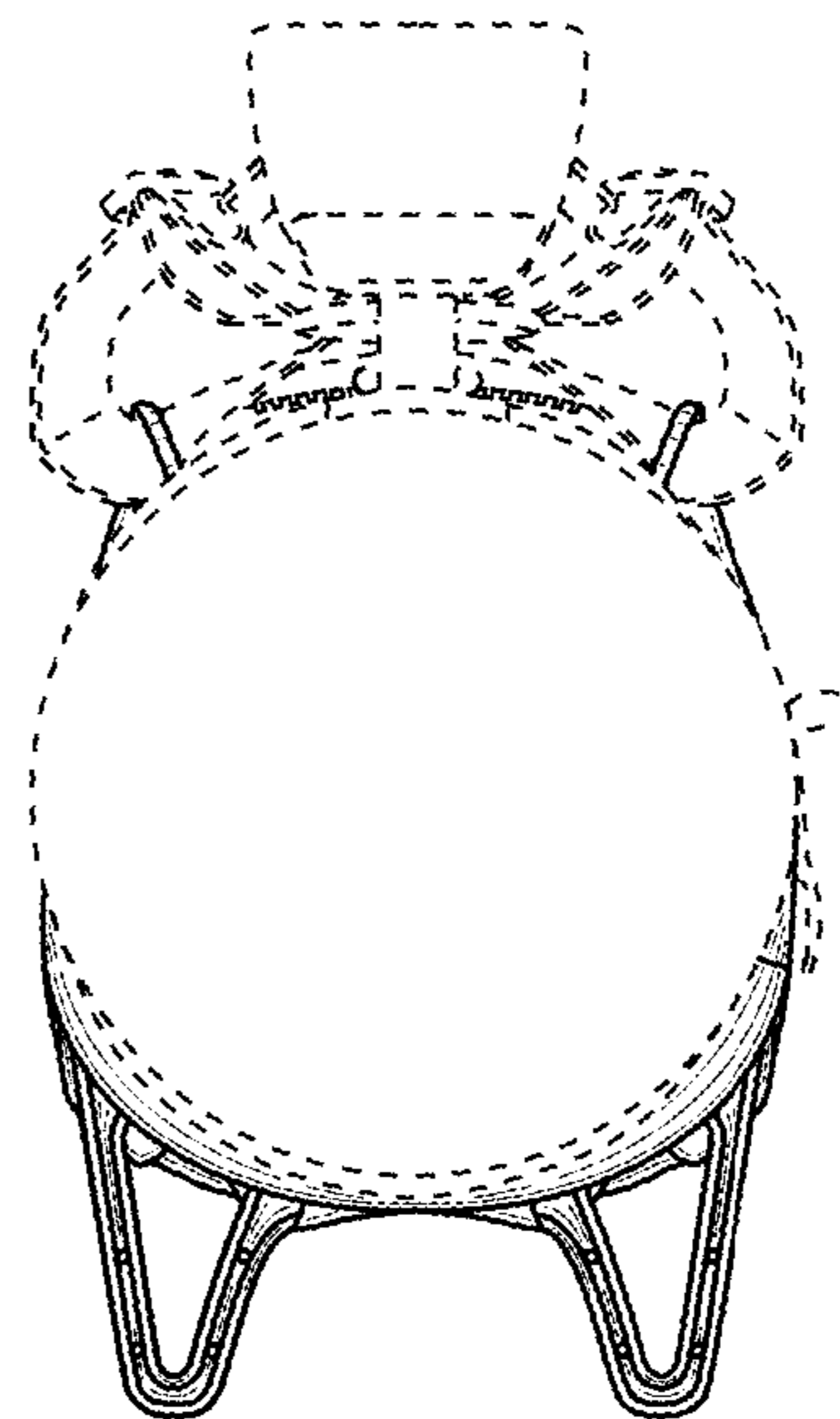

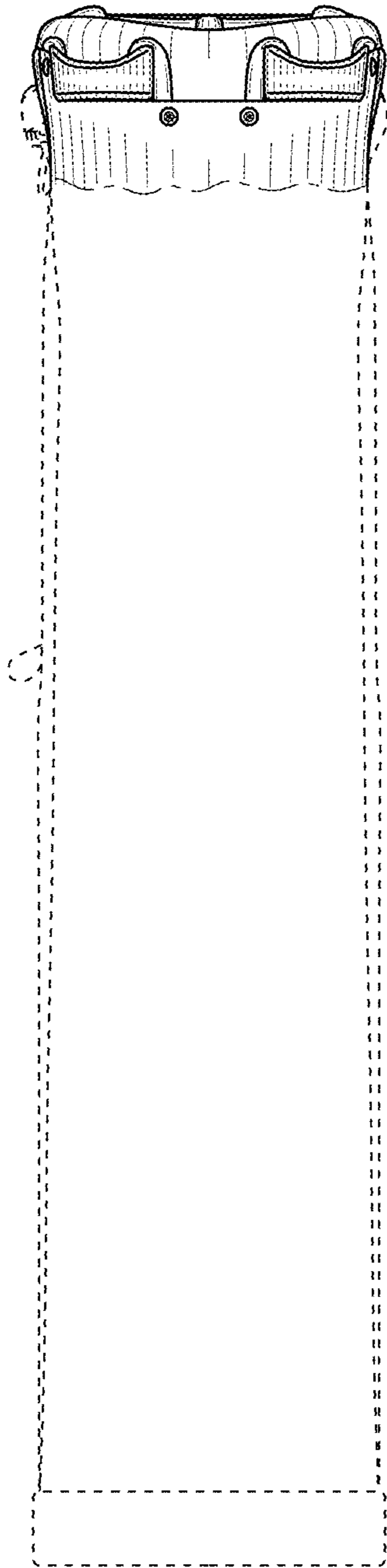

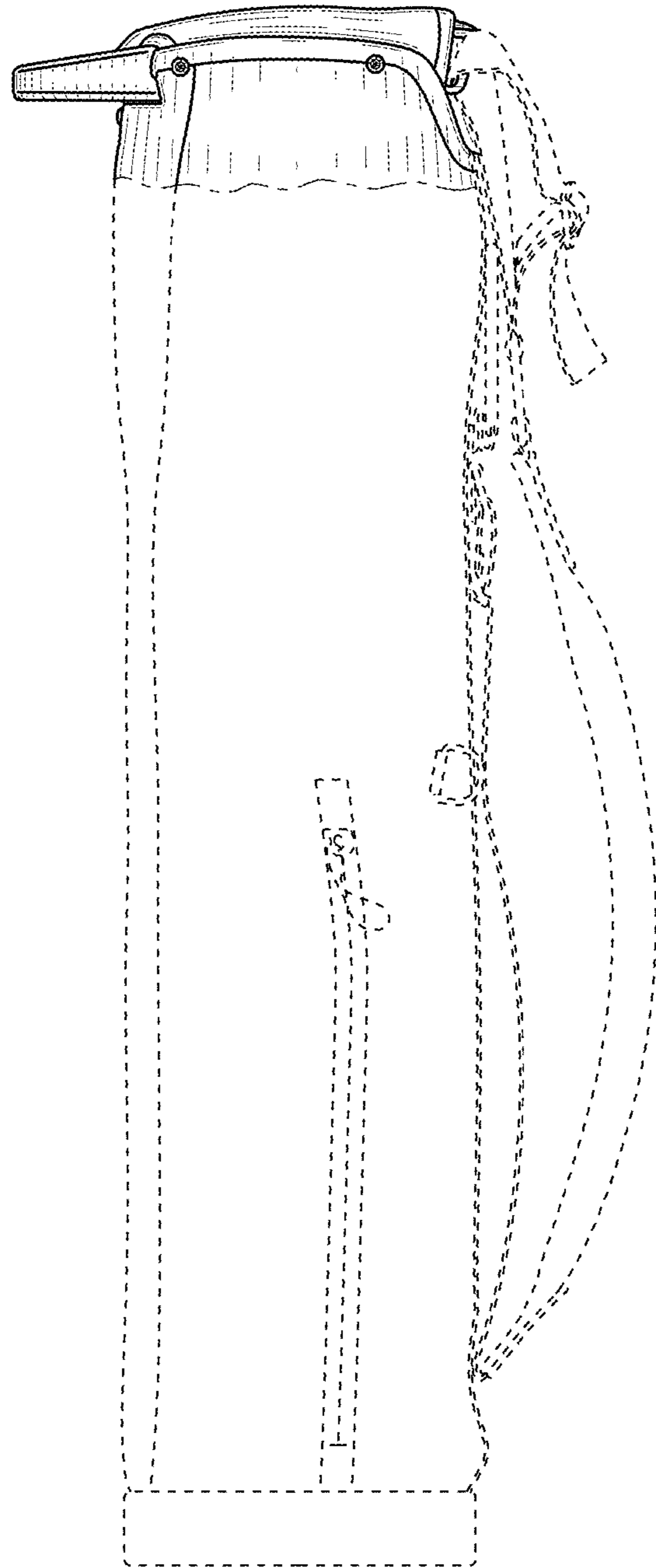

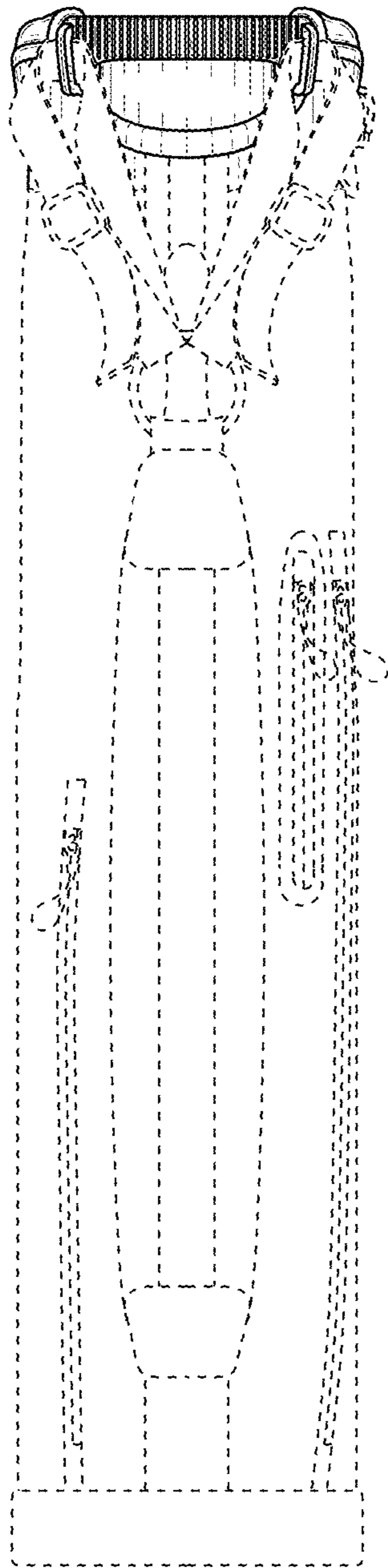

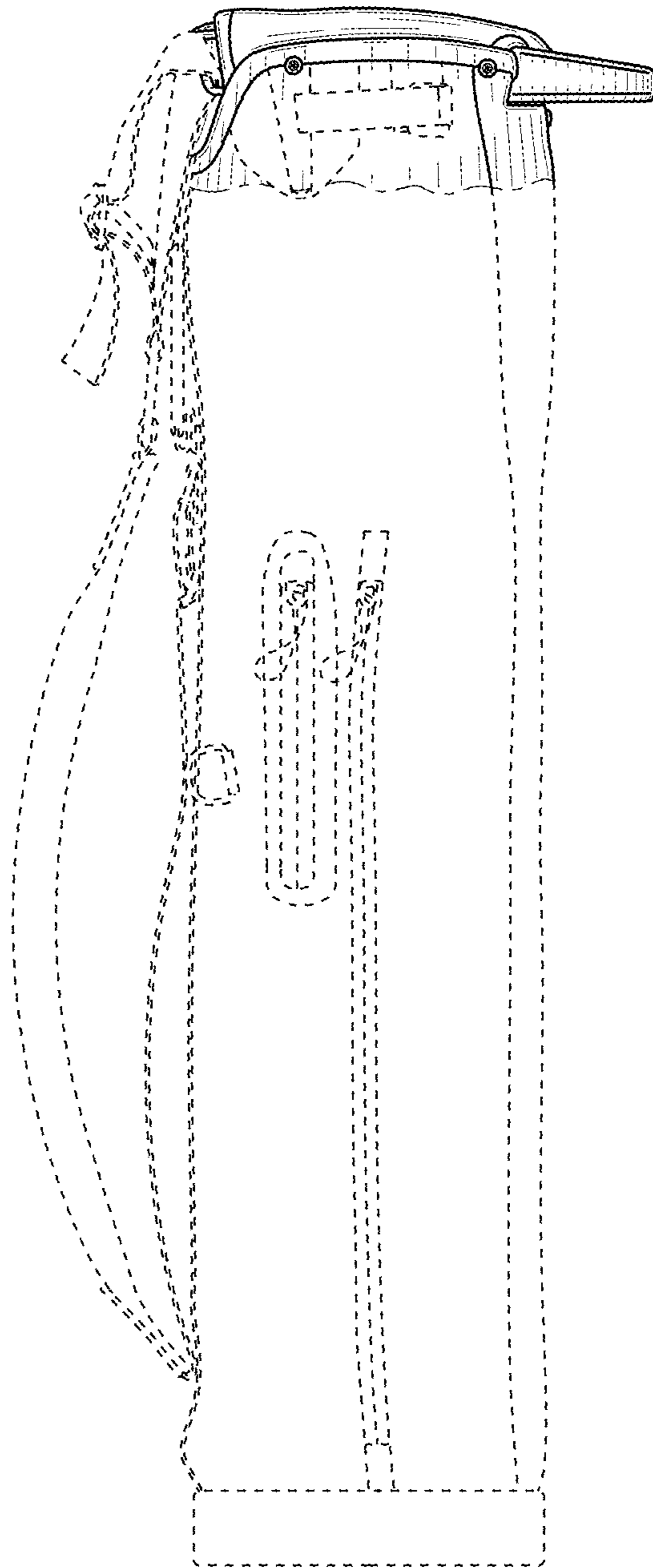
