(57) **CLAIM**
The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag showing my new design;
FIG. 2 is a front view of the handbag shown in FIG. 1;
FIG. 3 is a back view of the handbag shown in FIG. 1;
FIG. 4 is a left side view of the handbag shown in FIG. 1 (with the right side view being a mirror image thereof);
FIG. 5 is a top view of the handbag shown in FIG. 1; and,
FIG. 6 is a bottom view of the handbag shown in FIG. 1.
The broken lines showing portions of the handbag, handle, and handle rings depict environmental subject matter that forms no part of the claim.

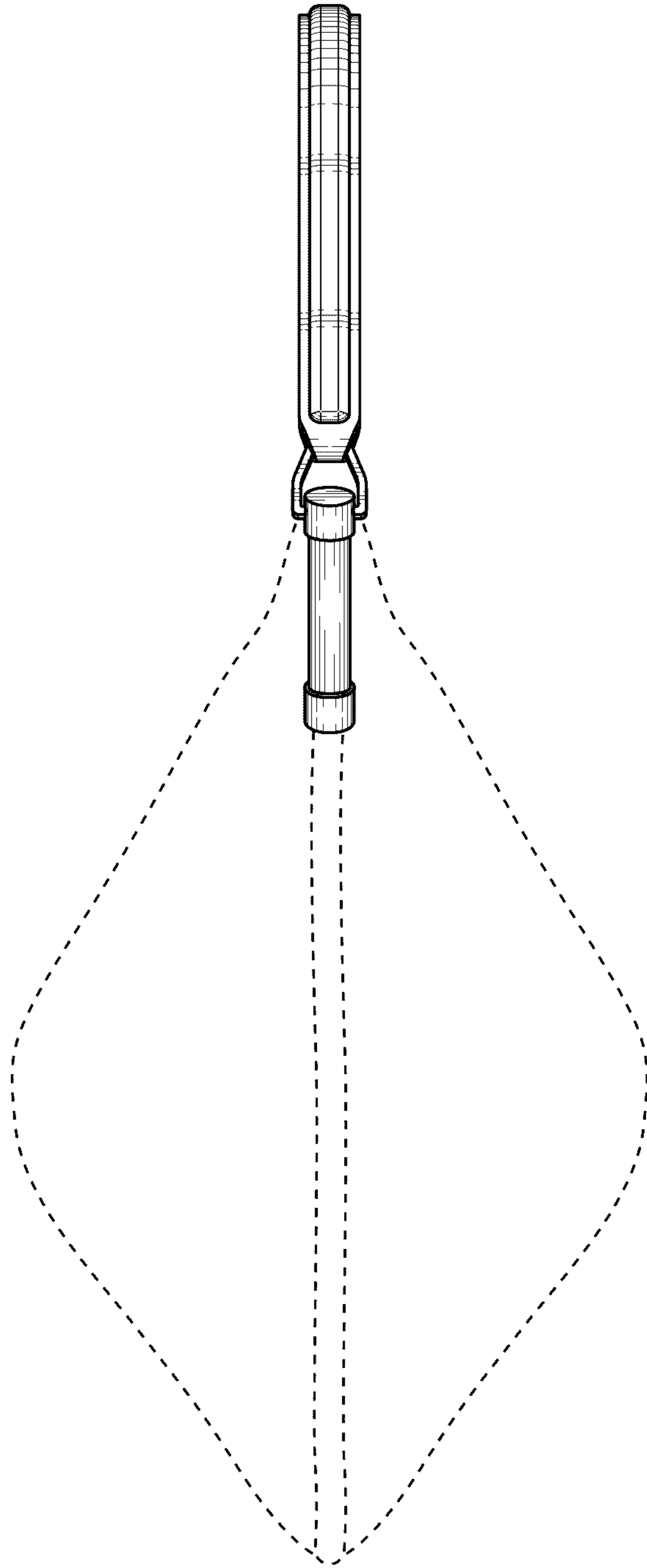

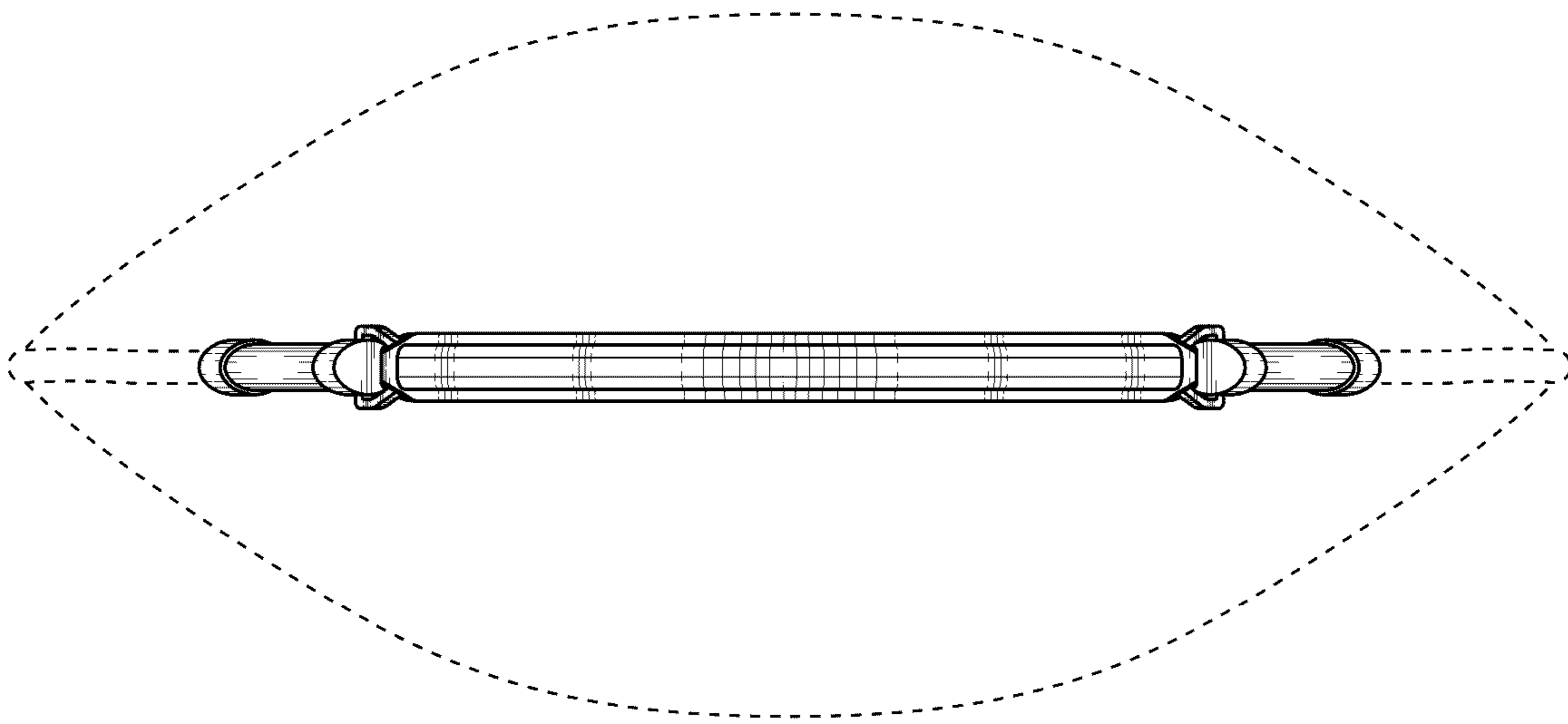

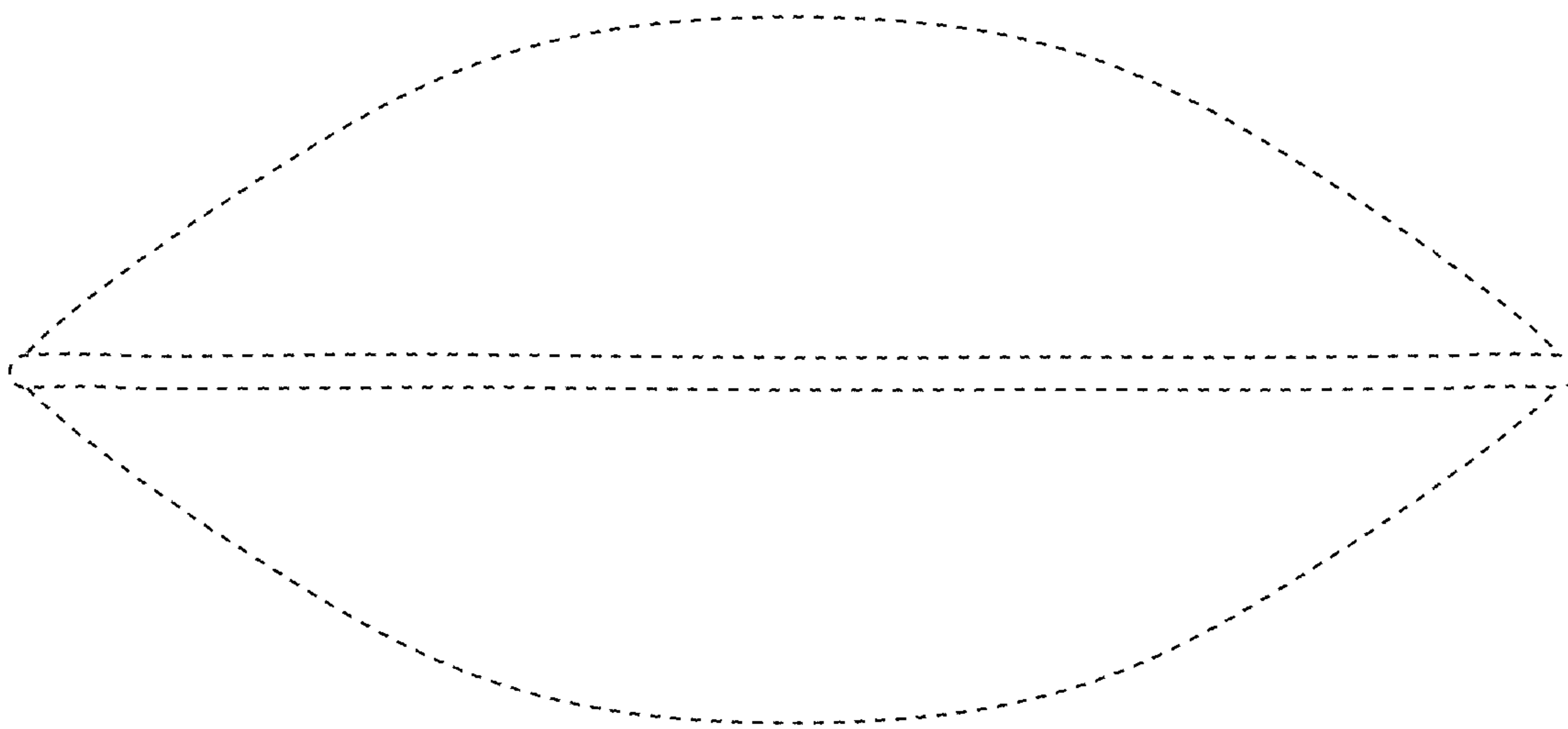
