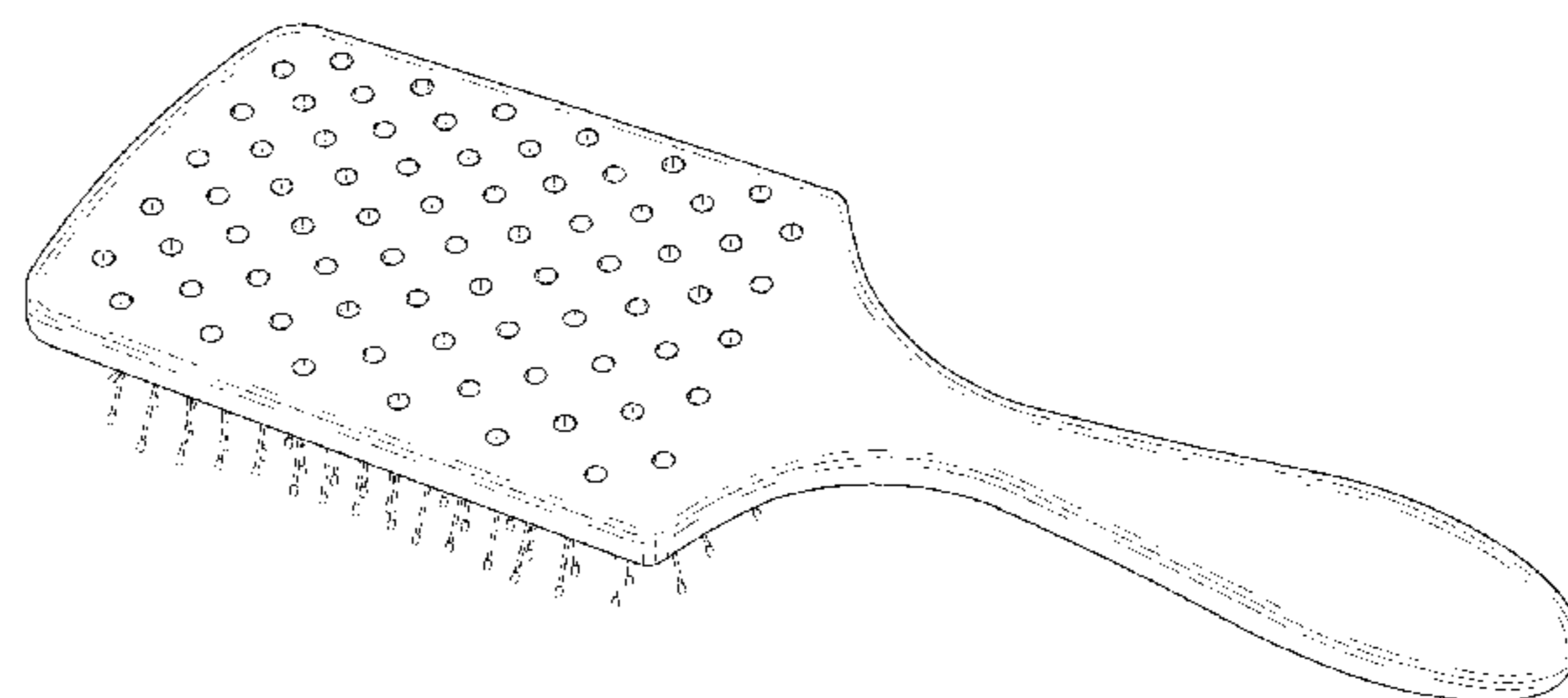
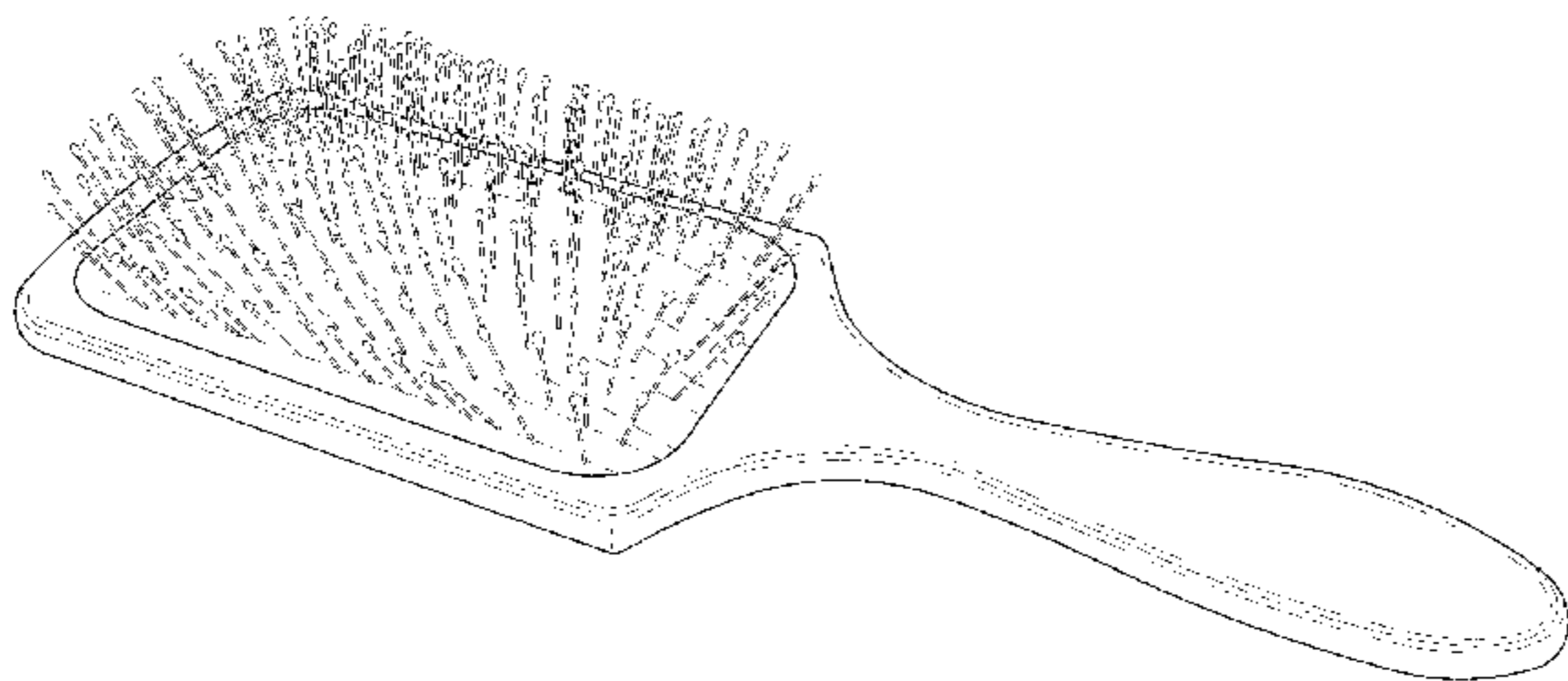
The ornamental design for a brush, as shown and described.

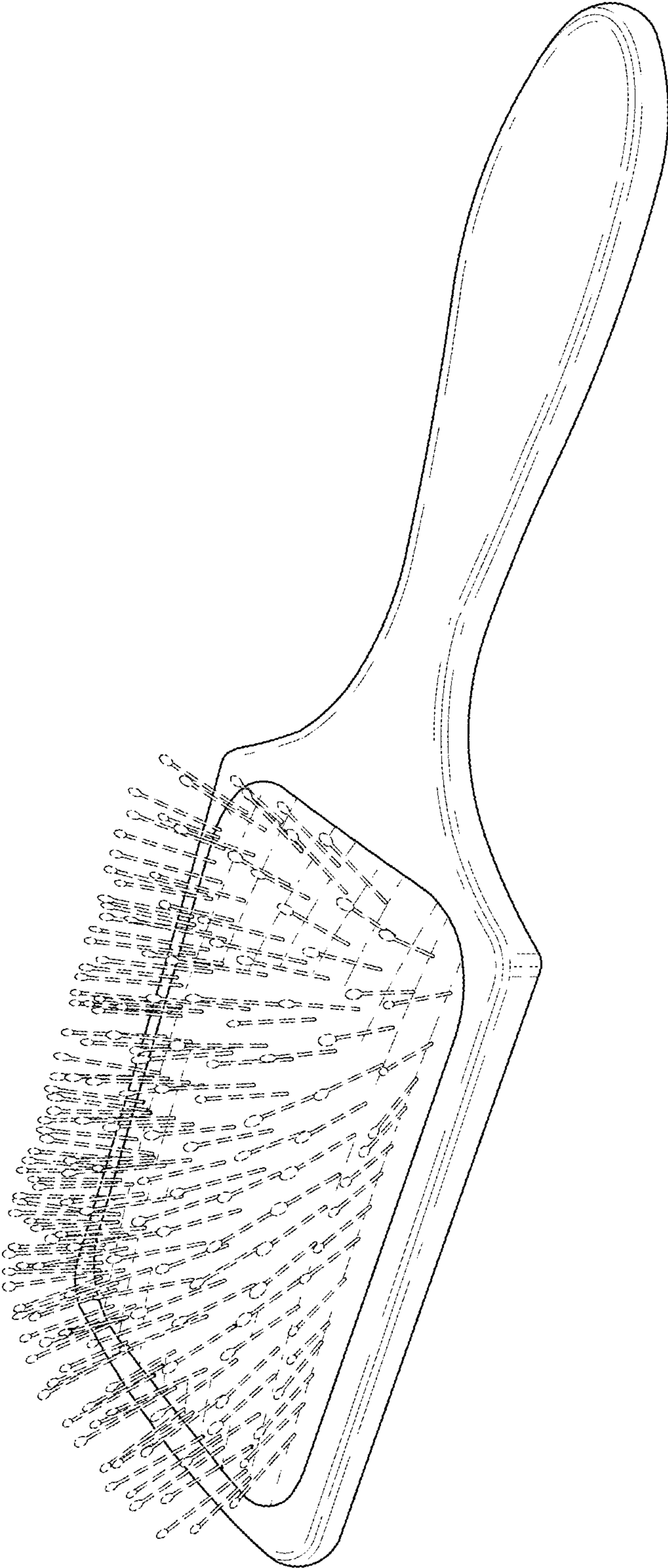

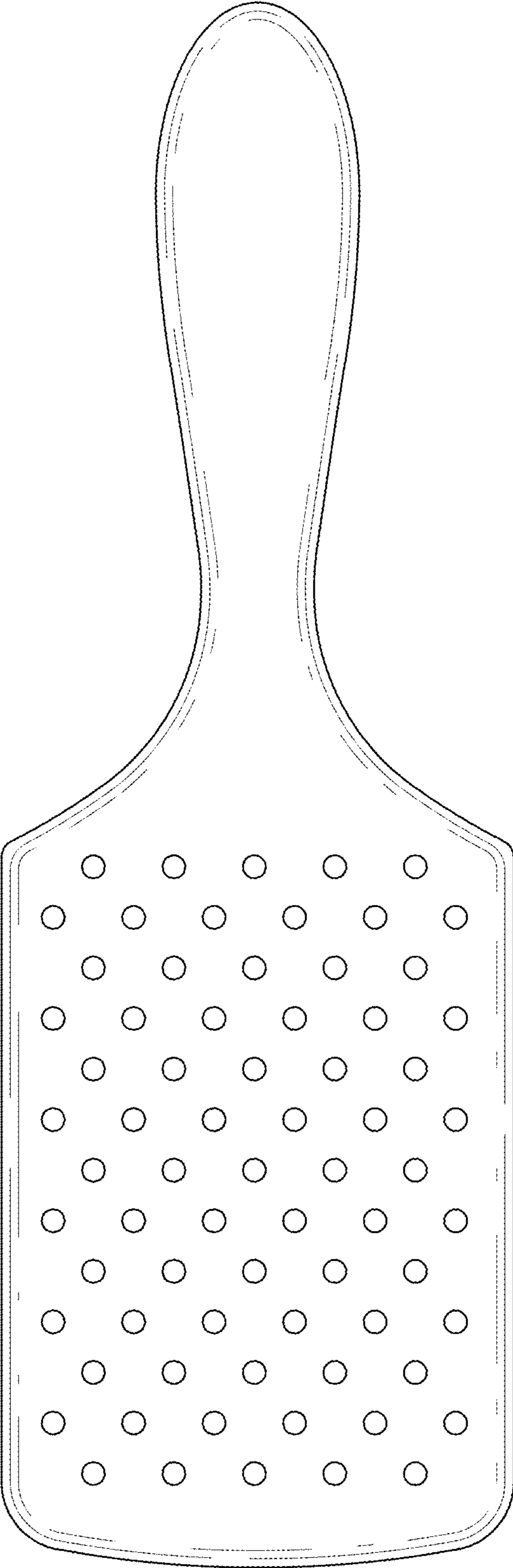

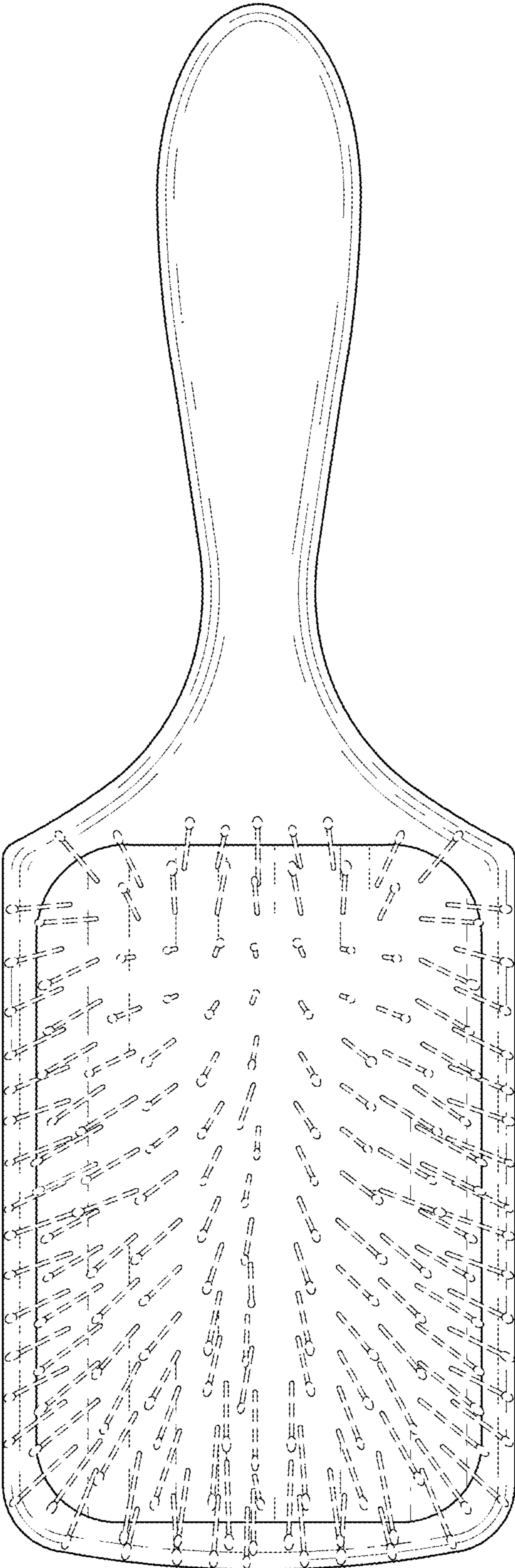

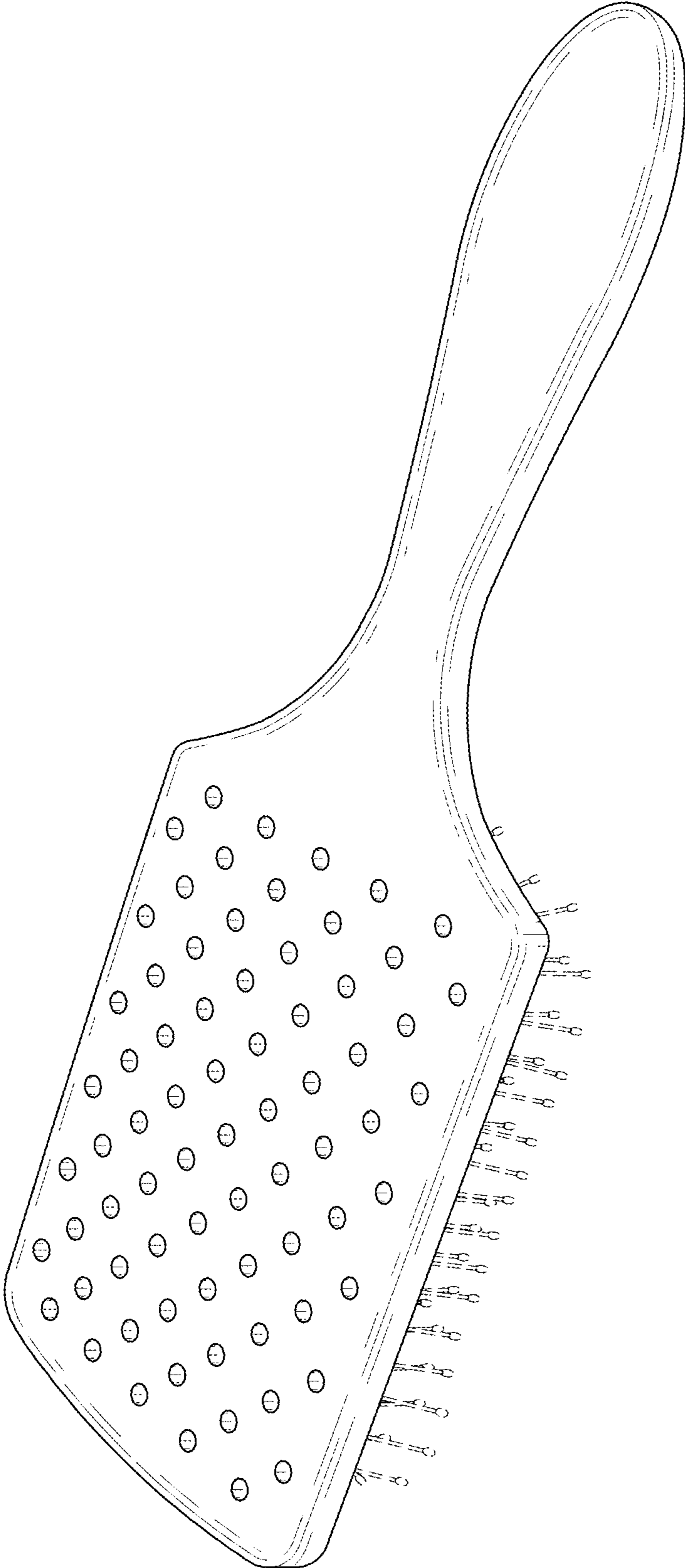

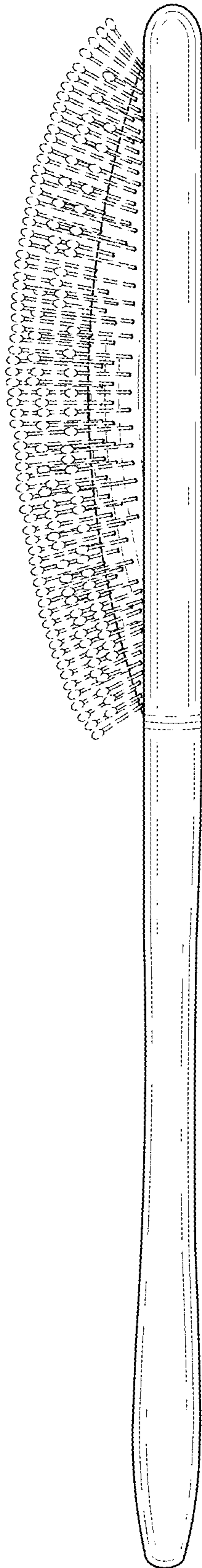

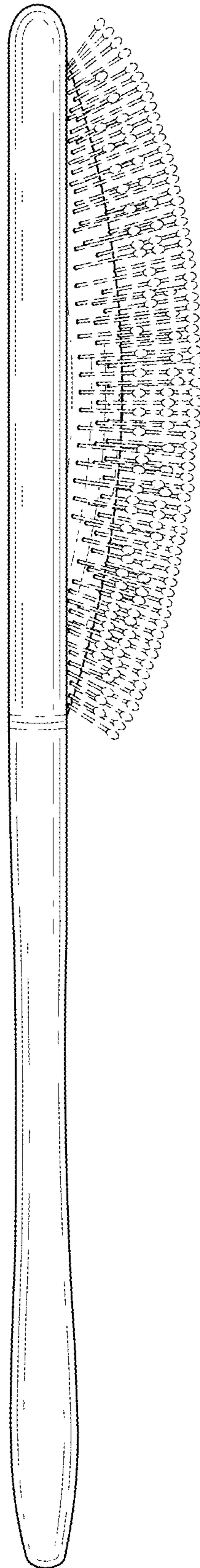

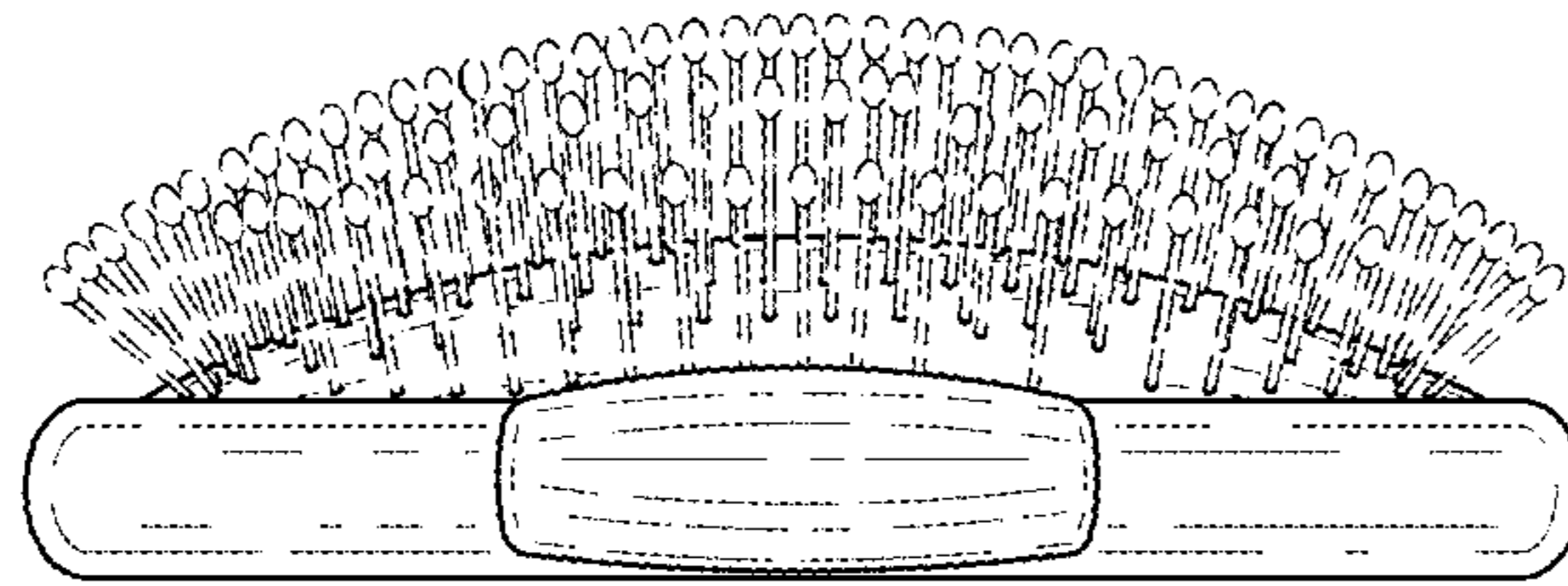

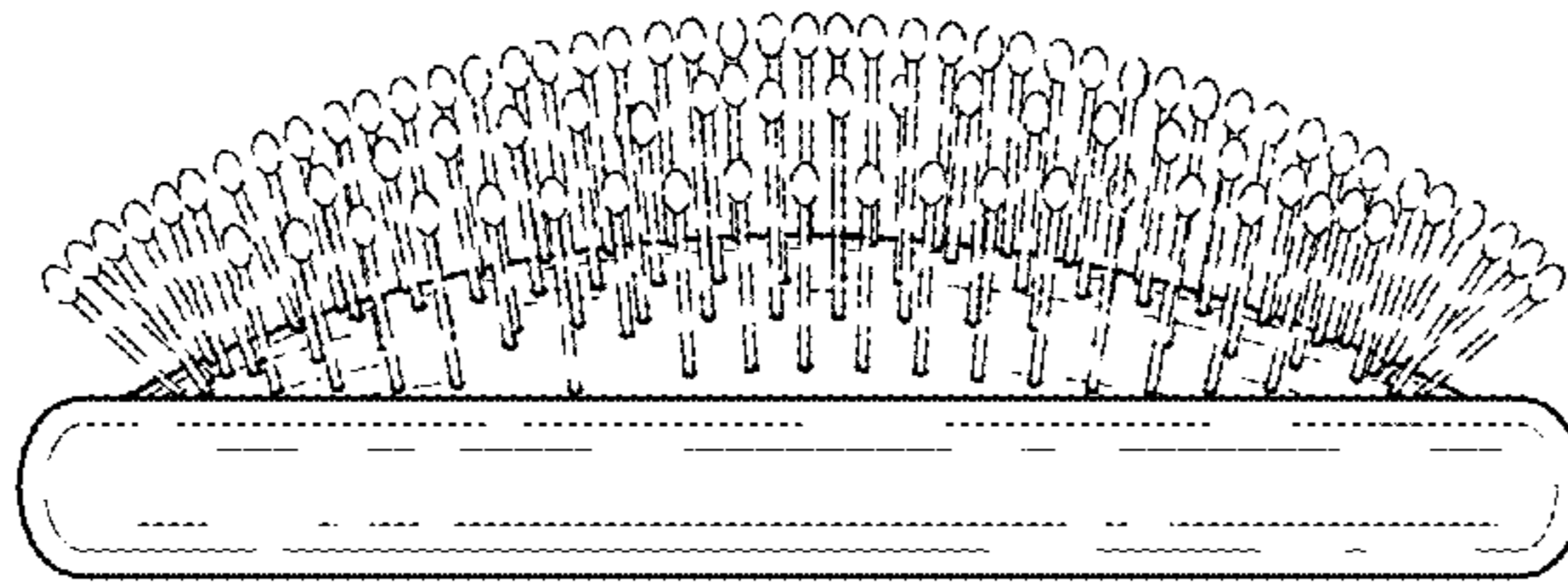
